Abstract

In human milk banks (HMBs), donor milk (DM) is commonly sterilized by Holder 27 pasteurization (HoP). High hydrostatic pressure (HHP) processing is an innovative, 28 alternative method for DM sterilization. We evaluated the impact of HHP processing 29 on the concentration of seven metabolic milk hormones. Eight samples of raw DM were 30 aliquoted. One aliquot was sterilized by HoP (62°C for 30 min), and another was 31 processed by HHP (350 MPa at 38°C). Compared with raw DM, HoP milk displayed 32 reduced concentrations of insulin, nesfatin-1, cortisol, leptin, apelin and GLP-1, though 33 adiponectin levels were unchanged. HHP processing maintained the levels of insulin, 34 nesfatin-1, cortisol and leptin at their initial levels in raw DM, reduced apelin and 35 adiponectin levels, but increased GLP-1 level. Sterilization of DM by HHP thus 36 preserves the main metabolic hormones in human milk, underlining the interest of this 37 method for use in HMBs. 38

41 1. Introduction

During the last decade, evidence has steadily accumulated for the importance of 42 bioactive breast milk (BM) hormones as factors in the health of newborns and the 43 44 development of infants. Experimental and clinical studies have shown that BM hormones could act directly on the newborn intestine or be absorbed and transferred 45 into the newborn's blood circulation to reach other organs (Victora et al., 2016; Badillo-46 Suárez et al., 2017; Savino & Liguori, 2008; Schueler et al., 2013). For instance, 47 studies in rodents have demonstrated that BM leptin can be absorbed into the 48 newborn's blood via the small intestine, and that it controls the establishment of 49 hypothalamic neural networks involved in food intake (Casabiell et al., 1997; Bouret et 50 al., 2004). Similarly, BM insulin was shown to reach the newborn's hypothalamus and 51 modulate neural connections (Vogt et al., 2014), and was also implicated in gut 52 maturation and in the reinforcement of the gut barrier (Shulman, 2002). So far, more 53 than thirty peptidic and steroid hormones have been described in human BM (Schams, 54 & Karg, 1986; Kratzsch et al., 2018). Their levels in BM are frequently correlated with 55 those in maternal plasma and are modulated by maternal characteristics such as body 56 mass index and diet (Schams, & Karg, 1986; Kratzsch et al., 2018; Andreas et al., 57 2014). Based on these findings, it was proposed that BM hormones may be part of a 58 system controlling energy homeostasis and gut maturation in newborns, both directly 59 and indirectly. 60

In preterm infants poor feeding is one of the main reasons for inadequate weight gain after birth. Immaturity of the gastrointestinal tract, feeding difficulties due to immaturity of sucking movements, low BM supply, and a lack of hepatic glycogen stores contribute to difficulty in meeting the nutritional requirements in preterm infants (McNelis et al., 2017). To ensure adequate growth of preterm babies, mother's BM is the best choice

for enteral feeding but, when unavailable, donor milk (DM) is often used (Boquien, 66 2018). DM is provided by human milk banks (HMBs) which collect, screen and store 67 DM. In order to ensure microbial safety for preterm newborns, most HMBs sterilize DM 68 using the standard method of Holder pasteurization (HoP), commonly performed by 69 heating DM to 62.5°C for 30 minutes (Picaud, & Buffin, 2017). Although clinical 70 practices demonstrate that many beneficial properties of DM still persist after HoP, this 71 pasteurization is known to partly degrade numerous heat-sensitive bioactive factors in 72 BM such as immunoglobulins, lactoferrin, some vitamins, lysozyme, the bile salt-73 dependent lipase (BSSL), and some milk hormones (Picaud, & Buffin, 2017; Escuder-74 75 Vieco et al., 2018; Ley et al., 2011). As these milk compounds are important for growth, development and immunity of premature babies, methods of DM sterilization such as 76 high-temperature short-time (HTST) or ultra-violet (UV) pasteurization, as well as 77 sterilization by high hydrostatic pressure (HHP) processing, have recently emerged as 78 alternatives (Wesolowska et al., 2019). 79

The HHP process applies high pressures in a temperature and time-controlled manner. 80 This method has been used for 25 years for sterilization in food processing and was 81 recently adapted for DM sterilization (Wesolowska et al., 2019; Demazeau et al., 2018; 82 Wesolowska et al., 2018). Demazeau et al. showed that HHP processing using four 83 cycles of a moderate pressure (350 MPa) during 5 minutes at 38°C is effective for 84 sterilizing DM and conserves lactoferrin, BSSL enzyme and lysozyme levels close to 85 those in raw DM (Demazeau et al., 2018). The aim of the present study was to 86 investigate if HHP treatment also conserved several key metabolic hormones in DM 87 88 including six peptidic hormones (*i.e.* leptin, insulin, adiponectin, apelin, GLP-1 and nesfatin-1), as well as one steroid hormone (cortisol). These hormones were also 89 measured in raw DM and in DM pasteurized by HoP for comparison. 90

92 **2. Materials and Methods**

2.1. Milk collection and processing

Sample collection, preparation, and the experimental design of the present study 94 are shown in Figure 1. Frozen DM samples from 11 donors were provided by the 95 regional HMB (Lactarium Régional de Lille, Jeanne de Flandre Children's Hospital, 96 CHU Lille). Donors provided written, informed consent for the use of their milk for this 97 research purpose. After thawing of milk samples, 8 different batches of DM were 98 99 created under sterile conditions by mixing various volumes (from 10 to 30 ml) of all BM samples, primarily in order to homogenize DM composition between batches (BM 100 hormones levels display high level of inter-individual variation). 101

Three aliquots of DM were prepared for each batch: one fraction was stored at -102 80°C without any other treatment (raw milk sample); one fraction was subjected to HoP 103 according to the standard pasteurization protocol (62.5°C for 30 min) in our regional 104 HMB; the last fraction was subjected to HHP processing as previously described 105 (Demazeau et al., 2018). Briefly, the set of HHP parameters was as follows: pressure 106 = 350 MPa, temperature = 38° C, VA (application rate) = 1 MPa.s⁻¹, number of cycles 107 = 4 cycles, duration of each cycle = 5 min and a latency time with normal pressure 108 between each cycle of 5 min. After HoP and HHP treatments, a microbiological 109 analysis was performed to verify the efficacy of sterilization (Department of 110 Microbiology, Centre de Biologie Pathologie, CHU de Lille). Sterilized samples were 111 then stored at -80°C until analysis for milk hormonal content. 112

113 **2.2. Quantification of milk hormones**

The concentrations of hormones were determined in each milk fraction using 114 whole milk. To check for potential matrix inhibition, each assay was optimized for 115 linear-range detection of each hormone. Six abundant peptidic milk hormones and one 116 steroid hormone were quantified using commercial ELISA kits: leptin (DLP00, R&D 117 Systems, Abingdon, UK), insulin (HUEB0185, ELISA Genie, Dublin, Ireland), 118 adiponectin (RD191023100, BioVendor, Brno, Czech Republic), apelin-12 (EKE-057-119 23, Phoenix Pharmaceuticals, Strasbourg, France), GLP-1 (HUFI00805, ELISA Genie, 120 Dublin, Ireland), nesfatin-1 (EK-003-26A, Phoenix Pharmaceuticals, Strasbourg, 121 France) and cortisol (RE62111, IBL, Männedorf, Switzerland). 122

123 **2.3. Statistics**

Data are presented as mean \pm SEM. Statistical analysis were performed with GraphPad Prism 7.0. software (San Diego, USA). Grubb's test was used to detect any outliers. Normality of variables was evaluated by a D'Agostino-Pearson test. If necessary, a log10 transformation was applied to reach normality. Statistical differences were then tested by paired T-test or Wilcoxon test according to sample normality assessment results. A *p* value <0.05 was considered significant.

131 3. **Results**

The microbiological analyses of milk samples treated by HoP and HHP confirmed their efficacy as sterilization methods and the microbial safety for nutritional use of DM for preterm newborns (data not shown). Effects of HoP and HHP treatments on DM hormones levels are reported in Figure 2. Compared to raw milk, HoP treatment reduced dramatically insulin (-63%, Fig. 2A), nesfatin-1 (-41%, Fig. 2B), cortisol (-11%, Fig. 2C), leptin (-100%, Fig. 2D), apelin (-41%, Fig.2E) and GLP-1 (-83%, Fig.2F).

However, adiponectin levels were not different between raw and HoP-treated milk 138 fractions (Fig. 2G). Conversely, HHP-processed fractions did not show any significant 139 reduction in levels of insulin (Fig. 2A), nesfatin-1 (Fig. 2B), cortisol (Fig. 2C) or leptin 140 (Fig. 2D) compared with raw DM. However, HHP-treatment reduced milk apelin (-20%, 141 Fig.2E) and adiponectin (-50%, Fig. 2G) levels compared with raw DM, while GLP-1 142 levels were increased (+64%, Fig.2F). Hence, a comparison between HoP and HHP 143 treatments showed that HHP processing significantly increased concentrations of 144 insulin, nesfatin-1, cortisol, leptin, apelin and GLP-1. Only milk adiponectin was 145 reduced by 52% by HHP processing compared with its level in pasteurized HoP-treated 146 147 milk (Fig. 2G).

149 4. **Discussion**

150 Milk hormones are non-nutritive bioactive compounds that may exert short- and long-term beneficial health effects, as well as positively influence metabolic 151 programming in both premature and full-term newborns (Victora et al., 2016; Badillo-152 Suárez et al., 2017; Savino & Liguori, 2008; Schueler et al., 2013; Bouret et al., 2004; 153 Vogt et al., 2014). In this study, we compared the effect of HoP (the reference method 154 for DM sterilization in HMBs) with an alternative sterilization method, HHP processing, 155 on the preservation of seven important metabolic hormones. We showed that HHP 156 processing better preserves the concentrations of insulin, nesfatin-1, cortisol, leptin, 157 apelin and GLP-1 in breast milk than HoP, and maintained these hormones at levels 158 close to their initial levels in raw DM. We also observed that HHP process reduced milk 159 adiponectin levels by 52%, whereas HoP did not affect this hormone in our study. 160

Few studies have characterized the effects of HoP on human breastmilk 161 hormones and, so far, they have focused on a few well-described hormones including 162 leptin, insulin and adiponectin (Escuder-Vieco et al., 2018; Ley et al., 2011; Vass et al., 163 2020 Wesolowska et al., 2018). Although discrepancies due to samples preparation or 164 types of assay were reported, all these studies have shown that HoP reduced milk 165 hormonal content. For example, breastmilk insulin levels were reported to be reduced 166 after HoP treatment by 14% (Vass et al., 2020), 32% (Wesolowska et al., 2018) and 167 46% (Ley et al., 2011); milk leptin by 77% (Wesolowska et al., 2018), 87% (Vass et al., 168 2020) and 90% (Escuder-Vieco et al., 2018); and milk adiponectin by 33% (Ley et al., 169 170 2011; Wesolowska et al., 2018). In the present study, HoP treatment decreased insulin by 63% and leptin by 100% but did not significantly affect adiponectin. In line with 171 previous observations, our study demonstrates that both insulin and leptin are very 172 sensitive components of human breastmilk and that their levels are drastically reduced 173 by HoP. Discrepancies between studies (Escuder-Vieco et al., 2018; Ley et al., 2011; 174 Wesolowska et al., 2018; Vass et al., 2020) could be related to differences in 175 pasteurizer performance (Picaud, & Buffin, 2017). For adiponectin, in accordance with 176 Escuder-Vieco et al. (Escuder-Vieco et al., 2018), we did not observe any effect of HoP 177 178 on this hormone in DM whereas two studies have reported a 33% reduction of adiponectin level after HoP pasteurization (Ley et al., 2011; Wesolowska et al., 2018). 179 We also observed a small, but significant, 11% reduction in cortisol after HoP. Using 180 181 this same pasteurization method, Vass et al. (Vass et al., 2020) reported a 35% reduction of this hormone after HoP, suggesting that this steroid hormone is also a 182 feature of DM sensitive to HoP. Finally, to the best of our knowledge, we report for the 183 first time that the levels of nesfatin-1, apelin and GLP-1 are reduced in HoP-treated 184 milk by 40%, 41% and 83%, respectively. This reinforces the idea that peptide 185

breastmilk hormones are largely degraded by HoP, probably leading to DM withreduced hormonal benefits for preterm newborns.

HHP processing was shown to protect numerous bioactive milk compounds from 188 189 degradation (Picaud, & Buffin, 2017; Escuder-Vieco et al., 2018; Wesolowska et al., 2019; Demazeau et al., 2018; Wesolowska et al., 2018). We observed in this study 190 that breastmilk insulin, nesfatin-1, cortisol, leptin, apelin and GLP-1 are all preserved 191 at close to raw DM levels after HHP sterilization. Surprisingly, milk GLP-1 levels were 192 found to be increased after HHP processing. This could result from the influence of 193 hydrostatic pressure on the physicochemical properties of human milk. Indeed, human 194 milk is a very complex biological fluid that could be characterized simply as an emulsion 195 of fat globules in an aqueous liquid with cells components. Although, the precise 196 distribution of GLP-1 in human milk remains unknown, due to its peptide structure GLP-197 1 is probably mainly located in the emulsion phase of human milk, which consists of 198 milk fat droplets or fat-associated proteins suspended in the aqueous fraction of the 199 200 milk. Documented effects of high pressure on milk lipids are scarce: two studies have shown that while milk fat globules are still present after HHP, an alteration in globule 201 size was observed (Demazeau et al., 2018; Mahara et al., 2014). Hence, our 202 hypothesis is that HHP treatment of DM causes the release of GLP-1 from fat globules 203 to the aqueous phase. This mechanism was also proposed by Wesolowska A et al. 204 (Wesolowska et al., 2018), who observed that a high-pressure application (ranging 205 from 400 to 600 MPa) increased milk leptin levels in the emulsion phase of DM. 206

In this study, adiponectin was the only hormone whose levels were reduced after HHP processing. This finding is in accordance with the study of Wesolowska *et al.* who reported a drastic reduction of milk adiponectin following HHP process using various high pressures ranging from 200 to 600 MPa (Wesolowska et al., 2018). Adiponectin

is composed of multimer complexes of proteins in plasma (Kadowaki, & Yamauchi,
2005). High-molecular-weight (HMW) adiponectin, which is the most biologically active
form, is a large multimer of 12–18 subunits (Lihn et al., 2005)). This HMW adiponectin
is present in human milk (Bronsky et al., 2006; Martin et al., 2006). As postulated above
for GLP-1, we here speculate that HHP may have modified the physicochemical
properties of human milk and altered the structure of the bioactive HMW adiponectin
leading to its partial degradation. Further study is needed to test this hypothesis.

Previous studies have shown that HHP better preserved numerous compounds in 218 DM than HoP, such as immunoglobins, lactoferrin, BSSL enzyme, lysozyme or 219 220 vitamins (Wesolowska et al., 2019; Demazeau et al., 2018; Wesolowska et al., 2018). The present findings demonstrate that hormonal components of DM are also largely 221 preserved by this non-thermal method. We believe that preservation of milk hormones 222 in sterilized DM is especially important in the context of feeding preterm newborns with 223 DM, as these babies have specific nutritional needs and metabolism, and hormones 224 225 are involved in the maturation of numerous physiological systems in the early postnatal period (McNelis et al., 2017; Boquien, 2018; Platt, 2014). For example, experimental 226 data have shown that leptin in breastmilk participates in the neonatal regulation of food 227 intake and, along with insulin, in hypothalamic development; while insulin has been 228 also shown to be involved in the maturation of digestive mucosa (Schueler et al., 2013; 229 Casabiell et al., 1997). Both leptin and insulin were recently associated with early 230 changes in the infant intestinal microbiome (Lemas et al., 2016; Gotteland et al., 2017). 231 Milk glucocorticoids have been implicated in the maturation of the gastrointestinal tract, 232 energetic metabolism and in long-term metabolic programming (Badillo-Suárez et al., 233 2017; Rose et al., 2013; Van Der Voorn et al., 2020). Adiponectin has been proposed 234 to regulate the carbohydrate-lipid metabolism in newborns (Savino, & Liguori, 2008; 235

Kratzsch et al., 2018), while nesfatin-1 may regulate food and water intake (Schalla, &
Stengel, 2018; Aydin et al., 2009; Aydin, 2010). Breastmilk GLP-1 was proposed to be
involved in infant satiety, glucose homeostasis and reduction of gastrointestinal motility
(Müller et al., 2019; Schueler et al., 2013). Finally, oral apelin administration was shown
to control intestinal maturation by modulating cell proliferation in the digestive mucosa
in developing rodents (Antushevich et al., 2015).

243 5. Conclusion

In conclusion, we have demonstrated that our HHP protocol (4 cycles of a moderate pressure (350 MPa) during 5 minutes performed at 38°C) preserves the main metabolic hormones in human milk, reinforcing the potential of this new sterilization method to be used to treat DM in HMBs. Through the preservation of numerous important milk bioactive factors, HHP-treatment of DM could improve growth, neurodevelopment, intestinal maturation and microbiota establishment in preterm infants who receive it.
