## Playing with Persians in Athenian Imagery of the 4<sup>th</sup> Century BCE

ABSTRACT-. Greek representations of Persians correlate to the complexities of their military and diplomatic relations. Over the 5<sup>th</sup> century BC, Persians in vase-painting range from the ethnographically accurate battle scenes to their belittlement as warriors. In the 4<sup>th</sup>-century BC context of more complex relations, Athenian artisans thrust Persians into entirely new directions. The amorous Persian emerges and figure-lekythoi of dancing Persians can even be winged. The projection of real-life Persians into creatures of fantasy most conspicuously appears in griffin-riding and griffin-hunting imagery. The contrast between the "fantasticization" of Persians in art and their imperial strength suggests an Athenian strategy of anxiety-displacement.

KEYWORDS-. Athenian vase-painting, Greek images of Persians

RÉSUMÉ-. Les représentations grecques de Perses sont contemporaines de relations militaires et diplomatiques complexes. Dans la peinture de vases, au cours du v<sup>e</sup> siècle av. J.-C., les Perses figurent d'abord dans des scènes de bataille à valeur ethnographique, avant d'être ensuite dépréciés en tant que guerriers. Au IV<sup>e</sup> siècle av. J.-C., où les relations sont plus complexes, les artisans athéniens figurent les Perses suivant des modèles entièrement nouveaux. Le Perse amoureux fait son apparition et des vases en forme de danseurs perses sont même parfois pourvus d'ailes. Le remplacement de Perses réalistes par des créatures fantastiques est particulièrement frappant dans les représentations de griffons montés et de chasse au griffon. Le contraste entre cette figuration fantasmatique des Perses et leur puissance politico-militaire suggère une stratégie athénienne de compensation.

MOTS-CLÉS-. Peinture de vases attique, images grecques des Perses

In the last chapter of his *Alien Wisdom: The Limits of Hellenization*, after discussing Celts, Jews, and Romans, Arnaldo Momigliano considered "Iranians and Greeks."<sup>1</sup> He outlined the various points of contact between Greeks and Persians from the time of Cyrus' conquest of Lydia and noted that for the sixty years following 411, the Great Kings of Persia had "put far greater pressure on Greece" than in the time of Athens' naval hegemony. After turning to analysis of Ctesias, Xenophon and the Alexander historians, Momigliano articulated an important point of puzzlement:

I find it very difficult to understand why the severe but appreciative attitude towards the Persian Empire prevailing in the fifth century yielded in the fourth century to a mixture of idealization of dead Persian kings and of gossip about contemporary court intrigues. Lack of interest in the realities

of Persian political and social organization remained conspicuous in the historians who narrated its end.

Representations of Persians in Greek arts, notably Athenian ceramic, exhibit a similar trajectory.<sup>2</sup> Scenes of combat in red-figure vases of the earlier fifth century in which well-armed Persians valiantly battle Greek hoplites gradually become generic and then change into images of the fourth century that trivialize or fantasticate Persians. There are amorous Persians, Persians who have dealings with griffins, Persians who are more interested in dance than warfare. The murkiness of the phenomenon has led to its general neglect; it is appropriate in the present context to reconsider the question.<sup>3</sup>

In all the repertoire of subjects depicted on the thousands of Athenian decorated vases of the sixth through fourth centuries, subjects depicting scenes of life (as opposed to myth) number only in the hundreds.<sup>4</sup> Within that select group, less than 150 vases are decorated with images evidently of Persians, despite the historical evidence for the continuing importance of the Persian Empire in all aspects of Greek life over the two centuries after the conquest of Lydia.

After the major campaigns of conquest by Cyrus, and then Cambyses and Darius, the extent of the Persian Empire remained more or less stable for two centuries. Different satrapies at different times presented challenges to the Kings of Kings, but the strength and significance of the whole remained intact. The "liberation" of the Greek city-states by the campaigns of Cimon and the Delian League in the fifth century impacted only the western fringes of the empire; to the east the empire continued to stretch to the  $\xi \sigma \chi \alpha \tau \alpha \gamma \eta \varsigma$ , the edges of the known world. The fact of continuity despite the vicissitudes of royal authority at the top allowed the claim of Alexander of Macedon that he was "liberating" the peoples of the empire as he swept through to the outer reaches.

What did change over this period of time (ca. 546–323) was the representation of the Persians in Athenian arts. In the earlier sixth century, men in foreign dress tend to be some form of Scythian; of these, the "pointed hat Saka" (to use the term of Persian royal texts) are the most readily recognizable. The advent of Persians in Athenian vase-painting, with good reason, is typically linked with the Persian invasions of Darius (Datis and Artaphernes) and Xerxes that led to the land battles of Marathon and Plataea. In the Persian War period Athenian red-figure vases present scenes of battles against Persians that are notable for their accuracy in representing both Greek and Persian dress and weaponry. Here the Persians are a formidable enemy, both brave and well-equipped. Although in the imagery the general movement from left to right signals Greek victory by a standard convention, even in retreat the Persians battle on. In many ways the best example of this is the name vase of the "Painter of the Oxford Brygos."<sup>5</sup> On one exterior side of the cup, fully armed hoplites battle spear-bearing Persians properly equipped with their defensive weaponry, including both fish-scale and quilted linen corselets, and *gerron* shields. One Persian still grasps his sword even as he falls. Valiant defense by cuirass-wearing and sword-wielding Persians is similarly found on other paintings of the Persian Wars period.<sup>6</sup>

Over the following decades, in art the threat presented by Persians is increasingly diminished. In general, they are displaced from the battlefield into domestic contexts.7 In the battle imagery a more caricatural mode predominates as, for example, a Persian fleeing in frontal-faced terror on a krater in Basel; for their part, the Greek hoplites battle naked, eschewing the need for corporeal defensive weaponry.8 In the last quarter of the fifth century a new class of drinking vessel shaped like human heads include some Persians. With their open mouths and furrowed brows, the Persians look distinctly worried perhaps, it has been humorously suggested, because they are about to confront a Greek drinker.<sup>9</sup> [Fig. 1]

In the imagery of the fourth century, the historical Persian virtually disappears, even though in life the Persian Empire figured in all Greek strategic and military calculations and the fifth-century public arts of Athens continued to present conspicuous reminders of victory against Persians.<sup>10</sup> In place of the historical or veristic mode a range of constructs develop that strip from the Persian his quality as a warrior. A hint of what is to come appears on the neck of the Persian head vase, where a youth in Persian dress pursues a peplos-wearing woman who looks back to him coquettishly [Fig. 1].

#### THE AMOROUS PERSIAN

The "amorous Persian" takes off in fourth-century imagery, in a new mode that might be called novelistic [Fig. 2]. Although it appears infrequently in surviving ceramic, its occurrence on

a range of vessel types from different workshops across several decades attests to its popularity. Early examples include the tondo of a red-figured cup in Vienna and an oinochoe in Dresden, in which the pair calmly converse.<sup>11</sup> Such images have tended to be read as mythological, from which perspective the couple have been seen as Paris and Helen.<sup>12</sup> No clear indication that the two are to be so identified is visible, and the existence of analogous but more complex imagery over the fourth century argues against the notion. Already in late fifth-century imagery two lekanis lids present a circular composition of Persians (some bearded) pursing women.<sup>13</sup> Their fragmentary state challenges certain reading, but the presence of vegetation and an altar put them in the Meidian category of the nostalgic *locus amoenus* so well articulated by Lucilla Burn.<sup>14</sup>

Elaborations on larger vessels include a Persian at centre on foot rushing to the right, with women on either side.<sup>15</sup> The Persian can be mounted on a horse, as most simply on an early fourth century pelike in New York with only one woman.<sup>16</sup> Two women moving to the sides appear on a hydria in St. Petersburg [Fig. 2].<sup>17</sup> Here the peplos-wearing woman going to the right seems to hold

a tympanon, but with no other hint of maenadism and the woman running left simply extends her arms as she looks back. Most interesting is a hydria in Hildesheim, about mid-fourth century, with several figures, including an Eros hovering between the mounted Persian and a bejeweled woman.<sup>18</sup> Pan looking on at right (his horns clearly rendered in extruded clay) strengthens the sense of rustic idyll; above sits a nymph partially dressed in a himation. The whole composition combines romance with country idyll.

#### PERSIANS WITH GRIFFINS

A most extraordinary elaboration of the idea develops in the early fourth century, as evidenced by a small pelike in Mainz: the Persian rides not a horse but a griffin and the woman running ahead, again wearing a peplos, holds what seems to be a casket in her upraised left hand [Fig. 3].<sup>19</sup> The most elaborate examples of such imagery appear on two calyx kraters attributed to the Painter of the London Griffin-Calyx, dating from the mid-fourth century, one (the name vase) in London and the other in Copenhagen.<sup>20</sup> Here griffin riders moving both to the left and to the right are interspersed with youths in generic Persian dress running amidst women who run to the right, looking back. Some youths have fallen to their knee. While the predominate movement is in one direction, figures facing back or moving the other way present more of a confused, almost Dionysian, revel.

The other side of these kraters with griffinriding youths presents a less friendly relationship with griffins: a single youth in larger scale, wearing Persian-looking dress and bearing a pelta shield, defends himself with spear against a griffin. The griffin rears up in attack. On the London krater, it seems to leap down from higher ground at left. A long tradition of scholarship sees such compositions as a battle

between griffins and Arimasps [see Fig. 4].<sup>21</sup> Arimasps are mentioned in a range of classical sources as a people who live north(east) of the Black Sea; Herodotus knows of them as living beyond the Issedones and being one-eyed (4.13-14), a tradition also known to Aeschylus, who adds that they ride horses (Prometheus Bound 804-805). One Aristeas of Proconnesus (in the Propontis), earliest mentioned by Herodotus in extant sources, reportedly composed an Arimaspeia that has been variously dated in a range between the later 7th to early 5th century.<sup>22</sup> The most succinct account is that of Pausanias's description of the helmet of Athena Parthenos (1.24.6); he explains that Arimasps fight with griffins who guard gold that comes from the earth. A handful of archaic representations may show such a subject.<sup>23</sup> On one Attic small squat lekythos of ca 380 in London, two white griffins with blue wings flank a mound covered with gilt nodules of extruded clay, doubtless meant to be the gold.24

Men wearing Persian-looking dress battling with griffins, and so usually identified as mythical Arimasps, frequently appear in fourthcentury Athenian imagery. Especially from about 370, grypomachies are small scale, as on the pelikai in Paris, Sydney [Fig. 4] and, later, in Skopje.<sup>25</sup> The earliest full-scale combat adorns

an unattributed calyx-krater in Brussels dating from the second quarter of the fourth century; the best known is a Group G Falaieff krater in Paris dating mid-century.<sup>26</sup> Two details of these kraters are especially noteworthy: on both, bearded men number among the combatants who are normally beardless, and on the Paris krater one fighter wears the Persian *kandys*.

In some Athenian images of the griffin-riders, there are other hints of precisely accurate ethnographic detail in the form of the riders' tiara: the appearance of a distinctive rounded bump just above the forehead on pelikai in Mainz [Fig. 3] and Sydney [Fig. 4].<sup>27</sup> This feature closely resembles the tiara worn by Sogdians in Persian imperial arts, such as Persepolis Apadana Delegation XVII.<sup>28</sup> It is recognizable also on the figure above the Sogdians' cartouche on the base of the statue of Darius I recovered at Susa in 1972.<sup>29</sup> The precise association of griffin-riding with a satrapy in the far eastern Persian Empire places it in the general region where, according to Herodotus, lived the Issedones. In other words, these are not figures of a wild imagination among vase-painters so much as a reflection of what may be a popular general vision of a part of the world so distant that such bizarre creatures might have conceivably lived. Imported Persian glyptic with imagery of the royal hero in combat with a griffin perhaps helped concretize a Greek notion that Persians battled griffins.<sup>30</sup>

#### EXOTIC IMAGERY AND TARGET-MARKETING

The question arises whether such exotic imagery was developed with a view to target-marketing on the part of the Athenian vase-painters. The provenance of many Athenian vases in European and other collections is not known but enough are known to consider the question. Certainly a few instances of target-marketing by Athenian potters have been convincingly identified, but they tend to relate rather to imitation of shape, as most famously the works of the sixth century Nikosthenic Workshop that precisely targeted Etruscan markets. For example, their production of the "Nikosthenic amphora" imitated an Etruscan bucchero shape associated with Cerveteri and is found to have been exported especially to Cerveteri.<sup>31</sup> Although such strategic marketing is especially and most extensively attested for Italy to the west, it is attested also eastwards to Cyprus in the case of the Athenian sixth-century "Cypro-jug," an oinochoe produced in the form of Cypriote jug Type V.<sup>32</sup> In contrast, very rarely can imagery be shown to be shaped by a desire to be attractive to a foreign audience although there is some evidence for Athenian targeting of Etruria in sixth-century black figure: a loincloth (*perizoma*) is given to figures normally naked in athletic or symposion imagery, and heterosexual intercourse, absent on vases found in Athens, is found on vases exported to Italy.<sup>33</sup>

Some of the vessels considered in this paper do have suggestive provenances, most notably the "Xenophantos lekythos" [Fig. 5], found at Pantikapaion in 1836; the provenance of the hydria of Fig. 2 is not reported but its location in the Hermitage may indicate a similar findspot. Some vessels with romantic Persians did make their way to the Black Sea, like the griffin-rider pursuit in Moscow thought to be from Kerch; the combat between a bearded figure and two griffins now in Pilsen had

a provenance in Kerch.<sup>34</sup> However, griffin-riders pursuing women also decorated vessels that were exported to Italy and even Spain.<sup>35</sup> The very wide extent of the known findspots with these themes (amorous Persians, griffin-riding or griffin-fighting) attests to the export of vessels with such ornamentation not only to Spain and Italy, but also North Africa as well as elsewhere in Greece.<sup>36</sup> The choice of themes and the manner of their production was assuredly Athenian.

An innovative ornamental composition of grouped human and animal protomes emerged in Athenian painting about 380-370 and continued throughout the century. On the larger threeprotome pelikai, the human heads wear some form of *tiara* and are typically positioned at centre, to be flanked by horse and eagle-griffin heads; McPhee aptly describes the arrangement as a visual synecdoche of grypomachy.<sup>37</sup> On the earliest, dating from the second quarter of the fourth century, McPhee identified the heads as beardless (youthful) males; a smaller group featured bearded heads with Persian tiara, presumably actual Persians.<sup>38</sup> The protome pelikai are perhaps all by one painter within Group G but were exported widely throughout the Mediterranean.<sup>39</sup> Sometimes the human heads may be female; some of them, youths and possibly women, dating from the mid to the late fourth century, wear the distinctive Sogdian tiara discussed above. The series perhaps presents a visual system in which Persians, Arimasps and Amazons are interchangeable. Occasionally a human is flanked by two of the same creature; for example, on a pelike exported to Galera in Spain a beardless figure who perhaps wears a Sogdian tiara appears flanked by eagle-griffin protomes. Regardless of the specific details, in this form of synecdoche, as McPhee observes, it is up to the viewer to read whether mounted griffin-combat or something else is intended.<sup>40</sup>

Fourth-century griffin-fighting significantly is anticipated on two fifth-century Athenian vases, both with Persian contexts. The less well known is a ram-head cup (so, a Persianizing shape) whose neck is adorned with the image of a griffin attacking a bleeding horse while, on the right, a

bearded man armed and equipped as a Persian raises his sword.<sup>41</sup> Much more familiar is the large relief squat lekythos signed by Xenophantos that depicts Persians engaging in a multiple-quarry hunt set in a *paradeisos* [Fig. 5].<sup>42</sup> Many elements of the mold-make figures present high levels of ethnographic accuracy with regard to dress and equipment, such as the Persian riding cloths with distinctive borders. Here two features especially signify: first, several of the hunters are given explicitly Persian names, including Dareios and Kyros, and second, among the prey (boar and stag) are two griffins, one an eagle-griffin and the other the (much rarer and more certainly Persian) lion-griffin. These figures emphatically transport the Persians from the familiar to exotic lands. As Franks has put it, these Persians hunt at ἔσχατα γῆς, the very edges of the known world.<sup>43</sup> It was an easy step to suppose that this would especially take place in the far north-east of the Empire, the home of the Sogdians.

#### COURTLY PLEASURES


At the end of the fifth century, a new hedonistic projection of the Persian king emerged, most clearly presented on a small volute krater in Vienna dating from the early fourth century [Fig. 6].<sup>44</sup> Although the fan-bearer provides the attribute of royal majesty, this enthroned king relaxes, entertained by music and dance with his court. From the uneven ground-lines it appears that the scene is set in a garden pavilion. Nibbles are near to hand on a small table. One axe-bearing guard—the only bearded figure here apart from the king himself—alone alludes to the normal regalia of the Persian court. Two youths dance the sinuous *oklasma* dance on tiptoes, bending over with their hands clasped above their heads, to the music of the pipes. All is relaxed and serene; the winged figure with chaplet at upper left, if Eros, would hint at romance.



A similar sense of indulgent lifestyle presents itself on a squat lekythos in London whose ostensible subject is a royal progress [Fig. 7].<sup>45</sup> The royal figure is mounted side-saddle on a camel with nose-plug whose Persian-style riding cloth has a decorated border. The king is attended by fan-bearer and torchbearer (gilt lines at top identify this as a torch rather than a flywhisk). But this is no sober procession as documented in various texts. It is enlivened by music of kithara, lyre and drum or tambourine. The only bearded men apart from the King raise their arms above their heads, dancing the *oklasma*. It is interesting to remember in this context that Aristotle while discussing the importance of education in music to young Athenians notes the contrast between Athenian and Persian practice, that the Persian kings enjoy listening to rather than benefit from the discipline of playing instruments (*Politics* 8. 1337a-1339b). Being surrounded by music and dance enhanced the pleasures of life at the Persian court.

The association of *oklasma*-dancing with royal entertainment may explain the emergence in Athens of a special class of figure-vessel, that is a closed vessel (commonly a lekythos or oinochoe) whose vessel form is disguised by a human figure.<sup>46</sup> One popular fourth-century type is *oklasma*-dancers wearing Persian dress. The dancers, both erect or kneeling, clasp their hands above their heads; while the best-known examples were exported elsewhere in Greece, in Athens fragments of some, even a mould, have been found.<sup>47</sup> A notable element is that these dancers tend to be winged, furthering the distance from the here and now.

#### ON THE BATTLEFIELD

Although by and large Persian figures in Athenian fourth-century imagery have little to do with the rigors of warfare (battles with griffins might be regarded as a form of courtly hunt), a handful of representations depict battle between Greeks and Persians: two pelikai and two hydriai.<sup>48</sup> They differ in almost every respect from their predecessors of the fifth century, as can be seen from the pelike excavated at Pella in 2007 [Fig. 8]:<sup>49</sup> the Persians are mounted, in three cases opposed by two Greeks, one on each side. The Greek hoplite, following the trends of the later fifth century, appears with only his helmet, shield, and spear, but on two of the vases, that in Pella and a hydria in London, his companion is a *psilos*, a light-armed warrior. On the London hydria, the *psilos* wears a chitoniskos and wields a bow; archers played an important role at Plataea (Hdt. 9.22.1–2). The

fragmentary state of the pelike in Pella makes reading difficult, but while both Greeks wear a pilos helmet and carry a shield, the figure at right holds a stone.<sup>50</sup>

These battle images are striking for both their accurate and their generic elements. The Persians, although mounted on horses aligning with the historical sources' attestation to their strength in cavalry, ride mounts that have nothing to do with Persian equestrianism as attested in Persian arts.<sup>51</sup> The accuracy in these scene lies in their inclusion of the wider range of combatants in

classical armies. This is not the occasion to debate whether the inclusion of the psilos is owing to a change in ideology in fourth century imagery; alternatively, it may reflect an oral tradition regarding the contributions of all Athenians to the land armies of the Persian War period.

In sum, some important innovations in the imagery of later fifth century led the way to the extraordinary near-disappearance of Persians as a subject of Athenian vase-painting in the imagery of the fourth century. Just as Momigliano observed regarding fourth-century literary sources, popular Athenian interest in Persians as reflected in vase-painting tended towards romance and sensual pleasure. Especially interesting is the shift in mode from the veristic, then caricatural, to the more novelistic and ultimately the fantastic, in that in the imagery Persians are cast out of lived reality by being merged with griffin-fighting Arimasps. In view of the continuing strength of the Persian Empire in the fourth century, and the relative weakness of the Athenians in controlling their fate, such displacement of the Persians may very well represent a form of compensation to deflect attention from a grim reality.
