Body-fitted (Sliding/Overset mesh methods) [1]

- + Geometry well represented in calculation domain
- + Aerodynamic forces calculated directly
- Mesh movement/adaptation needed to follow the solid
- Very expensive; unaffordable for regular use

Objectives

Immersed Boundary Methods (IBM) [1]

- + Geometry well represented in calculation domain
- + Aerodynamic forces calculated directly
- + No re-meshing required
- +/- Variety of models with different strengths and weaknesses [2]
- Mass/momentum conservation not always guarantied [3]

<u>Remark</u>: $\gamma = \left(1 + \frac{\chi}{\eta}\Delta t\right)$ the penalty density factor varies in space and time: $\gamma(\boldsymbol{x}, t) = 1$ in fluid, $\gamma(\boldsymbol{x}, t) > 1$ in solid

- Features
 - Large Eddy Simulations
 - Unstructured meshes and adaptive grid refinement
 - Low-Mach number Navier-Stokes equations (incompressible and variable density)
 - Double-domain decomposition and hybrid OpenMP/MPI communications

- The mean error remains constant
- Depends on discretization errors of initial solid meh

Theoretical solid surface Discretized solid surface Lost solid volume



- The mean fluctuation error is essentially negligible
 - Diminishes with finer grid resolution \rightarrow linked to interpolation errors

The solid volume is conserved in time and is independent of the fluid mesh resolution!

- VOS-IVP results match very well with BF and reference data [1]
- \blacktriangleright Drag relative error remains less than 3%
- \blacktriangleright Lift relative error less than 10%
- \succ Strouhal relative error less than 6%

- The noise comes from the momentum source term \mathscr{P} \geq
 - Specifically, there are local overshoots at the immersed \geq body's surface for the time derivative:

- ✤ Higher cost per iteration for VOS-IVP
- ✤ PPE cost increases due to variable Laplace operator
- \clubsuit Iso-grid, the new method costs in total two times more (x2)

Remark: the penalty factor varies in space and time: $\gamma(\boldsymbol{x},t) = 1 ext{ in fluid}, \ \gamma(\boldsymbol{x},t) > 1 ext{ in solid}$

Force estimation

For mobile immersed bodies, the negative sum of the IB forcing terms is equal to the total force, which includes both the forces from external fluid and the internal forces (needed to move the fluid inside the solid region) [1,2]



In our case the internal force is already supplied to the system via the solid momentum source term whose role is to move the fluid inside the solid, so the external force can be computed by the negative sum of the penalty forces over the domain.

$$\boldsymbol{F} = -\sum_{\Omega} \rho \, \mathbf{f}^{\text{pen}} \Delta V = \sum_{\Omega} \rho \, (\mathbf{f}^{\text{prediction}} + \mathbf{f}^{\text{correction}}) \Delta V$$

Inline force compared to experimental data and resolved body-fitted simulation (y⁺=0.5) w/ moving reference frame:



If the solid momentum is included to the N.S. equation, the total force has way less high frequency noise.

This noise is also reduced by increasing the mesh resolution.
