Evidence of microplastic-mediated transfer of PCB-153 to sea urchin tissues using
 radiotracers

15 Abstract

16

17 The present study reports the first experimental microplastic-mediated transfer of a key PCB 18 congener into adult specimens of the sea urchin Paracentrotus lividus. Three experiments were 19 conducted to assess whether ¹⁴C-PCB-153 adsorbed onto negatively buoyant MPs (500-600 μ m) is 20 bioavailable to the sea urchin : (1) exposure to a low concentration of ¹⁴C-PCB-153 sorbed onto a 21 high number of virgin MPs ("lowPCB highMP" experiment), (2) exposure to a high concentration of 22 ¹⁴C-PCB-153 sorbed onto a relatively low number of virgin MPs ("highPCB lowMP" experiment), and 23 (3) exposure to a low concentration of ¹⁴C-PCB-153 sorbed onto a relatively low number of aged MP 24 ("lowPCB lowMP" experiment). Results showed that the transfer of ¹⁴C-PCB-153 from MPs to sea 25 urchin tissues occurred in each of the three 15-day experiments, suggesting that MPs located on the 26 seafloor may act as vectors of PCB-153 to sea urchins even during short-term exposure events. 27

28 Introduction

29

30 The ubiquity and abundance of plastic litter in the marine environment has become a global 31 environmental concern (Coyle et al., 2020). Plastics in oceans are encountered in a range of different 32 shapes and sizes (Cole et al., 2011), influencing their behaviour and ultimate fate (de Sá et al., 2018). 33 Microplastics (MPs), defined as plastic items size ranging from $1 \mu m$ to 5 mm (Frias and Nash, 2019; 34 Hartmann et al., 2019), can be classified either as primary MPs, referring to manufactured particles 35 produced as such (e.g. plastic pellets, exfoliating cosmetics or synthetic clothing fibres), or secondary 36 MPs, which result from the breakdown of larger plastic debris (e.g. fragments; GESAMP, 2015). In 37 marine environments, MP surfaces are relatively rapidly colonised by microorganisms termed as 38 "plastisphere", a process known as biofouling or biofilm formation (Zettler et al., 2013).

40 Due to their small size, persistence and ubiquitous presence in aquatic ecosystems, MPs may 41 present a significant threat to marine fauna. It is well documented that microplastics are available 42 for ingestion to a broad range of neustonic (buoyant microplastics), pelagic (microplastics in 43 suspension in the water column) and benthic species (sinking microplastics), potentially affecting 44 aquatic food webs at multiple trophic levels and ecological niches (Setälä et al., 2018). Accumulating 45 within organisms, MPs may cause physical harm, such as feeding and digestion disruption, by 46 generating blockages, false satiation and injuries in the digestive tract (Jabeen et al., 2018; Wright et 47 al., 2013). In addition to the potential physical impacts of ingested microplastics, chemical toxicity 48 could also arise from the leaching of plastic-associated contaminants (i.e. co-contaminants). Co-49 contaminants carried by MPs include chemicals incorporated during manufacture (e.g. additives 50 such as flame retardants, plasticisers and stabilisers, Rochman, 2015) as well as chemicals sorbed 51 from the environment (e.g. metals and organic pollutant such as polychlorinated biphenyls, 52 Rodrigues et al., 2019; Rochman et al., 2013; Koelmans et al., 2016; Ogata et al., 2009). More than 53 250 organic compounds have been identified on plastic debris (Campanale et al., 2020). Based on 54 both their ubiquity and abundance in the marine environment, as well as their ability to carry 55 environmental contaminants and substantial proof of particle uptake by marine organisms, the 56 hypothesis that MPs may play a role in aquatic ecotoxicology as vectors for toxic contaminants has 57 arisen. Once ingested by organisms, as physico-chemical properties change, the myriad of 58 contaminants associated with MPs can desorb from the plastic and potentially become bioavailable 59 to organisms (Hartmann et al., 2017; Teuten et al., 2009; Engler, 2012). These co-contaminants may 60 threaten marine organisms when MPs become inadvertently ingested and transferred up the food 61 chain (Miller et al., 2020).

63 However, there remains some uncertainties regarding the actual risks associated with exposure to 64 MPs and associated co-contaminants. The relevance of MPs as vectors of has been challenged with 65 the argument that plastics play a minor role as contaminant vectors compared to natural particles, 66 such as suspended organic particles and natural prey, because of their relative abundance in the 67 environment (Koelmans et al., 2021; Koelmans et al., 2016; Besson et al., 2020). As a result, the 68 extent to which microplastics act as vectors of adsorbed pollutants is currently a matter of debate 69 and needs to be better understood in order to evaluate the potential response of marine 70 ecosystems to MPs exposure (Rodrigues et al., 2019). Improving our understanding of the 71 bioavailability of MPs-associated co-contaminants upon their ingestion by organisms remains a 72 prerequisite to accurately assess the importance of MPs as carriers of co-contaminants to marine 73 biota. To address this knowledge gap, the use of radiotracer techniques has been recently 74 recognised as a uniquely suited approach due to their rapidity, accuracy and sensitivity, allowing for 75 the study of the bioavailability of MP-associated chemicals within environmentally realistic 76 concentration ranges (Besson et al., 2020; Johansen et al., 2018; Lanctôt et al., 2018; Adhikari et al., 77 2022).

79 The Mediterranean sea urchin Paracentrotus lividus (Lamarck, 1816) was selected as a model 80 organism for this study because it is a keystone species in Mediterranean coastal ecosystems where 81 it plays a crucial ecological role (Boudouresque and Verlague, 2020). As a consequence of its 82 continuous benthic foraging activity, combined with its presence in highly anthropic areas, adult 83 specimens of *P.lividus* are potential targets of MPs accumulation in marine benthic ecosystems 84 (Manzo et Schiavo, 2022). Among the few studies that investigated the relationship between adult P. 85 lividus and microplastics, ingestion of MPs has been demonstrated (Parolini et al., 2020; Murano et 86 al., 2020; Murano et al., 2021; Porter et al., 2019; Hennicke et al., 2021) and small MPs (1-5 μm) 87 have been recently proven to be able to cross their intestinal wall and reach their coelomic fluid (Pyl 88 et al., 2022). Moreover, MPs have been shown to induce a slight modulation of oxidative status 89 (Parolini et al., 2020), as well as to impact the circulating immune cells (Murano et al., 2020; Murano 90 et al., 2021) of adults P. lividus. Nevertheless, no information is available to date on the potential

- 91 "vector" effect of co-contaminants adsorbed onto MPs using adult specimens of *P.lividus* as a model,
- 92 despite being recognised as an excellent model organism in marine ecotoxicology (Sugni *et al.*, 2013)
- 93 as well as species of great ecological and commercial importance (Pearse, 2006; Andrew et al.,
- 94 2002).
- 95
- 96 The objective of this present work is to assess the potential of microplastics to act as vector for the
- transfer of PCB-153 to sea urchins *P.lividus* using radiotracers. More specifically, the bioavailability of
 ¹⁴C-labelled PCB-153 sorbed onto negatively buoyant and relatively large polyethylene MPs, to sea
- 99 urchin tissues was investigated under different experimental conditions. A transfer efficiency (%) of
- ¹⁴C-PCB-153 was calculated to establish how much ¹⁴C-PCB-153, initially sorbed onto the MPs, was
- 101 transferred to sea urchins under the different experimental conditions.

102 Materials and Methods

- 104 105

1. Sampling of the sea urchins and acclimatation

106 Specimens of adult sea urchins (Paracentrotus lividus, Lamarck) were collected by divers in the Bay 107 of Villefranche-sur-mer (NW Mediterranean coastline, France) from mid-October 2020 to the end of 108 November 2020. This autumnal period corresponds to premature and beginning of gonadal 109 maturation of the sea urchins from the Bay of Villefranche-sur-mer (Fenaux, 1968). Prior to 110 experimentation, specimens were acclimated to laboratory conditions for at least one week in 111 constantly aerated open circuit aquaria, with natural seawater (salinity = 38‰, UV-sterilized and 1 112 μ m filtered) at 17 ± 0.5 °C, in a 12/12h dark/light cycle. Sea urchins were fed *ad libitum* every two 113 days with dry leaves of the algae Saccharina latissima, purchased from Biocean® during 114 acclimatation.

2. Radiotracer and microplastics (MPs)

¹⁴C-labelled congener IUPAC-153 (2,2',4,4',5,5'-hexachlorobiphenyl) was selected as representative of PCBs for this study as it is one of the most bioaccumulative and the most abundant congener in marine biota (Safe, 1994; Stebbing *et al.*, 1992) and is considered a good indicator of PCB levels in contaminant monitoring studies (Danis *et al.*, 2005). This β-emitting radiotracer, with a purity higher than 95%, was purchased from American Radiolabelled Chemicals[®], USA. The specific activity of this mother source was 12.6 mCi mmol⁻¹.

125 The MPs considered in this study were high density polyethylene microplastics (HDPE MP), as 126 polyethylene is the most common polymers found in the environment (Hidalgo-Ruz et al., 2012; 127 PlasticsEurope, 2020) with the highest adsorption capacity (Rochman, 2015). These HDPE MP were 128 microbeads purchased from Cospheric® as an isopheric homogeneous solid powder (size = 500-600 129 μ m; density = 1.2 g cm⁻³; containing black paramagnetic iron oxide; specific surface area = 9 m² kg⁻¹). 130 These microplastics were specifically selected for this study in order (1) to be available to benthic 131 organisms for ingestion as they are negatively buoyant and thus sink to the bottom of the aquarium, 132 (2) to avoid the use of surfactant with its potential interference in the adsorption processes, and (3) 133 for ease of visibility and detection. Preliminary tests showed that these microplastics are available to 134 sea urchins for ingestion as they were readily detected in the gut of the organisms. Further details 135 on the method and results of the verification of MPs uptake can be found in the Supplementary 136 Information section.

3. Experimental procedure

138 139

140 Three different experiments were conducted to assess whether ¹⁴C-PCB-153 adsorbed onto the 141 surface of MPs is bioavailable for the sea urchin *P.lividus* during 15 days : (1) exposure of *P. lividus* to 142 a low concentration of ¹⁴C-PCB-153 sorbed onto a high number of virgin (i.e. non-aged) MPs 143 ("lowPCB highMP" experiment), (2) exposure of *P.lividus* to a high concentration of ¹⁴C-PCB-153 144 sorbed onto a relatively low number of virgin MPs ("highPCB lowMP" experiment) and (3) exposure 145 to a low concentration of ¹⁴C-PCB-153 sorbed onto a relatively low number of aged MP ("lowPCB 146 lowMP" experiment). The concentrations of PCB-153 and amounts of MPs available per sea urchin 147 within the aquariums of each experiment were selected to ensure the detection of any transfer of 148 PCB-153 from MPs to sea urchin tissues while avoiding lethal effects.

149

150 The method applied for each experiment is composed of different phases, summarized as follows : 151 (1) adsorption of ¹⁴C-labelled PCB-153 onto MPs by applying the procedures described per Pyl et al. 152 (2021) (2) 15 days supremum of B // initial procedures and anter the surface of MDs.

152 (2021); (2) 15 days exposure of *P.lividus* to ¹⁴C-labelled PCB-153 adsorbed onto the surface of MPs;

153 (3) dissection of the organisms and the extraction of the radiotracer among the different body 154 compartments; (4) the use of β spectroscopy to determine the concentration of ¹⁴C-PCB-153 on the 155 particles and the distribution of PCBs within the different organs of the experimental model.

3.1. Adsorption of ¹⁴C-labelled PCB-153 onto MPs

- 159 The MPs used in the "lowPCB highMP" and in the "highPCB lowMP" experiment required the 160 preparation of solutions and their incubation in order to enable the adsorption of ¹⁴C-labelled PCB-161 153 onto the surface of MPs. For these two experiments, the adsorption of ¹⁴C-labelled PCB-153 162 onto MPs were achieved following the procedures described in Pyl et al. (2021) with adaptations 163 detailed in the Supplementary Information. The radio-labelled MPs were then gently transferred 164 from their vials to the bottom of the aquaria. The MPs used in the "lowPCB lowMP" experiment 165 were sampled at the end of the "highPCB lowMP" experiment from the bottom of the aquariums 166 using glass volumetric bulb pipettes (10 mL) combined with a pipette filler. These MPs were 167 collected in transparent containers, photographed, automatically counted using the software IMAGE 168 J, then placed at the bottom of each aquarium. In order to assess the stability of the ¹⁴C-PCB-153 169 concentration per MP and the potential leaching of ¹⁴C-labelled PCB-153, samples of MPs were 170 regularly collected and radioanalysed throughout the experiments. All sampling of MPs from the 171 bottom of the aquaria were performed using glass volumetric bulb pipettes (10 mL) combined with a 172 pipette filler. The average numbers and mass of MP available per aquaria at the beginning of the 173 three experiments are displayed in Table 1. Details related to preparation of PCB-loaded MPs are 174 reported in Supplementary Information.

3.2. Sea urchin exposure

178 All experiments were conducted in 20L capacity glass aquaria constantly aerated via an open circuit 179 (water renewal : 20L h⁻¹) with natural seawater (UV-sterilized and 1 μ m filtered, salinity = 38‰, pH = 180 8.1) at 16.4 ± 0.5 °C, in a 12/12h dark/light cycle. Sea urchins were fed every two days ad libitum 181 with dry leaves of the algae Saccharina latissima, purchased from Biocean®, during all experiments. 182 The duration of exposure of the sea urchin to MPs was 15 days. Within the experimental aquaria, 183 sea urchins were placed at the bottom in order to allow direct contact between the radioactive MPs 184 and the organisms. As presented in Figure 1, for the "highPCB lowMP" and "lowPCB lowMP" 185 experiments, one sea urchin was placed at the bottom of each exposure aquaria as enough 186 aquariums were available to maximise the number of true replications. However, as only three 187 exposure aquariums were available at the time of the "lowPCB highMP" experiment, three sea 188 urchins were placed in each aquarium to increase the number of replicates of the exposure 189 treatment (Figure 1). Moreover, control sea urchins were placed in a separated compartment 190 (termed "cage", made of polyethylene with a mesh size of 0.5 cm²) within one aquarium of each 191 experiment (Figure 1) to control possible cross-contamination through sea water via leaching of the 192 ¹⁴C-PCB-153 from MPs. Since the amount of ¹⁴C-PCB-153 sorbed onto the aged MPs used for the 193 "lowPCB lowMP" experiment was known to be stable (Figure S1) and contamination via leaching 194 deemed unlikely, one sea urchin placed in the "cage" was considered sufficient as a control. For the 195 "highPCB lowMP" and "lowPCB lowMP" experiments, as the amount of ¹⁴C-PCB-153 sorbed onto 196 virgin MPs was unknown to be stable, three sea urchins were placed in the "cage" within the control 197 aquarium to account for potential contamination via leaching (Figure 1).

- 3.2.1. **"LowPCB highMP" experiment :** exposure of *P.lividus* to a low concentration of ¹⁴C-PCB-153 sorbed onto a high number of virgin MPs
- For the "lowPCB highMP" experiment, twelve sea urchins *P.lividus* (ambital diameter 56 ± 2 mm) and four aquariums (three exposure and one control) filled with 10 L of seawater were used (Figure 1).

204 The entire water volume of each aquarium was renewed every 30 minutes during the 15 days of the 205 experiment. At the beginning of the experiment, 5143 (\pm 30) and 7550 (\pm 30) MPs, each 206 radiolabelled with 0.17 ng of ¹⁴C-PCB-153, were available at the bottom of each exposure aquarium 207 and in the control aquarium, respectively (Table 1). The difference in the initial abundance of MPs 208 between the control aquarium and the exposure aquariums is justified by the fact that the samples 209 of MPs, in order to control the stability of the PCB adsorbed on the MPs, were carried out only in the 210 control aquarium during the "lowPCB highMP" experiment. Based on both the initial concentration 211 of ¹⁴C-PCB-153 per MP and on the number of MPs per aquarium (corrected for t_0), a total amount of 212 871.56 (n=1) and 1279.51 (n=1) ng of ¹⁴C-PCB-153 was estimated to be available per exposure 213 aquarium and in the control aquarium respectively, at the beginning of the experiment (Table 1). 214 Once the MPs were deposited in the aquaria, the experiment was initiated by placing three sea 215 urchins at the bottom of each exposure aquarium, as well as three sea urchins within the cage of the 216 control aquarium (Figure 1). A total amount of 290.52 ng of ¹⁴C-PCB-153, loaded on an average 217 number of 1714 (± 10) MPs, were therefore available per sea urchin in direct contact with particles 218 at the beginning of the experiment (Table 1). As the "lowPCB highMP" experiment was the first to 219 assess the bioavailability of sorbed ¹⁴C-radiolabelled PCB onto MPs to marine organisms, both the 220 minimal concentration of PCB-153 per MP and minimal number of radiolabelled MPs needed to 221 ensure a detectable radiotracer signal following uptake and organ distribution by sea urchins was 222 unknown. Therefore, high amounts of MPs available per sea urchin (average of 1714 (± 10) MPs), 223 each radiolabelled with an average activity of 0.17 Bq (± 0.02, n=6), were selected to maximise the 224 chance to detect the potential transfer of the radiotracer onto the tissues of sea urchins while 225 avoiding lethal effects.

3.2.2. **"HighPCB lowMP" experiment :** exposure of *P.lividus* to a high concentration of ¹⁴C-PCB-153 sorbed onto a relatively low number of virgin MPs

230 For the "highPCB lowMP" experiment, nine sea urchins (ambital diameter 62 ± 2 mm) and seven 231 aquariums (six exposure and one control) filled with 20 L of seawater were used (Figure 1). The 232 entire volume of water in each aquarium was renewed every 60 minutes. At the beginning of the 233 experiment, 1185 (± 30) MPs, each radiolabelled with 0.49 (± 0.03, n=18) ng of ¹⁴C-PCB-153, were 234 available at the bottom of each experimental aquarium. Similarly, 1170 (± 30) MPs, each 235 radiolabelled with 0.68 (\pm 0.04, n=3) ng of ¹⁴C-PCB-153, were placed at the bottom of the control 236 aquarium (Table 1). Based on both the initial concentration of ¹⁴C-PCB-153 per MP and on the 237 number of MPs per aquarium (corrected for t0), a total amount of 575.93 (± 32.86, n=18) and 792.21 238 $(\pm 46.01, n=3)$ ng of ¹⁴C-PCB-153 was estimated to be available per exposure aquarium and in the 239 control aquarium, respectively, at the beginning of the experiment (Table 1). One sea urchin was 240 placed per exposure aquarium and three sea urchins were placed within the cage of the control 241 aquarium (Figure 1). A total amount of 575.93 (± 32.86, n=18) ng of ¹⁴C-PCB-153, loaded onto an 242 average number of 1185 (± 30) MPs, were therefore available per sea urchin in direct contact with 243 particles at the beginning of the "highPCB lowMP" experiment (Table 1).

3.2.3. **"LowPCB lowMP" experiment :** exposure to a low concentration of ¹⁴C-PCB-153 sorbed onto a relatively low number of aged MP

At the end of the "highPCB lowMP" experiment, the MPs were collected and reused for the "lowPCB lowMP" experiment. This implies that, unlike the MPs used for the two other experiments which were virgin, the MPs used for the "lowPCB lowMP" experiment were aged during 15 days. Solely MPs that were both (1) not contained in fecal pellets and (2) identical to virgin MPs (in terms of shape and size), were selected to be reused for the "lowPCB lowMP" experiment. This indicates that the aged MPs used in the "lowPCB lowMP" experiment did not pass through the digestive tract of sea urchins during the "highPCB lowMP" experiment. For the "lowPCB lowMP" experiment, five sea 255 urchins *P.lividus* (ambital diameter 58 ± 2 mm) and four aquariums filled with 20 L of seawater were 256 used (Figure 1). The entire water volume in each aquarium was renewed every 60 minutes. At the 257 bottom of each aquarium, an average number of 1216 MPs (± 8, n=4), each radiolabelled with 0.15 258 ng (\pm 0.02, n=12) of ¹⁴C-PCB-153, were available at the beginning of the experience (Table 1). Based 259 on both the initial concentration of ¹⁴C-PCB-153 per MP and on the number of MPs per sea urchin 260 (corrected for t_0), a total amount of 181.56 (± 22.15, n=12) ng of ¹⁴C-PCB-153 was estimated to be 261 available per aquarium just prior to the beginning of the experiment (Table 1). One sea urchin was 262 placed at the bottom of each aquarium and one control sea urchin was placed in the cage within the 263 first aquarium (Figure 1). A total amount of 181.56 (± 22.15, n=12) ng of ¹⁴C-PCB-153, loaded on an 264 average number of 1216 (± 8, n=4) MPs, were therefore available per sea urchin in direct contact 265 with particles at the beginning of the "lowPCB lowMP" experiment (Table 1). 266

4. Dissection

268 269 After 15 days of exposure, all specimens were collected and rinsed abundantly with UV-sterilized 1 270 µm filtered sea water in order to remove potential MPs in contact with the tegument and the 271 peristomial membrane. The sea urchins were then measured, weighed, and sacrificed by cold 272 exposure. The test of the sea urchin was then cut following the ambital diameter. Two mL of 273 coelomic liquid were sampled and directly poured into a scintillation vial for radiocounting. Then, 274 the entire digestive tract, from the oesophagus to the anus was collected, cut longitudinally and 275 abundantly rinsed with sea water in order to remove all the digestive content and potentially 276 ingested MPs. Once devoid of digestive content, the digestive tract walls were collected in 277 scintillation vials and weighed. Then, the gonads and Aristotle's lantern were sampled, rinsed with 278 sea water, collected in scintillation vials and weighed. The sex of the specimen, determined based on 279 the colour of the gonadal fluid, as well as the wet weight of the entire tegument including the spines 280 were recorded. A small piece of tegument was then cut and weighed before and after the removal of 281 its spines. Once weighed and the spines removed, the fragment of tegument was transferred into a 282 scintillation vial and cut into very small pieces for radiocounting. The dissection tools (scalpel, 283 scissors, tweezers) were systematically decontaminated, both between the collection of different 284 organs from the same urchin, and between the dissection of different urchins. To be 285 decontaminated, tools were immersed successively into ethanol and osmotic water, then were left 286 to dry before reuse.

5. Sample treatment and liquid scintillation counting

290 Radioactivity in samples was determined using a liquid scintillation counting method. While MPs and 291 water samples were shortly analysed after the addition of 10 mL of Ultima Gold XR[®] (PerkinElmer[®]) 292 scintillation liquid into the counting vials (PerkinElmer®), biological samples required preparation 293 before counting. The extraction of ¹⁴C-PCB-153 from the four body compartments (digestive wall, 294 gonads, Aristotle's lantern, and fragment of tegument) of the sea urchins was conducted by applying 295 the methods described in Danis et al. (2005). A schematic diagram of the sample treatment is shown 296 in Figure 2. First, samples were ultrasonicated twice at room temperature for 10 minutes, each time 297 with 2 mL of Acetonitrile® (Sigma-Aldrich®). The 4 mL of Acetonitrile® was mixed with 16 mL of 298 filtered sea water contained within a glass tube (23 mL capacity, Fisher®). This treatment produced, 299 for each sample, 20 mL of liquid phase containing the extracted ¹⁴C-PCB-153 and a residue.

300

301The residue was digested with 2 mL of Soluene® (PerkinElmer®) at 70°C for 24h. Then, 10 mL of302Hionic Fluor® (PerkinElmer®) scintillation liquid was added in each vial containing residue for303counting.

305 From the liquid phase, ¹⁴C-PCB-153 was extracted twice, using 2 mL of n-Hexane® each time 306 (Fisher®). To do so, 2 mL of n-Hexane® was added and mixed by vortex to the liquid phase of each 307 tube. Prior to vortexing, the top of the tube was tightly wrapped with parafilm to prevent splashing 308 of radioactive material. This treatment produced an organic phase (2 mL) and an aqueous phase (20 309 mL). The organic phase (2 mL) was collected within a scintillation vial, and the extraction operation 310 was repeated a second time. To do so, another 2 mL of n-Hexane® was added to the liquid phase of 311 each tube, mixed by vortex, and extracted. The organic phase from the second extraction (2 mL) was 312 combined with the first (2 mL) within the scintillation vial and 10 mL of Ultima Gold XR® scintillation 313 liquid was added. Finally, 2 mL of the aqueous phase was collected in another scintillation vial and 314 mixed with 10 mL of Ultima Gold XR[®] scintillation liquid.

315

316 Once the scintillation liquid was added to all radioactive samples, they were thoroughly mixed to 317 homogenize the solution and kept in the dark for 24 h before radio counting. Maintaining samples in 318 the dark for 24 hours before counting limited the phenomena of photoluminescence (potentially produced by the scintillation cocktail) as it decays in the dark. ¹⁴C-radioactivity was then measured in 319 320 the samples using a Tri-Carb 4910 TR liquid scintillation counter (PerkinElmer®), compared to 321 standards of known activities, and measurements were corrected for counting efficiency, physical 322 radioactive decay and quenching effects (Metian et al., 2019). Counting times were adapted to 323 obtain counting rates with relative propagated errors less than 5% (maximal counting duration was 324 90 min). 325

6. Data analyses

328 The total amount of ¹⁴C-PCB-153 (ng) accumulated per *P. lividus* body compartment was obtained by 329 summation of the amounts of ¹⁴C-PCB-153 (ng) measured within the samples of organic phase, of 330 the aqueous phase and of Soluene® of the body compartment (cfr section 3.4). The total amount of 331 ¹⁴C-PCB-153 (ng) accumulated by the whole body wall, as well as by the coelomic fluid, were 332 estimated by extrapolating the amount of ¹⁴C-PCB-153 (ng) measured in the sub-samples to the 333 weight of the total body wall, or to the entire volume of coelomic fluid, respectively. As the sampling 334 of 0.5 mL of coelomic fluid represents about 2.5% of the total volume of *P.lividus* individuals of 335 similar size (Collard et al., 2013), the total volume of coelomic fluid per sea urchin was assumed to 336 be 20 mL in this work.

The concentrations of ¹⁴C-PCB-153, reported as ng g_{dw}^{-1} or ng g_{lipids}^{-1} , were calculated for each sea urchin body compartment by dividing the total amount of ¹⁴C-PCB-153 (ng) accumulated into the body compartments by its dry weight (g_{dw}) or its total lipid content (g_{lipids}). The total lipid contents of the experimental body compartments were determined on the basis of their dry weight (g_{dw}) and on the average total lipid content determined gravimetrically on lyophilized powder with hexane:dichloromethane (1:1) in prior experiments. Further details on the method and results of the total lipid content analyses can be found in the Supplementary Information.

As the objective of this study was to evaluate the potential of MPs to act as vectors of PCBs into sea urchins, as a result of direct physical contact with the particles or as a result of the ingestion of particles, the potential part of ¹⁴C-PCB-153 accumulation due to the contamination via seawater, as a result of the leaching of the particles, was removed. To do so, the average concentrations of ¹⁴C-PCB-153 (ng g_{dw}^{-1} or ng g_{upds}^{-1}) measured in the control sea urchins were subtracted from the concentrations measured for the sea urchins which had been in contact with the microplastics for all the body compartments (digestive wall, gonads, Aristotle's lantern, body wall, and coelomic fluid).

The distribution of 14 C-PCB-153 (%) among the body compartments was calculated, for each sea urchin in contact with the MPs, by reporting the amount of 14 C-PCB-153 (ng) measured within the various body compartments (digestive wall, gonads, Aristotle's lantern, body wall, and coelomicfluid) by their sum, while taking into account the weighted contribution of each compartment.

358

The transfer efficiency of ¹⁴C-PCB-153 (%) was calculated, for each sea urchin in contact with the MPs, by reporting the sum of the amount of ¹⁴C-PCB-153 (ng) measured within of the various body compartments (digestive wall, gonads, Aristotle's lantern, body wall, and coelomic fluid) by the total amount of ¹⁴C-PCB-153 available per sea urchin on average over the 15 days of exposure (ng).

363

364 Statistical analyses were performed using R statistical software (R Development Core Team), with a 365 significance level of α =0.05 for all analyses. Normality of the data and homoscedasticity were 366 evaluated using Shapiro-Wilk's test and Levene's test, respectively. When the normality and 367 homoscedasticity of the data could be assumed, parametric analyses were conducted to identify 368 significant differences in the dataset. In particular, comparisons were conducted using a 1-way 369 ANOVA analysis followed by a Tukey's pairwise test, while Pearson's tests were used to look for 370 relationships. In contrast, when the data did not satisfy the assumption of normality and/or 371 homoscedasticity, the non-parametric Kruskal–Wallis tests for multiple comparisons, and the post-372 hoc Dunn tests with Bonferroni corrections for pairwise comparisons were conducted.

374 Results

1. ¹⁴C-PCB-153 sorbed onto MPs during the 15 days exposure

The concentration of ¹⁴C-PCB-153 sorbed onto MPs was monitored over the 15 days of exposure. In the "lowPCB highMP" and "highPCB lowMP" experiments, the ¹⁴C-PCB-153 concentrations per MP decreased linearly and exponentially as a function of time, respectively. Over the course of the "lowPCB lowMP" experiment, the amount of ¹⁴C-PCB-153 sorbed onto MPs remained constant throughout the 15 days exposure (Table 2). Parameters and statistics of kinetics, as well as further details on the calculations and statistical results can be found in the Supplementary Information (Figure S1; Table S3).

385

As leaching of ¹⁴C-PCB-153 from the MPs occurred in the "lowPCB highMP" and "highPCB lowMP" experiments, the average ¹⁴C-PCB-153 concentration per MP over the 15 days exposure has been taken into account for the rest of the calculations, and the total amounts of ¹⁴C-PCB-153 available per sea urchin through the three experiments have been recalculated accordingly (Table 2). In order to correctly assess the accumulation of ¹⁴C-PCB-153 within the sea urchin body due to direct contact with MPs, any contamination via seawater as a result of the leaching of the particles was quantified using control specimens and removed accordingly.

393

394 On average over the entire duration of the "lowPCB highMP" experiment, an amount of $0.13 (\pm 0.02,$ 395 n = 6) ng of ¹⁴C-PCB-153 was concentrated per MP (Table 2). An average number of 5143 MPs (± 30) 396 and of 4320 MPs (± 1151, n = 6) were available per experimental aquarium and in the control 397 aquarium, respectively. Based on both the average ¹⁴C-PCB-153 concentration per MP and on the 398 quantity of MPs available per aquarium over the 15 days exposure, a total amount of 681.86 ng (± 399 92.35, n = 6) and 572.75 ng (\pm 77.57, n = 6) of ¹⁴C-PCB-153 was estimated to be available per 400 experimental aquarium and in the control aquarium, respectively (Table 2). The total amount of ¹⁴C-401 PCB-153 available per aquarium during the "lowPCB highMP" experiment was not significantly 402 different between aquariums (1-way Anova, p-val = 0.998). Therefore, the twelve sea urchins in the 403 "lowPCB highMP" experiment were all exposed to comparable ¹⁴C-PCB-153 levels. On average, over 404 the duration of the experiment, a total amount of 227.29 ng (\pm 30.78, n = 6) of ¹⁴C-PCB-153, loaded 405 on an average number of 1714 (± 30) MPs, was available per sea urchin in contact with the MPs 406 (Table 2).

407 408 On average over the entire duration of the "highPCB lowMP" experiment, an amount of 0.35 (± 0.01, 409 n = 120) ng of ¹⁴C-PCB-153 was available per MP (Table 2). In addition, throughout this experiment, 410 an average of 1156 MPs (± 4, n = 28) and 1065 MPs (± 26, n = 8) were available per experimental 411 aquarium and in the control aquarium, respectively. Based on both the average ¹⁴C-PCB-153 412 concentration per MP and on the quantity of MPs available per aquarium over the 15 days exposure, 413 a total amount of 394.49 ng (\pm 16.36, n = 84) and 407.06 ng (\pm 39.86, n = 24) of ¹⁴C-PCB-153 was 414 estimated to be available by experimental aquarium and in the control aquarium, respectively (Table 415 2). On average, during the 15 days of exposure, the total amount of ¹⁴C-PCB-153 available per 416 aquarium was not significantly different between aquariums (Kruskal-Wallis X²₆= 3.854, p-val = 417 0.697). Therefore, the six sea urchins in contact with the MPs during the "highPCB lowMP" 418 experiment were all exposed to comparable ¹⁴C-PCB-153 levels. On average, over the duration of the 419 experiment, a total amount of 394.49 (± 16.36, n = 84) of ¹⁴C-PCB-153, loaded on an average number 420 of 1156 (± 4, n=28) MPs, was available per sea urchin in contact with the MPs (Table 2). Finally, on 421 average during the 15 days of exposures, the total amount of ¹⁴C-PCB-153 per sea urchin was higher 422 during the "highPCB lowMP" experiment compared to the "lowPCB highMP" experiment (Dunn test, 423 p-val = 0.001).

424

425 On average over the duration of the "lowPCB lowMP" experiment, 1201 MPs (± 5, n = 12) were 426 available per sea urchin in direct contact with MPs. Since on average over the entire duration of the 427 experiment, an amount of 0.14 (± 0.01, n = 36) ng of ¹⁴C-PCB-153 was available per MP, this implies 428 that a total amount of 172.71 (\pm 9.12, n = 36) of ¹⁴C-PCB-153 was available per aquarium (Table 2). 429 On average, during the 15 days of exposure, the total amount of ¹⁴C-PCB-153 available per aquarium 430 was not significantly different between aquariums (Kruskal-Wallis $X_3^2 = 2.782$, p-val = 0.427). 431 Therefore, the four sea urchins in contact with the MPs during the "lowPCB lowMP" experiment 432 were all exposed to comparable ¹⁴C-PCB-153 levels. Finally, on average during the 15 days of 433 exposure, the total amount of ¹⁴C-PCB-153 per sea urchin during the "lowPCB lowMP" experiment was lower than that of the "highPCB lowMP" experiment (Dunn test, p-val = 3.3×10^{-12}) but not of the 434 435 "lowPCB highMP" experiment (Dunn test, p-val = 0.113) (Table 2).

2. Concentration of ¹⁴C-PCB-153 accumulated in sea urchin tissues (in ng g_{uu}^{-1} and in ng g_{uu}^{-1})

440 No sea urchin mortality was detected, nor was there any evidence of a spontaneous spawning event 441 during the course of the three experiments. Based on daily observations, the sea urchins displayed 442 optimal health conditions (e.g. climbing ability, straightened spines) throughout the exposure period 443 of all experiments. It was noted that the sea urchins used in the "lowPCB highMP" experiment (three 444 sea urchins per aquarium) were more mobile (i.e. increased displacement) during the whole 445 experiment than the sea urchins used in the "highPCB lowMP" and the "lowPCB lowMP" 446 experiments (one sea urchin per aquarium).

447

448 The transfer of ¹⁴C-PCB-153 from MPs to sea urchin tissues occurred in each of the three 449 experiments and in every body compartment (except in the body wall and Aristotle's lantern of sea 450 urchins from the "lowPCB lowMP" experiment, see Figure 3). Over the exposure period of the three 451 experiments, the digestive wall and the gonads concentrated ¹⁴C-PCB-153 to the highest degree, 452 reaching mean concentrations up to 18.76 and 28.39 ng g^{-1} dry weight (ng g_{dw}^{-1}), respectively (Figure 453 3). For all experiments, ¹⁴C-PCB-153 was concentrated to a similar degree in the digestive wall and in the gonads (ng g_{dw}^{-1} ; Dunn test, p-val_{"lowPCB highMP"exp} = 1, p-val_{"highPCB lowMP" exp} = 1, p-val_{"lowPCB lowMP" exp} = 1, p-val_{"lowPCB lowMP" exp} = 1, p-val_{"lowPCB lowMP" exp} = 1, p-val_{"lowPCB lowMP" exp} = 1, p-val_{"lowPCB lowMP} = 1, p-val_{"lowPCB lowPCB lowPCB low}}} 454 455 1).

457 For the "lowPCB highMP" experiment, since there is no significant difference in terms of body 458 concentration of ¹⁴C-PCB-153 (ng g_{lipids}^{-1} and ng g_{dw}^{-1}) between aquariums (Kruskal-Wallis $X_{2}^{2} = 2.328$, 459 p-val = 0.312), individuals from the same aquarium were considered as replicates in our calculations. 460 During this experiment, both the digestive wall and gonads did concentrate significantly more ¹⁴C-461 PCB-153 than the Aristotle's lantern and the coelomic fluid (ng g_{dw}^{-1} ; Figure 3A; Dunn test, p-val_{TD-AL} = 0.042, p-val_{GON-AL} = 0.018, p-val_{TD-LC} = 8.1×10^{-05} , p-val_{GON-LC} = 2.4×10^{-05}). In addition, the average ¹⁴C-462 463 PCB-153 concentration of the body wall was not significantly different when compared to other 464 body compartments (ng g_{dw}^{-1} ; Figure 3A; Dunn test, p-val_{TEG-TD} = 0.372, p-val_{TEG-GON} = 0.195, p-val_{TEG-AL} 465 = 1, p-val_{TEG-LC} = 0.173). During the "highPCB lowMP" experiment, ¹⁴C-PCB-153 was concentrated to a 466 similar degree in digestive wall, gonads and Aristotle's lantern (ng g_{dw}⁻¹; Figure 3B; Dunn test, p-val_{TD-} 467 $_{GON}$ = 1, p-val_{TD-AL} = 0.188, p-val_{GON-AL} = 0.681). Moreover, for this experiment, the ¹⁴C-PCB-153 468 concentration of the digestive wall was significantly higher than body wall and coelomic fluid (ng 469 g_{dw}^{-1} ; Figure 3B; Dunn test, p-val_{TD-TEG} = 0.019; p-val_{TD-LC} = 0.0003), whereas the gonads did not 470 concentrate significantly more ¹⁴C-PCB-153 than the body wall but significantly more than the 471 coelomic fluid (ng g_{dw}^{-1} ; Figure 3B; Dunn test, p-val_{GON-TEG} = 0.099; p-val_{GON-LC} = 0.002). For the 472 "lowPCB lowMP" experiment, ¹⁴C-PCB-153 was concentrated to different levels in body compartments (Kruskal-Wallis X_4^2 = 13.004, p-val = 0.011), but pairwise multiple comparison 473 474 analyses were inconclusive (ng g_{dw}^{-1} ; Figure 3C; Dunn test with p-values all > 0.05; Table S4).

475

476 When the concentrations of ¹⁴C-PCB-153 were expressed in ng g⁻¹ total lipids, the digestive wall 477 concentrated ¹⁴C-PCB-153 to the highest degree over the exposure period of the three experiments, 478 reaching mean concentrations up to 464.53 ng g⁻¹ total lipids (Figure 3). However, no significant 479 difference was found between the body compartments of the sea urchins from the "lowPCB highMP" experiment (ng g_{lipids}^{-1} ; Figure 3D; Kruskal-Wallis $X_2^2 = 1.79$, p-val = 0.409). For the "highPCB 480 lowMP" experiment, the digestive wall was found to concentrate significantly more ¹⁴C-PCB-153 481 482 than the gonads (ng g_{lipids}^{-1} ; Figure 3E; Dunn test, p-val_{TD-GON} = 0.014). In addition, no significant 483 difference was found between the ¹⁴C-PCB-153 concentrations of the digestive wall and Aristotle's 484 lantern (ng g_{lipids}^{-1} ; Figure 3E; Dunn test, p-val_{TD-AL} = 0.303), nor between the Aristotle's lantern and 485 gonads (ng g_{lipids}⁻¹; Figure 3E; Dunn test, p-val_{AL-GON} = 0.236). For the "lowPCB lowMP" experiment, 486 digestive wall did concentrate significantly more ¹⁴C-PCB-153 than the Aristotle's lantern (ng g_{lipids}⁻¹; 487 Figure 3F; Dunn test, p-val_{TD-AL} = 0.044), whereas the concentration of these two compartments was 488 not significantly different than the gonads (ng g_{lipids}^{-1} ; Figure 3F; Dunn test, p-val_{TD-GON} = 1, p-val_{AL-GON} 489 = 0.202).

3. Assessment of the body distribution of the accumulated ¹⁴C-PCB-153

495 The body wall, digestive wall and gonads displayed the highest proportions of accumulated ¹⁴C-PCB-496 153 for all experiments, except for the "lowPCB lowMP" experiment where ¹⁴C-PCB-153 was not 497 found to concentrate within the body wall (Figure 3). For all experiments, the body distribution of 498 ¹⁴C-PCB-153 was not significantly different among the body wall, digestive wall, and gonads (p-values 499 of Dunn test were all > 0.05; Tables S5a, S5b, S5c). For the "lowPCB highMP" experiment, the 500 average proportion of ¹⁴C-PCB-153 accumulated by the body wall was not significantly higher than 501 that of the digestive wall or gonads (Figure 3G; Dunn test, p-val_{TEG-TD} = 1, p-val_{TEG-GON} = 1), but 502 significantly higher than that of the Aristotle's lantern and coelomic fluid (Figure 3G; Dunn test, p-503 $val_{TEG-AL} = 0.003$, p-val_{TEG-LC} = 0.001). Moreover, in this experiment, the average proportions of ¹⁴C-504 PCB-153 accumulated by the digestive wall and by the gonads were significantly higher than that of 505 coelomic liquid (Figure 3G; Dunn test, p-val_{TD-LC} = 0.031, p-val_{GON-LC} = 0.040), but not that of Aristotle's 506 lantern (Figure 3G; Dunn test, p-val_{TD-AL} = 0.105, p-val_{GON-AL} = 0.129). For the "highPCB lowMP" experiment, the average proportion of ¹⁴C-PCB-153 contained in the digestive wall and gonads were 507

508 not significantly higher than that of the body wall and Aristotle's lantern (Figure 3H; Dunn test, p-509 $val_{TD-TEG} = 1$, $p-val_{GON-TEG} = 1$, $p-val_{TD-AL} = 0.079$, $p-val_{GON-AL} = 0.530$), but higher than that of the 510 coelomic fluid (Figure 3H; Dunn test, p-val_{TD-LC} = 0.001, p-val_{GON-LC} = 0.016). In this experiment, the 511 distribution of ¹⁴C-PCB-153 was not significantly different between the body wall, Aristotle's lantern 512 and coelomic fluid (Figure 3H; Dunn test, p-val_{TEG-AL} = 1, p-val_{TEG-LC} = 0.236, p-val_{AL-LC} = 1). For the 513 "lowPCB lowMP" experiment, the distribution of ¹⁴C-PCB-153 was different between the different 514 body compartments (Kruskal-Wallis X_4^2 = 13.614, p-val = 0.009), but pairwise multiple comparison 515 analyses are inconclusive (Figure 3I; all p-values of Dunn test were all > 0.05; Table S5c).

4. Assessment of the transfer efficiency of MP-loaded ¹⁴C-PCB-153 to sea urchin tissues

520 For the "lowPCB highMP" experiment, an average value of 10.41 % (± 2.28, n = 9) of ¹⁴C-PCB-153 was 521 transferred from the MPs to the body compartments of the sea urchins collected. Since there is no 522 significant difference in terms of transfer efficiency between the aquariums of the first experiment 523 (1-way ANOVA, p-val = 0.348), all individuals from the same aquarium were considered as replicates 524 in our calculations. The sea urchins from "highPCB lowMP" and "lowPCB lowMP" experiments 525 accumulated on average 1.95% (\pm 0.53, n = 6) and 0.39% (\pm 0.09, n = 4) of the ¹⁴C-PCB-153 adsorbed 526 on the MPs, respectively. Even though the three experiments were not directly comparable because 527 of the differences in their experimental setup, the average transfer efficiency of ¹⁴C-PCB-153 from 528 MPs to body compartments of sea urchins in the "lowPCB highMP" experiment was notably higher 529 than that of the "highPCB lowMP", which in turn were found to be higher than the "lowPCB lowMP" 530 experiment. The transfer efficiency of ¹⁴C-PCB-153 in urchins increased with the amount of ¹⁴C-PCB-531 153 available in the aquarium ($F_{1.17}$ = 36.802, p-val = 1.258x10⁻⁰⁵, Figure 4).

532

533 Discussion

534

535 Although globally banned since the 1980's, polychlorinated biphenyls (PCBs) still persist in the 536 marine environment (e.g. Beyer and Biziuk, 2009; Reddy et al., 2019) and are omnipresent on 537 microplastics from all over the world (Ohgaki et al., 2021). In the present work, the most abundant 538 PCB congener in marine biota (i.e. PCB-153) was shown to be transferred and accumulated by sea 539 urchins from MPs in all experiments. These findings indicate that the ¹⁴C-PCB-153 adsorbed onto the 540 MPs was bioavailable to sea urchins in direct contact with MPs and suggest that MPs located on the 541 seafloor may act as vectors of PCB-153 contamination for sea urchins even during short-term 542 exposure periods of only fifteen days. Moreover, the fact that a transfer of radiolabelled PCB-153 543 occurred in the three experiments suggest that the concentration gradient of PCB-153 was negative 544 during each experiment (i.e., higher in MPs than in biological tissues), even though levels of native 545 PCB-153 contained within urchins upon sampling were not analysed in this work.

546 While this work constitutes the first study on the potential "vector" effect of MPs using adult sea 547 urchins, previous studies have also found a transfer of PCB sorbed onto MPs to biological tissues of 548 seabird chicks (Teuten et al., 2009), lobsters (Devriese et al., 2017), goldfish (Grigorakis and 549 Drouillard., 2018), lugworms (Besseling et al., 2013; 2017), while no transfer of PCB-153 from MPs 550 was found into herring larvae (Norland et al., 2021). The studies that compared the MP-mediated 551 uptake of PCBs to natural bioaccumulation pathways agreed that MP would be a minor contribution 552 to total bioaccumulation comparatively to natural environmental uptake pathways (Devriese et al., 553 2017; Grigorakis and Drouillard., 2018; Besseling et al., 2013; 2017). Overall, there seems to be a 554 growing consensus among various research groups that microplastics in the environment would 555 have minor effects on bioaccumulation of associated chemicals in organisms (Koelmans et al., 2021; 556 2016; Besseling et al., 2013; 2017; Bakir et al., 2016; Beckingham et al., 2017; Devriese et al., 2017; 557 Grigorakis and Drouillard., 2018). In contrast, it has been recently suggested that the current 558 estimates of marine total plastic load could have been greatly underestimated (Lindeque et al., 559 2020), making the abundance of plastic debris and their relative importance compared to natural 560 particles still unknown. Another challenge of clarifying the uncertainties regarding the importance of 561 MPs as carriers of co-contaminants to marine biota is the lack of consistent approaches between 562 experimental methodologies, making direct comparison difficult if not impossible. Similar to the 563 need of applying standard guidelines and procedures when studying the sorption-desorption kinetics 564 of chemicals bound to MPs and natural particles (Pyl et al., 2021), there is an urgent need to 565 standardise the metrics for the assessment of bioaccumulation when experimentally testing the 566 importance of MPs as carriers of co-contaminants to marine biota (see Besseling et al., 2017 for 567 comparison between different bioaccumulation metrics). The establishment of standardised 568 methods and guidelines would give rise to improvement of the comparability between studies of 569 different research groups, leading towards clarification regarding the uncertainty of the vector 570 effects of MPs on bioaccumulation.

571

572 Among the three experiments carried out in this work, the sea urchins exposed to a low 573 concentration of ¹⁴C-PCB-153 sorbed onto a high number of virgin MPs (i.e. "lowPCB highMP" 574 experiment) were found to accumulate ¹⁴C-PCB-153 to the highest degree (Figure 3). This could be 575 explained by the fact that the average amount of ¹⁴C-PCB-153 available per aquarium throughout 576 this experiment was higher than for the two other experiments. Three sea urchins were placed in 577 each exposure aquarium in the "lowPCB highMP" experiment, which when compared to a single sea 578 urchin in the two other experiments, results in reasonably similar ¹⁴C-PCB-153 amount per urchin 579 across all experiments. However, the individuals in the "lowPCB highMP" experiment had potential 580 contact with a much greater number of MPs within the aquarium, which could explain the higher 581 ¹⁴C-PCB-153 accumulation in these individuals. Moreover, the high MP-mediated transfer of ¹⁴C-PCB-582 153 that occurred in the "lowPCB highMP" experiment could also be related to the observed higher 583 mobility of the individuals in the aquarium compared those in the other two experiments. We 584 speculate that a high mobility could be due to inter-individual competition for food, that would lead 585 to a high grazing activity of *P. lividus*.

586

587 The sea urchins from the "lowPCB lowMP" experiment that were exposed to 15 days aged MPs were 588 found to accumulate ¹⁴C-PCB-153 to the lowest degree when compared to the sea urchins from the 589 "lowPCB highMP" and "highPCB lowMP" experiments that were exposed to virgin MPs. The low 590 transfer of PCB from MPs to sea urchin during the "lowPCB lowMP" is most likely due to the fact that 591 the average amount of ¹⁴C-PCB-153 available per aquarium throughout this experiment was lower 592 than for the two other experiments. The variation of PCB accumulation in sea urchins from 15 days 593 aged MPs (potentially coated with a biofilm) compared to virgin particles could be attributed to the 594 difference in surface coating. Porter et al. (2019) showed that the grazing activity of P. lividus onto 595 macroplastics was significantly higher when the plastic surface was biofouled rather than "clean" 596 (i.e. not fouled). These authors also observed the highest grazing activity when sea urchins were 597 exposed to both biofouled macroplastics and kelp simultaneously, which is in disagreement with our 598 results of transfer. Our findings of transfer are also in contradiction with the statement that aged 599 MPs would constitute a higher uptake pathway than virgin MPs, both given their higher absorbance 600 capacity of co-contaminants (Johansen et al., 2018) and their higher likelihood to be ingested by 601 organisms as they may not be recognised as inorganic matter (Fabra et al., 2021; Vroom et al., 2017; 602 Porter et al., 2019). However, it is noteworthy that the MPs used in our "lowPCB lowMP" 603 experiment were contaminated by PCB-153 before being left for 15 days to age in sea water, 604 whereas the MPs used the previously cited work were contaminated by co-contaminants after the 605 aging process. We speculate that aging the MPs prior to their contamination by co-contaminant, 606 rather than aging the particles while the sorption of the co-contaminant already occured, makes the 607 sorbed co-contaminant more available to biological tissues upon ingestion by organisms. To test this hypothesis, further work comparing the bioavailability of chemicals loaded onto the two types of
 aged MPs is required. Nevertheless, our results suggest that PCB-loaded MPs, aged in a non contaminated conditions are still a potential source of PCB-153 upon their ingestion by organisms.

612 Over the exposure period of the three experiments, digestive wall and the gonads concentrated ¹⁴C-PCB-153 (ng g_{dw}^{-1}) to the highest degree. As PCB-153 is a highly hydrophobic and lipophilic 613 compound, the higher ¹⁴C-PCB-153 concentrations (ng g_{dw}^{-1}) in the sea urchin gonads and digestive 614 615 walls compared to other body parts is probably related to the highest lipid content obtained for these two compartments. The lipidic concentrations of ¹⁴C-PCB-153 (ng g_{lipids}⁻¹) indicates that the 616 617 digestive wall incorporated ¹⁴C-PCB-153 to the highest degree over the exposure period of the three 618 experiments, suggesting that the primarily uptake pathway of ¹⁴C-PCB-153 could be attributed to the 619 ingestion of MPs. This is in accordance with Danis et al. (2005) showing that the digestive wall of 620 P.lividus displayed the highest concentrations of ¹⁴C-PCB-153 (ng g_{lipids}⁻¹) when individuals were 621 exposed via food. Overall, the fact that the digestive wall is the predominant compartment for body 622 transfer of ¹⁴C-PCB-153 from MPs is likely due to the proximity of ingested MPs to the digestive walls 623 for a long period of time. Furthermore, we speculate that the transit of PCB-loaded MPs through the 624 slightly alkaline environment of the sea urchin gut (pH between 6.4 and 7.3; Claereboudt and 625 Jangoux, 1985), coupled with digestive enzymes (Trenzado et al., 2012) and microbiome activity 626 (Meziti et al., 2007) favoured the desorption of ¹⁴C-PCB-153 from MPs as well as its bioaccumulation 627 into biological tissues.

628

Although the ${}^{14}C$ -PCB-153 concentrations (ng g_{dw}^{-1}) and proportions (%) indicate that dermal 629 630 sorption of ¹⁴C-PCB-153 from MPs was the secondary route of transfer during the "lowPCB highMP" 631 and "lowPCB highMP" experiments, this was not the case for the "lowPCB highMP" experiment, 632 where the body walls of urchins incorporated higher proportions of ¹⁴C-PCB-153 than the gonads 633 and digestive wall. We speculate that these higher proportions of ¹⁴C-PCB-153 accumulated by the 634 body wall during this experiment, compared to the two other experiments, might be due to more 635 physical contact between the tegument and particles as a result of the high mobility of sea urchins 636 observed during the "lowPCB highMP" experiment.

637

638 In this work, the ¹⁴C-PCB-153 concentrations based on the total lipids contents did not allow to 639 better discriminate between the different body compartments than the concentrations expressed in 640 terms of dry weight. We hypothesize that a longer exposure time could trigger a predominant 641 accumulation of ¹⁴C-PCB-153 within the body compartments containing the highest lipid contents 642 (such as gonads), which could potentially lead to a better discrimination between the different body 643 compartments. To test this hypothesis, further work investigating the influence of exposure time on 644 the lipidic accumulation of PCB-153 is required. This is probably due to the fact that the total lipid 645 contents were determined prior to experiments on individuals other than those exposed in this 646 study, whereas the dry weights of each body compartment of exposed sea urchin were measured as 647 part of the sample processing. Biological samples were not available in sufficient quantities to enable 648 both the analysis of their total lipid content and their ¹⁴C-radioactivity measure in this work. In order 649 to strengthen the findings of future studies, it is advised to analyse the total lipid content of every 650 body compartment from every organism used experimentally when biological samples are available 651 in sufficient quantities. It is also encouraged for future work to continue to express the PCB 652 concentrations based on the total lipids content given the lipophilicity of the contaminants. In 653 addition, the PCB concentrations expressed on a total lipid content basis are particularly valuable 654 information given the seasonal transferability of lipids, and their associated contaminants, across the 655 body parts observed for various organisms including for Paracentrotus lividus (Fernandez, 1997; 656 Rocha et al., 2019; Anedda et al., 2021). In general for Paracentrotus lividus, the highest lipids 657 content corresponds to a prevalence of recovery gametogenic stage (accumulation of reserves 658 during the summer season), and the lowest lipids content in gonads corresponds to a high

- occurrence of mature gametogenic stages (reserves used for gamete development during the winter
 season) (Fernandez, 1997; Anedda *et al.*, 2021). In order to investigate the seasonality of the MP mediated transfer of PCB, further work mimicking the present study while using adult *P.lividus* in a
 different gonadic maturation stage than ours is required.

Although the transfer efficiency of PCB appears to increase with the PCB amount available to urchins throughout the experiments (Figure 4), the high variability of transfer efficiencies observed at high PCB budgets suggests that further investigation is needed to clarify this trend. Transfer efficiencies cannot exceed 100% and PCB accumulation could be regulated by the urchins. For instance, Danis et al. (2005) showed a decrease of PCB-153 concentration in *P. lividus* tissues during the depuration phase of exposures, indicating the existence of detoxification mechanisms in these organisms.

671

672 The MP-mediated uptake of ¹⁴C-PCB-153 into sea urchin tissues, even in the case of the highest 673 concentration on the HDPE particles, did not induce any lethal effects or any other external sign of 674 unhealthy condition during the 15 day exposures. This is in line with Devriese et al. (2017) and 675 Besseling et al. (2013; 2017), where longer exposures to PCB-loaded PE microplastics did not trigger 676 noticeable effect on the survival of lobsters or lugworms, respectively. Although the sub-lethal 677 effects of MP ingestion were not investigated in this work, sinking MPs have been recently shown to 678 impair the P.lividus's oxidative status at adult stage (Parolini et al., 2020). However, the modulation 679 of the sea urchin oxidative status obtained by Parolini et al. (2020) was triggered by a higher dose of 680 MPs (daily exposure of 800 MPs during 7 days) than the MPs levels used in our study. In addition, 681 the characteristics of MPs (irregular shaped PET-MPs of an average diameter 316 \pm 12 μ m) used by 682 Parolini et al (2020) were different from ours, making the comparison between studies challenging. 683 In general, the presence of MPs and associated contaminants within adult specimens of sea urchins 684 and their associated biological effects remain poorly documented, indicating that this is an area 685 requiring further research.

687 **Conclusion and perspectives**

688

689 The present study reports for the first time a microplastic-mediated transfer of a key PCB congener 690 into adult specimens of the sea urchin Paracentrotus lividus. These findings suggests that the ¹⁴C-691 PCB-153 adsorbed onto the MPs was bioavailable to sea urchins across all experiments and that 692 these MPs acted as vectors of ¹⁴C-PCB-153 even during short-term exposure periods of only fifteen 693 days. In order to clarify the uncertainty regarding the vector effects of MPs, further experimental 694 studies investigating the extent at which MPs act as vectors for co-contaminants, compared to other 695 naturally occurring particles, are much needed. It is advised for future studies to keep in mind that 696 the relevance of MPs as vectors of co-contaminants depends on various factors such as the gradient 697 of co-contaminant concentrations between MPs and the organisms (Koelmans et al., 2013). A truly 698 comprehensive understanding of the importance of MPs as vectors for associated chemicals will, in 699 turn, eventually give rise to a better characterisation of MPs as a threat to organisms, potentially 700 leading towards more rigorous risk assessments of microplastic for human health and environment. 701 The relevance of further study of MP pollution is evident when taking into account the predicted 702 increase in MP abundance in the world's oceans in the coming years (Stollberg et al., 2021). In order 703 to enhance our understanding regarding the extent at which MPs act as vectors for co-contaminants, 704 further experimental studies investigating their role in the bioaccumulation of a wide range of 705 contaminants, by different organisms, and at various pollution levels compared to other naturally 706 occurring particles is much needed (Rodrigues et al., 2019). The use of radiolabelled chemicals to 707 address this knowledge gap shows to be highly promising, as radiotracer techniques offer strong 708 assets in terms of rapidity, accuracy and sensitivity (Besson et al., 2020; Johansen et al., 2018; 709 Lanctôt et al., 2018). It is also advised for future work to assess the relevance of MPs for 710 bioaccumulation of associated chemicals under environmentally realistic exposure conditions. In this 711 work, as the concentrations of PCB-153 used were in the highest range of the PCBs concentration 712 detected on MPs in the field, ranging from 0.2 to 7554 ng g⁻¹ (Campanale *et al.*, 2020, Taniguchi *et* 713 al., 2016), it is recommended to improve the experimental set up of future studies by selecting 714 environmentally realistic concentrations of PCBs or other co-contaminants. In addition, for studies 715 aiming at further investigating the vector effect of sinking MPs to benthic grazers in particular, it is 716 recommended to add sediments to the aquariums in order to enable appropriate comparison

- between the experimental and environmental levels of MPs (in terms of kg of dry sediment) and to
- 718 mimic a more realistic situation.
