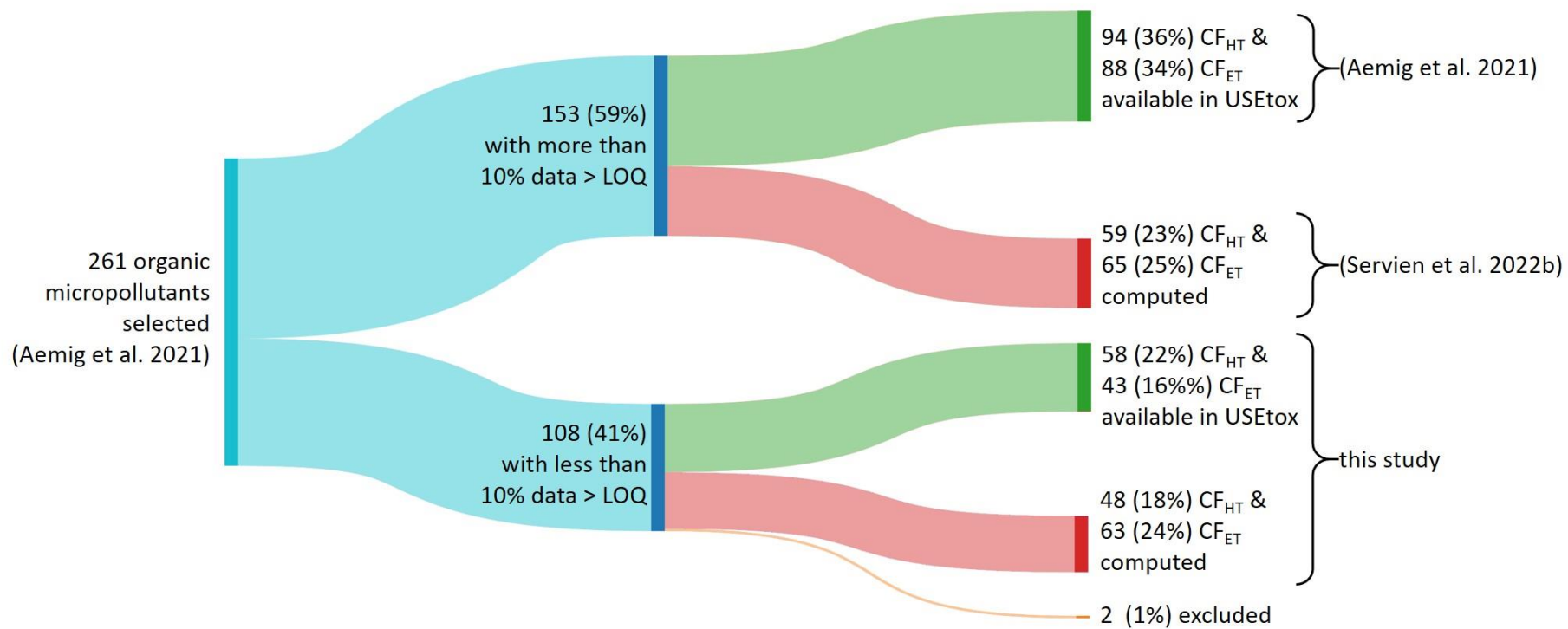


Figure S1. Position of this study in the general context

When the probability is equal to one, it means that no measured value is below this percentage of LOQ. For the DDD 24' the minimal concentration is infinite because its CF_{HT} is equal to zero.
