Introduction

Several approaches are possible to construct a model for elastic materials undergoing finite transformations:

- Rate type, hypo-elastic models with the use of objective transports: does not guarantee a reversible behavior.
- Thermodynamics of irreversible processes with an intrinsic dissipation rate equal to zero. For adiabatic or isothermal reversible transformations the first principle of thermodynamics leads to:

$$\boldsymbol{\sigma}: \boldsymbol{d} - \rho \dot{\psi} = 0$$

where ψ is the specific internal energy (an energy per unit mass), σ is the Cauchy stress tensor, d is the rate of deformation and ρ is the mass density. The dot over the quantity indicates a total derivative with respect to time.

If there is no constraint on $\dot{\varepsilon}$, it comes: $\boldsymbol{\sigma} = \frac{\partial W}{\partial \varepsilon} \tag{4}$	where Σ is the second Piola-Kirschhoff tensor and D is the lagrangian rate of deformation. Eulerian models limited to the isotropic case may then be derived : $\sigma = 2 \frac{\rho}{\rho_0} B \frac{\partial W_0}{\partial B} \qquad \sigma = 2 \frac{\rho}{\rho_0} \frac{\partial W_0}{\partial q} \qquad (6)$
leads to the classical Hooke model.	where B is the left Cauchy-Green deformation tensor and is the right equa-

tion known as Doyle-Ericksen formula; \boldsymbol{g} is the ambiant metric.

Questions

Why is it necessary to derive the model in the reference configuration? One could wonder how to treat the derivation with respect to time in the reference configuration: is it possible to take into account the variation of the density ρ_0 in space? Is it possible to write such an equation with an energy that is not per unit of undeformed volume? Equation $D = \dot{E}$ is written for the reference configuration, does it have a counterpart in an Eulerian description? This raises the question of the geometric nature of \dot{E} and thus D. Is it then possible to derive the equivalent of Equation 5 without resorting to the reference configuration?

The Lie derivative

The Lie derivative in the velocity field $\mathscr{L}_v(.)$ of a scalar a, a scalar density α , a second order contravariant tensor A or covariant tensor B is:

$$\mathscr{L}_{v}a = \dot{a} \qquad \mathscr{L}_{v}\alpha = \dot{\alpha} + \alpha \nabla v \qquad \mathscr{L}_{v}A = \dot{A} - (\nabla v)A - A(\nabla v)^{T} \qquad \mathscr{L}_{v}B = \dot{B} + (\nabla v)B + B(\nabla v)^{T}$$

Interesting relations:

$$\mathscr{L}_v \rho = 0, \qquad \mathscr{L}_v \boldsymbol{g} = 2\boldsymbol{d}, \qquad \mathscr{L}_v \boldsymbol{e} = \boldsymbol{d} \qquad \mathscr{L}_v \boldsymbol{b} = 0 \qquad \text{with} \quad \boldsymbol{b} = (F^T)^{-1} F^{-1}$$

where F is the deformation gradient and $e = \frac{1}{2}(g - b)$ is the Euler-Almansi strain tensor. The first equation is the mass conservation.

Eulerian anisotropic hyper elasticity

Rewrite Equation 1 ($\boldsymbol{\sigma} : \boldsymbol{d} - \rho \dot{\psi} = 0$) as:

$$\frac{1}{2}\boldsymbol{\sigma}: \boldsymbol{d} - \rho \mathscr{L}_{v}\psi = 0 \qquad \rightarrow \qquad \frac{1}{2}\boldsymbol{\sigma}: \boldsymbol{d} - \mathscr{L}_{v}(\rho\psi) = 0 \qquad \qquad \frac{1}{2}\boldsymbol{\sigma}: \boldsymbol{d} - \mathscr{L}_{v}W = 0 \qquad \text{with} \qquad W = \rho\psi$$

Choose the energy density such that $W(\rho, C, e)$ where C is a fourth order tensor containing material parameters and verifying $\mathscr{L}_v C = 0$ (or for the isotropic case, $W(\rho, C_i, I_i(e))$ where $I_i(e)$ corresponds to a number i of invariants of the strain tensor e and C_i are material parameters), then:

$$\frac{\partial W}{\partial \rho} \underbrace{\stackrel{=0}{\mathscr{L}_v \rho}}_{\mathcal{N}} + \frac{\partial W}{\partial C} \underbrace{\stackrel{=0}{\mathscr{L}_v C}}_{\mathcal{N}} + \left(2\frac{\partial W}{\partial g} - \boldsymbol{\sigma}\right) : \boldsymbol{d} = 0 \quad \text{then} \quad \boldsymbol{\sigma} = 2\frac{\partial W}{\partial g}$$

Conclusion

It is possible to derive an elastic model in the Eulerian configuration for anisotropic materials in the context of finite deformations.

- The Lie derivative is used.
- The mass conservation is used to treat properly the variation of the mass density.

The relation $\mathscr{L}_v e = d$ is geometrically sound and is the Eulerian counterpart of $D = \dot{E}$.
