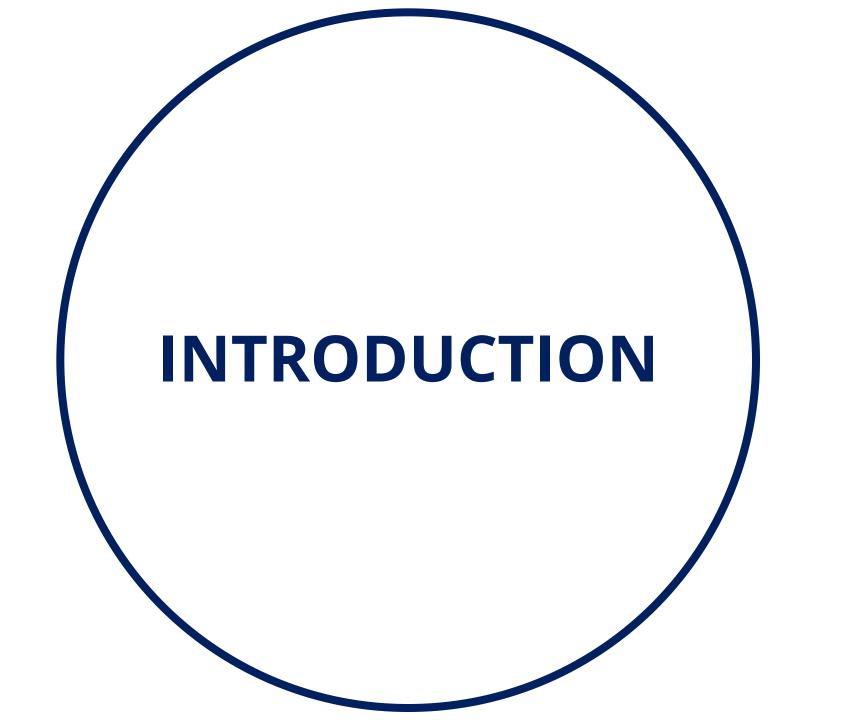

Research Questions (1) What is the **Physical Activity level** of esports athletes?

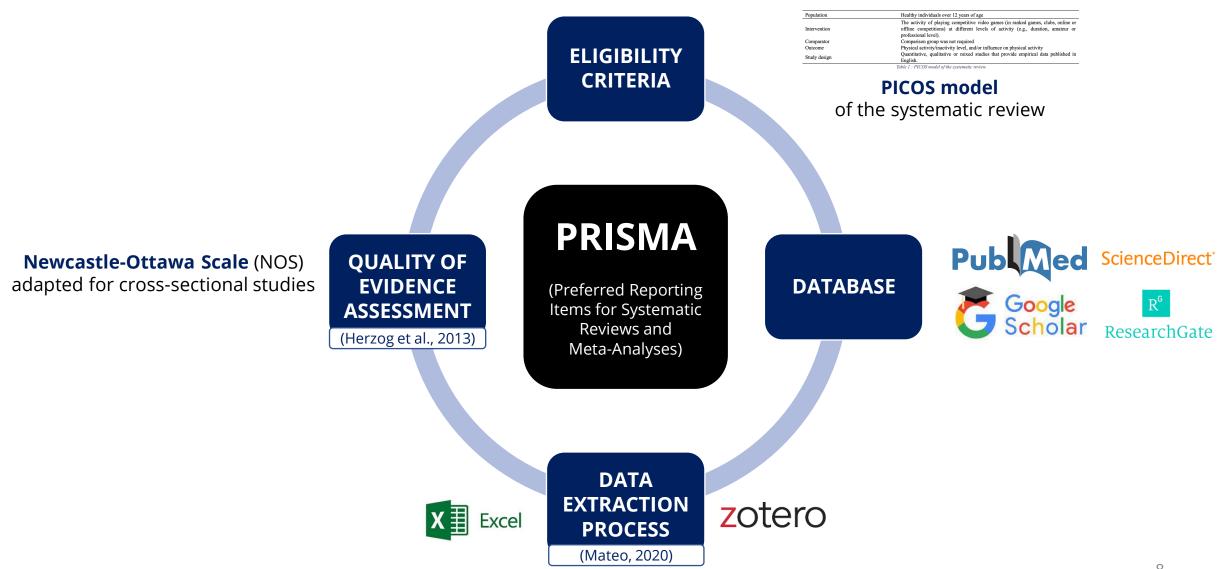


(2) Is there any **data about the influence** of esports on the physical activity of esports athletes (level, intensity, engagement, kind of sport, etc.)?

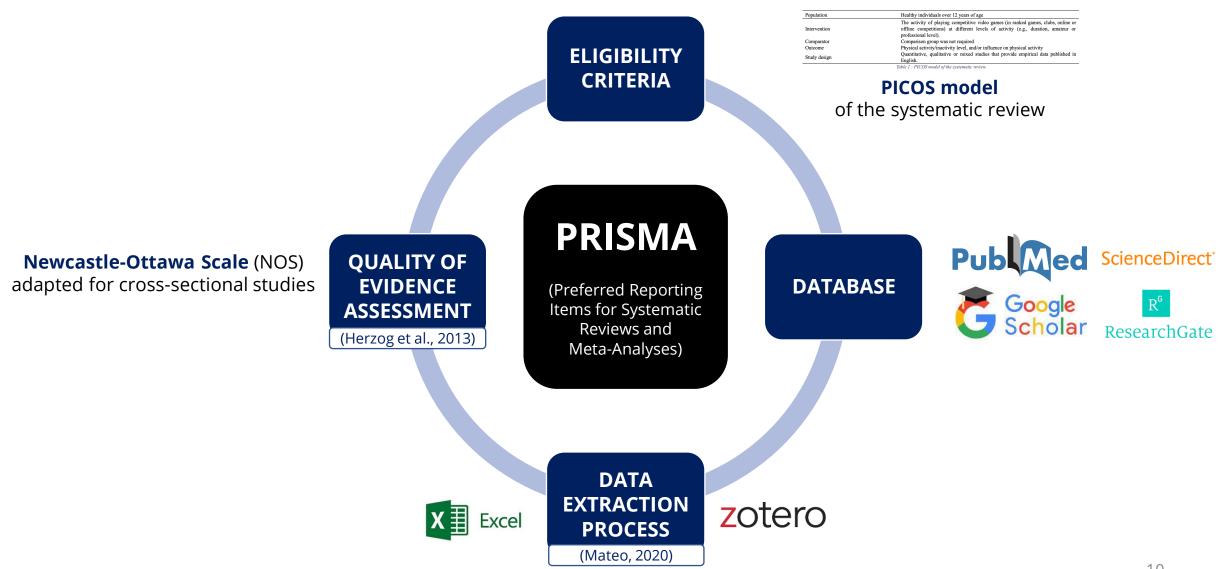


METHODOLOGY

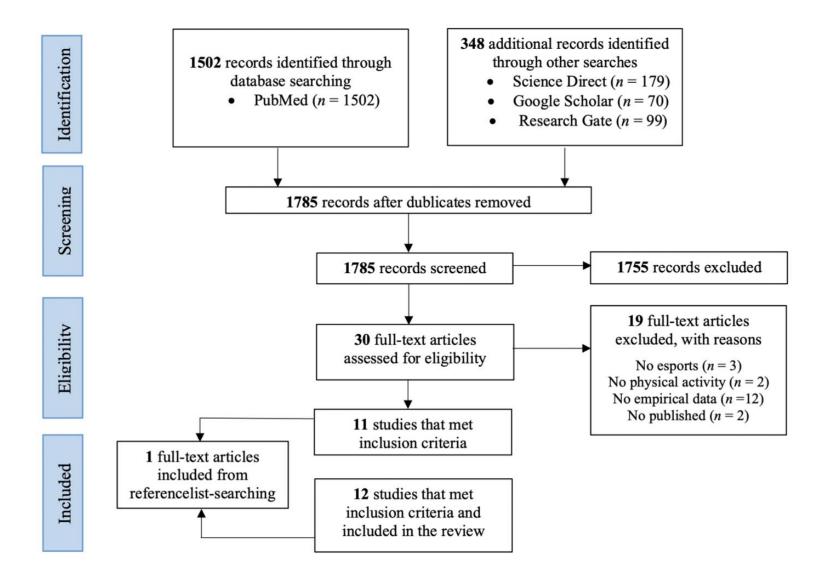
Population	Healthy individuals over 12 years of age
Intervention	The activity of playing competitive video games (in ranked games, clubs, online or offline competitions) at different levels of activity (e.g., duration, amateur or professional level).
Comparator	Comparison group was not required
Outcome	Physical activity/inactivity level, and/or influence on physical activity
Study design	Quantitative, qualitative or mixed studies that provide empirical data published in English.

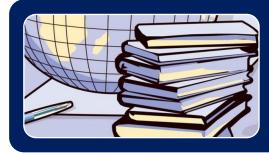

YOUNG MALE PLAYERS LARGELY REPRESENTED

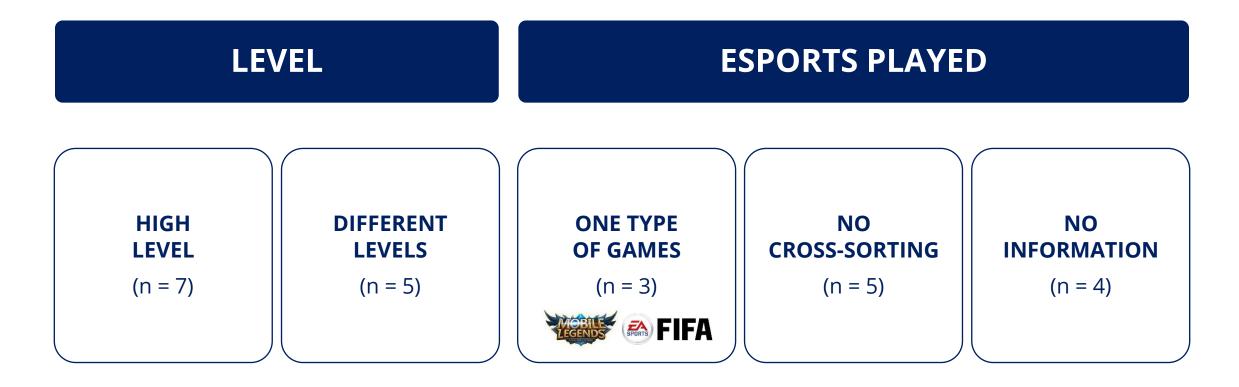
- 6 studies had 100% male participants
- Only 2 study with more than 10% female participants

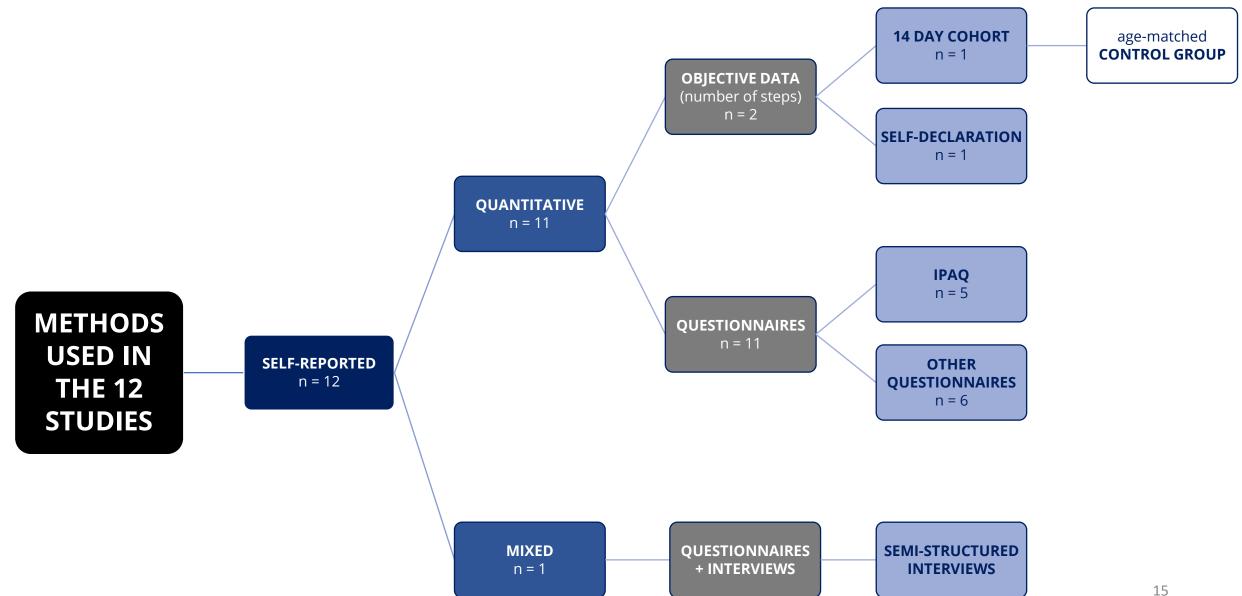


DIFFERENT GEOGRAPHICAL AREAS

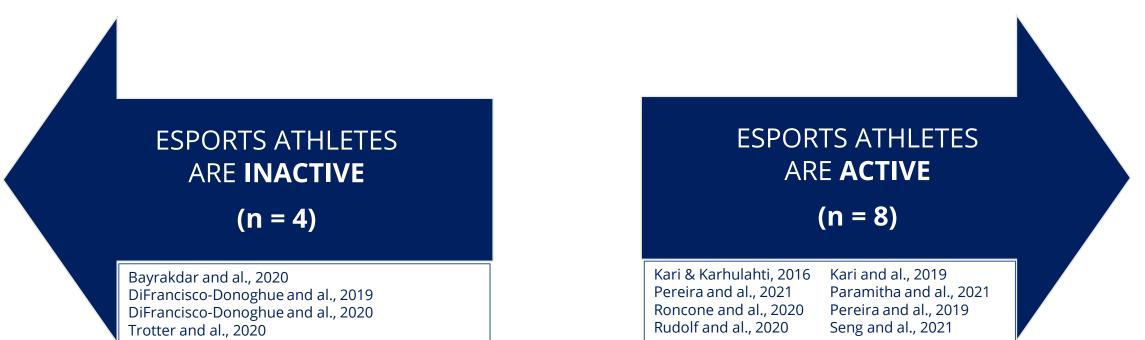
- 8 studies targeted **specific country** [USA (n=3), Portugal (n=2), Indonesia, Germany, Malaysia]

PHYSICAL ACTIVITY LEVELS (2)

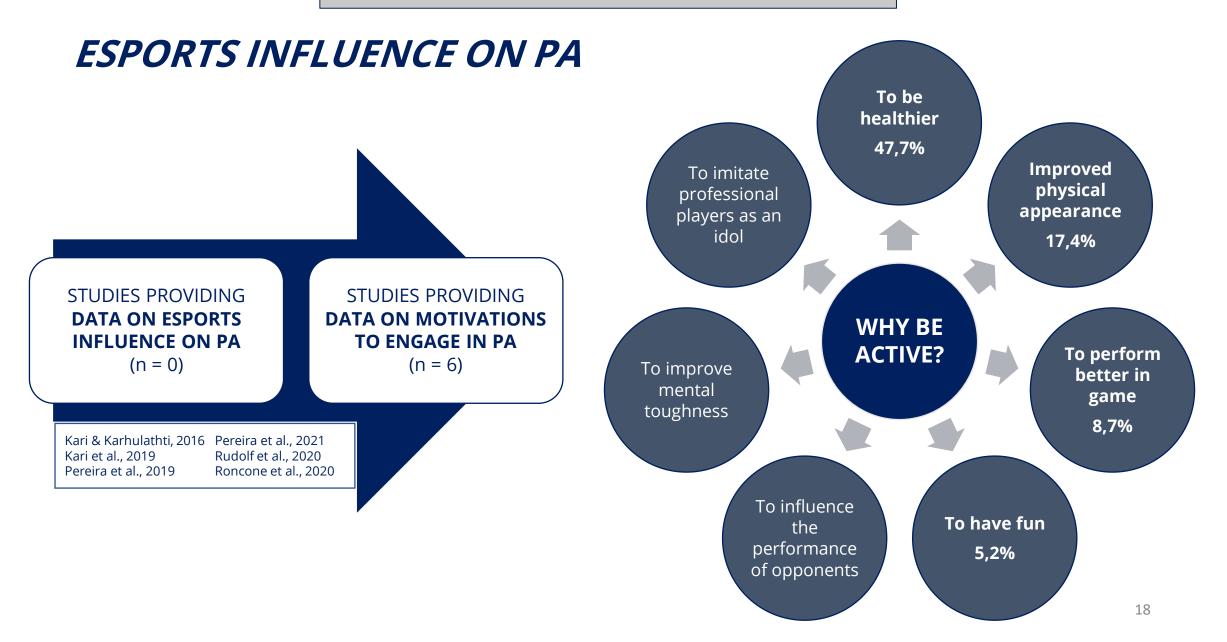
INFORMATION ABOUT THE **KIND OF** PHYSICAL ACTIVITY (n = 3)

> Esports players in UNITED STATES = INACTIVE

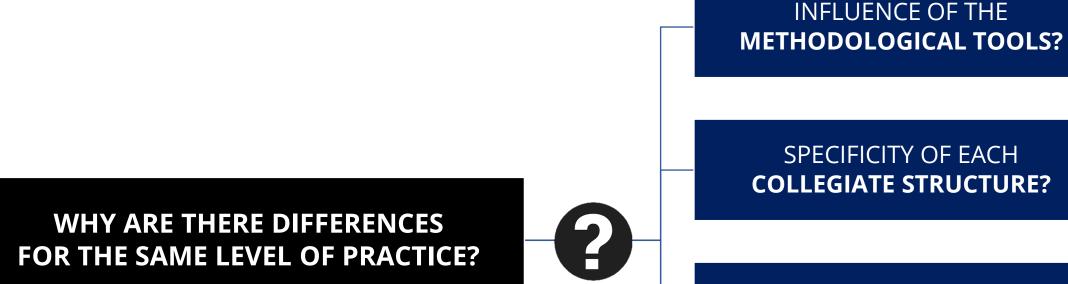

If motivations to engage in a physical activity are highlighted, there is **no data on the esports influence on the PA engagement**

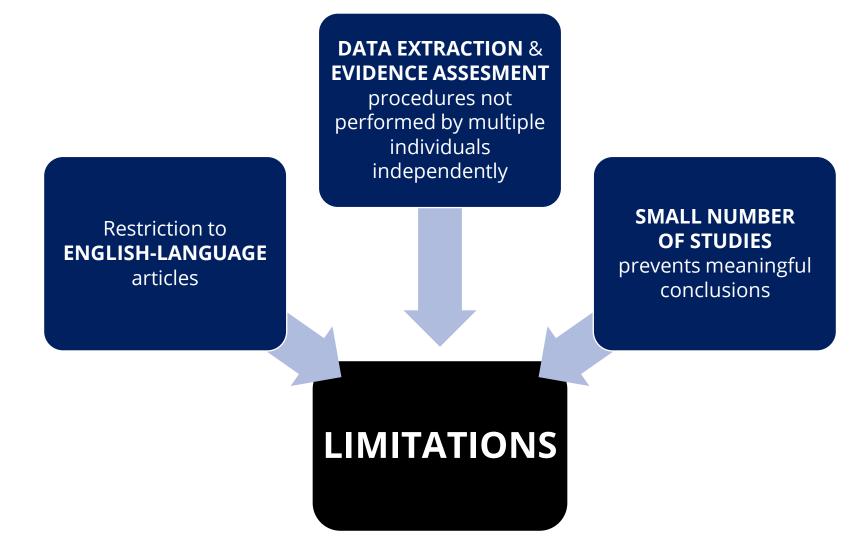

OBJECTIVE MEASUREMENT TOOLS: accelerometers + heart rate

IDEAL STUDY

MIXED METHODOLOGY (quantitative & qualitative data) **INTERVIEWS** focus on esports influence on PA engagement, re-engagement, retention or withdrawal.
