# Hydrodynamic limit of the Schelling model with spontaneous Glauber and Kawasaki dynamics

#### Abstract

In the present article we consider the Shelling model, an agent-based model describing a segregation dynamics when we have a cohabitation of two social groups. As for several social models, the behavior of the Shelling model was analyzed by exploiting theoretical physics tools and computer simulations. This approach led to conjecture a phase diagram in which either different social groups were segregated in two large clusters or they were mixed. As far as the authors know, this model has never been consider by the mathematical community, a rigorous mathematical analysis of the model is one of the main novelties of the paper. We describe the Shelling model as a particle system model and, adding a Glauber and Kawasaki dynamics to the original Schelling dynamics, we prove the existence of an hydrodynamic limit described by a reaction-diffusion equation with a discontinuous non-linear reaction term. The existence and uniqueness of the solution is non trivial and the analysis of the limit PDE is interesting in its own. Based on our results, we conjecture the existence of a phase diagram in which we have a mixed, a segregated and a metastable segregation phase.

## 1 Introduction

Schelling's model of segregation was introduced by Thomas Schelling in 1971 [21, 22]. The original model is defined on a square grid of $N$ sites (or, more generally, on a regular graph with $N$ sites) where agents (individuals) belonging to two groups are randomly disposed. A local dynamic is defined by each agent, the agent located at a site of the grid compares its group with the group of its neighbors. More precisely, we fix a tolerance threshold $T \in[0,1]$. We call $r_{x}$ the fraction of neighbors belonging to the agent's group at site $x$ and we say that the agent is satisfied if $r_{x} \geqslant T$. If the agent is unsatisfied, then he moves on a site that makes him satisfied. The dynamics is not unique, we briefly discuss this point here below. The process ends when all the agents are either satisfied or blocked (no move makes the agent satisfied). This model is thus characterized by a local dynamics which generates a global dynamics of the system. The study of this model enters naturally in the field of statistical physics which provides a large number of tools to study the properties of the model.

The parameters which characterize the model are
(1) The size of the neighborhood,
(2) The initial distribution of the agents,
(3) The choice of the satisfaction condition,
(4) The local dynamics between agents.

Several variants of Shelling's model have been considered in the recent literature in order to study the behavior of the model when the fundamental parameters are modified. We refer to [19] for a complete overview on the subject. The common result of the considered variants is the existence of three stationary states separated by two critical thresholds $T_{f}$ and $T_{c}$ (a frozen state $T<T_{f}$, a segregated state $T_{f}<T<T_{c}$ and a mixed state $T>T_{c}$ ) towards which the system evolves, suggesting an universal behavior of the model. When the system is open (agents can change the group) the behaviour of the system is expected to be symmetric with respect to $T=1 / 2$, see 13 .

In the present paper, we approach the model from a physical point of view, by interpreting the agent dynamics as a particle systems in interaction. This approach was adopted by the physical community to study this model,

[^0]see for instance [3, 9, 12, 13]. In particular we consider the setting where the points of the grid (a discrete torus $\left.\mathbb{T}_{N}^{d}:=(\mathbb{Z} / N \mathbb{Z})^{d}, d \geqslant 1\right)$ are fully occupied and unsatisfied agents flip their state if it makes them satisfied (Glauber dynamics). The size of the neighborhood taken into account to compute the fraction $r_{x}$, grows at most logarithmically with $N$. Moreover we introduce random perturbations, either by flipping a state of an agent at rate $\beta$ (spontaneous Glauber dynamics) or exchanging the position of two agents at rate $\alpha N^{2}$ (accelerated Kawasaki dynamics).

Our main result is to prove an hydrodynamic limit described by a reaction-diffusion equation for the system and to give a complete description of the limit PDE that we get. In the case where the size of the neighborhood stays finite in the limit, we obtain a classical reaction-diffusion equation, this is the case where the size of the interaction term stays finite and thus microscopic. However, when the size of the neighborhood goes to infinity we get a non-linearity (the reaction term) which is discontinuous at two points. In this case, the interaction of the Schelling dynamics takes into account more and more agents but in the limit, the reaction term is still purely local.

In this "mesoscopic" limit, the existence and uniqueness of the solution of the reaction-diffusion equation with discontinuities is one of the major technical points of the paper. More precisely, the system does not have a unique solution for some class of initial condition, and some values of $\beta$, the parameter tuning the spontaneous Glauber dynamics. Finally, we conjecture the existence of a rich phase diagram in which beyond a mixed and a segregated phase there is a transition in between. In this phase, the system has the potential to show a metastable segregation: the mixing phase should be the most stable one but symmetrical stable segregation phases also exist. The critical points depend on the parameters $\beta$ and $T$ but not on $\alpha$, see Figure 1. A rigorous proof of the phase diagram requires a delicate analysis of the local dynamics that goes beyond the techniques used in the present paper.

Our method of proof is based on the technique of the relative entropy method in the framework developed by Jara and Mezenes in [14], [15], and also used by Funaki and Tsunoda in [8]. However, in our setting, we needed to adapt their proofs to cover the case where the number of particles in the interaction would be going to infinity. We also prove existence and local uniqueness for a class of initial conditions of our limiting PDE, viewed as a differential inclusion.

A detailed plan of the method of proof and the article is given at the end of Section 3 containing the main result and assumptions. In the following Section, we define the model.

## 2 The model

### 2.1 Configurations

For $N \in \mathbb{N}=\{1,2,3, \ldots\}$ we let $\mathbb{T}_{N}^{d}=(\mathbb{Z} / N \mathbb{Z})^{d}$ be the discrete torus and let $\Omega_{N}=\{0,1\}^{\mathbb{T}_{N}^{d}}$ be the space of all possible configurations. We call $\eta \in \Omega_{N}$ a configuration and $i \in \mathbb{T}_{N}^{d}$ a site. Let $\mathcal{V}_{N} \subset \mathbb{T}_{N}^{d} \backslash\{0\}$ be a bounded set. We say that two sites $i, j \in \mathbb{T}_{N}^{d}$ are neighbors if $i-j \in \mathcal{V}_{N}$. We denote $K_{N}=\left|\mathcal{V}_{N}\right|$ its cardinality. For a configuration $\eta \in \Omega_{N}$ and a site $i \in \mathbb{T}_{N}^{d}$ we let

r_{i}(\eta)=\frac{1}{K_{N}} \sum_{j \in \mathcal{V}_{N}} \mathbb{1}_{\left\{\eta_{i}=\eta_{i+j}\right\}} \quad \text { and } \quad \rho_{i}(\eta)=\frac{1}{K_{N}} \sum_{j \in \mathcal{V}_{N}} \eta_{i+j} . \tag{2.1}

The quantity $\rho_{i}(\eta)$ is the mean field of $\eta$ on the neighborhood $\mathcal{V}_{N}+i$. Let us observe that $\rho_{i}(\eta)$ is independent of $\eta_{i}$. We note that

For a given configuration, we now introduce the definition of stable, unstable and potentially stable site.
Definition 2.1. For a given site $i$, let us denote $\eta^{i}$ the configuration where we change $\eta_{i}$ to $1-\eta_{i}$.
Let $T \in[0,1]$. If $r_{i}(\eta)<T$, the site $i$ is said unstable for $\eta$, otherwise if $r_{i}(\eta) \geqslant T$ the site is said stable for $\eta$. An unstable site $i$ for $\eta$ which is stable for $\eta^{i}$ is said potentially stable.

Note that $r_{i}\left(\eta^{i}\right)=1-r_{i}(\eta)$. Thus

1. a site $i$ is potentially stable if and only if $r_{i}(\eta)<T$ and $r_{i}(\eta) \leqslant 1-T$. In particular if $T \leqslant \frac{1}{2}$ an unstable site for $\eta$ is automatically potentially stable.
2. if $T>\frac{1}{2}$ and $1-T<r_{i}(\eta)<T$, we have $r_{i}\left(\eta^{i}\right)<T$ and the site $i$ is unstable for $\eta$ and $\eta^{i}$.

### 2.2 Infinitesimal generator, construction of the process

Fix $\alpha>0$ and $\beta>0$. Let us consider the following dynamics : starting from a configuration $\eta$

1. if a site $i$ is potentially stable, we flip the value at $i$ with rate 1 ,
2. two nearest-neighbors $i$ and $j$ exchange their values with rate $\alpha N^{2}$ (accelerated Kawasaki dynamics),
3. a site $i$ can change its value at rate $\beta>0$ (spontaneous Glauber dynamics).

This dynamics defines an infinitesimal generator $\mathcal{L}_{N}$ defined for $F$ cylinder function on $\Omega_{N}$ by

where $\eta^{i j}$ is the configuration where the values at site $i$ and $j$ have been exchanged.
The following proposition states that the process is well defined, since the state space is finite.
Proposition 2.1. Given an initial configuration $\eta_{0}, \mathcal{L}_{N}$ is the infinitesimal generator of a Feller process, denoted $\left(\eta^{N}(t)\right)_{t \geqslant 0}$.

We let $\mu_{t}^{N}$ be the distribution of $\eta^{N}(t)$.
Remark 2.1. In this article we focus on the compact setting (torus) because a non compact framework, as $\mathbb{R}^{d}$, presents technical problems for the convergence of the process, nevertheless the discrete model can be well defined on $\mathbb{Z}^{d}$ (cf. 2.3) and Proposition 2.1).

## 3 Main results

We let $u_{0}^{N}(i):=\mathbb{E}_{\mu_{N}}\left[\eta_{i}^{N}(0)\right], i \in \mathbb{T}_{N}^{d}$ be the initial distribution of our process, that is, $\eta_{i}^{N}(0)$ is distributed as a Bernoulli of parameter $u_{0}^{N}(i)$.

For a vector $v,|v|$ denotes its euclidean norm and $|v|_{\infty}$ its uniform norm.
Assumption 1. Assumptions on $\mathcal{V}_{N}$.

1. Let $\ell_{\mathcal{V}}$ be the diameter of $\mathcal{V}$. Then, $\ell_{\mathcal{V}} \leqslant \delta(\log N)^{\frac{1}{d}}$ for some $\delta>0$.
2. If $d=1$, suppose that $\mathcal{V}_{N} \subset \mathbb{Z} \backslash \mathbb{N}$.

Assumption 2. Assumptions on $u_{0}^{N}$.

1. There exists $\varepsilon>0$ such that $\varepsilon \leqslant u_{0}^{N}(i) \leqslant 1-\varepsilon$ uniformly on $i \in \mathbb{T}_{N}^{d}$ and $N \in \mathbb{N}$.
2. There exists $C_{0}>0$ independent of $N$ such that $\left|\nabla u_{0}^{N}(i)\right|_{\infty} \leqslant \frac{C_{0}}{N}$, where $\nabla u_{0}^{N}(i)=\left(u_{0}^{N}\left(i+e_{k}\right)-u_{0}^{N}(i)\right)_{k=1}^{d}$, with $e_{k} \in \mathbb{Z}^{d}$ the unit vector of direction $k$.
3. Let $v_{u_{0}^{N}}^{N}=\bigotimes_{i \in \mathbb{T}_{N}^{d}} \mathrm{~B}\left(u_{0}^{N}(i)\right)$ be the law of a sequence of independent Bernoulli of parameter $u_{0}^{N}(i)$. Suppose that $\mathcal{H}\left(\mu_{0}^{N} \mid v_{u^{N}(0)}^{N}\right)=O\left(N^{d-\varepsilon_{0}}\right)$ for some $\varepsilon_{0}>0$ small, where $\mathcal{H}(\mu \mid v)$ is the relative entropy of $\mu \ll v$,

\mathcal{H}(\mu \mid v):=\int \frac{\mathrm{d} \mu}{\mathrm{~d} v} \log \left(\frac{\mathrm{~d} \mu}{\mathrm{~d} v}\right) \mathrm{d} v \tag{3.1}

4. Let $\widetilde{u}_{0}^{N}(x)$ be the linear interpolation on $\mathbb{T}^{d}=(\mathbb{R} / \mathbb{Z})^{d}$, the $d$ dimensional torus, of $u_{0}^{N}(i)$ such that $\widetilde{u}_{0}^{N}(i / N)=u_{0}^{N}(i)$. Then, there exists $u_{0} \in \mathcal{C}\left(\mathbb{T}^{d}\right)$ such that $\widetilde{u}_{0}^{N}$ converges to $u_{0}$ in $\mathcal{C}\left(\mathbb{T}^{d}\right)$.

Remark 3.1. The assumption 1 (2.) is only technical and it could be removed by considering the dimension $d=1$ separately from the rest of the dimensions, cf. Remark 4.3.

Define

$$
\begin{equation*}
\pi_{t}^{N}=\pi_{t}^{N}(\eta, \mathrm{~d} v)=\frac{1}{N^{d}} \sum_{i \in \mathbb{T}_{N}^{d}} \eta_{i}(t) \delta_{\frac{i}{N}}(\mathrm{~d} v) \tag{3.2}
\end{equation*}

the empirical measure associated to the Markov process $\eta$ where the space is rescaled by $\frac{1}{N}$, which is a positive measure on $\mathbb{T}^{d}$.

We now state our main result, which concerns the convergence of subsequences of the empirical measure.
Theorem 3.1. Under Assumptions 1 and 2, for every test function $\varphi: \mathbb{T}^{d} \rightarrow \mathbb{R}$ and for every $\varepsilon>0$, there exists $\tau>0$ and an increasing sequence $\left(N_{i}\right)$ such that

\lim _{i \rightarrow+\infty} \mu^{N_{i}}\left(\left|\left\langle\pi^{N_{i}}, \varphi\right\rangle-\langle u, \varphi\rangle\right|>\varepsilon\right)=0, \quad \forall t \in[0, \tau]

where $\left\langle\pi^{N}, \varphi\right\rangle$ and $\langle u, \varphi\rangle$ denote the integral of $\varphi$ with respect to the measure $\pi^{N}$ or $u(x) \mathrm{d} x$ respectively. The function $u=u(t, x)$ is a density solution of the following reaction-diffusion equation

u(0, x)=u_{0}(x)

on the torus $\mathbb{T}^{d}$, with $g_{\infty}(p):=(1-p) \mathbb{1}_{\{1-p<\min (T, 1-T)\}}-p \mathbb{1}_{\{p \leqslant \min (T, 1-T)\}}$. Moreover if $u_{0}$ (the limit of the initial condition, according to Assumption 2-4) is such that

1. $u_{0} \in \mathcal{C}^{1}\left(\mathbb{T}^{d}\right)$, with $\nabla u_{0}$ Lipschitz,
2. $\nabla u_{0}(p) \neq 0$ for $p=\min (T, 1-T)$ and $p=1-\min (T, 1-T)$,
then the solution of Equation (3.3) is unique on $[0, \tau]$ for some $\tau>0$ and the convergence holds for the sequence itself.

### 3.1 Organisation of the paper

To prove Theorem 3.1 we first prove that the empirical measure is close to a discrete measure $u^{N}$ which is a solution of a discrete analogous of (3.3), this is Theorem 4.2. Its proof is based on a entropy method approach in which the relative entropy between $\mu^{N}$ and $v_{u^{N}}^{N}$, see Theorem 4.1. Even if this technique is quite standard in the particle system theory, some new technical estimations arising from the geometry of the system are needed. In Section 5 we discuss some central technical estimations about $u^{N}$, in order to describe the behaviour of the discrete model. Then, in Section 6 we discuss the existence and uniqueness of (3.3) and in Section 7 we show the convergence of the $u^{N}$ toward the density $u$ by completing the proof of Theorem 3.1. We stress that the proof of the existence and uniqueness is not standard and the analysis of this PDE is interesting in its own.

In Section 3.2 we state our conjecture on the phase diagram of the model.

### 3.2 Conjecture on the phase diagram

In this Section, we discuss the phase diagram that describes the mixed and segregated phases. We start by setting the Equation (3.3) in a more convenient form. Set $p_{0}(T):=\min (T, 1-T) \in\left[0, \frac{1}{2}\right]$. For $p \in[0,1]$ we define

\beta\left(p-\frac{1}{2}\right)^{2}+\frac{1}{2}\left(p^{2}-p_{0}(T)^{2}\right) & \text { for } 0 \leqslant p<p_{0}(T)  \tag{3.4}\\
\beta\left(p-\frac{1}{2}\right)^{2} & \text { for } p_{0}(T) \leqslant p<1-p_{0}(T) \\
\beta\left(p-\frac{1}{2}\right)^{2}+\frac{1}{2}\left((1-p)^{2}-p_{0}(T)^{2}\right) & \text { for } 1-p_{0}(T) \leqslant p \leqslant 1
\end{array}\right.
$$

Our conjecture is based on the analysis of $\gamma_{\infty, \beta}$ and it is represented in Figure 1. We observe that $\gamma_{\infty, \beta}$ is continuous and satisfies $\gamma_{\infty, \beta}(p)=\gamma_{\infty, \beta}(1-p)$. For $p \neq p_{0}(T), 1-p_{0}(T)$, we have that $\gamma_{\infty, \beta}^{\prime}(p)=-\beta(1-2 p)-g_{\infty}(p)$ and (3.3) can be written as

Figure 1: Representation of the different phases of the system as function of the parameter $p_{0}(T) \in\left[0, \frac{1}{2}\right]$. When $T$ is close to 0 or $1\left(p_{0}(T) \in\left(0, p^{\ell}\right)\right)$ we do not have segregation (red parts) and typical configurations are provided by a mixing of 0 and 1 . If $T$ is close to $1 / 2\left(p_{0}(T) \in\left(p^{m}, \frac{1}{2}\right)\right)$ we have segregation (green parts): a very large parts of the configuration are composed of 0 or 1 . We have also intermediate values of $T\left(p_{0}(T) \in\left(p^{\ell}, p^{m}\right)\right.$ ) for which the segregation is metastable (yellow parts).

To discuss the phase transition we can look at the structure of $\gamma_{\infty, \beta}(p)$. The function $p \mapsto \beta\left(p-\frac{1}{2}\right)^{2}+$ $\frac{1}{2}\left(p^{2}-p_{0}(T)^{2}\right)$ has a unique minimum at $p=p^{\ell}:=\frac{\beta}{1+2 \beta}$. Therefore, if $0 \leqslant p^{\ell}<p_{0}(T)<\frac{1}{2}$, the function $\gamma_{\infty, \beta}$ has three regular minima $: p^{c}:=\frac{1}{2}, p^{\ell}$ and $p^{r}:=1-p^{\ell}$. Note that

\gamma_{\infty, \beta}\left(p^{c}\right)=0 \quad \text { and } \quad \gamma_{\infty, \beta}\left(p^{r}\right)=\gamma_{\infty, \beta}\left(p^{\ell}\right)=\frac{\beta}{4(1+2 \beta)}-\frac{p_{0}(T)^{2}}{2}
$$

Then we get that if $p_{0}(T)<p^{m}:=\sqrt{\frac{\beta}{2(1+2 \beta)}}$, we have $\gamma_{\infty, \beta}\left(p^{c}\right)<\gamma_{\infty, \beta}\left(p^{\ell}\right)$ and if $p^{m}<p_{0}(T)$, we have that $\gamma_{\infty, \beta}\left(p^{c}\right)>\gamma_{\infty}\left(p^{\ell}\right)$. If $p^{\ell}>p_{0}(T), p^{c}$ is the only minimum.

The two thresholds for $p_{0}(T)$ are then $p^{\ell}$ and $p^{m}$, see Figure 1 . Since $p^{\ell}<p^{m}$, we have the following picture: as $T$ is close to 0 and below $p^{\ell}$, we have a unique minimum of $\gamma_{\infty, \beta}$, so that typical configurations are close to $p=1 / 2$ which is of lowest energy $\gamma_{\infty, \beta}$. It means that, at equilibrium, we expect a configuration balanced between 0 and 1 and we do not have segregation. Then, as $T$ goes above the threshold $p^{\ell}$ but stays below $p^{m}$, other minima at $p=p^{\ell}$ and $p=p^{r}$ appear, and these two configurations are metastable since their energy is higher, so we can have segregation for a small proportion of the time. The next threshold is $p^{m}$, at which the two metastable configurations become stable and $p=1 / 2$ is the metastable one so that we expect stable segregation. For $T$ above $\frac{1}{2}$ the picture is symmetric.
Remark 3.2. The hydrodynamic limit (3.3) has, at least, two different formulations as a gradient flow :

1. in the classical $L^{2}\left(\mathbb{T}^{d}\right)$ setting, with the potential $\mathcal{F}$ defined for $u: \mathbb{T}^{d} \rightarrow[0,1]$

Equation (6.2) can be written as $\partial_{t} u=-\delta \mathcal{F}(u)$ where $\delta \mathcal{F}$ denotes the Fréchet derivative of $\mathcal{F}$.
2. in a Wasserstein-like setting defined in [18] with the entropy potential $\mathcal{H}$, for $\left.\left.u: \mathbb{T}^{d} \rightarrow\right] 0,1\right]$, and $\xi: \mathbb{T}^{d} \rightarrow \mathbb{R}$ (seen as an element in the tangent bundle)

Equation (3.3) can be written as

Since $\delta \mathcal{H}=\log (2 u)$ and $\mathcal{K}(u)(\delta \mathcal{H})=-2 \alpha \Delta u+\gamma_{\beta, \infty}^{\prime}(u)$.
Both formulations could be useful to establish a rigorous proof of the phase diagram given in Figure 1. In particular, along a gradient flow the potential is non-increasing, thus for all $t>0$, along a solution $u$ we have $\mathcal{F}(u(t)) \leqslant \mathcal{F}(u(t=0))$ and if $u$ converges to a stationary solution $v$, it must be a stationary point of $\mathcal{F}$ (i.e. $\delta \mathcal{F}(v)=0)$.

For the second formulation, note that

\left.\left.\frac{\gamma_{\infty, \beta}^{\prime}(u)}{\log (2 u)}>0, u \in\right] 0,1\right] \Longleftrightarrow p_{0}(T)<p^{\ell}=\frac{\beta}{1+2 \beta} \Longleftrightarrow \beta>\frac{p_{0}(T)}{1-2 p_{0}(T)} . \tag{3.8}

We are thus in the mixing phase of the diagram and $\mathcal{K}(u)$ is positive definite in the sense that

Then, one can prove that along a solution $u$, we get that :

\end{equation*}

where $c=\beta-\frac{p_{0}(T)}{1-2 p_{0}(T)}>0$, and we get that $\mathcal{H}(u(t)) \leqslant \mathcal{H}(u(0)) e^{-c t}$. Thus $\mathcal{H}(u(t))$ goes to 0 as $t \rightarrow \infty$, this entails that $u$ converges to the only stationary point of $\mathcal{H}$ which is the constant $\frac{1}{2}$. Heuristically, it suggests that an exponential relaxation is taking place in the mixing phase of Figure 1.

## 4 Relative entropy method

Using the relative entropy method, in this section we prove that the empirical measure $\pi^{N}(t)$ is close to $u^{N}(t)=$ $\left(u^{N}(t, i)\right)_{i \in \mathbb{T}_{N}^{d}}$ the solution of a suitable discrete PDE.

In order to state the main result of this section, we observe that the generator $\mathcal{L}_{N}$ in 2.3) can be written as $\mathcal{L}_{N}=\mathcal{G}_{N}+2 \alpha N^{2} \mathcal{K}_{N}$ where $\mathcal{G}_{N}$ is the generator which describes the Glauber-Shelling dynamics and $\mathcal{K}_{N}$ the generator which describes the Kawasaki dynamics, that is,

\mathcal{G}_{N} F(\eta) & =\sum_{\substack{i \in \mathbb{T}_{N}^{d}}}\left(\mathbb{1}_{\left\{r_{i}(\eta)<T, r_{i}(\eta) \leqslant 1-T\right\}}+\beta\right)\left(F\left(\eta^{i}\right)-F(\eta)\right),  \tag{4.1}\\
\mathcal{K}_{N} F(\eta) & =\frac{1}{2} \sum_{\substack{i, j \in \mathbb{T}_{N}^{d} \\
|i-j|=1}}\left(F\left(\eta^{i j}\right)-F(\eta)\right) \tag{4.2}
\end{align*}
$$

Let us stress that $\mathcal{G}_{N}$ can be written as follows

where $c_{i}(\eta)$ is a local function which describes the dynamics (Glauber-Schelling dynamics). To be more precise, we write $c_{i}(\eta)=c_{0}\left(\tau_{i} \eta\right)$ where $c_{0}$ is the flipping rate of a particle at the origin, that is,

We observe that $\lim _{n \rightarrow+\infty} \frac{\kappa_{N}}{K_{N}}=\min (T, 1-T)$. Since $c_{0}(\eta)=\mathbb{1}_{\left\{r_{0}(\eta) \leqslant \frac{\kappa_{N}}{K_{N}}\right\}}=\mathbb{1}_{\left\{r_{0}(\eta) \leqslant \frac{\kappa_{N}}{K_{N}}, \eta_{0}=0\right\}}+\mathbb{1}_{\left\{r_{0}(\eta) \leqslant \frac{\kappa_{N}}{K_{N}}, \eta_{0}=1\right\}}$, we define

so that $c_{0}(\eta)=c_{0}^{+}(\eta)\left(1-\eta_{0}\right)+c_{0}^{-}(\eta) \eta_{0}$, by 2.2 . The functions $c^{+}$and $c^{-}$can be viewed as the rate of creation and annihilation of a particle at $i=0$ respectively.

For any function $u=\left(u_{i}\right)_{i \in \mathbb{T}_{N}^{d}}$ we define

where $\Delta u^{N}(t, i)$ is the discrete Laplacian on the torus. Note that 4.10 can be interpreted as a discretized version of (3.3).

In the following result we prove that the relative entropy of $v_{u^{N}(t)}^{N}$ (cf. (4.7)) with respect to $\mu_{t}^{N}$ stays small in time, if it is small at $t=0$.
Theorem 4.1. Under Assumptions 1 and 2, with $\delta>0$ sufficiently small, we have that for some $\varepsilon>0$ small

Theorem 4.1 implies Theorem 3.1 for $u^{N}$ defined in 4.10. More precisely, we consider $u^{N}$ as a measure on $\mathbb{T}^{d}$, that is,

Since $u^{N} \in(0,1)$ (cf. Proposition 5.2), the proof of 4.15) is model independent and follows line by line the proof of Proposition 2.2 in [8].
Remark 4.1. Let us note that $c_{0}$ can be expressed as a polynomial on the variables $\eta_{j}$ 's, as in relation (1.5) of [8]. This remark will be useful in the sequel of the paper. For this purpose, let $A \subset \mathcal{V}_{N}$, we denote :

By an abuse of notation, for a function $u=\left(u_{j}\right)_{j \in \mathbb{T}_{N}^{d}}$ we let let also $c_{A}^{+}(u)=\prod_{j \in A}\left(1-u_{j}\right) \prod_{j \in \bar{A} \cap \mathcal{V}_{N}} u_{j}$ and accordingly for $c_{A}^{-}(u) . B y, 4.6$ we have that

c_{0}^{+}(\eta)=\sum_{k=0}^{\kappa_{N}} \mathbb{1}_{\left\{r_{0}(\eta)=\frac{k}{K_{N}}, \eta_{0}=0\right\}}=\left(1-\eta_{0}\right) \sum_{\substack{A \subset \mathcal{V}_{N} \\|A| \leqslant \kappa_{N}}} c_{A}^{+}(\eta) . \tag{4.18}
\end{equation*}
$$

Accordingly, we have

c_{0}^{-}(\eta)=\sum_{k=0}^{\kappa_{N}} \mathbb{1}_{\left\{r_{0}(\eta)=\frac{k}{K_{N}}, \eta_{0}=1\right\}}=\eta_{0} \sum_{\substack{A \subset \mathcal{V}_{N} \\|A| \leqslant \kappa_{N}}} c_{A}^{-}(\eta) . \tag{4.19}
\end{equation*}

In the rest of this section we prove Theorem 4.1. The strategy that we use follows the one used to prove the analogous result in [8] and [15], but some extra-technicality is required due to the geometry of our problem.

### 4.1 Proof of Theorem 4.1

To make the notation lighter, for $t \geqslant 0, j \in \mathbb{T}_{N}^{d}, p \in(0,1)$ and $u^{N}$ the solution of 4.10, we let

We let $\mathcal{H}_{N}(t):=\mathcal{H}\left(\mu_{t} \mid v_{u(t)}\right)$ be the relative entropy of $v_{u(t)}$ with respect to $\mu_{t}$ cf. (3.1). We have all the ingredients to state Yau's inequality in our context (cf. proof Lemma A. 1 in [15]).

Proposition 4.3. For any $t \geqslant 0$ we have that

where $\mathcal{L}_{N}^{*, v_{u(t)}}$ is the adjoint of $\mathcal{L}_{N}$ with respect to the measure $v_{u(t)}$ and $\Gamma_{N}(h)(\eta)=\mathcal{L}_{N} h^{2}(\eta)-2 h(\eta) \mathcal{L}_{N} h(\eta)$ is the carré du champ operator.

The forward Fokker-Plank equation tells us that $f_{t} \psi_{t}=\frac{\mathrm{d} \mu_{t}}{\mathrm{~d} \vartheta_{\alpha}}(\eta)$ is solution of $\frac{\mathrm{d}}{\mathrm{d} t}\left(f_{t} \psi_{t}\right)=\mathcal{L}_{N}^{*, \alpha}\left(f_{t} \psi_{t}\right)$, so that by deriving in time (4.24) we obtain

\end{align*}

Since $\int \mathcal{L}_{N}^{*, \alpha}\left(f_{t} \psi_{t}\right)(\eta) \vartheta_{\alpha}(\mathrm{d} \eta)=\int\left(f_{t} \psi_{t}\right)(\eta) \mathcal{L}_{N} \mathbf{1} \vartheta_{\alpha}(\mathrm{d} \eta)=0$ we get that the right term of 4.25) equals

& \leqslant \sum_{\eta^{\prime}} r\left(\eta, \eta^{\prime}\right)\left[\left(h\left(\eta^{\prime}\right)-h(\eta)\right)-\left(\sqrt{h\left(\eta^{\prime}\right)}-\sqrt{h(\eta)}\right)^{2}\right]=\mathcal{L}_{N} h(\eta)-\Gamma_{N}(\sqrt{h})(\eta)
\end{aligned}

Appling this result to the first term of the integral in (4.26) we get 4.23).
We define the current $\mathcal{J}_{t}=\mathcal{J}_{t}^{N}(\eta)$ as

Our main goal is to estimate the current $\mathcal{J}_{t}$ to control the right hand side of 4.23 ). In particular we show that

\end{equation*}

with $a \in(0,1)$ if $d \geqslant 2$ and $a \in\left(0, \frac{1}{2}\right)$ if $d=1$. Gronwall's inequality gives

Since $e^{C \ell_{\nu}^{d} t} \leqslant N^{C \delta t}$ by Assumption 1 the proof of Theorem 4.1 is complete.

### 4.1.1 The current $\mathcal{J}_{t}^{N}$

To control $\mathcal{L}_{N}^{*, v_{u(t)}} \mathbf{1}$ we have to compute the adjoint of $\mathcal{K}_{N}$ and of $\mathcal{G}_{N}$, cf. (4.1) ans (4.2). We follow the computations done in [8]. By Lemma 2.4 of [8], we get
where $(\Delta u)_{i}=\sum_{j \in \mathbb{T}_{N}^{d},|i-j|=1}\left(u_{j}-u_{i}\right)$ is the discrete Laplacian. Since $c_{0}$ satisfies the condition (1.5) of [8] (see Remark 4.1], by Lemma 2.5 of [8] we get

= & \sum_{i \in \mathbb{T}_{N}^{d}}\left(\left(c_{i}^{+}(\eta)-c_{i}^{+}(u)\right)\left(1-u_{i}\right)-\left(c_{i}^{-}(\eta)-c_{i}^{-}(u)\right) u_{i}\right) \omega_{i}  \tag{4.31}\\
& +\sum_{i \in \mathbb{T}_{N}^{d}}\left(c_{i}^{+}(u)\left(1-u_{i}\right)-c_{i}^{-}(u) u_{i}+\beta\left(1-2 u_{i}\right)\right) \omega_{i} .
\end{align*}

In the second equality we centered the variables $c_{i}^{+}(\eta) c_{i}^{-}(\eta)$ since under $v_{u}, c_{i}^{+}(\eta)$ and $c_{i}^{-}(\eta)$ are Bernouilli random variables with expectation $c_{i}^{+}(u)$ and $c_{i}^{-}(u)$ respectively. Finally, by Lemma 2.6 of [8] we get

where $G$ was defined in (4.9) and

V^{+}(u, \eta) & =\sum_{i \in \mathbb{T}_{N}^{d}}\left(c_{i}^{+}(\eta)-c_{i}^{+}(u)\right)\left(1-u_{i}\right) \omega_{i}  \tag{4.34}\\
V^{-}(u, \eta) & =\sum_{i \in \mathbb{T}_{N}^{d}}\left(c_{i}^{-}(\eta)-c_{i}^{-}(u)\right) u_{i} \omega_{i},  \tag{4.35}\\
V(u, \eta) & =-\alpha N^{2} \sum_{\substack{i, j \in \mathbb{T}_{N}^{d},|i-j|=1}}\left(u_{i}-u_{j}\right)^{2} \omega_{j} \omega_{i} . \tag{4.36}

In particular, if $u$ satisfies 4.10 the current reduces to the second line.
In the rest of the section we provide estimates of $V^{+}, V^{-}$and $V$.

### 4.1.2 Estimates of $V^{+}$and $V^{-}$

Let us denote $\left\{e_{1}, e_{2}, \ldots, e_{d}\right\}$ the canonical basis of $\mathbb{Z}^{d}$. For $\varphi: \mathbb{T}_{N}^{d} \rightarrow \mathbb{R}$ and $i \in \mathbb{T}_{N}^{d}$ and $k \in\{1, \ldots, d\}$, let $\nabla_{k} \varphi(i)=\varphi\left(i+e_{k}\right)-\varphi(i)$. We denote $\|\nabla \varphi\|_{\infty}=\max _{i, k}\left|\nabla_{k} \varphi(i)\right|$.

We note that

so that the bound for $V^{+}$can be transferred to $V^{-}$, see Remark 4.2. In the following we get an upper-bound for $V^{+}$. Denote $\vartheta_{i}^{+}=c_{i}^{+}(\eta)-c_{i}^{+}(u)$ and $\omega_{i}^{+}=\left(1-u_{i}\right) \omega_{i}=\frac{\eta_{i}-u_{i}}{u_{i}}$.

To bound $V^{+}(u, \eta)$ we follow the method used by Jara and Menezes [15] and by Funaki and Tsuneda [8]. For this purpose let us observe that the carré du champ referred to the generator $\mathcal{L}_{N}$, namely, $\Gamma_{N}(h)=\mathcal{L}_{N} h^{2}-2 h \mathcal{L}_{N} h$ can be decomposed as

In the next result we provide the control that we need for $V^{+}$.
Proposition 4.5. Under Assumption 1, we have that for any $u: \mathbb{T}_{N}^{d} \rightarrow[0,1]$ such that

1. $\varepsilon:=1-\| \| u \|_{\infty}>0$ with $\|\mid u\|_{\infty}:=\min \left\{\|u\|_{\infty},\|1-u\|_{\infty}\right\}$,
2. $\|\nabla u(i)\|_{\infty} \leqslant \frac{C_{0}}{N}$ with $C_{0}$ independent of $N$,
and for any density $f$ with respect to $v_{u}$ we have that

for any $\delta>0$ and $C_{1}=3^{d} d(d+1) \frac{6}{\varepsilon^{2}}\left(\frac{1}{\delta}+\frac{C_{0}}{\varepsilon^{2}}\right), C_{2}=\frac{6 C_{0}}{\varepsilon^{4}}$ for $N>\frac{2 C_{0}}{\varepsilon^{2}}$.
Remark 4.2. Note that if the estimate (4.41) holds, then it holds for $V^{-}$. Indeed, using (4.37), the fact that $\left\|\left|u\left\|_{\infty}=\right\|\right| 1-u\right\|_{\infty}=1-\varepsilon$ and that, under $v_{1-u}(\mathrm{~d} \eta), 1-\eta$ has for law $v_{u}$ we get

& =\delta N^{2} \int \Gamma_{N}^{\mathcal{K}}(\sqrt{f})(\eta) v_{u}(\mathrm{~d} \eta)+C_{1} \ell_{\mathcal{V}}^{d} \mathcal{H}\left(f v_{u} \mid v_{u}\right)+C_{2} N^{d-a}
\end{aligned}
$$

Proof of Proposition 4.5. The proof will proceed in several steps.
Note that, according to Hoeffeding Inequality (Lemma A.4, under the probability measure $v_{u}, \vartheta_{i}^{+}$is subGaussian with variance parameter $\frac{1}{4}$ and $\omega_{i}^{+}$is sub-Gaussian with variance parameter $\frac{1}{4 u_{i}^{2}}$.

As in Jara and Menezes [15], we proceed to use an averaged version of $V^{+}$. Let $\ell>0$ and consider $\Lambda_{\ell}=$ $\{0 \ldots, \ell-1\}^{d}$ the cube of size $\ell$ starting at 0 . Let $p_{\ell}(i)=\ell^{-d} \mathbb{1}_{\left\{i \in \Lambda_{\ell}\right\}}$ and $\hat{p}_{\ell}(i)=\ell^{-d} \mathbb{1}_{\left\{i \in-\Lambda_{\ell}\right\}}=p_{\ell}(-i)$. Then for $\varphi$ defined on $\mathbb{T}_{N}^{d}$, we set

Let us denote $q_{\ell}=p_{\ell} * p_{\ell}$. We have $q_{\ell}(i)=\ell^{-2 d}\left|\Lambda_{\ell} \cap\left(i-\Lambda_{\ell}\right)\right|$. Thus, $0 \leqslant q_{\ell}(i) \leqslant \ell^{-d}$ and $q_{\ell}(i)=0$ if and only if $i \notin \Lambda_{2 \ell-2}$. All sum being finite, we get for $\varphi$ and $\psi$ defined on $\mathbb{T}_{N}^{d}$ :

Thus let $V^{+, \ell}:=\sum_{i \in \mathbb{T}_{N}^{d}} \vartheta_{i}^{+} \omega_{i}^{+, \ell}$ with $\omega_{i}^{+, \ell}=\sum_{j} \omega_{i+j}^{+} q_{\ell}(j)$. We have that

Then Proposition 4.5 is proved with the following two estimates.

Suppose $\varepsilon=1-\| \| u \|_{\infty}>0$ and $\|\nabla u(i)\|_{\infty} \leqslant \frac{C_{0}}{N}$ for some $C_{0}>0$ independent of $N$, where $\nabla u(i)=\left(\nabla_{k} u(i)\right)_{k=1}^{d}$. Then, for any $\ell>\ell \mathcal{V}$, with $\ell=N^{\kappa}$ for some $\kappa>0$, and $\delta>0$

& +C_{1} \ell^{d} \mathcal{V} \frac{g_{d}(\ell) \ell^{d}}{N}\left(\left(2+\frac{\ell \mathcal{V}}{\ell}\right)^{d} \mathcal{H}\left(f v_{u} \mid v_{u}\right)+\frac{N^{d}}{\ell^{d}}\right)+C_{2} N^{d-1} \tag{4.46}
\end{align*}
$$

where $C_{2}=\frac{3 C_{0}}{\varepsilon^{4}}\left(1+\frac{2 C_{0}}{N \varepsilon^{2}}\right)$ and $C_{1}=3^{d} d(d+1)\left(\frac{2}{\delta \varepsilon^{2}}\left(1+\frac{C_{0}}{N \varepsilon^{2}}\right)+C_{2}\right)$ depends only on the dimension and $g_{d}(\ell)$ is defined in 4.50.

Indeed, we choose $\ell$ such that $\frac{\ell^{d} g_{d}(\ell)}{N} \leqslant C_{0}$ : more precisely, for any $\delta_{0} \in(0,1)$ we take

Since $\ell_{\nu}^{d}$ has a log-growth (cf. Assumption 1), this choice of $\ell$ together with Lemmas 4.6 and 4.7 concludes the proof of Proposition 4.5.

We now prove Lemma 4.6 and Lemma 4.7 .

Proof of Lemma 4.6. We start by recalling that $V^{+, \ell}=\sum_{i \in \mathbb{T}_{N}^{d}} \overleftarrow{\vartheta^{+}}{ }_{i} \vec{\omega}^{+}{ }_{i}$. Note that, under $v_{u}$, using Lemma A.3. $\vec{\omega}^{+}{ }_{i}$ is a sub-Gaussian variable with variance parameter $\sum_{i \in \Lambda_{\ell}} \frac{1}{4 u_{i}^{2} \ell^{2 d}} \leqslant \frac{1}{4 \varepsilon^{2} \ell^{d}}$.

Since $c_{i}^{+}(\eta)$ is a function of $\left(\eta_{i+j}\right)_{j \in \mathcal{V}_{N}}$, then for $i$ and $j$ such that $|i-j|_{\infty}>\ell_{\mathcal{V}}, \vartheta_{i}^{+}$and $\vartheta_{j}^{+}$are independent, and sub-Gaussian with variance parameter $\frac{1}{4}$. Using Lemma A.3. ${\overleftarrow{\vartheta^{+}}}_{i}$ is a sub-Gaussian variable with variance parameter $\frac{\ell_{V}^{d}}{4 \ell^{d}}\left(1+\frac{\ell_{V}}{\ell}\right)^{d} \leqslant 2^{d-2} \frac{\ell_{\nu}^{d}}{\ell^{d}}$.

We note that all the sites involved in the averages $\overleftarrow{\vartheta^{+}}{ }_{i} \vec{\omega}^{+}{ }_{i}$ are in $i+Q_{\ell_{\nu} / 2+\ell}$, where $Q_{m}=\{-m, \ldots, m\}^{d}$ is the $d$-dimensional cube centered at 0 . In particular, for $i$ and $j$ such that $|i-j|_{\infty}>\ell_{\mathcal{V}}+2 \ell$, the corresponding averages are independent (under $v_{u}$ ). Then, we can take a partition of $\mathbb{T}_{N}^{d}$ into independent sites by letting $i=j+\left(\ell_{\mathcal{\nu}}+2 \ell\right) k$ where $j \in \Lambda_{\ell_{\mathcal{V}}+2 \ell}$ and $k \in \Lambda_{\left[N /\left(\ell_{\mathcal{V}}+2 \ell\right)\right] \text {. The entropy inequality (cf. (B.3) in [15]) gives }}$

& \leqslant \sum_{j \in \Lambda_{\ell_{\mathcal{V}}+2 \ell}} \frac{1}{\gamma}\left(\mathcal{H}\left(f v_{u} \mid v_{u}\right)+\sum_{k \in \Lambda_{\left[N /\left(\ell_{\mathcal{V}}+2 \ell\right)\right\rceil}} \log \int \exp \left\{\gamma \vartheta^{+}{ }_{j+\left(\ell_{\mathcal{V}}+2 \ell\right) k}{\overrightarrow{\omega^{+}}}_{j+\left(\ell_{\mathcal{V}}+2 \ell\right) k}\right\} v_{u}(\mathrm{~d} \eta)\right) \\
& \leqslant \frac{\left(\ell_{\mathcal{V}}+2 \ell\right)^{d}}{\gamma} \mathcal{H}\left(f v_{u} \mid v_{u}\right)+\frac{1}{\gamma} \sum_{i \in \mathbb{T}_{N}^{d}} \log \int \exp \left\{\gamma{\vartheta^{+}}^{i}{ }_{i \omega^{+}}{ }_{i}\right\} v_{u}(\mathrm{~d} \eta)
\end{aligned}
$$

According to Lemma A.2, for $\gamma^{-1}=2^{d / 2+2} \ell^{-d} \varepsilon^{-1} \ell_{\mathcal{V}}^{d / 2}$, we have $\log \int \exp \left\{\gamma \overleftrightarrow{\vartheta^{+}}{ }_{i} \overrightarrow{\omega^{+}}{ }_{i}\right\} v_{u}(\mathrm{~d} \eta) \leqslant \log 3$. Thus we obtain

Proof of Lemma 4.7. We first prove the Lemma by also assuming that $\mathcal{V}_{N} \subset \mathbb{Z}^{d} \backslash \mathbb{N}^{d}$. In Remark 4.3 at the end of the proof we show how to remove this assumption in dimension $d>1$.

We then proceed as in Jara and Menezes [15]. We use the fact that

- $\sum_{j:|i-j|=1} \Phi_{\ell}(i, j)=\mathbb{1}_{\{0\}}(i)-q_{\ell}(i)$
- $\Phi_{\ell}(i, j)=0$ for $i, j \notin \Lambda_{2 \ell-1}$
- there is a constant $C=C(d)$ independent of $\ell$ such that

& =\sum_{k=1}^{d} \sum_{i, j \in \mathbb{T}_{N}^{d}} \vartheta_{i-j}^{+} \Phi_{\ell}\left(j, j+e_{k}\right)\left(\omega_{i}^{+}-\omega_{i+e_{k}}^{+}\right) \\
& =\sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}} h_{i}^{k}\left(\omega_{i}^{+}-\omega_{i+e_{k}}^{+}\right) \tag{4.51}
\end{align*}

To complete the result we need to estimate (4.51). We apply Lemma 3.5 of [8]. Note that the hypothesis of Lemma 3.5 are satisfied in our case: $u_{-}=\varepsilon$ and $u_{+}=1-\varepsilon$ and $h_{i}^{k}\left(\eta^{i, i+e_{k}}\right)=h_{i}^{k}(\eta)$ for any configuration $\eta$ inasmuch $h_{i}^{k}$ is only a function of the sites $\eta_{i-j+s}$, for $s \in \mathcal{V}_{N}, j \in \Lambda_{2 \ell-1}$, so that it does not depend on $\eta_{i}$ and $\eta_{i+e_{k}}$ since $\mathcal{V}_{N} \subset \mathbb{Z}^{d} \backslash \mathbb{N}^{d}$. Moreover, we observe that Lemmas 3.4 and 3.5 apply to our case replacing $\chi\left(u_{i}\right)$ by $u_{i}$. Therefore, for any $\alpha^{\prime}>0$ we have that

with $C_{1, \varepsilon}=\frac{2}{\varepsilon^{2}}\left(1+\frac{C_{0}}{N \varepsilon^{2}}\right)$ and where the rest term $R_{i}^{k}$ is controlled as

The first term is the same of (4.46), then to conclude the proof we have to upper bound the second and the third term of 4.55).

& =\frac{(2 \ell+\ell \mathcal{V})^{d}}{\gamma} \mathcal{H}\left(f v_{u} \mid v_{u}\right)+\frac{1}{\gamma} \sum_{i \in \mathbb{T}_{N}^{d}} \log \left\{\exp \left\{\gamma\left(h_{i}^{k}\right)^{2}\right\} v_{u}(\mathrm{~d} \eta)\right.
\end{align*}

To conclude we use a concentration inequality. We have that $h_{i}^{k}$ is sub-Gaussian random variable, let $\sigma^{2}$ be its variance parameter. By Proposition A.1 we have that for any $\gamma \leqslant \frac{1}{4 \sigma^{2}}$,

By getting $\gamma$ as large as possible, namely $\gamma^{-1}=(d+1) \ell_{\mathcal{V}}^{d} g_{d}(\ell)$ we obtain that

Remark 4.3. By (4.51) we recall that $V^{+}-V^{+, \ell}=\sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}} h_{i}^{k}\left(\omega_{i}^{+}-\omega_{i+e_{k}}^{+}\right)$where $h_{i}^{k}$ is defined in 4.52). We also observe that, by assumption, $\ell>\ell_{\mathcal{V}}$. Since $h_{i}^{k}$ is a function of the sites $\eta_{i-j+s}$, for $s \in \mathcal{V}_{N}, j \in \Lambda_{2 \ell-1}$, whenever $|j|>\ell_{\mathcal{V}}$, then $\vartheta_{i-j}^{+}$does not depend on $\eta_{i}$ and $\eta_{i+e_{k}}$. Therefore we split $h_{i}^{k}$ into the sum of two functions $h_{i}^{\prime}$ and $h_{i}^{\prime \prime}$. The first one is independent of $\eta_{i}$ and $\eta_{i+e_{k}}$, while the second one depends on these sites,

& \leqslant\left(\sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}}\left(\int\left(h_{i}^{\prime \prime}\right)^{2} f v_{u}(\mathrm{~d} \eta)\right) \sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}}\left(\int\left(\omega_{i}^{+}-\omega_{i+e_{k}}^{+}\right)^{2} f v_{u}(\mathrm{~d} \eta)\right)\right)^{\frac{1}{2}} \tag{4.62}

& =\sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}}\left\{\widetilde{\omega}_{i}^{k} \omega_{i+e_{k}}+\widetilde{\omega}_{i-e_{k}}^{k} \omega_{i}\right\}=2 \sum_{k=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}} \widetilde{\omega}_{i-e_{k}}^{k} \omega_{i} .

For $k \in\{1, \ldots, d\}$ we let $\tilde{V}^{k}:=\sum_{i \in \mathbb{T}_{N}^{d}} \widetilde{\omega}_{i-e_{k}}^{k} \omega_{i}$ and $\widetilde{V}^{k, \ell}:=\sum_{i \in \mathbb{T}_{N}^{d}} \widetilde{\omega}_{i-e_{k}}^{k} \overrightarrow{\omega_{i}}$. We estimate $\tilde{V}^{k, \ell}$ and $\widetilde{V}^{k}-\tilde{V}^{k, \ell}$ separately by showing that they satisfy (4.45) and (4.46) respectively.

For $\widetilde{V}^{k, \ell}$, by Lemma A.4 we have that $\widetilde{\omega}_{i}^{k}$ is a sub-Gaussian random variable with variance parameter $\sigma_{i}^{2} \leqslant \frac{C_{0}^{2}}{\varepsilon^{2}}$ (we used the assumption on $\left|\nabla_{k} u_{i}\right|$ and that $\chi(u)>\frac{\varepsilon}{2}$ ), while we recall that $\omega_{i}$ is a sub-Gaussian random variable with variance parameter $\frac{1}{4}$. Therefore, $\overleftarrow{\tilde{\omega}_{i}^{k}}$ is a sub-Gaussian random variable with variance parameter $\sum_{i \in \Lambda_{\ell}} \frac{\sigma_{i}^{2}}{\ell^{2 d}} \leqslant \frac{C_{0}^{2}}{\varepsilon^{2} \ell^{d}}$ and $\overrightarrow{\omega_{i}}$ is also a sub-Gaussian random variable with variance parameter $\frac{1}{4 \ell^{d}}$.

Note that the averages $\stackrel{\widetilde{\omega}_{i-e_{k}}^{k}}{\overrightarrow{\omega_{i}}}$ are in $i+Q_{\ell}$, so that for $i$ and $j$ such that $|i-j|_{\infty}>2 \ell$, the corresponding averages are independent (under $v_{u}$ ). Then, we can partition $\mathbb{T}_{N}^{d}$ into independent blocks by letting $i=j+(2 \ell) k$ where $j \in \Lambda_{2 \ell}$ and $k \in \Lambda_{[N /(2 \ell)]}$. Therefore, as in the proof of Lemma 4.6 the entropy inequality gives

& \leqslant c N^{2} \int \Gamma_{N}^{\mathcal{K}}(\sqrt{f}) v_{u}(\mathrm{~d} \eta)+\frac{c}{N} \sum_{m=1}^{d} \sum_{i \in \mathbb{T}_{N}^{d}} \int\left(\tilde{h}_{i}^{m}\right)^{2} f v_{u}(\mathrm{~d} \eta)+N^{d-1}
\end{aligned}
$$

To conclude the proof, for $m \in\{1, \ldots, d\}$, we bound $\sum_{i \in \mathbb{T}_{N}^{d}} \int\left(\widetilde{h}_{i}^{m}\right)^{2} f v_{u}(\mathrm{~d} \eta)$. An application of the entropy inequality gives

$$
\sum_{i \in \mathbb{T}_{N}^{d}} \int\left(\widetilde{h}_{i}^{m}\right)^{2} f v_{u}(\mathrm{~d} \eta) \leqslant \frac{c \ell^{d}}{\gamma} \mathcal{H}\left(f v_{u} \mid v_{u}\right)+\frac{c}{\gamma} \sum_{i \in \mathbb{T}_{N}^{d}} \log \int \exp \left\{\gamma\left(\widetilde{h}_{i}^{m}\right)^{2}\right\} v_{u}(\mathrm{~d} \eta)
$$

By Lemma F. 12 in [15] we then have that $\widetilde{h}_{i}^{m}$ is a sub-Gaussian random variable with $\sigma^{2} \leqslant C_{d, \varepsilon} g_{d}(\ell)$. We can take $\gamma^{-1}=C_{d, \varepsilon} g_{d}(\ell)$ and conclude that

$$
\sum_{i \in \mathbb{T}_{N}^{d}} \int\left(\widetilde{h}_{i}^{m}\right)^{2} f v_{u}(\mathrm{~d} \eta) \leqslant C g_{d}(\ell) \ell^{d}\left(\mathcal{H}\left(f v_{u} \mid v_{u}\right)+\frac{N^{d}}{\ell^{d}} \log 3\right)
$$

in particular 4.46) is satisfied. This implies that $V(u, \eta)$ satisfies (4.41).

### 4.1.4 Conclusion: Gronwall's inequality 4.28)

We observe that since $\Gamma_{N}^{\mathcal{K}}(\sqrt{f}) \leqslant \Gamma_{N}(\sqrt{f})$, cf. 4.39 and that the carré du champ operator is non-negative, 4.28) is a consequence of Propositions 4.3 and 4.5 with $u(t)=u^{N}(t)$, the solutions of 4.10), $f=\frac{\mathrm{d} \mu_{t}}{\mathrm{~d} v_{u(t)}}$ if we show that $u^{N}$ satisfies Assumption 2 for any $t \in[0, \tau]$. This is one of the goal of the Section 5 , see Propositions 5.2 and 5.3 .

## 5 Estimates on the solutions $\left(u^{N}\right)$ of (4.10)

Note that (4.10) is a first order ordinary differential equation in $\mathbb{R}^{T^{d}}$. By standard theory, we have a solution, locally in time, starting from every initial condition.

We say that $u$ is supersolution of (4.10) if $\partial_{t} u_{i} \geqslant 2 \alpha N^{2}(\Delta u)_{i}+\beta\left(1-2 u_{i}\right)+G(i, u)$ and that it is a subsolution if $\partial_{t} u_{i} \leqslant 2 \alpha N^{2}(\Delta u)_{i}+\beta\left(1-2 u_{i}\right)+G(i, u)$.

Note that any solution is both a super- and a subsolution. We have a comparaison lemma between super and subsolutions.

Proposition 5.1. Let $u$ be a supersolution, and $v$ be a subsolution such that $u(0, i) \geqslant v(0, i)$ for all $i \in \mathbb{T}_{N}^{d}$. Then, for all $t \geqslant 0$ and all $i \in \mathbb{T}_{N}^{d}, u(t, i) \geqslant v(t, i)$.

Proof. Since $u$ and $v$ have derivative in time they are continuous, consider $i$ and $t$ such that $u(t, i)=v(t, i)$ and $u(t, j) \geqslant v(t, j)$. Then, we have $G(i, u(t)) \geqslant G(i, v(t))$ by Proposition B.1, and thus

$$
\begin{equation*}
\partial_{t}(u(i, t)-v(i, t))=2 \alpha N^{2} \sum_{j,|i-j|=1}(u(j, t)-v(j, t))+G(i, u(t))-G(i, v(t)) \geqslant 0 \tag{5.1}
\end{equation*}
$$

This proves that $u$ stays above $v$ at all time.
From the two previous propositions we conclude :
Proposition 5.2. Let $\delta=\frac{\beta}{1+4 \beta}$ and suppose $0<\delta<\frac{1}{4 e}$. Let also $4 \delta \leqslant T \leqslant 1-4 \delta$ and $0 \leqslant \varepsilon<2 \delta$. For all $K_{N}>\frac{|\log (\varepsilon / 2)|}{\varepsilon^{2}}$, and all $N$, consider the solution $\left(u^{N}(t, i)\right)_{i \in \mathbb{T}_{N}^{d}}$ of Equation 4.10 starting from $u_{0} \in[\varepsilon, 1-\varepsilon]$, then we have that $u^{N}(t, i) \in[\varepsilon, 1-\varepsilon]$ for all $i$ and $t \geqslant 0$.

Note that the proposition holds for $\varepsilon=0$.
Proof. Let $p \in[0,1]$, and set $u(i)=p$, for all $i$. Using that $g_{K_{N}}(p)=G(i, p)$, we have that

- if $g_{K_{N}}(p)+\beta(1-2 p) \geqslant 0$, then $u$ is a subsolution;
- if $g_{K_{N}}(p)+\beta(1-2 p) \leqslant 0$, then $u$ is a supersolution.

Then, by using the result of Proposition B.2 on the analysis of $g_{K}(p)$ close to $p=0$ and $p=1$, it is easy to check that $u(i)=\varepsilon$ is a subsolution and $u(i)=1-\varepsilon$ is supersolution, for $\varepsilon$ satisfying the hypothesis of the proposition.

In particular, for $p=1, g_{K_{N}}(1)=0$, we have a supersolution. For $p=0, g_{K_{N}}(0)=0$, we have a subsolution.

In the next result, we show that if $u$ solves 4.10) and $\|\nabla u(0, i)\|_{\infty} \leqslant \frac{C}{N}$, then $\|\nabla u(t, i)\|_{\infty} \leqslant \frac{C \sqrt{t}}{N}$ for any $t>0$.
Proposition 5.3. Let $u$ be a solution of (4.10 with $u(0)=u_{0}$ such that, there exists $C_{0}>0$ for which $\left|\nabla u_{0}\right|_{\infty} \leqslant \frac{C_{0}}{N}$. Then, there exists $C>0$ such that $\|\nabla u(t, i)\|_{\infty} \leqslant \frac{C_{0}+C \sqrt{t}}{N}$ for all $t \geqslant 0$.

To prove Proposition 5.3 we follow [8] and the reference therein, in particular [7]. Using the notation of [7] we let $p(t, x, z)$ be the heat kernel of discrete Laplacian

$$
\begin{equation*}
\Delta u(t, i)=\sum_{j \in \mathbb{Z}^{d}} a(t, i, i+j)[u(t, i+j)-u(t, i)] \tag{5.2}
\end{equation*}
$$

with $a(t, i, j)=\mathbb{1}_{\{j-i \in \Gamma\}}$ and $\Gamma=\left\{ \pm e_{i}, i=1, \ldots, d\right\}$, that is,

$$
\left\{\begin{array}{l}
p\left(\cdot, i_{0}, i\right)=\delta_{i_{0}}(\cdot) \\
\partial_{t} p\left(t, i_{0}, i\right)=\Delta p\left(t, i_{0}, i\right)
\end{array}\right.
$$

In this case (comments below (1.2) of [7]) we have that $a^{*}(t, i, j)=a(t, i, j)$ so that $p^{*}(t, i, j)=p(t, i, j)$. Let $\nabla_{k} u(t, i)=u\left(t, i+e_{k}\right)-u(t, i)$, then since $p$ is a uniform transitions function, there exist $c, C>0$ independent of $t, k$ such that (cf. (1.3) of [7])

$$
\begin{equation*}
\left|\nabla_{k} p(t, 0, i)\right| \leqslant C \frac{p(c t, 0, i)}{\sqrt{1 \vee t}} \tag{5.3}
\end{equation*}
$$

We refer to [7], Section 4 and the reference therein for a proof. We stress that the delicate point is to extend the classical theory of E. De Giorgi, J. Nash and J. Moser to discrete operators. The authors follow mainly [6], but similar results can be also found in [10] (Appendix B) and [23].

Proof of Proposition 5.3. Using Duhamel's formula (i.e., variation of constant) we get that

$$
\begin{equation*}
u(t, i)=\sum_{j \in \mathbb{T}_{N}^{d}} u(0, j) p_{N}(t, i, j)+\int_{0}^{t} \mathrm{~d} s \sum_{j \in \mathbb{T}_{N}^{d}}\left(\beta\left(1-2 u_{j}\right)+G_{j}(u)\right) p_{N}(t-s, i, j), \tag{5.4}
\end{equation*}
$$

where $p_{N}(t, i, j)=\sum_{z \in N \mathbb{Z}^{d}} p\left(2 \alpha N^{2} t, i, j+z\right)$ is the heat kernel of discrete Laplacian on the torus speeds up by a factor $2 \alpha N^{2}$ and $p(t, i, j)$ is the heat kernel introduced above. We observe that 5.3 gives

$$
\begin{equation*}
\left|\nabla_{k} p_{N}(t, 0, i)\right| \leqslant \frac{C}{N} \frac{p_{N}(c t, 0, i)}{\sqrt{t}} \tag{5.5}
\end{equation*}
$$

For the first term, using that $p_{N}(t, i, j)=p_{N}(t, i+z, j+z)$ for any $i, j, z \in \mathbb{T}_{N}^{d}$ and the assumption on $\nabla u_{0}$ (cf. Assumptions 22, an integration by parts gives

$$
\begin{aligned}
\left|\nabla_{k}\left\{\sum_{j \in \mathbb{T}_{N}^{d}} u(0, j) p_{N}(t, i, j)\right\}\right| & =\left|\sum_{j \in \mathbb{T}_{N}^{d}} u(0, j)\left(p_{N}\left(t, i+e_{k}, j\right)-p_{N}(t, i, j)\right)\right| \\
& =\left|\sum_{j \in \mathbb{T}_{N}^{d}} u(0, j) p_{N}\left(t, i, j-e_{k}\right)-\sum_{j \in \mathbb{T}_{N}^{d}} u(0, j) p_{N}(t, i, j)\right| \\
& =\left|\sum_{j \in \mathbb{T}_{N}^{d}}\left(u\left(0, j+e_{k}\right)-u(0, j)\right) p_{N}(t, i, j)\right| \leqslant \frac{C}{N} .
\end{aligned}
$$

By using that $\left(\beta\left(1-2 u_{j}\right)+G_{j}(u)\right)$ is bounded and (5.5) we get that for any $k=1, \ldots, d$,

$$
\left|\nabla_{k}\left\{\int_{0}^{t} \mathrm{~d} s \sum_{j \in \mathbb{T}_{N}^{d}}\left(\beta\left(1-2 u_{j}\right)+G_{j}(u)\right) p_{N}(t-s, i, j)\right\}\right| \leqslant \frac{C}{N} \int_{0}^{t} \frac{1}{\sqrt{t-s}} \mathrm{~d} s=\frac{C}{N} \sqrt{t}
$$

## 6 Existence and uniqueness of reaction-diffusion PDE

In Section 7, we prove that in the limit $N \rightarrow \infty$, the solution of the discretized Equation 4.10, with $u^{N}(t=0)=$ $u_{0}^{N} \in[0,1]^{\mathbb{T}_{N}^{d}}$ satisfying Assumption 2 converges to a solution of the scalar nonlinear reaction diffusion equation

- when $K_{N} \rightarrow K$ as $N \rightarrow \infty$ :

$$
\begin{equation*}
\partial_{t} u(t, x)=2 \alpha \Delta u(t, x)+\beta(1-2 u(t, x))+g_{K}(u(t, x)), \tag{6.1}
\end{equation*}
$$

- when $K_{N} \rightarrow \infty$ as $N \rightarrow \infty$ :

$$
\begin{equation*}
\partial_{t} u(t, x)=2 \alpha \Delta u(t, x)+\beta(1-2 u(t, x))+g_{\infty}(u(t, x)) . \tag{6.2}
\end{equation*}
$$

The main difference between the two equations is that in the first case $(K<+\infty), g_{K}$ is a $C^{1}$ function on $[0,1]$ (thus Lipschitz) so the reaction diffusion equation (6.1) is very classical, whereas for the second case $(K=+\infty)$, since $g_{\infty}$ is not even continuous we need to consider (6.2) as a subdifferential inclusion.

The main results of this section are
(i) Proposition 6.3 which proves existence of a solution, in a suitable sense, for the equation 6.2),
(ii) Proposition 6.4 which proves local uniqueness of the solution, in a suitable sense, for the equation 6.2, starting from a suitable class of initial conditions,
(iii) and Theorem 7.1 which proves that all accumulation points of $\left(u^{N}\right)_{N}$ is a solution, in a suitable sense, for the equation (6.2).

In the rest of this section we change our notations and define $v=2 u-1$. We center the solution around the constant steady state $u=\frac{1}{2}$. It simplifies the presentation and proofs of our results. The original form of our equations can be retrieved by letting $u=\frac{1}{2}(v+1)$. In such a way (6.1) takes the form

$$
\begin{equation*}
\partial_{t} v(t, x)-2 \alpha \Delta v(t, x)+2 \beta v-2 g_{K}\left(\frac{1}{2}(v+1)\right)=0 . \tag{6.3}
\end{equation*}
$$

### 6.1 Solution of (6.1)

Let us denote $s(t, x, y)$ the semigroup of the operator $\frac{1}{2} \Delta$ on $\mathbb{T}^{d}$, that is,

$$
\begin{equation*}
s(t, x, y)=\frac{1}{(2 \pi t)^{d / 2}} \sum_{k \in \mathbb{Z}^{d}} \exp \left(-\frac{\|x-y-k\|^{2}}{2 t}\right) . \tag{6.4}
\end{equation*}
$$

Denote also $s_{0}(t, x, y)$ the semigroup of the operator $\frac{1}{2} \Delta$ on $\mathbb{R}^{d}$,

$$
\begin{equation*}
s_{0}(t, x, y)=\frac{1}{(2 \pi t)^{d / 2}} \exp \left(-\frac{\|x-y\|^{2}}{2 t}\right) . \tag{6.5}
\end{equation*}
$$

Note that $\xi \mapsto s_{0}(t, 0, \xi)$ is the density of $d$ independent normal random variables with variance $t$.
Let us consider $\left(S_{t}^{\lambda, \gamma}\right)$ the semigroup on $L^{1}\left(\mathbb{T}^{d}\right)$ defined by, for $f \in L^{1}\left(\mathbb{T}^{d}\right), \lambda \geqslant 0$ and $\gamma>0$

$$
\begin{equation*}
S_{t}^{\lambda, \gamma} f(x)=\int_{\mathbb{T}^{d}} e^{-\lambda t} s(\gamma t, x, y) f(y) \mathrm{d} y=\int_{\mathbb{R}^{d}} e^{-\lambda t} s_{0}(\gamma t, x, y) \tilde{f}(y) \mathrm{d} y \tag{6.6}
\end{equation*}
$$

where for a measurable function $f$ on $\mathbb{T}^{d}$, we denoted $\tilde{f}$ its extension on $\mathbb{R}^{d}$ defined by $\tilde{f}(x)=f(x-\lfloor x\rfloor)$.
Another way to define $S_{t}^{\lambda, \gamma}$ is to use the Brownian motion: denote by $X$ a Brownian motion on $\mathbb{R}^{d}$ starting from $x$ on some probability space $\left(\Omega, \mathcal{F}, \mathbb{P}_{x}\right)$, indeed we have $S_{t}^{\lambda, \gamma} f(x)=e^{-\lambda t} \mathbb{E}_{x}\left(\tilde{f}\left(X_{\gamma t}\right)\right)$, and for all $\lambda \geqslant 0$, and $\gamma>0, S^{\lambda, \gamma}$ is a $C_{0}$-contraction semigroup on $L^{p}\left(\mathbb{T}^{d}\right)$ for $p \in[1,+\infty]$.

As we will look at $\sqrt{6.1}$ in its mild form, the following result is crucial to study the regularity of the solution.

Proposition 6.1. For $v_{0} \in L^{\infty}\left(\mathbb{T}^{d}\right)$ and $g \in L^{\infty}\left([0, T] \times \mathbb{T}^{d}\right)$, define

$$
\begin{equation*}
v(t, x):=S_{t}^{\lambda, \gamma} v_{0}(x)+\int_{0}^{t} S_{t-s}^{\lambda, \gamma}(g(s, \cdot))(x) \mathrm{d} s \tag{6.7}
\end{equation*}
$$

then $v \in C\left([0, T], \mathbb{T}^{d}\right)$. We have the following estimates, for all $(t, x) \in \mathbb{R}^{+} \times \mathbb{T}^{d}$,

$$
\begin{equation*}
|v(t, x)| \leqslant e^{-\lambda t}\left\|v_{0}\right\|_{\infty}+\frac{1}{\lambda}\left(1-e^{-\lambda t}\right)\|g\|_{\infty} \leqslant\left\|v_{0}\right\|_{\infty}+\frac{1}{\lambda}\|g\|_{\infty} \tag{6.8}
\end{equation*}
$$

and for all $T>0$, there exists a constant $C$ depending only on $T, \gamma, \lambda$ and $d$, such that for all $(t, x),(s, y) \in$ $[1 / T, T] \times \mathbb{T}^{d}$ with $s<t$

$$
\begin{equation*}
|v(t, x)-v(s, y)| \leqslant C((t-s)|\log (t-s)|+\|x-y\|)\left(\|g\|_{\infty}+\left\|v_{0}\right\|_{\infty}\right) \tag{6.9}
\end{equation*}
$$

Remark 6.1. $v$ is called a mild solution of the equation $\partial_{t} v-\frac{\gamma}{2} \Delta v+\lambda v=g$ with initial value $v_{0}$. The fact that a mild solution is a classical solution if $g$ is sufficiently regular is a result from Pazy ([20], Corollary 4.2.5).
Proof of Proposition 6.1. The fact that $v \in C\left([0, T], L^{\infty}\left(\mathbb{T}^{d}\right)\right)$ is a consequence of the fact that $S^{\lambda, \gamma}$ is a $C_{0}$ contraction semigroups on $L^{\infty}$. For the first estimate (6.8), we have that :

$$
\begin{aligned}
|v(t, x)| & \leqslant\left|S_{t}^{\lambda, \gamma} v_{0}(x)\right|+\left|\int_{0}^{t} S_{t-u}^{\lambda, \gamma}(g(u, \cdot))(x) \mathrm{d} u\right| \\
& \leqslant e^{-\lambda t}\left\|v_{0}\right\|_{\infty} \int_{\mathbb{R}^{d}} s_{0}(\gamma t, x, z) \mathrm{d} z+\|g\|_{\infty} \int_{0}^{s} e^{-\lambda(t-u)} \int_{\mathbb{R}^{d}} s_{0}(\gamma(t-u), x, z) \mathrm{d} z \mathrm{~d} u \\
& =e^{-\lambda t}\left\|v_{0}\right\|_{\infty}+\frac{1}{\lambda}\left(1-e^{-\lambda t}\right)\|g\|_{\infty} .
\end{aligned}
$$

For the estimate (6.9), we start by letting $s<t$, we have

$$
\begin{aligned}
|v(t, x)-v(s, y)| & \leqslant\left|S_{t}^{\lambda, \gamma} v_{0}(x)-S_{s}^{\lambda, \gamma} v_{0}(y)\right|+\left|\int_{0}^{t} S_{t-u}^{\lambda, \gamma}(g(u, \cdot))(x) \mathrm{d} u-\int_{0}^{s} S_{s-u}^{\lambda, \gamma}(g(u, \cdot))(y) \mathrm{d} u\right| \\
& \leqslant I_{1}\left\|v_{0}\right\|_{\infty}+\left(I_{2}+I_{3}\right)\|g\|_{\infty}
\end{aligned}
$$

where

$$
\begin{aligned}
& I_{1}=\int_{\mathbb{R}^{d}}\left|e^{-\lambda t} s_{0}(\gamma t, x, z)-e^{-\lambda s} s_{0}(\gamma s, y, z)\right| \mathrm{d} z \\
& I_{2}=\int_{0}^{s} \int_{\mathbb{R}^{d}}\left|e^{-\lambda(t-u)} s_{0}(\gamma(t-u), x, z)-e^{-\lambda(s-u)} s_{0}(\gamma(s-u), y, z)\right| \mathrm{d} z \mathrm{~d} u \\
& I_{3}=\int_{s}^{t} \int_{\mathbb{R}^{d}} e^{-\lambda(t-u)} s_{0}(\gamma(t-u), x, z) \mathrm{d} z \mathrm{~d} u
\end{aligned}
$$

We have that $I_{3} \leqslant t-s$. For $I_{1}$ and $I_{2}$, we use the fact that, for $i=1 \ldots d$

$$
\begin{aligned}
\partial_{t} s_{0}(t, 0, \xi) & =\frac{1}{2} \Delta_{\xi} s_{0}(t, 0, \xi)=\frac{1}{2}\left(\frac{\|\xi\|^{2}}{t^{2}}-\frac{d}{t}\right) s_{0}(t, 0, \xi) \\
\partial_{\xi_{i}} s_{0}(t, 0, \xi) & =-\frac{\xi_{i}}{t} s_{0}(t, 0, \xi)
\end{aligned}
$$

First for $I_{1}$, denote $c_{1}(r)=r t+(1-r) s$ and $\left.c_{2}(r)=r(z-x)+(1-r)(z-y)\right)=z-(r x+(1-r) y)$ for $r \in[0,1]$, We have that

$$
\begin{aligned}
&\left|\left(\partial_{t} s_{0}\right)\left(\gamma c_{1}(r), 0, c_{2}(r)\right)\right| \leqslant \frac{1}{2}\left(\frac{\left\|c_{2}(r)\right\|^{2}}{\gamma^{2} c_{1}(r)^{2}}+\frac{d}{\gamma c_{1}(r)}\right) s_{0}\left(\gamma c_{1}(r), 0, c_{2}(r)\right) \\
&\left|\left(\partial_{\xi_{i}} s_{0}\right)\left(\gamma c_{1}(r), 0, c_{2}(r)\right)\right| \leqslant \frac{\left|c_{2}(r)_{i}\right|}{\gamma c_{1}(r)} s_{0}\left(\gamma c_{1}(r), 0, c_{2}(r)\right)
\end{aligned}
$$

Therefore

$$
\begin{aligned}
I_{1}= & \int_{\mathbb{R}^{d}}\left|e^{-\lambda t} s_{0}(\gamma t, 0, z-x)-e^{-\lambda s} s_{0}(\gamma s, 0, z-y)\right| \mathrm{d} z \\
\leqslant & \int_{\mathbb{R}^{d}} \int_{0}^{1}\left|c_{1}^{\prime}(r) \partial_{t}\left(e^{-\lambda t} s_{0}(\gamma t, 0, \xi)\right)_{\mid t=c_{1}(r), \xi=c_{2}(r)}\right| \mathrm{d} r \mathrm{~d} z \\
& +\int_{\mathbb{R}^{d}} \int_{0}^{1} \sum_{i=1}^{d}\left|c_{2}^{\prime}(r)_{i} \partial_{\xi_{i}}\left(e^{-\lambda t} s_{0}(\gamma t, 0, \xi)\right)_{\mid t=c_{1}(r), \xi=c_{2}(r)}\right| \mathrm{d} r \mathrm{~d} z \\
\leqslant & I_{1,1}+I_{1,2}
\end{aligned}
$$

where we have, by applying Fubini and a change of variable

$$
\begin{aligned}
I_{1,1} & =(t-s) \int_{\mathbb{R}^{d}} \int_{0}^{1}\left[\lambda e^{-\lambda c_{1}(r)}+\frac{\gamma}{2}\left(\frac{\left\|c_{2}(r)\right\|^{2}}{c_{1}(r)^{2}}+\frac{d}{c_{1}(r)}\right)\right] s_{0}\left(\gamma c_{1}(r), 0, c_{2}(r)\right) \mathrm{d} r \mathrm{~d} z \\
& \leqslant(t-s) \int_{0}^{1}\left[\lambda e^{-\lambda c_{1}(r)}+\frac{\gamma}{2}\left(\frac{d \gamma c_{1}(r)}{\gamma^{2} c_{1}(r)^{2}}+\frac{d}{\gamma c_{1}(r)}\right)\right] \mathrm{d} r \\
& \leqslant(t-s) \int_{0}^{1}\left[\lambda e^{-\lambda c_{1}(r)}+\frac{d}{c_{1}(r)}\right] \mathrm{d} r=\int_{s}^{t}\left(\lambda e^{-\lambda u}+\frac{d}{u}\right) \mathrm{d} u=e^{-\lambda s}\left(1-e^{-\lambda(t-s)}\right)+d \log \left(\frac{t}{s}\right) \\
& \leqslant\left(\lambda+\frac{d}{s}\right)(t-s) .
\end{aligned}
$$

For the term $I_{1,2}$, we get, using Cauchy-Schwarz, Fubini and a change of variable

I_{1,2} & =\int_{\mathbb{R}^{d}} \int_{0}^{1} \sum_{i=1}^{d}\left|y_{i}-x_{i}\right| e^{-\lambda c_{1}(r)} \frac{\left|c_{2}(r)_{i}\right|}{\gamma c_{1}(r)} s_{0}\left(\gamma c_{1}(r), 0, c_{2}(r)\right) \mathrm{d} r \mathrm{~d} z \\
& \leqslant\|x-y\| \int_{0}^{1} \frac{e^{-\lambda c_{1}(r)}}{\gamma c_{1}(r)} \int_{\mathbb{R}^{d}}\left\|c_{2}(r)\right\| s_{0}\left(\gamma c_{1}(r), 0, c_{2}(r)\right) \mathrm{d} z \mathrm{~d} r=\|x-y\| \int_{0}^{1} \frac{e^{-\lambda c_{1}(r)}}{\sqrt{\gamma c_{1}(r)}} \mathrm{d} r C_{1} \\
& \leqslant C_{1}\|x-y\| \int_{s}^{t} \frac{e^{-\lambda u}}{\sqrt{\gamma u}} \frac{\mathrm{~d} u}{t-s} \leqslant \frac{C_{1}}{\sqrt{\gamma s}}\|x-y\|
\end{aligned}
$$

where $C_{1}$ is the expectation of the quadratic norm of $X=\left(X_{1}, X_{2}, \ldots X_{d}\right)$ of $d$ independent standard normal variables : $C_{1}=\mathbb{E}(\|X\|) \leqslant \mathbb{E}\left(\|X\|^{2}\right)^{1 / 2}=\sqrt{d}$ (we also have $\left.C_{1}=\sqrt{2} \frac{\Gamma((d+1) / 2)}{\Gamma(d / 2)} \sim \sqrt{d}\right)$. We get that, for $s \geqslant \frac{1}{T}$,

For $I_{2}$, we make the same computations with $c_{1}(r)=r(t-u)+(1-r)(s-u)=r t+(1-r) s-u$ where $u \in[0, s]$, we have, since $c_{1}^{\prime}(r)=t-s$,

For the first integral, we have

\int_{0}^{s} \int_{s-u}^{t-u}\left(\lambda e^{-\lambda v}+\frac{d}{v}\right) \mathrm{d} v \mathrm{~d} u & =\left(1-e^{-\lambda(t-s)}\right) \int_{0}^{s} e^{-\lambda(s-u)} \mathrm{d} u+d \int_{0}^{s} \log \left(\frac{t-u}{s-u}\right) \mathrm{d} u \\
& =\frac{1}{\lambda}\left(1-e^{-\lambda(t-s)}\right)\left(1-e^{-\lambda s}\right)+d[t \log (t)-s \log (s)-(t-s) \log (t-s)] \\
& \leqslant \lambda s(t-s)+d[s(\log (t)-\log (s))+(t-s)(\log (t)-\log (t-s))] \\
& \leqslant \lambda s(t-s)+d(t-s)+d(t-s)(|\log (t)|+\mid \log (t-s)) \mid) \\
& \leqslant(\lambda s+d+|\log (t)|)(t-s)+d(t-s)|\log (t-s)|
\end{aligned}
$$

For the second integral, we get

Then we obtain, for $1 / T \leqslant s<t \leqslant T$

& +\left[(\lambda T+|\log (T)|+d+1)(t-s)+d(t-s)|\log (t-s)|+\sqrt{\frac{2 d T}{\gamma}}\|x-y\|\right]\|g\|_{\infty} .
\end{aligned}

We modify a little our equation (6.1), both in order to obtain a sharper estimate on the uniform norm of the solution and to get a coherent notation with the solution of the limit equation when $K \rightarrow+\infty$.

We define for $q \in[-1,1]$,

r_{K}^{\prime}(q)=-2 g_{K}\left(\frac{1}{2}(q+1)\right)=-(1-q) \mathbb{P}_{\frac{1-q}{2}}[X<\kappa(K, T)]+(1+q) \mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)] . \tag{6.11}
\end{equation*}
$$

So we let $h_{K}$ be

h_{K}(q)=\left\{\begin{array}{r}
-1 \text { for } q<-1  \tag{6.12}\\
-r_{K}^{\prime}(q)+q \text { for } q \in[-1,1] \\
1 \text { for } q>1
\end{array}\right.
$$

Since $r_{K}^{\prime}(1)=0$ and $r_{K}^{\prime}(-1)=0, h_{K}$ is continuous on $\mathbb{R}$. We have that, for $q \in[-1,1]$,

h_{K}(q)=-r_{K}^{\prime}(q)+q=(1-q) \mathbb{P}_{\frac{1-q}{2}}[X<\kappa(K, T)]-(1+q) \mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+q .

We now solve the following equation

Note that, this equation and (6.3) are exactly the same with the term $v$ added on both sides if $\|v\|_{\infty} \leqslant 1$, since for $q \notin[-1,1], h_{K}(q) \neq q$. Thus, a solution $v$ of (6.3) with $\|v\|_{\infty} \leqslant 1$ will also be a solution of (6.13) and reciprocally.

Proposition 6.2. For $v_{0} \in L^{\infty}\left(\mathbb{T}^{d}\right)$ with $\left\|v_{0}\right\|_{\infty} \leqslant 1$, there exists a unique solution $\left(v(t, x), t \geqslant 0, x \in \mathbb{T}^{d}\right)$ to the problem

- $v$ is continuous from $\mathbb{R}_{+}^{*}$ to $L^{\infty}\left(\mathbb{T}^{d}\right)$
- $v$ satisfies, for all $t>0$ and $x \in \mathbb{T}^{d}$

$$
\begin{equation*}
v(t, x)=S_{t}^{2 \beta+1,4 \alpha} v_{0}(x)+\int_{0}^{t} S_{t-s}^{2 \beta+1,4 \alpha}\left[h_{K}(v(s, \cdot))\right](x) \mathrm{d} s \tag{6.14}
\end{equation*}
$$

We say that $v$ is a mild solution to (6.13). We have also that $\|v\|_{\infty} \leqslant 1$ and $v$ satisfies

$$
\begin{equation*}
v(t, x)=S_{t}^{2 \beta, 4 \alpha} v_{0}(x)-\int_{0}^{t} S_{t-s}^{2 \beta, 4 \alpha}\left[r_{K}^{\prime}(v(s, \cdot))\right](x) \mathrm{d} s \tag{6.15}
\end{equation*}
$$

and thus is a mild solution of 6.3).

Proof. The first part of the proposition comes from a fixed point argument (see also Pazy [20], Theorem 6.1.2) applied to the following functional let $T>0$ and define the functional $\left.\left.\left.F: C(] 0, T], L^{\infty}\left(\mathbb{T}^{d}\right)\right) \rightarrow C(] 0, T\right], L^{\infty}\left(\mathbb{T}^{d}\right)\right)$ defined by

We equip $\left.C(] 0, T), L^{\infty}\left(\mathbb{T}^{d}\right)\right)$ with the uniform topology on all compact subset. We can apply the Banach fixed point Theorem to $F$ (see the proof of Pazy [20], Theorem 6.1.2. Moreover, the mapping $v_{0} \mapsto v$ is Lipschitz continuous from $L^{\infty}$ to $\left.\left.C(] 0, T\right), L^{\infty}\left(\mathbb{T}^{d}\right)\right)$.

An application of Proposition 6.1 proves that $\|v\|_{\infty} \leqslant 1$.
Since $h_{K}$ is differentiable, then, if $v_{0} \in C^{2}\left(\mathbb{T}^{d}\right), v_{0}$ is in the domain of $\Delta$ and thus $v$ is classical solution of 6.13) (Theorem 6.1.5 [20]). Thus $v$ is a classical solution of (6.3) since $\|v\|_{\infty} \leqslant 1$ and a mild solution of 6.3). Now consider an approximating sequence $\left(v_{0, n}\right)$ in $C^{2}\left(\mathbb{T}^{d}\right)$ of $v_{0} \in L^{\infty}$, and $\left(v_{n}\right)$ the sequence of mild solutions with initial value $v_{0, n}$ and $v$ the mild solution of 6.13 with initial value $v$. Then, since $v_{0} \mapsto v$ is Lipschitz continuous, by the dominated convergence theorem, we get that, uniformly on $\left[t_{0}, T\right] \times \mathbb{T}^{d}$ for all $t_{0}>0$, the right hand side of

\end{equation*}

converges to $S_{t}^{2 \beta, 4 \alpha} v_{0}(x)-\int_{0}^{t} S_{t-s}^{2 \beta, 4 \alpha}\left[r_{K}^{\prime}(v(s, \cdot))\right](x) \mathrm{d} s$, whereas the left hand side converges to $v$. So we obtain that $v$ is a mild solution of 6.3).

### 6.2 Solution of 6.2

### 6.2.1 Existence of a solution

We use the same transform as before, and let $h_{\infty}$ be the pointwise limit of $h_{K}$. The equation (6.2) is now formally

For the limiting equation, we prove first that the family $\left(v_{K}\right)_{K}$ of solutions associated to $h_{K}$ with common initial value $v_{0} \in L^{\infty}\left(\mathbb{T}^{d}\right)$ in $C\left(\mathbb{R}_{*}^{+} \times \mathbb{T}\right)$ is compact (with uniform norm on all compact subset). Then, by taking the limit, any accumulation point $v_{\infty}$ of the sequence satisfy the mild formulation of the limiting equation relaxed as a subdifferential inclusion.

In order to prove this, we set some notations :

r_{\infty}(q):=-\int_{\frac{1}{2}}^{\frac{1}{2}(q+1)} 4 g_{\infty}(s) \mathrm{d} s \tag{6.19}

$h_{\infty}$, the pointwise limit of $h_{K}$, is the function on $\mathbb{R}$

h_{\infty}(q)=2 g_{\infty}\left(\frac{1+q}{2}\right)+q=-\mathbb{1}_{q \leqslant-2 \rho}+q \mathbb{1}_{-2 \rho<q \leqslant 2 \rho}+\mathbb{1}_{q>2 \rho} . \tag{6.20}
\end{equation*}
$$

Then $h_{\infty}$ is non-decreasing and is the left-derivative of the convex function $H_{\infty}$

$$
\begin{align*}
H_{\infty}(q) & :=-r_{\infty}(q)+\frac{q^{2}}{2}  \tag{6.21}\\
& =\left[-q+2 \rho+2 \rho^{2}\right] \mathbb{1}_{\{q \leqslant-2 \rho\}}+\frac{1}{2} q^{2} \mathbb{1}_{\{-2 \rho<q \leqslant 2 \rho\}}+\left[q-2 \rho+2 \rho^{2}\right] \mathbb{1}_{\{2 \rho<q\}}
\end{align*}
$$

The subdifferential of $H_{\infty}$ at $q$ is defined as

$$
\partial H_{\infty}(q)=\left\{p \in \mathbb{R}, H_{\infty}\left(q^{\prime}\right)-H_{\infty}(q) \geqslant p\left(q^{\prime}-q\right), \text { for all } q^{\prime} \in[-1,1]\right\} .
$$

In particular we have,

$$
\partial H_{\infty}(q)= \begin{cases}\{-1\} & \text { for } q<-2 \rho  \tag{6.22}\\ {[-1,-2 \rho]} & \text { for } q=-2 \rho \\ \{q\} & \text { for }-2 \rho<q<2 \rho \\ {[2 \rho, 1]} & \text { for } q=2 \rho \\ \{1\} & \text { for } q>2 \rho\end{cases}
$$

We adopt the following definition for a solution of the equation :

\begin{equation*}
\partial_{t} v(t, x)-2 \alpha \Delta v(t, x)+(2 \beta+1) v \in \partial H_{\infty}(v(t, x)) . \tag{6.23}
\end{equation*}
$$

Definition 6.1. We say that $v$ is a mild solution of Equation 6.23) if it satisfies

\begin{equation*}
v(t, x)=S_{t}^{2 \beta+1,4 \alpha} v_{0}(x)+\int_{0}^{t} S_{t-s}^{2 \beta+1,4 \alpha}[w(s, \cdot)](x) \mathrm{d} s \tag{6.24}
\end{equation*}
$$

where $w \in L^{2}\left([0, T] \times \mathbb{T}^{d}\right)$, with $w(t, x) \in \partial H_{\infty}(v(t, x))$ almost everywhere.
Proposition 6.3. For $v_{0} \in L^{\infty}\left(\mathbb{T}^{d}\right)$, any accumulation point (in $C\left(\mathbb{R}_{+}^{*} \times \mathbb{T}^{d}\right.$ ) equipped with uniform norm on each compact set), of the sequence ( $v_{K}$ ) of solutions given by Proposition 6.2 is a mild solution of (6.23).

As a consequence of the proposition, there exists $\left(v(t, x), t \geqslant 0, x \in \mathbb{T}^{d}\right)$ a mild solution of 6.23) such that $v$ is continuous from $\mathbb{R}_{+}^{*}$ to $L^{\infty}\left(\mathbb{T}^{d}\right)$, and $\|v\|_{\infty} \leqslant 1$.

The existence of a solution for a given initial condition $v_{0}$ is not difficult and can be prove in different ways (see remark 6.3). Here we adopt some kind of regularization procedure, since we have a natural family of differentiable functions (namely the ( $h_{K}$ )) approximating $h_{\infty}$ and we use the convergence of the sequence ( $v_{K}$ ) in the next section to prove the convergence of the stochastic process. In the appendix, we present another construction of solution(s) using the monotonicity of $h_{\infty}$ which is interesting since it gives an insight on the problem of non-uniqueness.

Proof. For each $K$, we have a mild solution $v_{K}$ from Proposition 6.2, From Proposition 6.1, we have that each solution is uniformly bounded, uniformly continuous on $[1 / T, T] \times \mathbb{T}^{d}$, and the modulus of continuity only depends on $T>1$ (since the others parameters are fixed).

Therefore, by the Arzela-Ascoli Theorem, the sequence $\left(v_{K}\right)_{K}$ is compact on $C\left([1 / T, T] \times \mathbb{R}^{d}\right)$ and we can extract a subsequence converging uniformly in $C\left([1 / T, T] \times \mathbb{R}^{d}\right)$, and then by a diagonal argument, a sequence converging to a limit $v_{\infty}$ in $C(] 0, \infty\left[\times \mathbb{R}^{d}\right)$, uniformly on each compact. Note that since $\left\|v_{K}\right\| \leqslant 1$ for all $K$, we also have $\left\|v_{\infty}\right\| \leqslant 1$. We show that $v_{\infty}$ satisfies (6.18).

Let us assume that $\rho>0$. Denote for any $s>0, \mathcal{A}_{\rho}(s):=\left\{y \in \mathbb{R}^{d}:\left|v_{\infty}(s, y) \pm 2 \rho\right|=0\right\}$. Note that since $h_{\infty}$ is uniformly continuous on $[-1,-2 \rho[]-,2 \rho, 2 \rho[$ and $] 2 \rho, 1]$, we have that for any $y \notin \mathcal{A}_{\rho}(s), \lim _{K \rightarrow \infty} h_{K}\left(v_{K}(s, y)\right)=$ $h_{\infty}\left(v_{\infty}(s, y)\right)$. Let $y \in \mathcal{A}_{\rho}(s)$ and assume $v_{\infty}(s, y)=2 \rho$ without loss of generality, since $v_{K}(s, y)$ converges to $v_{\infty}(s, y)$, for all $\varepsilon>0$ such that $2 \rho-\varepsilon>0$, there exists $K_{0}$ such that for all $K \geqslant K_{0}, 2 \rho-\varepsilon<v_{K}(s, y)<2 \rho+\varepsilon$. Thus, using Lemma B. 5 we have that, for all $K \geqslant K_{0}, 2 \rho-2 \varepsilon \leqslant h_{K}\left(v_{K}(s, y)\right) \leqslant 1$. Then taking the limits in $K$ and $\varepsilon \rightarrow 0$, we get

h_{\infty}(2 \rho)=2 \rho \leqslant \liminf _{K \rightarrow \infty} h_{K}\left(v_{K}(s, y)\right) \leqslant \limsup _{K \rightarrow \infty} h_{K}\left(v_{K}(s, y)\right) \leqslant 1=h_{\infty}\left(2 \rho^{+}\right) . \tag{6.25}
\end{equation*}
$$

For $\rho=0$, we have the same inequality since then $h_{\infty}(0)=-1$ and $h_{\infty}(0+)=1$.
Therefore, let $w_{+}(s, y)=\lim \sup _{K \rightarrow \infty} h_{K}\left(v_{K}(s, y)\right)$ and $w_{-}(s, y)=\liminf _{K \rightarrow \infty} h_{K}\left(v_{K}(s, y)\right)$, we have that for all $(s, y) \in] 0,+\infty\left[\times \mathbb{T}^{d}\right.$ :

\begin{equation*}
h_{\infty}\left(v_{\infty}(s, y)\right) \leqslant w_{-}(s, y) \leqslant w_{+}(s, y) \leqslant h_{\infty}\left(v_{\infty}(s, y)^{+}\right) . \tag{6.26}
\end{equation*}
$$

Since $h_{K}\left(v_{K}\right)$ is bounded, by the Banach Alaoglu Theorem, the sequence is weakly compact in $L^{2}(] 0, T\left[\times \mathbb{T}^{d}\right)$, and we have a subsequence of $\left(h_{K}\left(v_{K}\right)\right)_{K}$ converging weakly to $w \in L_{l o c}^{2}(] 0,+\infty\left[\times \mathbb{T}^{d}\right)$. Since the density of the semigroup $S^{2 \beta+1,4 \alpha}$ is in $\left.\left.L^{2}(] 0, T\right] \times \mathbb{R}^{d}\right)$ for all $T>0$, we have as $K \rightarrow+\infty$,

\begin{equation*}
v_{\infty}(t, x)=S_{t}^{2 \beta+1,4 \alpha} v_{0}(x)+\int_{0}^{t} S_{t-s}^{2 \beta+1,4 \alpha} w(s, \cdot)(x) \mathrm{d} s \tag{6.27}
\end{equation*}
$$

Moreover, $w_{-}$and $w_{+}$are bounded and therefore in $\left.\left.L^{2}(] 0, T\right] \times \mathbb{T}^{d}\right)$. Let $\left.\left.\varphi \in L^{2}(] 0, T\right] \times \mathbb{T}^{d}\right)$ and $\varphi \geqslant 0$, by the Fatou Lemma we get

0=\int_{] 0, T] \times \mathbb{T}^{d}} \liminf _{K \rightarrow+\infty}\left(h_{K}\left(v_{K}\right)-w_{-}\right) \varphi \leqslant \liminf _{K \rightarrow+\infty} \int_{j 0, T] \times \mathbb{T}^{d}}\left(h_{K}\left(v_{K}\right)-w_{-}\right) \varphi=\int_{] 0, T] \times \mathbb{T}^{d}}\left(w-w_{-}\right) \varphi \tag{6.28}
\end{equation*}
$$

We also have

$$
\begin{equation*}
0=\int_{] 0, T] \times \mathbb{T}^{d}} \liminf _{K \rightarrow+\infty}\left(w_{+}-h_{K}\left(v_{K}\right)\right) \varphi \leqslant \liminf _{K \rightarrow+\infty} \int_{] 0, T] \times \mathbb{T}^{d}}\left(w_{+}-h_{K}\left(v_{K}\right)\right) \varphi=\int_{] 0, T] \times \mathbb{T}^{d}}\left(w_{+}-w\right) \varphi \tag{6.29}
\end{equation*}
$$

Thus, almost everywhere on $] 0,+\infty\left[\times \mathbb{T}^{d}\right.$, we have that

$$
\begin{equation*}
h_{\infty}\left(v_{\infty}\right) \leqslant w_{-} \leqslant w \leqslant w_{+} \leqslant h_{\infty}\left(v_{\infty}^{+}\right) . \tag{6.30}
\end{equation*}
$$

Therefore, $w \in \partial H_{\infty}\left(v_{\infty}\right)$ a.e.

### 6.2.2 Uniqueness of solution of 6.23

The main problem concerns the uniqueness of a solution.
Remark 6.2. We prove first that, we do not have uniqueness for a constant initial condition $v_{0}(x)=2 \rho$ when $2 \rho<\frac{1}{1+2 \beta}$, so we are in the case of segregation or metastable segragation described by Figure 1 . We describe three possible solutions starting from this initial condition.

Note that

\end{equation*}

Let us consider the functions

& v^{2}(t, x)=c^{2}(t)=2 \rho e^{-(2 \beta+1) t}+\frac{1}{1+2 \beta}\left(1-e^{-(2 \beta+1) t}\right)=2 \rho+\left(\frac{1}{1+2 \beta}-2 \rho\right)\left(1-e^{-(2 \beta+1) t}\right) \tag{6.34}
\end{align*}
$$

Since, $c^{1}(t) \in\left[0,2 \rho\left[\right.\right.$, for $t>0$, we have $h_{\infty}\left(c^{1}(t)\right)=c^{1}(t)$ and then

\int_{0}^{t} h_{\infty}\left(c^{1}(s)\right) e^{-(2 \beta+1)(t-s)} \mathrm{d} s=\int_{0}^{t} 2 \rho e^{-2 \beta s} e^{-(2 \beta+1)(t-s)} \mathrm{d} s=2 \rho e^{-(2 \beta+1) t}\left(e^{t}-1\right) \tag{6.35}
\end{equation*}
$$

Therefore

S_{t}^{2 \beta+1,4 \alpha} v_{0}(x)+\int_{0}^{t} S_{t-s}^{2 \beta+1,4 \alpha}\left[h_{\infty}\left(v^{1}(s, \cdot)\right)\right](x) \mathrm{d} s=2 \rho e^{-(2 \beta+1) t}+2 \rho e^{-(2 \beta+1) t}\left(e^{t}-1\right)=2 \rho e^{-2 \beta t}=v^{1}(t, x) \tag{6.36}
\end{equation*}
$$

Since $\left.\left.2 \rho<\frac{1}{1+2 \beta}, c^{2}(t) \in\right] 2 \rho, 1\right]$, for $t>0$, we have $h_{\infty}\left(c^{2}(t)\right)=1$ and then by the same computation,

Thus, both $v^{1}$ and $v^{2}$ are mild solutions to (6.18) and thus to with the same initial conditions. Note that at $t=0$, we have $v^{1}(0, x)=v^{2}(0, x)=2 \rho$ and

& \partial_{t} v^{1}(0, x)=-4 \beta \rho=-(2 \beta+1) 2 \rho+2 \rho=-(2 \beta+1) 2 \rho+h_{\infty}\left(2 \rho^{-}\right)  \tag{6.39}\\
& \partial_{t} v^{2}(0, x)=-2 \rho(2 \beta+1)+1=-(2 \beta+1) 2 \rho+h_{\infty}\left(2 \rho^{+}\right) \tag{6.40}
\end{align*}

We see that non uniqueness really comes from the fact that at $t=0$, where $v(t, x)=2 \rho$, we have two choices for the derivative due to the fact that $h_{\infty}$ is not continuous. Therefore, we cannot expect uniqueness for this problem for all initial condition, we have to impose some condition on the initial condition if we want a unique solution.

Note that if we consider the mild solution to the subdiffrential inclusion (6.23), then we have at least a third solution : $v^{3}(t, x)=2 \rho$. We consider $w(t, x)=2 \rho(2 \beta+1)$, we have

S_{t}^{2 \beta+1,4 \alpha} v_{0}(x)+\int_{0}^{t} S_{t-s}^{2 \beta+1,4 \alpha}[w(s, \cdot)](x) \mathrm{d} s & =2 \rho e^{-(2 \beta+1) t}+2 \rho(2 \beta+1) \int_{0}^{t} e^{-(2 \beta+1)(t-s)} \mathrm{d} s  \tag{6.41}\\
& =2 \rho
\end{align*}

Since, $2 \rho<\frac{1}{1+2 \beta}$, we have that $2 \rho<2 \rho(2 \beta+1)<1$ so $w(t, x) \in \partial H_{\infty}(2 \rho)$.

In the literature, we can find different conditions ensuring that the solution of Equation (6.23) is unique. Following [11] and [4], we prove that the regularity of the initial condition at the levels where the non-linearity $H_{\infty}$ is not differentiable is sufficient.

Definition 6.2. A function $v_{0}: \mathbb{T}^{d} \rightarrow[-1,1]$ in $C^{1}\left(\mathbb{T}^{d}\right)$ is regular at level $\left.q \in\right]-1,1\left[\right.$ if for all $x \in \mathbb{T}^{d}$, such that $v_{0}(x)=p$, we have $\nabla v_{0}(x) \neq 0$.

Proposition 6.4. For $v_{0} \in C^{1}\left(\mathbb{T}^{d}\right)$, such that $\nabla v_{0}$ is Lipschitz on $\mathbb{T}^{d}$ and regular at levels $2 \rho$ and $-2 \rho$, the solution $v$ to Equation 6.23) is locally unique. Moreover, the Lebesgue measure of the set $\mathcal{A}_{\rho}(s):=\left\{y \in \mathbb{R}^{d}:|v(s, y) \pm 2 \rho|=\right.$ $0\}$ is zero.

We adapt two arguments by 11 and [4].
Lemma 6.5. If $v$ is a mild solution of (6.23) with $v_{0} \in C^{1}\left(\mathbb{T}^{d}\right)$, and such that $\nabla v_{0}$ is Lipschitz on $\mathbb{T}^{d}$, then, for all $T>0$, there exists a constant $C>0$ such that, for all $t \in[0, T]$

Proof. Since $v$ is a mild solution of 6.23) there exists $w \in L_{l o c}^{\infty}\left(\left[0+\infty\left[\times \mathbb{T}^{d}\right)\right.\right.$ with $\|w\|_{\infty} \leqslant 1$ since $w \in \partial H_{\infty}(v)$. Thus we get

& \leqslant L e^{-(2 \beta+1) t} \int_{\mathbb{R}^{d}} s_{0}(4 \alpha t, x, y)\|y-x\|_{2} \mathrm{~d} y \\
& \leqslant L e^{-(2 \beta+1) t} \sqrt{4 \alpha t d} \leqslant L \sqrt{4 \alpha d} t^{1 / 2}
\end{aligned}
$$

where $L$ is the Lipschitz constant of $v_{0}$ and the third inequality comes from the computation of the upper bound of the quadratic norm of $d$ independent random variables with common variance $4 \alpha t$. Therefore we obtain

\end{equation*}
$$

We can treat both integrals as before, for the last integral :

\left|\int_{0}^{t} \int_{\mathbb{R}^{d}} e^{-(2 \beta+1)(t-s)} \partial_{x_{i}} s_{0}(4 \alpha(t-s), x, y) w(s, y) \mathrm{d} y \mathrm{~d} s\right| & \leqslant \int_{0}^{t} \frac{e^{-(2 \beta+1)(t-s)}}{4 \alpha(t-s)} \int_{\mathbb{R}^{d}}\left|x_{i}-y_{i}\right| s_{0}(4 \alpha(t-s), x, y) \mathrm{d} y \mathrm{~d} s \\
& \leqslant \int_{0}^{t} \frac{e^{-(2 \beta+1)(t-s)}}{4 \alpha(t-s)} \sqrt{2 \alpha(t-s)} \mathrm{d} s \\
& \leqslant \frac{1}{\sqrt{2 \alpha}} \int_{0}^{\sqrt{t}} e^{-(2 \beta+1) u^{2}} \mathrm{~d} u \leqslant \frac{\sqrt{t}}{\sqrt{2 \alpha}}
\end{aligned}
$$

For the first integral, we have the same estimates as before

\end{equation*}

where $L^{\prime}$ is the maximum of the Lipschitz constants of $\left(\partial_{x_{i}} v_{0}\right)_{i}$. Thus, we get

Note that the previous Lemma entails that, for all $T>0$, there exists $C$, such that for $t<T$, we have $e(t) \leqslant C \sqrt{t}$.

We define $I_{s, t}^{+}=\left\{(s, y), s \leqslant t,\left|v_{1}(s, y)-2 \rho\right| \leqslant e(t)\right\}$ and $I_{s, t}^{-}=\left\{(s, y), s \leqslant t,\left|v_{1}(s, y)+2 \rho\right| \leqslant e(t)\right\}$.
Since $v_{1}$ and $v_{2}$ are solutions of (6.23), there exists $w_{1}$ and $w_{2}$ such that $w_{1} \in \partial H_{\infty}\left(v_{1}\right)$ a.e. and $w_{2} \in \partial H_{\infty}\left(v_{2}\right)$. We can decompose each $w_{i}$ as $w_{i}(t, x)=f_{\infty}\left(v_{i}(t, x)\right)+g_{i}(t, x)$ where $f_{\infty}$ is the continuous part of $\partial H_{\infty}$ :

& q \text { for } q \in[-1,-2 \rho] \\
& 2 \rho \text { for } q \in[2 \rho, 1]

and $g_{i}(t, x)=w_{i}(t, x)-f_{\infty}\left(v_{i}(t, x)\right)$. Note that

g_{i}(t, x) & =-1+2 \rho \text { a.e. on }\left\{(t, x), v_{i}(t, x)<-2 \rho\right\}, \\
g_{i}(t, x) & =0 \text { a.e. on }\left\{(t, x),-2 \rho<v_{i}(t, x)<2 \rho\right\},  \tag{6.50}\\
g_{i}(t, x) & =1-2 \rho \text { a.e. on }\left\{(t, x), v_{i}(t, x)>2 \rho\right\},
\end{align*}
$$

since $w_{i}=h_{\infty}\left(v_{i}\right)$ a.e. on $\left\{(t, x),\left|v_{i}(t, x)\right|=2 \rho\right\}$.
As a consequence we have that, up to a negligible set, $\left\{(s, y), s \leqslant t, g_{1}(s, y) \neq g_{2}(s, y)\right\} \subset I_{s, t}^{+} \cup I_{s, t}^{-}$since, $g_{1}(s, y) \neq g_{2}(s, y)$ entails that one of the following inequalities is true $v_{2}(s, y)<2 \rho<v_{1}(s, y)$ or $v_{2}(s, y)<-2 \rho<$ $v_{1}(s, y)$ or $v_{1}(s, y)<2 \rho<v_{2}(s, y)$ or $v_{1}(s, y)<-2 \rho<v_{2}(s, y)$. For each case, the inclusion is true : for the first one for example, if $s \leqslant t$ and $v_{2}(s, y)<2 \rho<v_{1}(s, y)$

& +\int_{0}^{t} \int_{I_{s, t}^{+} \cup I_{s, t}^{-}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y)\left(g_{1}(s, y)-g_{2}(s, y)\right) \mathrm{d} y \mathrm{~d} s \tag{6.52}
\end{align*}
$$

For the first integral in 6.52 we note that $f_{\infty}$ is 1 -Lipschitz, thus

& \left|\int_{0}^{t} \int_{\mathbb{T}^{d}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y)\left(f_{\infty}\left(v_{1}(s, y)\right)-f_{\infty}\left(v_{2}(s, y)\right)\right) \mathrm{d} y \mathrm{~d} s\right| \\
& \leqslant \int_{0}^{t} \int_{\mathbb{T}^{d}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y) e(t) \mathrm{d} y \mathrm{~d} s \leqslant t e(t)
\end{aligned}
$$

For the second integral in 6.52 we note that $\left|g_{i}\right| \leqslant 1-2 \rho$, then we first have

\begin{aligned}
& \left|\int_{0}^{t} \int_{I_{s, t}^{+} \cup I_{s, t}^{-}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y)\left(g_{1}(s, y)-g_{2}(s, y)\right) \mathrm{d} y \mathrm{~d} s\right| \\
& \leqslant 2(1-2 \rho) \int_{0}^{t} \int_{I_{s, t}^{+} \cup I_{s, t}^{-}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y) \mathrm{d} y \mathrm{~d} s .
\end{aligned}
$$

Let $s \leqslant t$, since $v_{0}$ is regular on the level set $\left\{v_{0}=2 \rho\right\}$ which is compact (since $\mathbb{T}^{d}$ is) and $\nabla v_{0}$ is a Lipschitz function, we can find $\delta, \eta>0$ such that on $\left\{v_{0}=2 \rho\right\}+B_{\delta}(0),\left|\nabla v_{0}(x)\right|>\eta$. Using the second part of Lemma 6.5 , and since $e(t) \leqslant C \sqrt{t}$, there exists $T>0$ such that for $s \leqslant t \leqslant T, I_{s, t}^{+} \subset\left\{v_{0}=2 \rho\right\}+B_{\delta}(0)$ and on $I_{s, t}^{+}$, $\left|\nabla v_{1}(s)\right|>\eta / 2$.

Since $I_{s, t}^{+}$is compact and $\nabla v_{1}(s) \neq 0$, by the implicit function theorem, we can find a finite cover by open balls $\left(B_{i}\right)_{1 \leqslant i \leqslant N}$ centered on points on $I_{s, t}^{+}$such that locally on each ball $B_{i}$, the level set $\left\{v_{1}(s, y)=2 \rho\right\}$ is the graph of a function, e.g $y_{1}=\varphi\left(y_{2}, \ldots y_{d}\right)$. Note that since $\left\{v_{0}=2 \rho\right\}$ is compact, $N$ is uniform in $s \leqslant T$, since by the lemma, we can make the cover of open balls on $\left\{v_{0}=2 \rho\right\}$ and take their traces on $\left\{v_{1}(s, y)=2 \rho\right\}$.

By the mean value theorem on the first coordinate $y_{1}$ of $v_{1}(s)$, we have $I_{s, t}^{+} \cap B_{i} \subset[-2 e(t) / \nu, 2 e(t) / \nu] \times \Pi_{1}\left(B_{i}\right)$, where $\Pi_{1}$ is the projection along the first coordinate. Thus,

& \int_{0}^{t} \int_{I_{s, t}^{+} \cap B_{i}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y) \mathrm{d} y \mathrm{~d} s \\
& \quad \leqslant \int_{0}^{t} e^{-(2 \beta+1)(t-s)} \frac{4 e(t)}{\nu \sqrt{4 \alpha(t-s)}} \int_{\Pi_{1}\left(B_{i}\right)} s\left(4 \alpha(t-s), 0,\left(0, y_{2}, \ldots y_{d}\right)\right) \mathrm{d} y_{2} \cdots \mathrm{~d} y_{d} \mathrm{~d} s \\
& \quad \leqslant \int_{0}^{t} e^{-(2 \beta+1)(t-s)} \frac{2 e(t)}{\nu \sqrt{\alpha(t-s)}} \mathrm{d} s \leqslant \frac{2 e(t) t^{1 / 2}}{\nu \sqrt{\alpha}}
\end{aligned}
$$

Thus

$$
\begin{equation*}
\int_{0}^{t} \int_{I_{s, t}^{+}} e^{-(2 \beta+1)(t-s)} s(4 \alpha(t-s), x, y) \mathrm{d} y \mathrm{~d} s \leqslant \frac{2 N e(t) t^{1 / 2}}{\nu \sqrt{\alpha}} \tag{6.53}
\end{equation*}
$$

Since the same holds for $I_{s, t}^{-}$, we obtain, that for some constant $C>0$, and all $t<T$

Then $e(T) \leqslant\left(T+C T^{1 / 2}\right) e(T)$, and taking $T$ small enough, we obtain $e(T)=0$ thus $v_{1}=v_{2}$ on $[0, T] \times \mathbb{T}^{d}$.
Remark 6.3. Maximal and minimal solutions. Another approach to 6.2 is to use a monotone construction of solutions, which arises from a comparison principle close to the one developed in Proposition 5.1. This was done initially in [2] and also in [5] Define $\overline{h_{\infty}}$ the right continuous version of $h_{\infty}$ (Equation 6.20) by

& \bar{F}(v)(t, x):=e^{-(2 \beta+1) t} S_{t} v_{0}(x)+\int_{0}^{t} e^{-(2 \beta+1)(t-s)} S_{t-s}\left[\overline{h_{\infty}}(v(s, \cdot))\right](x) \mathrm{d} s \tag{6.57}
\end{align*}
$$

Then, fixed points of the maps above are mild solutions of these two formulations of our subdifferential inclusion:

& \partial_{t} v(t, x)-2 \alpha \Delta v(t, x)+(2 \beta+1) v(t, x)=\overline{h_{\infty}}(v(t, x)) \tag{6.59}
\end{align*}

Since $h_{\infty}\left(\right.$ resp. $\overline{h_{\infty}}$ ) is non decreasing and that $h_{\infty}(p) \leqslant \overline{h_{\infty}}(p)$ for all $p \in[-1,1]$, we have that, for $u, v$ two functions such that $-1 \leqslant v \leqslant u \leqslant 1$,

1. $\underline{F}(v)(t, x) \leqslant \underline{F}(u)(t, x)$
2. $\bar{F}(v)(t, x) \leqslant \bar{F}(u)(t, x)$
3. $\underline{F}(u)(t, x) \leqslant \bar{F}(u)(t, x)$

We define the sequences $\left(V^{n}\right)_{n}$ and $\left(W^{n}\right)_{n}$ of functions on $\mathbb{R}^{+} \times \mathbb{T}^{d}: V^{0}(t, x)=1, W^{0}(t, x)=-1$ and for all $n \geqslant 1$

\begin{align*}
V^{n}(t, x) & =e^{-(2 \beta+1) t} S_{t} v_{0}(x)+\int_{0}^{t} e^{-(2 \beta+1)(t-s)} S_{t-s}\left[\bar{f}\left(V^{n-1}(s, \cdot)\right)\right](x) \mathrm{d} s  \tag{6.60}\\
W^{n}(t, x) & =e^{-(2 \beta+1) t} S_{t} v_{0}(x)+\int_{0}^{t} e^{-(2 \beta+1)(t-s)} S_{t-s}\left[\underline{f}\left(W^{n-1}(s, \cdot)\right)\right](x) \mathrm{d} s \tag{6.61}
\end{align*}
$$

Thus, for $-1 \leqslant v_{0}(x) \leqslant 1$, we can prove by induction that the sequences $\left(V^{n}\right)$ and $\left(W^{n}\right)$ satisfy, for all $n$

-1 \leqslant W^{1} \leqslant W^{2} \cdots \leqslant W^{n} \leqslant V^{n} \leqslant \cdots \leqslant V^{2} \leqslant V^{1} \leqslant 1 \tag{6.62}
\end{equation*}

By a compactness and monotony argument, one can prove that $\left(W^{n}\right)$ and $\left(V^{n}\right)$ converge to functions $w$ and $w$ which are mild solutions of the subdifferential inclusion. These are the minimal and maximal solutions of the subdifferential inclusion, in the sense that any other solution (Definition 6.1) must be bounded below by $w$ and above by $v$. Uniqueness follows if one can prove that $w=v$.

## 7 Convergence of the discrete PDE

In analogy with the continuous setting, we define $v^{N}=2 u^{N}-1$ where $u^{N}$ is the solution of the discretized Equation (4.10) and $H\left(i, v^{N}\right)=2 G\left(i, \frac{v^{N}+1}{2}\right)+v_{i}^{N}$.

In such a way 4.10 becomes

\left\{\begin{array}{l}
\partial_{t} v^{N}(t, i)=2 \alpha N^{2} \Delta u^{N}(t, i)-(2 \beta+1) v^{N}(t, i)+H\left(i, v^{N}\right)  \tag{7.1}\\
v^{N}(t, i)=2 u_{0}^{N}-1(i)
\end{array}\right.
$$

We main goal of this section is to prove the following result which states the convergence of $v^{N}$.
Theorem 7.1. Let $v^{N}$ be the solution of (7.1). Then there exists a sub-sequence $k_{N}$ such that

$$
\begin{equation*}
\lim _{N \rightarrow+\infty}\left\|v^{k_{N}}-v_{\infty}\right\|_{\left.\mathbb{T}^{d} \times\right] 0,+\infty[ }=0 \tag{7.2}
\end{equation*}
$$

where $v_{\infty}$ is a solution of (6.23) and $\left\|v^{N}-v_{\infty}\right\|_{\left.\mathbb{T}^{d} \times\right] 0,+\infty[\text { means the uniform norm on all compact sets of }}$ $\left.\mathbb{T}^{d} \times\right] 0,+\infty[$.

In particular, whenever the solution of (7.1) is a.e. unique, $v_{\infty}$ is also (the) mild solution of (6.2) and the whole sequence $v^{N}$ converges to $v_{\infty}$, uniformly on all compact sets of $\left.\mathbb{T}^{d} \times\right] 0,+\infty[$.

To prove Theorem 7.1 we need some technical results. Let consider the semigroup of the discrete Laplacian $\frac{1}{2} N^{2} \Delta^{N}$ on $\mathbb{T}_{N}^{d}$ and $\mathbb{Z}^{d}$, denoted by $s^{N}(t, i, j)$ and $s_{0}^{N}(\gamma t, i, j)$ respectively. In particular we have that $s^{N}(t, i, j)=$ $p_{N}(t, i, j)$, where $p_{N}(t, i, j)$ is heat kernel of discrete Laplacian on the discrete torus, cf. (5.2).

For any $\lambda, \gamma \geqslant 0$ and $f: \frac{1}{N} \mathbb{T}_{N}^{d} \rightarrow \mathbb{R}$, we let $\left(S_{t}^{N, \lambda, \gamma}\right)$ be the semigroup defined by

S_{t}^{N, \lambda, \gamma} f(x)=\sum_{y \in \frac{1}{N} \mathbb{T}_{N}^{d}} e^{-\lambda t} s^{N}(\gamma t, N x, N y) f(y)=\sum_{y \in \frac{1}{N} \mathbb{Z}^{d}} e^{-\lambda t} s_{0}^{N}(\gamma t, N x, N y) \tilde{f}(y) \tag{7.3}
\end{equation*}
$$

where, as in (6.6), $\tilde{f}$ is the periodic extension of $f$ on $\frac{1}{N} \mathbb{Z}^{d}$.
In the remaining part of this article we will consider $S_{t}^{N, \lambda, \gamma} f(x)$ with $f \in \mathcal{C}\left(\mathbb{T}^{d}\right)$. In that case we mean that the function $f$ is restricted on $\frac{1}{N} \mathbb{T}_{N}^{d} \subset \mathbb{T}^{d}$, which is equivalent to consider $f^{N}(x):=f(\lfloor N x\rfloor / N)$. We observe that if $f$ is also Lipschitz, then $\left\|f-f^{N}\right\|_{\mathbb{T}^{d}} \leqslant \frac{c}{N^{d}}$ for some $c>0$ and $\left\|f^{N}\right\|_{\mathbb{T}^{d}} \leqslant\|f\|_{\mathbb{T}^{d}}$. Then, with the same extension to $\mathbb{T}^{d}$ for $s^{N}$ we can write, for any $x \in \mathbb{T}^{d}$

S_{t}^{N, \lambda, \gamma} f(x)=\int_{\mathbb{T}^{d}} e^{-\lambda t} N^{d} s^{N}(\gamma t, N x, N y) f^{N}(y) \mathrm{d} y \tag{7.4}
\end{equation*}
$$

By a slight abuse of notation, we still denote by $v^{N}$ the linear interpolation on $\mathbb{T}^{d}$ such that $v^{N}\left(t, \frac{i}{N}\right)=v_{i}^{N}(t)$. We also redefine the function $H$ on the torus $\mathbb{T}^{d}$ by the linear interpolation such that $H\left(\frac{i}{N}, v^{N}\right)=H\left(i, v^{N}\right)$ and we define $H^{N}$ as $f^{N}$ in (7.4).

Definition 7.1. Let $N \in \mathbb{N}$ and $v_{0}^{N} \in L^{\infty}\left(\mathbb{T}^{d}\right)$. We say that $\left(v^{N}(t, x), t \geqslant 0, x \in \mathbb{T}^{d}\right)$ is a mild solution of (7.1) if

- for any $N, v^{N}$ is continuous from $\mathbb{R}_{+}^{*}$ to $L^{\infty}\left(\mathbb{T}^{d}\right)$,
- for all $t>0$ and $x \in \mathbb{T}^{d}$

$$
\begin{equation*}
v^{N}(t, x)=S_{t}^{N, 2 \beta+1,4 N^{2} \alpha}\left(v_{0}^{N}\right)(x)+\int_{0}^{t} S_{t-s}^{N, 2 \beta+1,4 N^{2} \alpha}\left[H^{N}\left(\cdot, v^{N}(s, \cdot)\right)\right](x) \mathrm{d} s \tag{7.5}
\end{equation*}
$$

Let $u^{N}$ be the unique solution of (4.10), so that $v^{N}=2 u^{N}-1$ satisfies (7.1). Of course, for any $N$ the solution $v^{N}$ of 7.5 exists and it is unique.

The proof of Theorem 7.1 is based on the representation of $v^{N}$ as in 7.5. We define $\widetilde{v}^{N}$ as a slight modification of 7.5 , that is,

\end{equation*}
$$

Lemma 7.2. For any $T>0$

\lim _{N \rightarrow+\infty}\left\|\widetilde{v}^{N}-v^{N}\right\|_{[1 / T, T] \times \mathbb{T}^{d}}=0 . \tag{7.7}
\end{equation*}
$$

Proof. Let $T>0$, then

& \sup _{t \in\left[\frac{1}{T}, T\right], x \in \mathbb{T}^{d}}\left|\widetilde{v}^{N}(t, x)-v^{N}(t, x)\right| \leqslant \sup _{t \in\left[\frac{1}{T}, T\right], x \in \mathbb{T}^{d}}\left|S_{t}^{N, \lambda, N^{2} \gamma} v_{0}^{N}(x)-S_{t}^{\lambda, \gamma} v_{0}(x)\right| \\
&+\sup _{t \in\left[\frac{1}{T}, T\right], x \in \mathbb{T}^{d}}\left|\int_{0}^{t}\left\{S_{t-s}^{N, 2 \beta+1,4 N^{2} \alpha}\left[H^{N}\left(\cdot, v^{N}(s, \cdot)\right)\right](x)-S_{t-s}^{2 \beta+1,4 \alpha}\left[H\left(\cdot, v^{N}(s, \cdot)\right)\right](x)\right\} \mathrm{d} s\right| . \tag{7.8}
\end{align*}
$$

We show that the right hand side of (7.8) converges to 0 . We detail the convergence of the second term, which is more delicate. The argument can be adapted to the first term by using Assumption 2 which ensures that $v_{0}^{N}$ converges to $v_{0}$ in $C\left(\mathbb{T}^{d}\right)$.

We fix $\varepsilon \in\left(0, \frac{1}{T}\right)$ and we get that

& \left|\int_{0}^{t} S_{t-s}^{N, 2 \beta+1,4 N^{2} \alpha}\left[H^{N}\left(\cdot, v^{N}(s, \cdot)\right)\right](x)-S_{t-s}^{2 \beta+1,4 \alpha}\left[H\left(\cdot, v^{N}(s, \cdot)\right)\right](x) \mathrm{d} s\right| \\
& \quad \leqslant\left|\int_{0}^{t-\varepsilon} S_{t-s}^{N, 2 \beta+1,4 N^{2} \alpha}\left[H^{N}\left(\cdot, v^{N}(s, \cdot)\right)\right](x)-S_{t-s}^{2 \beta+1,4 \alpha}\left[H\left(\cdot, v^{N}(s, \cdot)\right)\right](x) \mathrm{d} s\right|+C \varepsilon \tag{7.9}
\end{align*}
$$

where we used that Lemma B. 6 which implies that $H\left(\cdot, v^{N}\right)$ is bounded by 1 uniformly on $N$. The integral on the right hand side of $(7.9)$ is bounded from above by

\int_{0}^{t-\varepsilon} e^{-(2 \beta+1)(t-s)} \mid & \int_{\mathbb{T}^{d}} \\
& \left(N^{d} s^{N}\left(4 N^{2} \alpha(t-s), N x, N y\right)-s(4 \alpha(t-s), x, y)\right) H^{N}\left(y, v^{N}(s, y)\right) \mathrm{d} y \mid \mathrm{d} s  \tag{7.10}\\
& +\int_{0}^{t-\varepsilon} e^{-(2 \beta+1)(t-s)} \int_{\mathbb{T}^{d}} s(4 \alpha(t-s), x, y)\left|H^{N}\left(y, v^{N}(s, y)\right)-H\left(y, v^{N}(s, y)\right)\right| \mathrm{d} y \mathrm{~d} s
\end{align*}
$$

Since $\sup _{s \geqslant 0, y \in \mathbb{T}^{d}}\left|H^{N}\left(y, v^{N}(s, y)\right)-H\left(y, v^{N}(s, y)\right)\right| \leqslant \frac{1}{N}$, the second integral is smaller than $\frac{c_{\alpha, \beta}}{N}$. For the first integral, we first use that $H\left(\cdot, v^{N}\right)$ is bounded by 1 uniformly on $N$ and then we operate the change of variable $u=t-s$ which gives that it is bounded from above by

\int_{\varepsilon}^{t} e^{-(2 \beta+1) u} \int_{\mathbb{T}^{d}}\left|N^{d} s^{N}\left(4 N^{2} \alpha u, N x, N y\right)-s(4 \alpha u, x, y)\right| \mathrm{d} y \mathrm{~d} u \tag{7.11}
\end{equation*}
$$

We now use the local central limit theorem (cf. Theorem 2.1.1 and (2.5) in [17]): let $\rho$ be the Gaussian Kernel and $\rho(u, x, y)=\frac{1}{u^{d / 2}} \rho\left(\frac{x-y}{u^{1 / 2}}\right)$, then

\psi_{\varepsilon, T, N}:=\sup _{u \in[\varepsilon, T], y \in \frac{1}{N} \mathbb{Z}^{d}}\left|N^{d} p\left(u N^{2}, N x, N y\right)-\rho(u, x, y)\right| \xrightarrow{N \rightarrow+\infty} 0 . \tag{7.12}
\end{equation*}
$$

We also observe that by symmetry the supremium in 7.12 is independent of $x$. Moreover, by Proposition 2.4.6 in [17] we have that there exist $c_{1}, c_{2}>0$ independent of $x, y, u$ such that

In such a way, for any $M>0$ fixed we write $\mathbb{T}^{d}=B_{x}(M) \cup B_{x}(M)^{c}$ and we get that 7.11 is smaller than

c_{d} \int_{\varepsilon}^{t} e^{-(2 \beta+1) u}\left(M^{d} \psi_{N, \varepsilon, T}+\frac{c_{1}}{M^{d} u^{\frac{d}{2}}} e^{-c_{2} \frac{M^{2 d}}{u}}\right) \mathrm{d} s \leqslant C_{d}\left(M^{d} \psi_{N, \varepsilon, T}+\frac{1}{M^{d}}\right) \tag{7.14}
\end{equation*}
$$

where $c_{d}, C_{d}>0$ are two positive constants that depend only on the dimension $d$.
We conclude that the right hand side of $\left(7.9\right.$ is bounded by $\frac{c_{\alpha, \beta}}{N}+c M^{d} \psi_{N, \varepsilon, T}+\frac{c}{M^{d}}+C \varepsilon$, uniformly on $x \in \mathbb{T}^{d}$ and $t \in\left[\frac{1}{T}, T\right]$. Therefore, by taking the limit on $N \rightarrow+\infty$ and then on $M \rightarrow+\infty$ and $\varepsilon \rightarrow 0$ we conclude the proof.
Proof of Theorem 7.1. We control $\widetilde{v}^{N}$ to get the convergence of $v^{N}$. We observe that since $H\left(\cdot, v^{N}(s, \cdot)\right)$ is uniformly bounded so that by Proposition 6.1 $\widetilde{v}^{N}$ is uniformly bounded in $N$, uniformly continuous on $[1 / T, T] \times$ $\mathbb{T}^{d}$, and the modulus of continuity only depends on $T>1$. By the Ascoli-Arzela Theorem, the sequence $\left(\widetilde{v}^{N}\right)_{N}$ is compact on $C\left([1 / T, T] \times \mathbb{R}^{d}\right)$ and we can extract (by a diagonal argument) a subsequence converging uniformly to a limit $v_{\infty}$ in $C(] 0, \infty\left[\times \mathbb{R}^{d}\right)$, uniformly on each compact. By Lemma $(7.2)$ we get that $v^{N}$ admits a sub-sequence converging to $v_{\infty}$.

Using Corollary B.4 we can adapt the argument used in the proof of Proposition 6.3 6.25 6.30 to get that $v_{\infty}$ is a mild solution of 6.23), we omit the details.

### 7.1 Proof of Theorem 3.1

Theorem 3.1 is now a consequence of Theorems 4.2 and 7.1 .

## A Concentration inequalities

We follow the definitions in Jara and Menezes [15] and [14] and Boucheron, Lugosi, Massart [1], Section 2.3. We omit the proofs since there are present in the references.
Definition A. 1 ([15] and [1], Section 2.3). Let $X$ be a real random variable. $X$ is said to be sub-Gaussian with variance parameter $\sigma^{2}$ if, for all $t \in \mathbb{R}$

Proposition A.1. [[1] and [14], Proposition F.7] The following statements are equivalent :

1. $X \in \mathcal{G}\left(\sigma^{2}\right)$
2. $\mathbb{P}(|X|>t) \leqslant 2 \exp \left(-\frac{t^{2}}{2 \sigma^{2}}\right)$
3. $\mathbb{E}\left(\exp \left(\gamma X^{2}\right)\right) \leqslant 3$ for all $0 \leqslant \gamma<\frac{1}{4 \sigma^{2}}$.

Let us complete our family of inequality :
Lemma A.2. [14], Proposition F.8] Let $X \in \mathcal{G}\left(\sigma_{1}^{2}\right)$ and $Y \in \mathcal{G}\left(\sigma_{2}^{2}\right)$, then for all $0 \leqslant \gamma<\frac{1}{4 \sigma_{1} \sigma_{2}}$,

[[14], Proposition F.12] Let $X_{1}, \ldots, X_{n}$ be random variables with $X_{i} \in \mathcal{G}\left(\sigma_{i}^{2}\right)$, such that there is a partition of $K$ subsets $P_{1}, \ldots, P_{K}$ each containing $L$ variables that $\Sigma_{k}=\sigma\left(X_{i}, i \in P_{k}\right)$ are independent $\sigma$ algebra then, for all real $\alpha_{1}, \ldots, \alpha_{n}$, the random variable $Y=\sum_{i} \alpha_{i} X_{i}$ is sub-Gaussian with variance parameter $L \sum_{i} \alpha_{i}^{2} \sigma_{i}^{2}$.

Note that if $L=1$, the variables are independent.
Lemma A. 4 (Hoeffeding Inequality, [1], Section 2.3). Let $X$ be a bounded random variable with $X \in[a, b]$, then $X-\mathbb{E} X \in \mathcal{G}\left(\frac{(b-a)^{2}}{4}\right)$.

## B Controls for the non-linearities

In this section, we collect some results about the specifics of our model. Recall the notations: for $\eta \in\{0,1\}^{\mathbb{T}_{N}^{d}}$

For any function $u=\left(u_{i}\right)_{i \in \mathbb{T}_{N}^{d}}$, we define $v_{u}(\mathrm{~d} \eta)=v_{u}^{N}(\mathrm{~d} \eta):=$ $\otimes_{i \in \mathbb{T}_{N}^{d}} \mathrm{~B}\left(u_{i}\right)$ where $B\left(u_{i}\right)$ denote a Bernoulli distribution with parameter $u_{i}$. and we let $c_{0}^{+}(u)$ and $c_{0}^{-}(u)$ be the expectations of $c_{0}^{+}(\eta)$ and $c_{0}^{-}(\eta)$ under $v_{u}$. We set $\left(\tau_{i} \eta\right)_{j}=\eta_{i+j}$, and likewise $\tau_{i}$ acts on $u$. Then,

G(u):=\left(1-u_{0}\right) c_{0}^{+}(u)-u_{0} c_{0}^{-}(u)=\left(1-u_{0}\right) \mathbb{P}_{v_{u}}\left[\rho_{0}(\eta) \geqslant 1-\frac{\kappa_{N}}{K_{N}}\right]-u_{0} \mathbb{P}_{v_{u}}\left[\rho_{0}(\eta) \leqslant \frac{\kappa_{N}}{K_{N}}\right] \tag{B.1}
\end{equation*}
$$

and $G(i, u):=G\left(\tau_{i} u\right)$. We start with some results on the non linearity $G$ :
Proposition B.1. Let $u, v \in[0,1]^{T_{N}^{d}}$ such that $u_{i} \geqslant v_{i}$ for all $i \in \mathcal{V}_{N}$ and $u_{0}=v_{0}$. Then $G(0, u) \geqslant G(0, v)$.
Proof. We construct a coupling between $v_{u}$ and $v_{v}$ : let $\left(U_{i}\right)$ be independent and identically distributed random variables uniform on $[0,1]$. Define $\eta_{i}=\mathbb{1}_{\left\{U_{i} \leqslant u_{i}\right\}}$ and $\eta_{i}^{\prime}=\mathbb{1}_{\left\{U_{i} \leqslant v_{i}\right\}}$. We have $\eta_{i} \geqslant \eta_{i}^{\prime}$ for all $i \in \mathcal{V}_{N}$, therefore $\rho_{0}(\eta) \geqslant \rho_{0}\left(\eta^{\prime}\right)$. This proves that $c_{0}^{+}(u) \geqslant c_{0}^{+}(v)$ and $c_{0}^{-}(u) \leqslant c_{0}^{-}(v)$. The results follows since $u_{0}=v_{0}$.

For $p \in[0,1], T \in[0,1], K \in \mathbb{N}^{*}$, we let $\kappa(K, T)=\min \{[K T\rceil-1 ;\lfloor K(1-T)\rfloor\} \leqslant K / 2$, and we define $g_{K}(p)$ as

where $X$ is a random variable with binomial distribution with parameter $(K, p)$ under $\mathbb{P}_{p}$. In particular, we have that $g_{K_{N}}(p)=G(i, u)$ for $u(t, i)=p$ for all $i \in \mathbb{T}_{N}^{d}$. Note that $g_{K}$ is $C^{\infty}([0,1])$. We also have

& =\sum_{k=0}^{\kappa(K, T)-1}\binom{K}{k}\left[(1-p)^{k+1} p^{K-k}-p^{k+1}(1-p)^{K-k}\right]-\binom{K}{\kappa(K, T)} p^{\kappa(K, T)+1}(1-p)^{K-\kappa(K, T)} . \tag{B.2}

We recall $g_{\infty}(p):=(1-p) \mathbb{1}_{\left\{1-p<p_{0}(T)\right\}}-p \mathbb{1}_{\left\{p \leqslant p_{0}(T)\right\}}$, where $p_{0}(T)=\min (T, 1-T)$.
The following proposition estimates the convergence of $g_{K}$ to $g_{\infty}$, in particular we prove that close to $p=0$ (resp. $p=1$ ), $g_{K}$ is negative (resp. positive).

Proposition B.2. For all $K \in \mathbb{N}^{*} \cup\{\infty\}$, we have $g_{K}(0)=g_{K}(1)=0$. For all $K \in \mathbb{N}^{*}$ and $p \in[0,1]$, we have, for $\left|p-p_{0}(T)\right|>\frac{1}{K}$ and $\left|(1-p)-p_{0}(T)\right|>\frac{1}{K}$

$$
\begin{equation*}
\left|g_{K}(p)-g_{\infty}(p)\right| \leqslant 2 e \exp \left(-2 K\left(p_{0}(T)-p\right)^{2}\right)+2 e \exp \left(-2 K\left(p_{0}(T)-(1-p)\right)^{2}\right) \tag{B.3}
\end{equation*}
$$

In particular, for any $0<\delta<\frac{1}{4 e}, T \in[4 \delta, 1-4 \delta]$, and $K>\frac{|\log (\delta)|}{4 \delta^{2}}$, we have that $g_{K}(2 \delta)<-\delta$ and $g_{K}(1-2 \delta)>\delta$. Proof. We consider $g_{K}$ written as in (B.2). Then, the values at $p=0$ and $p=1$ are obvious.

Note that, under $\mathbb{P}_{p}, \frac{X}{K}-p$ converges to $0\left(\right.$ in $\left.L^{2}\left(\Omega_{N}\right)\right)$ and is sub-Gaussian with variance parameter $\frac{1}{4 K}$, thus, for any $t>0$,

$$
\mathbb{P}_{p}\left(\left|\frac{X}{K}-p\right|>t\right) \leqslant 2 \exp \left(-2 K t^{2}\right)
$$

We also have that

$$
0 \leqslant p_{0}(T)-\frac{\kappa(K, T)}{K} \leqslant \frac{1}{K}
$$

Then, for $p>p_{0}(T)$,

$$
\begin{aligned}
\mathbb{P}_{p}[X \leqslant \kappa(K, T)] & =\mathbb{P}_{p}\left[p-\frac{X}{K} \geqslant p-p_{0}(T)+p_{0}(T)-\frac{\kappa(K, T)}{K}\right] \leqslant \mathbb{P}_{p}\left[p-\frac{X}{K} \geqslant p-p_{0}(T)\right] \\
& \leqslant 2 \exp \left(-2 K\left(p-p_{0}(T)\right)^{2}\right)
\end{aligned}
$$

and for $p<p_{0}(T)-\frac{1}{K}$,

$$
\begin{aligned}
\mathbb{P}_{p}[X>\kappa(K, T)] & =\mathbb{P}_{p}\left[\frac{X}{K}-p>\frac{\kappa(K, T)}{K}-p_{0}(T)+p_{0}(T)-p\right] \leqslant \mathbb{P}_{p}\left[\frac{X}{K}-p \geqslant p_{0}(T)-p-\frac{1}{K}\right] \\
& \leqslant 2 \exp \left(-2 K\left(p_{0}(T)-p-1 / K\right)^{2}\right) \leqslant 2 e^{2\left(p_{0}(T)-p\right)} \exp \left(-2 K\left(p_{0}(T)-p\right)^{2}\right) \\
& \leqslant 2 e \exp \left(-2 K\left(p_{0}(T)-p\right)^{2}\right) .
\end{aligned}
$$

Thus, we have the following, for $\left|p-p_{0}(T)\right|>\frac{1}{K}$,

$$
\left|\mathbb{P}_{p}[X \leqslant \kappa(K, T)]-\mathbb{1}_{\left\{p \leqslant p_{0}(T)\right\}}\right|<2 e \exp \left(-2 K\left(p_{0}(T)-p\right)^{2}\right) .
$$

The results follows with the same estimates with $(1-p)$ instead of $p$. This prove (B.3).
Let $\delta>0$ and set $p=2 \delta$, and $T \in[4 \delta, 1-4 \delta]$, then $\left|2 \delta-p_{0}(T)\right| \leqslant 2 \delta$ for $K>\frac{1}{2 \delta}$ and we have the same for $1-p=1-2 \delta$. Applying the result, we have

$$
\left|g_{K}(2 \delta)-g_{\infty}(2 \delta)\right|=\left|g_{K}(2 \delta)+2 \delta\right| \leqslant 4 e \exp \left(-8 K \delta^{2}\right)
$$

Then, if $4 e \exp \left(-8 K \delta^{2}\right)<\delta$, we get the result. This happens if $\exp \left(-8 K \delta^{2}\right)<\delta^{2}$ and $\delta<\frac{1}{4 e}$, which gives the condition on $K$.

Proposition B.3. Let $v: \mathbb{T}^{d} \rightarrow[0,1]$ be a continuous fixed density on the torus. For any $i \in \mathbb{T}_{N}^{d}$ we let $u_{i}:=v_{i / N}$. Then as $i / N \rightarrow x$, we have that $u_{i}$ converges to $v_{x}$. Let $v_{u}=\otimes_{i \in \mathbb{T}_{N}^{d}} \mathrm{~B}\left(u_{i}\right)$. Then, $\rho_{0}(\eta)$ converges to $v_{0}$ in probability.

Proof. We use the coupling introduced in Lemma B.1: we let $\left(U_{i}\right)$ be i.i.d uniform random variables on [0, 1] so that under $v_{u}$ we have that $\rho_{0}(\eta)$ and $\frac{1}{K_{N}} \sum_{i \in \mathcal{V}_{N}} \mathbb{1}_{\left\{U_{i}<u_{i}\right\}}$ are equal in law. By the Tchebychev inequality, we have that for any $\varepsilon>0$

$$
\mathbb{P}\left(\left|\frac{\sum_{i \in \mathcal{V}_{N}} \mathbb{1}_{\left\{U_{i}<u_{i}\right\}}}{K_{N}}-\frac{\sum_{i \in \mathcal{V}_{N}} u_{i}}{K_{N}}\right|>\varepsilon\right) \leqslant \frac{1}{4 K_{N} \varepsilon^{2}}
$$

Moreover, the sequence $K_{N}^{-1} \sum_{i \in \mathcal{V}_{N}} u_{i}$ converges to $v_{0}$ because for any $i \in \mathcal{V}_{N}, i / N \rightarrow 0$.
We have the following corollary.
Corollary B.4. Let $u=\left(u_{i}\right)_{i \in \mathbb{T}_{N}^{d}}$ as in Proposition B.3. Then, $G(u)$ and $g_{K_{N}}\left(v_{0}\right)$ converge both to $g_{\infty}\left(v_{0}\right)$ as $N \rightarrow+\infty$.

Recall that, for $q \in[-1,1]$,

$$
h_{K}(q)=2 g_{K}\left(\frac{1}{2}(q+1)\right)+q=(1-q) \mathbb{P}_{\frac{1-q}{2}}[X<\kappa(K, T)]-(1+q) \mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+q .
$$

Recall the critical parameter $\rho:=\rho(T)=\left|T-\frac{1}{2}\right|=\frac{1}{2}-p_{0}(T) \in\left[0, \frac{1}{2}\right]$. Note that $h_{K}$ converges pointwise to the function $h_{\infty}(q)=2 g_{\infty}\left(\frac{1+q}{2}\right)+q=-\mathbb{1}_{q \leqslant-2 \rho}+q \mathbb{1}_{-2 \rho<q \leqslant 2 \rho}+\mathbb{1}_{q>2 \rho}$. The points $q= \pm 2 \rho$ are the discontinuities of $h_{\infty}$, and compare the Lemma to the fact that $2 \rho=h_{\infty}\left(2 \rho^{-}\right)$and $1=h_{\infty}\left(2 \rho^{+}\right)$. A similar estimate holds at $q=-2 \rho$.

Lemma B.5. For all $q \in[-1,1],\left|h_{K}(q)\right| \leqslant 1$. Moreover, for all $\varepsilon>0$ such that $2 \rho-\varepsilon>0$, there is $K_{0}>0$ such that for $K \geqslant 0$,

$$
\begin{array}{rlrl}
2 \rho-2 \varepsilon=h_{\infty}\left(2 \rho^{-}\right)-2 \varepsilon \leqslant h_{K}(q) \leqslant h_{\infty}\left(2 \rho^{+}\right)=1 & \text { for } q \in[2 \rho-\varepsilon, 2 \rho+\varepsilon] \\
-1=h_{\infty}\left(-2 \rho^{-}\right) \leqslant h_{K}(q) \leqslant h_{\infty}\left(-2 \rho^{+}\right)+2 \varepsilon=-2 \rho+2 \varepsilon & & \text { for } q \in[-2 \rho-\varepsilon,-2 \rho+\varepsilon]
\end{array}
$$

Proof. We start by observing that for all $q \in[-1,1], \mathbb{P}_{\frac{1-q}{2}}[X<\kappa(K, T)]=\mathbb{P}_{\frac{1+q}{2}}[X>K-\kappa(K, T)]$. We also have that

$$
1=\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+\mathbb{P}_{\frac{1+q}{2}}[\kappa(K, T)<X \leqslant K-\kappa(K, T)]+\mathbb{P}_{\frac{1+q}{2}}[X>K-\kappa(K, T)]
$$

Thus, using the definiton of $h_{K}$, we get

$$
h_{K}(q)=-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+q \mathbb{P}_{\frac{1+q}{2}}[\kappa(K, T)<X \leqslant K-\kappa(K, T)]+\mathbb{P}_{\frac{1+q}{2}}[X>K-\kappa(K, T)] .
$$

This gives us the result. Indeed, for $q \in[0,1]$, we have

$$
\begin{aligned}
h_{K}(q) & \leqslant q \mathbb{P}_{\frac{1+q}{2}}[\kappa(K, T)<X \leqslant K-\kappa(K, T)]+\mathbb{P}_{\frac{1+q}{2}}[X>K-\kappa(K, T)] \\
& \leqslant \mathbb{P}_{\frac{1+q}{2}}[\kappa(K, T)<X] \leqslant 1
\end{aligned}
$$

and

$$
\begin{aligned}
h_{K}(q) & \geqslant-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+\mathbb{P}_{\frac{1+q}{2}}[X>K-\kappa(K, T)] \\
& \geqslant \mathbb{P}_{\frac{1-q}{2}}[X<\kappa(K, T)]-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)] \geqslant-\mathbb{P}_{\frac{1+q}{2}}[X=\kappa(K, T)] .
\end{aligned}
$$

The last inequality comes form the fact that, by a coupling argument, $p \mapsto \mathbb{P}_{p}[X<\kappa(K, T)]$ is decreasing on $[0,1]$, and since $q \geqslant 0, \frac{1-q}{2} \leqslant \frac{1+q}{2}$.

In particular, for $q \in[2 \rho-\varepsilon, 2 \rho+\varepsilon]$ such that $2 \rho-\varepsilon>0$, we have the same upper bound as before for $h_{K}(q)$, and for the lower bound:

$$
\begin{aligned}
h_{K}(q) & \geqslant-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+q \mathbb{P}_{\frac{1+q}{2}}[X>\kappa(K, T)] \\
& \geqslant-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]+(2 \rho-\varepsilon)\left(1-\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)]\right) \\
& \geqslant 2 \rho-\varepsilon-2 \mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)] .
\end{aligned}
$$

From the proof of Proposition B.2. we have that, for $K \geqslant K_{0}$ :

$$
\mathbb{P}_{\frac{1+q}{2}}[X \leqslant \kappa(K, T)] \leqslant 2 \exp \left(-K(q+2 \rho)^{2} / 2\right) \leqslant 2 e^{-2 K_{0} \rho^{2}}
$$

Choosing $K_{0}$ large enough such that the right hand side is less than $\varepsilon / 2$, we get the result.
For $q \in[-1,0]$, the proof is completely similar.

Lemma B.6. Let $u=\left(u_{i}\right)_{i \in \mathbb{T}_{N}^{d}}$, with $u_{i} \in[0,1]$ and let $v=2 u-1$. Then, $|H(i, v)| \leqslant 1$, uniformly on $i \in \mathbb{T}_{N}^{d}$.
Proof. We recall (4.9), in particular that $G(i, u)=G\left(\tau_{i} u\right)$. So that we only prove that $|H(v)| \leqslant 1$, where $H(v)=G((v+1) / 2)+v_{0}$. The proof is similar to Lemma B.5. Indeed, again by 4.9) we have that

$$
\begin{aligned}
2 G\left(\frac{v+1}{2}\right)+v_{0} & =c_{0}^{+}\left(\frac{v+1}{2}\right)\left(1-v_{0}\right)-c_{0}^{-}\left(\frac{v+1}{2}\right)\left(1+v_{0}\right)+v_{0} \\
& =c_{0}^{+}\left(\frac{v+1}{2}\right)-c_{0}^{-}\left(\frac{v+1}{2}\right)+v_{0}\left(1-c_{0}^{+}\left(\frac{v+1}{2}\right)-c_{0}^{-}\left(\frac{v+1}{2}\right)\right) .
\end{aligned}
$$

We observe that, by definition, $1-c_{0}^{+}\left(\frac{v+1}{2}\right)-c_{0}^{-}\left(\frac{v+1}{2}\right)>0$. This implies that $-1 \leqslant H(v) \leqslant 1$.
