## Error estimates for Gaussian beams at a fold caustic

### Abstract

Keywords: high frequency approximations, Gaussian beams, caustics

## 1 Introduction

We consider the particular case of a fold caustic in two dimensions generated by the index of refraction  $n(x, y)^2 = 1 - x$ . To be precise, we consider the out-going solution for the Helmholtz equation with a compactly supported source that concentrates on x = 0,

$$\Delta u + k^2 (1 - x)u = ik\delta(x)f(y),$$

where we take

$$f(y) = \frac{1}{\xi_0} A_0(y) e^{i\eta_0 y}, \qquad \xi_0 = \sqrt{1 - \eta_0^2}.$$

This represents an incoming plane wave in the direction  $\theta$  with amplitude envelope  $A_0(y)$ , where  $\eta_0 = \cos \theta$ .

#### 2 Exact solution

We let  $\hat{u}(x,\eta)$  be the k-scaled Fourier transform in y of the exact solution, i.e.

$$\hat{u}(x,\eta) = \sqrt{\frac{k}{2\pi}} \int e^{-i\eta ky} u(x,y) dy.$$

For x > 0 we can derive an exact expression written in terms of x,  $\eta$  and k using Airy functions,

$$\hat{u}(x,\eta) = \bar{\alpha} \frac{\operatorname{Ai}(k^{\frac{2}{3}}(x+\eta^2-1))}{\operatorname{Ai}(\alpha k^{\frac{2}{3}}(1-\eta^2))} \hat{u}_+(0,\eta). \quad (1)$$

In this expression, one notices that the denominator never vanish because all the roots of the Airv function are on the negative real axis.

what is  $\alpha$  and  $\hat{u}_+$ ?

### 3 Gaussian beam approximation

The approximation is made up of a superposition of Gaussian beams,

$$u_{GB}(x,y) = \sqrt{\frac{k}{2\pi}} \int v(x,y;z) dz.$$

where v is the Gaussian beam starting at y = z,

$$\begin{split} v(\boldsymbol{x}; z) &= \\ A(s; z) \exp\Bigl(ik\bigl[S(s; z) + (\boldsymbol{x} - \gamma(s; z)) \cdot \boldsymbol{p}(s; z) \\ &+ \frac{1}{2}(\boldsymbol{x} - \gamma(s; z))^T M(s; z)(\boldsymbol{x} - \gamma(s; z))\bigr]\Bigr), \end{split}$$

where  $\boldsymbol{x} = (x, y)$ . The beam parameters are the central ray position  $\gamma$ , the beam direction  $\boldsymbol{p}$  the shape M, the initial phase S and the amplitude A. They all satisfy known ODEs in s with initial data determined by z. In this particular case the ODEs can be solved exactly,

$$\begin{split} \gamma(s;z) &= (x(s;z), y(s;z) = (2s\xi_0 - s^2, \ z + 2s\eta_0) \\ \boldsymbol{p}(s;z) &= (\xi(s;z), \eta(s;z))) = (\xi_0 - s, \eta_0), \\ S(s;z) &= \eta_0 z + 2s - 2s^2\xi_0 + \frac{2}{3}s^3, \\ M(s;z) &= (I + 2sM_0)^{-1}M_0, \\ A(s;z) &= \frac{\tilde{A}_0(z)}{\sqrt{1 + 2si - s^2\beta}}. \end{split}$$

what is  $M_0$ ,  $\beta$  and  $\tilde{A}_0(z)$ ?

For the evaluation of the beam we connect s to a particular y-coordinate by

$$s(y;z) = \frac{y-z}{2\eta_0}$$

Then we can derive the following expression for the k-scaled Fourier transform of  $u_{GB}$ ,

$$\hat{u}_{GB}(x,\eta) = 2\eta_0 \hat{\tilde{A}}_0(\eta - \eta_0) \sqrt{\frac{k}{2\pi}} e^{ik(-2\eta_0\xi_0(\eta - \eta_0) + 2\xi_0^3/3)}$$
(2)  
 
$$\times \int \frac{e^{ik\phi(x,\theta,\eta - \eta_0)}}{\sqrt{1 + 2(\xi_0 + \theta)i - (\xi_0 + \theta)^2\beta}} d\theta,$$

where

$$\phi(x,\theta,\eta) = -\frac{1}{3}\theta^3 + \theta(\xi_0^2 - x - 2\eta_0\eta) + \frac{1}{2}m_{11}(\xi_0 + \theta)(x - \xi_0^2)$$

and  $m_{11}$ ?

## 4 Error estimate

We want to compute the max error at a fixed xand use the error in the k-scaled Fourier transform to estimate this,

$$\sup_{y} |u_{GB}(x,y) - u(x,y)| \le \sqrt{\frac{k}{2\pi}} \int |\hat{u}_{GB}(x,\eta) - \hat{u}(x,\eta)| dx$$

Away from the caustic where  $0 \leq x < \xi_0^2$  we obtain the expected  $O(k^{-1})$  error by using standard stationary phase estimates of the integral in the expression for  $\hat{u}_{GB}$  in (2) and asymptotic estimates for large arguments of Airy functions in the expression for  $\hat{u}$ . in (1).

The more interesting case is at the caustic where  $x = \xi_0^2$ . Then the asymptotic estimates above fail and a more precise analysis is needed. We use the Malgrange preparation theorem to change variables in (2). The critical values of the phase  $\phi$  for  $\eta$  small are needed. Observing that  $\partial_{\theta^3}^3(\xi_0^2, 0, 0) < 0$ , let  $\theta(x)$  solve (locally)  $\partial_{\theta^2}^2(x, \theta(x), \eta) = 0$ . One has  $\theta(x) = (x - \xi_0^2)k(x)$ , the (complex) critical points are  $\theta_{\pm}(x, \eta) = \theta(x) \pm \delta_{\pm}\sqrt{\partial_{\theta}\phi}$  for  $\Re \partial_{\theta} \phi > 0$ , hence, for  $\eta$  small, two critical values arise:

$$\begin{aligned} \phi_{\pm}(x,\eta) &= \phi_0(x) \pm \frac{2}{3} (\tilde{\rho}(x,\eta))^{\frac{3}{2}}, \text{ with} \\ \tilde{\rho}(x,\eta) &= \partial_{\theta} \phi(x,\theta(x),\eta) r(x,\eta) \\ &= (\xi_0^2 - x + 2\eta\eta_0 + O((x - \xi_0^2)^2) r. \end{aligned}$$

Deduce then

$$\hat{u}_{GB}(x,\eta) = 2\eta_0 \hat{\tilde{A}}_0(\eta - \eta_0) \sqrt{2\pi} k^{\frac{1}{6}} \times$$
(3)

$$[\sigma_0 Ai + ik^{-\frac{3}{3}} \sigma_1 Ai'] (-k^{\frac{3}{2}} \tilde{\rho}(x,\eta)) \quad (4)$$
  
 
$$\times e^{ik(-2\eta_0 \xi_0(\eta-\eta_0) + 2\xi_0^3/3 + \phi_0(x,\eta))},$$

Comparing (3) and (1), using the principal term of  $\tilde{\rho}$ ,  $\phi_0, \sigma_0, \sigma_1$ , the max error is of the order  $O(k^{-5/6})$ , which is demonstrated in numerical computations. Since the size of the solution itself grows as  $O(k^{1/6})$  at the caustic, the relative error is then still  $O(k^{-1})$ .
