New diterpenoids and phenolic amides from Icacina mannii Oliv.

Abstract

Fourteen undescribed compounds in clusting five *neo*-clerodanes (1–5), three labdanes (12–14), three pimarane (15–17) derivatives, one carbamate (24) and two clovamide-type amides (25 and 26), along with twenty-two known compounds (6–11, 18–23 and 27–36) were isolated from the tuber and stem of *leavina mannii*. Their structures were elucidated by 1D and 2D NMR and HR-ESI-MS defa analysis, and by comparing their NMR data with those of the literature.

Keywords: *Icacina mannii*, Icacinaceae, diterpenoids, labdane, *neo*-clerodane, pimarane, clovamide.

1. Introduction

Icacinaceae is a pan-tropical family of trees, shrubs and lianas, with 23 genera including the genus *Icacina* with only six species (Burkill 1994). The *Icacina* species could be used as a food source because of the nutritional contents of their seeds. The roots are toxic and are used in traditional medicine after detoxifying according to local means by macerating them in water or ethanol for about three days (Fay, 1991). Previous chemical and pharmacological investigations on some *Icacina* species indicated the presence of diterpenes with pimarane skeleton (Monday Onakpa et al., 2014; On'Okoko et al., 1977; 1980; 1985b; Zhao et al.,

2015a, 2015b, 2015c), flavonoids and clovamide (Manga et al., 2013), exhibiting various pharmacological activities (Akuodor et al., 2014; 2017; Zhao et al., 2015c, 2017).

Icacina mannii Oliv. (Icacinaceae) is a scandent shrub up to 6 m high, growing from a large underground tuber and widely distributed in African tropical regions (Burkill, 1994). The different parts (stem bark, roots, and leaves) of this plant are widely used as a food source or medicinal plant to treat many diseases (Adjanohoun et al., 1979). Traditional healers in Ivory Coast used *Icacina mannii* against oedema, women sterility, sexual asthenia and haemorrhoids, as well as a laxative and a powerful diuretic (Bouquet A. et Debray, Malan et al., 2015). In Congo (RDC), the leaves are used as expectorant and emetic to relieve bronchial affections and coughs. The tubers are used to treat gastroi. testinal disorders, dysentery, fibrous tumors and dysmenorrhea (On'Okoko et al., 1977; 1980, 1985a; 1985b). To the best of our knowledge, very few chemical studies have been correct out on *I. mannii* and only icacinone, a diterpene with pimarane skeleton (On'Okoko et al., 1985), was reported.

In the course of continuing efforts to discover novel natural products from medical plants, we report the isolation and structure elucidation of thick-six compounds including fourteen undescribed compounds from the stems and the furler rinds of *I. mannii*.

2. Results and discussion

2.1 Identification of compounds

Methanol/water (80/20, v/v) and cm, ⁴ acetate extracts of the stems and of the tuber rinds of *I.* mannii resulted after fractionation, to the isolation of thirty-six (1–36) compounds including fourteen undescribed structures (1–5, 12–17, 24–26) (Fig.1). Their structures were elucidated by 1D and 2D-NMR experiments in combination with HR-ESI-MS spectrometry data analysis and by comparison with "tenature values. The known compounds were identified as six *neo*clerodanes (6–11), six pi...arane (18–23) derivatives, three clovamides (27–29), four labdanes (30–33) and three lignanes (34–36) (Table 1).

Compound **1** was isolated as an amorphous white powder. Its molecular formula was assigned as $C_{20}H_{30}O_4$, with 6 indices of hydrogen deficiency, on the basis of the high-resolution ESI-MS experiment (negative-ion mode) by observation of pseudo-molecular ion peak at m/z 333.2069 [M-H]⁻ (calcd $C_{20}H_{29}O_4$, 333.2066). The ¹H NMR (Table 2) spectrum of **1** showed signals of one oxygenated methylene at δ_H 4.81 (H-15), and an α,β -unsaturated γ -lactone with the diagnostic peak at δ_H 7.34 (H-14). The ¹³C NMR spectrum (Table 3) displayed 20 carbon signals

assigned, with the aid of HSQC spectrum, to three methyl groups at $\delta_{\rm C}$ 16.3 (C-17), 15.3 (C-19) and 18.5 (C-20), eight methylene groups (including one oxygenated at $\delta_{\rm C}$ 72.1 (C-15), four methine groups (including one olefinic at $\delta_{\rm C}$ 147.3 (C-14), three quaternary (including one olefinic at δ_c 134.9 (C-13) and two carbonyls at δ_c 178.3 (C-18) and 176.9 (C-16). The lactone ring was confirmed by the HMBC correlations between H-14 and C-13, C-15 and C-16. Of the required six double bond equivalents, three accounted for the α,β -unsaturated carbonyl group and a carboxylic acid function while the remaining three were satisfied by the bicyclic and lactone rings. The characteristic features of ¹H and ¹³C NMR together with the molecular formula suggesting that 1 was a neo-clerodane type diterpenoid (Li et al., 2016, Merritt et al., 1992) The ¹H-¹H COSY spectrum of **1** included three fragments consisting of H-1 to H-4/H-10 to H-12, H-6 to H-8/H-17, and H-14/H-15 (Fig. 2). The presence of a carbonyl at C-18 was confirmed by HMBC correlations from H-3 and H-4 to C-18. in the NOESY experiment, the cross-peak between H-10 and H-6 β , and between H-8 and H-1^{\circ}, indicated that H-8, H-10, and C-11 were β -oriented. The absolute structure of compound 1 was determined as 4S, 5R, 8R, 9S, 10R, 15R. Therefore, 1 was identified as (4S, 5R, 8K, 9S, 10R)-neo-clerod-13-en-15,16olide-18-oic acid and named icacimannitin A.

The molecular formula of compound **2** was established as $C_{21}H_{32}O_5$ based on the pseudomolecular ion peak at *m/z* 363.2173 [M-1]^T (calcd $C_{21}H_{31}O_5$, 363.2710) observed in the HR-ESI-MS spectrum, indicating a gain or 30 *uma* compared to **1**. The ¹H and ¹³C NMR spectra (Tables 2 and 3) of **2** were very similar in those of **1**, differing in the presence of a methoxy group at δ_H 3.55 (s) in **2** linked to $c_1 b$ (δ_C 104.5) in the HMBC spectrum. The final structure was confirmed by analysis of correlations observed in COSY, HSQC and HMBC spectra. The relative configuration of **2** was determined by ROESY NMR correlations, except for the hemiacetal proton (H-15) which did not result in any informative cross-peaks. Accordingly, the structure of **2** was assigned as (4*S*, 5*R*, 8*R*, 9*S*, 10*R*)-methoxy-*neo*-clerod-13-en-15,16-olide-18-oic acid and named icacimannitin B.

Compound **3** had the same chemical formula as compound **1**, assigned by the negative HR-ESI-MS (m/z 333.2068 [M-H]⁻; calcd C₂₀H₂₉O₄, 333.2066). Their main difference was the position of the lactone function. According to ¹H and ¹³C NMR data (Tables 2 and 3) and HMBC correlations, the lactone function in **3** was located on C-15 (Table 3), in agreement with *neo*-clerodane diterpenoids bearing an 3-ethyl-2-butenolide-based side chain at C-9 (Li et al., 2016). Thus, **3** was unambiguously identified as (4S, 5R, 8R, 9S, 10R)-*neo*-clerod-13-en-16,15-olide-18-oic acid and named icacimannitin C.

The molecular formula of compound **4** was established as $C_{20}H_{32}O_2$ based on ESI-MS at m/z 304.3 [M-H]⁻. Compound **4** differs from the known compound **6** (Tables 2 and 3) by the

replacement of the acid function in **6** with an alcohol function in **4**. The presence of a β monosubstituted furan ring was clearly indicated by the ¹H and ¹³C signals at δ_{H} 6.28 (H-14), 7.38 (H-15) and 7.26 (H-16) and δ_{C} 125.6 (C-13), 110.5 (C-14), 142.5 (C-15) and 138.2 (C-16), which were in agreement with those of crolechinic acid (**6**) (Cai et al., 1993). In addition, a hydroxy group was involved in the molecule as shown by a ¹³C signal at δ_{C} 62.1 (C-18) compared to the carboxylic acid group at δ_{C} 180.4 in **6**. Furthermore, all analyses confirmed the structure of compound **4** as (4*S*, 5*R*, 8*R*, 9*S*, 10*R*)-*neo*-15,16-epoxy-clerod-13(16),14-dien-18-ol or 3,4-dihydro-bacchalineol and named icacimannitol A.

Compound 5, named 18-hydroxy-kolavenol, had the molecular formula $C_{20}H_{34}O_2$ exhibiting two rings and two C=C bonds, as evidenced by analysis of ESI-MS (n/z 306.25 [M-H]) and NMR data (Tables 2 and 3). The ¹H NMR spectrum of **5** containing 'our nethyl signals at $\delta_{\rm H}$ 1.69 (s, H_3 -16), 0.86 (d, J = 6.4 Hz, H_3 -17), 1.12 (s, H_3 -19) and 0.80 's, H_3 -20), attributed to a vinyl methyl and three methyl groups linked to sp^3 C-atom. respectively, suggested a bicyclic diterpenoid carbon framework. The presence of a all lic hydroxy methylene (HO-C-15) located on the lateral alkyl chain was indicated by the signal at $\delta_{\rm H}$ 4.08 (d, J = 6.7, H₂-15), which was coupled in the COSY spectrum to a vici al olefinic proton (H-14, $\delta_{\rm H}$ 5.38, m). A signal at $\delta_{\rm H}$ 5.57 (m) was assigned to zero another olefinic proton (H-3) coupled with two methylenes (H-2) resonating at $\delta_{\rm H}$ 2.17–2. (m), in turn linked to the methylene (H-1) at $\delta_{\rm H}$ 1.67–1.50 (m). A methyl (H-19) had direct correlation with the signals at δ_c 148.6 (C-4), δ_c 38.8 (C-5) and δ_c 47.6 (C-10), and where β_c carbon in turn showed significant long-range crosspeaks with H-2, in the HMBC spectrum, supporting the location of the second double bond in the ring A of a rearranged neo-ularodane diterpenoid. Particularly diagnostic were the longrange HMBC correlations of the quaternary carbon C-9 (δ_c 39.7) with H-8, H-11a, H-17, and H-20 as well as C-10 (5 47.6) with H-6a. The geometry of the double bond in the lateral chain was determined to be (E) is in kolavenol (7) by the chemical shift of the vinyl proton H-16 (δ_c 16.4) (Lopes et al., 1987; Salah et al., 2003; Tsichritzis and Jakupovic, 1991). Compound 5 was identified as 18-hydroxy-kolavenol or (5R, 8R, 9S, 10R)-neo-13-methyl-clerod-3,13E-dien-15,18-diol and named icacimannitol B.

Compounds 12 to **14** have the similar basic skeleton as compounds **5** and **7**, according to their NMR spectra (Fig 1).

Compound **12** had the same molecular formula (ESI-MS m/z 290.3 [M]⁺) as **7**. The ¹H NMR spectrum of **12** (Table 4) was similar to that of **7**. The two compounds differed by the position of the methyl groups C-18 and C-19 positioned at C-4 in compound **12**, thus suggesting it to have a labdane-type diterpenoid skeleton (Freiburghaus et al., 1998). Of the required four

double bond equivalents, two double bonds were attributable to (C-1=C-10) and (C-13=C-14), while the remaining two were satisfied by the bicyclic rings. The methyls H₃-18 at δ_{H} 0.91 and H₃-19 at δ_{H} 0.85 had direct correlation with the signals at δ_{C} 32.4 (C-4), δ_{C} 44.8 (C-5), and δ_{C} 34.2 (C-3) in the HMBC spectrum (Figure 2). Total NMR assignment of **12** (Table 4), suggested its bicyclic halimene backbone (Hara et al., 1995). Thus, **12** was identified as *neo*-halima-1(10),13*E*-dien-15-ol.

Compound **13** had the same molecular formula (ESI-MS m/z 290.3 [M]⁺) as **12**. The NMR spectra of **13** (Table 4) were similar to those of **12**. However, **13** differed from **12** by the position of the double bond at C-5-C-10 in **13** instead of C-1-C-10 in **12**. Total assignment of NMR data (Table 4) identified **13** as *neo*-halima-5(10),13*E*-dien-¹⁵-ol.

Compound **14** had the same molecular formula (ESI-MS m/z 306 35 [M]⁺) as **5**. The ¹H NMR spectrum of **14** (Table 4) was similar to that of **13** described above, except the presence of hydroxyl group at C-19 characterized by oxygenated metrogram protons at δ_{H} 3.26 and 3.49 in **14**. Total assignment of NMR data (Table 4) as ribuled **14** to *neo*-19-hydroxy-halima-5(10),13*E*-dien-15-ol.

Compound 15 was obtained as colourless amorphous solid. A molecular formula of C₁₉H₂₆O₇ with 7 indices of hydrogen deficiency, we suggested by the positive HR-ESI-MS (m/z389.1579 [M+Na]⁺; calcd $C_{19}H_{26}O_7Na$, 389.1576). The ¹H NMR and HSQC spectra of **15** revealed the presence of two methyl groups as singlets at $\delta_{\rm H}$ 0.99 and 1.22 corresponding to the methyl carbons at δ_c 16.4 (C-15) and 19.2 (C-16), respectively (Table 5). Four methylene group signals were observed in the ¹H NMR spectrum at δ_{H-1} 1.54 and 1.42, δ_{H-2} 1.92 and 1.64, δ_{H-11} 1.62 and 1.16, and δ_{H-12} 1.7 and 1.48. Signals at δ_{H} 5.06 (dd, J = 7.5, 4.5 Hz), 3.55 (d, J= 4.5 Hz) and $\delta_{\rm H}$ 3.66 (d, \prime = 1.6 Hz) corresponded to the oxygenated methine carbons C-6, C-7 and C-14, respectively Signals at $\delta_{\rm H}$ 2.21 (d, J = 7.5 Hz) and 1.55 (dd, J = 12.8, 4.4 Hz) were assigned to the machine carbons C-5, and C-9, respectively (Fig. 2). The ¹³C NMR spectrum also exhibited a singlet of a methoxy group at $\delta_{\rm H}$ 3.20 linked to C-19, and two protons at $\delta_{\rm H}$ 4.51 (dd, J = 9.1, 3.4 Hz) and $\delta_{\rm H}$ 3.34 (dt, J = 9.1, 1.5 Hz), corresponding to an oxygenated methylene group (C-18). The ¹³C NMR spectrum of compound **15** showed the presence of 19 carbons. One lactone resonance at $\delta_{\rm C}$ 178.3 was attributed to C-17. The carbon resonances at $\delta_{\rm C}$ 96.9, 65.2 and 77.7 were attributed to oxygenated quaternary carbons C-3, C-8, and C-13, respectively after analysis of HMBC spectrum (Fig. 2). In the NOESY experiment, the cross-peak between H-18 β and H-11 and H-9, indicated that H-9 was in β -orientation. The COSY and HMBC correlations were in agreement with the seven degrees of unsaturation, including the carboxylic acid function of the lactone, the tricylic rings, while the remaining two were identified as a tetrahydropyran and an epoxide (Fig 2). These

assignments were consistent with the structure of reported (9 β -H)-pimarane derivative (Zhang et al., 2022). Accordingly, compound **15** was identified as 16-*nor*-(9 β -H)-pimarane and named Icacinlactone O.

Compound **16** was isolated as a colourless amorphous solid. The HR-ESI-MS indicated a molecular formula of $C_{18}H_{24}O_{10}$ (*m/z* 399.1288 [M-H]⁻; calcd $C_{18}H_{23}O_{10}$, 399.1291). Its ¹H NMR spectrum was similar to that of **15** (Table 5), differing in the resonances at δ_{c} 65.9 (C-1), 78.8 (C-5), 68.4 (C-11) and 71.3 (C-13), suggesting their oxygenated substitution. The final structure was confirmed using correlations observed in COSY, HSQC and HMBC spectra. Therefore, the structure of **16** has been established as icacinlactone P.

Compound 17 was obtained as a white amorphous powder and had a molecular formula of $C_{25}H_{30}O_{12}$, established by its negative ion HR-ESI-MS at n/z 521.1655 [M-H] (calcd for C₂₅H₂₉O₁₂, 521.1659), with 11 indices of hydrogen deficie icy. The ¹H and ¹³C NMR spectra displayed resonances due to the icacinone aglycone is in 19 (Table 5) with two olefinic protons ($\delta_{\rm H}$ 6.67 (H-15) and 7.72 (H-16)) of the tet any tropyran, one oxygenated methine proton ($\delta_{\rm H}$ 3.90, H-2), two methylene protons bearing an exygen ($\delta_{\rm H}$ 4.21, H-19b and 3.50, H-19a), and one methyl group ($\delta_{\rm H}$ 1.24, H₃-17), she inc correlations in the HSQC spectrum with their corresponding carbon at δ_c 106.9, 14 r.s. 76.7, 72.1 and 16.8, respectively. Furthermore, other characteristic signals were observed such as two oxygen-bearing carbons at $\delta_{\rm C}$ 193.1 (C-12) and $\delta_{\rm C}$ 177.1 (C-18), confirming use existence of two carbonyl groups, and one carbon at $\delta_{\rm C}$ 96.6 (C-3) suggesting the presence of a hemiacetalic function. Extensive 2D NMR analysis confirmed the structure c the aglycone to be icacinone (On'Okoko et al., 1985). The presence of one sugar molety in compound 17 was evidenced by the presence of one anomeric proton at $\delta_{\rm H}$ 4.32 (o, I = 7.8 Hz, H-1') (Table 5). Full sugar assignment was achieved by extensive 1D and D-. IMF spectra analyses (¹H-¹H-COSY, HSQC and HMBC) and by optical rotation measurement, allowing characterization of a β -D-glucopyranosyl. The large coupling constant (>7 Hz) for glucose indicated their β -configuration (Agrawal, 1992; Bock and Pedersen, 1983). The HMBC correlation between Glc-H-1 ($\delta_{\rm H}$ 4.32) and C-2 ($\delta_{\rm C}$ 76.7) of icacinone indicated the glycosidic linkage at the C-2 position of icacinone (Fig. 1). Therefore, the structure of **17** was established as $2-O-\beta$ -D-glucopyranosyl-icacinone.

The molecular formula of compound **24** was established as $C_{14}H_{20}N_2O_5$, based on the negative ion HR-ESI-MS at *m/z* 295.1295 [M-H]⁻ (calcd for $C_{14}H_{19}N_2O_5$, 295.1294). The ¹H-NMR spectrum (Table 6) showed a 1,3,4-trisubstituted benzene ring due to the presence of three aromatic signals from an ABX spin system, consisting of a broad singlet at δ_H 6.81 (brs, H-3), and two doublets at δ_H 6.72 (*J* = 7.2 Hz, H-5), δ_H 6.65 (*J* = 7.2 Hz, H-6). The ¹H-NMR spectrum displayed two singlets at δ_H 3.86 and 3.65 ascribed to two methoxyl groups. The ¹H-NMR

spectrum also exhibited a triplet at $\delta_{\rm H}$ 2.42 (2H, H-1') and a multiplet at $\delta_{\rm H}$ 2.10 (2H, H-2'), each corresponding to nitrogen-bearing protons, and two methylene protons at $\delta_{\rm H}$ 2.72 (2H, t, J = 6.4 Hz, H-7) and 3.39 (2H, t, J = 6.4 Hz, H-8) correlated each other in COSY spectrum (Fig. 2). The ¹³C NMR spectrum of **24** (Table 6) showed 14 signals including: six aromatic carbons, two methoxyl carbons, four carbons assigned to methylenes, and two carboxylic amides. The presence of oxygen on the aromatic carbons C-3 and C-4 was reflected by their deshielding at $\delta_{\rm C}$ 147.5 and 144.6, respectively. The HMBC experiment showed the linkages of the methoxyl group at $\delta_{\rm H}$ 3.86 (OCH₃) with the carbon at $\delta_{\rm C}$ 147.5 (C-3) of the benzene ring, and HMBC correlations between H-7 at $\delta_{\rm H}$ 2.72 and the carbons at $\delta_{\rm C}$ 130.5 (C-1), 111.9 (C-2), and 120.8 (C-6) (Fig. 2). Other correlations were observed from H-7 and H-1' to C-9 (δ_c 173.4) and from H-2' and the methoxyl group ($\delta_{\rm H}$ 3.65) to C-3' ($\delta_{\rm C}$ 1.2.1). The above data led to N-[2-[3-(1 hydroxy-3-methoxyphenyl)propyl identified the compound 24 as methyl amido]ethyl]carbamate and named Icaninamate.

Compound **25** had a molecular formula of $C_{18}H_{17}NO_{7}$ as great by observation of the pseudomolecular ion peak in the HR-ESI-MS at m/z 358.092 [M-H]⁻ (calcd for 358.0927). The ¹H and ¹³C NMR spectra displayed resonances due to the clivamide (EI-Sharawy et al., 2017, Manga et al., 2013, Sanbongi et al., 1998) with six propartic protons at $\delta_{\rm H}$ 6.70 (d, J = 2.1 Hz), 6.69 (d, J = 8.3 Hz), 6.84 (dd, J = 8.3, 2.1 Hz), 7 J8 (d, J = 2.1 Hz), 6.70 (d, J = 8.3 Hz), and 6.84 (dd, J = 8.3, 2.1 Hz) showing correlations in the HSQC spectrum with their corresponding carbon at δ_c 117.2 (C-2), 116.0 (C-5) 12 .7 (C-6), 115.1 (C-2'), 116.3 (C-5'), and 123.5 (C-6') (Table 6). Furthermore, other char acteristic signals were observed such as two olefinic protons at $\delta_{\rm H}$ 6.44 (H-7', d, J = 12.7 Hz, $\delta_{\rm H}$ 5.81 (H-8', d, J = 12.7 Hz), one methylene proton at $\delta_{\rm H}$ 3.10 (H-7b, dd, J = 14.0, 5.3 Hz) and 2.90 (H-7a, dd, J = 14.0, 8.5 Hz) and one nitrogenbearing methine proton a $\delta_{\rm H}$ 1.71 (H-8, dd, J = 8.6, 5.3 Hz) showing HSQC correlation with carbons at δ_c 139.5 (C-7'), 120.8 (C-8'), 37.8 (C-7) and 55.4 (C-8), respectively. The coupling constant (J = 12.7 Hz) between the ethylenic doublets at $\delta_{\rm H}$ 5.81 and 6.44, suggested that the double bond was of Z configuration. Extensive 2D NMR analysis confirmed the structure of 25 to be clovamide (Fig. 2). According to the above-described results, the structure of compound 25 was elucidated as (+)-N-(Z)-caffeoyl-L-dopamine. It was isolated in mixture with (-)-N-(E)caffeoyl-L-dopamine (28).

Compound **26** exhibited, in the negative ion-mode HR-ESI-MS, a pseudo-molecular ion peak at m/z 372.1082 [M-H]⁻ (calcd C₁₉H₁₈NO₇, 372.1083) compatible with the molecular formula C₁₉H₁₉NO₇. The ¹H NMR spectrum of **26** (Table 6) was similar to that of **25**, except for the presence of the signal of methyl ester group at δ_{H} 3.70. Based on the above spectral data, the

structure of **26** was identified as (-)-(Z)-caffeoyl-L-dopamine methyl ester. It was isolated in mixture with its isomer E (**29**).

2.3 Chemotaxonomic significance

Icacinone (**19**) have been previously identified in the tubers of *I. mannii* (On'Okoko et al., 1985a). Compounds **18**, **19**, **20**, **22** and **23**, were previously isolated in the genus *Icacina* (On'Okoko et al., 1985; Sun, 2019; Zhao et al., 2015). Deoxyclovamid (**27**) [*N*-(*E*)-caffeoyl-L-dopamine] was previously identified in the leaves of *I. senegalensis* (Manga et al., 2013), but this is the first report of annonalide (**21**), phenolic amides compounds (**24–29**) from *I. mannii*. In addition, this study is the first structural elucidation of *neo*-clerogenes (**6–11**), labdanes (**30–33**), and lignans (**34–36**) from the genus *Icacina*.

3. Conclusion

In conclusion, we have isolated eleven new diverpenoids (1-5, 12-17) and three new clovamide-type amides, (24-26) from peeling of tubers and stems of *I. mannii*. Many of the isolated compounds were *neo*-clerodane type diterpenoids. Indeed, this finding showed that the diterpene and amide derivatives could play a key role in chemotaxonomic classification of *lcacina* genus. The presence of these molecules can explain the different medicinal properties of *I. mannii*. Further chemical and Liclogical studies are necessary for promoting these molecules.

4. Experimental

4.1. General experimental procedures

Optical rotations were measured on a Perkin-Elmer 341 polarimeter. 1D and 2D-NMR spectra were recorded in MeOH- d_4 or DMSO- d_6 on Bruker Avance DRX III 500 or 600 instrument using standard Bruker microprograms (Karlsruhe, Germany). (–) and (+)-HR-ESI-MS were obtained from Micromass Q-TOF micro-instrument (Manchester, UK). Flash chromatography was performed on a Grace Reveleris system equipped with dual UV and ELSD detection using Grace cartridges (silica gel or RP-C₁₈), and the monitored wavelengths were at 205 and 254 nm. The medium-pressure liquid chromatography (MPLC) was employed using a Buchi pump system AP250/500 (Bushi, France), with a RP-C₁₈ silica gel Merck column (15 × 230 and 26 × 460 mm). Semi-preparative HPLC was performed on an apparatus equipped with an ASI-100 Dionex autosampler, an Ultimate 3000 pump ThermoFisher Scientific, a diode array detector

UVD 340S and a Chromeleon software (Dionex, ThermoFisher Scientific, France). RP-C₁₈ column (Phenomenex 250 ×15 mm, Luna 5 μ , Interchim, France) was used for the semipreparative HPLC with a binary gradient eluent (H₂O pH 2.4 with TFA; CH₃CN) and a flow rate of 5 mL/min; the chromatogram was monitored at 205, 254, 300, and 360 nm. Analytical TLC was performed using silica gel plates (Merck Kieselgel 60 F254) and RP-C₁₈ plates (Kieselgel 60 F₂₅₄) and visualized at 254 and 366 nm and by spraying the dried plates with vanillin and 50% of H₂SO₄, followed by heating.

4.2. Plant material

Peeling of tubers and stems of *I. mannii* Oliv. (Icacinaceae) were collected in December 2018 from Abidjan (South Ivory Coast) during the wet season, and idensified at the National Floristic Center of the University Félix Houphouët Boigny of Cocody Abid jan (Ivory Coast), where a voucher specimen (UCJ008642) has been deposited.

4.3. Extraction and isolation

4.3.1. Fractionation of the tuber rinds of I. mannii

The tuber rinds of *I. mannii* (295.5 g) were milled and extracted with 80% aqueous methanol (4L) by maceration (72 h) followed by leacing. After evaporation of the MeOH, the aqueous phase was successively partitioned with $C_1 C_2$ and *n*-BuOH. The CH₂Cl₂ extract (19.7 g) was subjected to vacuum liquid chromatography (VLC) over silica gel (318 g, 9 cm) and eluted with petroleum ether-CH₂Cl₂-MeOH (from 1. υ) to 0:0:1, v/v/v) to give six fractions (F1-F6). The combined fractions (F2+ F3) (1.2 g), suted with petroleum ether-CH₂Cl₂ (9:1 and 8:2), was separated over a silica gel colur. n using a gradient of petroleum ether-CH₂Cl₂ (from 1:0 to 0:1, v/v; 25 mL each) to give 19 s. bfractions (Fa-Fs). The subfraction Fi gave 6 (508 mg). Compounds 7 (26 mg), 12 (10 mg) and 30 (70 mg) were obtained from Fj (2.4 g) by preparative HPLC (CH₃ \cup N-H₂O, 8:2 to 10:0, v/v; 10 mL/min). The subfraction Fn (761 mg) was purified by preparative HPLC eluted with CH_3CN-H_2O (7:3 to 10:0, v/v; 10 mL/min) to afford compounds 4 (12 mg) and 9 (70 mg). Fraction F5, eluting with petroleum ether-CH₂Cl₂-MeOH (0:1:0) was fractionated into 24 subfractions (E_1 - E_{24}) by RP₁₈ flash chromatography (40 g) using a gradient of CH₃CN-H₂O (2:8 to 8:2, v/v; 25 mL each). Compound **15** (*tr*=12.9 min, 3) mg) was purified by semi-preparative HPLC from subfraction E₂, eluted with CH₃CN-H₂O (2:8 to 4:6 v/v, during 35 min). The subfraction E_4 was purified by semi-preparative HPLC eluted with CH₃CN-H₂O (25:75 to 50:50, v/v, during 35 min) to afford 20 (tr=11.4 min, 11 mg), 18 (tr=13.3 min, 5 mg), and 21 (tr=13.6 min, 5 mg). Compounds 22 (tr=15.1 min, 6 mg), and 2 (tr=20.1 min, 1 mg) were obtained from subfraction E_{10} by semi-preparative HPLC (CH₃CN-H₂O, 5:5 to 7:3, v/v, during 35 min). The combined subfractions (E₁₂ and E₁₃) was further purified by semi-preparative HPLC (CH₃CN-H₂O, 65:35 to 75:25, v/v, during 35 min) to

give compounds **3** (*tr*=11.3 min, 6 mg) and **1** (*tr*=12.6 min, 6 mg). The combined subfractions ($E_{14} - E_{16}$) was purified by preparative HPLC eluted with CH₃CN-H₂O (6:4 to 10:0, v/v; 10 mL/min) to yield compounds **8** (4 mg), **5** (13 mg) and **11** (13 mg). Compounds **31** (*tr*=13.2 min, 2 mg) and **14** (*tr*=14 min, 2 mg) were purified from subfraction E_{17} by semi-preparative HPLC (CH₃CN-H₂O, 8:2 to 10:0, v/v, during 35 min).

A part of the *n*-BuOH extract (18.5 g) was passed through a macroporous resin Diaion HP-20 column (5 × 45.5 cm) eluted with EtOAc-MeOH-H₂O (from 0:2:8 to 1:0:0, v/v/v, 1.5 L each) to give six fractions (B1-B6). The fraction B1 (15.7 g) was separated into 29 subfractions named M_1 - M_{29} using RP₁₈ flash chromatography eluted with CH₃CN/H₂O (from 5/95 to 40/60, v/v). The combined subfractions M_{11} - M_{14} was chromatographed by PLC eluted with CH₃CN-H₂O (5:95 to 40:60, v/v; 10 mL/min) to afford compounds **16** (6 mg) and **21** (\ge mg). Compounds **17** (147 mg), **19** (27 mg), **34** (4 mg), **35** (2 mg), **36** (6 mg), and **26** (5 mg) were purified from combined subfractions M_{16} - M_{18} by PLC (CH₃CN-H₂O, 10:90 to 50:50, v/v) to mL/min). Compound **23** (57 mg) was precipitated from the subfraction M_{24} . Fraction \ge 2, eluting with EtOAc-MeOH-H₂O (0:40:60), was further purified by semi-preparative HPLC (CH₃CN-H₂O, 2:8 to 4:6 v/v, during 30 min) to yield compounds **25** (*tr*=5.6 min, 8 mr₃), **28** (*tr*=13.3 min, 12 mg), **27** (*tr*=17 min, 2 mg) and **29** (*tr*=20.5 min, 9 mg).

4.3.2. Fractionation of the stems of I. monnii

Powdered air-dried stems (2 kg) wer $: oxtracted by maceration with EtOAc (20L) at room temperature for 72h. The extract (0 g) was fractionated by VLC on silica gel with a gradient of petroleum ether-CH₂Cl₂-MeOH (:om 1:0:0 to 0:0:1, v/v/v) to give eight fractions (S1-S8). Fraction S4 (120 g), obtaine <math>\cdot$ with the mixture petroleum ether-CH₂Cl₂-MeOH (7:3:0), was separated into 16 subfraction: (Sa-Sp) by RP₁₈ flash chromatography eluted with a gradient CH₃CN-H₂O (8:2 to 10:0, v/v). The subfraction Sc (3.075 g) contain the pure compound **6**. Compounds **10** (*tr*=17 min, 5 mg), **33** (*tr*=17.7 min, 3.2 mg), and **32** (*tr*=19.3 min, 4.2 mg), were purified by semi-preparative HPLC of subfraction Sf, eluted with CH₃CN-H₂O (95:5 to 100:0, v/v, during 30 min). The subfraction Sg was chromatographed by PLC eluted with CH₃CN-H₂O (8:2 to 10:0, v/v; 10 mL/min) to afford compounds **7** (13 mg) and **12** (1.2 mg). The subfraction Sh was purified by semi-preparative HPLC eluted with CH₃CN-H₂O (98:2 to 10:0, v/v; 10 mL/min) to afford compounds **7** (13 mg) and **13** (*tr*=20.5 min, 2 mg).
