## Article New insight into the reactivity of S,S-bis-ylide

Abstract: The present work focuses on the reactivity of S,S-bis-ylide 2, which presents a strong nu-12cleophilic character as evidenced by reactions with methyl iodide and CO2 affording C-methylated13salts 3 and betaine 4, respectively. Derivatization of betaine 4 affords the corresponding ester deriv-14ative 6 which was fully characterized by NMR spectroscopy and X-ray diffraction analysis. Further-15more, an original reaction with phosphenium ions leads to the formation of a transient push-pull16phosphino(sulfonio)carbene 8 which rearranges to give stabilized sulfonium ylide derivative 7.17

## 1. Introduction

Since the discovery of ylides in the 1920s [1,2], their chemistry has experienced an 21 important grow [3-5] and they have become very important synthetic tools [6-9]. Bis-22 ylides, which are the combination of two ylide functions on a single carbon atom, have 23 attracted significant attention from many research groups [10-16] Indeed, since the first 24 synthesis of carbodiphosphoranes I by Ramirez in the 60s [17], many models have been 25 developed (Figure 1). Among them, we can mention carbodicarbenes II prepared by Ber-26 trand's group [18] after initial theoretical predictions by Frenking [19], the mixed carbo-27 phosphinocarbene III initially synthetized by Fürstner and Alcarazo and later by Ong et 28 al. [20,21,22] and mixed phosphonio/sulfonio IV and phosphonio/sulfoxonio V (X = O) 29 bis-vlides prepared by our group [23-25]. Finally, major contributions were made by Fu-30 jii's group with various combinations of selenium/sulfur or sulfur/sulfur stabilized car-31 bones V-VIII [26-30]. Naturally, this diversity of structures has brought considerable 32 knowledge on these species that exhibit a very diverse reactivity ranging from their use 33 as ligands in organometallic chemistry [15] to activation of small molecules [21] and even 34 application as atomic carbon sources [23]. Bis-ylides main application remains their use 35 as ligands because of the peculiar environment of the central carbon atom. In particular, 36 the presence of two lone pairs located on a single carbon atom [10-16] offers unique coor-37 dination modes for transition metals. Indeed, Stephen took advantage of the presence of 38 the two lone pairs to stabilize certain transition metals, achieving high efficiency in hy-39 drogenation reactions [31]. Ong's group has evidenced that the unexpected accepting 40 character of carbodicarbenes at the N-heterocyclic carbene fragments was benefic for an 41 ambiphilic-type reactivity allowing the activation of small molecules [32,33]. It is obvious 42 that the reactivity and applications of bis-ylides are directly linked to the combination of 43 the two ylide functions, but overall remain rare. 44

In 2010, we have reported the first stable and isolable mixed P,S-bis-ylide IV [23] which can be used as atomic carbon reagent to introduce one carbon atom into various organic molecules [34]. In particular, the labile character of sulfide ligand in IV facilitates substitution reactions at the central carbon atom and thus atomic carbon transfer reactions. Therefore, S,S-bis-ylide VI constituted of two labile sulfide moieties should be an excellent atomic carbon reagent. However, probably due to the thermal instability of VI, only a few reactions with Au(I), demonstrating its carbone character were described [30] and no reaction with organic reagents has been reported to date. In this article, we report original reactions of S,S-bis-ylide VI with CO<sub>2</sub> and phosphenium ions (Figure 1).

#### 2. Results and Discussion

Monoprotonated precursor 1 (Scheme 1) has been prepared according to the method previously described by Fujii [30]. The spectroscopic data are in good agreement with the reported values. In particular, the central proton and carbon resonances of **1** appear at  $\delta$  = 3.88 ppm and  $\delta$  = 19.4 ppm, respectively in <sup>1</sup>H and <sup>13</sup>C NMR spectra. Because of the thermal instability of S,S-bis-ylide 2, the deprotonation was then realized in THF-d<sub>8</sub> using potas-sium hexamethyldisilazane at -80 °C and was analyzed at low temperature, in situ, in the presence of conjugated acid. With the appearance of a bright yellow color, in the <sup>1</sup>H NMR spectrum the C-H signal in disappeared while the central carbon in the <sup>13</sup>C NMR spectrum was lower field shifted at  $\delta$  = 39.0 ppm compared to **1**. Bis-ylide **2** starts to decompose at -30 °C to afford black carbon precipitate and diphenyl sulfide.

The formation of S,S-bis-ylide **2** was unambiguously confirmed by its methylation 78 reaction (Scheme 1). Indeed, upon addition of one equivalent of methyl iodide to a THF 79 solution of **2** at -80 °C, the yellow color immediately disappeared concomitantly with the 80 precipitation of a white solid. After treatment, the desired C-methylated salt **3** was isolated in 85% yield. The methylation was confirmed by the presence of two characteristic signals for the methyl group at  $\delta = 1.67$  ppm and  $\delta = 10.2$  ppm in the <sup>1</sup>H and <sup>13</sup>C NMR 83 spectra, respectively. C-methylated salt **3** was isolated in the crystalline form layering 84

diethyl ether onto a saturated dichloromethane solution and its structure was confirmed by X-ray diffraction analysis (Figure 2). As expected, the S-C bond lengths in **3** (1.682 and 1.687 Å) are very similar to those of the protonated bis-ylide precursor **1** (1.685 Å and 1.676 Å) [30] and much shorter than a S-C single bond length (1.81 Å), showing the delocalization of the negative charge from the central carbon atom to the SPh<sub>2</sub> fragments, and justifying the planar environment around the C1 atom ( $\Sigma^\circ$ = 359.7°). The S1-C1-S2 angle is also almost identical to that of **1**.

It is well known that carbodiphosphoranes (P,P-bis-ylides) react with CO2 to form 101 zwiterrionic donor-acceptor complexes that can coordinate transition metals or evolve 102 upon heating towards phosphine oxyde and phosphoranylideneketene [35-39]. The sulfur 103 analogue 2 also reacts with CO<sub>2</sub> (3 bars) at -70 °C affording the corresponding CO<sub>2</sub> adduct 104 4 (Scheme 2).  $^{13}$ C NMR analysis of the resulting solution at -20 °C shows two broad signals 105 appearing at  $\delta$  = 167.2 ppm and  $\delta$  = 40.16 ppm corresponding to the coordinated CO<sub>2</sub> 106 fragment and the central carbon atom, respectively, in good agreement with the formation 107 of betaine 4. However, at room temperature, zwiterionic CO<sub>2</sub> adduct 4 reacts slowly 108 hexamethyldisilazane byproduct to afford the O-silylated ester 5 [40]. Alternatively, CO<sub>2</sub> 109 adduct 4 can be trapped by adding one equivalent of MeI to generate the O-methylated 110 salt 6, which is stable and was easily isolated in 80% yield. Compound 6 has been fully 111 characterized by NMR spectroscopy (see experimental section and supporting 112 information). Single crystals of 6 were grown layering pentane onto a saturated DCM at 113 room temperature [41] and then analyzed by X-ray diffraction confirming the expected 114 structure (Figure 3). The S1-C2 and S2-C2 bond lengths (1.720(2) Å and 1.713(3) Å, 115 respectively) are slightly longer than in those of **3** (1.682 Å and 1.687 Å). The central carbon 116 C1 shows a planar environment and the C1-C2 bond length is short 1.437(4) Å. This 117 bonding pattern can be explained by a major contribution of the ester fragment to stabilize 118 the negative charge [42]. 119 120

In order to demonstrate the leaving group ability of sulfide group, we have consid-131 ered the reaction of S,S-bis-ylide 2 with an electrophile bearing a lone pair such as a 132 phosphenium ion (Scheme 3) [43]. The reaction of 2 with bis(diisopropyla-133 mino)phosphenium ion at -80 °C affords ylide 7 with a good selectivity when the reaction 134 mixture is rapidly brought to room temperature [44]. The structure of 7 was established 135 by X-ray diffraction analysis (Figure 4). Variable temperature NMR analysis indicate the 136 formation of adduct 8 ( $\delta$  = 48.3 ppm in <sup>31</sup>P NMR) at -70°C that starts to evolve towards 137 sulfonium ylide 7 ( $\delta$  = 25.7 ppm in <sup>31</sup>P NMR) above -40°C (carbene intermediate 9 was not 138 detected). The process can be explained by the initial attack of nucleophilic bis-ylide 2 on 139 the positively charged phosphenium salt generating a phosphino cationic ylide interme-140 diate 8 (Scheme 4). The  $\pi$ -donation of phosphine lone pair induces sulfide elimination and 141 formation of phosphino(sulfonio)carbene 9. This push-pull carbene, substituted by a 142  $\pi$ -donating phosphino- and a  $\pi$ -accepting sulfonio-group, exhibits a strong electrophilic 143 character on the phosphorus center [45], and therefore reacts with triflate anion to afford 144 **10**. Finally, rearrangement, starting with the nucleophilic attack of central carbon to the 145

sulfoxide moiety, occurs to afford sulfonium ylide 7 which is stabilized by two  $\pi$ -accept-146 ing substituents such as trifluoromethanesulfonyl and phosphonyl groups, as indicated 147 by the short C1-S2 and C1-P1 bond lengths [1.694(2) and 1.807(2) Å, respectively]. Thanks 148to the high leaving group ability of sulfide ligand, such a strongly electrophilic phos-149 phino(sulfonio)carbene 9, which reacts even with the generally non-coordinating triflate 150 anion, can be generated from 8 by elimination of diphenyl sulfide. It should be noted that, 151 in the case of carbodiphosphoranes, such an addition-elimination reaction does not take 152 place. Instead, they react with a chlorophosphine to form a stable adduct similar to 8 153 [46,47]. 154

3. Materials and Methods

### 3.1. General Comments

All manipulations were performed under an inert atmosphere of argon by using standard 170 Schlenk techniques or high-pressure NMR tube techniques. Dry and oxygen-free solvents 171 were used. <sup>1</sup>H, <sup>13</sup>C, <sup>19</sup>F and <sup>31</sup>P NMR spectra were recorded on Brucker Avance II 300 MHz, 172 Avance III HD 400 MHz and Avance I and II 500 MHz spectrometers (Brucker, Karlsruhe, 173 Germany). Chemical shifts are expressed in parts per million with residual solvent signals 174 as internal reference (<sup>1</sup>H and <sup>13</sup>C{<sup>1</sup>H}). <sup>19</sup>F and <sup>31</sup>P NMR chemical shifts were reported in 175 ppm relative to CFCl<sub>3</sub> and 85% H<sub>3</sub>PO<sub>4</sub>, respectively. The following abbreviations and their 176 combinations are used: br, broad; s, singlet; d, doublet; t, triplet; q, quartet; hept, heptuplet; 177 m, multiplet. <sup>1</sup>H and <sup>13</sup>C resonance signals were attributed by means of 2D COSY, HSQC 178 and HMBC experiments. Mass spectra were recorded on a Hewlett Packard 5989A 179 spectrometer (Hewlett-Packard, Palo Alto, CA, United States). HRMS was realized on a 180 Xevo G2 QTof apparatus (Waters, Milford, United States). Melting points were measured 181 in a sealed glass tube on a Stuart SMP-30 melting point apparatus. All commercially 182 available reagents were used without further purification otherwise noted. 1 was 183 prepared following previously reported procedure [30]. 184

### 3.2. Synthesis

S,S-Bis-ylide 2: In a J. Young NMR tube, protonated precursor of bis-ylide 1 (50 mg, 186 0.094 mmol, 1 eq.) was dissolved in THF- $d_8$  (0.2 mL). At -80 °C, a solution of KHMDS (19 187 mg, 0.095 mmol, 1 eq.) in 0.2 mL of THF-ds was added. The NMR tube was then closed 188 and carefully shaken the mixture while remaining at low temperature. The yellow colored 189 solution was obtained. Because of thermal instability of 2, the product was used or char-190 acterized at low temperature in presence of hexamethyldisilazane without any purifica-191 tion. <sup>1</sup>H NMR (400 MHz, 213 K, THF-ds):  $\delta$  = 7.41–7.26 (m, 12H, CHar), 8.02-7.90 (m, 8H, 192 CH<sub>ar</sub>). <sup>13</sup>C{<sup>1</sup>H} NMR (101 MHz, 213 K, THF-*d*<sub>8</sub>):  $\delta$  = 39.0 (s, SCS), 127.1 (s, CH<sub>ar</sub>), 129.3 (s, 193 CHar), 129.6 (s, CHpara), 148.2 (s, Cipso). 194

C-methylated salt 3: In a Schlenk flask containing bis-ylide precursor 1 (50 mg, 0.094 195 mmol, 1 eq.) and KHMDS (19 mg, 0.095 mmol, 1 eq.) was added 0.5 mL of THF at -80 °C. 196 After the yellow coloration of the solution, 1 equivalent of iodomethane (5.9  $\mu$ L, 0.094 197 mmol, 1eq) was added at the same temperature. The solution immediately became color-198 less and a white precipitate appeared. After 15 min, the solution was allowed to warm up 199 to RT, then the volatiles were removed under reduced pressure. The crude was extracted 200 with CH2Cl2 (3 x 2 mL). The resulting solution was dried using MgSO4 then evaporated to 201 afford 3 as white solid (42 mg, 0.080 mmol, 85% yield). Crystals were grown layering di-202 ethyl ether onto a saturated CH<sub>2</sub>Cl<sub>2</sub> solution. <sup>1</sup>H NMR (500 MHz, 298 K, CD<sub>3</sub>CN): δ = 1.67 203 (s, 3H, CH<sub>3</sub>), 7.54–7.57 (m, 8H, CH<sub>ar</sub>), 7.59–7.69 (m, 12H, CH<sub>a</sub>r). <sup>13</sup>C{<sup>1</sup>H} NMR (125 MHz, 204 298 K, CD<sub>3</sub>CN): δ = 10.2 (s, CH<sub>3</sub>), 23.4 (s, SCS), 129.7 (s, CH<sub>ar</sub>), 131.4 (s, CH<sub>a</sub>r), 132.7 (s, C<sub>ipso</sub>), 205 133.3 (s, CH<sub>para</sub>). Mp = 116 °C (decomposition). HRMS (ESI+): m/z [M]<sup>+</sup> calculated for 206  $C_{26}H_{23}S_2 = 399.1241$  found = 399.1248. 207

CO<sub>2</sub>-adduct 4: In a high-pressure NMR tube, to a solution of bis-ylide 2, freshly pre-208 pared from the protonated precursor 1 (50 mg, 0.094 mmol, 1 eq.) and KHMDS (19 mg, 209 0.094 mmol, 1 eq.) in THF-ds (0.4 mL) at -70 °C, 3 bars of CO<sub>2</sub> were applied. The tube was 210 shaken carefully leading to a colorless solution. Because of thermal instability of 4, the 211 product was characterized at 0 °C in presence of hexamethyldisilazane and CO2 without 212 any purification. <sup>1</sup>H NMR (400 MHz, 273 K, CD<sub>3</sub>CN): δ = 7.30–7.42 (br s, 12H, CH<sub>ar</sub>), 7.65– 213 7.88 (br s, 8H, CH<sub>a</sub>r). <sup>13</sup>C{<sup>1</sup>H} NMR (100 MHz, 273 K, CD<sub>3</sub>CN): δ = 40.2 (br s, SCS), 130.7 (s, 214 CHar), 130.8 (s, CHar), 132.6 (s, CHpara), 134.4 (s, Cipso), 167.2 (br s, C-CO<sub>2</sub>). 215

O-methylated CO<sub>2</sub> adduct **6**: In a pressure NMR tube, to a solution containing freshly 216 generated CO<sub>2</sub> adduct **4** by above mentioned method, at -70 °C then warmed up to room 217 temperature and CO<sub>2</sub> pressure released. Subsequently, MeI (1.0 eq, 6  $\mu$ L) was added then 218

precipitation occurs overnight. After removal of volatiles under reduced pressure, the 219 crude was washed with pentane  $(3 \times 2 \text{ mL})$ . Then 6 was extracted from the crude using 220 DCM. After concentration, the solution was layered with pentane affording 6 as colorless 221 crystals at room temperature (42 mg, 0.075 mmol, 80% yield). <sup>1</sup>H NMR (300 MHz, 298 K, 222 CD<sub>2</sub>Cl<sub>2</sub>):  $\delta$  = 3.67 (s, 3H, CH<sub>3</sub>), 7.55–7.65 (m, 16H, CH<sub>a</sub>), 7.66–7.75 (m, 4H, CH<sub>a</sub>). <sup>13</sup>C{<sup>1</sup>H} 223 NMR (75 MHz, 298 K, CD<sub>2</sub>Cl<sub>2</sub>):  $\delta$  = 44.0 (s, SCS), 52.6 (s, CH<sub>3</sub>), 129.2 (s, C<sub>ipso</sub>), 129.7 (s, CH<sub>ar</sub>), 224 131.1 (s, CH<sub>ar</sub>), 133.7 (s, CH<sub>para</sub>), 164.2 (s, CO<sub>2</sub>CH<sub>3</sub>). Mp = 160 °C (decomposition). HRMS 225  $(ESI+): m/z [M]^+$  calculated for  $C_{27}H_{23}O_2S_2 = 443.1139$  found = 443.1140. 226

Sulfonium ylide 7: In a Schlenk flask containing bis-ylide precursor 1 (50 mg, 0.094 227 mmol, 1 eq.) and KHMDS (19 mg, 0.094 mmol, 1 eq.) was added 0.5 mL of THF at -80 °C. 228 After the yellow coloration of the solution, 1 equivalent of phosphenium triflate (35.7 mg, 229 0.094 mmol, 1eq) was added at the same temperature. The solution was rapidly brought 230 to room temperature then the volatiles were removed under reduced pressure. The crude 231 was extracted with CH<sub>2</sub>Cl<sub>2</sub> (3 x 2 mL). The resulting solution was dried then evaporated. 232 The crude was purified by flash silica gel chromatography using pentane and ethyl acetate 233 as solvents. 3 was obtained as white solid (32 mg, 0.056 mmol, 60% yield). #### 3.3. X-ray Data

The data of the structures for 3, 5, 6-I, 6-OTf and 7 were collected at 193 K on a 250Bruker-AXS APEX II CCD Quazar diffractometer (7) equipped with a 30 W air-cooled 251 microfocus source and on a Brucker-AXS D8-Venture diffractometer (3, 5, 6-I and 6-OTf) 252 equipped with a Photon III-C14 detector with MoK $\alpha$  radiation (wavelength = 0.71073 Å) 253 by using phi- and omega-scans. The data were integrated with SAINT, and an empirical 254 absorption correction with SADABS was applied [48]. The structures were solved using 255 an intrinsic phasing method (ShelXT) [49] and refined using the least-squares method on 256  $F^2$  (ShelXL-2014) [50]. All non-H atoms were treated anisotropically. All H atoms attached 257 to C atoms were fixed geometrically and treated as riding on their parent atoms with C-258 H = 0.95 Å (aromatic), 0.98 Å (CH<sub>3</sub>), 0.99 Å (CH<sub>2</sub>) or 1.0 Å (CH) with U<sub>iso</sub>(H) = 1.2U<sub>eq</sub>(CH, 259 CH<sub>2</sub>) or  $U_{iso}(H) = 1.5U_{eq}(CH_3)$ . The structures **3** and **6-I** were found to be disordered. Sev-260 eral restraints (SAME, SADI, SIMU, DELU) were applied to refine these disorders and to 261 avoid the collapse of the structure during the least-squares refinement by the large aniso-262 tropic displacement parameters. 263

### 4. Conclusions

In summary, S,S-bis-ylide 2 readily reacts with MeI to give the C-methylated salt 3. 270 Moreover, 2 also reacts with  $CO_2$  to give betaine 4 which was characterized in solution by 271 NMR spectroscopy at low temperature. CO2 adduct 4 was still reactive and undergoes O-272 silvlation and O-alkylation reactions, in the presence of HMDS and MeI respectively, to 273 afford the corresponding salts 5 and 6. Finally, the high leaving group ability of sulfide 274 ligand in **2** was demonstrated by an original reaction with phosphenium ions, yielding a 275 stabilized ylide 7 probably through the transient formation of a strongly electrophilic 276 phosphino(sulfonio)carbene 9. Efforts are currently underway to extend the potential of 277 this type of ylides. 278
