EFFECTS OF PLYOMETRIC TRAINING ON THE STIFFNESS AND DISSIPATIVE PROPERTIES OF THE ACHILLES TENDON

Introduction

Plyometric training (PT) is known to improve vertical jump performances [e.g. 1]. During a plyometric exercise, the mechanical properties of the Achilles tendon, such as stiffness and dissipative properties, underlie the elastic energy storage-recoil process and the transmission of muscular tension [2]. Astonishingly, PT effects on Achilles tendon dissipative properties were little studied.

These mechanical properties may also play a role in debilitating injuries, including Achilles tendon rupture or tendinopathy [3]. A comprehensive assessment of the geometric properties of the Achilles tendon (i.e., cross sectional area) is needed to discuss the nature of the potential physiological mechanisms involved in the changes in mechanical properties after plyometric training.

The aim of the present study was to determine effects of 14 weeks of PT on the stiffness, dissipative properties and

Methods

Subjects:

19 males divided to trained (TG, n=9) and control groups (CG, n=10).

Data acquisition:

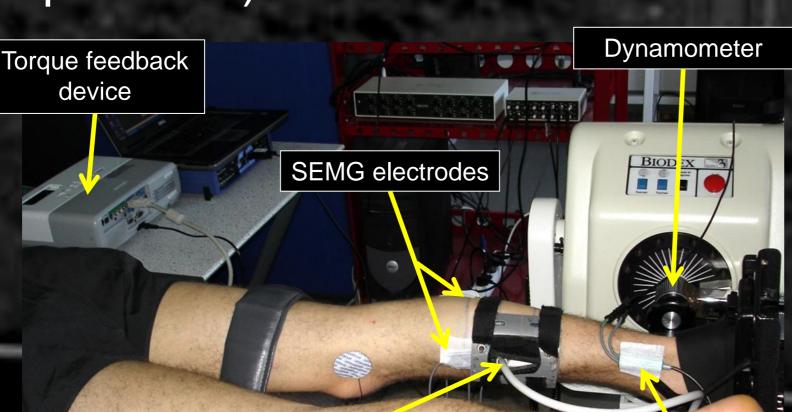
- Mechanical signals as ankle joint angle, angular velocity and external torque (Isokinetic dynamometer Biodex Pro 3[®]).

- Surface electromyography activities (SEMG) of the *triceps surae* muscles (Delsys[®]).

- Ultrasonographic images (Philips[®] HD3).

Protocol :

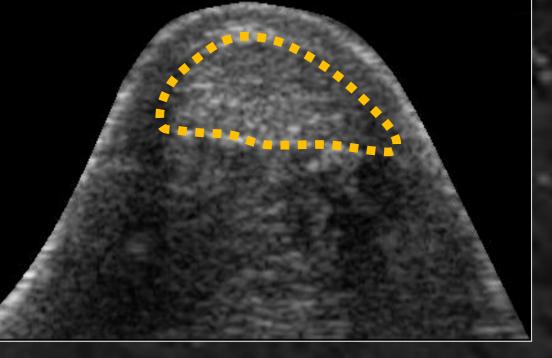
Jump tests (Squat Jump, Counter Movement Jump and Reactive jumps).
Achilles tendon stiffness (S_{AT}) determination and



- Subjects lay prone with their legs fully extended (Figure 1). Tendon elongation (Δ L) of the medial *gastrocnemius* determined during isometric plantarflexion using ultrasonography [4].

- Cross-sectional area of Achilles tendon determined using ultrasonography (Figure 2).

Data Processing:



<u>Figure 2:</u> Ultrasonographic scan of the Achilles tendon at rest in the transverse plane at the level of the medial malleolus

- S_{AT} = slope of the force-elongation (force higher than 50% of maximal force) [5].

- Areas under ascending and descending phases of the curve were used to calculate a dissipation coefficient (DC) [6].

tendon cross sectional area (CSA_T) measurement.

Goniometer

<u>Figure 1:</u> Position of the subject during the isometric plantarflexion from rest to 90% of maximal force and unload to rest

- Two-ways ANOVAs were performed. Critical level o significance was set at P < 0.05.

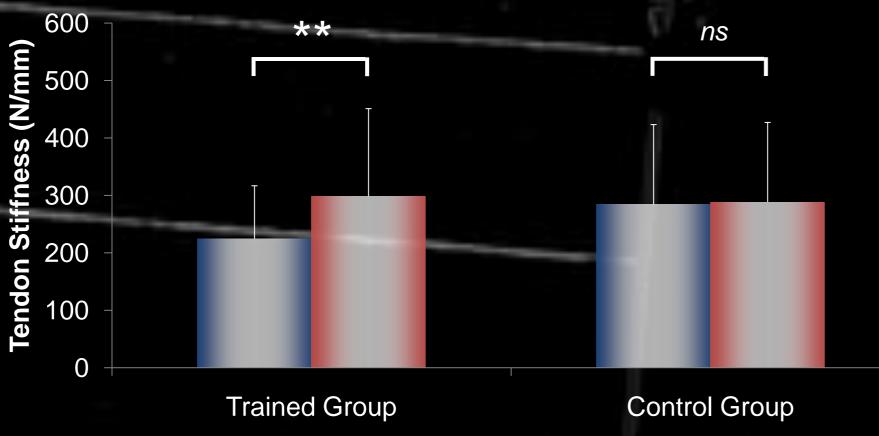
Significant increase in jump performances for the TG : changes between +7.3% and +26.5% according to the jump modality.

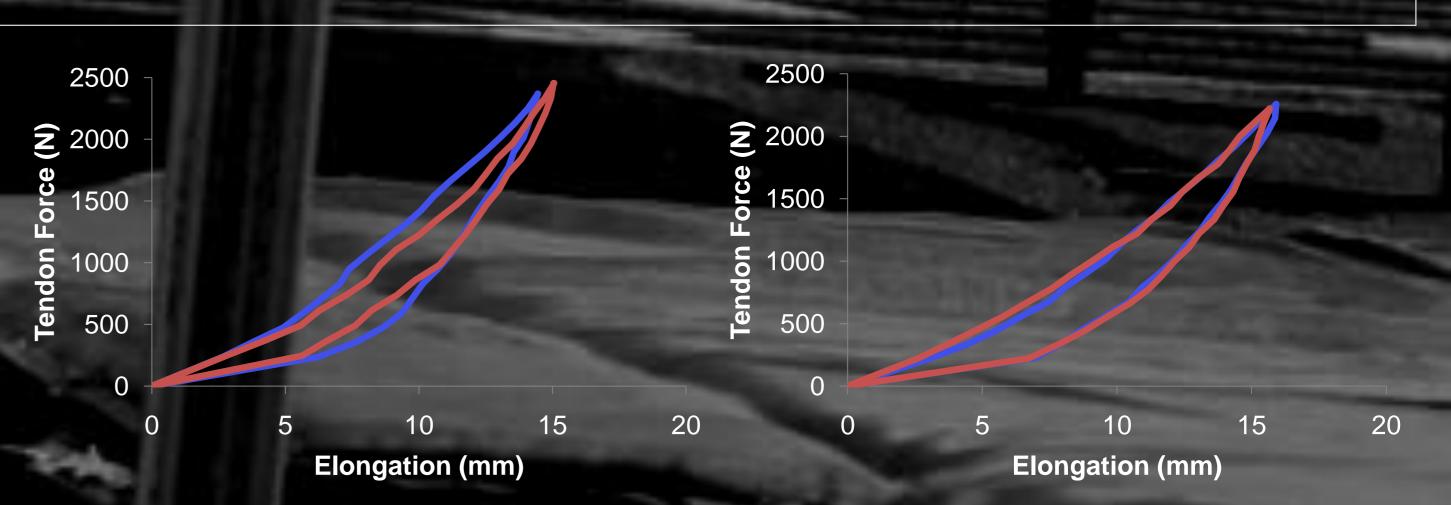
Ultrasonic probe

Increases of 24.1% and 21.0% in S_{AT} (Figure 3) and normalized stiffness (i.e., S_{AT} /CSA) respectively for the TG (*P* < 0.05).

<u>Figure 3:</u> Average of the tendon stiffness (mean \pm SD) between pretest () and posttest () for both trained (TG) and control (CG) groups.

**: P < 0.05; ns: non-significant.





<u>Figure 4:</u> Mean relationship between the tendon force (Ft) and the Achilles tendon elongation ($\triangle L$) in the trained group (A) and the control group (B) in pretest (—) and posttest (—). Standard deviation bars were removed for clarity.

**: P < 0.05; ns: non-significant

Decrease of 35.0% in DC for the TG (P < 0.05), without any changes in Achilles tendon CSA_T (P > 0.05).

Discussion

Results

PT enhances the muscular tension transmission through an increase in stiffness and a reduction in energy dissipated by the tendon. These changes in mechanical properties would improve muscle tension transmission and the storage-recoil of elastic energy.

The lack of changes in CSA_T indicates that changes in mechanical properties would mainly result from a qualitative change in tendinous tissues (e.g., changes in collagen fiber type).

Thus, PT induced changes in mechanical properties of Achilles tendon, which partially explain the performance improvements, but may increase the risk of muscle or tendon injuries.
