Evaluation of meteorological drought events and trends over the Republic of Djibouti from 1961 to 2021 (Horn of Africa)

Abstract: Drought is a meteorological and hydrological phenomenon affecting environment, agri-14 15 culture, and socio-economic conditions, especially in the arid and semi-arid regions. A better un-16 derstanding of drought characteristics at short and long timescales is therefore crucial for drought mitigation and long-term strategies. This study evaluates for the first time the drought occurrence, 17 18 duration and intensity over the Republic of Djibouti by using a long-term (1961 to 2021) rainfall time-series at Djibouti-Airport, completed by the CHIRPS precipitation product and local records 19 from 35 weather stations. The drought is examined based on the Standardized Precipitation Evap-20 otranspiration Index (SPEI) and the Standardized Precipitation Index (SPI) at 3-, 12-, and 24-months 21 22 timescales, to document short, medium and long duration events, respectively. The analysis revealed that the Eastern coastal region of the republic of Djibouti was the most affected by an in-23 24 creased drought incidence in the recent decades, with more than 80% of the extremely and severely dry events occurring within the period 2007-2017. By contrary, the Western regions recorded a pos-25 itive trend of its SPI indices during the period 1981-2021, due to the dominance of the June-Septem-26 ber (JJAS) rains which tend to increase. However, in the last decades, the whole country experienced 27 the droughts of 2006/2007 and 2010/2011, which were the longest and most intense. Large-scale cli-28 29 mate variability in the Indo-Pacific region partly affects drought in Djibouti. SPI is significantly pos-30 itively correlated with the Indian Ocean Dipole during October-December (OND), while for JJAS it is negatively correlated with Nino3.4. This study provides essential information on the characteris-31 tics of drought in the Republic of Djibouti for decision makers to better plan appropriate strategies 32 33 for early warning systems to adapt and mitigate recurrent droughts that put the country's agropastoral populations in a precarious situation. 34

1. Introduction

Drought is a complex phenomenon that affects natural environments and socioeconomic systems in the world, which is characterized by abnormally dry weather over a period of time long enough to cause a serious hydrological imbalance [1]. It usually consists in a reduction of soil moisture content, groundwater level and volume of surface runoff that may induce crop failure, food shortage, and in the worst cases famine, epidemics and mass migration. 43

In East Africa (EA), where extensive regions experience arid to semi-arid conditions, 44 drought manifests itself as a natural endemic phenomenon [2, 3]. This region exhibits 45

Drought has been one of the main causes of socioeconomic insta-47 bility in various nations, including Somalia, Kenya, and Ethiopia [6]. There have been a 48 number of drought-related events that have occurred in the EA region in the recent dec-49 ades, resulting in massive crop failures, livestock deaths, and human casualties [7, 8]. Dur-50 ing the past few decades, the frequency of droughts in EA has increased from once every 51 six years to once every three years and become widespread [6, 9]. There have been eight 52 boreal spring droughts in the EA region in the last 16 years. Over 13 million people in 53 EA were affected by the drought from 2008 to 2010 [10]. Recent catastrophic events in the 54 area were brought on by the Horn of Africa drought that lasted from 2010 to 2011 [11, 12]. 55 In 2022, due several consecutive failed rainy seasons, it is forecasted that 16 million people 56 will be in need of immediate food assistance, particularly in Somalia where the situation 57 58 is catastrophic.

Like most countries of East Africa, the Republic of Djibouti has been facing an un-59 precedented chronic drought during 2007-2011 resulting into high rates of cattle mortality, 60 food insecurity, severe water and food shortages [13]. More than 120,000 people in rural 61 areas (i.e., 50% of the rural population and 15% of the total population) are estimated to 62 be victims of drought hazards in Djibouti [13]. This drought also caused an estimated 3.9% 63 loss in Gross Domestic Product of the country [13, 14]. On the other hand, drought is one 64 of the main factors of migration for rural agropastoral nomads towards urban areas in 65 Djibouti [15]. However, the long-term spatial and temporal evaluation of drought occur-66 rences remain unexplored. This has resulted in poor preparedness and uninformed strat-67 egies for drought management in the country. Ozer and Mahamoud [16] analyzed 68 changes in extreme precipitation between 1980 and 2011 in Djibouti based on annual sta-69 70 tistics from the single station of Djibouti Airport. They found a strong decline in precipitation (73%) during 2007-2011 compared to total average rainfall. Recently, Assowe et.al, 71 [17] evaluated spatiotemporal variability of rainfall over the republic of Djibouti by using 72 monthly data from 14 weather stations and high-resolution long-term satellite rainfall 73 products. These two studies analyzed overall rainfall variability and trends in Djibouti, 74 75 but no known study has ever attempted to assess the countrywide pattern of drought incidence. Therefore, there is a need for a critical investigation of long-term historical spa-76 tio-temporal patterns of droughts over the Republic of Djibouti. 77

Numerous indices have been established to measure drought events and their fea-78 79 tures, including the Standardized Precipitation Index (SPI; [18]), Standardized Precipita-80 tion Evapotranspiration Index (SPEI; [19]), Palmer Drought Severity Index (PDSI; [20]), and the Soil Moisture Deficit Index (SMDI; [21]). Each of these indices takes into account 81 82 one or more environmental factors including rainfall, temperature, and soil moisture, among others. SPEI and SPI, however, are some of the most often employed drought in-83 dicators for keeping track of meteorological, agricultural, and hydrological drought. SPI 84 is globally recommended by the World Meteorological Organization (WMO) for drought 85 assessment [22] and can be used to determine the anomalously wet or dry events on a 86 particular time scale for any locations where precipitation records are available. SPI re-87 quires only precipitation data, while SPEI require additional potential evapotranspiration 88 89 (PET) data to assess drought. Both indices can be computed over periods of time of vary-90 ing lengths, thus enabling to account for both short-term droughts (mostly meteorological 91 droughts) and long-term events (generally of major hydrological and ecosystemic significance). Thus, the key aim of this research is to study meteorological drought and its char-92 acteristics using the SPI and SPEI drought indexes over the Republic of Djibouti. 93

In addition, to the best of our knowledge, the large-scale climate variability associated with the occurrence of drought in Djibouti has not been specifically evaluated to date. 95 El Niño-Southern Oscillation (ENSO), one of the prominent natural modes of climate variability originating from the tropical Pacific Ocean, impacts rainfall variability over East 97 Africa [3]. Many studies demonstrated that ENSO partly controls June-September (JJAS) 98 interannual rainfall variations in Ethiopia and ENSO was the ultimate cause of most 99 drought years in Ethiopia [23-25]. Other studies [26, 27] based on different datasets in East 100 Africa region showed a strong connection between rainfall variability during the October-101 December (OND) season and the Indian Ocean Dipole (IOD), a seesaw in sea-surface tem-102 perature (SST) anomalies between the western and the western Indian Ocean. However, 103 there is still an absence of any systematic analysis on the part of Djibouti's drought varia-104 tions explained by climate drivers such as ENSO and the IOD. Based on this fact, this 105 study also examined the link between seasonal and annual drought occurrence in the Re-106 public of Djibouti and SST indices associated with global-scale climate variations. 107

The present study is therefore the first one to comprehensively document the spatial 108 and temporal variation of drought characteristics (frequency, severity, and intensity) in 109 the Republic of Djibouti by using long-term (1961 to 2021) observed rainfall time-series 110 combined with a merged (satellite and observed) precipitation product (CHIRPS). The 111 drought occurrences are examined based on SPI and the SPEI indices at 3-, 12-, and 24-112 months timescales, to document short, medium and long duration events, respectively. 113 Seasonal and annual trends of drought were described to assess whether there is any long-114 term change in drought characteristics in the country, as suggested by several studies in-115 dicating a decrease in the boreal spring (March-May) rains over parts of East Africa since 116 the 1980s [3, 9, 28]. The aim is next to determine the drought-prone regions and to assess 117 whether droughts occur simultaneously in the different parts of the Republic of Djibouti. 118 The teleconnection between the global SSTs (e.g., IOD and ENSO) and seasonal and an-119 nual drought indices are also discussed. The results of this study could greatly help con-120 cerned decision makers to understand the spatiotemporal variation of droughts to subse-121 quently design appropriate drought mitigation and early warning systems in the Republic 122 of Djibouti. 123

This study is organized as follows; Section 2 provides a description of the study area, data, methods, and drought index. Section 3 presents the detailed results of the spatial and temporal variability of drought at seasonal and annual scales. Finally, conclusion and recommendation are presented in Section 4.

2. Materials and data collection

2.1. Study area

The Republic of Djibouti is geographically located in the Horn of Africa facing the 130 Red Sea and the Gulf of Aden (Figure 1). It is found within latitude 11-12.5° N and longi-131 132 tude 42–43.5°E. The neighboring countries are Eritrea in the north, Ethiopia in the west and south, Somalia in the southeast (Figure 1). Its coastline is extended to about 372 km 133 distributed between the Gulf of Aden (80 km), the Red Sea (38 km), and the Tadjoura Gulf 134 (254 km) [29]. Elevations in the country range from 150 meters below the sea level (Asal 135 Lake) to over 2000 meters above the sea level (northern mountainous regions), while the 136 east is lowland. 137

The Republic of Djibouti has a low precipitation regime, with the mean annual rain-138 139 fall ranging from 60 to 300 mm [17]. The local climate is regulated by the complex topographical features of the country and the proximity of the Indian Ocean. Rainfall variation 140 in Djibouti is embedded in large-scale climate variability, particularly that associated with 141 the El Niño Southern Oscillation and the Indian Ocean Dipole (IOD) [17]. Djibouti has two 142 predominating seasons which are a cool season (winter) from October through April and 143 a hot season (summer) from May through September [30]. In winter, the climate is char-144acterized by northeast trade winds coming from the eastern Arabian Peninsula and the 145 Gulf of Aden and an average temperature between 20 °C and 30 °C. In summer, westerly 146 winds associated with the African-Asian monsoon circulation dominates [31] and average 147 temperatures range from 30 °C to 45 °C. The potential evapotranspiration rate is very high, 148 149 amounting to 2000 mm per year [32].

2.2. Data source

The availability of climate data in the Republic of Djibouti is limited. Monthly pre-153 cipitation from the "Agence Nationale de la Météorologie (ANM)" is recorded at Thirty-154 five (35) stations distributed across the country. They are mainly concentrated in the 155 south-east of the country while the Nord-west (complex and rugged terrain) is less cov-156 ered (Figure 1). Most records started around 1961 and are analyzed here until 2021, but 157 contain many gaps, and no data at all is available between 1991 and 2012 except at the 158 Djibouti-Airport station which contains the most complete meteorological data available 159 in the country, uninterrupted for the whole period of study (1961-2021). Figure 1 shows 160 the administrative boundaries, elevation, and meteorological stations used in this study. 161

The most fundamental barrier that hinders regional studies such as drought moni-162 toring is the long-term recording and quality of climatic data. Most ground observation 163 in the Republic of Djibouti contain a long gap in the 1990s and 2000s. Accordingly, it is 164 difficult to analyze the distribution of drought and climatic trends in space. For this pur-165 pose, the study used a satellite-based rainfall estimate from Climate Hazards Group In-166 frared Precipitation with Station observation (CHIRPS version 2.0). CHIRPS is a quasi-167 global (ranging from 50°S to 50°N) precipitation dataset mainly designed for monitoring 168 droughts and other global environmental changes in data scarce regions such as East Af-169 rica [33]. The product is available at a high spatial resolution of 0.05° (≥ 5 km) and on 170 multiple time scales (e.g., daily to monthly) from 1981 to present. More details of the prod-171 uct can be found from [33]. 172

CHIRPS was compared to other satellite rainfall estimates and reanalysis datasets in our previous study and the results revealed the good performance of CHIRPS compared to other datasets [17]. Ayugi et al. [34] also recommended CHIRPS for examination of long-term precipitation trends and for drought analysis in Kenya. On the other hand, CHIRPS datasets are among the most used products over East Africa and display the longest time-series to date [35-37]. Overall, the CHIRPS datasets can be employed as an 178 alternative to in-situ datasets in a region characterized by scarcity of ground-based da-179 tasets for droughts characterization.

2.3. Methodology

2.3.1. Drought Analysis Procedures

Drought indices with specific time-scales are important elements for drought monitoring and management planning system [38]. The Standardized Precipitation Index (SPI; [18]) and the Standardized Precipitation Evapotranspiration Index (SPEI; [19]) are useful to assess drought events in arid-dominated regions such as East Africa [39]. In this study, the SPI and SPEI drought indices were used to identify the anomalous dry and wet conditions in the Republic of Djibouti. 189

The SPI was developed to describe long-term meteorological drought. It is one of the 190 most commonly used drought indexes and compares the normalized rainfall with average 191 rainfall to express the deficit and excess of rainfall for a particular time period and climate. 192 SPI is globally recommended by the World Meteorological Organization (WMO) for 193 drought assessment [22]. The SPI was calculated based on long-term rainfall data for Dji-194 bouti-Airport station and CHIRPS regional rainfall indices with gamma distribution esti-195 mation method. The SPEI is an improved index for regional drought monitoring because 196 197 of its ability to identify the effects of temperature on drought conditions [40]. The SPEI is 198 mainly selected to evaluate the role of temperature through its influence on potential evapotranspiration (PET), which relates to global warming and the occurrence of drought 199 [41]. The SPEI is quantified using precipitation (P) and potential evapotranspiration (PET) 200 as input variables resulting in an index describing the water balance. Due to the limited 201 availability data, the present study used the modified Hargreaves technique, which only 202 requires precipitation, maximum, and minimum temperature datasets [42]. SPEI values 203 were estimated by fitting historical observations into log-logistic distribution. More de-204205 tails on the mathematical equations behind the calculations of SPEI and SPI can be found in [42]. 206

2.3.2. Evaluating drought characteristics

208 In order to examine the impact of drought events in the Republic of Djibouti, the study considers drought components of drought duration (D), drought frequency (F) and 209 drought intensity (I). These parameters were used to detect the potential effects of climate 210 change on drought characteristics in the context of global warming. 211

To determine how frequently there are droughts (drought frequency of occurrence, F) in a given area, the following formula can be used [43].

where n is the number of drought events (SPI/SPEI < -1.0) and N is the total number of the months over the study period. The average drought duration (D) is the length of a drought episode (months) during which the drought index is consecutively above or below a truncation value. It can be calculated as follows [44]:

Where d i is duration of ith drought event and n is the total number of drought events. The intensity (I) of drought is used to measure the overall intensity of drought events and can be defined as follow:

With n is number of drought occurrences in months with SPI/SPEI < -1.

Additionally, one of the most significant benefits of SPI and SPEI is that they can be computed at various time scales, allowing us to factor in the influence of the variable's 232 previous values in the computation. To assess and characterize the meteorological 233 drought in the Republic of Djibouti, we have studied both short-term SPI/SPEI (3 and 6 234 months) and long-term SPI/SPEI (12 and 24 months). According to [18], drought levels 235 were classified according to the seven SPI and SPEI range of values as presented in Table 236 237 1. These drought severity classes were used to compute time series of drought indices (SPI and SPEI) based on monthly, seasonal annual timescale. 238

3. Results

3.1. Mean climatological patterns

245 The spatial rainfall variability which is the key parameter influencing the occurrence of drought events is first analyzed. Based on the 35 rain-gauges station, the annual rainfall 246 amount over the republic of Djibouti is presented in Figure 2. Rainfall in Djibouti is gen-247 erally erratic, infrequent and extreme wet and dry events can be observed in some years 248 [45]. Rainfall amounts displayed high spatial variability which is largely associated with 249 the altitudinal variation within the country. Orographic effects appear most prevalent in 250 251 the highlands, where the rainfall gradient broadly follows terrain. The highest rainfall is found along a north-south discontinuous ridge (150 mm to 250 mm) while in the south-252 east and southwest of the country annual rainfall is between 100 mm and 150 mm. On the 253 other hand, northeastern coastal regions receive less than 100 mm annually. 254

In order to identify spatial patterns of droughts, a clustering method, the Hierarchical 255 Agglomerative Clustering (HAC), is applied on mean monthly rainfall at the 35 stations 256 over the period 1961–2021 (Figure 3). The spatial variability of rainfall regimes in Djibouti 257 reveals the existence of two regions, that is a coastal region (EAST) and a continental re-258 gion (WEST). This regionalization (Figure 3) is further used to study the spatial variation 259 of drought over the whole country in section 3.4. 260

Figure 4 show the mean monthly precipitation regime in the EAST and WEST regions264averaged during 1961-2021 (Figure 4a and Figure 4b). The mean monthly of rainfall and265temperature at Djibouti-Airport station which is part of the eastern region are presented266

in (Figure 4c, Figure 4d). More rainfall is recorded during the MAM (March-April-May)267season with a peak in April and decline by the end of May for the EST region (Figure 4a268and Figure 4c). The whole country receives about the same amount of rainfall during this269season (Figure 4a, Figure 4b and Figure 4c). The monthly rainfall peaks in April during270MAM with ~15 mm is observed for both regions. June is the driest month across the country.271

The Eastern part of the country receives more rainfall amounts than western part 273 during OND (October-November-December) and JF (January-February). The MAM and 274OND are the two main wet seasons in most part of the East Africa countries [44, 46-47]. 275 As indicated by Camberlin [48]. the equatorial regions and most of the Indian Ocean 276 coastal plains have double-peak regimes with rains in the transition seasons (MAM and 277 OND). JJAS (June-July-August-September) includes the wettest period in the western part 278 of the country lasting from July to September with a peak in August. By contrast, the East-279 ern area receives a small amount of rain in July-August (Figure 4a and Figure 4c). The 280 July-September rainy season is more widespread Ethiopia and covers the entire country 281 with a steep gradient from north-west to south-east close to Djibouti [49]. The minimum 282 and maximum air temperatures at the airport station are presented in Figure S1 in sup-283 porting information files. Average monthly temperatures range from 25.2°C in January to 284 36.8°C in July (Figure 4d). 285

3.2. Temporal variation of SPI and SPEI

296 The assessment of the short and long-term of SPI index issued from Djibouti-airport 297 station exhibited the existence of dry and wet events throughout the study period (Figure 5). The temporal variations of SPEI for the different time scale are presented in Figure S2 298 in supporting information files. As expected, the drought events are more frequent with 299 shorter durations for 3-month SPI compared to the 12-month, and 24-month SPI (Figure 300 301 7a). These results agree with those of [50] who found a decreasing trend in frequency of the wet and dry periods with increase in SPEI and SPI timescales. During 1961–2006, few 302 drought events were recorded in Djibouti. For instance, moderate to severe drought con-303 ditions were observed in 1986, 1971 and 1981. Droughts were more severe and persistent 304 during 2007-2018 than those during other periods, as revealed by both indices. It was 305 evident that drought events increasingly occurred, especially after 2007 with high 306

307 intensity and duration (Figure 5b). As indicated by [51], droughts at the SPI-12 or larger 308 timescales tended to persist much longer. The SPEI results detected the same period of drought, but the drought is much more pronounced with the SPEI than with the SPI (Fig-309 310 ure S2 in supporting information files). Because SPEI takes into account evapotranspiration, it is more sensitive to changes in drought, so there are some differences with SPI 311 results further shows that the most intense drought (SPI = -2.19) based on SPI 3 occurred 312 between October to December 1981. For the 12-month SPI, the most intense drought (SPI 313 = -1.65) occurred between January to December 2013. On the other hand, based on SPI-12 314 and SPI-24 (as well as SPEI-12 and SPEI-24), the 2010-2011 and 2013-2015 drought events 315 were the most severe experienced in Djibouti (Figure 5b, Figure 5c). These drought events 316 were found to have large scale impacts in the Horn of Africa on the environment and 317 society [52]. The 2010–2011 Horn of Africa drought caused a wide range of food insecurity 318 situation in the region [12, 53-54]. Rainfall was at least 50% to 75% below average in the 319 Horn of Africa regions. 320

Drought duration, intensity and frequency are important properties for droughts 323 characterization. Table 2 present the mean duration, frequency and intensity of droughts 324 at various timescales over the Djibouti-airport station during 1961-2021 for both SPI and 325 SPEI indexes. Drought and wet duration tend to increase with the SPI and SPEI timescales. 326 The average drought durations were 2.77 and 6.93 months for SPI-3 and SPI-12 and 2.40 327 and 5.63 months for SPEI-3 and SPEI-12 respectively. SPI index revealed high frequency 328 of drought than SPEI ranging between 20.53% and 26.01% (Table 2). The average drought 329 intensity varies between -1.68 for SPI-3 to -1.28 for SPI-12. This suggests that drought in-330 tensity decreases with the timescale. 331

Figure 6 shows the long-term temporal variation in the occurrence of drought in the 336 district of Djibouti-ville, the country's capital, where the meteorological station at Djibouti 337 airport, which contains the most comprehensive meteorological data in the country, is 338 located. According to table 2, the evaluation of drought and wet events were classified as 339 moderate, severe, and extreme at 3-months timescales (Figure 6 and Figure S3). Analysis 340 of SPI-3 at the Djibouti-airport exhibited recurrent drought events during the period 1961-341 2021 (Figure 6a). The SPI-3 results show that the existence of moderate and severe drought 342 cases between 1961 and 2000. Only three extremes drought events occurred in this period 343 (1962, 1980 and 1997). However, the extreme drought incidences were intensified since 344 2003, yielding critical situations in Djibouti. 12 extremes drought events were identified 345 between 2003 and 2021 accounting more than 80% of total extreme drought in Djibouti 346 since 1961. In contrast, no severe wet conditions were recorded between 2003 and 2017 347 and the moderate wet events were still low indicating significant rainfall decrease in this 348 period (Figure S3). The analysis of SPEI-3 showed moderate to severe drought in Djibouti 349 but does not clearly indicate the existence of extreme dry events (Figure 6b). The number 350 of wet years remained the same both for SPEI and SPI values (Figure S3), but the wet 351 severity of the SPEI was higher than SPI. 352

3.3. Annual and seasonal variations of drought

In this section we analyzed the SPI index on a seasonal scale to assess whether the drying up of the recent decades in Djibouti is associated with a specific season (Figure 7). 356 The analysis of SPI values at a seasonal scale clearly shows the existence of severe and 357 extreme droughts events in any season, although the index being standardized it cannot 358 be used to compare the severity of droughts between seasons (Figure 7a). Several extreme 359

dry events have been occuring since 2009 during the JF (January-February) season, indi-360 cating a strong rainfall decline in this season. The JJAS season experienced the longest 361 recurrent drought events during 1970s and 1980s (Figure 7c). Williams et al. [55] docu-362 mented a decline in JJAS rainfall in the Horn of Africa from 1970 to 1989, which they at-363 tributed to the warming of the southern tropical Indian Ocean. It was followed by wetter 364 conditions, interrupted by some dry events (e.g., 1996-97, 2004, 2011, 2018). However, a 365 consistent rainfall decline occurred between 2005 and 2017 (Figure 7e). 366

The SPI index at MAM season showed that moderate wet periods started from the 367 368 year 1981 until 1988 (Figure 7b). The most severe wet event is observed in 1989 which is the wettest years ever registered in Djibouti, with rainfall amount exceeding 450 mm/year 369 370 [17]. This period was followed by alternating wet and dry MAM seasons, then an extensive, almost uninterrupted drought period from 2006 to 2017. On the other hand, the OND 371 season experienced a more regular alternation between severe dry events and wet events 372 (Figure 7d). Two extremes dry events occurred for OND at 2012 and 2016. However, as 373 374 for MAM, moderate to severe dry events occurred from 2006 to 2017 in the OND season (Figure 7b-7d). This period was characterized by a persistent rainfall decline in these sea-375 sons, which both contributed to the prolonged drought conditions as displayed above in 376 377 the monthly SPI index. The MAM and OND seasons are actually the wettest seasons in the eastern parts of Djibouti [17]. Limited precipitation in both the October-December 378 2010 and March-May 2011 rainy seasons were the main causes of 2010-2011 droughts in 379 380 the Republic of Djibouti (Figure 7b-7d).

In the larger East African region, the MAM long rains season is the primary rainy season [9, 56]. Nicholson [9] indicated that the greatest changes in drought appear to have occurred during the long rains (MAM). As agriculture in the region is largely dependent on rainfall, the decline in the MAM rains season has had major consequences for food insecurity [9, 11, 26].

3.4. Trends and spatial patterns of drought since 1981

In view of the increased drought conditions of the recent decades in Djibouti, a focus is made on the period 1981-2021 using both observed (Djibouti-Airport station) and CHIRPS data. The aim is to quantify the linear trends of the SPI computed at different timescales and to assess their spatial patterns by considering the two sub-regions defined in section 3.1 (Figure 8, Table 3). SPEI is not presented here since it was shown to broadly display the same evolution. Due to the interrupted data records during the 1991-2012 in all stations of the country (except for Djibouti-airport station), CHIRPS datasets were used to evaluates the spatial variability of drought and its trends over the whole country.

At Djibouti-Airport, the annually-averaged SPI values generally show negative values, suggesting drying trends. The observed data depicted a significant increasing drought trend (P<0.01) for all the SPI timescales (SPI-3, SPI-12 and SPI-24). However, CHIRPS showed an insignificant drying tendency for SPI-3 and SPI-12 but a significant trend for the long-term SPI-24 index. The stronger trend found for the longest SPI timescales indicate that while there was only a moderate increase of short duration droughts, there has been a marked increase in prolonged drought events.

403 Figure 9 shows the time series of SPI index at 3-, 12- and 24-months for the east and west during 1981-2021. In 3-months, moderate to severe drought were observed for both 404 climate zones. The SPI-12 and SPI-24 show the most prominent drought years in the Re-405 public of Djibouti. At a country scale, the analysis of the SPI-3 time series showed a non-406 significant decreasing trend in the eastern parts of Djibouti (Table 3, Figure 9). Likewise, 407 SPI-12 and SPI-24 time series exhibited a non-significant drying tendency over the eastern 408 regions. This seems to indicate that the coastal region may be the driest area in Djibouti. 409 This absence of significant trends is due to the fact that, while there has been a prolonged 410 drought between about 2002 and 2016, more recent years recorded much wetter condi-411 tions (Figure 9) Using the CHIRPS high resolution dataset, Gebrechorkos et al. [36] 412 found increasing drought in large part of East Africa region by analyzing the long-term 413 trend in the SPI 3, 6, and 12-month but their study was restricted to the period ending in 414 2016, therefore not including some wetter years which occurred later on. 415

In the Western part of the country, contrary to the Eastern sub-region, the SPI trends 416 over 1981-2021 are positive, and even significant (P<0.05) for SPI-12 and SPI-24 (table 3). 417 This is due to the fact that the 1980s were particularly dry years (figure 9), as in much of 418 Ethiopia, Sudan and the Sahelian region. Droughts reoccurred recurrently between 2003 419 and 2016. This well correlates to the extended drought period found in the Eastern sub-420 region, but the droughts in the West were interrupted by periods of higher rainfall. 421 Drought actually seems to affect the whole country at the same time (e.g., 1984, 2006, 2009, 422 2013 and 2015) but the severity is higher in the eastern part on a regional scale. In addition, 423 drought durations are much longer in the east than in the west as demonstrated by SPI-424 24. 425

The contrasted trends for the Eastern and the Western sub-regions are partly related 426 427 to their different rainfall regimes, because the JJAS rains have a dominant part in the West, while in the East the OND and JF rains have a bigger share of the annual rainfall. At Dji-428 429 bouti-Airport, a significant negative trend (drier conditions) is found during the JF and MAM seasons in the observation (table 4). CHIRPS also shows a negative trend in these 430 seasons but it is only significant (p < .05) in JF season. For the Eastern and Western indices, 431 consistent negative trends are similarly found in both JF and MAM, but none is significant. 432 JJAS is the only season experiencing a positive trend (wetter conditions) for both observa-433 tion and CHIRPS. It is statistically significant (P<0.05) in both the Western and Eastern 434 sub-regions, though not at Djibouti-Airport. The JJAS season is the main rainy season in 435 the northern and northeastern parts of East Africa [57]. Teshome and Zhang [58] found a 436 positive trend over the period 1980-2015 over most parts of Ethiopia, thereby indicating 437 that the drought occurrence is decreasing in the JJAS season. Using CHIRPS to compute 438 drought indices, Brown et al. [59] found that, over the period 1982-2014 in northeastern 439 Ethiopia (near Djibouti), there were strong but contrasting trends between March-June 440(increasing drought) and June-September (increasing precipitation). These mimic the 441 trends found over the Republic of Djibouti. The greater share of the JJAS rains in the West 442 (which have a positive trend) with respect to the MAM and JF rains (generally showing a 443 negative trend) explain that this region does not show the same overall evolution of the 444 SPI than the Eastern region. 445

3.4. Relationship between droughts and SST indices

To understand the large-scale climate conditions associated with the occurrence of 455 drought events, teleconnections with global SST (Nino3.4 and IOD) are analysed using 456 the Hadley Centre Global Sea Ice and Sea Surface Temperature (HadISST1.1) dataset [60]. 457 Many studies [61-65] demonstrated that the variability of large-scale climate oscillations 458 in the Indo-Pacific region (e.g., IOD and ENSO) is responsible for the occurrence of 459 droughts in East Africa by modulating the rainfall patterns. Analysing the correlation be-460 tween SSTs and drought indices allows to depict whether there is a relationship between 461 the occurrence of dry and wet years in Djibouti and IOD and Nino3.4. The correlations 462 between seasonal (JJAS and OND) SPI for both observation and CHIRPS with the IOD 463 and Nino3.4 indices during 1981-2021 are presented in Figure 10 and Table 4. Drought 464 indices in OND seasons show a positive correlation with both SST indices (Table 4). How-465 ever, IOD appears to have the largest influence with significant correlation values of 0.36 466 and 0.41 for SPI observation and CHIRPS respectively. As an example, the wet event in 467 2019 (OND) causing devastating floods in Djibouti city is linked with a positive IOD 468 anomaly (Figure 10). During MAM, there is also a significant negative correlation (-0.33) 469 between SPI and IOD, although the correlation is moderate. SPI indicate non-significant 470 negative correlation in both SST indices. Significant positive correlation with IOD is ob-471 served in the eastern and western region (Table 4). These results are in agreement with 472 the previous studies showing a strong forcing of the OND seasonal rains further south in 473 Equatorial East Africa by ENSO and the IOD, while the MAM rains are only weakly re-474lated to Indo-Pacific SST anomalies. Changes in SST gradients between the Warm Pool 475 area and nearby equatorial oceans have often been suggested to explain the protracted 476 drought which affected Eastern Africa in the early period of the twenty-first century dur-477 ing this season (including the Djibouti area as demonstrated above), but there is still much 478 479 uncertainty on its real cause [3, 26, 66-67].

During JJAS, the SPI is negatively correlated with Nino3.4, hereby suggesting the 480 influence of El-Niño events on drought occurrence in this season. CHIRPS indicate a neg-481 ative significant correlation (-0.55) between Nino3.4 and SPI at the airport station and the 482 two sub-region (-0.43). For instance, the drought incidence in 2015 (JJAS) is associated 483 with an El Niño year (Figure 10). Droughts driven by El Niño were found to have large 484scale impacts in the East Africa countries [50, 51]. Recently, Anose et al [68] indicated that 485 the JJAS Kirmet season droughts in Ethiopia was highly correlated with global climate 486 indices such as Nino3.4. Getachew [68] also reported that the recent El Niño-induced 487 drought of 2015/2016 has led to severe impact in Ethiopia pastoralist area. The large-scale 488 climate variability in which Djibouti is influenced are meaningful to develop in the future 489 to better anticipate persistent droughts or devastating floods in the country. 490

4. Conclusions

This study provides for the first time a description of temporal and spatial variation of drought in the Republic of Djibouti for the period of 1961–2021. The dryness and wetness patterns were assessed by characterizing the trends, intensity, duration, and frequencies at seasonal and interannual level through the SPI and SPEI indexes at 3-, 12- and 24month time series. Based on the Hierarchical Agglomerative Clustering, two sub-regions with different climate variability were identified from east to west. The most important results of this work can be concluded as follow:

- The results of temporal evolution of SPI and SPEI indexes indicate the existence of moderate and severe drought incidences between 1961 and 2000 at 3 months timescale. However, 12 extremes drought events have been detected by SPI-3 since 2003, representing more than 80% of the total extreme drought in Djibouti since 1961,

- As expected, drought events of shorter duration (detected by 3-month SPI) are more frequent. However, the very long drought periods detected by 12-month, and 24month indices may have more adverse effects. The longest and most intense dry period was 2007–2017 for both SPI and SPEI index, but the drought is much more pronounced with SPEI than with the SPI. Within this period, the whole country experienced the droughts of 2010-2011 and 2013-2015 but, the severity of drought was much higher at eastern region than western regions. 515

- SPI results from all timescales showed decreasing trends for both observation and CHIRPS rainfall estimate in the eastern part. In the Western part of the country, contrary to the Eastern sub-region, the SPI trends are positive and even significant (P<0.05). The contrasted trends for the Eastern and the Western sub-regions are partly related to their different rainfall regimes, because the JJAS rains have a dominant part in the West. The analysis also shows that the main drought events of the recent decades tend to affect the MAM and OND rainy seasons.

This study on drought in the Republic of Djibouti, which is the first of its kind, would 529 530 be very useful to the country's policy and decision makers as well as to the UN Resident Coordinator in Djibouti to better understand the drought cycles in the country for a better 531 532 coordination of efforts to help the victims of these droughts. This is especially relevant as there is an urgent need to consider the development of a drought early warning system 533 for better drought mitigation in the country as well as the implementation of long-term 534 535 strategies for better resilience of the agro-pastoral communities most affected by recurrent 536 droughts in this part of the world. In addition, a devastating drought is currently affecting 537 the Republic of Djibouti and the Horn of Africa regions with more than thirteen million people already affected by the drought. Therefore, this first study of drought in the Re-538 539 public of Djibouti will contribute very strongly to the national strategy for resilience to recurrent droughts that is being developed. 540
