33 **ABSTRACT**

34 Conservation conflicts involve an important emotional component that has been little
35 investigated so far. In particular, the study of emotions involved in conservation conflicts
36 have been limited in their scope (e.g. negative vs. positive sentiments) by the language
37 studied (mostly English). Natural Language Processing (NLP) approaches combined with
38 informed expert knowledge constitute a promising tool to analyze the occurrence of
39 discrete emotions in textual contents. We applied NLP on the textual content of German
40 print and online news publications featuring the return of wolves (*Canis lupus*) in the Saxony
41 region of Germany (n=3,096), to investigate the occurrence of 7 basic emotions and their
42 associations with 9 stakeholder groups. All emotions could be detected with different
43 accuracy levels, and except for *interest* that was detected in all articles, negative emotions
44 tended to dominate the articles' emotional content (*anger* in 74% and *fear* in 36% of the
45 articles). *Anger* was most frequently detected in articles featuring *farmers* (20%) and
46 *hunters* (15%), as was *fear* (17% with *farmers*, 14% with *hunters*). Our study of a diverse set
47 of emotions, in local language, demonstrates the usefulness of NLP approaches to broaden
48 the understanding of local conservation conflicts, in which the news organizations have a
49 pivotal, yet often neglected role.

65 **INTRODUCTION**

66 Conservation conflicts and the underlying tensions between stakeholders over wildlife
67 management can generate heated debates (Chapron and López-Bao, 2020; Nyhus, 2016),
68 involving strong emotions. The role of emotions in conservation conflicts has been
69 recognized in recent years (Chapron et al., 2014; Jacobs and Vaske, 2019; Jacobs, 2012;
70 Nelson et al., 2016), as they influence our dispositions towards wildlife (Jacobs & Vaske
71 2019) and seem tied to attitudes (Landon et al., 2019; Sponarski et al., 2015; Straka et al.,
72 2020). However, they remain seldom studied. To date, studies on emotions towards wildlife
73 have mostly focused on fear (Flykt et al., 2013; Johansson et al., 2012). The current lack of
74 knowledge on emotions in the context of conservation probably owes to the lack of
75 consensus around the definition of emotions (Izard, 2007; Jacobs, 2012), their diversity
76 (Jackson et al., 2019) and their cultural and language specificities (Aman and Szpakowicz,
77 2007). The study of emotions in the context of conservation conflicts thus requires strong
78 interdisciplinary integrations and appropriate tools to address these challenges.

79 In recent years, Natural Language Processing (NLP) approaches, i.e. Artificial
80 Intelligence techniques that allow computers to read and interpret information from natural
81 language texts (Thessen et al., 2012), have been broadly used in multidisciplinary
82 biodiversity projects (Thessen et al., 2012). Recent studies have highlighted the usefulness
83 of Artificial Intelligence methods in conservation, as they can be used to identify
84 conservation icons (Ladle et al., 2016), track illegal wildlife trade on social media (Di Minin et
85 al., 2018; Xu et al., 2019), investigate human-nature interactions (Toivonen et al., 2019) or
86 sentiments towards iconic species like white rhinoceros (Fink et al., 2020). We argue that
87 NLP approaches, , combined with informed expert knowledge (Dadvar et al., 2014;
88 Hirschberg and Manning, 2015; Hovy, 2015; Mohammad, 2016) constitute a promising
89 avenue to investigate emotions in conservation conflicts, as they can be applied to a broad
90 set of textual resources, to a wide range of contexts, and most importantly, to datasets
91 containing an amount of data that cannot be processed manually. However, to date,
92 automatic detection of emotions in textual content (i.e. sentiment analysis) applied in
93 conservation have been limited by (i) the dichotomy between positive and negative
94 emotions, although emotions are more diverse than simple polarizations (see Hausmann et

95 al. 2020 for a recent illustration in South African National Parks), and (ii) the focus on English
96 language resources, which is, in many cases, of limited local conservation relevance.

97 In this study, we applied NLP in automatic analysis of emotions on the textual
98 content of print and online news publications featuring the return of wolves (*Canis lupus*) in
99 the Saxony region of Germany, where they have been present since their recolonization of
100 Germany in 2000 (Reinhardt et al., 2019). Wolf conservation is one of the most contentious
101 conservation topics in human-dominated landscapes (Darinmont et al., 2018), and its return
102 to Germany has sparked important media coverage. Stories involving returning carnivores
103 are good candidates for being selected by news organizations, as they are perceived to be
104 relevant to a broad readership (although few people interact with carnivores), involve a
105 charismatic animal and often feature negative news (e.g. depredation events, concerns for
106 human health) (Harcup and O'Neill, 2001). Hence, human-carnivore coexistence is
107 frequently featured in the press (Bombieri et al., 2018; Fernández-Gil et al., 2016; Killion et
108 al., 2018) and contains an important emotional component that play an important role in
109 the mechanisms behind the effect of news frames on opinions, or framing effects (Lecheler
110 et al., 2015). Here, we investigated a set of seven basic emotions, namely *interest, surprise,*
111 *joy, sadness, fear, anger* and *disgust* (Jacobs et al., 2014). In addition, we investigated the
112 co-occurrence of the seven emotions and nine specific wolf conservation stakeholders,
113 namely *politics, research, Non-Governmental, Organizations, farmers, hunters, military,*
114 *news agencies, media, Saxony's Wolf Information Office.*

116 MATERIALS and METHODS

117 *Corpus of news*

118 Since wolf return to Saxony in 2000, the Wolf Information Office “Kontaktbüro Wölfe in
119 Sachsen” has been continuously compiling press clippings featuring wolves, in print and
120 digitized formats. The sampling protocol has evolved through time: at first, articles were
121 collected manually by surveying local (i.e., from the region of Saxony) and national press,
122 and opportunistically collecting news on wolves from other federal states; then, the advent
123 of online newspapers allowed automatized data collection based on keyword entries. It is
124 therefore possible that some articles were missed, but we assume that this would have

125 mostly affected articles from sources outside Saxony, and we do not anticipate specific
126 biases in terms of topics or emotional content. We obtained 4,000 newspaper articles, all in
127 German, that covered the entire period from 2000 to 2018, to investigate their content. As
128 most articles were indeed published in Saxony (n=2,556) or were from national sources
129 (n=764), we excluded articles from German federal States other than Saxony and focused on
130 a set of 3,320 newspaper articles. Each article was scanned and processed with an Optical
131 Character Recognition program. We only extracted the textual information and excluded
132 articles containing unrecognized text (n=224), resulting in a total of 3,096 articles for our
133 analysis.

134 *Natural Language Processing*

135 We pre-processed the texts using the Natural Language Toolkit in Python: we removed stop
136 words and non-informative symbols and punctuations, and used stemming to reduce them
137 to their word stem. The identification of emotions followed several steps (see Supporting
138 Information Fig. S1). First, we developed our own lexicons to identify the seven emotions in
139 the articles' texts, by compiling words referring to each of the seven emotions. We used the
140 SentimentWortschatz (V1.8) dictionary (Remus et al., 2010) to further enhance our list and
141 find synonyms to the words associated with each of the seven emotions (see Supporting
142 Information Table S1). Second, we used the Term Frequency-Inverse Document Frequency
143 (TF-IDF) numerical approach (Aizawa, 2003) to identify the most informative and distinct
144 words in each text and to investigate whether they included the words related to the
145 emotions. Third, we identified the presence of emotions in each text based on the
146 frequency of occurrence of words related to a specific emotion (Whitelaw et al., 2005).
147 Fourth, we used a word-level n-gram model (here bigram, n=2) that takes into account the
148 co-occurring words within a given window around the words associated with the specific
149 emotions. This provided the possibility to further look into the context that a word has been
150 used for, rather than only the frequency of its occurrences.

152 *Stakeholder categorization and extraction*

153 We created a lexicon for each of the stakeholder groups by populating a list of the keywords
154 based on our own expertise. We further improved the lexicon using an inductive approach
155 and adding terms that we found in the newspapers during the labelling process (see

156 Evaluation). We included *politics*, *research*, *Non-Governmental Organizations*, *farmers*,
157 *hunters* as these groups are most active in wolf conservation debates. We further included
158 *military* (military training areas have been critical for wolf recolonization in Germany)
159 (Reinhardt et al., 2019), *news agencies*, *media* (i.e. people involved in cultural and artistic
160 activities associated with wolves e.g. books, films, exhibits, etc.) and the *Wolf Information*
161 *Office* as these were frequently mentioned in the articles. We then used the lexicons as a
162 proxy to detect the occurrence of the stakeholders in each article (see Supporting
163 Information Table S2, Fig. S1).

164 *Evaluation*

165 The evaluation dataset consisted of 498 articles manually and independently labelled for
166 presence/absence of the seven emotions by two annotators with a social-ecological
167 background. The inter-annotator agreement was 0.80 (average agreement over the 7
168 emotions) meaning that in 80% of the labelled cases, the reviewers labelled the newspaper
169 articles to the same emotion categories (see Table 1).

170 We used the manually labeled dataset, where both annotators were in agreement,
171 to evaluate the accuracy of the NLP approach and to report the precision and the recall of
172 the identified emotions. For a specific emotion, precision is the fraction of accurately
173 detected instances (true positives) among the detected instances by the NLP (true positives
174 + false positives), whereas recall is the fraction of accurately detected instances (true
175 positives) among the total amount of relevant instances, i.e. texts that genuinely contained
176 that specific emotion (true positives + false negatives). Accuracy also reported the F1-Score
177 which is the number of correctly identified emotions divided by the number of all correctly
178 identified emotions returned. Finally, to investigate the co-occurrence of emotions and
179 stakeholder groups in the newspaper articles, we used pairwise Pearson correlation tests
180 between the seven emotions and the nine stakeholder groups, and implemented a
181 bonferroni correction on p-values to account for multiple tests.

182

183 **RESULTS**

184 The classification accuracy was different among emotions (Table 1). *Disgust* (1.00) and
185 *interest* (0.84) had the highest precision whereas *joy* (0.43) and *surprise* (0.62) had the

186 lowest. *Interest* (1.00) and *anger* (0.61) had the highest rates of recall whereas *disgust* (0.08)
187 and *joy* (0.09) had the lowest rates. Hence, *interest* (0.91) and *anger* (0.63) had the highest
188 F1-scores, whereas *disgust* (0.14) and *joy* (0.15) had the lowest (Table 1). Across 3,096
189 newspaper articles on wolves, *interest* (1.00), *anger* (0.74) and *fear* (0.36) were the most
190 frequently detected emotions (Fig. 1).

191 We identified *politics* (0.56) and *farmers* (0.54) as the most frequently found
192 stakeholders in the articles (Fig. 1). Comparatively, the *Wolf Information Office* (0.04) and
193 the *military* (0.04) were the least featured stakeholders in the articles (Fig. 1). The most
194 frequently detected co-occurrences between emotions and stakeholders in the newspaper
195 articles were between *farmers* and *anger* (0.20, $t=11.33$, $p < 0.001$), *farmers* and *fear* (0.17,
196 $t=9.68$, $p < 0.001$), *hunters* and *anger* (0.15, $t=9.68$, $p < 0.001$) and *hunters* and *fear* (0.14,
197 $t=7.82$, $p < 0.001$) (Fig. 2). The highest correlation between two emotions was found
198 between *anger* and *fear* (0.36, $t=21.57$, $p < 0.001$).

199

200 DISCUSSION

201 *Main findings*

202 Overall, our approach using NLP to detect emotions in German articles featuring wolves
203 demonstrated that all emotions could be detected in the corpus of 3,096 articles, and that
204 the approach could be applied to another language than English, increasing its local
205 relevance for conservation. Although emotion detection accuracy was sometimes low, we
206 detected a domination of negative emotions like *anger* and *fear*. The detection of *fear* and
207 *anger* in news articles featuring *farmers* and *hunters*, although reflecting the challenges of
208 human-carnivore coexistence, may hint at an unbalanced representation of wolf
209 conservation in the news.

210

211 *Natural Language Processing' relative efficiency to detect emotions*

212 Emotion detection is a challenging task because it is language- and topic-specific (Aman and
213 Szpakowicz, 2007). The inter-annotator agreement of ca. 80% illustrated the challenge of
214 labelling texts containing specific emotions. However, this value was in the range of
215 previous sentiment analysis in German (Momtazi, 2012) and other languages (Mozetič et al.,
216 2016). Furthermore, the F1-scores, reflecting quantity and quality of detected emotions,

217 were also in line with previous findings (Balahur et al., 2012; Kušen et al., 2017), reporting
218 higher precision for negative emotions and lower recall values for positive emotions (Table
219 1), meaning that negative emotions are more accurately detected, and positive emotions
220 occur less frequently in the news. Such pattern probably echoes the news tendencies to
221 select and frame negative news more frequently (Harcup and O'Neill, 2001). *Interest* may
222 not be a relevant emotion as it was detected in all newspaper articles, which publication
223 probably already reflects an expression of interest, thereby artificially inflating recall values
224 (1.00).

225 Except for *interest*, the prevalence of negative emotions like *anger*, *fear* and *sadness*
226 reflected the overall negative framing of human-carnivore coexistence in the news
227 (Bombieri et al., 2018; Nanni et al., 2020). The domination of *anger* and *fear* is problematic
228 for carnivore conservation, as emotions play an important role in mediating news framing
229 effects on people's attitudes (Lecheler et al., 2015). In fact, it is widely accepted that
230 negative information has a stronger impact on people's attitudes than positive information
231 (Soroka, 2006). As only few people directly interact with wolves (Arbieu et al., 2020) or
232 other conflict-prone wildlife, human-wildlife relations are mainly shaped by information and
233 not personal experience. Therefore, at a time where human activities increasingly encroach
234 on wildlife habitats and potentially generate more conservation conflicts, the conservation
235 community should embrace the complexity of emotions in conservation conflicts, for long-
236 term human-wildlife coexistence. We demonstrated that NLP approaches are promising
237 tools in this regard.

238

239 *Emotions and stakeholders' representation*

240 News organizations play an important role in giving a voice to conservation actors, and
241 stakeholder recognition is a critical aspect of conservation conflict management (Redpath et
242 al., 2017). We are aware of only few studies investigating stakeholder occurrence in the
243 media (see e.g. Rust, 2015; Webb and Raffaelli, 2008). Our approach using NLP to
244 investigate the co-occurrence between stakeholder and emotions revealed that the highest
245 associations between *hunters*, *farmers*, and *anger* and *fear* depicted a bleak image of
246 human-wolf coexistence in Saxony. This finding is at odds with a previous study that found
247 rather neutral attitudes expressed by the broad public towards wolves in this region (Arbieu
248 et al., 2019), reflecting an attenuation of the conflict over time. This discrepancy between

249 the negative and emotional content found in the newspapers that focus on the short-term,
250 often negative news and people's rather neutral attitudes that reflect longer timeframes of
251 learning to coexist with carnivores, illustrates the news agencies' narrow focus and
252 perception of human-carnivore coexistence. Understanding stakeholder's as well as news
253 agencies' perceptions (Bennett et al. 2016) may be critical to restore a more balanced and
254 fair representation of human-carnivore coexistence in the media. In addition, the
255 prevalence of *politics* and the under-representation of *research* demonstrates that the
256 information conveyed by news organizations may not always be evidence-based, and calls
257 for improved communication from the scientific community. Therefore, NLP approaches can
258 be a useful tool to investigate local conservation conflicts and potential polarizations (Webb
259 and Raffaelli, 2008). Besides, they are useful to analyse big textual datasets and resources,
260 such as online social media platform contents and news archives. However, most existing
261 tools and technical resources, such as training datasets and gold standards for automatic
262 detections have mainly been developed for the English language. Therefore, having these
263 tools and classification models developed for other languages, such as our study in German,
264 could be beneficial to local conservation contexts. In particular, this will help identifying
265 imbalances in stakeholder representation, investigating emotional contents, and developing
266 strategies to produce evidence-based information that do not mainly focus on short-term
267 negative news.

268

269 *Outlook*

270 This work calls for further investigations of the role of emotions in news featuring
271 conservation topics. First, to improve the accuracy of emotion detection, we would
272 recommend manually labeling an evaluation dataset that covers sufficient numbers of each
273 emotion to train a machine learning model, prepared by at least 3 annotators. Second,
274 further investigations could go beyond emotion occurrence and address emotional
275 intensity, and investigate changes at different spatial and temporal scales. Such
276 investigations would be very important in contexts of rapid social-ecological changes. Third,
277 comparisons across charismatic species could inform on discrepancies in species framings
278 (Bombieri et al., 2018). Most importantly, we encourage conservation scientists to embrace
279 interdisciplinarity and develop collaborations with scholars across journalism studies,
280 natural and computer sciences.

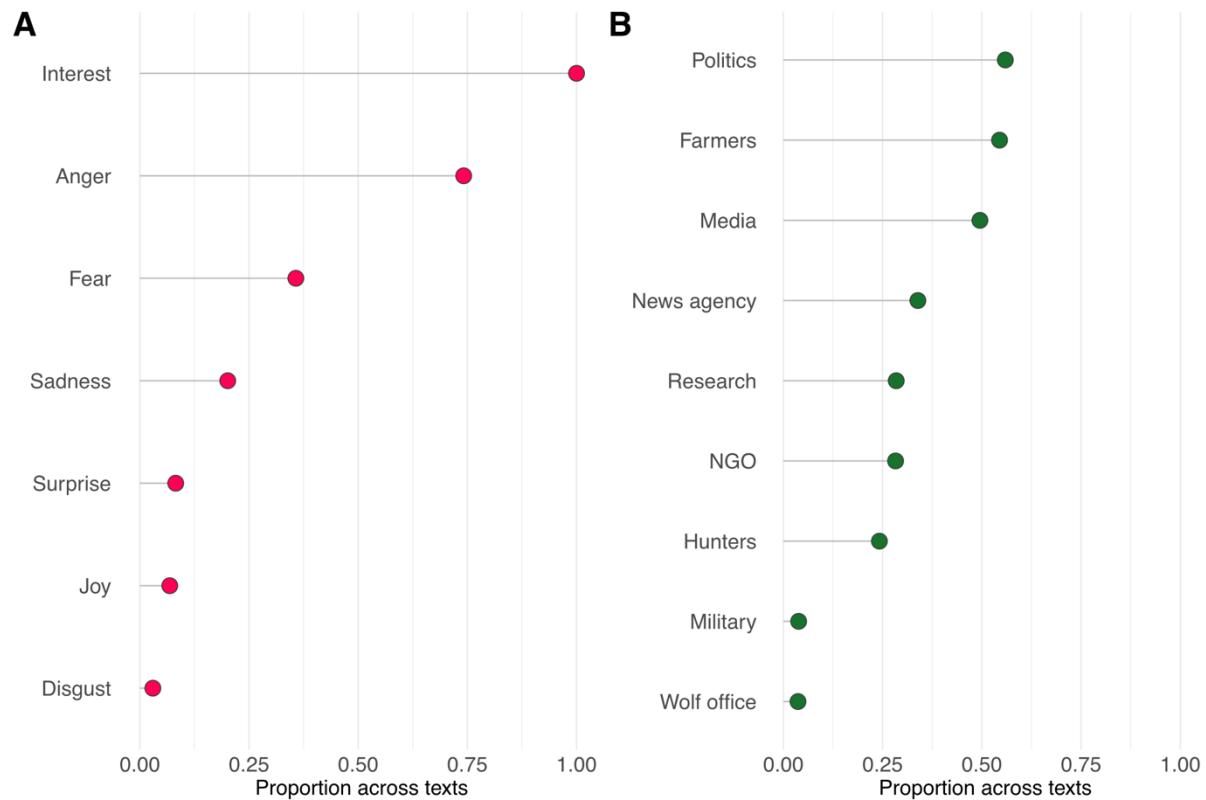

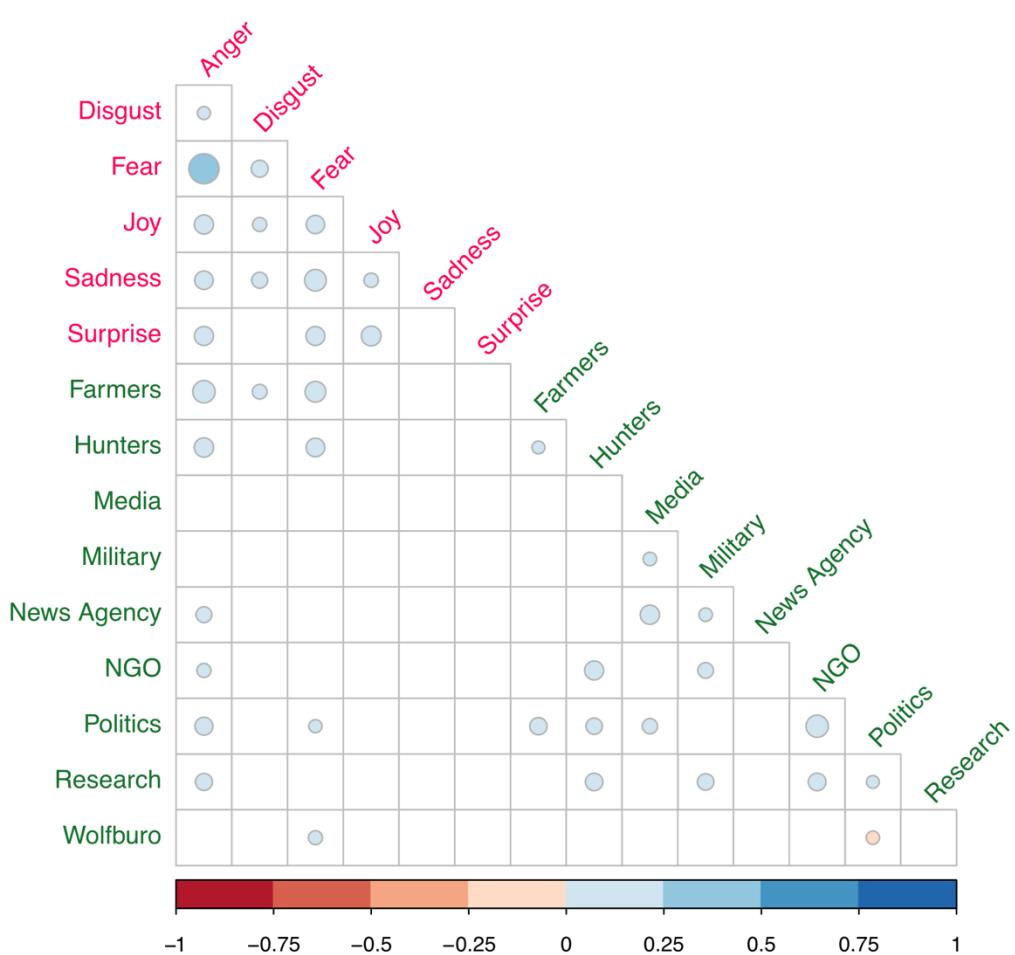

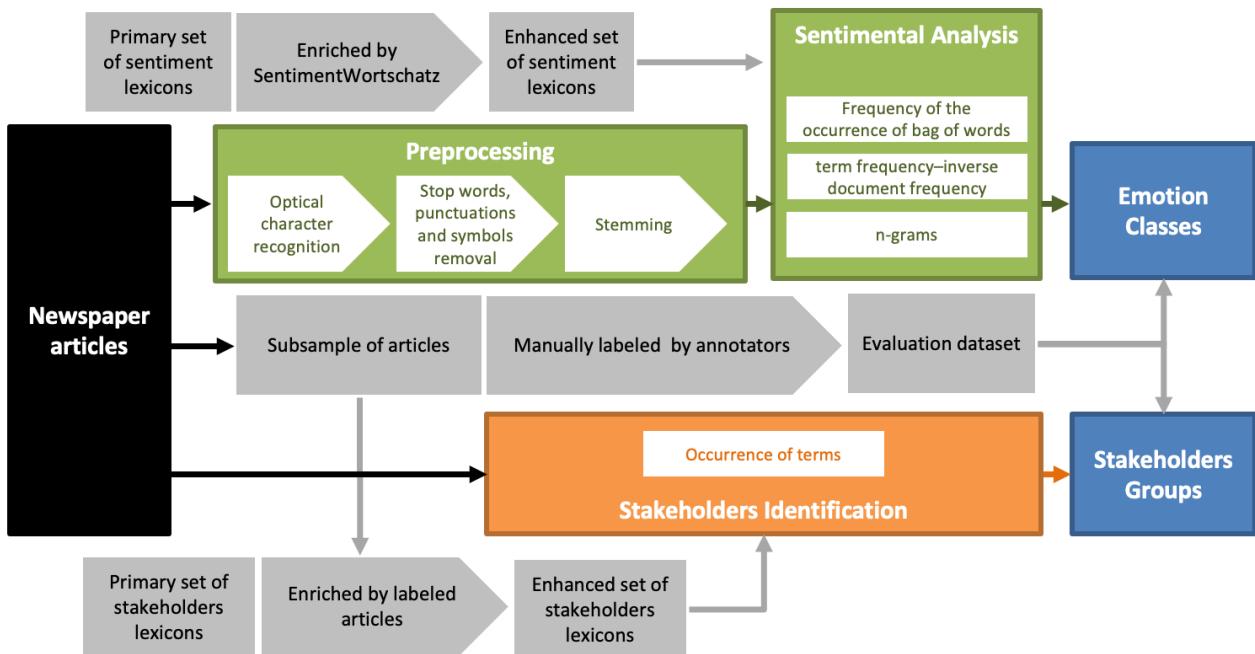
