12 13 Abstract. The interaction of V(IV) and V(V) with succinic acid was investigated by affinity 14 capillary electrophoresis (ACE) in aqueous acid solutions at pH values 1.5, 2.0 and 2.4, and 15 different ligand concentrations. V(IV) and V(V) form protonated complexes with succinic acid 16 ligand at this pH range. The logarithms of the stability constants, measured at 0.1 mol L⁻¹ 17 (NaClO₄/HClO₄) ionic strength and 25°C, are $\log\beta_{111}=7.4\pm0.2$ and $\log\beta_{122}=14.1\pm0.5$ for V(IV), 18 and $\log\beta_{111}=7.3\pm0.1$ for V(V), respectively. The stability constant values, extrapolated to zero ionic strength with the Davies equation, are $\log\beta^{\circ}_{111}=8.3\pm0.2$ and $\log\beta^{\circ}_{122}=15.6\pm0.5$ for V(IV) 19 20 and $\log\beta^{\circ}_{111}=7.9\pm0.1$ for V(V). The application of ACE to the simultaneous equilibria of V(IV) 21 and V(V) (injection of two analytes) was also attempted. When the results were compared with 22 those obtained when introducing only one analyte in the capillary, using the traditional version 23 of the method, similar stability constants and precision are obtained. The possibility of studying 24 two analytes simultaneously decreases the time needed for the determination of the constants; 25 this feature is especially valuable when working with hazardous materials or when only small

30 1 Introduction

31 Thermodynamic data on complex equilibria of metal ions are very important, not only 32 for fundamental knowledge reasons, but also in many diverse fields, such as toxicology, clinical 33 and biological chemistry, geochemistry and environmental chemistry, and analytical and 34 industrial processes [1]. Affinity capillary electrophoresis (ACE) is gaining an increasingly 35 prominent place in metal ion equilibrium studies [2-9]. This technique has been successfully 36 used, not only for the determination of complex stability constant with a 1 to 1 metal/ligand 37 ratio, but also in the study of more complicated systems [10,11]. ACE is useful for establishing 38 the stoichiometries of the complexes formed because the changes in the mobility of the 39 complexes enables deduction of their degree of protonation [9,10]. In this respect, ACE offers 40 undeniable advantages over other classical methods.

A further interesting advantage of ACE is that it requires only a small quantity of analyte
for thermodynamic equilibrium studies [9]. This is especially important when working either
with highly toxic or radiotoxic substances or with precious ligands.

The separation efficiency of the ACE also allows the study of simultaneous complexation equilibria including two or more metal ions with the same ligand. Although the possibility of using ACE for simultaneous determination of binding constants of several proteins with a ligand was pointed out in a pioneer work [12], to our knowledge, this feature has not been explored in equilibrium studies of complexation of metal ions yet.

The differences between aqueous V(IV) and V(V) species offer the possibility of
investigating whether the simultaneous equilibria of these metal ions. Since V(IV) and V(V)

51 are present as $VO(H_2O)_5^{2+}$ [13-15] and $VO_2(H_2O)_4^+$ [14-16] ions, respectively, in aqueous 52 solution, their different charges allow their easy separation by capillary electrophoresis.

53 There is a growing interest in the study of vanadium because of the potential 54 environmental hazards linked to its increasing use [17]. Vanadium is becoming important in 55 energy storage because of its use as a valuable microalloying component. Such applications 56 provide important opportunities in carbon dioxide reduction initiatives [18,19]. Although large 57 vanadium concentrations can cause harmful effects on ecosystems [20,21], the element seems 58 to play a dual role in environmental systems since it is also considered, at micro concentration 59 levels, as an element of beneficial character with a range of application for human welfare [22]. 60 Disentangling these apparently contradictory facts requires that vanadium is studied "to 61 understand properly and contextually apply the chemistry of vanadium to its toxicological 62 properties, environmental chemical forms and the development of new regulations and 63 standards in order to maximize the benefits and mitigate any potential risks of utilizing 64 vanadium"[18].

65 Vanadium is present in oxidation degrees IV and V in most natural waters and soils. 66 V(IV) is stable in moderately reducing conditions, especially under acidic pH values [23]. 67 Among a variety of possible geochemical processes, complex formation with natural organic 68 matter (NOM) present in the aqueous phase may play an important role in the eventual 69 dispersion of vanadium [23]. The formation of such complexes typically causes significant 70 changes in migration properties of chemical elements in the environment. Succinic acid is 71 chosen here for complexation studies of V(IV) and V(V) as a simple model of the structurally 72 more complicated NOM [24,25]. Alongside, the complex equilibria of V(IV) and V(V) with 73 succinic acid are poorly investigated. To our knowledge, only a few papers have been published 74 containing stability constants for complexes of V(IV) with succinic acid [26-30] Existing data 75 are gathered in table 1. Poor agreement is noted amongst the authors. Potentiometric studies

[26,27,29] led to different sets of constants and values being proposed. Even when a larger pH
range (2.0-6.7) was used, Costa Pessoa et al. [29] could not differentiate 111 and 121
complexes. Only one paper [31] has been found where the interaction of V(V) with succinic
acid had been studied by ⁵¹V NMR spectroscopy, but no thermodynamic constants were
provided.

The capabilities of ACE provide a suitable tool for the study of the complexation of V(IV) and V(V) with succinic acid. In this study, the possibility of studying V(IV) and V(V) simultaneously is explored. In this approach, two analytes are simultaneously injected and results compared with those obtained with the traditionally ACE methodology using single analyte injection. Finally, the obtained stability constant values are discussed in the light of available data from the literature for complexation of metal cations with succinic acid.

87 2 Materials and methods

88 2.1 Chemicals and solutions

All chemicals and reagents used were of analytical grade. 1 M perchloric acid solution
was obtained from Fisher Scientific. Sodium perchlorate monohydrate (≥ 99 %) was supplied
by Merck. Ammonium vanadate solution (≥ 99 %), vanadyl sulfate hydrate (≥ 99 %), succinic
acid (≥ 99 %) and dimethyl sulfoxide (99.9%) were supplied by Sigma Aldrich. All solutions
were prepared with fresh, high-purity deionized water (*R* = 18.2 MΩ cm) produced by a
Millipore direct Q cartridge system.

95 2.2 Apparatus, procedure and data treatment

96 *Capillary Electrophoresis measurements.* A P/ACE system MDQ capillary
97 electrophoresis instrument (Beckman Coulter, France) was used. The system included a 0–30
98 kV high-voltage built in power supply equipped with a UV-vis spectrophotometric diode array

99 detector. UV direct detection at 200 nm was used in this work. A capillary (50 μ m I.D., 363 μ m 100 O.D.) made from fused silica was obtained from Beckman Instruments. It had a total length (L_t) 101 of 31.2 cm and an effective separation length (L_d) of 21 cm. The capillary was housed in an 102 interchangeable cartridge with circulating liquid coolant (temperature 25°C). Every 103 measurement was repeated at least three times. Data acquisition and processing were carried 104 out with Karat 32 software (Beckman Coulter, France).

The capillary was conditioned prior to use by successive washes with 0.1 M sodium hydroxide, deionised water and with the buffer solution used in the study. It was rinsed for 2 minutes (at a pressure of 103.4 kPa) with the buffer between two runs, and kept filled with deionised water overnight.

109 The procedure used in this study was similar to that previously described in [25]. Series 110 of solutions containing different concentrations of succinic acid were prepared at the desired 111 pH at an ionic strength of 0.1 M, from stock solutions of HClO₄ (0.1M), NaClO₄ (1 M) and succinic acid. The dissociation of succinic acid was taken into account in the solution 112 113 preparation. These solutions were used as the background electrolytes (BGE). V(IV) and/or V(V) solutions at fixed concentrations of 5×10^{-4} and 1×10^{-3} M, respectively were injected in 114 115 the capillary. In order to avoid hydrolysis and/or polymerisation of the V(IV) and V(V) ions, 116 which could potentially lead to the formation of additional species and/or to the modification 117 of the vanadium species mobility values, the pH value of solutions containing the BGE was < 2.5. At such pH values and V(IV) and V(V) concentrations, the contribution of hydrolysed and 118 119 polymeric species is not noticeable (Fig. S1).

120 The normal polarity mode was applied (the injection was performed at the positive 121 capillary end). The sample, containing the analyte (or analytes) and the neutral marker, was 122 injected into the capillary. Dimethyl sulfoxide (0.05% DMSO) was used as a neutral marker for 123 electroosmotic flow mobility determination. The capillary contained BGE with fixed

124 concentrations of succinic acid. Sets of runs were then made for different concentrations of 125 succinic acid (from 0 to 0.4 M) in BGE. The separation voltage applied was 5 kV and the 126 injection time (by a pressure of 3.45 kPa) was 4 s. The value of the applied voltage was chosen 127 to respect the Ohm's law linearity. The current was about 45 µA and the input power was about 128 0.2 W. In these conditions we can estimate that the effect of Joule heating is insignificant in the 129 thermostated part of the capillary and the deviation from the desired temperature 25°C is at 130 most 1°C [32,33]. The non-thermostated capillary inlet has no influence on stability constant 131 values obtained under such conditions [34-36]. The separation was performed at constant 132 forward pressure of 1.4 kPa.

133 The electrophoretic mobility μ (m² s⁻¹ V⁻¹) was calculated by using the following 134 expression:

where L_t (m) was the total capillary length, L_d (m) the length between the capillary inlet and
the detection window, U the applied voltage in V, t (s) the migration time of the studied species,
and t_{eof} (s) the migration time of a neutral marker.

All concentration and constant calculations were performed with the EXCEL® and
ORIGIN® software programs. The experimental points were fitted by a least squares curve
method.

pH measurements. The pH was controlled with a pH-meter. pH-meter GLP-21 (Crison,
France) and a combination electrode was used for pH measurements after calibration against
NIST standards (4.01 and 7.00). The pH values of the solutions were in an interval of ±0.05
units from desired values.

Perchlorate measurements. Combined ion specific electrode (ISE) "Fisher brand" for
perchlorate from Fisher Scientific was used to check perchlorate concentrations of stock
solutions and to control ionic strength. The RSD was less than 2%.

2.3 Ionic strength corrections

The Davies equation [37] was used to calculate activity coefficients of ions at low ionic
strengths. The equation works fairly well up to ionic strengths (I_m) of 0.1 mol kg⁻¹.

152 The Davies equation for the activity coefficient (γ) of an ion *i* of charge z_i is at 25°C:

154 **3 Results and discussion**

155 **3.1** Monitoring of V(IV) and V(V) electrophoretic mobility: two analytes *vs* one.

156 The electropherograms obtained with an injection from the sample, containing the 157 mixture of V(IV) and V(V) species, in the presence of different concentrations of succinic acid in BGE at pH=2 and an ionic strength 0.1 mol L⁻¹ (HClO₄-NaClO₄) are presented in Figure 1A. 158 159 For comparison, the electropherograms obtained in the case of separate injections of V(IV) and 160 V(V) are also shown in Figure 1B and 1C, respectively. As expected, the number of analytes 161 injected does not have any influence on their mobilities. Only one peak is observed for each 162 vanadium species, whose mobility is decreased with the increase of succinic acid concentration 163 in BGE. This indicates that we deal with kinetically labile complexes [7,38]. The equilibrium 164 is sufficiently fast and the time required for equilibrium negligible compared with the separation 165 time. The kinetic behaviour of the aqua complexes of metal ions can serve as a reference point 166 for complex formation reactions. The loss of the first water molecule from the first coordination 167 sphere is an important step in complex formation of metal cations [39], and is often the rate determining step. For V(IV) aqua-complex (VO(H₂O) $_{5}^{2+}$), the half life for four equatorial water 168 169 ligand exchange is ~1 ms. The half time for a water ligand located opposite to the doublebonded oxygen is about 10^{-11} s [14,40]. For V(V) (VO₂(H₂O)₄⁺), the water rate exchange 170 constant is estimated at 10^{8.2} s⁻¹ [41]. These values confirm our ACE observation of fast ligand 171 172 exchange (only one peak is observed). V(V) peaks are narrower than V(IV) examples (Figure comparison with V(V) (VO₂⁺). Thus, as expected, V(IV) mobility is greater (migration time is

174 observation also agrees with the kinetic data given above. $V(IV) (VO^{2+})$ has a double charge in

176 lower) than for V(V). The mobility observed corresponds to the sum of mobilities of coexisting

177 charged species formed with the ligand under study (eq.3)

178 In Eq.3, μ_i stands for the intrinsic electrophoretic mobility and α_i for the molar fraction of 179 individual species (*i*) present in the migration band.

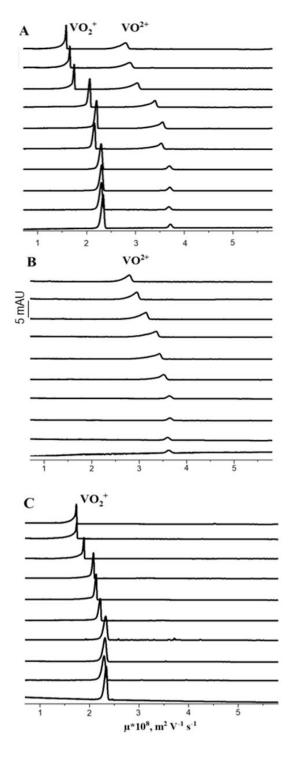


Figure 1. Electropherograms of 5×10^{-4} M V(IV) and 1×10^{-3} M V(V), in the presence of different amounts of succinic acid in BGE. Ligand concentrations in BGE from bottom to the top: 0, 1×10^{-3} , 6×10^{-3} , 8×10^{-3} , 0.04, 0.08, 0.1, 0.2, 0.3 and 0.4 M. A – simultaneous injection of two analytes. B – injection only V(IV). C – injection only V(V). pH=2, I=0.1 M (NaClO₄ – HClO₄). Detection wavelength: 200 nm, T=25°C.

180 The decrease in the global charge of the species when increasing the concentration of 181 succinic acid (migration time increases) (fig.1) suggests the formation of a less charged 182 complex species with increasing succinic acid concentration.

184 **3.2** Chemical equilibria and stability constants

The equilibria of the vanadium species with the succinate ligand (denoted as L²⁻ further)
can be expressed as:

Equilibrium constant values can be obtained by fitting experimental mobilities (Tables
S2-S6) using the general equation (3). A non-linear fitting (NNLS) method is preferred over a
linear regression method [42-44].

199 In this case, the molar fraction of species to be introduced in equation (3) can be written200 as

where C(L) is the total succinic acid concentration, and [H₂L], [HL⁻] and [L²⁻] the concentrations of the different forms of succinic acid at equilibrium. At pH \leq 2.5 succinic acid is mainly present in its completely protonated form, as H₂L (Fig. S2).

213 Protonated complexes with succinic acid for the transition metal ions are known 214 [25,45], but mostly deprotonated complexes of V(IV) with succinic acid have been described 215 in the literature (Table 1). Only Costa-Pessoa et al. [29] suggest the formation of a protonated 216 species with V(IV). Owing to the complex charge change linked to protonation or 217 deprotonation, it is possible to distinguish protonated from deprotonated complexes by ACE 218 [7,9,25]. The identification of the interacting species requires the variation of the concentration 219 of each succinic acid species in order to know which influences the vanadium species mobility 220 [10,46]. As all succinic species are present in the dynamic equilibria, it is not possible to vary 221 the concentration of only one species without modifying the concentrations of the rest.

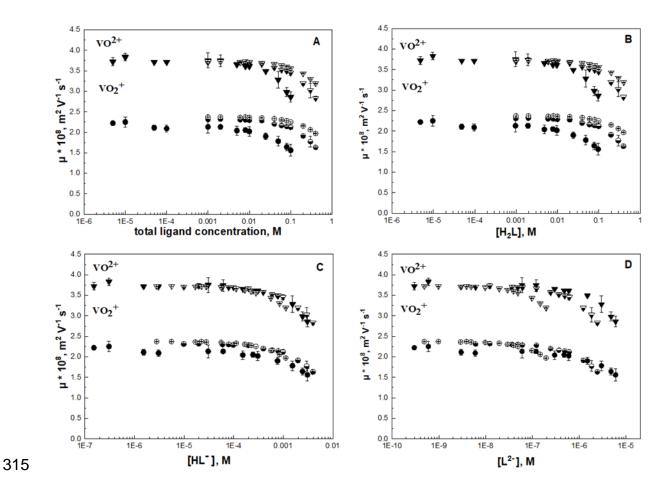
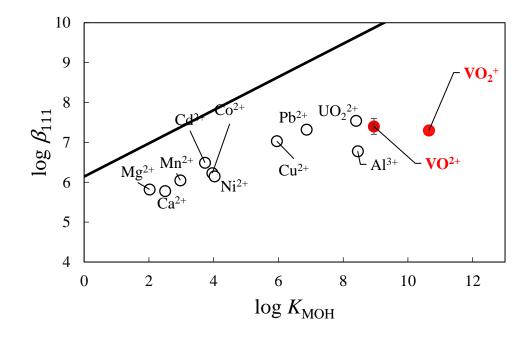


Figure 2. Mobilities of V(IV) (triangles) and V(V) (circles) at pH=1.5 (empty markers) pH=2

222 Thus, it is necessary to plot the V(IV) and V(V) mobilities, measured at different acidic pH values (Figure 2), as a function of the total succinic acid (A), [H₂L] (B), [HL⁻] (C) and [L²⁻ 223 224] (D) concentrations. We can state unambiguously the similarity of the curves in the case of HL⁻ 225 for V(IV) and V(V). However, in the case of V(V), a slightly lower mobility is observed at pH 226 2.4, because of about 15% hydrolysis of V(V) and the corresponding formation of a less charged 227 species (Fig. S1A). It can be concluded that only HL⁻ affects the vanadium species mobility. 228 Thus, most probably, we have a formation of mainly protonated complex species of V(IV) and 229 V(V) with succinic ligand in these conditions. The graphs presented in fig. 2 were obtained in 230 the case of simultaneous injection of V(IV) and V(V). As expected, similar graphs are obtained 231 when analytes are introduced separately (Fig. S3).

Considering only the equilibria with HL⁻ as the ligand, different models were explored:
formation of one 1:1:1 complex, simultaneous formation of two complexes (1:1:1 and 1:2:2),
formation of one 1:2:2 complex, simultaneous formation of two complexes (1:1:1 and 1:2:1).

We note that the system suffers from a mathematical indetermination, meaning that the product $\alpha_{111}\mu_{111}$ (eq. 3) is well defined but each individual term, α_{111} and μ_{111} , cannot be precisely determined. A similar case has been already described in [47]. In this case, to reach convergence it was necessary to make a reasonable guess of the μ_{111} value and to keep this value constant. The same approach is used in this study.

In the case of V(IV), the best fits were found for the model with two complexes (1:1:1) and (1:2:2). The constants obtained at different pH values are given in table 2 for the two cases: that of only one analyte injected and also of two analytes simultaneously injected. The values obtained are practically the same. It is worthwhile to note that our value for $\log\beta_{111}$ is very close to that proposed by [29]. For the second constant (1:2:2) the error is much larger, because the concentration of this species is low in our conditions.

In the case of V(V), only one complex (1:1:1) was found. Again, no significant difference
was observed between the values obtained with only one analyte injection or the simultaneous
injection of two analytes.

The average values for V(IV) and V(V) complexes are also shown in Table 2. The stability of protonated complexes (1:1:1) for V(IV) and V(V) is practically the same. We extrapolated the stability constant values to zero ionic strength with the use of the Davies equation (2). Thermodynamic stability constants are also presented in table 2.

253 3.3 Compari

Comparison with literature data

A Linear Free Energy Relationship (LFER) is applied to compare our values with literature data for complexes formed by different metal ions with succinate. This approach is commonly used in the literature to compare the affinity of a given ligand for a series of metal cations (M^{z+}). The effect of the negatively charged oxygen-donor group of the ligand on complex stability appears to depend on the acidity of the metal ion considered, i.e., the affinity of the metal ion for the archetypal negative O-donor ligand, the OH⁻ ion [48]. Thus, the stability constant of metal ion complexes with a ligand, containing an oxygen-donor group, correlates
with the formation constant K_{MOH} on a log-log scale, indicating that the stability depends
primarily on the Lewis acidity of the metal ion, similar to that expected for an electrostatic
interaction. Moreover, a similar binding mode can also be inferred from such linear plots.

264 Figure 3 shows a LFER where $\log \beta_{111}$ is plotted as a function of $\log K_{MOH}$ for different 265 metal ions, including the $\log \beta_{111}$ values for V(IV) and V(V) measured by ACE in this study. 266 Other stability constant values at 0.1 M ionic strength and 25 °C were taken from the literature 267 (Table S7). A good linear trend is observed for all cations, except for V(V). The $\log \beta_{111}$ for 268 V(V) is lower than predicted from the LFER correlation. This suggests that V(V) complexation 269 is not only governed by electrostatic interactions, but that there might be a significant 270 contribution of a steric factor. Indeed, the $VO_2(H_2O)_4^+$ displays a very distorted octahedral 271 configuration with a O=V=O bond angle of ca. 105° [15]. This can hamper the electrostatic 272 interaction with the ligand and weaken complex stability. Most probably, for the same reason, 273 the oxalate complexes of V(IV) are more stable than those of V(V)[49].

275 4 Conclusions

We demonstrate in this study the possibility of using the simultaneous injection in a capillary of two metal cations in equilibria studies by ACE. Certainly, this is a very attractive feature of this method since it can drastically decrease the time needed for equilibria studies and, moreover, allow the fast screening of interactions. This is especially important when manipulating hazardous and/or precious materials. It is expected that three or more analytes can be used simultaneously in equilibria studies provided they have different enough mobilities.

282 This study also describes a significant contribution to the knowledge of V(IV) and V(V)283 chemistry. For the first time, to our knowledge, the existence of a protonated V(V) complex

284	with succinic acid is illustrated and the corresponding stability constant measured. A significant
285	insight is also provided on V(IV)-succinic acid complexation.
