Image of a social class in question

- Very long history (for about ten centuries until the 14th c.) of coexistence of diverse religious traditions
- Sudden appearance of a social class (intellectual) isolated in one tradition and impervious to the others, from the 15th to the 19th c. (Chosŏn period) ?
- The culture of litterati class : exclusively Confucian ?

Constructing factors ?

- A idealized / constructed image of this social class by 2 constructing factors ?
- Confucian historiography : exemplary (moral and political) history
- Monotheistic and rational notion of « religion » : « it is a religion only when an experience is confirmed through a confession of faith ».

Recent Studies Reveal :

- Socio-cultural changes in the 18th c.
- Confucian Buddhist dynamics : A more general phenomenon beyond personal and isolated cases
- Cases of literati who show esteem for the other traditions as much as for Confucianism
- Cases of literati, while keeping their Confucian conviction exclusive, interested too in Buddhism and Taoism

Recent Studies Reveal :

- Limit of previous studies : depending on ideological, philosophical or literary exchanges
- Limit of previous viewpoints : sclerotic, monolithic and static regards
- Limit of previous approaches : depending on textual documentation

Amplified and pluri-disciplinary approaches in need

- Object : Contact and exchange provide information about sociocultural dynamism
- Its origins
- Its background and context
- Its indication and parameter

Why the 18th century ?

- In the 16th c. : generalization of Confucian culture (ideology and practices) in the center and provinces
- 17th c. : new relationship between State/Society and Buddhist world
- 18th c. : fundamental and various changes in economic, social and cultural dimensions
- 19th c. : decline of Confucian hegemony, free and detached attitude toward Buddhist world

Historical, social, cultural contexts

- Since the 15th c.
 - Buddhism, royal family and court
 - Buddhism as female religion in *yangban* family
- Since the 17th c.
 - State's acknowledgement of Buddhists monks' devotions during wars
- Relationship between local administration and monasteries
 - Exploitation, cooperation and mutual support

Historical, social, cultural contexts

- Buddhist efforts for resurgence
 - Scholarly promotion
 - Contribution to book production
 - Absorption of Confucian value and practice
 - Approach to Confucian literati
- Monasteries as open space
 - Artistic attractions
 - Place for sightseeing, meeting, studying
 - Pilgrimage for government officials

Historical, social, cultural contexts

- Exchanges between people from different social status, *yangban* and other classes
- → Monks and monasteries' usual existence in many spheres of society and culture

Literati's personal contexts

- Family relationship
- Master disciple relationship
- Political ordeal or alienation
- Loss of beloved ones
- *P'ungniu* 風流 mind/taste
- Request for writings

Kind of monks in contact

- Collapsed *yangban* family
- Having a Confucian grounding
- Renowned for ascetic achievement or scholarly attainment

Positive attitudes toward Buddhist world

- Non-dogmatic
 - Self-reflection,
 - Critical & pragmatic mind,
 - Acknowledgment of subjectiveness
 - Extensive learning
- Comprehensive understanding of Buddhism & profound understanding of Confucianism
 - Acknowledgment of Buddhist fundamental value
 - Search for spirit of primitive Confucianism and deeper understanding of Zhu Xi's thought
- Concern about after death or invisible world

Positive attitudes toward Buddhist world

- Disillusion about Confucianism
 - Buddhists for comparison with Confucians
 - Buddhism for social criticism
- Personal experience and internalisation
 - Recognition through personal exchange and experience
 - Adoption of Buddhist eye as his own not as other's
- One of the ways for self-perfection
- Particular literary style in sūtra
- Concern about history of Buddhism in Korea

Other benefits from Buddhist world

- Space for study, leisure and meeting
- Rituals for ancestors' peace
- Support for book production

Roles as Confucian for Buddhist world

- Criticism
 - Irrational, illogic ideas, ex. : idea of Samsara
 - Scholarly monks' desire for fame
 - Coexistence of critical and positive attitudes
- Social education for monks
 - Confucian education and socialization
- Support for Buddhist activities
 - Writing, compilation, book production
 - Rituals for ancestors

In 18th c. Chosŏn, probably

- Closeness and variety in relationship between Buddhism & Confucianism : more dynamic
- Significant role and place of the Buddhist world in personal and social dimension
- Buddhism was more ubiquitous

Case of a rural Confucian scholar

- Yi Chun 李濬 (1686-1740)
- Hamp'yŏng district in the Chŏlla province
- His journal *Tojae ilgi* 導哉日記 (1717 – 1731)
- Having applied many times for public service without success
- Properties barely sufficient to sustain his family
- Diverse medical and religious practices



Diverse religious practices

- Being faced with uncertainty of life or with death
- Divinations based on the *Book of Changes of the Zhou* 周易.
- Praying to the spirits of nature (明神 : the sun, the moon, mountains, flows or areas of water)
- Buddhist rituals for deads

Buddhist rituals for deads

- Conducted in parallel with the Confucian rites
- Constant presence of Buddhist monk in Confucian families (in a clan community)
- Positive attitude toward Buddhist rite (*ch'ōndo chae* 薦度齋, « Guidance service for the souls of the deceased (in a good place) »)
- A Confucian scholar accepted Buddhist rituals which were admitted and practices by his society.

Factors of plurality

- Observation : Complementarity & porosity
- 3 closeness in social / global level :
 - Historical closeness (understanding based on prejudice from history)
 - Closeness in spirituality
 - Closeness in group organization
- 2 closeness in personal level :
 - Closeness in space
 - Closeness in a particular social situation
