Asymptotic behavior of a plate with non-planar top surface G. GRISO

Abstract

In this paper we study the asymptotic behaviors of a plate with non-planar top surface in the framework of linear elasticity. For this plate, we give a decomposition of the displacements. We show that every displacement of the plate is the sum of a Kirchhoff-Love displacement and a residual displacement that takes into account the deformations of the fibers of the plate and the shearing. We also prove Korn's type inequalities.

Résumé

Dans cet article, nous étudions, dans le cadre de l'élasticité linéaire, les comportements asymptotiques d'une plaque dont la surface supérieure est non plane. Pour cette plaque, nous donnons une décomposition des déplacements. Nous montrons que tout déplacement de la plaque est la somme d'un déplacement de Kirchhoff-Love et d'un déplacement résiduel qui prend en compte les déformations des fibres de la plaque et le cisaillement. Nous donnons également des inégalités de type Korn.

1 Introduction

The first difficulty encountered when studying a plate with a non-planar top surface is the estimation of displacements. The second, as in all problems of linear elasticity of thin structures, is to give a simple expression to the strain limit tensor. In this paper, we start by extending the result obtained in [21] for flat plates: namely that any displacement is the sum of a Kirchhoff-Love displacement and a residual displacement. Here, our proof uses the result of [21] and is based on simple geometrical considerations concerning the lateral boundary and the parameterization of the non-flat part of the plate. This decomposition of a displacement is followed by estimates of each of its terms using the norm of the strain tensor. When investigating the behavior of the strain tensor of a sequence of displacements, these estimates allow to obtain a simple expression for the limit strain tensor only in terms of the limit Kirchhoff-Love displacements and the limit residual displacements. This done, we can give the asymptotic behavior of a non-planar plate made of an isotropic and homogeneous material and also give the asymptotic behavior of this type of plate in the framework of reduction of dimension and homogenization.

Plates with rough surfaces are the subject of an important literature. In [5], we find a Korn type inequality for a rough surface plate and in [10] a Korn type inequality for a structure made of plates whit non-flat surfaces. The asymptotic behavior of a plate with a rough surface is studied in [6, 7, 8]. Other papers [11, 12, 14, 17] study the jonction of a plate with a vertical rod or a family of regularly spaced vertical rods. As a general reference on elasticity, we refer the reader to [1, 3]. For mathematical modeling of plates we refer to [2, 4, 9, 16, 21]. For the periodic unfolding method we refer to [16].

This paper is organized as follows:

- In Section 2 we introduce the main notations and the plate Ω_{δ} with non-flat top surface.
- In Section 3 we recall some results obtained in [21] concerning the displacements of a plate. Any displacement of a plate of constant thickness is the sum of a Kirchhoff-Love displacement and a residual part (the shearing and the warping). We also recall the estimates of the terms of this decomposition (see Lemma 3.1 and Proposition 3.1).
- In Section 4 we extend the results obtained in [21] to non-flat plates.
- In Section 5 we transform the plate Ω_{δ} into a fixed domain Ω using a dilation in the plate thickness direction. Then, we introduce the dimension reduction operator Π_{δ} which acts on functions defined in Ω_{δ} , this allows to work with functions defined in Ω . In Subsection 5.1, we consider a sequence of displacements $\{u_{\delta}\}_{\delta}$ whose strain tensors satisfy

$$||e(u_{\delta})||_{L^{2}(\Omega_{\delta})} \leq C\delta^{5/2}.$$

In Theorem 5.1 and Lemma 5.1 we give the asymptotic behavior of the sequence $\{1/\delta^2\Pi_\delta(e(u_\delta))\}_{\delta}$ using the limits of the partial derivatives of the terms of the decomposition of u_δ .

In order to solve problems of dimension reduction and homogenization, we introduce a specific operator $\mathfrak{T}_{\varepsilon\delta}$ that combines dimension reduction and periodic unfolding. The dimension of the periodic cells is ε , we are interested in the case

$$(\varepsilon, \delta) \to (0, 0)$$
 and $\frac{\varepsilon}{\delta} \to \theta \in (0, +\infty).$ (1.1)

In Subsection 5.2, we choose a sequence of displacements $\{u_{\varepsilon,\delta}\}_{\varepsilon,\delta}$ satisfying

$$||e(u_{\varepsilon,\delta})||_{L^2(\Omega_{\delta})} \le C\delta^{5/2}.$$
(1.2)

In Theorem 5.2 we give the asymptotic behavior of the sequence $\{1/\delta^2\mathfrak{T}_{\varepsilon\delta}(e(u_{\varepsilon,\delta}))\}_{\varepsilon,\delta}$. In the limit strain tensor the parameter θ appears.

- In Section 6, the plate is submitted to applied body forces. We study the linear elasticity problem posed in the domain Ω_{δ} . The coefficients of Hooke's law are periodic (period ε) and they also vary strongly according to the thickness of the plate (we make the assumptions (1.1)). The applied body forces are chosen in order that the solution $u_{\varepsilon,\delta}$ of the elasticity problem satisfies (1.2). Thanks to the results of Section 5 we obtain the limit elasticity problem posed in the rescaled and unfolded domain (see Theorem 6.1). Then, as usual in homogenization we introduce the correctors and we give the problem whose solution are the limit membrane displacement \mathcal{U}_m^{θ} and the limit bending \mathcal{U}_3^{θ} . These fields depend continuously on the parameter θ .
- In Section 7 we partially extend the results of Section 4 to plates with strongly oscillating top surfaces.
- The Appendix (Section 8) is devoted to the proofs of technical results used in Section 4.

Throughout this paper, we use the Einstein convention of summation over repeated indices. As a rule, the Greek indices α , β , α' and β' take values in $\{1,2\}$ and the Latin indices i, j, k and l take values in $\{1,2,3\}$. The courant point of \mathbb{R}^2 is denoted $x' = (x_1, x_2)$. The courant point of Y is $X' = (X_1, X_2)$ while the courant point of Y is $X = (X_1, X_2, X_3)$.

2 Notations

Denote

- $(\mathbf{e}_1, \mathbf{e}_2, \mathbf{e}_3)$ the usual orthonormal basis of \mathbb{R}^3 ,
- ω a bounded domain in \mathbb{R}^2 with Lipschitz boundary,

The plate with a non-planar top surface is the domain

$$\Omega_{\delta} = \left\{ x = (x_1, x_2, x_3) \in \omega \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta \phi(x_1, x_2) \right\}.$$

We also consider

$$\Omega_{0,\delta} = \omega \times (-\delta C_0, \delta C_0) \subset \Omega_{\delta}$$

the plate with flat top and bottom surfaces.

The plate Ω_{δ} (resp. $\Omega_{0,\delta}$) is clamped on a part Γ_{δ} (resp. $\Gamma_{0,\delta}$) of its lateral boundary

3 Some reminders on the decomposition of plate displacements

For every $u \in W^{1,p}(\Omega_{0,\delta})^3$, $1 , we denote <math>e_{ij}(u)$ the entries of the strain tensor e(u) of u

$$e_{ij}(u) = \frac{1}{2} \left(\frac{\partial u_i}{\partial x_i} + \frac{\partial u_j}{\partial x_i} \right), \qquad (i, j) \in \{1, 2, 3\}^2.$$

In [21] we have proven that any displacement $u \in W^{1,p}(\Omega_{0,\delta})^3$, 1 , is the sum of a Kirchhof-Love displacement and a residual one

$$u(x) = \underbrace{\begin{pmatrix} \mathcal{U}_{1}(x') - x_{3} \frac{\partial \mathcal{U}_{3}}{\partial x_{1}}(x') \\ \mathcal{U}_{2}(x') - x_{3} \frac{\partial \mathcal{U}_{3}}{\partial x_{2}}(x') \\ \mathcal{U}_{3}(x') \end{pmatrix}}_{\text{Kirchhoff-Love displacement}} + \underbrace{\widetilde{u}(x)}_{\text{residual displacement}}$$

where U_{KL} and \widetilde{u} belong to $W^{1,p}(\Omega_{0,\delta})^3$. We recall that the map $u \in W^{1,p}(\Omega_{0,\delta})^3 \longmapsto U_{KL} \in W^{1,p}(\Omega_{0,\delta})^3$ is continuous and linear (see [21]).

The sum

$$\mathcal{U}_m = \mathcal{U}_1 \mathbf{e}_1 + \mathcal{U}_2 \mathbf{e}_2$$

is the membrane displacement, while \mathcal{U}_3 represents the bending of the mid-surface of the plate. The residual part \tilde{u} stands for shearing and warping (the deformation of the fibers $\{x'\} \times (-\delta C_0, \delta C_0)$, see [13, 21]). The residual displacement satisfies the following two conditions:

Theorem 3.1 (Theorem 6.1 in [21]). Let u be in $W^{1,p}(\Omega_{0,\delta})^3$, $1 . The fields <math>\mathcal{U}_m = \mathcal{U}_1\mathbf{e}_1 + \mathcal{U}_2\mathbf{e}_2$, \mathcal{U}_3 and \widetilde{u} satisfy

The constants do not depend on δ .

Lemma 3.1 (Lemma 3.4 in [21]). Suppose that the plate is clamped on $\Gamma_{0,\delta}$. Then, we have

The constants do not depend on δ .

As a consequence of the above theorem and lemma, one has

Proposition 3.1 (Proposition 3.5 in [21]). Let u be a displacement in $W^{1,p}(\Omega_{0,\delta})$, $1 . Assume the plate clamped on <math>\Gamma_{0,\delta}$. Then, we have

The constants do not depend on δ .

4 Displacements decompositions of the non-planar plate

Let u be a displacement in $W^{1,p}(\Omega_{\delta})^3$, $1 . The restriction <math>u_{|\Omega_{0,\delta}}$ is a displacement of the plate $\Omega_{0,\delta}$, we decompose it as (3.1). The Kirchhoff-Love displacement U_{KL} can also be considered as a displacement of the plate Ω_{δ} , so it belongs to $W^{1,p}(\Omega_{\delta})^3$. We write

$$u = U_{KL} + \mathfrak{u}. \tag{4.1}$$

The residual part \mathfrak{u} belongs to $W^{1,p}(\Omega_{\delta})^3$, it stands for the deformations of the fibers of the plate Ω_{δ} . Note that $\mathfrak{u} = \widetilde{u}$ a.e. in $\Omega_{0,\delta}$.

Theorem 4.1. For every displacement u in $W^{1,p}(\Omega_{\delta})^3$, $1 , the terms <math>\mathcal{U}$ and \mathfrak{u} of its decomposition given by (4.1) satisfy

with a constant C independent of δ .

Proof. The estimates $(4.2)_{1,2}$ are the consequences of those in Theorem 3.1 and the fact that $||e(u)||_{L^2(\Omega_0,\delta)} \le ||e(u)||_{L^2(\Omega_\delta)}$ since $\Omega_{0,\delta} \subset \Omega$. We have

$$e(U_{KL}) = \begin{pmatrix} e_{11}(\mathcal{U}) - x_3 \frac{\partial^2 \mathcal{U}_3}{\partial x_1^2} & e_{12}(\mathcal{U}) - x_3 \frac{\partial^2 \mathcal{U}_3}{\partial x_1 \partial x_2} & 0) \\ e_{12}(\mathcal{U}) - x_3 \frac{\partial^2 \mathcal{U}_3}{\partial x_1 \partial x_2} & e_{22}(\mathcal{U}) - x_3 \frac{\partial^2 \mathcal{U}_3}{\partial x_2^2} & 0 \\ 0 & 0 & 0 \end{pmatrix}.$$

Since U_{KL} is a affine function with respect to x_3 , the estimate $(4.2)_{1,2}$ and the fact that $\mathfrak{u} = u - U_{KL}$ lead to $(4.2)_3$. The proof of (4.3) is postponed in Subsection 8.2 of the Appendix.

If the plate is clamped on Γ_{δ} then we have the following Korn's type inequalities.

Proposition 4.1. Let u be a displacement in $W^{1,p}(\Omega_{\delta})$, $1 . Assume the plate clamped on <math>\Gamma_{\delta}$. Then, we have

The constants do not depend on δ .

Proof. Estimates (4.4) are the consequences of the decomposition (4.1) of u and the estimates (4.2)-(4.3).

From now on, in Sections 5 and 6, every $u \in W^{1,p}(\Omega_{\delta})^3$ will be decomposed as the sum of a Kirchhoff-Love displacement and a residual displacement.

5 Asymptotic behavior of a sequence of displacements

The set of admissible displacements is denoted \mathbb{D}_{δ}

$$\mathbb{D}_{\delta} \doteq \left\{ u \in H^1(\Omega_{\delta})^3 \mid u = 0 \text{ on } \Gamma_{\delta} \right\}. \tag{5.1}$$

We rescale Ω_{δ} to Ω in the \mathbf{e}_3 direction. We set

$$\Omega \doteq \left\{ (x', X_3) \in \omega \times \mathbb{R} \mid -C_0 < X_3 < \phi(x') \right\},$$

$$\Omega_1 \doteq \omega \times (-C_0, C_1), \qquad \Omega \subset \Omega_1.$$

We denote

$$\Xi_{\varepsilon} \doteq \Big\{ \xi \in \mathbb{Z}^2 \mid \varepsilon(\xi + Y) \subset \omega \Big\}, \qquad \widehat{\omega}_{\varepsilon} \doteq \operatorname{Interior} \Big(\bigcup_{\xi \in \Xi_{\varepsilon}} \varepsilon(\xi + \overline{Y}) \Big), \qquad \Lambda_{\varepsilon} \doteq \omega \setminus \overline{\widehat{\omega}_{\varepsilon}}.$$

Definition 5.1 (The dimension reduction operator Π_{δ}). For every measurable function ψ on Ω_{δ} , we define the measurable function $\Pi_{\delta}(\psi)$ on Ω as follows:

$$\Pi_{\delta}(\psi)(x', X_3) = \psi(x', \delta X_3)$$
 for a.e. $(x', X_3) \in \Omega$.

For every $f \in L^1(\Omega_{\delta})$ and $g \in L^2(\Omega_{\delta})$, one has

$$\int_{\Omega_{\delta}} f \, dx = \delta \int_{\Omega} \Pi_{\delta}(f) \, dx' dX_3, \qquad \|\Pi_{\delta}(g)\|_{L^2(\Omega)} = \frac{1}{\delta^{1/2}} \|g\|_{L^p(\Omega_{\delta})}.$$

Moreover, if $f \in H^1(\Omega_\delta)$, one has $(\alpha \in \{1, 2\})$

We recall below the definition of the classical unfolding operator (see [16, Chapter 1]).

Definition 5.2 (The unfolding operator $\mathcal{T}_{\varepsilon}$). For every measurable function g on ω , we define the measurable function $\mathcal{T}_{\varepsilon}(g)$ on $\omega \times Y$ as follows:

¹For $x' \in \mathbb{R}^2$, $[x'] \in \mathbb{Z}^2$ is the integer par of x'.

The unfolding operator with parameters will also be denoted $\mathcal{T}_{\varepsilon}$.

Definition 5.3. For every measurable function ψ on Ω_1 , we define the measurable function $\mathcal{T}_{\varepsilon}(\psi)$ on $\omega \times \mathcal{Y}$ as follows:

Regarding the properties of the unfolding operator $\mathcal{T}_{\varepsilon}$ with or without parameters, we refer the reader to [16, Subsections 1.1 and 1.5].

We will denote $\mathfrak{T}_{\varepsilon\delta} = \dot{\mathcal{T}_{\varepsilon}} \circ \Pi_{\delta}$ the dimension reduction and unfolding operator which acts on measurable function on Ω_{δ} .

Note that if ψ does not depend on x_3 then $\mathfrak{T}_{\varepsilon\delta}(\psi) = \mathcal{T}_{\varepsilon}(\psi)$.

5.1 First case: only dimension reduction

$$\begin{split} &H^1_{\gamma}(\omega) \doteq \big\{\varphi \in H^1(\omega) \mid \varphi = 0 \text{ a.e. on } \gamma\big\}, \\ &H^2_{\gamma}(\omega) \doteq \big\{\varphi \in H^2(\omega) \mid \varphi = 0 \text{ and } \nabla\varphi = 0 \text{ a.e. on } \gamma\big\}, \\ &\mathbb{D}_M(\omega) \doteq H^1_{\gamma}(\omega)^2 \times H^2_{\gamma}(\omega), \\ &\mathbb{W}(\Omega) \doteq \Big\{\Phi \in L^2(\Omega)^3 \mid \frac{\partial\Phi}{\partial X_0} \in L^2(\Omega)^3\big\}. \end{split}$$

We equip $\mathbb{W}(\Omega)$ with the norm

The following theorem is proved in [21].

Theorem 5.1 (Theorem 4.2 in [21]). Let $\{u_{\delta}\}_{\delta}$ be a sequence of displacements belonging to \mathbb{D}_{δ} and satisfying $\|e(u_{\delta})\|_{L^{2}(\Omega_{\delta})} \leq C\delta^{5/2}$.

There exist a subsequence of $\{\delta\}$, still denoted $\{\delta\}$, and functions $\mathcal{U} = (\mathcal{U}_1, \mathcal{U}_2, \mathcal{U}_3) \in \mathbb{D}_M(\omega)$ and $\mathfrak{U} \in \mathbb{W}(\Omega)$ such that

Now, we can give the limit of the rescaled strain tensor of the sequence $\{u_{\delta}\}_{\delta}$. As a consequence of Theorem 5.1 we have

e_{11}(\Pi_{\delta}(\mathfrak{u}_{\delta})) & e_{12}(\Pi_{\delta}(\mathfrak{u}_{\delta})) & \frac{1}{2} \left(\frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial x_{1}} + \frac{1}{\delta} \frac{\partial \Pi_{\delta}(\mathfrak{u}_{1,\delta})}{\partial X_{3}}\right) \\
e_{12}(\Pi_{\delta}(\mathfrak{u}_{\delta})) & e_{22}(\Pi_{\delta}(\mathfrak{u}_{\delta})) & \frac{1}{2} \left(\frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial x_{1}} + \frac{1}{\delta} \frac{\partial \Pi_{\delta}(\mathfrak{u}_{2,\delta})}{\partial X_{3}}\right) \\
\frac{1}{2} \left(\frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial x_{1}} + \frac{1}{\delta} \frac{\partial \Pi_{\delta}(\mathfrak{u}_{1,\delta})}{\partial X_{3}}\right) & \frac{1}{2} \left(\frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial x_{1}} + \frac{1}{\delta} \frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial X_{3}}\right) & \frac{1}{\delta} \frac{\partial \Pi_{\delta}(\mathfrak{u}_{\delta,3})}{\partial X_{3}}

5.2 Second case: dimension reduction and homogenization simultaneously

We decompose $u_{\varepsilon,\delta}$ as (4.1). Then, we extend the displacement $\mathfrak{u}_{\varepsilon,\delta}$ using the extension operator \mathcal{P}_{δ} (see Lemma 8.2 in Appendix). The extended displacement $\mathcal{P}_{\delta}(\mathfrak{u}_{\varepsilon,\delta})$ will be still denoted $\mathfrak{u}_{\varepsilon,\delta}$. Due to Lemma 8.2 in Appendix, the estimates (5.3)_{2.3} and the properties of the reduction of dimension and unfolding operators, we have

and \mathfrak{V} is 1-periodic with respect to X_1 and X_2 .

We endow $\mathbb{W}(\Omega)$ with the norm

$$\forall \mathfrak{V} \in \mathbb{W}(\mathbf{\Omega}), \qquad \|\mathfrak{V}\|_{\mathbb{W}(\mathbf{\Omega})} = \sqrt{\|\mathfrak{V}\|_{L^2(\mathbf{\Omega})}^2 + \|\nabla_X \mathfrak{V}\|_{L^2(\mathbf{\Omega})}^2}.$$

For every $\mathfrak{V} \in \mathbb{W}(\Omega)$, we define the 3×3 symmetric tensor $E_w^{\theta}(\mathfrak{V}) \in L^2(\Omega)^{3 \times 3}$ by

 $\mathcal{M}(\mathfrak{V})$ belongs to $L^2(\omega)^3$, the measure of $\mathcal{Y}_{x'}$ is $\phi(x') + C_0$. The operator \mathcal{M} is continuous and linear from $\mathbb{W}(\Omega)$ into $L^2(\omega)^3$.

\frac{1}{\delta}\mathfrak{T}_{\varepsilon\delta}(u_{\varepsilon,\delta,3}) \longrightarrow \mathcal{U}_{3} \quad strongly \ in \ L^{2}(\omega; H^{1}(\mathcal{Y})).$$

$$\delta\mathfrak{T}_{\varepsilon\delta}\left(\frac{1}{\delta^{3}}\frac{\partial\mathfrak{u}_{\varepsilon,\delta}}{\partial x_{3}}\right) = \frac{\partial}{\partial X_{3}}\mathfrak{T}_{\varepsilon\delta}\left(\frac{1}{\delta^{3}}\mathfrak{u}_{\varepsilon,\delta}\right) \rightharpoonup \frac{\partial\mathring{\mathfrak{U}}}{\partial X_{3}} \quad \text{weakly in} \quad L^{2}(\omega \times \mathcal{Y})^{3}.$$
(5.16)

Now, we have

$$\begin{split} \mathfrak{T}_{\varepsilon\delta} \Big(e(u_{\varepsilon,\delta}) \Big) &= \begin{pmatrix} e_{11}(\mathcal{U}_{\varepsilon,\delta}) - X_3 \, \delta \frac{\partial^2 \mathcal{U}_{\delta,3}}{\partial x_1^2} & e_{12}(\mathcal{U}_{\varepsilon,\delta}) - X_3 \, \delta \frac{\partial^2 \mathcal{U}_{\delta,3}}{\partial x_1 \partial x_2} & 0 \\ e_{12}(\mathcal{U}_{\varepsilon,\delta}) - X_3 \, \delta \frac{\partial^2 \mathcal{U}_{\delta,3}}{\partial x_1 \partial x_2} & e_{22}(\mathcal{U}_{\varepsilon,\delta}) - X_3 \, \delta \frac{\partial^2 \mathcal{U}_{\delta,3}}{\partial x_2^2} & 0 \\ 0 & 0 & 0 \end{pmatrix} \\ &+ \begin{pmatrix} \frac{1}{2\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,1})}{\partial X_1} & \frac{1}{2\varepsilon} \Big(\frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,2})}{\partial X_1} + \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,1})}{\partial X_2} \Big) & \frac{1}{2} \Big(\frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_1} + \frac{1}{\delta} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,1})}{\partial X_3} \Big) \\ \frac{1}{2\varepsilon} \Big(\frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_1} + \frac{1}{\delta} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,2})}{\partial X_3} \Big) & \frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,2})}{\partial X_2} & \frac{1}{\varepsilon} \Big(\frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_3} + \frac{1}{\delta} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_3} \Big) \\ \frac{1}{2} \Big(\frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_1} + \frac{1}{\delta} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_3} \Big) & \frac{1}{2} \Big(\frac{1}{\varepsilon} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_1} + \frac{1}{\delta} \frac{\partial \mathfrak{T}_{\varepsilon\delta} (\mathfrak{u}_{\varepsilon,\delta,3})}{\partial X_3} \Big) \\ \end{pmatrix}. \end{split}$$

$$\begin{split} \frac{1}{\delta^2} \mathfrak{T}_{\varepsilon\delta} \big(e(u_{\varepsilon,\delta}) \big) &\rightharpoonup E_M(\mathcal{U}) + \begin{pmatrix} e_{11,X'}(\widehat{\mathcal{U}}_m) - X_3 \, \frac{\partial^2 \widehat{\mathcal{U}}_3}{\partial X_1^2} & e_{12,X'}(\widehat{\mathcal{U}}_m) - X_3 \, \frac{\partial^2 \widehat{\mathcal{U}}_3}{\partial X_1 \partial X_2} & 0) \\ e_{12,X'}(\widehat{\mathcal{U}}_m) - X_3 \, \frac{\partial^2 \widehat{\mathcal{U}}_3}{\partial X_1 \partial X_2} & e_{22,X'}(\widehat{\mathcal{U}}_m) - X_3 \, \frac{\partial^2 \widehat{\mathcal{U}}_3}{\partial X_2^2} & 0 \\ 0 & 0 & 0 \end{pmatrix} \\ &+ \frac{1}{\theta} \begin{pmatrix} \frac{\partial \mathring{\mathfrak{U}}_1}{\partial X_1} & * & * \\ \frac{1}{2} \Big(\frac{\partial \mathring{\mathfrak{U}}_2}{\partial X_1} + \frac{\partial \mathring{\mathfrak{U}}_1}{\partial X_2} \Big) & \frac{\partial \mathring{\mathfrak{U}}_2}{\partial X_2} & * \\ \frac{1}{2} \Big(\frac{\partial \mathring{\mathfrak{U}}_3}{\partial X_1} + \theta \, \frac{\partial \mathring{\mathfrak{U}}_1}{\partial X_3} \Big) & \frac{1}{2} \Big(\frac{\partial \mathring{\mathfrak{U}}_3}{\partial X_2} + \theta \, \frac{\partial \mathring{\mathfrak{U}}_2}{\partial X_3} \Big) & \theta \, \frac{\partial \mathring{\mathfrak{U}}_3}{\partial X_3} \end{pmatrix} \quad \text{weakly in } L^2(\omega \times \mathcal{Y})^{3 \times 3}. \end{split}$$

where
$$e_{\alpha\beta,X'}(\widehat{\mathcal{U}}_m) = \frac{1}{2} \left(\frac{\partial \widehat{\mathcal{U}}_{\alpha}}{\partial X_{\beta}} + \frac{\partial \widehat{\mathcal{U}}_{\beta}}{\partial X_{\alpha}} \right)$$
. Set

$$\widehat{\mathfrak{U}} = \left(\widehat{\mathcal{U}}_1 - X_3 \frac{\partial \widehat{\mathcal{U}}_3}{\partial X_1}\right) \mathbf{e}_1 + \left(\widehat{\mathcal{U}}_2 - X_3 \frac{\partial \widehat{\mathcal{U}}_3}{\partial X_2}\right) \mathbf{e}_2 + \theta \widehat{\mathcal{U}}_3 \mathbf{e}_3 + \frac{1}{\theta} (\mathring{\mathfrak{U}} - \mathcal{M}(\mathring{\mathfrak{U}})).$$

Observe that $\mathcal{M}(\widehat{\mathfrak{U}}) = 0$ a.e. in ω . This leads to (5.14). Convergences (5.13) are the consequences of (5.12) and the properties of $\mathfrak{T}_{\varepsilon\delta}$.

Lemma 5.2. For every function $\widehat{\mathfrak{D}} \in \mathbb{W}(\Omega)$, one has $(\alpha \in \{1, 2\})$

\theta \le 1, & \|\frac{\partial\widehat{\mathfrak{V}}}{\partial X_{\alpha}}\|_{L^{2}(\Omega)} + \theta \|\frac{\partial\widehat{\mathfrak{V}}}{\partial X_{3}}\|_{L^{2}(\Omega)} \le C \|E_{w}^{\theta}(\widehat{\mathfrak{V}})\|_{L^{2}(\Omega)}.
\end{cases} (5.17)$$

The constant does not depend on θ .

Proof. Consider the domains $\mathcal{Y}_{x'}$, $x' \in \omega$. Note that

$$Y \times (-C_0, C_0) \subset \mathcal{Y}_{x'} \subset Y \times (-C_0, C_1) \qquad \forall x' \in \omega.$$

Proceeding as in [16, Chapter 11] we obtain that for every $\psi \in H^1_{ner}(\mathcal{Y}_{x'})^3$ $(\alpha \in \{1,2\})$

\theta \ge 1, & \left\| \nabla_X \psi_{\alpha} \right\|_{L^2(\mathcal{Y}_{x'})} + \frac{1}{\theta} \left\| \frac{\partial \psi_3}{\partial X_{\alpha}} \right\|_{L^2(\mathcal{Y}_{x'})} + \theta \left\| \frac{\partial \psi_3}{\partial X_3} \right\|_{L^2(\mathcal{Y}_{x'})} \le C \left\| E_w^{\theta}(\psi) \right\|_{L^2(\mathcal{Y}_{x'})}, \\
\theta \le 1, & \left\| \frac{\partial \psi}{\partial X_{\alpha}} \right\|_{L^2(\mathcal{Y}_{x'})} + \theta \left\| \frac{\partial \psi}{\partial X_3} \right\|_{L^2(\mathcal{Y}_{x'})} \le C \left\| E_w^{\theta}(\psi) \right\|_{L^2(\mathcal{Y}(x'))}
\end{cases} (5.18)$$

where $H_{per}^1(\mathcal{Y}_{x'})^3$ is the subspace of $H^1(\mathcal{Y}_{x'})^3$ containing the periodic functions with respect to X_1 and X_2 . The constant C does not depend on θ and x'.

Now, let $\widehat{\mathfrak{D}}$ be in $\mathbb{W}(\Omega) \cap \mathcal{C}^1(\overline{\omega} \times \overline{\mathcal{Y}})^3$. We apply the above result to the function $\widehat{\mathfrak{D}}(x', \cdot) \in H^1_{per}(\mathcal{Y}_{x'})^3$. This leads to (5.17). Then, a density argument gives the result for every function in $\mathbb{W}(\Omega)$.

Corollary 5.1. For every $\theta \in (0, +\infty)$ and for every $\psi \in H^1_{per}(\mathcal{Y}_{x'})^3$ we have

Lemma 5.3. There exist two strictly positive constants c and C, independent of θ , such that for every $\mathcal{V} = (\mathcal{V}_m, \mathcal{V}_3) \in H^1(\omega)^2 \times H^2(\omega)$ and $\widehat{\mathfrak{V}} \in \mathbb{W}(\Omega)$ satisfying $\mathcal{M}(\widehat{\mathfrak{V}}) = 0$ a.e. in ω , we have

$$c\left(\|\mathcal{V}_{m}\|_{H^{1}(\omega)} + \|\mathcal{V}_{3}\|_{H^{2}(\omega)} + \frac{\theta}{1+\theta^{2}}\|\widehat{\mathfrak{D}}\|_{\mathbb{W}(\Omega)}\right) \leq \|E_{M}(\mathcal{V}) + E_{w}^{\theta}(\widehat{\mathfrak{D}})\|_{L^{2}(\Omega)}$$

$$\leq C\left(\|\mathcal{V}_{m}\|_{H^{1}(\omega)} + \|\mathcal{V}_{3}\|_{H^{2}(\omega)} + (1+\theta)\|\widehat{\mathfrak{D}}\|_{H^{1}(\Omega)}\right).$$
(5.20)

Proof. First, due to the periodicity of the fields $\widehat{\mathfrak{D}}_m$ and $\widehat{\mathfrak{D}}_3$, we have

$$||E_M(\mathcal{V}) + E_w^{\theta}(\widehat{\mathfrak{D}})||_{L^2(\Omega)}^2 = ||E_M(\mathcal{V})||_{L^2(\Omega)}^2 + ||E_w^{\theta}(\widehat{\mathfrak{D}})||_{L^2(\Omega)}^2.$$

Then, since the components of $E_M(\mathcal{V})$ are affine functions with respect to X_3 , there exist two strictly positive constants c_M and C_M such that

$$c_{M} \sum_{\alpha,\beta=1}^{2} \left(\|e_{\alpha\beta}(\mathcal{V}_{m}\|_{L^{2}(\omega)}^{2} + \left\| \frac{\partial^{2}\mathcal{V}_{3}}{\partial x_{\alpha}\partial x_{\beta}} \right\|_{L^{2}(\omega)}^{2} \right)$$

$$\leq \|E_{M}(\mathcal{V})\|_{L^{2}(\Omega)}^{2} \leq C_{M} \sum_{\alpha=1}^{2} \left(\|e_{\alpha\beta}(\mathcal{V}_{m}\|_{L^{2}(\omega)}^{2} + \left\| \frac{\partial^{2}\mathcal{V}_{3}}{\partial x_{\alpha}\partial x_{\beta}} \right\|_{L^{2}(\omega)}^{2} \right).$$

Then, the boundary conditions together with the Poincaré inequality yield

$$c(\|\mathcal{V}_m\|_{H^1(\omega)} + \|\mathcal{V}_3|_{H^2(\omega)}) \le \|E_M(\mathcal{V})\|_{L^2(\Omega)} \le C(\|\mathcal{V}_m\|_{H^1(\omega)} + \|\mathcal{V}_3|_{H^2(\omega)}).$$

From the definition of the matrix $E_w^{\theta}(\widehat{\mathfrak{D}})$, there exists a constant C_w independent of θ such that

Observe that for every $x' \in \omega$, the domains $\mathcal{Y}_{x'}$ are star-shaped with respect to balls whose radii are $\inf\{1/2, 2C_0\}$ and have a diameter less than $2+2C_1$. Hence, [13, Proposition 2.2] gives the following Poincaré-Wirtinger inequality

$$\|\widehat{\mathfrak{D}}(x',\cdot)-\mathcal{M}(\widehat{\mathfrak{D}})(x')\|_{L^2(\mathcal{Y}_{x'})} \le C\|\nabla_X\widehat{\mathfrak{D}}(x',\cdot)\|_{L^2(\mathcal{Y}_{x'})}.$$
 for a.e. $x'\in\omega$

where the constant does not depend on $x' \in \omega$.

Thus

$$\frac{\theta}{1+\theta^2} \|\widehat{\mathfrak{V}}\|_{\mathbb{W}(\mathbf{\Omega})} \le C \|E_w^{\theta}(\widehat{\mathfrak{V}})\|_{L^2(\mathbf{\Omega})}.$$

Finally we obtain (5.20).

6 The linear elasticity problem in Ω_{δ}

For $1 \leq i, j, k, l \leq 3$, let a_{ijkl} be in $L^{\infty}(\mathcal{Y})$ and satisfy the symmetry conditions

$$a_{ijkl}(X) = a_{jikl}(X) = a_{klij}(X)$$
 for a.e. $X \in \mathcal{Y}$,

as well as the coercivity condition

$$a_{ijkl}\tau_{ij}\tau_{kl} \ge c_0 \tau_{ij}\tau_{ij}$$
 a.e. in \mathcal{Y} (6.1)

for every symmetric matrix $\tau = (\tau_{ij})$ of order 3, where c_0 is a strictly positive constant.

The coefficients $a_{ijkl}^{\varepsilon,\delta}$ of the Hooke tensor are then given by

$$a_{ijkl}^{\varepsilon,\delta}(x) = a_{ijkl}\left(\left\{\frac{x'}{\varepsilon}\right\}, \frac{x_3}{\delta}\right)$$
 for a.e. $x \in \Omega_{\delta}$

where $\{x'\}$ is the fractional part of x'^2 .

The constitutive law of the materials is the relation between the strain tensor and the stress tensor,

$$\sigma_{ij}^{\varepsilon,\delta}(v) = a_{ijkl}^{\varepsilon,\delta} e_{kl}(v), \qquad \forall v \in \mathbb{D}_{\delta}. \tag{6.2}$$

For simplicity, we consider only applied body forces f_{δ} .

The displacement $u_{\varepsilon,\delta} \in \mathbb{D}_{\delta}$ is the solution of the following elasticity problem:

We make the assumption that the applied body forces f_{δ} are of the form

where $f = (f_1, f_2, f_3)$ is in $L^2(\omega)^3$ and $g = (g_1, g_2)$ in $L^2(\omega)^2$.

Now, for every $u \in \mathbb{D}_{\delta}$ decompose as (4.1) one has

$$\begin{split} \int_{\Omega_{\delta}} f_{\delta} \cdot U_{KL} \, dx &= \delta^3 \int_{\omega} f_{\alpha} \, \mathcal{U}_{\alpha} \, (\phi + C_0) dx' - \frac{\delta^4}{3} \int_{\omega} g_{\alpha} \frac{\partial \mathcal{U}_3}{\partial x_{\alpha}} \, (\phi^3 + C_0^3) dx' \\ &+ \frac{\delta^3}{2} \int_{\omega} g_{\alpha} \, \mathcal{U}_{\alpha} \, (\phi^2 - C_0^2) dx' - \frac{\delta^4}{2} \int_{\omega} f_{\alpha} \frac{\partial \mathcal{U}_3}{\partial x_{\alpha}} \, (\phi^2 - C_0^2) dx' \\ &+ \delta^4 \int_{\omega} f_3 \, \mathcal{U}_3 \, (\phi + C_0) dx', \\ \left| \int_{\Omega_{\delta}} f_{\delta} \cdot \mathfrak{u} \, dx \right| \leq C \delta^3 \big(\|f\|_{L^2(\omega)} + \|g\|_{L^2(\omega)} \big) \|e(u)\|_{L^2(\Omega_{\delta})}. \end{split}$$

²Remind that for a.e. $x' \in \mathbb{R}^2$, we have $x' = [x'] + \{x'\}$ with $[x'] \in \mathbb{Z}^2$ and $\{x'\} \in \mathbb{Y}$.

From the estimates (3.5) and those above, we obtain an upper bound of the right-hand side of (6.3)

$$\begin{split} &\frac{1}{\delta^2}\mathcal{U}_{\varepsilon,\delta,\alpha}\longrightarrow\mathcal{U}^{\theta}_{\alpha} \quad strongly \ in \ H^1_{\gamma}(\omega), \\ &\frac{1}{\delta}\mathcal{U}_{\varepsilon,\delta,3} \rightharpoonup \mathcal{U}^{\theta}_{3} \quad weakly \ in \ H^2(\omega) \quad and \ strongly \ in \ H^1(\omega), \\ &\frac{1}{\delta^2}\mathfrak{T}_{\varepsilon\delta}(u_{\varepsilon,\delta,\alpha}) \longrightarrow \mathcal{U}^{\theta}_{\alpha} - X_3 \frac{\partial \mathcal{U}^{\theta}_{3}}{\partial x_{\alpha}} \quad strongly \ in \ L^2(\omega; H^1(\mathcal{Y})), \\ &\frac{1}{\delta}\mathfrak{T}_{\varepsilon\delta}(u_{\varepsilon,\delta,3}) \longrightarrow \mathcal{U}^{\theta}_{3} \quad strongly \ in \ L^2(\omega; H^1(\mathcal{Y})) \end{split}$$

$$(6.6)$$

and

$$\frac{1}{\delta^2} \mathfrak{T}_{\varepsilon \delta} \left(e(u_{\varepsilon,\delta}) \right) \longrightarrow E_M(\mathcal{U}^{\theta}) + E_w^{\theta} (\widehat{\mathfrak{U}}^{\theta}) \quad strongly \quad in \quad L^2(\mathbf{\Omega})^{3 \times 3}. \tag{6.7}$$

The pair $(\mathcal{U}^{\theta}, \widehat{\mathfrak{U}}^{\theta}) \in \mathbb{D}_{M}(\omega) \times \mathbb{W}(\Omega)$ is the unique solution to

+ \frac{1}{2} \int_{\omega} \left(g_{\alpha} \mathcal{V}_{\alpha} - f_{\alpha} \frac{\partial \mathcal{V}_{3}}{\partial x_{\alpha}} \right) (\phi^{2} - C_{0}^{2}) dx' \qquad \forall (\mathcal{V}, \widehat{\mathfrak{V}}) \in \mathbb{D}_{M}(\omega) \times \mathbb{W}(\Omega).
\end{cases} (6.8)$$

The solution to the above problem satisfies the following estimate:

$$\|\mathcal{U}_{m}^{\theta}\|_{H^{1}(\omega)} + \|\mathcal{U}_{3}^{\theta}\|_{H^{2}(\omega)} + \frac{\theta}{1+\theta^{2}} \|\widehat{\mathfrak{U}}^{\theta}\|_{\mathbb{W}(\Omega)} \le C(\|f\|_{L^{2}(\omega)} + \|g\|_{L^{2}(\omega)}). \tag{6.9}$$

The constant C does not depend on θ .

Proof. Step 1. First of all, the convergences.

Taking $v_{\varepsilon,\delta}$ as test displacement in (6.3), then transforming with $\mathfrak{T}_{\varepsilon\delta}$ and passing to the limit using the convergences (5.14) and those above regarding the test displacement lead to (6.8) with the pair $(\mathcal{V}, \widehat{\mathfrak{V}})$.

Then, since the space of the fields $\widehat{\mathfrak{V}}$ in $H^1(\omega \times \mathcal{Y})^3 \cap \mathbb{W}(\Omega)$ such that $\widehat{\mathfrak{V}} = 0$ on $\gamma \times \mathcal{Y}$ is dense in $\mathbb{W}(\Omega)$, problem (6.8) is satisfied for every $\widehat{\mathfrak{V}}$ in $\mathbb{W}(\Omega)$.

Step 3. Uniqueness of the solution of problem (6.8).

$$A_{\alpha\beta\alpha'\beta'}^{mb,\theta} = \int_{\mathcal{Y}_{x'}} a_{ijkl} \left(\mathbf{M}_{ij}^{\alpha\beta} + E_{w,ij}^{\theta}(\chi_{m,\theta}^{\alpha\beta}) \right) \left(X_3 \mathbf{M}_{kl}^{\alpha'\beta'} + E_{w,kl}^{\theta}(\chi_{b,\theta}^{\alpha'\beta'}) \right) dX,$$

$$(6.19)$$

Observe that due to the symmetry conditions of the a_{ijkl} 's, one has

$$\int_{\mathcal{Y}_{x'}} a_{ijkl} \left(\mathbf{M}_{ij}^{\alpha\beta} + E_{w,ij}^{\theta}(\chi_{m,\theta}^{\alpha\beta}) \right) \left(X_3 \mathbf{M}_{kl}^{\alpha'\beta'} + E_{w,kl}^{\theta}(\chi_{b,\theta}^{\alpha'\beta'}) \right) dX \\
= \int_{\mathcal{Y}_{x'}} a_{ijkl} \left(X_3 \mathbf{M}_{ij}^{\alpha\beta,\theta} + E_{w,ij}^{\theta}(\chi_{b,\theta}^{\alpha\beta}) \right) \left(\mathbf{M}_{kl}^{\alpha'\beta'} + E_{w,kl}^{\theta}(\chi_{m,\theta}^{\alpha'\beta'}) \right) dX.$$

Proof of Theorem 6.2. In (6.8), we choose as test displacements $\mathcal{V} \in \mathbb{D}_M(\omega)$ and

$$\widehat{\mathfrak{V}} = \chi_{m,\theta}^{\alpha\beta} e_{\alpha\beta}(\mathcal{V}) - \chi_{b,\theta}^{\alpha\beta} \frac{\partial^2 \mathcal{V}_3}{\partial x_{\alpha} \partial x_{\beta}}.$$

Then, we replace $\widehat{\mathfrak{A}}^{\theta}$ by its value given by (6.14). That gives (6.18). As usual, thanks to (6.1) and the expressions (6.19) of the bilinear form in the left-hand side of (6.18), we get the coercivity and continuity of this bilinear form. Hence, we have the existence and unicity of the solution to (6.18).

As a consequence of the estimates (6.13), the coefficients $A^{m,\theta}_{\alpha\beta\alpha'\beta'}$, $A^{b,\theta}_{\alpha\beta\alpha'\beta'}$ and $A^{mb,\theta}_{\alpha\beta\alpha'\beta'}$ belong to $L^{\infty}(\omega)$. More precisely, we have

Lemma 6.1. As functions of the variables (ϑ, x') , all the coefficients $A^{m,\theta}_{\alpha\beta\alpha'\beta'}$, $A^{b,\theta}_{\alpha\beta\alpha'\beta'}$ and $A^{mb,\theta}_{\alpha\beta\alpha'\beta'}$ belong to $L^{\infty}((0,+\infty)\times\omega)$. Moreover, for a.e. $x'\in\omega$ the functions $\theta\longmapsto A^{m,\theta}_{\alpha\beta\alpha'\beta'}(x')$, $\theta\longmapsto A^{b,\theta}_{\alpha\beta\alpha'\beta'}$ and $\theta\longmapsto A^{mb,\theta}_{\alpha\beta\alpha'\beta'}$ are Lipschitz continuous on every segment included in $(0,+\infty)$.

Proof. First, observe that

$$A^{m,\theta}_{\alpha\beta\alpha'\beta'}(x') = \int_{\mathbf{V}} \overline{a_{ijkl}}(x',\overline{X}) \left(\mathbf{M}^{\alpha\beta}_{ij} + \mathcal{E}^{\vartheta}_{w,ij} (\overline{\chi^{\alpha\beta}_{m,\vartheta}})(x',\overline{X}) \right) \left(\mathbf{M}^{\alpha'\beta'}_{kl} + \mathcal{E}^{\vartheta}_{w,kl} (\overline{\chi^{\alpha'\beta'}_{m,\vartheta}})(x',\overline{X}) \right) d\overline{X}.$$

We have similar equalities for the other coefficients. We have

$$\mathcal{E}_{w}^{\vartheta}(\overline{\mathfrak{W}}) - \mathcal{E}_{w}^{\vartheta'}(\overline{\mathfrak{W}}) = \frac{\vartheta - \vartheta'}{2} \begin{pmatrix} 0 & 0 & \frac{\partial \overline{\mathfrak{W}}_{1}}{\partial X_{3}'} \\ 0 & 0 & \frac{\partial \overline{\mathfrak{W}}_{2}}{\partial X_{3}'} \\ \frac{\partial \overline{\mathfrak{W}}_{1}}{\partial X_{3}'} & \frac{\partial \overline{\mathfrak{W}}_{2}}{\partial X_{3}'} & 2\frac{\partial \overline{\mathfrak{W}}_{3}}{\partial X_{3}'} \end{pmatrix} \qquad \forall \overline{\mathfrak{W}} \in H_{per}^{1}(\boldsymbol{\mathcal{Y}})^{3}.$$

$$(6.20)$$

Now, starting from $(6.15)_1$ and taking into account the above equality (6.20) and (5.19), for a.e. $x' \in \omega$ we obtain

$$\begin{split} &\int_{\boldsymbol{\mathcal{Y}}} \overline{a_{ijkl}}(x',\cdot)\,\mathcal{E}_{w,ij}^{\vartheta}\left(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}}\right)(x',\cdot)\,\mathcal{E}_{w,kl}^{\vartheta}(\overline{\mathfrak{W}})\,d\overline{X} \\ \leq &C|\vartheta - \vartheta'|\Big(\Big\|\mathcal{E}_{w}^{\vartheta'}(\overline{\mathfrak{W}})\Big\|_{L^{2}(\boldsymbol{\mathcal{Y}})}\|\nabla_{\overline{X}}\overline{\chi_{m,\vartheta'}^{\alpha\beta}}(x',\cdot)\|_{L^{2}(\boldsymbol{\mathcal{Y}})} + \|\nabla_{\overline{X}}\overline{\mathfrak{W}}\|_{L^{2}(\boldsymbol{\mathcal{Y}})}\Big(1 + \Big\|\mathcal{E}_{w}^{\vartheta'}(\overline{\chi_{m,\vartheta'}^{\alpha\beta}})(x',\cdot)\|_{L^{2}(\boldsymbol{\mathcal{Y}})}\Big)\Big) \\ \leq &C|\vartheta - \vartheta'|\Big\|\mathcal{E}_{w}^{\vartheta'}(\overline{\mathfrak{W}})\Big\|_{L^{2}(\boldsymbol{\mathcal{Y}})}\Big(\|\nabla_{\overline{X}}\overline{\chi_{m,\vartheta'}^{\alpha\beta}}(x',\cdot)\|_{L^{2}(\boldsymbol{\mathcal{Y}})} + \vartheta' + \frac{1}{\vartheta'} + \Big\|\mathcal{E}_{w}^{\vartheta'}(\overline{\chi_{m,\vartheta'}^{\alpha\beta}})(x',\cdot)\|_{L^{2}(\boldsymbol{\mathcal{Y}})}\Big). \end{split}$$

Now, choose $\overline{\mathfrak{W}} = (\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}})(x',\cdot)$, due to (6.16) and (6.17) this gives

$$\left\| \mathcal{E}_{w}^{\vartheta} \left(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}} \right) (x', \cdot) \right\|_{L^{2}(\mathcal{Y})}^{2} \leq C |\vartheta - \vartheta'| \left\| \mathcal{E}_{w}^{\vartheta'} \left(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}} \right) (x', \cdot) \right\|_{L^{2}(\mathcal{Y})} \left(\vartheta' + \frac{1}{\vartheta'} \right).$$

Similarly we show that

$$\left\|\mathcal{E}_{w}^{\vartheta'}\big(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}}\big)(x',\cdot)\right\|_{L^{2}(\boldsymbol{\mathcal{Y}})}^{2} \leq C|\vartheta - \vartheta'| \left\|\mathcal{E}_{w}^{\vartheta}\big(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}}\big)(x',\cdot)\right\|_{L^{2}(\boldsymbol{\mathcal{Y}})} \left(\vartheta + \frac{1}{\vartheta}\right).$$

Hence

$$\left\| \mathcal{E}_w^{\vartheta} \left(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}} \right) (x', \cdot) \right\|_{L^2(\mathcal{Y})} \le C |\vartheta - \vartheta'| \left(\vartheta + \vartheta' + \frac{1}{\vartheta} + \frac{1}{\vartheta'} \right)$$

and then

$$\left\| \left(\overline{\chi_{m,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}} \right) (x',\cdot) \right\|_{H^1(\mathcal{Y})} \le C |\vartheta - \vartheta'| \left(\vartheta + \vartheta' + \frac{1}{\vartheta} + \frac{1}{\vartheta'} \right)^2.$$

As a consequence, for a.e. $x' \in \omega$ the function $\theta \longmapsto A^{m,\theta}_{\alpha\beta\alpha'\beta'}(x')$ is Lipschitz continuous on every segment included in $(0,+\infty)$. In the same way, we prove that

$$\begin{split} & \left\| \mathcal{E}_{w}^{\vartheta} \big(\overline{\chi_{b,\vartheta}^{\alpha\beta}} - \overline{\chi_{b,\vartheta'}^{\alpha\beta}} \big)(x',\cdot) \right\|_{L^{2}(\boldsymbol{\mathcal{Y}})} \leq C |\vartheta - \vartheta'| \Big(\vartheta + \vartheta' + \frac{1}{\vartheta} + \frac{1}{\vartheta'} \Big), \\ & \left\| \big(\overline{\chi_{b,\vartheta}^{\alpha\beta}} - \overline{\chi_{m,\vartheta'}^{\alpha\beta}} \big)(x',\cdot) \right\|_{H^{1}(\boldsymbol{\mathcal{Y}})} \leq C |\vartheta - \vartheta'| \Big(\vartheta + \vartheta' + \frac{1}{\vartheta} + \frac{1}{\vartheta'} \Big)^{2}. \end{split}$$

So, the functions $\theta \longmapsto A^{b,\theta}_{\alpha\beta\alpha'\beta'}$ and $\theta \longmapsto A^{mb,\theta}_{\alpha\beta\alpha'\beta'}$ are Lipschitz continuous on every segment included in $(0,+\infty)$.

As immediate consequence of the above lemma, we have

Theorem 6.3. The map $\theta \in (0, +\infty) \longmapsto \mathcal{U}^{\theta} \in \mathbb{D}_{M}(\omega)$ is locally Lipschitz continuous for the strong topology of $\mathbb{D}_{M}(\omega)$.

Remark 6.1. As in [16, Chapter 11] we can show that

• the map $\theta \longmapsto \mathcal{U}^{\theta}$ admits a limit $\mathcal{U}^0 \in \mathbb{D}_M(\omega)^3$ when θ goes to 0. This limit corresponds to the case

$$(\varepsilon, \delta) \to (0, 0)$$
 and $\frac{\varepsilon}{\delta} \to 0$.

It can also be obtained if we first homogenize $\varepsilon \to 0$, δ being fixed, and then reduce the dimension $\delta \to 0$.

• the map $\theta \longmapsto \mathcal{U}^{\theta}$ admits a limit $\mathcal{U}^{\infty} \in \mathbb{D}_{M}(\omega)^{4}$ when θ goes to $+\infty$. This limit corresponds to the case

$$(\varepsilon, \delta) \to (0, 0)$$
 and $\frac{\varepsilon}{\delta} \to +\infty$.

It can also be obtained if we first reduce the dimension $\delta \to 0$, ε being fixed, and then homogenize $\varepsilon \to 0$.

6.4 The case of an isotropic and homogeneous material

In this subsection we assume that the plate is made of an isotropic and homogeneous material whose Lamé constants are λ and μ . In this case, one has

$$a_{ijkl} = \lambda \boldsymbol{\delta}_{ij} \boldsymbol{\delta}_{kl} + \mu (\boldsymbol{\delta}_{ik} \boldsymbol{\delta}_{jl} + \boldsymbol{\delta}_{il} \boldsymbol{\delta}_{jk})$$

where the δ_{ij} 's are the Kronecker symbols.

In this subsection, we denote u_{δ} the solution to problem (6.3). We first have the convergences in Theorem 5.1 and Lemma 5.1.

Here, we easily obtain

$$\frac{\partial \mathfrak{U}_1}{\partial X_3} = \frac{\partial \mathfrak{U}_2}{\partial X_3} 2 = 0, \qquad \frac{\partial \mathfrak{U}_3}{\partial X_3} = \frac{\lambda}{\lambda + 2\mu} \Big(- \Big(\frac{\partial \mathcal{U}_1}{\partial x_1} + \frac{\partial \mathcal{U}_2}{\partial x_2} \Big) + X_3 \Delta \mathcal{U}_3 \Big) \qquad \text{a.e. in } \Omega.$$

The following theorem is a consequence of Theorem 6.2 and the values of the a_{ijkl} 's.

Theorem 6.4. The field $\mathcal{U} \in \mathbb{D}_M(\omega)$ is the unique solution to

$$\begin{cases}
\frac{E}{1-\nu^{2}} \int_{\omega} \left[(1-\nu) e_{\alpha\beta}(\mathcal{U}) e_{\alpha\beta}(\mathcal{V}) + \nu e_{\alpha\alpha}(\mathcal{U}) e_{\beta\beta}(\mathcal{V}) \right] (\phi + C_{0}) dx' \\
+ \frac{E}{2(1-\nu^{2})} \int_{\omega} (1-\nu) \left(e_{\alpha\beta}(\mathcal{U}) \frac{\partial^{2} \mathcal{V}_{3}}{\partial x_{\alpha} \partial x_{\beta}} + e_{\alpha\beta}(\mathcal{V}) \frac{\partial^{2} \mathcal{U}_{3}}{\partial x_{\alpha} \partial x_{\beta}} \right) (\phi^{2} - C_{0}^{2}) dx' \\
+ \frac{E}{2(1-\nu^{2})} \int_{\omega} \nu \left(e_{\alpha\alpha}(\mathcal{U}) \Delta \mathcal{V}_{3} + e_{\alpha\alpha}(\mathcal{V}) \Delta \mathcal{U}_{3} \right) (\phi^{2} - C_{0}^{2}) dx' \\
+ \frac{E}{3(1-\nu^{2})} \int_{\omega} \left[(1-\nu) \frac{\partial^{2} \mathcal{U}_{3}}{\partial x_{\alpha} \partial x_{\beta}} \frac{\partial^{2} \mathcal{V}_{3}}{\partial x_{\alpha} \partial x_{\beta}} + \nu \Delta \mathcal{U}_{3} \Delta \mathcal{V}_{3} \right] (\phi^{3} + C_{0}^{3}) dx' \\
= \int_{\omega} f \cdot \mathcal{V} (\phi + C_{0}) dx' - \frac{1}{3} \int_{\omega} g_{\alpha} \frac{\partial \mathcal{V}_{3}}{\partial x_{\alpha}} (\phi^{3} + C_{0}^{3}) dx' \\
+ \frac{1}{2} \int_{\omega} \left(g_{\alpha} \mathcal{V}_{\alpha} - f_{\alpha} \frac{\partial \mathcal{V}_{3}}{\partial x_{\alpha}} \right) (\phi^{2} - C_{0}^{2}) dx', \qquad \forall \mathcal{V} \in \mathbb{D}_{M}(\omega)
\end{cases}$$
(6.21)

where $E = \frac{\mu(3\lambda + 2\mu)}{\lambda + \mu}$ is the Young modulus and $\nu = \frac{\lambda}{2(\lambda + \mu)}$ the Poisson constant.

Moreover, one has

$$\frac{1}{\delta}\Pi_{\delta}(\sigma_{11}(u_{\delta})) \longrightarrow \frac{E}{1-\nu^{2}} \Big[e_{11}(\mathcal{U}) - X_{3} \frac{\partial^{2}\mathcal{U}_{3}}{\partial x_{1}^{2}} + \nu \Big(e_{22}(\mathcal{U}) - X_{3} \frac{\partial^{2}\mathcal{U}_{3}}{\partial x_{2}^{2}} \Big) \Big] \quad strongly \ in \ L^{2}(\Omega),$$

$$\frac{1}{\delta}\Pi_{\delta}(\sigma_{22}(u_{\delta})) \longrightarrow \frac{E}{1-\nu^{2}} \Big[e_{22}(\mathcal{U}) - X_{3} \frac{\partial^{2}\mathcal{U}_{3}}{\partial x_{2}^{2}} + \nu \Big(e_{11}(\mathcal{U}) - X_{3} \frac{\partial^{2}\mathcal{U}_{3}}{\partial x_{1}^{2}} \Big) \Big] \quad strongly \ in \ L^{2}(\Omega),$$

$$\frac{1}{\delta}\Pi_{\delta}(\sigma_{12}(u_{\delta})) \longrightarrow 2\mu \Big[e_{12}(\mathcal{U}) - X_{3} \frac{\partial^{2}\mathcal{U}_{3}}{\partial x_{1} \partial x_{2}} \Big] \quad strongly \ in \ L^{2}(\Omega),$$

$$\frac{1}{\delta}\Pi_{\delta}(\sigma_{i3}(u_{\delta})) \longrightarrow 0 \quad strongly \ in \ L^{2}(\Omega).$$

7 Complement. The case of a plate with a strongly oscillating top surface

Let us consider a function ϕ belonging to $W^{1,\infty}(\omega \times Y)$ such that for a.e. $x' \in \omega$ the map $(X_1, X_2) \mapsto \phi(x', X_1, X_2)$ is 1-periodic with respect to X_1 and X_2 and satisfies

$$|\phi(x', X') - \phi(z', Z')| \le K_0(|x' - z'|_2 + |X' - Z'|_2), \quad \forall (x', X', z', Z') \in (\overline{\omega \times Y})^2,$$

 $\phi(x', X') \ge 2C_0, \quad \forall (x', X') \in \omega \times Y, \quad C_1 = \|\phi\|_{L^{\infty}(\omega \times Y)},$

where $|\cdot|_2$ is the euclidian norm in \mathbb{R}^2 , K_0 and C_0 are strictly positive constants.

Now, the plate whose top surface oscillates strongly is the domain

$$\Omega_{\varepsilon\delta} = \left\{ x = (x_1, x_2, x_3) \in \omega \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta\phi_{\varepsilon}(x_1, x_2) \right\}$$

with

$$\phi_{\varepsilon}(x_1, x_2) = \phi\left(x_1, x_2, \frac{x_1}{\varepsilon}, \frac{x_2}{\varepsilon}\right).$$

Observe that $\Omega_{0,\delta} \subset \Omega_{\varepsilon\delta}$.

As in Section 4, we decompose every displacement u belonging to $W^{1,p}(\Omega_{\varepsilon\delta})^3$ as the sum of a Kirchhoff-Love displacement and a residual displacement

$$u = U_{KL} + \mathfrak{u}.$$

We have

Theorem 7.1. Let u be a displacement in $W^{1,p}(\Omega_{\varepsilon\delta})^3$, $1 , decomposed as the sum of a Kirchhoff-Love displacement and a residual displacement. Assume that there exists a constant <math>C^{\diamond}$ such that

$$\frac{\delta}{\varepsilon} \le C^{\diamond} \quad and \quad \varepsilon \le 1. \tag{7.1}$$

Then, the terms \mathcal{U} and \mathfrak{u} satisfy

$$||e_{\alpha\beta}(\mathcal{U}_{m})||_{L^{p}(\omega)} \leq \frac{C}{\delta^{1/p}} ||e(u)||_{L^{p}(\Omega_{\delta})},$$

$$||D^{2}\mathcal{U}_{3}||_{L^{p}(\omega)} \leq \frac{C}{\delta^{1+1/p}} ||e(u)||_{L^{p}(\Omega_{\delta})},$$

$$||e(\mathfrak{u})||_{L^{p}(\Omega_{\epsilon\delta})} \leq C ||e(u)||_{L^{p}(\Omega_{\epsilon\delta})}$$
(7.2)

and

$$\|\mathfrak{u}\|_{L^{p}(\Omega_{\varepsilon\delta})} \leq C \,\delta \,\|e(u)\|_{L^{p}(\Omega_{\varepsilon\delta})},$$

$$\|\nabla \mathfrak{u}\|_{L^{p}(\Omega_{\varepsilon\delta})} \leq C \|e(u)\|_{L^{p}(\Omega_{\varepsilon\delta})}$$
(7.3)

with a constant C independent of ε and δ .

Proof. The estimates (7.2) are proved in the same way as those of Theorem 4.1.

Now, for simplicity we suppose that the origin O belongs to ω . We transform the plate $\Omega_{\varepsilon\delta}$ by the dilation $x = \varepsilon z$, $z \in \omega_{1/\varepsilon} = 1/\varepsilon\omega$. The new plate is

$$\mathbf{\Omega}_{\varepsilon\delta} = \left\{ z = (z_1, z_2, z_3) \in \omega_{1/\varepsilon} \times \mathbb{R} \mid -\frac{\delta}{\varepsilon} C_0 < z_3 < \frac{\delta}{\varepsilon} \Phi_{\varepsilon}(z_1, z_2) \right\}$$

where

$$\Phi_{\varepsilon}(z') = \phi(\varepsilon z_1, \varepsilon z_2, z_1, z_2) \qquad \forall z' = (z_1, z_2) \in \overline{\omega}_{1/\varepsilon}$$

and satisfies

$$|\Phi_{\varepsilon}(z') - \Phi_{\varepsilon}(t')| \le K_0 \left(\varepsilon |z' - t'|_2 + |z' - t|_2\right) \le 2K_0 |z' - t'|_2, \quad \forall (z', t') \in \omega_{1/\varepsilon}.$$

The plate $\Omega_{\varepsilon\delta}$ has a thickness of order δ/ε , the diameter of the domain $\omega_{1/\varepsilon}$ is of order $1/\varepsilon$. The proof of (7.3) follows the same lines as the proof of (4.3) (see Subsection 8.2 in the Appendix).

The question now is: what happens if we replace the assumptions (7.1) with the following:

$$\lim_{(\delta,\varepsilon)\to(0,0)} \frac{\delta}{\varepsilon} \to \infty ? \tag{7.4}$$

The estimates (7.2) remain valid. The top surface of the plate is now made by small beams. Below we give an example.

Choose $\omega = (0, L)^2$, $\varepsilon > 0$ such that $\frac{L}{\varepsilon} \in \mathbb{N}$. Let ψ be the 1-periodic function defined by

$$\psi(t) = \begin{cases} 3t & \text{if } t \in [0, 1/3], \\ 1 & \text{if } t \in [1/3, 2/3], \\ 3(1-t) & \text{if } t \in [2/3, 1]. \end{cases}$$

We define ϕ_{ε} by

$$\phi_{\varepsilon}(x_1, x_2) = 2C_0 + \psi\left(\frac{x_1}{\varepsilon}\right)\psi\left(\frac{x_2}{\varepsilon}\right), \quad \forall (x_1, x_2) \in \overline{\omega}.$$

Denote

$$\Omega_{\delta}^{d} = \omega \times (-\delta C_0, 2\delta C_0), \qquad \Omega_{\varepsilon\delta}^{u} = \Big\{ x = (x_1, x_2, x_3) \in \omega \times \mathbb{R} \mid 2\delta C_0 < x_3 < \delta\phi_{\varepsilon}(x_1, x_2) \Big\}.$$

Since Ω_{δ}^d is a plate of thickness $3\delta C_0$ we have

$$\|\mathfrak{u}\|_{L^p(\Omega_\delta^d)} \le C \, \delta \, \|e(u)\|_{L^p(\Omega_{\varepsilon\delta})}, \qquad \|\nabla \mathfrak{u}\|_{L^p(\Omega_\delta^d)} \le C \|e(u)\|_{L^p(\Omega_{\varepsilon\delta})}.$$

The constant does not depend on δ . The domain $\Omega^u_{\varepsilon\delta}$ is made of thin beams whose lengths are δ and thickness of order ε . Using the results of [20] we obtain

$$\begin{split} \|\mathfrak{u}_1\|_{L^p(\Omega_{\varepsilon\delta})} + \|\mathfrak{u}_2\|_{L^p(\Omega_{\varepsilon\delta}^u)} &\leq C\frac{\delta^2}{\varepsilon} \|e(u)\|_{L^p(\Omega_{\varepsilon\delta})}, \qquad \|\mathfrak{u}_3\|_{L^p(\Omega_{\varepsilon\delta}^u)} \leq C \|e(u)\|_{L^p(\Omega_{\varepsilon\delta})}, \\ \|\nabla\mathfrak{u}\|_{L^p(\Omega_{\varepsilon\delta}^u)} &\leq C\frac{\delta}{\varepsilon} \|e(u)\|_{L^p(\Omega_{\varepsilon\delta})}. \end{split}$$

The constants do not depend on δ and ε .

8 Appendix

8.1 Simple star-shaped domains

Lemma 8.1. Let $B_{\delta R} \subset \omega$ be a domain of diameter less than $3\delta R$, star-shaped with respect to to the disc $D(O, \delta R_1)$. If $R_1 \leq R \leq \frac{C_0}{2K_0}$ then the domain

$$\mathcal{D}_{\delta R} = \left\{ (x_1, x_2, x_3) \in B_{\delta R} \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta \phi(x_1, x_2) \right\}$$

is star-shaped with respect to the ball $B(O, \delta R'_1)$ where

$$R_1' = \min \{C_0, R_1\}. \tag{8.1}$$

 $\mathcal{D}_{\delta R}$ has a diameter less than $\delta(3R+2C_1)$.

Proof. Let $A = (a_1, a_2, a_3)$ be in $\mathcal{D}_{\delta R}$ such that $a_3 \geq 0$ and $M = (x_1, x_2, \delta \phi(x_1, x_2))$ a point on the top surface. Consider the point A_{λ} of the interval [A, M)

$$A_{\lambda} = (1 - \lambda)A + \lambda M, \qquad \lambda \in [0, 1).$$

One has

$$|\phi(x') - \phi((1-\lambda)a' + \lambda x')| \le K_0(1-\lambda)|x' - a'|_2, \qquad x' = (x_1, x_2), \quad a' = (a_1, a_2).$$

Hence

$$\phi(x') - K_0(1-\lambda)|x'-a'|_2 \le \phi((1-\lambda)a' + \lambda x') \le \phi(x') + K_0(1-\lambda)|x'-a'|_2.$$

The point A_{λ} belongs to $\mathcal{D}_{\delta R}$ if

$$(1 - \lambda)a_3 + \lambda\delta\phi(x') \le \delta\phi((1 - \lambda)a' + \lambda x').$$

A sufficient condition to get $A_{\lambda} \in \mathcal{D}_{\delta R}$, for all $\lambda \in [0, 1)$, is

$$(1 - \lambda)a_3 + \lambda\delta\phi(x') \le \delta\phi(x') - \delta K_0(1 - \lambda)|x' - a'|_2$$

for all $(x', a') \in B_{\delta R} \times B_{\delta R}$. So, the above condition becomes

$$a_3 \le \delta \phi(x') - \delta K_0 |x' - a'|_2, \qquad \forall x' \in B_{\delta R}.$$
 (8.2)

Suppose $a_3 \in [0, \delta C_0]$, we recall that $\phi(x') \geq 2C_0$, hence a sufficient condition is

$$\delta C_0 \leq 2\delta C_0 - 2\delta R K_0$$
.

Condition met.

Obviously, if $a_3 \in [-\delta C_0, 0]$, (8.2) is satisfied. We have proved that any interval [A, M) from a point $A \in B(O, \delta R'_1)$ to a point M on the top surface is included in $\mathcal{D}_{\delta R}$. Similarly, we can prove that any interval [A, M) from a point $A \in B(O, \delta R'_1)$ to a point M on the bottom surface is included in $\mathcal{D}_{\delta R}$. The lemma is proved.

Let f be a function belonging to $W^{1,\infty}(-a_0,a_0)$, $a_0>0$, satisfying

$$|f(t) - f(t')| \le K_1 |t - t'|, \quad \forall (t, t') \in [-a_0, a_0]^2.$$




Figure 1: The two domains $\mathcal{D}_{a,x_0}^{top}$ and $\mathcal{D}_{a,x_0}^{bottom}$.

For every $x_0 \in [-a_0, a_0]$ and $a \in (0, 2a_0)$ such that $-a_0 \le x_0 < x_0 + a \le a_0$, the domains $\mathcal{D}_{a, x_0}^{top}$ and $\mathcal{D}_{a, x_0}^{bottom}$ (see Figure 1) defined by

$$\mathcal{D}_{a,x_0}^{top} \doteq \left\{ (x_1, x_2) \in \mathbb{R}^2 \mid x_0 < x_1 < x_0 + a, \quad f(x_0) - (2K_1 + 1)a < x_2 < f(x_1) \right\},$$

$$\mathcal{D}_{a,x_0}^{bottom} \doteq \left\{ (x_1, x_2) \in \mathbb{R}^2 \mid x_0 < x_1 < x_0 + a, \quad f(x_1) < x_2 < f(x_0) + (2K_1 + 1)a \right\},$$

$$(8.3)$$

are star-shaped with respect to balls of radius a/2 (or less) and have a diameter less than $(3K_1 + 2)a$.

8.2 Proof of (4.3)

8.2.1 Interior estimates

Set
$$R_0 = \frac{C_0}{2K_0}$$
, $Z = (-R_0, R_0)^2$ and
$$\Xi_\delta \doteq \left\{ \xi \in 2R_0 \mathbb{Z}^2 \mid \delta \xi + \delta Z \subset \omega \right\}, \qquad \widetilde{\omega}_\delta \doteq \operatorname{Interior} \left(\bigcup_{\xi \in \Xi_\delta} \delta \xi + \delta \overline{Z} \right),$$

$$\widetilde{\Omega}_\delta \doteq \left\{ (x_1, x_2, x_3) \in \widetilde{\omega}_\delta \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta \phi(x_1, x_2) \right\},$$

$$\mathcal{D}_{0,\delta,\xi} = \left(\delta \xi + \delta Z \right) \times (-\delta C_0, \delta C_0) \subset \mathcal{D}_{\delta,\xi},$$

$$\mathcal{D}_{\delta,\xi} = \left\{ (x_1, x_2, x_3) \in \left(\delta \xi + \delta Z \right) \times \mathbb{R} \mid -\delta C_0(x_1, x_2) < x_3 < \delta \phi(x_1, x_2) \right\}.$$

Note that the domain $\delta \xi + \delta Z$ is star-shaped with respect to the disc $D(\delta \xi, \delta R_0)$. Then, due to Lemma 8.1, the domain $\mathcal{D}_{\delta,\xi}$ has a diameter less than $\delta(3R_0 + 2C_1)$ and is star-shaped with respect to the ball $B(\varepsilon \xi, \delta \min \{C_0, R_0\})$.

Now, Theorem 2.3 in [13] gives a rigid displacement \mathbf{r}_{ξ} ($\mathbf{r}_{\xi}(x) = \mathbf{a}_{\xi} + \mathbf{B}_{\xi}(x - \delta \xi)$, $x \in \mathbb{R}^3$, $\mathbf{a}_{\xi} \in \mathbb{R}^3$, \mathbf{B}_{ξ} is a 3×3 antisymmetric matrix with constant entries) such that

$$\|\nabla(\mathfrak{u} - \mathbf{r}_{\xi})\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p} \le C^{*}\|e(\mathfrak{u})\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p}, \qquad \|\mathfrak{u} - \mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p} \le C^{*}\delta\|e(\mathfrak{u})\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p}. \tag{8.4}$$

The constant C^* only depends on the ratio $\frac{3R_0 + 2C_1}{\min\{C_0, R_0\}}$.

Hence, we have

$$8\delta^{3}R_{0}^{2}C_{0}|\mathbf{B}_{\xi}|_{F}^{p} = \|\nabla\mathbf{r}_{\xi}\|_{L^{p}(\mathbf{D}_{0,\xi})}^{p} \leq 2^{p-1}(\|\nabla\mathbf{u}\|_{L^{p}(\mathbf{D}_{0,\xi})}^{p} + \|\nabla(\mathbf{u} - \mathbf{r}_{\xi})\|_{L^{p}(\mathbf{D}_{\delta,\xi})}^{p}),$$

$$8\delta^{3}R_{0}^{2}C_{0}|\mathbf{a}_{\xi}|_{2}^{p} = \|\mathbf{r}_{\xi}\|_{L^{p}(\mathbf{D}_{0,\xi})}^{p} \leq 2^{p-1}(\|\mathbf{u}\|_{L^{p}(\mathbf{D}_{0,\xi})}^{p} + \|\mathbf{u} - \mathbf{r}_{\xi}\|_{L^{p}(\mathbf{D}_{\delta,\xi})}^{p})$$

$$(8.5)$$

where $|\cdot|_F$ is the Frobenius norm.

Since \mathbf{r}_{ξ} is a affine function with respect to x_1 , x_2 and x_3 , we have

$$\|\nabla \mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\varepsilon})}^{p} \leq C^{**} \|\nabla \mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{0,\varepsilon})}^{p}, \qquad \|\mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\varepsilon})}^{p} \leq C^{**} \|\mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{0,\varepsilon})}^{p}. \tag{8.6}$$

The constant C^{**} only depends on the ratio $\frac{C_1}{C_0}$.

Besides we have

$$\|\nabla \mathfrak{u}\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p} \leq 2^{p-1} (\|\nabla \mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p} + \|\nabla (\mathfrak{u} - \mathbf{r}_{\xi})\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p})$$

$$\|\mathfrak{u}\|_{L^{p}(\mathcal{D}_{\delta,\xi})}^{p} \leq 2^{p-1} (\|\mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\xi})} + \|\mathfrak{u} - \mathbf{r}_{\xi}\|_{L^{p}(\mathcal{D}_{\delta,\xi})}).$$

$$(8.7)$$

So, (8.4)-(8.5)-(8.6) and then summing the above inequalities (8.7) ($\xi \in \Xi_{\delta}$) and due to the estimates of \widetilde{u} (see (3.3)₃ and remind that $\mathfrak{u} = \widetilde{u}$ in $\Omega_{0,\delta}$), we get

$$\|\nabla \mathfrak{u}\|_{L^{p}(\widetilde{\Omega}_{\delta})}^{p} \leq \mathbf{C}\|e(\mathfrak{u})\|_{L^{p}(\Omega_{\delta})}^{p}, \qquad \|\mathfrak{u}\|_{L^{p}(\widetilde{\Omega}_{\delta})}^{p} \leq \mathbf{C}\delta^{p}\|e(\mathfrak{u})\|_{L^{p}(\Omega_{\delta})}^{p}. \tag{8.8}$$

The constant C only depends on K_0 , C_0 , C_1 and obviously on p.

8.2.2 Boundary layer estimates

The domain $\widetilde{\omega}_{\delta}$ covers a large part of ω . One has

$$\operatorname{dist}(\widetilde{\omega}_{\delta}, \partial \omega) < 3\delta R_0.$$

Since the boundary of ω is Lipshitz, there exist constants a_0 and β strictly positive and a finite number N of local coordinate systems (x_{1n}, x_{2n}) in orthonormal frames $(O_n; \mathbf{e}_{1n}, \mathbf{e}_{2n})$ and Lipschitz continuous maps $f_n: [-a_0, a_0] \longrightarrow \mathbb{R}, 1 \le n \le N$ such that

$$\partial \omega = \bigcup_{n=1}^{N} \left\{ (x_{1n}, x_{2n}) \in \mathbb{R}^{p} \mid x_{2n} = f_{n}(x_{1n}), \quad |x_{1n}| < a_{0} \right\},$$

$$\mathcal{A}_{n,\beta} \doteq \left\{ (x_{1n}, x_{2n}) \in \mathbb{R}^{p} \mid f_{n}(x_{1n}) - \beta < x_{2n} < f_{n}(x_{1n}), \quad |x_{1n}| < a_{0} \right\},$$

$$\mathcal{A}_{\beta} \doteq \bigcup_{n=1}^{N} \mathcal{A}_{n,\beta} \subset \omega.$$

One easily shows that there exists $\delta_0 > 0$ such that

$$\omega \setminus \overline{\widetilde{\omega}_{\delta}} \subset \mathcal{A}_{\beta}, \quad \forall \delta \in (0, \delta_0].$$

Without loss of generality, we assume that

$$|f_n(t) - f_n(t')| \le K_1 |t - t'|, \quad \forall (t, t') \in [-a_0, a_0]^2, \quad \forall n \in \{1, \dots, N.\}$$

Now, set

$$x_k = -a_0 + ka_\delta$$
, $k \in \{0, \dots, N_\delta - 1\}$ and $x_{N_\delta} = a_0 - a_\delta$

where $N_{\delta} = \left[\frac{2a_0}{a_{\delta}}\right]$, $[t] \in \mathbb{N}$ is the integer part of $t \in \mathbb{R}^+$. The strictly positive real number $a_{\delta} \in (0, 2a_0]$ will be given below by (8.9).

Denote

$$\mathcal{A}_{n,k,\delta} \doteq \left\{ (x_{1n}, x_{2n}) \in \mathbb{R}^p \mid \begin{array}{c} x_k < x_{1n} < x_k + a_{\delta}, \\ f_n(x_{1n}) - \beta < x_{2n} < f_n(x_{1n}), \end{array} \right\}, \quad k \in \left\{ 0, \dots, N_{\delta} \right\},$$

We cover every strip $A_{n,k,\delta}$ by the domains (see (8.3))

- $\mathcal{D}_{a,x_0}^{top}$ (see Figure 1) where f is replaced by f_n , a by a_{δ} , x_0 by x_k , $k \in \{0,\ldots,N_{\delta}\}$,
- $\mathcal{D}_{a,x_0}^{bottom}$ (see Figure 1) where f is replaced by $f_n \beta$, a by a_δ , x_0 by x_k , $k \in \{0, \dots, N_\delta\}$,
- the remaining parts of the strips

$$\left\{ (x_{1n}, x_{2n}) \in (x_k, x_k + a_\delta) \times \mathbb{R} \mid f_n(x_k) + (2K_1 + 1)a_\delta - \beta < x_{2n} < f_n(x_k) - (2K_1 + 1)a_\delta \right\}$$

are covered by $\left[\frac{\beta - 2(2K_1 + 1)a_{\delta}}{a_{\delta}}\right] + 1^5$ squares whose edges have length a_{δ} .

We set

$$a_{\delta} = \frac{3C_0}{(3K_1 + 2)K_0} \delta, \qquad 0 < \delta \le \inf \left\{ \delta_0, \frac{2(3K_1 + 2)K_0}{3C_0} a_0, \frac{(3K_1 + 2)K_0}{6(2K_1 + 1)C_0} \beta \right\}. \tag{8.9}$$

Observe that $a_{\delta} \leq 2a_0$, $(3K_1 + 2)a_{\delta} = 3\delta \frac{C_0}{K_0} \leq 3\delta R_0$, $2(2K_1 + 1)a_{\delta} \leq \beta$.

So, the strip $A_{n,k,\delta}$ is covered by domains star-shaped with respect to balls of radii $a_{\delta}/2$ and whose diameters are

⁵If this integer is strictly greater than 1, otherwise these parts are empty.

less than $3\delta R_0$. Each point in $\mathcal{A}_{n,k,\delta}$ belongs to at most two domains of the covering.

Then, proceeding as in Subsection 8.2.1, we obtain

$$\|\nabla \mathfrak{u}\|_{L^{p}(\mathcal{B}_{n,k,\delta})}^{p} \leq \mathbf{C}^{*} \|e(\mathfrak{u})\|_{L^{p}(\mathcal{B}_{n,k,\delta})}^{p}, \qquad \|\mathfrak{u}\|_{L^{p}(\mathcal{B}_{n,k,\delta})}^{p} \leq \mathbf{C}^{*} \delta^{p} \|e(\mathfrak{u})\|_{L^{p}(\mathcal{B}_{n,k,\delta})}^{p}$$

$$(8.10)$$

where

$$\mathcal{B}_{n,k,\delta} = \Big\{ (x_1, x_2, x_3) \in \mathcal{A}_{n,k,\delta} \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta \phi(x_1, x_2) \Big\}.$$

The constant \mathbb{C}^* only depends on K_1 , K_0 , C_0 and δ_0 .

Every point contained in $\mathcal{A}_{n,\beta}$ belongs to at most two $\mathcal{A}_{n,k,\delta}$. Then, summing the above inequalities lead to

$$\|\nabla \mathfrak{u}\|_{L^p(\mathcal{B}_{n,\beta,\delta})}^p \le 2\mathbf{C}^* \|e(\mathfrak{u})\|_{L^p(\Omega_{\delta})}^p, \qquad \|\mathfrak{u}\|_{L^p(\mathcal{B}_{n,\beta,\delta})}^p \le 2\mathbf{C}^* \delta^p \|e(\mathfrak{u})\|_{L^p(\Omega_{\delta})}^p \tag{8.11}$$

where

$$\mathcal{B}_{n,\beta,\delta} = \Big\{ (x_1, x_2, x_3) \in \mathcal{A}_{n,\beta} \times \mathbb{R} \mid -\delta C_0 < x_3 < \delta \phi(x_1, x_2) \Big\}.$$

Finally, summing the inequalities (8.8) and (8.11) give

$$\|\nabla \mathfrak{u}\|_{L^{p}(\Omega_{\delta})} \le C^{**}\|e(\mathfrak{u})\|_{L^{p}(\Omega_{\delta})}, \qquad \|\mathfrak{u}\|_{L^{p}(\Omega_{\delta})} \le C^{**}\delta\|e(\mathfrak{u})\|_{L^{p}(\Omega_{\delta})}. \tag{8.12}$$

The constant does not depend on δ , it depends on N, K_1 , K_0 , C_0 , C_1 , δ_0 and p.

Note that in the proof of the estimates (4.3), the dimensional parameters a_0 , β and the diameter of ω are not involved.

8.3 The extension operator \mathcal{P}_{δ}

Set

$$\widetilde{\Omega}_{\delta} \doteq \omega \times (-\delta C_0, \delta C_1).$$

Lemma 8.2. There exist an extension operator \mathcal{P}_{δ} from $W^{1,p}(\Omega_{\delta})$, $1 \leq p \leq \infty$, into $W^{1,p}(\widetilde{\Omega}_{\delta})$ such that for all $\Phi \in W^{1,p}(\Omega_{\delta})$

$$\begin{split} & \| \mathcal{P}_{\delta}(\Phi) \|_{L^{p}(\widetilde{\Omega}_{\delta})} \leq \| \Phi \|_{L^{p}(\Omega_{\delta})}, \\ & \left\| \frac{\partial \mathcal{P}_{\delta}(\Phi)}{\partial x_{1}} \right\|_{L^{p}(\widetilde{\Omega}_{\delta})} + \left\| \frac{\partial \mathcal{P}_{\delta}(\Phi)}{\partial x_{2}} \right\|_{L^{p}(\omega \times (-C_{0}, +\infty))} \leq C \| \Phi \|_{W^{1, p}(\Omega_{\delta})}, \\ & \left\| \frac{\partial \mathcal{P}_{\delta}(\Phi)}{\partial x_{3}} \right\|_{L^{p}(\widetilde{\Omega}_{\delta})} \leq C \Big(\| \nabla \Phi \|_{L^{p}(\Omega_{\delta})} + \frac{1}{\delta} \| \Phi \|_{L^{p}(\Omega_{\delta})} \Big). \end{split}$$

The constant C is independent of δ .

Proof. Every measurable function Φ in Ω_{δ} is extended as follows:

$$\mathcal{P}_{\delta}(\Phi)(x', x_3) = \Phi(x', x_3) \qquad \text{for a.e. } x_3 \in \left(-\delta C_0, \delta \phi(x')\right),$$

$$\mathcal{P}_{\delta}(\Phi)(x', x_3) = \Phi\left(x', 2\delta \phi(x') - x_3\right) \left(1 + \frac{\delta \phi(x') - x_3}{\delta C_0}\right) \qquad \text{for a.e. } x_3 \in \left(\delta \phi(x'), \delta \phi(x') + \delta C_0\right),$$

$$\mathcal{P}_{\delta}(\Phi)(x', x_3) = 0 \qquad \qquad \text{for a.e. } x_3 \in \left(\delta \phi(x') + \delta C_0, +\infty\right)$$
and for a.e. $x' \in \omega$.

By construction $\mathcal{P}_{\delta}(\Phi) = \Phi$ a.e. in Ω_{δ} . Then, we consider the restriction of $\mathcal{P}_{\delta}(\Phi) = 0$ to the domain $\widetilde{\Omega}_{\delta}$. A straightforward calculations gives the estimates of the lemma.
