# Model $\lambda\left(\varphi^{2 n}\right)_{4}, n \geq 2$ Quantum Field Theory: A Nonstandard Approach Based on Nonstandard Pointwise-Defined Quantum Fields

#### Abstract

A new non-Archimedean approach to interacted quantum fields is presented. In proposed approach, a field operator $\varphi(x, t)$ no longer a standard tempered operator-valued distribution, but a non-classical operator-valued function. We prove using this novel approach that the quantum field theory with Hamiltonian $P(\varphi)_{4}$ exists and that the corresponding $C^{*}$ - algebra of bounded observables satisfies all the Haag-Kastler axioms except Lorentz covariance. We prove that the $\lambda\left(\varphi^{2 n}\right)_{4}, n \geq 2$ quantum field theory models are Lorentz covariant.


## 1. Introduction

Extending the real numbers $\mathbb{R}$ to include infinite and infinitesimal quantities originally enabled D. Laugwitz [1] to view the delta distribution $\delta(x)$ as a nonstandard point function. Independently A. Robinson [2] demonstrated that distributions could be viewed as generalized polynomials. Luxemburg [3] and Sloan [4] presented an alternate representative of distributions as internal functions within the context of canonical Robinson's theory of nonstandard analysis. For further information on classical model theoretical nonstandard analysis namely $N S A$, we refer to [5]-[8].
Abbreviation 1.1In this paper we adopt the following canonical notations. For a standard set $E$ we often write $E_{\text {st }}$. For a set $E_{\text {st }}$ let ${ }^{\sigma} E_{\text {st }}$ be a set ${ }^{\sigma} E_{\text {st }}=\left\{{ }^{*} x \mid x \in E_{\text {st }}\right\}$. We identify $z$ with ${ }^{\sigma} z$ i.e., $z \equiv \sigma_{Z}$ for all $z \in \mathbb{C}$. Hence, ${ }^{\sigma} E_{\text {st }}=E_{\text {st }}$ if $E \subseteq \mathbb{C}$, e.g., ${ }^{\sigma} \mathbb{C}=\mathbb{C},{ }^{\sigma} \mathbb{R}=\mathbb{R},{ }^{\sigma} P=P,{ }^{\sigma} L_{+}^{\uparrow}=L_{+}^{\uparrow}$, etc. Let ${ }^{*} \mathbb{R}_{\approx},{ }^{*} \mathbb{R}_{\approx+,}{ }^{*} \mathbb{R}_{\mathrm{fin}},{ }^{*} \mathbb{R}_{\infty}$, and ${ }^{*} \mathbb{N}_{\infty}$ denote the sets of infinitesimal hyper-real numbers, positive infinitesimal hyper-real numbers, finite hyper-real numbers, infinite hyper-real numbers and infinite hyper natural numbers, respectively.

Definition 1.1 Let $\{X,\|\cdot\|\}$ be a standard Banach space. For $x \in{ }^{*} X$ and $\varepsilon>0, \varepsilon \approx 0$ we define the open $\approx$-ball about $x$ of radius $\varepsilon$ to be the set $B_{\varepsilon}(x)=\left\{\left.y \in{ }^{*} X\right|^{*}\|x-y\|<\varepsilon\right\}$.

Definition 1.4 Let $\{\{X,\|\cdot\|\}$ be a standard Banach space. We shall say that internal hyper infinite sequence $\left\{x_{n}\right\}_{n=1}^{* \infty}$ in ${ }^{*} X$ is $*$-converges to $x \in{ }^{*} X$ as $n \rightarrow{ }^{*} \infty$ if for any $\varepsilon \in{ }^{*} \mathbb{R}_{\approx+}$ there is $N \in{ }^{*} \mathbb{N}$ such that for any $n>N:^{*}\|x-y\|<\varepsilon$.
Definition 1.5 Let $\left\{\left\{X,\|\cdot\|_{X}\right\},\left\{\left\{Y,\|\cdot\|_{Y}\right\}\right.\right.$ be a standard Banach spaces. A linear internal operator $A: D(A) \subseteq{ }^{*} X \rightarrow{ }^{*} Y$ is * -closed if for every internal hyper infinite sequence $\left\{x_{n}\right\}_{n=1}^{{ }^{*}}$ in $D(A) *$ -converging to $x \in{ }^{*} X$ such that $A x_{n} \rightarrow y \in{ }^{*} Y$ as $n \rightarrow{ }^{*} \infty$ one has $x \in D(A)$ and $A x=y$. Equivalently, $A$ is $*$-closed if its graph is $*$-closed in the direct sum ${ }^{*} X \bigoplus^{*} Y$.
Definition 1.6 Let $H$ be a standard external Hilbert space. The graph of the internal linear transformation $T:{ }^{*} H \rightarrow{ }^{*} H$ is the set of pairs $\{\langle\varphi, T \varphi\rangle \mid \varphi \in D(T)\}$. The graph of $T$, denoted by $\Gamma(\mathrm{T})$, is thus a subset of ${ }^{*} H \times{ }^{*} H$ which is internal Hilbert space with inner product $\left(\left\langle\varphi_{1}, \psi_{1}\right\rangle,\left\langle\varphi_{2}, \psi_{2}\right\rangle\right)=$

Definition 1.7 Let $H$ be a standard Hilbert space. Let $T_{1}$ and $T$ be internal operators on internal Hilbert space * $H$. Note that if $\Gamma\left(T_{1}\right) \supset \Gamma(T)$, then $T_{1}$ is said to be an extension of $T$ and we write $T_{1} \supset$ $T$. Equivalently, $T_{1} \supset T$ if and only if $D\left(T_{1}\right) \supset D(T)$ and $T_{1} \varphi=T \varphi$ for all $\varphi \in D(T)$.
Definition 1.8 Any internal operator $T$ on ${ }^{*} H$ is *-closable if it has a *-closed extension. Every *-closable internal operator $T$ has a smallest *-closed extension, called its *-closure, which we denote by $*-\bar{T}$.
Definition 1.9 Let $H$ be a standard Hilbert space. Let $T$ be a $*$-densely defined internal linear operator on internal Hilbert space ${ }^{*} H$. Let $D\left(T^{*}\right)$ be the set of $\varphi \in{ }^{*} H$ for which there is a vector $\xi \in{ }^{*} H$ with $(T \psi, \varphi)=(\varphi, \xi)$ for all $\psi \in D(T)$, then for each $\varphi \in D\left(T^{*}\right)$, we define $T^{*} \varphi=\xi . T^{*}$ is called the * -adjoint of $T$. Note that $S \subset T$ implies $T^{*} \subset S^{*}$.
Definition 1.10 Let $H$ is a standard Hilbert space. A *-densely defined internal linear operator $T$ on internal Hilbert space * $H$ is called symmetric (or Hermitian) if $T \subset T^{*}$. Equivalently, $T$ is symmetric if and only if $(T \varphi, \psi)=(\varphi, T \psi)$ for all $\varphi, \psi \in D(T)$.
Definition 1.11 Let $H$ be a standard Hilbert space. A symmetric internal linear operator $T$ on internal Hilbert space ${ }^{*} H$ is called essentially self- $*$-adjoint if its $*$-closure $*-\bar{T}$ is self- $*$-adjoint. If $T$ is *-closed, a subset $D \subset D(T)$ is called a $*$-core for $T$ if $*-(\overline{T \upharpoonright D})=T$. If $T$ is essentially self- $*$-adjoint, then it has one and only one self - - -adjoint extension.

Let $F$ be the standard Fock space [9],[10] for a massive, neutral scalar field in four-dimensional space-time [10]. The elements of ${ }^{*} F$ are internal sequences of functions on internal momentum space $\mathbb{R}^{3}$. Let the standard annihilation and creation operators be normalized by the relation

Remark 1.1 Note that the domain $D_{0, \varkappa}$ is a nonstandard external set so there is no standard set $\mathcal{D}$ such that $D_{0, \varkappa}={ }^{*} \mathcal{D}$.

Remark 1.2 It follows from (2.11) that:
(1) ${ }^{*} H_{I, \varkappa}(g)$ is well defined on the domain $D_{0, \varkappa}$,
(2) there is a $*$-closure $*-{ }^{*} H_{I, \varkappa}(g)$ with domain $D\left(*-\overline{{ }^{*} H_{I, \varkappa}(g)}\right) \supset D_{0, \varkappa}$,
(3) external set $D_{0, \varkappa}$ is a $*$-core for ${ }^{*} H_{I, \varkappa}(g)$ i.e., $*-\left({ }^{*} H_{I, \varkappa}(g) \upharpoonright D_{0, \varkappa}\right)={ }^{*} H_{I, \varkappa}(g)$

Remark 1.3 The operator $*-{ }^{*} H_{I, \varkappa}(g)$ is external mapping $*-{ }^{*} H_{I, \varkappa}(g): ~{ }^{*} F \rightarrow{ }^{*} F$ i.e., there is no standard operator $T: F \rightarrow F$ with domain $D(T)$ such that:
$(1){ }^{*} D(T)=D\left(*-{ }^{*} H_{I, \varkappa}(g)\right)$ and (2) ${ }^{*} T \upharpoonright{ }^{*} D(T)=*-{ }^{*} H_{I, \varkappa}(g) ~ \upharpoonright D\left(*{ }^{*} H_{I, \varkappa}(g)\right)$.
Thus we cannot derive the desired properties of the operator $*-{ }^{*} H_{I, \varkappa}(g)$ by using Robinson transfer principle [2]-[7].

As that has been explained in [8] classical model theoretical nonstandard analysis NSA does not power enough to resolve the stated in [8] problems in constructive quantum field theory related to physical dimension $d=4$,

In order to avoid any difficultness mentioned above, in this paper as in [8] we deal by using minimal non-conservative extension of NSA developed in [11]-[14]. We will denote this extension by NSA ${ }^{\#}$. The formal theory $\mathrm{NSA}^{\#}$ is based on the following definitions and axioms presented below. Remind that Robinson nonstandard analysis (NSA) many developed using set theoretical objects called super-structures [5]-[7]. A superstructure $V(S)$ over a set $S$ is defined in the following way: $V_{0}(S)=S, V_{n+1}(S)=V_{n}(S) \cup P\left(V_{n}(S)\right), V(S)=U_{n \in \mathbb{N}} V_{n+1}(S)$. Making $S=\mathbb{R}$ will suffice for virtually any construction necessary in analysis. Bounded formulas are formulas where all quantifiers occur in the form: $\forall x(x \in y \rightarrow \cdots), \exists x(x \in y \rightarrow \cdots)$. A nonstandard embedding is a mapping $*: \mathrm{V}(X) \rightarrow \mathrm{V}(Y)$ from a superstructure $\mathrm{V}(X)$ called the standard universe, into another superstructure $\mathrm{V}(Y)$ called nonstandard universe, satisfying the following postulates:

1. $Y={ }^{*} X$
2. Transfer Principle For every bounded formula $\Phi\left(x_{1}, \ldots, x_{n}\right)$ and elements $a_{1}, \ldots, a_{n} \in V(X)$ the property $\Phi\left(a_{1}, \ldots, a_{n}\right)$ is true for $a_{1}, \ldots, a_{n}$ in the standard universe if and only if it is true for ${ }^{*} a_{1}, \ldots,{ }^{*} a_{n}$ in the nonstandard universe $V(X) \neq \Phi\left(x_{1}, \ldots, x_{n}\right) \leftrightarrow V(Y) \neq \Phi\left({ }^{*} a_{1}, \ldots,{ }^{*} a_{n}\right)$.
3. Non-triviality For every infinite set $A$ in the standard universe, the set $\left\{{ }^{*} a \mid a \in A\right\}$ is a proper subset of * $A$.
Definition 1.12 A set $x$ is internal if and only if $x$ is an element of ${ }^{*} A$ for some $A \in \mathrm{~V}(\mathbb{R})$. Let $X$ be a set and $A=\left\{A_{i}\right\}_{i \in I}$ a family of subsets of $X$.Then the collection $A$ has the infinite intersection property, if any infinite sub collection $J \subset I$ has non-empty intersection. Nonstandard universe is $\sigma$ saturated if whenever $\left\{A_{i}\right\}_{i \in I}$ is a collection of internal sets with the infinite intersection property and the cardinality of $I$ is less than or equal to $\sigma$.
Remark 1.4 For each standard universe $U=V(X)$ there exists canonical language $L_{U}$ and for each nonstandard universe $W=V(Y)$ there exists corresponding canonical nonstandard language ${ }^{*} L=L_{W}$ [5],[7]
4.The restricted rules of conclusion If Let $A$ and $B$ well formed, closed formulas so that $A, B \in{ }^{*} L$. If $W \vDash A$, then $\neg A \Vdash_{R M P} B$. Thus, if a statement $A$ holds in nonstandard universe, we cannot obtain from formula $\neg A$ any formula $B$ whatsoever.
Definition 1.13 [8] A set $S \subset{ }^{*} \mathbb{N}$ is a hyper inductive if the following statement holds in $V(Y)$ :

Example 1.1 Remind the proof of the following statement: structure ( $\mathbb{N},<,=$ ) is a well-ordered set. Proof Let $X$ be a nonempty subset of $\mathbb{N}$. Suppose X does not have a <-least element. Then consider the set $\mathbb{N} \backslash X$. Case $1 . \mathbb{N} \backslash X=\emptyset$. Then $X=\mathbb{N}$ and so 0 is a $<$-least element but this is a contradiction. Case2. $\mathbb{N} \backslash X \neq \emptyset$. Then $1 \in \mathbb{N} \backslash X$ otherwise 1 is a $<$-least element but this is a contradiction. Assume now that there exists some $n \in \mathbb{N} \backslash X$ such that $n \neq 1$, but since we have supposed that $X$ does not have a <-least element, thus $n+1 \notin X$. Thus we see that for all $n$ the statement $n \in \mathbb{N} \backslash X$ implies that $n+1 \in \mathbb{N} \backslash X$. We can conclude by axiom of induction that $n \in \mathbb{N} \backslash X$ for all $n \in \mathbb{N}$. Thus $\mathbb{N} \backslash X=\mathbb{N}$ implies $X=\emptyset$. This is a contradiction to $X$ being a non-empty subset of $\mathbb{N}$. Remind that structure ( ${ }^{*} \mathbb{N},<,=$ ) is not a well-ordered set [5]-[7]. We set now $X_{1}={ }^{*} \mathbb{N} \backslash \mathbb{N}$ and thus ${ }^{*} \mathbb{N} \backslash X_{1}=\mathbb{N}$. In contrast with a set $X$ mentioned above the assumption $n \in{ }^{*} \mathbb{N} \backslash X_{1}$ implies that $n+1 \in{ }^{*} \mathbb{N} \backslash X_{1}$ if and only if $n$ is finite, since for any infinite $n \in{ }^{*} \mathbb{N} \backslash \mathbb{N}$ the assumption $n \in{ }^{*} \mathbb{N} \backslash X_{1}$ contradicts with a true statement $V(Y) \vDash n \nexists^{*} \mathbb{N} \backslash X_{1}=\mathbb{N}$ and therefore in accordance with postulate 4 we cannot obtain from $n \in{ }^{*} \mathbb{N} \backslash X_{1}$ any closed formula $B$ whatsoever.
For further information on non-classical nonstandard analysis namely $N S A^{\#}$, we refer to [8]-[13].
Abbreviation1.2 In this paper we adopt the following notations [8]. For a standard set $E$ we often write $E_{\text {st }}$ let ${ }^{\sigma} E_{\text {st }}=\left\{{ }^{*} x \mid x \in E_{\text {st }}\right\}$. We identify $z$ with ${ }^{\sigma} Z$ i.e., $z \equiv{ }^{\sigma} Z$ for all $z \in \mathbb{C}$. Hence, ${ }^{\sigma} E_{\text {st }}=E_{\text {st }}$ if $E \subseteq \mathbb{C}$, e.g., ${ }^{\sigma} \mathbb{C}=\mathbb{C},{ }^{\sigma} \mathbb{R}=\mathbb{R}$, etc. Let ${ }^{*} \mathbb{R}_{c}^{\#},{ }^{*} \mathbb{R}_{c, \tilde{\sim}}^{\#},{ }^{*} \mathbb{R}_{c, \sim+}^{\#},{ }^{*} \mathbb{R}_{c, \text { fin }}^{\#},{ }^{*} \mathbb{R}_{c, \infty}^{\#},{ }^{*} \mathbb{N}_{\infty}$ de-note the sets of Cauchy hyper-real numbers, Cauchy infinitesimal hyper-real numbers, Cauchy positive infinitesimal hyperreal numbers, Cauchy finite hyper-real numbers, Cauchy infinite hyper-real numbers and infinite hypernatural numbers, respectively. Note that ${ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}={ }^{*} \mathbb{R}_{c}^{\#} \backslash{ }^{*} \mathbb{R}_{c, \infty}^{\#}$.
Definition 1.13 Let $H$ be external hyper infinite dimensional vector space over the complex field ${ }^{*} \mathbb{C}_{\mathbf{c}}^{\#}={ }^{*} \mathbb{R}_{c}^{\#}+\mathrm{i}^{*} \mathbb{R}_{\boldsymbol{c}}^{\#}$. An inner product on $H$ is $\mathrm{a}^{*} \mathbb{C}_{\mathbf{c}}^{\#}$-valued function, $\langle\cdot ;\rangle: H \times H \rightarrow{ }^{*} \mathbb{C}_{c}^{\#}$, such that (1) $\langle a x+b y, z\rangle=\langle a x, z\rangle+\langle b y, z\rangle$, (2) $\overline{\langle x, y\rangle}=\langle y, x\rangle$, (3) $\|x\|^{2} \equiv\langle x, x\rangle \geq 0$ with equality $\langle x, x\rangle=0$ if and only if $x=0$.
Theorem 1.1 (Generalized Schwarz Inequality) Let $\{H,\langle\cdot\rangle$,$\} be an inner product space, then for all$ $x, y \in H:|\langle x, y\rangle| \leq\|x\|\|y\|$ and equality holds if and only if $x$ and $y$ are linearly dependent.
Theorem 1.2 Let $\{H,\langle\cdot \cdot\rangle\}$ be an inner product space, and $\|x\|_{\#}=\sqrt{\langle x, x\rangle}$. Then $\|\cdot\|_{\#}$ is a ${ }^{*} \mathbb{R}_{c}^{\#}$ valued \#-norm on a space $H$. Moreover $\langle x, x\rangle$ is \#-continuous on Cartesian product $H \times H$, where $H$ is viewed as the \#-normed space $\left\{H,\|\cdot\|_{\#}\right\}$.
Definition 1.14 A non-Archimedean Hilbert space $H$ is a \#-complete inner product space.
Two elements $x$ and $y$ of non-Archimedean Hilbert space $H$ are called orthogonal if $\langle x, y\rangle=0$.
Definition 1.15 The graph of the linear transformation $T: H \rightarrow H$ is the set of pairs $\{\langle\phi, T \phi\rangle \mid(\phi \in$ $D(T))\}$. The graph of the operator $T$, denoted by $\Gamma(\mathrm{T})$, is thus a subset of $H \times H$ which is a nonArchimedean Hilbert space with the following inner product $\left(\left\langle\phi_{1}, \psi_{1}\right\rangle,\left\langle\phi_{2}, \psi_{2}\right\rangle\right)$. Operator $T$ is called a \#-closed operator if $\Gamma(\mathrm{T})$ is a \#-closed subset of $H \times H$.
Definition 1.16 Let $T_{1}$ and $T$ be operators on H . If $\Gamma\left(T_{1}\right) \supset \Gamma(\mathrm{T})$, then $T_{1}$ is said to be an extension of $T$ and we write $T_{1} \supset T$. Equivalently: $T_{1} \supset T$ if and only if $D\left(T_{1}\right) \supset D(T)$ and $T_{1} \phi=T \phi$ for all $\phi \in D(T)$.
Definition 1.17 An operator $T$ is \#-closable if it has a \#-closed extension. Every \#-closable operator has a smallest \#-closed extension, called its \#-closure, which we denote by \#-T.
Theorem 1.3 If $T$ is \#-closable, then $\Gamma(\#-\bar{T})=\#-\overline{\Gamma(T)}$.
Definition 1.18 Let $D\left(T^{*}\right)$ be the set of $\varphi \in H$ for which there is an $\xi \in H$ with $(T \psi, \varphi)=(\psi, \xi)$ for all $\psi \in D(T)$. For each $\varphi \in D\left(T^{*}\right)$, we define $T^{*} \varphi=\xi$. The operator $T^{*}$ is called the \#-adjoint of $T$. Note that $\varphi \in D\left(T^{*}\right)$ if and only if $|(T \psi, \varphi)| \leq C\|\psi\|_{\#}$ for all $\psi \in D(T)$. Note that $S \subset T$ implies $T^{*} \subset S$.
Remark 1.5 Note that for $\xi$ to be uniquely determined by the condition $(T \psi, \varphi)=(\psi, \xi)$ one need
the fact that $D(T)$ is \#-dense in $H$. If the domain $D\left(T^{*}\right)$ is \#-dense in $H$, then we can define $T^{* *}=$ $\left(T^{*}\right)^{*}$.
Theorem 1.4 Let $T$ be a \#-densely defined operator on a non-Archimedean Hilbert space $H$. Then: (a) $T^{*}$ is \#-closed. (b) The operator $T$ is \#-closabie if and only if $D\left(T^{*}\right)$ is -dense in which case $T=T^{* *}$. (c) If T is \#-closable, then $(\#-\bar{T})^{*}=T^{*}$.

Definition 1.19 Let $T$ be a \#-closed operator on a non-Archimedean Hilbert space $H$. A complex number $\lambda \in{ }^{*} \mathbb{C}_{\boldsymbol{c}}^{\#}$ is in the resolvent set $\rho(T)$, if $\lambda I-T$ is a bijection of $D(T)$ onto $H$ with a finitely or hyper finitely bounded inverse. If complex number $\lambda \in \rho(T), R_{\lambda}=(\lambda I-T)^{-1}$ is called the resolvent of $T$ at $\lambda$.
Definition 1.20 A \#-densely defined operator $T$ on a non-Archimedean Hilbert space is called symmetric or Hermitian if $T \subset T^{*}$, that is, $D(T) \subset D\left(T^{*}\right)$ and $T \varphi=T^{*} \varphi$ for all $\varphi \in D(T)$ and equivalently, $T$ is symmetric if and only if $(T \varphi, \psi)=(\varphi, T \psi)$ for all $\varphi, \psi \in D(T)$.
Definition 1.21 A \#-densely defined operator $T$ is called self-\#-adjoint if $T=T^{*}$, that is, if and only if $T$ is symmetric and $D(T)=D\left(T^{*}\right)$.
Remark 1.6 A symmetric operator $T$ is always \#-closable, since $D(T)$ \#-dense in $H$. If $T$ is symmetric, $T^{*}$ is a \#-closed extension of $T$ so the smallest \#-closed extension $T^{* *}$ of $T$ must be contained in $T^{*}$. Thus for symmetric operators, we have $T \subset T^{* *} \subset T^{*}$, for \#-closed symmetric operators we have $T=T^{* *} \subset T^{*}$ and, for self-\#-adjoint operators we have $T=T^{* *}=T^{*}$. Thus a \#-closed symmetric operator $T$ is self-\#-adjoint if and only if $T^{*}$ is symmetric.
Definition 1.22 A symmetric operator $T$ is called essentially self-\#-adjoint if its \#-closure \#- $\bar{T}$ is self-\#-adjoint. If $T$ is \#-closed, a subset $D \subset D(T)$ is called a core for $T$ if \#- $\overline{T \upharpoonright D}=T$.
Remark 1.7 If $T$ is essentially self-\#-adjoint, then it has one and only one self-\#-adjoint extension.

The three main steps to convert the above argument into a rigorous proof are (a) to introduce a spatial cut-off into the Lorentz boost generators in such a way that we obtain a self-\#-adjoint operators $M_{\varkappa, g}^{0 k}$, $k=1,2,3$; (b) to show that for suitable bounded regions $O \subset{ }^{*} \mathbb{R}_{c, \text { fin }}^{\# 3}$, (1.34) holds in the sense that for every $f \in C_{0}^{*}\left({ }^{*} \mathbb{R}_{c, \text { fin }}^{\# 3},{ }^{*} \mathbb{R}_{c, \text { in }}^{\#}\right)$,

Note that (1.38) states that $M_{\varkappa, g}^{0 k}$ are the locally correct Lorentz boost generators for the region $O$ corresponding to the exact cancellation of higher order terms in (1.34) is the fact that second and higher order terms in $M_{\varkappa, g}^{0 k}(t)$ are localized $\approx$-outside region $O$ and hence $\approx$-commutes with $\varphi_{\varkappa}^{\#}(f)$. From (1.38) one obtains the relations

Remark 1.8 Note that because we can always translate in the positive $\boldsymbol{x}_{\boldsymbol{k}}, \boldsymbol{k}=\mathbf{1}, \mathbf{2}, \mathbf{3}$ directions, it is sufficient to prove Theorem 1.6 for sets $\boldsymbol{O}$ such that both $\boldsymbol{O}$ and $\boldsymbol{\Lambda}_{\boldsymbol{\beta}}^{(\boldsymbol{k})} \boldsymbol{O}, \boldsymbol{k}=\mathbf{1}, \mathbf{2}, \mathbf{3}$ are contained in $\boldsymbol{O}_{\boldsymbol{I}^{3}}$ for some \#-closed interval $\boldsymbol{I} \subset{ }^{*} \mathbb{R}_{c, \text { fin }+}^{\#}$. The advantage of working over ${ }^{*} \mathbb{R}_{c, \text { fin }+}^{\# 3}$ is that the locally correct Lorentz boost generators $\boldsymbol{M}_{\chi, g}^{\mathbf{0 k}}, \boldsymbol{k}=\mathbf{1 , 2 , 3}$ are bounded below.
2. Properties of the Lorentz boost generators $M_{\varkappa, g}^{0 k}, k=1,2,3$

In this section we consider the basic properties of $H_{\varkappa, g}$ and $M_{\varkappa, g}, k=1,2,3$ in particular, the first order estimates they satisfy. Note that $H_{\mathcal{\varkappa}, g}$ and $M_{\varkappa, g}^{0 k}, k=1,2,3$ are well defined operators on a nonArchimedean Fock space $\mathcal{F}^{\#}$. We take the definition of $\mathcal{F}^{\#}$ and the definition of the pointwise-defined time-zero field operators on $\mathcal{F}^{\#}$ as in [8] (see [8, Section 9]). The spatially cut-off Hamiltonian is defined as self-\#-adjoint operator on a non-Archimedean Fock space $\mathcal{F}^{\#}$ [8].
Let $g=\left\{g_{0}, g_{1}\right\}$, where $g_{0}=\left\{g_{0}^{(k)}\right\}, k=1,2,3, g_{0}^{(k)}, g_{1} \in C_{0}^{* \infty}\left({ }^{*} \mathbb{R}_{c, \text { fin }}^{\# 3},{ }^{*} \mathbb{R}_{\mathrm{c}, \text { fin }}^{\#}\right)$ and $g_{0}^{(k)}, g_{1} \geq$ $0, k=1,2,3$. The spatially cut-off Hamiltonian reads

## 3. Quadratic estimates

In this section we prove the self-\#-adjointness of the operators $M_{\varkappa, k}^{0 k}, k=1,2$, by interpreting the operator $T_{0, \varkappa, \kappa}$ as generalized Kato perturbation [8]. Thus we need proving quadratic inequalities

where $a_{\kappa}$ and $b$ are constants with $a_{\kappa}$ depending on $\kappa$. Here $\lambda$ is finite constant and $f_{0, k}=$ $\alpha^{-1} x_{k} g_{0}^{(k)}(x)$ where $g_{0}^{(k)}(x)$ satisfies conditions (2.5).

Theorem 3.1 The operators $M_{0, \chi, \kappa}^{i k}, k=1,2,3$ are essentially self-\#-adjoint on $D^{\#}$. There are constants $a$ and $b$ independent of $\kappa$, such that for $\kappa<\varkappa$ and $k=1,2,3$

It follows that $a(\boldsymbol{k})$ is defined on the \#-dense domain

where $I=\left\{i_{1}, \ldots, i_{s}\right\}$ be a set of distinct ordered positive integers, $(1, r)=\{1,2, \ldots, r\}$, $a_{I}=E x t-\prod_{l=1}^{S} a\left(k_{i_{l}}\right)$ for $s>0, a_{I}=I$ for $s=0$. The sum in (3.5) takes place over all partitions of $\{1,2, \ldots, r\}$ into disjoint subsets $I_{1}, \ldots, I_{j+1}$ (including permutations among the subsets) for $j=0$, $1, \ldots, r$. The elements of each $I_{i}$ are taken in natural order. Let $R_{J_{l}}=R(\zeta), R(z)=\left(T_{\varkappa}-z\right)^{-1}$, where $\zeta=z-E x t-\sum_{i \in J_{l}} \mu\left(k_{i}\right)$ and $J_{l}=I_{l} \cup I_{j+1} \cup \ldots \cup I_{j+1}$. Let $V^{I}=\left[a\left(k_{i_{1}}\right), \ldots,\left[a\left(k_{i_{s}}\right), V\right] \ldots\right]$ for $s>0$ and $V^{I}=0$ for $s=0$. Note that the sum (3.5) includes terms where $J_{j+1}$ is empty but not $I_{1}, \ldots, I_{j}$; this convention adjusts the sign $(-1)^{j}$ correctly. The $j=0$ term is simply $R_{1} a_{(1, r)} \psi$.

\left.+\lambda^{2} \sum_{i=1}^{2}\left\|\left(H_{0, \varkappa, \kappa}+\mu(k)\right)^{-\frac{1}{2}} X_{\varkappa, \kappa}^{(i)}(k) R_{\varkappa, \kappa}(-b) \psi\right\|_{\#}^{2}\right\} .
\end{gathered}

The integral of the first term on the right can be written as

where $H_{0, \mu, \kappa}^{-1 / 2}$ is taken equal to zero on the Fock vacuum. The terms in the integrand involving the $X_{\varkappa, \kappa}^{(i)}(k), i=1,2,3$, are all bounded by const. $\times \Theta(k, \kappa)$ by virtue of (3.20) and (2.13). Hence the integral is hyperfinite and the bound (3.18) holds. We remark that because of the momentum cut-off it was not necessary to use the full force of Lemmas 3.3-3.5, but only the estimates

Proposition 3.7 Let $T$ is a self-\#-adjoint operator and let $D$ be a \#-core for $T$. Suppose that $A$ is symmetric and that there are positive constants $a$ and $b$ with $a<1$ such that

Theorem 3.8 For $\kappa \leq \mathcal{u}$ and $g$ satiating (2.4), $M_{g, x, \kappa}^{0 k}, k=1,2,3$ are essentially self-\#-adjoint on $D$. Proof We show that $T_{\mathcal{\chi}, \kappa}^{0 k}$ given by (3.14) is self-\#-adjoint where $f_{0, k}=\left\{x_{k} g_{0}^{(k)} / \alpha\right\}, f_{1}=x_{k} g_{1} / \alpha$, $k=1,2,3$ and $\lambda=1$; this is equivalent to the statement of the theorem. We use Theorem 3.6 to prove Theorem 3.8 in spite of the fact that the conclusion of the second theorem appears as a hypothesis of the first. By Lemma 2.1 we know that there is a constant $c_{1}$ such that

Let us consider the sequence of values $\lambda=j / J, j=$ $0, \ldots, J$. Let $P_{j, k}$ be the statement that $T_{\chi, k}^{0 k}(j / J)$ is self-\#-adjoint and $Q_{j, k}$ the statement that $J^{-1} T_{0, \varkappa, \kappa}^{0 k}\left(f_{0, k}\right)$ is a Kato perturbation of $T_{\chi, k}^{0 k}(j / J)$, i.e., $\left\|J^{-1} T_{0, \chi, \kappa}^{0 k}\left(f_{0, k}\right) \psi\right\|_{\#} \leq a\left\|\left(T_{\chi, \kappa}^{0 k}(j / J)+b\right) \psi\right\|_{\#}$ for constants $a$ and $b$ with a < . As we have already observed, $P_{0, k}$ holds since $T_{\mathcal{\chi}, k}^{0 k}(0)$ reduces to the Hamiltonian $H_{f_{1}, \not, \kappa}$. Note that $P_{j, k}$ implies $Q_{j, k}, k=1,2,3$ since, for $\psi \in D\left(T_{\chi, k}^{0 k}(j / J)\right)$,

## 4. Higher order estimates

In this section we derive higher order estimates of the following form

The estimates (4.1) are used to prove that the powers $\left(M_{0, \mathcal{x}, \kappa}^{0 k}\right)^{j}$ are essentially self-\#-adjoint on $\mathcal{D}_{\text {fin }}^{\#}$ and do not survive in the \#-limit: $\kappa \rightarrow_{\#} \mathcal{X}$; on the other hand, the estimate (4.2) does transfer to the \#-limit $\kappa=\mathcal{\varkappa}$ and, in fact, enables us to prove that this \#-limit exists. For real $\tau \in{ }^{*} \mathbb{R}_{c}^{\#}$ we define the generalized number operator with hyperfinite momentum cut-off $\mathcal{\varkappa} \in{ }^{*} \mathbb{R}_{c, \infty}^{\#}$

From 4.14 we see that $D$ is also a \#-core for $B_{k}(0)+C=B_{k}\left(\lambda_{1}\right)$ and that $D\left(B_{k}\left(\lambda_{1}\right)\right)=D\left(B_{k}(0)\right)$ Continuing in this way we reach the conclusion that $D$ is a \#-core for $B_{k}(1)$. To complete the estimate (4.1), we dominate powers of $M_{\mathcal{\varkappa}, \kappa}^{0 k}, k=1,2,3$ by powers of $H_{0, \mu, \kappa}$.
Lemma 4.3 Let $j \in{ }^{*} \mathbb{N}$ be a positive hyperinteger. Then there are positive constants $b$ and $c_{\kappa}$, where $c_{\kappa}$ depends on $\kappa$ such that

Now because of the momentum cutoff, $M_{0, \varkappa, \kappa}^{0 k}$ has the form $M_{0, \nless, \kappa}^{0 k}=H_{0, \varkappa, \kappa}+\sum W_{i}$, where $W_{i}$ is a Wick monomial (2.12) whose kernel has \#-compact support. Each such monomial $W_{i}$ maps domain $D$ into a set of vectors which have a finite number of particles and which are of \#-compact support and $C^{*} \infty\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$ \#-almost everywhere in the momentum variables. It follows that $\left(M_{0, \varkappa, k}^{0 k}\right)^{j}$ can be expanded on $D$ into a sum of welldefined products of the form $A=E x t-\prod_{m=0}^{r} H_{0, x_{k}, ~}^{i_{2 m+1}} W^{i_{2 m+2}}$ where Ext- $\sum_{l=1}^{S} i_{l}=j$, and $W$ represents a typical Wick monomial in $M_{0, \mathcal{\varkappa}, \kappa}^{0 k}$. Each such product can be dominated by $\left(H_{0, \varkappa, \kappa}+b\right)^{n j}{ }_{\text {provided that }} b$ is chosen sufficiently large, say $b>2 n j \mu(\kappa)$. It suffices to show that

the operators $M_{\mathcal{\varkappa}, \kappa}^{0 k}+b, k=1,2$, . However we can dominate $H_{0, \mathcal{\varkappa}, \kappa}$ as in (4.2) if we abandon the requirement that the powers of $H_{0, \varkappa, \kappa}$ and $M_{\varkappa, \kappa}^{0 k}$ agree. The inequality

5. Essential self-\#-adjointness of the \#-limit $M_{\kappa, g}^{0 k}$ as $\kappa \rightarrow_{\#} \varkappa$

In the previous two sections we established a number of properties of the hyperfinite ultraviolet cutoff Lorentz boost generators $M_{\varkappa, \kappa}^{0 k}, k=1,2,3$ by methods that depended on $\kappa<\varkappa$ being hyperfinite. Now we take the \#-limit $\kappa \rightarrow_{\#} \mathcal{K}$ and find that many of the properties of $M_{\varkappa, \kappa}^{0 k}$ transfer to the \#-limiting operators $M_{\varkappa}^{0 k}, k=1,2,3$. As the next lemma states, $M_{\varkappa, \kappa}^{0 k}, k=1,2,3$ \#-converges to $M_{\varkappa}^{0 k}, k=1,2,3$ on the \#-dense domain

Note that \#-convergence in this sense is not strong enough to control the \#-limiting operator and in Theorem 5.3 we prove that the resolvents $R_{\varkappa, \kappa}^{(k)}(z)=\left(M_{\varkappa, \kappa}^{0 k}-z\right)^{-1}, k=1,2,3$ \#-converge in \#-norm. From this it follows that the operators $M_{\mathcal{\varkappa}}^{0 k}, k=1,2,3$ are essentially self-\#-adjoint on $D$.
Lemma 5.1 Let $\psi \in D_{n}$, then $M_{\mathcal{\varkappa}, \kappa}^{0 k} \psi \rightarrow_{\#} M_{0, \mathcal{H}}^{0 k} \psi, k=1,2,3$ as $\kappa \rightarrow_{\#} \mathcal{K}$.
Proof We write now $M_{\varkappa, \kappa, g}^{0 k}=H_{0, \varkappa, \kappa}+T_{0, \varkappa, \kappa}\left(x_{k} g_{0}^{(k)}\right)+T_{I, \varkappa, \kappa}\left(x_{k} g_{1}\right), k=1,2,3$ of the form

By the estimates (2.15), (2.16), and (4.26), $T_{0, \varkappa, \kappa}\left(f_{0, k}\right)$ and $T_{I, \mathcal{\varkappa}, \kappa}$ are defined on domain $D_{n}$, for $\kappa \leq$ $\mathcal{\varkappa}$. In fact, precisely these estimates prove \#-convergence. For consider the difference

Therefore, by (2.13), $\left\|A_{\mathcal{\varkappa}, \kappa}\left(N_{\mathcal{\varkappa}}+I\right)^{-n}\right\|_{\#}$ bounded by the $L_{2}^{\#}$-\#-norms of these tails which go to zero as $\kappa \rightarrow_{\#} \mathcal{H}$. Since a similar argument can be made for $T_{0, \varkappa, \kappa}^{(2)}(f)$ it follows that on $D_{n}$

where $\Theta(k, \kappa)$ is defined by $(2.10)$ with $\varkappa=\kappa$. Therefore,

where by (2.15) the right side is an $L_{2}^{\#}$ function in variables $\left(p_{1}, \ldots, p_{r}\right)$ whose \#-norm is bounded by const. $\left\|\left(H_{0, \varkappa}+I\right)^{-1} \psi_{r}\right\|_{\#}$. Moreover, as $\kappa \rightarrow_{\#} \mathcal{K},\left(B_{\varkappa, \kappa}^{(k)} \psi_{r}\right)\left(p_{1}, \ldots, p_{r}\right) \rightarrow_{\#} 0$ pointwise so that by the dominated \#-convergence theorem $\left\|B_{\chi, \kappa}^{(k)} \psi_{r}\right\|_{\#} \rightarrow_{\#} 0$. For the proof of resolvent \#- convergence we require a \#-norm \#-convergent statement for $T_{0, \mathcal{\chi}, k}^{(1)}\left(f_{0, k}\right)$. The failure in (5.3) is to be expected, for, roughly speaking; we can regard $T_{0, \varkappa, \kappa}^{(1)}\left(f_{0, k}\right)$ as $H_{0, \varkappa, \kappa}$ and obviously $C_{\varkappa, \kappa}=\left(H_{0, \varkappa}-H_{0, \varkappa, \kappa}\right)\left(H_{0, \varkappa}+\right.$ $I)^{-1}$ does not \#-converge to zero in \#-norm. However, this argument indicates that $\| B_{\chi, k}^{(k)}\left(H_{0, \varkappa}+\right.$ $I)^{-\tau} \|_{\#} \rightarrow_{\#} 0$ for $\tau>1$.
Lemma 5.2 Let $i, j \in{ }^{*} \mathbb{N}$ be nonnegative integers, and $f \in C_{0}^{* \infty}\left({ }^{*} \mathbb{R}_{c, \text { fin }+}^{\# 3 n},{ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}\right)$.

The essential supremum of a function $f$ is denoted $\approx-\operatorname{essup}_{x}(f)$. The essential supremum of the absolute value of a function $|f|$ is denoted $\|f\|_{* \infty}^{\# \approx}$ and this serves as the \#-norm for $L_{* \infty}^{\# \approx}$-infty-space.
As an example of (5.7), we consider the case $i=1$ and $j=2$. As in (5.4),

\leq\left\|w_{\varkappa, \kappa}(k, p)[\mu(p)]^{-1 / 2}\right\|_{\# 1,1} .

& \times\left(\approx-\operatorname{esssup}_{k}\left\{[\mu(k)]^{-\frac{1}{2}} E x t-\int|E x t-\hat{f}(k-p)|(\Theta(k, \varkappa) \Theta(p, \varkappa)-\Theta(k, \kappa) \Theta(p, \kappa)) d^{\# 3} p\right\}\right)
\end{aligned}
$$

\begin{equation*}
=\delta(\varkappa, \kappa) \rightarrow_{\#} 0 \text { as } \kappa \rightarrow_{\#} \mathcal{\varkappa} . \tag{5.11}
\end{equation*}

Theorem 5.3 There is a semibounded self-\#-adjoint operator $\boldsymbol{T}_{\mathcal{H}}$ such that for $\boldsymbol{z}$ sufficiently negative

Proof We first establish the \#-norm \#-convergence of the $2 n$-th powers $\left[R_{\kappa}(-b)\right]^{2 n}$ of the resolvents for all $b$ sufficiently large. Then the \#-norm \#-convergence of $R_{\kappa}(-b)$ follows by taking $2 n$-th roots and applying the generalized Stone-Weierstrass Theorem [8]. Let $\kappa \leq \boldsymbol{\varkappa}$ be two values of the hyperfinite ultraviolet cut-off. We use the following formula

by (5.7). This obviously establishes the \#-convergence of $R_{\kappa}^{2 n}$. Let $R_{\varkappa}(z)=\#-\lim _{\kappa \rightarrow \# \varkappa} R_{\kappa}(z)$. As a \#-limit of resolvents, $R_{\kappa}(z)$ is itself the resolvent of an operator if and only if the null space $N\left(R_{\mathcal{\varkappa}}(z)\right)=0$ for some $z$ [8]. But notice that this is a direct consequence of Lemma 5.1: Suppose that $\psi \in N\left(R_{\mathcal{\varkappa}}(-b)\right)$ where $b$ is sufficiently large so that $R_{\kappa}(-b)$ \#-converges. Take vector $\theta$ arbitrary in $D_{n}$. Then

Proof From the strong \#-convergence of $M_{\varkappa, \kappa}^{0 k}$ to $M_{\varkappa}^{0 k}$ on $D_{n}$ it follows by a simple argument that

(5.17) is just a restatement of (5.15). Since $H_{\varkappa}$ is a special case of $M_{\varkappa}^{0 k}$ obtained by setting, $g_{0}^{(k)}(x)=0$, it is clear that the higher order estimates (5.15) hold for $T_{\varkappa}=H_{\varkappa}$; hence the roles of $H_{\varkappa}$ and $M_{\varkappa}^{0 k}, k=1,2,3$ can be interchanged in (5.16) and (5.17).

## 6. Lorentz covariance

According to the discussion in Section 1 this amounts to showing that if $I^{3}=[a, b]^{3} \subset{ }^{*} \mathbb{R}_{c, \text {,fin }+}^{\# 3}$ and if $f$ is a $C_{0}^{* \infty}\left({ }^{*} \mathbb{R}_{c, \text { fin }}^{\# 4}, * \mathbb{R}_{c, \text { fii }}^{\#}\right)$ function with $\operatorname{supp}(f) \cup \operatorname{supp}\left(f_{\Lambda_{\beta}}\right) \subset O_{I^{3}}$, then on suitable near standard domain

$$
\begin{equation*}
\left[E x t-\exp \left(i M_{\varkappa}^{0 k} \beta\right)\right] \varphi_{\varkappa}(f)\left[E x t-\exp \left(-i M_{\varkappa}^{0 k} \beta\right)\right] \approx \varphi_{\varkappa}\left(f_{\Lambda_{\beta}}\right) \tag{6.1}

Notice that (6.1) is operator equality, since for ${ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}$ valued function $f, \varphi_{\varkappa}(f)$ is a self-\#-adjoint operator whose domain includes $D\left(\left(M_{\varkappa}^{i k}+b\right)^{1 / 2}\right)$. In addition, we prove on the domain $D\left(\left(M_{\varkappa}^{i k}+b\right)^{1 / 2}\right) \times D\left(\left(M_{\varkappa}^{i k}+b\right)^{1 / 2}\right)$ that

Here the vectors $(x, t)$ and $\Lambda_{\beta}(x, t)$ are in $O_{I^{3}}$, and the forms in (6.2) are \#-continuous in $x$ and $t$ by the first-order estimate (5.16) and results of [8] sect.6.

Notice that the main part in the proof of (6.1) is to verify the commutation relation (1.15) for $f \in$ $C_{0}^{* \infty}\left(O_{I^{3}},{ }^{*} \mathbb{R}_{c \text {,fin }}^{\#}\right)$ and $g$ a cut-off function for the region $O_{I^{3}}$. For convenience, we assume that a function $f$ with support contained in the region $O_{\varepsilon}$ defined by

It follows from this assumption that if $|s|<\varepsilon$, then external integral

The main parts of the proof are as follows:
Part1. For $\psi \in D\left(H_{\varkappa}^{n+3}\right)$ we define

Since the operators $P_{\varkappa}^{k}$ and $M_{\varkappa}^{i k}$ are defined on $D\left(H_{\varkappa}^{n}\right)$, extends to an operator equality on $D\left(H_{\varkappa}^{n+1}\right)$. Therefore, we obtain on the domain $D\left(H_{\varkappa}^{n+2}\right) \times$ $D\left(H_{\varkappa}^{n+2}\right)$ that

The exact statement is $\left[S^{k}, \mathfrak{R}\left(I^{3}\right)\right]=0, k=1,2,3$ on domain $D_{n}^{\#} \times D_{n}^{\#}$. Note that $D_{n}^{\#} \subset D\left(S^{k}\right), k=1,2,3$. It follows from (6.4) and (6.6) on domain $D_{n}^{\#} \times D_{n}^{\#}$ that

Let $\psi \in D\left(H_{\varkappa}\right)$; since $D\left(H_{\varkappa}^{n+3}\right)$ is a \#-core for $H_{\varkappa}$, there exists a hyper infinite sequence $\psi_{l}, l \in{ }^{*} \mathbb{N}$ in $D\left(H_{\varkappa}^{n+3}\right)$ such that $\psi_{l} \rightarrow_{\#} \psi$ and $H_{\varkappa} \psi_{l} \rightarrow_{\#} H_{\varkappa} \psi$ as $l \rightarrow^{*} \infty$. By the first order estimate, we have for some constants $a$ and $b$

## $\S 7$. The spectral theorem related to bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ operators.

In this section, we will discuss the generalized spectral theorem in its many aspects. This structure theorem is a concrete description of all self-\#-adjoint operators. There are several apparently distinct formulations of the spectral theorem. In some sense they are all equivalent. The form we prefer in this section, says that every bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator is a multiplication operator. This means that given a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator $A$ on a non-Archimedean Hilbert space $H^{\#}$, we can always find a \#-measure $\mu^{\#}$ on a \#-measure space $M$ and a unitary operator $U: H^{\#} \rightarrow$ $L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)$ so that $\left(U A U^{-1} f\right)(x)=F(x) f(x)$ for some bounded ${ }^{*} \mathbb{R}_{c}^{\#}$-valued \#-measurable function $F$ on $M$. In practice, $M$ will be a union of copies of ${ }^{*} \mathbb{R}_{c}^{\#}$ and $F$ will be $x$ so the core of the proof of the theorem will be the construction of certain \#-measures. Our main goal in this section will be to make sense out of $f(A)$, for $f$ a \#-continuous function. We will consider also the \#-measure defined by the functional: $f \mapsto\langle\psi, f(A) \psi\rangle_{\#}$ for fixed $\psi \in H^{\#}$.
Definition 7.1.The operator \#-norm of a linear operator $A: H^{\#} \rightarrow H^{\#}$ is the largest value by which $A$ stretches an element of $H^{\#}$,

$$
\|A\|_{\# \mathrm{op}}=\|A\|_{\mathcal{L}\left(H^{\#}\right)}=\sup \left\{\|A x\|_{\#} \mid x \in H^{\#},\|x\|_{\#}=1\right\}
$$

An operator $A$ is called bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ if $\|A\|_{\# \text { op }}<{ }^{*} \infty$, otherwise operator $A$ is called unbounded in ${ }^{*} \mathbb{R}_{c}^{\#}$. We often write bounded operator instead bounded in ${ }^{*} \mathbb{R}_{c}{ }_{c}$ and unbounded operator correspondingly.
Definition7.2. A linear operator $A: H^{\#} \rightarrow H^{\#}$ is called finitely bounded if $\|A\|_{\mathcal{L}\left(H^{\#}\right)}=\|A\|_{\# \text { op }} \in$ ${ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}$ i.e., if $\|A\|_{\# \text { op }}$ is a near standard number.
Definition7.3. Let $\mathbb{C}^{\#}(U)$ be the linear space of ${ }^{*} \mathbb{C}_{c}^{\#}$ - valued \#-continuous functions of \#-compact
support $U \subset{ }^{*} \mathbb{R}_{c}^{\#}$ endowed with the essential sup \#-norm $\|f\|_{*^{*}}=\operatorname{ess}_{\sup }^{x \in U}$ $\{f(x)\}$. An function $f$ in $C^{\#}(U)$ is called finitely bounded if $\|f\|^{*}{ }^{\infty} \in{ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}$ i.e., if $\|f\|^{*}$ is a near standard number.
Definition7.4. We define now $\mathrm{C}_{\text {fin }}^{\#}(U) \subsetneq C^{\#}(U)$ by

$$
\mathrm{C}_{\text {fin }}^{\#}(U)=\left\{f \mid\left[f \in \mathrm{C}^{\#}(U)\right] \wedge\left[\|f\|_{* \infty} \in{ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}\right]\right\} .
$$

An function $f$ is called finitely bounded if $f \in \mathrm{C}_{\text {fin }}^{\#}(U)$ i.e. if $\|f\|_{* \infty} \in{ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}$. Note that $\mathrm{C}_{\text {fin }}^{\#}(U)$ is a linear space over field ${ }^{*} \mathbb{R}_{c, \text { fin }}^{\#}$.
Theorem7.1. (\#-continuous functional calculus) Let $A$ be a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator on a non-Archimedean Hilbert space $H^{\#}$. Then there is a unique map $\phi: C^{\#}(\sigma(A)) \rightarrow \mathcal{L}\left(H^{\#}\right)$ with the following properties:
(a) $\phi$ is an algebraic $*$-homomorphism, that is,

$$
\phi(f g)=\phi(f) \phi(g), \phi(\lambda f)=\lambda \phi(f), \phi(1)=I, \phi(f)=\phi(f)^{*} .
$$

(b) $\phi$ is \#-continuous, that is, $\|\phi(f)\|_{\mathcal{L}\left(H^{\#}\right)} \leq C\|f\|^{*} \infty$.
(c) Let $f$ be the function $f(x)=x$; then $\phi(f)=A$.

Moreover, $\phi$ have the additional properties:
(d) If $\mathrm{A} \psi=\lambda \psi$, then $\phi(f) \psi=f(\lambda) \psi$.
(e) $\sigma[\phi(f)]=\{f(\lambda) \mid \lambda \in \sigma(A)\}[$ Spectral mapping theorem].
(f) If $f \geq 0$, then $\phi(f) \geq 0$.
(g) $\|\phi(f)\|_{\mathcal{L}\left(H^{\#}\right)}=\|f\|^{*}{ }^{*}$.

Remark 7.1.The proof which we give below is quite simple, (a) and (c) uniquely determine $\phi(\mathrm{P})$ for any hyperfinite polynomial $P(x)$. By the generalized Weierstrass theorem 7.3 , the set of hyperfinite polynomials is \#-dense in $\mathrm{C}^{\#}(\sigma(A))$ so the main part of the proof is showing that $\|P(A)\|_{\# o p}=$ $\sup _{\lambda \in \sigma(A)}|P(\lambda)|$. The existence and uniqueness of $\varphi$ then follow from the generalized B.L.T. theorem 7.4. To prove the crucial equality, we first prove a special case of (e) which holds for arbitrary bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ operators.

Lemma7.1. Let $P(x)=E x t-\sum_{n=1=0}^{N} c_{n} x^{n}, N \in{ }^{*} \mathbb{N} . P(A)=E x t-\sum_{n=1=0}^{N} c_{n} A^{n}$. Then

\sigma(P(A))=\{P(\lambda) \mid \lambda \in \sigma(A)\} .
$$

Proof Let $\lambda \in \sigma(A)$. Since $x=\lambda$ is a root of $P(x)-P(\lambda)$, we have $P(x)-P(\lambda)=(x-\lambda) Q(x)$, so $P(A)-P(\lambda)=(A-\lambda) Q(A)$. Since $(A-\lambda)$ has no inverse neither does $P(A)-P(\lambda)$ that is, $P(\lambda) \in \sigma(P(A))$. Conversely, let $\mu \in \sigma(P(A))$ and let $\lambda_{1}, \ldots, \lambda_{n}$ be the roots of $P(x)-\mu$, that is, $P(x)-\mu=a\left(E x t-\prod_{i=1}^{n}\left(x-\lambda_{i}\right)\right.$. If $\lambda_{1}, \ldots, \lambda_{n} \notin \sigma(A)$, then $(P(A)-\mu)^{-1}=a^{-1}\left[E x t-\prod_{i=1}^{n}(x-\right.$ $\left.\lambda_{i}\right)^{-1}$ ] so we conclude that some $\lambda_{i} \in \sigma(A)$ that is, $\mu=P(\lambda)$ for some $\lambda \in \sigma(A)$.
Definition 7.5. Let $r(A)=\sup _{\lambda \in \sigma(A)}|\lambda|$.Then $r(A)$ is called the spectral radius of $A$.
Theorem 7.2. Let $X$ be a non-Archimedean Banach space, $A \in \mathcal{L}(X)$. Then \#-lim ${ }_{n \rightarrow * * \infty} \sqrt[n]{\left\|A^{n}\right\|_{\# o p}}$ exists and is equal to $r(A)$. If $X$ is a non-Archimedean Hilbert space and $A$ is self-\#-adjoint, then
$r(A)=\|A\|_{\mathcal{L}(X)}$
Lemma 7.2 Let $A$ be a bounded self-\#-adjoint operator. Then

\|P(A)\|_{\# o p}=\sup _{\lambda \in \sigma(A)}|P(\lambda)| .
$$

Proof By theorem 6.2 we obtain

Notation7.1.We often write $\phi_{A}(f)$ or $f(A)$ for $\phi(f)$ in order to emphasize the dependence on operator $A$.
Definition7.6. (Hyperfinite Bernstein Polynomials) For each $n \in{ }^{*} \mathbb{N}$, the $n$-th hyperfinite Bernstein Polynomial $B_{n}^{\#}(x, f)$ of a function $f \in \mathrm{C}^{\#}\left([a, b],{ }^{*} \mathbb{R}_{c}^{\#}\right)$ is defined as

B_{n}^{\#}(x, f)=E x t-\sum_{k=0}^{n} f\left(\frac{k}{n}\right)\binom{n}{k} x^{k}(1-x)^{n-k}
$$

Theorem7.3. (Generalized Weierstrass approximation theorem) Let $f \in C^{\#}\left([a, b],{ }^{*} \mathbb{R}_{c}^{\#}\right),[a, b] \subset$ ${ }^{*} \mathbb{R}_{c}^{\#}$. Then there is a hyper infinite sequence of polynomials $p_{b}(x), n \in{ }^{*} \mathbb{N}$ that \#-converges uniformly to $f(x)$ on $[a, b]$.
Proof Consider first $f \in \mathbb{C}^{\#}\left([0,1],{ }^{*} \mathbb{R}_{c}^{\#}\right)$. Once the theorem is proved for this case, the general theorem will follow by a change of variables. Since $[0,1]$ is \#-compact, the \#-continuity of $f$ implies uniform \#-continuity. So, given $\varepsilon>0$, there exists $\delta>0$ such that: $\forall x, y(x, y \in[0,1])[|x-y| \leq \delta \Rightarrow$ $|f(x)-f(y)| \leq \varepsilon / 2]$. Now, let $M=\|f\|^{*}$. Note that $M$ exists since $f$ is a \#-continuous function on a \#-compact set. Now, fix $\xi \in[0,1]$. Then, if $|x-\xi| \leq \delta$, then the inequality holds $\mid f(x)-$ $f(\xi) \mid \leq \varepsilon / 2$ by \#-continuity. Alternatively, if $|x-\xi| \geq \delta$, then

$$
|f(x)-f(\xi)| \leq 2 M \leq 2 M\left(\frac{x-\xi}{\delta}\right)^{2}+\varepsilon / 2
$$

From the above two inequalities, we obtain that

$$
\forall x(x \in[0,1])\left[|f(x)-f(\xi)| \leq 2 M\left(\frac{x-\xi}{\delta}\right)^{2}+\varepsilon / 2\right]
$$

The hyperfinite Bernstein Polynomials can be used to approximate $f(x)$ on $[0,1]$. First, note that

$$
B_{n}^{\#}(x, f-f(\xi))=B_{n}^{\#}(x, f)-f(\xi) B_{n}^{\#}(x, 1)
$$

and for all $n \in * \mathbb{N}$

$$
B_{n}^{\#}(x, 1)=\text { Ext }-\sum_{k=0}^{n}\binom{n}{k} x^{k}(1-x)^{n-k}=(x+(1-x))^{n}=1,
$$

where the generalized Binomial Theorem was used in the second equality. Thus,

$$
\left|B_{n}^{\#}(x, f-f(\xi))\right| \leq B_{n}^{\#}\left(x, 2 M\left(\frac{x-\xi}{\delta}\right)^{2}+\frac{\varepsilon}{2}\right)=\frac{2 M}{\delta^{2}} B_{n}^{\#}\left(x,(x-\xi)^{2}\right)+\varepsilon / 2
$$

where in the second step the fact that $0 \leq B_{n}^{\#}(x, f)$ for $0 \leq f$ and $B_{n}^{\#}(x, g) \leq B_{n}^{\#}(x, f)$ if $g \leq f$ were used. Both can be proven directly from the definition of $B_{n}^{\#}(x, f)$. It can also be shown that

$$
B_{n}^{\#}\left(x,(x-\xi)^{2}\right)=x^{2}+n^{-1}\left(x-x^{2}\right)-2 \xi x+\xi^{2} .
$$

So

$$
\left|B_{n}^{\#}(x, f-f(\xi))\right| \leq \frac{\varepsilon}{2}+\frac{2 M\left(x-\xi^{2}\right)}{\delta^{2}}+\frac{2 M\left(x-x^{2}\right)}{n \delta^{2}} .
$$

In particular,

$$
\left|B_{n}^{\#}(\xi, f-f(\xi))\right| \leq \frac{\varepsilon}{2}+\frac{2 M\left(\xi-\xi^{2}\right)}{n \delta^{2}} .
$$

A simple calculation shows that on $[0,1]$, the maximum of $z-z^{2}$ is $1 / 4$. Thus,

$$
\left|B_{n}^{\#}(\xi, f-f(\xi))\right| \leq \frac{\varepsilon}{2}+\frac{2 M}{n \delta^{2}} .
$$

So, take $N \geq \frac{M}{2 \delta^{2} \varepsilon^{\prime}}$ for $n \geq N$ we get

$$
\left\|B_{n}^{\#}(\xi, f-f(\xi))\right\|_{*_{\infty}} .
$$

This proves the theorem for \#-continuous functions on $[0,1]$. Now we let $g \in C^{\#}([a, b])$. Consider the function $\varphi:[0,1] \rightarrow[a, b]$ defined by $\varphi: x \mapsto(b-a) x-a, \varphi$ is clearly a homeomorphism. Thus, the composite function $f=g \circ \varphi$ is a \#-continuous on $[0,1]$. By application of the theorem for functions on $[0,1]$, the case for an arbitrary interval $[a, b]$ follows.
Theorem 7.4. (Generalized B.L.T. theorem) Suppose that $Z$ is a non-Archimedean normed space, $Y$ is a non-Archimedean Banach space, and $S \subset Z$ is a \#-dense linear subspace of $Z$. If $T: S \rightarrow Y$ is a bounded in $\mathbb{R}_{c}^{\#}$ linear transformation (i.e. there exists $C<{ }^{*} \infty$ such that $\|T z\|_{\#} \leq C\|z\|_{\#}$ for all $z \in S$ ), then $T$ has a unique extension to an element of $\mathcal{L}(Z, Y)$.
Definition 7.7. (Unital Sub-Algebra, Separating Points). Let $K$ be a \#-compact metric space. Consider the non-Archimedean Banach algebra $\mathrm{C}^{\#}\left(K,{ }^{*} \mathbb{R}_{c}^{\#}\right)=\left\{f: K \rightarrow{ }^{*} \mathbb{R}_{c}^{\#} \mid f\right.$ is \#-continuous $\}$ equipped with the sup-norm, $\|f\|^{*} \infty$. Then, (1) $A \subset C^{\#}\left(K,{ }^{*} \mathbb{R}_{c}^{\#}\right)$ is a unital sub-algebra if $1 \in A$ and if $f, g \in A, \alpha, \beta \in{ }^{*} \mathbb{R}_{c}^{\#}$ implies that $\alpha f+\beta g \in A$ and $f g \in A$. (2) $A \subset C^{\#}\left(K,{ }^{*} \mathbb{R}_{c}^{\#}\right)$ separates points of $K$ if for all $s, t \in K$ with $s \neq t$, there exists $f \in A$ such that $f(s) \neq f(t)$.
Proof of the Theorem 7.1. Let $\phi(P)=P(A)$. Then $\|\phi(P)\|_{\mathcal{L}\left(H^{\#}\right)}=\|P\|_{C^{\#}(\sigma(A))}$ so $\phi$ has a unique linear extension to the \#-closure of the polynomials in $\mathrm{C}^{\#}(\sigma(A)$. Since the polynomials are an algebra containing $I$, containing complex conjugates, and separating points, this \#-closure is all of $\mathrm{C}^{\#}(\sigma(A)$. Properties (a), (b), (c), (g) are obvious and if $\tilde{\phi}$ obeys (a), (b), (c) it agrees with $\phi$ on polynomials and thus by \#-continuity on $C^{\#}(\sigma(A)$. In order to prove (d), note that $\phi(P) \psi=P(\lambda) \psi$ and apply \#-continuity. To prove (f), notice that if $f \geq 0$, then $f=g^{2}$ with $g$ is ${ }^{*} \mathbb{R}_{c}^{\#}$-valued and $g \in \mathrm{C}^{\#}(\sigma(A)$. Thus $\phi(f)=\phi(g)^{2}$ with $\phi(g)$ self-\#-adjoint, so $\phi(f) \geq 0$.
Remark 7.2 Notice that in addition the following statements hold:
(1) $\phi(f) \geq 0$ if and only if $f \geq 0$.
(2) Since $f g=g f$ for all $f, g,\left\{f(A) \mid f \in \mathbb{C}^{\#}(\sigma(A))\right\}$ forms an abelian algebra closed under adjoints.
(3) Since $\|\phi(f)\|_{\mathcal{L}\left(H^{\#}\right)}=\|f\|^{* \infty}$ and $\mathrm{C}^{\#}(\sigma(A))$ is \#-complete, $\left\{f(A) \mid f \in \mathrm{C}^{\#}(\sigma(A))\right\}$
is \#-norm-\#-closed. It is thus a non-Archimedean an abelian $\mathrm{C}^{*}$ algebra over field ${ }^{*} \mathbb{C}_{c}^{\#}$ of operators.
(4) $\operatorname{Ran}(\phi)$ is actually the non-Archimedean $\mathrm{C}^{*}$-algebra generated by $A$ that is, the smallest $\mathbf{C}^{*}$-algebra
over field ${ }^{*} \mathbb{C}_{c}^{\#}$ containing $A$.
(5) Notice that $C^{\#}(\sigma(A))$ and the non-Archimedean $\mathrm{C}^{*}$-algebra generated by $A$ are \#-isometrically isomorphic.
(6) The statement (b) actually follows from (a) and Proposition 7.1. Thus (a) and (c) alone determine $\phi$ uniquely.
Proposition 7.1 Suppose that $\phi: \mathrm{C}^{\#}(X) \rightarrow \mathcal{L}\left(H^{\#}\right)$ is an algebraic $*$-homomorphism, $X$ a \#-compact metric space. Then: (a) if $f \geq 0$, then $\phi(f) \geq 0$, (b) $\|\phi(f)\|_{\mathcal{L}\left(H^{\#}\right)} \leq\|f\|_{*_{\infty}}$.
8. The spectral \#-measures.

Definition 8.1. [16] ( $\sigma^{\#}$ - Algebra). Let $X$ be any set. A family $\mathcal{F} \subset 2^{X}$ is called a $\sigma^{\#}$ - algebra on $X$, if:
(i) $\emptyset \in \mathcal{F}$;
(ii) $\mathcal{F}$ is closed under complements, i.e. $A \in \mathcal{F}$ implies $X \backslash A \in \mathcal{F}$;
(iii) $\mathcal{F}$ is closed under hyper infinite unions, i.e. if $A_{n}, n \in{ }^{*} \mathbb{N}$ is a hyper infinite sequence in $\mathcal{F}$ then $\cup_{n \in{ }^{*} \mathbb{N}} A_{n} \in \mathcal{F}$.
Proposition 8.1.If $\mathscr{F}$ is a $\sigma^{\#}$ - algebra on $X$ then:

1. $\mathscr{F}$ is closed under hyper infinite intersections, i.e. if $A_{n}, n \in{ }^{*} \mathbb{N}$ is a hyper infinite sequence in $\mathcal{F}$ then $\bigcap_{n \in{ }^{*} \mathbb{N}} A_{n}$.
2. $X \in \mathcal{F}$.
3. $\mathscr{F}$ is closed under hyperfinite unions and hyperfinite intersections.
4. $\mathscr{F}$ is closed under set differences.
5. $\mathscr{F}$ is closed under symmetric differences.

Proposition 8.2. Suppose $\mathcal{F} \subset 2^{X}$ is a family of subsets satisfying the following:

1. $\varnothing \in \mathcal{F}$;
2. $\mathcal{F}$ is closed under complements;
3. $\mathcal{F}$ is closed under hyper infinite intersections.

Then $\mathcal{F}$ is a $\sigma^{\#}$ - algebra.
Proposition 8.3.If $\mathcal{F}_{\alpha}, \alpha \in I$ is a collection of $\sigma^{\#}$ - algebras on $X$, then $\bigcap_{\alpha} \mathcal{F}_{\alpha}$ is also a $\sigma^{\#}$ - algebra on $X$.
Proposition 8.4. ( $\sigma^{\#}$ - algebra generated by subsets). Let $K$ be a collection of subsets of $X$.There exists a $\sigma^{\#}$ - algebra, denoted $\sigma^{\#}(K)$ such that $K \subset \sigma^{\#}(K)$ and for every other $\sigma^{\#}$ - algebra $\mathcal{F}$ such that $K \subset \mathcal{F}$ we have that $\sigma^{\#}(K) \subset \mathcal{F}$. We call $\sigma^{\#}(K)$ the $\sigma^{\#}$ - algebra generated by $K$.
Proof Define $\sigma^{\#}(K) \triangleq \bigcap\left\{\mathcal{F} \mid \mathcal{F}\right.$ is a $\sigma^{\#}$ - algebra on $\left.X, K \subset \mathcal{F}\right\}$. This obviously is a $\sigma^{\#}$ - algebra with the required properties.
Proposition 8.5.If $K \subset \mathcal{L}$ then $\sigma^{\#}(K) \subset \sigma^{\#}(\mathcal{L})$. Also, if $K \subset \mathcal{F}$ and $\mathcal{F}$ is a $\sigma^{\#}$ - algebra, then $\sigma^{\#}(K)$ $\subset \mathcal{F}$.
Definition 8.2.[16] (Borel $\sigma^{\#}$ - algebra). Given a topological space $X$, the Borel $\sigma^{\#}$ - algebra is the $\sigma^{\#}$ algebra generated by the open sets. It is denoted $B^{\#}(X)$; specifically in the case $X={ }^{*} \mathbb{R}_{c}^{\# d}, d \in{ }^{*} \mathbb{N}$ we have that by definition $B^{\#}\left({ }^{*} \mathbb{R}_{c}^{\# d}\right)=\sigma^{\#}(U \mid U$ is an -open set $)$.
Definition 8.3.A Borel-\#-measurable set, i.e. a set in $B^{\#}(X)$, is called a \#-Borel set.
Definition 8.4. Let $f$ be a ${ }^{*} \mathbb{R}_{c}^{\#}$-valued function defined on a set $X$. We suppose that some $\sigma^{\#}$ - algebra $\Omega \subseteq P(X)$ is fixed. We say that f is \#-measurable, if $f^{-1}([a, b]) \in \Omega$ for any hyperreals $a, b \in{ }^{*} \mathbb{R}_{c}^{\#}$ such that $a<b$.
Proposition 8.6. [16] Let $f: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ be a function. Then the following conditions are equivalent:
(a) $f$ is \#-measurable;
(b) $f^{-1}([0, b)) \in \Omega$ for any hyperreal $b \in{ }^{*} \mathbb{R}_{c}^{\#}$;
(c) $f^{-1}\left(\left(b,{ }^{*} \infty\right)\right) \in \Omega$ for any hyperreal $b \in{ }^{*} \mathbb{R}_{c}^{\#}$;
(d) $f^{-1}(S) \in \Omega$ for any $S \in B^{\#}\left({ }^{*} \mathbb{R}_{c}^{\# d}\right)$.

Proposition 8.7. Let $f$ and $g$ be \#-measurable functions, then
(a) $(\alpha \times f)+(\beta \times g)$ is \#-measurable for any $a, b \in{ }^{*} \mathbb{R}_{c}^{\#}$;
(b) functions $\max \{f, g\}$ and $f \times g$ are \#-measurable;
(c) functions $f_{+}=\max \{f, 0\}, f_{-}=(-f)_{+}$, and $|f|=f_{+}+f_{-}$are \#-measurable.

Definition8.5. A pair $(X, \mathcal{F})$ where $\mathcal{F}$ is a $\sigma^{\#}$ - algebra on $X$ is call \#-measurable space. Elements of $\mathscr{F}$ are called \#-measurable sets. Given a \#-measurable space $(X, \mathcal{F})$, a function $\mu^{\#}: \mathcal{F} \rightarrow\left[0,{ }^{*} \infty\right]$ is called \#-measure on $(X, \mathcal{F})$ if:

1. $\mu^{\#}(\varnothing)=0$;
2. (Hyper infinite additivity) For all hyper infinite sequences $A_{n}, n \in{ }^{*} \mathbb{N}, A_{n} \in \mathcal{F}$ of pairwise disjoint sets in $\mathcal{F}$, we have that $\mu^{\#}\left(\cup_{n \in{ }^{*} \mathbb{N}} A_{n}\right)=E x t-\sum_{n \in{ }^{*} \mathbb{N}} \mu^{\#}\left(A_{n}\right)$.
Definition8.6.[16] $\left(X, \mathcal{F}, \mu^{\#}\right)$ is called a \#-measure space. A \#-measure space $\left(X, \mathcal{F}, \mu^{\#}\right)$ is called hyperfinite if $\mu^{\#}(X)<{ }^{*} \infty$. It is called $\sigma^{\#}$ - hyperfinite if $X=\bigcup_{n \in{ }^{*} \mathbb{N}} A_{n}$ where $A_{n} \in \mathcal{F}$ and $\mu^{\#}\left(A_{n}\right)<$ ${ }^{*} \infty$ for all $n \in{ }^{*} \mathbb{N}$.
Definition 8.7.Let $\mathcal{F}$ is a $\sigma^{\#}$ - algebra of subsets of a set $X$, and let $E=\left(E,\|\cdot\|_{\#}\right)$ be a non-
Archimedean Banach space. A function $\mu^{\#}: \mathcal{F} \rightarrow E \cup\left\{{ }^{*} \infty\right\}$ is called a vector-valued \#-measure (or $E$-valued \#-measure) if:
3. $\mu^{\#}(\emptyset)=0$;
4. $\mu^{\#}\left(\cup_{n \in{ }^{*} \mathbb{N}} A_{n}\right)=E x t-\sum_{n \in{ }^{*} \mathbb{N}} \mu^{\#}\left(A_{n}\right)$ for any pairwise disjoint sequence $A_{n}, n \in{ }^{*} \mathbb{N}, A_{n} \in \mathcal{F}$;
5. For any $S \in \mathcal{F}, \mu^{\#}(S)={ }^{*} \infty$, there exists $B \in \mathcal{F}$ such that $B \subseteq S$ and $0<\left\|\mu^{\#}(B)\right\|_{\#}<{ }^{*} \infty$.

Definition 8.8. (a) Let $\mathcal{F}$ be a $\sigma^{\#}$ - algebra of subsets of a set $X$. A function $\mu^{\#}: \mathcal{F} \rightarrow{ }^{*} \mathbb{C}_{c}^{\#} \cup\left\{{ }^{*} \infty\right\}$ is called a complex \#-measure if:

1. $\mu^{\#}(\emptyset)=0$;
2. $\mu^{\#}\left(\cup_{n \in{ }^{*} \mathbb{N}} A_{n}\right)=E x t-\sum_{n \in{ }^{*} \mathbb{N}} \mu^{\#}\left(A_{n}\right)$ for any pairwise disjoint sequence $A_{n}, n \in{ }^{*} \mathbb{N}, A_{n} \in \mathcal{F}$;
3. For any $S \in \mathcal{F}, \mu^{\#}(S)={ }^{*} \infty$, there exists $B \in \mathcal{F}$ such that $B \subseteq S$ and $0<\left|\mu^{\#}(B)\right|_{\#}<{ }^{*} \infty$.
(b) Let $\mathcal{F}$ be a $\sigma^{\#}$ - algebra of subsets of a set $X$. A function $\mu^{\#}: \mathcal{F} \rightarrow{ }^{*} \mathbb{R}_{c}^{\#} \cup\left\{{ }^{*} \infty\right\}$ is called a signed \#-measure if:
4. $\mu^{\#}(\emptyset)=0$;
5. $\mu^{\#}\left(\cup_{n \in{ }^{*} \mathbb{N}} A_{n}\right)=E x t-\sum_{n \in{ }^{*} \mathbb{N}} \mu^{\#}\left(A_{n}\right)$ for any pairwise disjoint sequence $A_{n}, n \in{ }^{*} \mathbb{N}, A_{n} \in \mathcal{F}$;
6. For any $S \in \mathcal{F}, \mu^{\#}(S)={ }^{*} \infty$, there exists $B \in \mathcal{F}$ such that $B \subseteq S$ and $0<\left|\mu^{\#}(B)\right|_{\#}<{ }^{*} \infty$.

Definition 8.9. If a certain property involving the points of \#-measure space is true, except a subset having \#-measure zero, then we say that this property is true \#-almost everywhere (abbreviated as \#-a.e.).
Definition 8.10.Let $\left(X, \mathcal{F}, \mu^{\#}\right)$ is a \#-measura space and let $f_{n}, n \in{ }^{*} \mathbb{N}$ be a hyper infinite sequence of ${ }^{*} \mathbb{R}_{c}^{\#}$-valued functions defined on $X$. We say that:

1. $f_{n} \rightarrow_{\#} f$ pointwise, if $f(x) \rightarrow_{\#} f(x)$ for all $x \in X$;
2. $f_{n} \rightarrow_{\#} f$ almost \#-everywhere (\#-a.e.), if $f_{n}(x) \rightarrow_{\#} f(x)$ for all $x \in X$ except a set of \#-measure 0 ;
3. $f_{n} \rightarrow_{\#} f$ \#-uniformly, if for any $\varepsilon>0, \varepsilon \approx 0$ there is $N(\varepsilon) \in{ }^{*} \mathbb{N}$ such that $\sup \left\{\left|f_{n}(x)-f(x)\right|: x \in\right.$ $X\} \leq \varepsilon$ for all $n \geq N(\varepsilon)$.
In the following definitions, we fix a $\sigma^{\#}$ - hyperfinite \#-measure space $\left(X, \mathcal{F}, \mu^{\#}\right)$.
Definition 8.11.Let $A_{i} \in \mathcal{F}, i=1, \ldots, n \in{ }^{*} \mathbb{N}$ be such that $\mu^{\#}\left(A_{i}\right)<{ }^{*} \infty$ for all $i$, and $\quad A_{i} \cap A_{j}=\emptyset$ for all $i \neq j$. The external function defined by

$$
f(x)=E x t-\sum_{i=1}^{n} \lambda_{i} \chi_{A_{i}}(x)
$$

$\lambda_{i} \in{ }^{*} \mathbb{R}_{c}^{\#}$, is called a simple external function. The Lebesgue external integral (Lebesgue \#-integral) of a simple external function $f(x)$ is defined as

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#}=E x t-\sum_{i=1}^{n} \lambda_{i} \mu^{\#}\left(A_{i}\right)
$$

Definition 8.12. Suppose the \#-measura $\mu^{\#}$ is hyperfinite. Let $f: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ be an arbitrary nonnegative bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ \#-measurable external function and let $f_{n}, n \in{ }^{*} \mathbb{N}$, be a hyper infinite sequence of simple external functions which \#-converges \#-uniformly to $f$. Then the Lebesgue \#-integral of $f$ is

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#}=\#-\lim _{n \rightarrow{ }^{*} \infty}\left(E x t-\int_{X} f_{n}(x) d^{\#} \mu^{\#}\right)
$$

Definition 8.13.[16] Let $f: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ be a \#-measurable function. Then the Lebesgue \#-integral of $f$ is defined by

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#}=E x t-\int_{X} f^{+}(x) d^{\#} \mu^{\#}-E x t-\int_{X} f^{-}(x) d^{\#} \mu^{\#}
$$

If both of these terms are finite or hyperfinite then the function f is called \#-integrable. In this case we write $f \in L_{1}^{\#}\left(X, \mathcal{F}, \mu^{\#}\right)$.

Notation 8.1.[16] Assume that $f, g: X \rightarrow^{*} \mathbb{R}_{c}^{\#}$ are \#- integrable functions and such that $f \leq_{s} g \#$-a.e. . If

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#} \leq E x t-\int_{X} g(x) d^{\#} \mu^{\#}
$$

we abbreviate $f \leq_{s} g$.
Proposition 8.8. (1) Let $f: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ be an arbitrary nonnegative \#-measurable function then
$E x t-\int_{X} f(x) d^{\#} \mu^{\#}=\sup \left\{E x t-\int_{X} \varphi(x) d^{\#} \mu^{\#} \mid \varphi\right.$ is a simple function such that $\left.0 \leq \varphi(x) \leq f(x)\right\}$.
(2) If $f, g: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ are \#-measurable, $g$ is \#-integrable, and $|f(x)| \leq_{s} g(x)$, then $f$ is \#-integrable and

$$
\left|E x t-\int_{X} f(x) d^{\#} \mu^{\#}\right| \leq E x t-\int_{X} g(x) d^{\#} \mu^{\#}
$$

(3) Ext- $\int_{X}|f(x)| d^{\#} \mu^{\#}=0$ if and only if $f(x)=0$ \#-a.e.
(4) If $f_{1}, f_{2}, \ldots f_{n}: X \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}, n \in{ }^{*} \mathbb{N}$ are \#-integrable then, for $\lambda_{1}, \lambda_{2}, \ldots, \lambda_{n} \in{ }^{*} \mathbb{R}_{c}^{\#}$, the linear combination $E x t-\sum_{l=1}^{n} \lambda_{i} f_{i}$ is \#-integrable and

$$
E x t-\int_{X}\left(E x t-\sum_{l=1}^{n} \lambda_{i} f_{i}\right) d^{\#} \mu^{\#}=E x t-\sum_{l=1}^{n} \lambda_{i}\left(E x t-\int_{X} f_{i} d^{\#} \mu^{\#}\right)
$$

(5) Let $f \in L_{1}^{\#}\left(X, \mathcal{F}, \mu^{\#}\right)$, then the equality

$$
v^{\#}(A)=E x t-\int_{X} f(x) \chi_{A}(x) d^{\#} \mu^{\#} \triangleq E x t-\int_{A} f(x) d^{\#} \mu^{\#}
$$

defines a signed \#-measure on the $\sigma^{\#}$ - algebra $\mathcal{F}$.
Theorem 8.1.[16].(The generalized monotone \#-convergence theorem) If $f_{n}, n \in{ }^{*} \mathbb{N}$ is a hyper infinite sequence in $L_{1}^{\#+}\left(X, \mathcal{F}, \mu^{\#}\right)$ such that $f_{j} \leq_{s} f_{j+1}$ for all $j \in{ }^{*} \mathbb{N}$ and $f(x)=\sup _{n \in^{*} \mathbb{N}} f_{n}(x)$ then

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#}=\#-\lim _{n \rightarrow * \infty}\left(E x t-\int_{X} f_{n}(x) d^{\#} \mu^{\#}\right)
$$

Theorem 8.2.[16].(The generalized dominated \#-convergence theorem) Let $f$ and $g$ be \#-measurable, let $f_{n}$ be \#-measurable for any $n \in{ }^{*} \mathbb{N}$ and such that $\left|f_{n}(x)\right| \leq g(x)$ \#-a.e., $\left|f_{n}(\mathrm{x})\right| \leq_{s} g(x)$ for any $n \in{ }^{*} \mathbb{N}$ and $f_{n}(x) \rightarrow_{\#} f(x) \#$-a.e. Then $f$ is also \#-integrable and

$$
E x t-\int_{X} f(x) d^{\#} \mu^{\#}=\#-\lim _{n \rightarrow{ }^{*} \infty}\left(E x t-\int_{X} f_{n}(x) d^{\#} \mu^{\#}\right)
$$

Definition 8.14. If $E \subseteq X_{1} \times X_{2}$ and $x_{1} \in X_{1}, x_{2} \in X_{2}$, we define

$$
E_{x_{1}}=\left\{x \in X_{2} \mid\left(x_{1}, x\right) \in E\right\} \text { and } E^{x_{2}}=\left\{x \in X_{1}:\left(x, x_{2}\right) \in E\right\}
$$

If $f: X_{1} \times X_{2} \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ is a function, we define $f_{x_{1}}: X_{2} \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ and $f^{x_{2}}: X_{1} \rightarrow{ }^{*} \mathbb{R}_{c}^{\#}$ by $f_{x_{1}}(x)=f\left(x_{1}, x\right)$ and $f^{x_{2}}(x)=f\left(x, x_{2}\right)$.
Theorem 8.3.[16].(The generalized Fubini's theorem) Let $\mu_{1}^{\#}, \mu_{2}^{\#}$ be $\sigma^{\#}$-hyperfinite \#-measures on $\left(X_{1}, \mathcal{F}_{1}\right)$ and $\left(X_{2}, \mathcal{F}_{2}\right),\left(X_{1} \times X_{2}, \mathcal{F}_{1} \otimes \mathcal{F}_{2}, \mu_{1}^{\#} \otimes \mu_{2}^{\#}\right)=\left(X_{1}, \mathcal{F}_{1}, \mu_{1}^{\#}\right) \times\left(X_{2}, \mathcal{F}_{2}, \mu_{2}^{\#}\right)$, and let $f \in L_{1}^{\#}\left(X_{1} \times X_{2}, \mathcal{F}_{1} \otimes \mathcal{F}_{2}, \mu_{1}^{\#} \otimes \mu_{2}^{\#}\right)$.Then $f_{x_{1}} \in L_{1}^{\#}\left(X_{2}, \mathcal{F}_{2}, \mu_{2}^{\#}\right) \mu_{1}^{\#}$-\#-a.e., and $f^{x_{2}} \in L_{1}^{\#}\left(X^{1}, \mathcal{F}^{1}, \mu_{1}^{\#}\right) \mu_{2}^{\#}$-\#-a.e., and the following equalities hold:

$$
E x t-\int_{X_{1} \times X_{2}} f d^{\#}\left(\mu_{1}^{\#} \otimes \mu_{2}^{\#}\right)=E x t-\int_{X_{2}}\left[E x t-\int_{X_{1}} f^{x_{2}} d^{\#} \mu_{2}^{\#}\right]=E x t-\int_{X_{1}}\left[E x t-\int_{X_{2}} f_{x_{1}} d^{\#} \mu_{2}^{\#}\right]
$$

We introduce now the \#-measures corresponding in natural way to a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operators. Let $A$ be bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator. Let $\psi \in H^{\#}$. Then

$$
f \longmapsto\langle\psi, f(A) \psi\rangle_{\#}
$$

is a positive ${ }^{*} \mathbb{R}_{c}^{\#}$-valued linear functional on $\mathrm{C}^{\#}(\sigma(A))$. Thus, by the generalized Riesz-Markov theorem, see Theorem 8.1, there is a unique \#-measure $\mu_{\psi}^{\#}$ on the \#-compact set $\sigma(A)$ with the property

$$
\langle\psi, f(A) \psi\rangle_{\#}=E x t-\int_{\sigma(A)} f(\lambda) d^{\#} \mu_{\psi}^{\#}
$$

Definition 8.15.[8]The \#-measure $\mu_{\psi}^{\#}$ is called the spectral \#-measure associated with the vector $\psi \in$ $H^{\#}$.The first and simplest application of the $\mu_{\psi}^{\#}$ is to allow us to extend the \#-continuous functional calculus to $B^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$, the bounded in ${ }^{*} \mathbb{R}_{c}^{\#} \#$-Borel functions on ${ }^{*} \mathbb{R}_{c}^{\#}$. Let $g \in B^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$. It is natural way to define $g(A)$ so that $\langle\psi, g(A) \psi\rangle_{\#}=E x t-\int_{\sigma(A)} g(\lambda) d^{\#} \mu_{\psi}^{\#}$. The polarization identity lets us recover $\langle\psi, g(A) \psi\rangle_{\#}$ from the functional $\langle\psi, g(A) \psi\rangle_{\#}$ and then the Generalized Riesz lemma lets us construct $g(A)$.
Theorem 8.1.[8] (Generalized Riesz-Markov theorem) Let $X$ be a locally \#-compact nonArchimedean metric space endowed with ${ }^{*} \mathbb{R}_{c}^{\#}$-valued metric. Let $\mathrm{C}_{c}^{\#}(X)$ be the space of \#-continuous \#-compactly supported ${ }^{*} \mathbb{C}_{\boldsymbol{c}}^{\#}$-valued functions on $X$. For any positive linear functional $\Phi$ on $\mathrm{C}_{c}^{\#}(X)$, there is a unique \#-measure $\mu_{\psi}^{\#}$ on $X$ such that $\forall f \in \mathrm{C}_{c}^{\#}(X): \Phi(f)=E x t-\int_{X} f(x) d^{\#} \mu^{\#}(x)$.
Theorem 8.2.[8] (Generalized Riesz lemma) Let $Y$ be a \#-closed proper vector subspace of a \#-normed space $\left(X,\|\cdot\|_{\#}\right)$ and let $\alpha \in{ }^{*} \mathbb{R}_{c}^{\#}$ be any real number satisfying $0<\alpha<1$. Then there exists a vector $u \in X$ of unit \#-norm $\|u\|_{\#}=1$ such that $\|u-y\|_{\#} \geq \alpha$ for all $y \in Y$.
Theorem 8.3.[8] (spectral theorem-functional calculus form) Let $A$ be a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-$\#$-adjoint operator on non-Archimedean Hilbert space $H^{\#}$. There is a unique map $\hat{\phi}: B^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right) \rightarrow$ $\mathcal{L}\left(H^{\#}\right)$ so that: (a) $\hat{\phi}$ is an algebraic $*$-homomorphism.
(b) $\hat{\phi}$ is \#-norm \#-continuous: $\|\hat{\phi}(f)\|_{\mathcal{L}\left(H^{\#}\right)} \leq\|f\|_{*_{\infty}}$.
(c) Let $f$ be the function $f(x)=x$; then $\hat{\phi}(f)=A$.
(d) Suppose $f_{n}(x) \rightarrow_{\#} f(x)$ for each x as $n \rightarrow_{\#}^{*} \infty$ and hyper infinite sequence $\left\|f_{n}\right\|_{*_{\infty}}$ is bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$.Then $\hat{\phi}\left(f_{n}\right) \rightarrow_{\#} \hat{\phi}(f)$, as $n \rightarrow_{\#}{ }^{*} \infty$ strongly.
Moreover $\hat{\phi}$ has the properties:
(e) If $\mathrm{A} \psi=\lambda \psi$, then $\hat{\phi}(f)=f(\lambda) \psi$.
(f) If $f \geq 0$, then $\hat{\phi}(f) \geq 0$.
(g) If $B A=A B$ then $\hat{\phi}(f) B=B \hat{\phi}(f)$.

## 9. The spectral projections

Definition 9.1.[8] Let $A$ be a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator and $\Omega$ a \#-Borel set of ${ }^{*} \mathbb{R}_{c}^{\#}$. $P_{\Omega}=\chi_{\Omega}(A)$ is called a spectral projection of $A$.
As the definition suggests, $P_{\Omega}$ is an orthogonal projection since $\chi_{\Omega}=\chi_{\Omega}^{2}=1$ pointwise. The properties of the family of projections $\left\{P_{\Omega} \mid \Omega\right.$ an arbitrary \#-Borel set $\}$ is given by the following elementary translation of the functional calculus.
Proposition 9.1.The family $\left\{P_{\Omega}\right\}$ of spectral projections of a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator, $A$, has the following properties:
(a) Each $P_{\Omega}$ is an orthogonal projection.
(b) $P_{\emptyset}=0 ; P_{(-a, a)}=I$ for some $a \in{ }^{*} \mathbb{R}_{c+}^{\#}$.
(c) If $\Omega=E x t-\cup_{n=1}^{* \infty} \Omega_{n}$ with $\Omega_{\mathrm{n}} \cap \Omega_{\mathrm{m}}=\emptyset$ for all $n \neq m$ then

$$
P_{\Omega}=s-\#-\lim _{N \rightarrow{ }^{*} \infty}\left(E x t-\sum_{n=1}^{N} P_{\Omega_{n}}\right)
$$

(d) $P_{\Omega_{1}} P_{\Omega_{2}}=P_{\Omega_{1} \cap \Omega_{2}}$.

Definition 9.2. A family of projections obeying (a)-(c) is called a projection-valued \#-measure (p.v. \#-m.).

Remark 9.1. Note that (d) follows from (a) and (c) by abstract considerations. As one might guess, one can integrate with respect to a p.v.\#-m. If $P_{\Omega}$ is a p.v. \#-m., then $\left\langle\varphi, P_{\Omega} \varphi\right\rangle_{\#}$ is an ordinary $\#$-measure for any $\varphi$. We will use the symbol $d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#}$ to mean integration with respect to this \#-measure. By generalized Riesz lemma methods, there is a unique operator $B$ with $\langle\varphi, B \varphi\rangle_{\#}$ $=\int_{{ }_{*} \mathbb{R}_{c}^{\#}} f(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#}$.
Theorem 9.1.If $P_{\Omega}$ is a p.v. \#-m. and $f$ a bounded in ${ }^{*} \mathbb{R}_{c}^{\# \#} \#$-Borel function on $\operatorname{supp}\left(P_{\Omega}\right)$, then there is a unique operator $B$ which we denote $\int_{* \mathbb{R}_{c}^{\#}} f(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#}$ so that

$$
\langle\varphi, B \varphi\rangle_{\#}=\int_{* \mathbb{R}_{c}^{\#}} f(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#} .
$$

## 10. The spectral theorem related to unbounded in ${ }^{*} \mathbb{R}_{\mathbf{c}}^{\#}$ self - \#- adjoint operators.

In this section we will show how the spectral theorem for bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operators which we developed in section 9 can be extended to unbounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operators.
Proposition 10.1.Let $\left\langle M, \mu^{\#}\right\rangle$ be a \#-measure space with $\mu^{\#}$ a hyperfinite \#-measure. Suppose that $f$ is a \#-measurable, ${ }^{*} \mathbb{R}_{c}^{\#}$-valued function on $M$ which is finite or hyperfinite $\mu^{\#}$-a.e.. Then the operator $T_{f}: \phi \rightarrow f \phi$ on $L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)$ with domain $D\left(T_{f}\right)=\left\{\varphi \mid f \varphi \in L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)\right\}$ is self-\#-adjoint and $\sigma\left(T_{f}\right)$ is the essential range of $T_{f}$.
Proposition10.2. Let $f$ and $T_{f}$ satisfy the conditions in Proposition 6.4.1. Suppose in addition that $f \in L_{p}^{\#}\left(M, d^{\#} \mu^{\#}\right)$ for $2<p<{ }^{*} \infty$. Let $D$ be any \#-dense set in $L_{q}^{\#}\left(M, d^{\#} \mu^{\#}\right)$, where $q^{-1}+p^{-1}=$
$1 / 2$. Then $D$ is a \#-core for $T_{f}$.
Theorem 10.1.(Spectral theorem-multiplication operator form) Let $A$ be a self-\#-adjoint operator on a

* $\infty$-dimensional a non-Archimedean Hilbert space $H^{\#}$ with domain $D(A)$. Then there is a \#-measure space $\left\langle M, \mu^{\#}\right\rangle$ with $\mu^{\#}$ a hyperfinite \#-measure, a unitary operator $U: H^{\#} \rightarrow L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)$ and a $\mathbb{R}_{c}^{\#}$ -valued function $f$ on $M$ which is finite or hyperfinite $\mu^{\#}$-a.e. so that
(a) $\psi \in D(A)$ if and only if $f(\cdot)(U \psi)(\cdot) \in L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)$.
(b) If $\varphi \in U[D(A)]$, then $\left(U A U^{-1} \varphi\right)(m)=f(m) \phi(m)$.

Remark 10.1.There is a natural way to define functions of a self-\#-adjoint operator by using the Theorem 10.1. Given a bounded \#-Borel function $h$ on ${ }^{*} \mathbb{R}_{c}^{\#}$ we define

$$
\begin{equation*}
h(A)=U T_{h(f)} U^{-1} \tag{10.1}
\end{equation*}
$$

where $T_{h(f)}$ is the operator on $\left.L_{2}^{\#}\left(M, d^{\#} \mu^{\#}\right)\right)$ which acts by multiplication by the function $h(f(m))$. Using this definition the following theorem follows easily from Theorem 6.4.1.
Theorem 10.2. (Spectral theorem -functional calculus form) Let $A$ be a self-\#-adjoint operator on $H^{\#}$. Then there is a unique map $\hat{\phi}$ from the bounded \#-Borel functions on ${ }^{*} \mathbb{R}_{c}^{\#}$ into $\mathcal{L}\left(H^{\#}\right)$, so that
(a) $\hat{\phi}$ is an algebraic $*$-homomorphism.
(b) $\hat{\phi}$ is \#-norm \#-continuous, that is, $\|\hat{\phi}(h)\|_{\mathcal{L}\left(H^{\#}\right)} \leq\|h\|_{* \infty}$.
(c) Let $h_{n}(x), n \in{ }^{*} \mathbb{N}$ be a hyper infinite sequence of bounded in ${ }^{*} \mathbb{R}_{c}^{\#} \#$-Borel functions with \#- $\lim _{n \rightarrow{ }^{*} \infty} h_{n}(x)=x$, for each $x$ and $\left|h_{n}(x)\right| \leq|x|$ for all $x$ and $n \in{ }^{*} \mathbb{N}$. Then, for any $\psi \in D(A)$,

$$
\#-\lim _{n \rightarrow{ }^{*} \infty}\left(\hat{\phi}\left(h_{n}\right) \psi\right)=A \psi
$$

(d) If $h_{n}(x) \rightarrow_{\#} h(x)$ pointwise and if the hyper infinite sequence $\left\|h_{n}(x)\right\|_{*_{\infty}}, n \in{ }^{*} \mathbb{N}$ is bounded in $\mathbb{R}_{c}^{\#}$, then $\hat{\phi}\left(h_{n}\right) \rightarrow_{\#} \hat{\phi}(h)$ strongly.
In addition:
(e) If $\mathrm{A} \psi=\lambda \psi$ then $\hat{\phi}(h)=h(\lambda) \psi$.
(f) If $h \geq 0$, then $\hat{\phi}(h) \geq 0$.

The spectral theorem in its projection-valued \#-measure form follows directly from the functional calculus. Let $P_{\Omega}$ be the operator $\chi_{\Omega}(A)$ where $\chi_{\Omega}$ is the characteristic function of the \#-measurable set $\Omega \subset{ }^{*} \mathbb{R}_{c}^{\#}$. The family of operators $\left\{P_{\Omega}\right\}$ has the following properties:

Proposition 10.3.The family $\left\{P_{\Omega}\right\}$ of spectral projections of abounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ self-\#-adjoint operator, $A$, has the following properties:
(a) Each $P_{\Omega}$ is an orthogonal projection.
(b) $P_{\emptyset}=0 ; P_{\left(-{ }^{*} \infty,{ }^{*} \infty\right)}=I$.
(c) If $\Omega=E x t-\cup_{n=1}^{* \infty} \Omega_{n}$ with $\Omega_{\mathrm{n}} \cap \Omega_{\mathrm{m}}=\emptyset$ for all $n \neq m$ then

$$
P_{\Omega}=s-\#-\lim _{N \rightarrow{ }^{*} \infty}\left(E x t-\sum_{n=1}^{N} P_{\Omega_{n}}\right)
$$

(d) $P_{\Omega_{1}} P_{\Omega_{2}}=P_{\Omega_{1} \cap \Omega_{2}}$.

Definition 10.1. A family of projections obeying (a)-(c) is called a projection-valued \#-measure (p.v. \#-m.).

Remark 10.2. This is a generalization of the notion of bounded projection-valued \#-measure introduced in Section 9. In that we only require $P_{\left(-{ }^{*} \infty,{ }^{*} \infty\right)}=I$ rather than $P_{(-a, a)}=I$ for some $a \in$ ${ }^{*} \mathbb{R}_{c+}^{\#}$. For vector $\varphi \in H^{\#},\left\langle\varphi, P_{\Omega} \varphi\right\rangle_{\#}$ is a well-defined Borel \#-measure on ${ }^{*} \mathbb{R}_{c}^{\#}$ which we denote by
$\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#}$ as in $\S$ 4.3. The complex ${ }^{*} \mathbb{C}_{c}^{\#}$-valued \#-measure $d^{\#}\left\langle\varphi, P_{\lambda} \psi\right\rangle_{\#}$ is defined by polarization. Thus, given a bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ \#-Borel function $g$ we can define $g(A)$ by

$$
\begin{equation*}
\langle\varphi, g(A) \varphi\rangle_{\#}=E x t-\int_{\mathbb{R}_{c}^{\#}} g(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#} \tag{10.2}
\end{equation*}
$$

It is not difficult to show that this map $g \mapsto g(A)$ has the properties (a)-(d) of Theorem 10.1 , so $g(A)$ as defined by (10.2) coincides with the definition of $g(A)$ given by Theorem 10.1. Now, suppose $g$ is an unbounded ${ }^{*} \mathbb{C}_{c}^{\#}$-valued \#-Borel function and let

$$
\begin{equation*}
D_{g}=\left\{\varphi \mid E x t-\int_{* \mathbb{R}_{c}^{\#}} g(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#}<^{*} \infty\right\} . \tag{10.3}
\end{equation*}
$$

Then, $D_{g}$ is \#-dense in $H^{\#}$ and an operator $g(A)$ is defined on $D_{g}$ by

$$
\begin{equation*}
\langle\varphi, g(A) \varphi\rangle_{\#}=E x t-\int_{* \mathbb{R}_{c}^{\#}} g(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \varphi\right\rangle_{\#} \tag{10.4}
\end{equation*}
$$

As in Section 9, we write symbolically

$$
\begin{equation*}
g(A)=E x t-\int_{* \mathbb{R}_{c}^{\#}} g(\lambda) d^{\#} P_{\lambda} \tag{10.5}
\end{equation*}
$$

In particular, for $\varphi, \psi \in D(A)$,

$$
\begin{equation*}
\langle\varphi, g(A) \psi\rangle_{\#}=E x t-\int_{*_{\mathbb{R}_{c}^{\#}}^{\#}} g(\lambda) d^{\#}\left\langle\varphi, P_{\lambda} \psi\right\rangle_{\#} \tag{10.6}
\end{equation*}
$$

if $g$ is ${ }^{*} \mathbb{R}_{c}^{\#}$-valued, then $g(A)$ is self-\#-adjoint on $D_{g}$. We summarize:
Theorem 10.3. (Spectral theorem-projection valued \#-measure form). There is a one-to-one correspondence between self-\#-adjoint operators $A$ and projection-valued \#-measures $\left\{P_{\Omega}\right\}$ on $H^{\#}$ the correspondence being given by

$$
\begin{equation*}
A=E x t-\int_{* \mathbb{R}_{c}^{\#}} \lambda d^{\#} P_{\lambda} \tag{10.7}
\end{equation*}
$$

We use now the functional calculus developed above in order to define $E x t-\exp (i t A)$.
Theorem 10.4 Let $A$ be a self-\#-adjoint operator and define $U(t)=E x t-\exp (i t A)$. Then
(a) For each $t \in{ }^{*} \mathbb{R}_{c}^{\#}, U(t)$ is a unitary operator and $U(t+s)=U(t) U(s)$ for all $s, t \in{ }^{*} \mathbb{R}_{c}^{\#}$.
(b) If $\phi \in H^{\#}$ and $t \rightarrow_{\#} t_{0}$, then $U(t) \phi \rightarrow_{\#} U\left(t_{0}\right) \phi$.
(c) For any $\psi \in D(A):((U(t) \psi-\psi) / t) \rightarrow_{\#} i A \psi$ as $t \rightarrow_{\#} 0$.
(d) If \#-lim $\lim _{\rightarrow 0}((U(t) \psi-\psi) / t)$ exists, then $\psi \in D(A)$.

Proof (a) follows immediately from the functional calculus and the corresponding statements for the ${ }^{*} \mathbb{C}_{c}^{\#}{ }^{-}$valued function $\operatorname{Ext}-\exp (i t \lambda)$. To prove (b) observe that

$$
\|E x t-\exp (i t A) \psi-\psi\|_{\#}^{2}=E x t-\int_{*_{\mathbb{R}_{c}^{\#}}}|E x t-\exp (i t \lambda)-1|^{2} d^{\#} g(\lambda) d^{\#}\left\langle P_{\lambda} \varphi, \psi\right\rangle_{\#} .
$$

Since $|E x t-\exp (i t \lambda)-1|^{2}$ is dominated by the \#-integrable function $g(\lambda)=2$ and since for each $\lambda \in{ }^{*} \mathbb{R}_{c}^{\#}|E x t-\exp (i t \lambda)-1|^{2} \rightarrow_{\#} 0$ as $t \rightarrow_{\#} 0$ we conclude that $(U(t) \psi-\psi) \rightarrow_{\#} 0$ as $t \rightarrow_{\#} 0$, by the generalized Lebesgue dominated-\#-convergence theorem. Thus $t \mapsto U(t)$ is strongly \#-continuous at $t=0$, which by the group property proves $t \mapsto U(t)$ is strongly \#-continuous everywhere. The proof of (c), again uses the dominated \#-convergence theorem and the estimate $\mid E x t-\exp (i t x)-$ $\left.1\right|^{2} \leq|x|$. To prove (d), we define

$$
D(B)=\left\{\psi \left\lvert\, \#-\lim _{t \rightarrow \# 0}\left(\frac{U(t) \psi-\psi}{t}\right)\right. \text { exists }\right\}
$$

and let $i B \psi=\#-\lim _{t \rightarrow \# 0}\left(\frac{U(t) \psi-\psi}{t}\right)$. A simple computation shows that $B$ is symmetric. $\mathrm{By}(\mathrm{c}), \mathrm{B} \supset A$, so $B=A$.
Definition 10.2. An operator-valued function $U(t)$ satisfying (a) and (b) is called a strongly \#-continuous one-parameter unitary group.
Definition 10.3 If $U(t)$ is a strongly \#-continuous one-parameter unitary group, then the self-\#-adjoint operator $A$ with $U(t)=E x t-\exp (i t A)$ is called the \#-infinitesimal generator of $U(t)$.
Theorem 10.5. Let $U(t)$ be a strongly \#-continuous one-parameter unitary group on a nonArchimedean Hilbert space $H^{\#}$. Then, there is a self-\#-adjoint operator $A$ on $H^{\#}$ so that $U(t)=E x t-\exp (i t A)$.
Theorem 10.6. Let $U(t)$ be a one-parameter group of unitary operators on a hyper infinite dimensional non-Archimedean Hilbert space $H^{\#}$. Suppose that for all $\phi, \psi \in H^{\#},\langle U(t) \psi, \phi\rangle_{\#}$ is \#-measurable.Then $U(t)$ is strongly \#-continuous.
Theorem 10.7. Suppose that $U(t)$ is a strongly \#-continuous one-parameter unitary group. Let $D$ be a \#-dense domain which is invariant under $U(t)$ and on which $U(t)$ is strongly \#-differentiable. Then $i^{-1}$ times the strong \#-derivative of $U(t)$ is essentially self-\#-adjoint on $D$ and its \#-closure is the \#-infinitesimal generator of $U(t)$.
Theorem 10.8. Let $A$ be a self-adjoint operator on $H^{\#}$ and $D$ be a \#-dense linear set contained in $D(A)$. If for all $t, \operatorname{Ext}-\exp (i t A): D \rightarrow D$ then $D$ is a \#-core for $A$.
Remark 6.4.3. Finally, we have the following generalization of Theorem 10.5. If $g(\lambda)$ is a ${ }^{*} \mathbb{R}_{c}^{\#-}$ valued \#-BoreI function on ${ }^{*} \mathbb{R}_{c}^{\#}$, then $g(A)=E x t-\int_{{ }^{*} \mathbb{R}_{c}^{\#}} g(\lambda) d^{\#} P_{\lambda}$. defined on $D_{g}(10.3)$ is self-\#-adjoint. If g is bounded, $g(A)$ coincides with $\hat{\phi}(g)$ in Theorem 10.2.
Theorem 10.9. Let $U(\boldsymbol{t})=U\left(t_{1}, \ldots, t_{n}\right)$ be a strongly \#-continuous map of ${ }^{*} \mathbb{R}_{c}^{\# n}$ into the unitary operators on a hyper infinite dimensional Hilbert space $H^{\#}$ satisfying $U(\boldsymbol{t}+\boldsymbol{s})=U(\boldsymbol{t}) U(\boldsymbol{s})$ Let $D$ be the set of hyperfinite linear combinations of vectors of the form

$$
\begin{equation*}
\varphi_{f}=E x t-\int_{* \mathbb{R}_{c}^{\# n}} f(\boldsymbol{t}) U(\boldsymbol{t}) d^{\# n} t \tag{10.8}
\end{equation*}
$$

where $\phi \in H^{\#}, f \in C_{0}^{\# *}{ }^{*}\left({ }^{*} \mathbb{R}_{c}^{\# n}\right)$. Then $D$ is a domain of essential self-\#-adjointness for each of the generators $A_{j}$ of the one-parameter subgroups $U\left(0,0, \ldots, t_{j}, \ldots, 0\right)$, each $A_{j}: D \rightarrow D$ and the $A_{j}$ commute, $j=1, \ldots, n$. Furthermore, there is a projection-valued \#-measure $P_{\Omega}$ on ${ }^{*} \mathbb{R}_{c}^{\# n}$ so that

$$
\begin{equation*}
\langle\varphi, U(\boldsymbol{t}) \psi\rangle_{\#}=E x t-\int_{* \mathbb{R}_{c}^{\# n}}[E x t-\exp (i\langle\boldsymbol{t}, \lambda\rangle)] d^{\#}\left\langle\varphi, P_{\lambda} \psi\right\rangle_{\#} \tag{10.9}
\end{equation*}
$$

for all $\phi, \psi \in H^{\#}$.
Remark 10.4. Suppose that $A$ and $B$ are two unbounded self-\#-adjoint operators on a non-
Archimedean Hilbert space $H^{\#}$. We would like to find a reasonable meaning for the statement: " $A$ and $B$ commute." This cannot be done in the straightforward way since the operator $C=A B-B A$ may not make sense on any vector $\psi \in H^{\#}$ for example one might have $(\operatorname{Ran}(A)) \cap D(B)=\emptyset$ in which case $B A$ does not have a meaning. This suggests that we find an equivalent formulation of commutativity for bounded self-\#-adjoint operators. The spectral theorem for bounded self-\#-adjoint operators $A$ and $B$ shows that in that case $A B-B A=0$ if and only if all their projections, $P_{\Omega}^{A}$ and $P_{\Omega}^{B}$, commute. We take this as our definition in the unbounded case.
Definition 10.3 Two (possibly unbounded in ${ }^{*} \mathbb{R}_{\mathbf{c}}^{\#}$ self-\#-adjoint operators $A$ and $B$ are said to commute if and only if all the projections in their associated projection-valued \#-measures commute.

Remark 10.5.The spectral theorem shows that if $A$ and $B$ commute, then all the bounded in ${ }^{*} \mathbb{R}_{\mathbf{c}}^{\#}$ \#-Borel functions of $A$ and $B$ also commutes. In particular, the resolvents $R_{\lambda}(A)$ and $R_{\mu}(B)$ commute and the unitary groups $E x t-\exp (i t A)$ and $E x t-\exp (i t A)$ commute. The converse statement is also true and this shows that the above definition of "commute" is reasonable.
Theorem 10.10 Let $A$ and $B$ be self-\#-adjoint operators on a non-Archimedean Hilbert space $H^{\#}$.Then the following three statements are equivalent:
(a) $P_{(a, b)}^{A}$ and $P_{(c, d)}^{B}$ commute.
(b) If $\operatorname{Im} \lambda$ and $\operatorname{Im} \mu$ are nonzero, then $R_{\lambda}(A) R_{\mu}(B)-R_{\mu}(B) R_{\lambda}(A)=0$.
(c) For all $s, t \in{ }^{*} \mathbb{R}_{c}^{\#},[E x t-\exp (i t A)][E x t-\exp (i t A)]=[E x t-\exp (i t A)][E x t-\exp (i t A)]$.

Proof The fact that (a) implies (b) and (c) follows from the functional calculus. The fact that (b) implies (a) easily follows from the formula which expresses the spectral projections of $A$ and $B$ as strong \#-limits of the resolvents together with the fact that $s-\#-\lim _{\varepsilon \rightarrow 0} i \varepsilon R_{a+i \varepsilon}(A)=P_{\{a\}}^{A}$. To prove that (c) implies (a), we use some simple facts about the Fourier transform. Let $f \in S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$, then, by generalized Fubini's theorem [16],

$$
\begin{gathered}
E x t-\int_{{ }_{\mathbb{R}_{c}^{\#}}^{\#}} f(t)\langle[E x t-\exp (i t A)] \varphi, \psi\rangle_{\#}= \\
=E x t-\int_{* \mathbb{R}_{c}^{\#}} f(t)\left(E x t-\int_{* \mathbb{R}_{c}^{\#}}([E x t-\exp (-i t \lambda)]) d_{\lambda}^{\#}\left\langle P_{\lambda}^{A} \varphi, \psi\right\rangle_{\#}\right) d^{\#} t= \\
=\sqrt{2 \pi_{\#}} E x t-\int_{*_{\mathbb{R}_{c}^{\#}}} \hat{f}(\lambda) d_{\lambda}^{\#}\left\langle P_{\lambda}^{A} \varphi, \psi\right\rangle_{\#}=\sqrt{2 \pi_{\#}}\langle\varphi, \hat{f}(A) \psi\rangle_{\#} .
\end{gathered}
$$

Thus, using (c) and generalized Fubini's theorem again,

$$
\begin{gathered}
\langle\varphi, \hat{f}(A) \hat{g}(B) \psi\rangle_{\#}= \\
=E x t-\int_{{ }_{* \mathbb{R}_{c}^{\#}}} E x t-\int_{{ }_{\mathbb{R}_{c}^{\#}}} f(t) g(s)\langle\varphi,[E x t-\exp (-i t A)][E x t-\exp (i s B)] \psi\rangle_{\#}= \\
=\langle\varphi, \hat{g}(B) \hat{f}(A) \psi\rangle_{\#}
\end{gathered}
$$

so, for all $f, g \in S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right), \hat{f}(A) \hat{g}(B)-\hat{g}(B) \hat{f}(A)=0$. Since the Fourier transform maps $S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$ onto $S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$ we conclude that $f(A) g(B)-g(B) f(A)=0$ for all $f, g \in S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right)$. But, the characteristic function, $\chi_{(a, b)}$ can be expressed as the pointwise \#-limit of a hyper infinite sequence $f_{n}, n \in{ }^{*} \mathbb{N}$ of uniformly bounded functions such that $f_{n} \in S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right), n \in{ }^{*} \mathrm{~N}$. By the functional calculus we get

$$
s-\#-\lim _{N \rightarrow * \infty} f_{n}(A)=P_{(a, b)}^{A} .
$$

Similarly, we find uniformly bounded $g_{n} \in S^{\#}\left({ }^{*} \mathbb{R}_{c}^{\#}\right), n \in{ }^{*} \mathbb{N}$ \#-converging pointwise to $\chi_{(c, d)}$ and therefore

$$
s-\#-\lim _{N \rightarrow *} g_{n}(B)=P_{(c, d)}^{B} .
$$

Since the $f_{n}$ and $g_{n}$ are uniformly bounded in ${ }^{*} \mathbb{R}_{c}^{\#}$ and $f_{n}(A) g_{n}(B)=g_{n}(B) f_{n}(A)$ for each $n \in{ }^{*} \mathbb{N}$, we conclude that $P_{(a, b)}^{A}$ and $P_{(c, d)}^{B}$ commute which proves (a).

## Conclusion

The technique of nonstandard analysis in constructive quantum field theory in order to obtain the standard model $\lambda: \varphi_{2}^{4}(x)$ : by using model theoretical nonstandard analysis (NSA) originally have been approved by Peter J. Kelemen and Abraham Robinson [17]-[18].As pointed out in author's papers [8], [19], canonical NSA does not power enough in order to obtain the standard model $\lambda: \varphi_{4}^{4}(x)$ : by using the classical nonstandard analysis, see also explanation in S. Albeverio handbook [5] section 7.4 and section 1 of this paper. In order to avoid this difficultness related to NSA we apply minimal nonconservative extension of NSA namely NSA $^{\#}$ [11]. Using NSA ${ }^{\#}$ Haag-Kastler axioms established for standard model $\lambda\left(\varphi^{4}\right)_{4}$ in author's papers [8], [19]. It is shown in this paper that the standard quantum field theory model $\left(\varphi^{2 n}\right)_{4}, n \geq 2$ is Lorentz covariant see also [20].For model $\left(\varphi^{2 n}\right)_{2}, n \geq$ 2 in unphysical dimension $d=2$ Lorentz covariance has been established in L. M. Rosen paper [21].
