### Marker placement

A motion capture system (Qualysis, Göteborg, Sweden; 100 Hz) composed of six cameras was used to track 13 markers with an 8-mm radius placed on anatomical landmarks of the hand and wrist (Figure s1 and Table s1.1). The radius was tracked by three markers placed on the dorsal aspect of the distal forearm. The 2<sup>nd</sup> and 3<sup>rd</sup> metacarpals were tracked by four markers placed on the dorsal aspects of hand. Phalanges were tracked by six markers, including three markers mounted on a dorsally shifted support.

#### Joint angle computation

The marker coordinates were first filtered (Butterworth low pass zero-phase filter at 10 Hz, order 2) and averaged on the same 500-ms window as the finger force to compute the joint angles of the index finger and wrist were estimated from the markers' 3D coordinates. The wrist and index finger metacarpophalangeal (MCPi) joints were described by two degrees of freedom (DoF) in flexion/extension and radial/ulnar deviation. The index finger distal (DIPi) and proximal (PIPi) joints were described by one DoF in flexion/extension. For each joint, a distal and a proximal segment coordinate system were calculated from the positions of 3 markers (Table s1.2).

 $\vec{u}_{(P1,P2)}$  represents the unit vector associated to the vector going from the P1 to the P2 points. For the phalanges, Pp and Pd refer to the points representing the proximal and distal ends of the segment, respectively, and Py refer to the point positioned upwardly on the supports

First, the longitudinal  $(\vec{x})$  axis was computed as the unit vector from the distal to the proximal marker vector. For the radius and metacarpal bones, the second axis was the coronal  $(\vec{y})$  one and was orthogonal to the plane defined by  $\vec{x}$  and a vector pointing radially. For the phalanges, the second axis was the sagittal  $(\vec{z})$  one and was orthogonal to the plane that includes the  $\vec{x}$  and the dorsally shifted marker. The third axis was the cross product of the two others. Then, joint angles were extracted from the relative orientation (distal to proximal) matrix segment rotation matrix using a Z-Y-X (flexion/abduction/pronation) sequence of Cardan angles. Flexion, and radial deviation angle were considered positive.
