# Homotopy Transfer Theorem and minimal models for pre-Calabi-Yau algebras 

Marion Boucrot


#### Abstract

In this article we prove that given quasi-isomorphic dg vector spaces and a pre-Calabi-Yau structure on one of them there exists a pre-Calabi-Yau structure on the other as well as a pre-Calabi-Yau morphism between the two. This extends the Homotopy Transfer Theorem proved by T. Kadeishvili and a similar result of D. Petersen. Moreover, we show that a pre-Calabi-Yau morphism whose first component is an isomorphism of dg vector spaces is a pre-Calabi-Yau isomorphism, i.e. the inverse of the isomorphism of dg vector spaces extends to an inverse of the pre-Calabi-Yau morphism. We incidentally show that any pre-Calabi-Yau algebra has a minimal model. Finally, we prove that any quasi-isomorphism of pre-Calabi-Yau algebras admits a quasiinverse.

## 1 Introduction

Pre-Calabi-Yau algebras were introduced by M. Kontsevich and Y. Vlassopoulos in the last decade. In the finite dimensional case, these structures have also appeared in [9] under the name of $V_{\infty^{-}}$ algebras and P. Seidel called them $A_{\infty}$-algebras with boundary in |6|. They also appear under the name of weak Calabi-Yau structures in [3]. These references show that pre-Calabi-Yau structures play an important role in homological algebra, symplectic geometry, string topology, noncommutative geometry and even in Topological Quantum Field Theory.

The notion of pre-Calabi-Yau algebras is strongly related to the notion $A_{\infty}$-algebras. Actually, for $d \in \mathbb{Z}$, a $d$-pre-Calabi-Yau structure on a finite dimensional graded vector space $A$ is equivalent to a cyclic $A_{\infty}$-structure on $A \oplus A^{*}[d-1]$ that restricts to $A$, where $A^{*}$ denotes the graded dual of A.

In 1980, T. Kadeishvili proved in [2] the following theorem:
Theorem 1.1. (Homotopy Transfer Theorem) For any dg algebra $C$ such that $H_{i}(C)$ is free for $i \geq 0$, there exists an $A_{\infty}$-structure on $H(C)$ with vanishing differential and an $A_{\infty}$-morphism $f: H(C) \rightarrow C$ such that $f^{1}$ is a quasi-isomorphism.

In 2020, D. Petersen published in [5| a proof of the following theorem, which is some kind of Homotopy Transfer Theorem:

Theorem 1.2. Let $R$ be a ring, $\left(V, d_{V}\right)$ and $\left(W, d_{W}\right) d g R$-modules and $f: V \rightarrow W$ a chain map. Let $\nu$ be a square-zero coderivation of $C(W)$ of degree -1 whose arity 1 term is $d_{W}$. Assume that finduces a quasi-isomorphism $\operatorname{Hom}_{R}(C(V), V) \rightarrow \operatorname{Hom}_{R}(C(W), W)$. Then, there exists noncanonically a squarezero coderivation $\mu$ of $C(V)$ of degree -1 whose arity 1 term is $d_{V}$ and a morphism $F: C(V) \rightarrow C(W)$ of coalgebras whose arity 1 term is $f$ and which is a chain map with respect to $\mu$ and $\nu$.

Using the bar construction relating $A_{\infty}$-algebras and coalgebras, the latter gives rise to the following theorem:

Theorem 1.3. Consider $d g$ vector spaces $\left(V, d_{V}\right)$ and $\left(W, d_{W}\right)$ and $f:\left(V, d_{V}\right) \rightarrow\left(W, d_{W}\right)$ a quasiisomorphism. Let $m_{W}$ be an $A_{\infty}$-structure on $W$ with $m_{W}^{1}=d_{W}[1]$. Then, there exists an $A_{\infty}$-structure $m_{V}$ on $V$ such that $m_{V}^{1}=d_{V}[1]$ and an $A_{\infty}$-morphism $F:\left(V, m_{V}\right) \rightarrow\left(W, d_{W}\right)$ with $F^{1}=f[1]$.

We also have the statement in the other direction, namely, if $V$ is endowed with an $A_{\infty^{-}}$ structure it is possible to construct such a structure on $W$.

We prove in this paper similar results for pre-Calabi-Yau algebras. Let us briefly present the contents of this paper. Section 2 is devoted to present the conventions we follow and notations we will use throughout this paper. In section 3 we recall the notions of $A_{\infty}$-algebras and $A_{\infty^{-}}$morphisms. We also recall well-known results including the ones appearing in [5], giving proofs entirely in terms of the structure of the $A_{\infty}$-algebra, instead of the associated bar constructions, as it is the case in the mentioned article. This is done in order to allow the comparison with the case of pre-Calabi-Yau algebras since the latter do not have any bar construction. We do not claim any originality in this regards. Section 4 is the core of the article. After recalling the definitions of $d$-pre-Calabi-Yau algebras given in [4], we prove that a $d$-pre-Calabi-Yau morphism whose first component is an isomorphism is an isomorphism in the category of $d$-pre-Calabi-Yau algebras (see Lemma 4.9). Then, we prove theorems 4.13 and 4.14 by generalizing the proofs of the case of $A_{\infty}$-algebras. Those theorems state that given dg vector spaces and a quasi-isomorphism between them, if one carries a $d$-pre-Calabi-Yau structure then we can construct such a structure on the other, as well as a $d$-pre-Calabi-Yau morphism between the two. We deduce that there exists minimal models for $d$-pre-Calabi-Yau algebras. Finally, using Lemma 4.9 and theorems 4.13 and 4.14 . we show that a quasi-isomorphism of $d$-pre-Calabi-Yau algebras has a quasi-inverse (see Theorem 4.18).

## 2 Notations and conventions

In what follows $\mathbb{k}$ will be a field of characteristic 0 and to simplify we will denote $\otimes$ for $\otimes_{\mathbb{k}}$. We will denote by $\mathbb{N}=\{0,1,2, \ldots\}$ the set of natural numbers and define $\mathbb{N}^{*}=\mathbb{N} \backslash\{0\}$. For $i, j \in \mathbb{N}$, we define the interval of integers $\llbracket i, j \rrbracket=\{n \in \mathbb{N} \mid i \leq n \leq j\}$. We also define $\mathcal{T}=\bigsqcup_{k>0} \mathcal{T}_{k}$ where $\mathcal{T}_{k}=\mathbb{N}^{k}$ for $k>1$ and $\mathcal{T}_{1}=\mathbb{N}^{*}$ and given $\bar{n}=\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$, we denote $N(\bar{n})=n_{1}+\cdots+n_{k}$.

Given a (cohomologically) graded vector space $V=\oplus_{i \in \mathbb{Z}} V^{i}$, we define the graded vector space $V[n]$ given by $V[n]^{i}=V^{n+i}$ for $i \in \mathbb{Z}$ and consider, for $n \in \mathbb{Z}$, the map $s_{V, n}: V \rightarrow V[n]$ whose
underlying set theoretic map is the identity. We will denote $s_{V, n}$ simply by $s_{n}$ when there is no possible confusion, and $s_{1}$ just by $s$.

We now recall the Koszul sign rules, that are the ones we use to determine the signs appearing in this paper. If $V, W$ are graded vector spaces, we have a map $\tau_{V, W}: V \otimes W \rightarrow W \otimes V$ defined as

\tau_{V, W}(v \otimes w)=(-1)^{|w| v \mid} w \otimes v
$$

where $v \in V$ is a homogeneous element of degree $|v|$ and $w \in W$ is a homogeneous element of degree $|w|$. More generally, given graded vector spaces $V_{1}, \ldots, V_{n}$ and $\sigma \in \mathcal{S}_{n}$, we have a map

\tau_{V_{1}, \ldots, V_{n}}^{\sigma}: V_{1} \otimes \cdots \otimes V_{n} \rightarrow V_{\sigma^{-1}(1)} \otimes \cdots \otimes V_{\sigma^{-1}(n)}
$$

sending an element $v_{1} \otimes \cdots \otimes v_{n}$ to $(-1)^{\epsilon}\left(v_{\sigma^{-1}(1)} \otimes \cdots \otimes v_{\sigma^{-1}(n)}\right)$ with

$$
\epsilon=\sum_{\substack{i>j \\ \sigma^{-1}(i)<\sigma^{-1}(j)}}\left|v_{\sigma^{-1}(i)}\right|\left|v_{\sigma^{-1}(j)}\right|
$$

where $v_{i} \in V_{i}$ is a homogeneous element of degree $\left|v_{i}\right|$ for $i \in \llbracket 1, n \rrbracket$.
All the products in this paper will be products in the category of graded vector spaces. Given graded vector spaces $\left(V_{i}\right)_{i \in I}$, we thus have $\prod_{i \in I} V_{i}=\bigoplus_{n \in \mathbb{Z}} \prod_{i \in I} V_{i}^{n}$ where the second product is the usual product of vector spaces.

Given two graded vector spaces $V, W$ we denote by $\operatorname{Hom}_{\mathfrak{k}}(V, W)$ the vector space of $\mathbb{k}$-linear maps $f: V \rightarrow W$ and by $\operatorname{hom}_{\mathbb{k}}^{d}(V, W)$ the vector space of homogeneous $\mathbb{k}$-linear maps $f: V \rightarrow W$ of degree d, i.e. $f(v) \in W^{n+d}$ for all $v \in V^{n}$. We assemble them in the graded vector space $\mathcal{H o m} \mathfrak{k}_{k}(V, W)=\bigoplus_{d \in \mathbb{Z}} \operatorname{hom}_{\mathfrak{k}}^{d}(V, W) \subseteq \operatorname{Hom}_{\mathbb{k}}(V, W)$. We define the graded dual of a graded vector space $V=\bigoplus_{n \in \mathbb{Z}} V^{n}$ as $V^{*}=\mathcal{H o m}_{\mathbf{k}}(V, \mathbb{k})$. Moreover, given graded vector spaces $V, V^{\prime}, W, W^{\prime}$ and homogeneous elements $f \in \mathcal{H}_{\mathrm{H}_{\mathfrak{k}}}\left(V, V^{\prime}\right)$ and $g \in \mathcal{H}^{\prime} m_{k}\left(W, W^{\prime}\right)$, we have that

$$
(f \otimes g)(v \otimes w)=(-1)^{|g||v|} f(v) \otimes g(w)
$$

for homogeneous elements $v \in V$ and $w \in W$. Throughout this paper, when we consider an element $v$ of degree $|v|$ in a graded vector space $V$, we mean a homogeneous element $v$ of $V$. Also, we will denote by id the identity map of every space of morphisms, without specifying it. Recall that given a dg vector space $\left(A, d_{A}\right)$ its cohomology is the graded vector space

$$
H(A)=\bigoplus_{n \in \mathbb{Z}} H^{n}(A)=\bigoplus_{n \in \mathbb{Z}} \operatorname{ker}\left(d_{A}^{n}\right) / \operatorname{im}\left(d_{A}^{n-1}\right)
$$

In this paper, we will often make the use of the diagrammatic calculus introduced in [4]. We refer the reader to [1] for a detailed account of the involved definitions and terminology, which we shall follow in this article. Using the convention of that reference, we remark that, for this article, the type of a diagram will be just a tuple of integers instead of a tuple of objects, since we work with pre-Calabi-Yau algebras instead of pre-Calabi-Yau categories. Moreover, given a diagram, we will often omit the corresponding bold arrow, i.e. the bold arrow can be any of the outgoing arrows of the diagram.

## 3 Transferring $A_{\infty}$-structures

This section is devoted to recall the notions of $A_{\infty}$-algebras and $A_{\infty}$-morphisms. For convenience of the reader, we also present the results appearing in [5], and we give proofs entirely in terms of the structure of the $A_{\infty}$-algebra, instead of the associated bar constructions, as it is the case in [5]. We do not claim any originality in this regards. This is merely done in order to allow the comparison with the case of pre-Calabi-Yau algebras appearing in the next section, since the latter do not have any bar construction.

Definition 3.1. Given graded vector spaces $A$ and $B$, we define the graded vector space $C(A, B)$ as $C(A, B)=\prod_{n \in \mathbb{N}^{*}} C^{n}(A, B)$ where $C^{n}(A, B)=\mathcal{H o m}_{\mathbb{k}}\left(A[1]^{\otimes n}, B[1]\right)$. We will denote $C(A, A)$ simply by $C(A)$.

Remark 3.2. If $\left(A, d_{A}\right)$ and $\left(B, d_{B}\right)$ are dg vector spaces, $C(A, B)$ becomes a dg vector space whose differential is given by $d_{C(A, B)} F=d_{B[1]} \circ F-(-1)^{|F|} F \circ d_{A[1] \otimes n}$ for a homogeneous element $F \in C^{n}(A, B)$.

Definition 3.3. An $A_{\infty}$-structure on a graded vector space $A$ is an element $m_{A} \in C(A)$ of degree 1 satisfying the Stasheff identities introduced by J. Stasheff in [7] and given by

$$
\begin{equation*}
\sum_{\substack{r+s+t=n \\ s>0}} m_{A}^{r+1+t} \circ\left(\mathrm{id}^{\otimes r} \otimes m_{A}^{s} \otimes \mathrm{id}^{\otimes t}\right)=0 \tag{n}
\end{equation*}
$$

for each $n \in \mathbb{N}^{*}$. This is tantamount to $\left[m_{A}, m_{A}\right]_{G}=0$ where $[-,-]_{G}$ denotes the Gerstenhaber bracket. In terms of diagrams, this reads $\sum \mathcal{E}(\mathscr{D})=0$ where the sum is over all the filled diagrams $\mathscr{D}$ of type $n \in \mathbb{N}^{*}$ and of the form


A graded vector space endowed with an $A_{\infty}$-structure is called an $A_{\infty}$-algebra.
Remark 3.4. Note that the identity $\left(S I^{1}\right)$ is simply $m_{A}^{1} \circ m_{A}^{1}=0$, meaning that an $A_{\infty}$-algebra $\left(A, m_{A}\right)$ gives rise to a dg vector space $\left(A, m_{A}^{1}[-1]\right)$, whose cohomology will be denoted by $H(A)$.

The following definition is due to M. Sugawara (see [8]).
Definition 3.5. Let $\left(A, m_{A}\right),\left(B, m_{B}\right)$ be two $A_{\infty}$-algebras. An $A_{\infty}$-morphism $F$ from $A$ to $B$ is an element $F \in C(A, B)$ of degree 0 satisfying the identities

$$
\begin{equation*}
\sum_{\substack{r+s+t=n \\ s>0}} F^{r+1+t} \circ\left(\mathrm{id}^{\otimes r} \otimes m_{A}^{s} \otimes \mathrm{id}^{\otimes t}\right)=\sum_{r_{1}+\cdots+r_{i}=n} m_{B}^{i} \circ\left(F^{r_{1}} \otimes \cdots \otimes F^{r_{i}}\right) \tag{n}
\end{equation*}
$$

for each $n \in \mathbb{N}^{*}$. This tantamount to $F \underset{G}{\circ} m_{A}-m_{B}{ }_{M}^{\circ} F=0$ where $\stackrel{\circ}{G}_{\circ}$ denotes the Gerstenhaber product and $\circ$ denotes the composition appearing on the right hand side of $M I^{n}$. In terms of diagrams, this reads $\sum \mathcal{E}(\mathscr{D})=\sum \mathcal{E}\left(\mathscr{D}^{\prime}\right)$ where the sums are over all the filled diagrams $\mathscr{D}$ and $\mathscr{D}^{\prime}$ of type $n \in \mathbb{N}^{*}$ and of the form

respectively.
Definition 3.6. Given $A_{\infty}$-algebras $\left(A, m_{A}\right),\left(B, m_{B}\right),\left(C, m_{C}\right)$ and $A_{\infty}$-morphisms $F: A \rightarrow B$ and $G: B \rightarrow C$, the composition of $F$ and $G$ is the element $(G \circ F) \in C(A, C)$ defined by

$$
(G \circ F)^{n}=\sum_{r_{1}+\cdots+r_{i}=n} G^{i} \circ\left(F^{r_{1}} \otimes \cdots \otimes F^{r_{i}}\right)
$$

for every $n \in \mathbb{N}^{*}$.
Lemma 3.7. The data of $A_{\infty}$-algebras together with $A_{\infty}$-morphisms and their composition give rise to a category denoted $A_{\infty}$. Moreover, given an $A_{\infty}$-algebra $\left(A, m_{A}\right)$, the $A_{\infty}$-identity morphism on $A$ is the one whose $n$-th component $\left(\operatorname{id}_{A}\right)^{n}: A[1]^{\otimes n} \rightarrow A[1]$ is $\operatorname{id}_{A[1]}$ if $n=1$ and 0 if $n>1$. It will be denoted $\operatorname{id}_{A}$ or simply by id when there is no possible confusion.

Definition 3.8. Given $A_{\infty}$-algebras $\left(A, m_{A}\right)$ and $\left(B, m_{B}\right)$, an $A_{\infty}$-morphism $F: A \rightarrow B$ is a quasiisomorphism if $F^{1}:\left(A[1], m_{A}^{1}\right) \rightarrow\left(B[1], m_{B}^{1}\right)$ is a quasi-isomorphism of dg vector spaces. Moreover, $F$ is an isomorphism if there exists an $A_{\infty}$-morphism $G: B \rightarrow A$ such that $G \circ F=\operatorname{id}_{A}$ and $F \circ G=\mathrm{id}_{B}$.
Lemma 3.9. Let $\left(A, m_{A}\right),\left(B, m_{B}\right)$ be $A_{\infty}$-algebras and $F: A \rightarrow B$ be an $A_{\infty}$-morphism. Suppose that $F^{1}:\left(A[1], m_{A}^{1}\right) \rightarrow\left(B[1], m_{B}^{1}\right)$ is an isomorphism of dg vector spaces. Then, $F$ is an isomorphism of $A_{\infty}$-algebras.
Proof. Since $F^{1}:\left(A[1], m_{A}^{1}\right) \rightarrow\left(B[1], m_{B}^{1}\right)$ is an isomorphism of dg vector spaces, it has an inverse $G^{1}:\left(B[1], m_{B}^{1}\right) \rightarrow\left(A[1], m_{A}^{1}\right)$ which is a chain map. To simplify, we will denote $F^{1}=f$ and $G^{1}=g$. Consider $n>1$ and suppose that we have constructed maps $G^{i}: B[1]^{\otimes i} \rightarrow A[1]$ satisfying that $(G \circ F)^{i}=0$ for $i<n$. We have that

$$
(G \circ F)^{n}=G^{n} \circ f^{\otimes n}+\sum_{\substack{r_{1}+\cdots+r_{i}=n \\ i<n}} G^{i} \circ\left(F^{r_{1}} \otimes \cdots \otimes F^{r_{i}}\right)
$$

We thus define

$$
G^{n}=-\sum_{\substack{r_{1}+\cdots+r_{i}=n \\ i<n}} G^{i} \circ\left(F^{r_{1}} \otimes \cdots \otimes F^{r_{i}}\right) \circ g^{\otimes n}
$$

Therefore, we have constructed a collection $G$ of maps $G^{i}: B[1]{ }^{\otimes i} \rightarrow A[1]$ for each $i \in \mathbb{N}^{*}$ such that $G \circ F=\operatorname{id}_{A}$. Note that we did not use the fact that $F$ is an $A_{\infty}$-morphism. Thus, there exists a collection $H$ of maps $H^{i}: A[1]^{\otimes i} \rightarrow B[1]$ such that $H \circ G=\mathrm{id}_{B}$. Using the associativity of the composition, we get that $H=F$ and thus $G \circ F=\operatorname{id}_{A}$ and $F \circ G=\operatorname{id}_{B}$.

It remains to show that $G$ is an $A_{\infty}$-morphism. It is clear that $g$ satisfies the identity $\left(M I^{1}\right)$. Consider $n>1$ and suppose that $G$ satisfies the identities $\left(M I^{i}\right)$ for all $i<n$. Since $F$ is an $A_{\infty^{-}}$ morphism, we have that $F \underset{G}{\circ} m_{A}=m_{B}{ }_{M}^{\circ} F$ and then $\left(F \underset{G}{\circ} m_{A}\right){ }_{M}^{\circ} G=\left(m_{B}{ }_{M}^{\circ} F\right){ }_{M}^{\circ} G$. Therefore, we
have that $G \stackrel{\circ}{\circ}\left(\left(F_{G}^{\circ} m_{A}\right) \circ_{M} G\right)=G_{G}^{\circ}\left(\left(m_{B} \circ_{M} F\right) \circ{ }_{M} G\right)$. It is clear that the right member of this equality is $G \circ_{G} m_{B}$ since $F \circ G=\mathrm{id}$. We now show that $G_{G}^{\circ}\left(\left(F_{G}^{\circ} m_{A}\right){ }_{M}^{\circ} G\right)=m_{A} \circ_{M}^{\circ} G$. We have that

respectively. The minus sign comes from the fact that the order of the first outgoing arrows of the two sources filled with $m_{A}$ is reversed and $\left|m_{A}\right|=1$. Thus, the identity (3.1) is satisfied since $\sum \mathcal{E}\left(\mathscr{D}_{2}\right)=\sum \mathcal{E}\left(\mathscr{D}_{3}\right)$ and $\sum \mathcal{E}(\mathscr{D})=\sum \mathcal{E}\left(\mathscr{D}_{1}\right)$.
 the filled diagrams $\mathscr{D}$ of type $n$ and of the form


It is clear that $\left(\left(m_{B} \underset{M}{\circ} F\right) \underset{G}{\circ} m_{A}\right)^{n}=\sum \mathcal{E}(\mathscr{D})$.
Corollary 3.13. Let $A$ and $B$ be two graded vector spaces. Consider $m_{A} \in C(A)$ and $m_{B} \in C(B)$ of degree 1 and $F \in C(A, B)$ of degree 0 . Suppose that $m_{B}$ satisfies the Stasheff identities $S I^{n}$ for every $n \in \mathbb{N}^{*}$. Then, the following holds.

We now recall the following theorem appearing in [5] in the case of $A_{\infty}$-algebras and give a proof which do not use the bar construction.

Theorem 3.14. Let $\left(A, d_{A}\right),\left(B, d_{B}\right)$ be dg vector spaces and $f: A \rightarrow B$ be a quasi-isomorphism of $d g$ vector spaces. Let $m_{B} \in C(B)$ be an element of degree 1 with $m_{B}^{1}=d_{B}[1]$ that turns $B$ into an $A_{\infty^{-}}$ algebra. Then, there exists an $A_{\infty}$-structure $m_{A}$ on $A$ with $m_{A}^{1}=d_{A}[1]$ as well as an $A_{\infty}$-morphism $F \in C(A, B)$ such that $F^{1}=f[1]$.

Proof. We will construct the $A_{\infty}$-structure and the $A_{\infty}$-morphism inductively. We already have that $m_{A}^{1}=d_{A}[1]$ and $F^{1}=f[1]$ satisfy the identities $\left(S I^{1}\right)$ and $\left(M I^{1}\right)$. Consider $n>1$ and suppose that we have constructed $m_{A} \in C(A)$ of degree 1 and $F \in C(A, B)$ of degree 0 such that the identities $\left(S I^{i}\right)$ and $\left(M I^{i}\right)$ are satisfied for every $i<n$.

Since $\left(m_{A}{ }_{G}^{\circ} m_{A}\right)^{i}$ vanishes for $i<n$ by assumption, the $n$-th term of the identity 3.1) is simply

We thus define the element $\mu_{A} \in C(A)$ by $\mu_{A}^{i}=m_{A}^{i}$ for $i<n$ and $\mu_{A}^{n}=m_{A}^{n}-e$. It satisfies that $\left(\mu_{A}{ }_{G}^{\circ} \mu_{A}\right)^{i}=0$ for $i \leq n$.

Moreover, by (3.3) we have that $\left(F{ }_{G}^{\circ} m_{A}-m_{B}{ }_{M}^{\circ} F\right)^{n}$ is a cycle so it can be written as

As proved in [5] we also have the statement in the other direction, namely, we have the following theorem:

Theorem 3.15. Let $\left(A, d_{A}\right),\left(B, d_{B}\right)$ be dg vector spaces and $f: A \rightarrow B$ be a quasi-isomorphism of $d g$ vector spaces. Let $m_{A} \in C(A)$ be an element of degree 1 with $m_{A}^{1}=d_{A}[1]$ that turns $A$ into an $A_{\infty}$-algebra. Then, there exists an $A_{\infty}$-structure $m_{B} \in C(B)$ on $B$ with $m_{B}^{1}=d_{B}[1]$ as well as an $A_{\infty}$-morphism $F \in C(A, B)$ such that $F^{1}=f[1]$.

Proof. As in the proof of Theorem 3.14, we will construct the $A_{\infty}$-structure and the $A_{\infty}$-morphism inductively. We already have that $m_{B}^{1}=d_{B}[1]$ and $F^{1}=f[1]$ satisfy the identities $\left(S I^{1}\right)$ and $\left(M I^{1}\right)$. Suppose that we have constructed $m_{B}$ of degree 1 and $F \in C(A, B)$ of degree 0 such that the identities $\left(S I^{i}\right)$ and $\left(M I^{i}\right)$ are satisfied for every $i<n$.

The $n$-th term of the identity (3.1) applied with $m_{B}$ instead of $m_{A}$ is just

As before, since $\left(m_{B}{ }_{G}^{\circ} m_{B}\right)^{n}$ is a cycle and $F^{1}$ is a quasi-isomorphism, $\left(m_{B}{ }_{G}^{\circ} m_{B}\right)^{n}$ is itself a boundary, meaning that there exists $e \in C^{n}(B)$ such that $\left(m_{B}{ }_{G}^{\circ} m_{B}\right)^{n}=\partial e$ where $\partial$ denotes the differential of $C(A, B)$. We thus define $\mu_{B}^{i}=m_{B}^{i}$ for $i<n$ and $\mu_{B}^{n}=m_{B}^{n}-e$ and get $\left(\mu_{B}{ }_{G}^{\circ} \mu_{B}\right)^{i}=0$ for $i \leq n$. Again, $\left(\mu_{B}{ }_{M}^{\circ} F-F{ }_{G}^{\circ} m_{A}\right)^{n}$ is a cycle and we can write

Therefore, since we have only modified $\mu$ by adding a cycle, we have $\left(\nu_{A}{ }_{G} \nu_{A}\right)^{i}=0$ for $i \leq n$. By the same argument as for Theorem 3.14. we have that $\left(G{ }_{G} m_{A}-\nu_{B}{ }_{M}^{\circ} G\right)^{n}=0$ so $G$ satisfies the morphism identities $\left(M I^{i}\right)$ for every $i \leq n$. This finishes the proof.

We now recall the definition of a minimal model of an $A_{\infty}$-algebra.
Definition 3.16. An $A_{\infty}$-algebra $\left(B, m_{B}\right)$ is minimal if $m_{B}^{1}=0$. Given an $A_{\infty}$-algebra $\left(A, m_{A}\right)$, a minimal model of $A$ is a minimal $A_{\infty}$-algebra $\left(B, m_{B}\right)$ together with a quasi-isomorphism $P: A \rightarrow B$ of $A_{\infty}$-algebras.

We remark the well-known fact that minimal models of $A_{\infty}$-algebras always exist. Indeed, given an $A_{\infty}$-algebra $\left(A, m_{A}\right)$, let $p: A \rightarrow H(A)$ be any quasi-isomorphism of dg vector spaces. By Theorem 3.15, there exists an $A_{\infty}$-structure on $H(A)$ and a morphism of $A_{\infty}$-algebras $P: A \rightarrow$ $H(A)$ such that $P^{1}=p[1]$. Moreover, we have the following result.

Lemma 3.17. Let $\left(A, m_{A}\right)$ be an $A_{\infty}$-algebra. Given any two quasi-isomorphisms of dg vector spaces $p: A \rightarrow H(A)$ and $i: H(A) \rightarrow A$, the $A_{\infty}$-structures $m_{i}$ and $m_{p}$ on $H(A)$ given in theorems 3.14 and 3.15 are isomorphic. In particular, given quasi-isomorphisms $p, p^{\prime}: A \rightarrow H(A)$ (resp. $\left.i, i^{\prime}: H(A) \rightarrow A\right)$ the $A_{\infty}$-structures $m_{p}$ and $m_{p^{\prime}}$ (resp. $m_{i}, m_{i^{\prime}}$ ) on $H(A)$ given in Theorem 3.15 (resp. in Theorem 3.14) are isomorphic.

Proof. Consider quasi-isomorphisms of dg vector spaces $p: A \rightarrow H(A)$ and $i: H(A) \rightarrow A$. By Theorem 3.15, there is an $A_{\infty}$-structure $m_{p}$ on $H(A)$ and an $A_{\infty}$-morphism $P: A \rightarrow H(A)$ such that $P^{1}=p[1]$. Moreover, by Theorem 3.14 , one can construct an $A_{\infty}$-structure $m_{i}$ on $H(A)$ as well as an $A_{\infty}$-morphism $I: H(A) \rightarrow A$ such that $I^{1}=i[1]$. Those two constructions give isomorphic structures. Indeed, $P \circ I:\left(H(A), m_{i}\right) \rightarrow\left(H(A), m_{p}\right)$ is an $A_{\infty}$-morphism such that $(P \circ I)^{1}$ is a quasi-isomorphism as the composition of quasi-isomorphism. In fact, $p \circ i$ is an isomorphism since $H(A)$ is minimal so $P \circ I$ is an isomorphism of $A_{\infty}$-algebras by Lemma 3.9

Definition 3.18. Let $\left(A, m_{A}\right)$ and $\left(B, m_{B}\right)$ be $A_{\infty}$-algebras. We consider quasi-isomorphisms of complexes $i_{A}: H(A) \rightarrow A$ and $p_{B}: B \rightarrow H(B)$. Then, by Theorem $3.14 H(A)$ is endowed with an $A_{\infty}$-structure $m_{i_{A}}$ and $i_{A}$ extends to an $A_{\infty}$-morphism $I_{A}: H(A) \rightarrow A$. Moreover, by Theorem 3.15 $H(B)$ is endowed with an $A_{\infty}$-structure $m_{p_{B}}$ and $p_{B}$ extends to an $A_{\infty}$-morphism $P_{B}: B \rightarrow H(B)$. Given an $A_{\infty}{ }^{-}$ morphism $F: A \rightarrow B$, we define an $A_{\infty}$-morphism $H(F): H(A) \rightarrow H(B)$ as $H(F)=P_{B} \circ F \circ I_{A}$.

Using the previous results, we deduce the following well-known theorem.

Theorem 3.19. Let $\left(A, m_{A}\right),\left(B, m_{B}\right)$ be two $A_{\infty}$-algebras and $F:\left(A, m_{A}\right) \rightarrow\left(B, m_{B}\right)$ be an $A_{\infty^{-}}$ morphism. Consider quasi-isomorphisms $i_{A}: H(A) \rightarrow A$ and $p_{B}: B \rightarrow H(B)$ and the associated $A_{\infty^{-}}$ morphism $H(F):\left(H(A), m_{i_{A}}\right) \rightarrow\left(H(B), m_{p_{B}}\right)$ given in Definition 3.18 Then, if $F$ is a quasi-isomorphism, there exists a quasi-isomorphism $G:\left(B, m_{B}\right) \rightarrow\left(A, m_{A}\right)$ of $A_{\infty}$-algebras and quasi-isomorphisms $i_{B}: H(B) \rightarrow B, p_{A}: A \rightarrow H(A)$ such that $p_{A} \circ i_{A}=\operatorname{id}_{H(A)}, p_{B} \circ i_{B}=\mathrm{id}_{H(B)}$ and whose associated $H(G)$ in the sense of Definition 3.18 is the inverse of $H(F)$.

Proof. Since $F$ is a quasi-isomorphism, it induces by Lemma 3.9 an isomorphism of $A_{\infty}$-algebras $H(F):\left(H(A), m_{i_{A}}\right) \rightarrow\left(H(B), m_{p_{B}}\right)$ which has an inverse $K:\left(H(B), m_{p_{B}}\right) \rightarrow\left(H(A), m_{i_{A}}\right)$. Consider $i_{B}: H(B) \rightarrow B, p_{A}: A \rightarrow H(A)$ such that $p_{A} \circ i_{A}=\operatorname{id}_{H(A)}$ and $p_{B} \circ i_{B}=\operatorname{id}_{H(B)}$. By Theorem 3.14 and Theorem 3.15, those four maps extend to $A_{\infty}$-morphisms $I_{A}: H(A) \rightarrow A$, $P_{A}: A \rightarrow \overline{H(A)}, I_{B}: H(B) \rightarrow B$ and $P_{B}: B \rightarrow H(B)$ such that $\left(P_{A} \circ I_{A}\right)^{1}=\operatorname{id}_{H(A)[1]}$ and $\left(P_{B} \circ I_{B}\right)^{1}=\operatorname{id}_{H(B)[1]}$. Moreover, up to an automorphism of the $A_{\infty}$-algebra $H(A)(\operatorname{resp} . H(B))$, it is possible to assume that $P_{A} \circ I_{A}=$ id (resp. $P_{B} \circ I_{B}=\mathrm{id}$ ). Then $G=I_{A} \circ K \circ P_{B}$ gives a quasi-inverse for $F$. Indeed, $H(G)=P_{A} \circ G \circ I_{B}=P_{A} \circ I_{A} \circ K \circ P_{B} \circ I_{B}=K$ is an inverse of $H(F)$ by definition.

## 4 Transferring pre-Calabi-Yau structures

### 4.1 Pre-Calabi-Yau algebras

In this subsection, we recall the notions of pre-Calabi-Yau structures and morphisms introduced in [4] and show that a $d$-pre-Calabi-Yau morphism whose first component is an isomorphism is an isomorphism in the category of $d$-pre-Calabi-Yau algebras.

Definition 4.1. Given graded vector spaces $A$ and $B$ and $d \in \mathbb{Z}$, we denote by $\operatorname{Multi}_{d}(A, B)$ the graded vector space

\operatorname{Multi}_{d}(A, B)=\prod_{k \in \mathbb{N}^{*}} \prod_{\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}} \operatorname{Multi}_{d}^{n_{1}, \ldots, n_{k}}(A, B)
$$

where $\operatorname{Multi}_{d}^{n_{1}, \ldots, n_{k}}(A, B)=\mathcal{H o m}_{\mathbb{k}}\left(A[1]^{\otimes n_{1}} \otimes \cdots \otimes A[1]^{\otimes n_{k}}, B[-d]^{\otimes k}\right)$. To simplify, we will denote $\operatorname{Multi}_{d}(A, A)$ simply by $\operatorname{Multi}_{d}(A)$.

The action of $\sigma=\left(\sigma_{n}\right)_{n \in \mathbb{N}^{*}} \in \prod_{n \in \mathbb{N}^{*}} C_{n}$ on $F=\left(F^{n_{1}, \ldots, n_{k}}\right)_{\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}} \in \operatorname{Multi}_{d}(A, B)$ is the element $\sigma \cdot F \in \operatorname{Multi}_{d}(A, B)$ given by

$$
(\sigma \cdot F)^{n_{1}, \ldots, n_{k}}=\tau_{B[-d], \ldots, B[-d]}^{\sigma^{-1}} \circ F^{\sigma\left(n_{1}, \ldots, n_{k}\right)} \circ \tau_{A[1] \otimes n_{1}, \ldots, A[1]^{\otimes n_{k}}}^{\sigma}
$$

for $\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$. We denote $\operatorname{Multi}_{d}(A, B)^{C}$ • the space of elements of $\operatorname{Multi}_{d}(A, B)$ that are invariant under the action of $\prod_{n \in \mathbb{N}^{*}} C_{n}$.

Remark 4.2. If $\left(A, d_{A}\right)$ and $\left(B, d_{B}\right)$ are dg vector spaces, $\operatorname{Multi}_{d}(A, B)$ becomes a dg vector space, with differential given by $d_{\text {Multi }_{d}(A, B)} F=d_{B[-d] \otimes k} \circ F-(-1)^{|F|} F \circ d_{A[1] \otimes\left(n_{1}+\cdots+n_{k}\right)}$ for $F \in \operatorname{Multi}_{d}^{n_{1}, \ldots, n_{k}}(A, B)$.

Definition 4.3. A d-pre-Calabi-Yau structure on a graded vector space $A$ is an element of degree 1 $s_{d+1} M_{A} \in \operatorname{Multi}_{d}(A)^{C} \cdot[d+1]$ satisfying the identities $\left(S I^{n_{1}, \ldots, n_{k}}\right)$ given by $\sum \mathcal{E}(\mathscr{D})+\sum \mathcal{E}\left(\mathscr{D}^{\prime}\right)=0$ where the sums are over all the filled diagrams $\mathscr{D}$ and $\mathscr{D}^{\prime}$ of type $\left(n_{1}, \ldots, n_{k}\right)$ and of the form

for every $\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$. This is tantamount to $\left[s_{d+1} M_{A}, s_{d+1} M_{A}\right]_{\text {nec }}=0$ where $[-,-]_{\text {nec }}$ denotes the necklace bracket given as the graded commutator of the necklace product o introduced in |4]. A graded vector space endowed with a d-pre-Calabi-Yau structure is called a d-pre-Calabi-Yau algebra.

We now recall the definition of pre-Calabi-Yau morphisms given in [4].
Definition 4.4. Let $\left(A, s_{d+1} M_{A}\right),\left(B, s_{d+1} M_{B}\right)$ be two d-pre-Calabi-Yau algebras. A d-pre-Calabi-Yau morphism $F:\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$ is an element $s_{d+1} F \in \operatorname{Multi}_{d}(A, B)^{C \bullet}[d+1]$ of degree 0 satisfying the identities $\left(M I^{n_{1}, \ldots, n_{k}}\right)$ given by $\sum \mathcal{E}(\mathscr{D})=\sum \mathcal{E}\left(\mathscr{D}^{\prime}\right)$ where the sums are over all the filled diagrams $\mathscr{D}$ and $\mathscr{D}^{\prime}$ of type $\left(n_{1}, \ldots, n_{k}\right)$ and of the form

and

for every $\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$. This is tantamount to $s_{d+1} F_{\text {multinec }}^{\circ} s_{d+1} M_{A}-s_{d+1} M_{B} \circ{ }_{\text {pre }}^{\circ} s_{d+1} F=0$ where the compositions $\underset{\text { multinec }}{\circ}$ and $\underset{\text { pre }}{\circ}$ denote the right hand side and left hand side of the equation respectively.

Remark 4.5. The identities $\left(S I^{n}\right)$ for $n \in \mathbb{N}^{*}$ are just the Stasheff identities given in Definition 3.3 Then, if $\left(A, s_{d+1} M_{A}\right)$ is a d-pre-Calabi-Yau algebra the collection of maps $\left(M_{A}^{n}\right)_{n \in \mathbb{N}^{*}}$ turns $A$ into an $A_{\infty}$-algebra and as before, $\left(A[1], M_{A}^{1}\right)$ is a dg vector space. Moreover, a d-pre-Calabi-Yau morphism $F$ : $\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$ induces an $A_{\infty}$-morphism between the underlying $A_{\infty}$-algebras.

Definition 4.6. Let $\left(A, s_{d+1} M_{A}\right),\left(B, s_{d+1} M_{B}\right)$ and $\left(C, s_{d+1} M_{C}\right)$ be d-pre-Calabi-Yau algebras and consider $s_{d+1} F:\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$ and $s_{d+1} G:\left(B, s_{d+1} M_{B}\right) \rightarrow\left(C, s_{d+1} M_{C}\right)$ two d-pre-Calabi-Yau morphisms. The composition of $s_{d+1} F$ and $s_{d+1} G$ is by definition the element $s_{d+1} G \circ s_{d+1} F$ of $\operatorname{Multi}_{d}(A, B)^{C} \cdot[d+1]$ given by $\left(s_{d+1} G \circ s_{d+1} F\right)^{n_{1}, \ldots, n_{k}}=\sum \mathcal{E}(\mathscr{D})$ where the sum is over all the filled diagrams $\mathscr{D}$ of type $\left(n_{1}, \ldots, n_{k}\right)$ and of the form


Lemma 4.7. The data of d-pre-Calabi-Yau algebras together with d-pre-Calabi-Yau morphisms and their composition give rise to a category denoted $\mathrm{pCY}_{d}$. Given a d-pre-Calabi-Yau algebra $\left(A, s_{d+1} M_{A}\right)$, the $d$ -pre-Calabi-Yau identity morphism on $A$ is the element of $\operatorname{Multi}_{d}(A)[d+1]$ given for $\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$ by $\operatorname{id}_{A[1]}$ if $k=1, n_{1}=1$ and by 0 otherwise. It will be denoted $\mathrm{id}_{A}$ or simply by id when there is no possible confusion.

Definition 4.8. Given d-pre-Calabi-Yau algebras $\left(A, s_{d+1} M_{A}\right)$ and $\left(B, s_{d+1} M_{B}\right)$, we say that a d-pre-Calabi-Yau morphism $s_{d+1} F:\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$ is a quasi-isomorphism if the map $s_{d+1} F^{1}:\left(A[1], M_{A}^{1}\right) \rightarrow\left(B[1], M_{B}^{1}\right)$ is a quasi-isomorphism of dg vector spaces. Moreover, $s_{d+1} F$ is an isomorphism if there exists a d-pre-Calabi-Yau morphism $s_{d+1} G:\left(B, s_{d+1} M_{B}\right) \rightarrow\left(A, s_{d+1} M_{A}\right)$ such that $s_{d+1} G \circ s_{d+1} F=\operatorname{id}_{A}$, and $s_{d+1} F \circ s_{d+1} G=\operatorname{id}_{B}$.

Lemma 4.9. Let $\left(A, s_{d+1} M_{A}\right),\left(B, s_{d+1} M_{B}\right)$ be d-pre-Calabi-Yau algebras and consider a d-pre-CalabiYau morphism $s_{d+1} F:\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$. If $s_{d+1} F^{1}:\left(A[1], s_{d+1} M_{A}^{1}\right) \rightarrow\left(B[1], s_{d+1} M_{B}^{1}\right)$ is an isomorphism of $d g$ vector spaces, then $s_{d+1} F$ is an isomorphism of $d$-pre-Calabi-Yau algebras.

Proof. By Lemma 3.9, we have already constructed maps $G^{n}: B[1]{ }^{\otimes n} \rightarrow A[1]$ for every $n \in \mathbb{N}^{*}$. We now construct maps $G^{n_{1}, \ldots, n_{k}}: B[1]^{\otimes n_{1}} \otimes \cdots \otimes B[1]^{\otimes n_{k}} \rightarrow A[-d]^{\otimes k}$ for every $k>1$ and $\left(n_{1}, \ldots, n_{k}\right) \in \mathcal{T}_{k}$. Consider $k>1$ and suppose that we have defined the maps $G^{i_{1}, \ldots, i_{j}}: B[1]^{\otimes i_{1}} \otimes$ $\cdots \otimes B[1]^{\otimes i_{j}} \rightarrow A[-d]^{\otimes k}$ satisfying that $\left(s_{d+1} G \circ s_{d+1} F\right)^{i_{1}, \ldots, i_{j}}=0=\left(s_{d+1} F \circ s_{d+1} G\right)^{i_{1}, \ldots, i_{j}}$ for every $\left(i_{1}, \ldots, i_{j}\right) \in \mathcal{T}_{j}, j<k$. We have

$$
\left(s_{d+1} F \circ s_{d+1} G\right)^{0, \ldots, 0}=\left(s_{d+1} F^{1}\right)^{\otimes k} \circ s_{d+1} G^{0, \ldots, 0}+s_{d+1} \chi^{0, \ldots, 0}
$$

where $\chi^{0, \ldots, 0}$ is a sum of maps $\mathbb{k} \rightarrow A[-d]^{\otimes k}$ such that the only components of $s_{d+1} G$ that appear are $s_{d+1} G^{u_{1}, \ldots, u_{r}}$ where $r<k$. We thus define $s_{d+1} G^{0, \ldots, 0}=-\left(s_{d+1} G^{1}\right)^{\otimes k} \circ s_{d+1} \chi^{0, \ldots, 0}$. Consider $\bar{n} \in \mathcal{T}_{k}$ and suppose that we have defined the maps $G^{i_{1}, \ldots, i_{k}}: B[1]^{\otimes i_{1}} \otimes \cdots \otimes B[1]^{\otimes i_{k}} \rightarrow A[-d]^{\otimes k}$ satisfying that $\left(s_{d+1} G \circ s_{d+1} F\right)^{i_{1}, \ldots, i_{k}}=0=\left(s_{d+1} F \circ s_{d+1} G\right)^{i_{1}, \ldots, i_{k}}$ for every $\bar{i}=\left(i_{1}, \ldots, i_{k}\right) \in \mathcal{T}_{k}$ with $N(\bar{i})<N(\bar{n})$. We have that $\left(s_{d+1} G \circ s_{d+1} F\right)^{\bar{n}}=\mathcal{E}\left(\mathscr{D}_{1}\right)+\sum \mathcal{E}\left(\mathscr{D}_{2}\right)$ where $\mathscr{D}_{1}$ is the unique diagram of type $\bar{n}$ containing a disc of type $\bar{n}$ filled with $G$ whose incoming arrows are shared with discs of type 1 filled with $F$ and where the sum is over all the filled diagrams $\mathscr{D}_{2}$ of type $\bar{n}$ and of the form

respectively. Note that $\mathscr{D}_{1}$ is the only diagram containing a disc of type $\bar{n}$ filled with $G$. Moreover, diagrams involved in the previous sum $\sum \mathcal{E}\left(\mathscr{D}_{2}\right)$ contain either only discs filled with $F$ having one outgoing arrow or at least one disc filled with $F$ with several outgoing arrows. In the first case, the terms only contain discs filled with $G$ of type $\bar{i} \in \mathcal{T}_{k}$ with $N(\bar{i})<N(\bar{n})$. Indeed, the discs filled with $F$ only have one outgoing arrow but there is at least one of them having more that one incoming arrow. Then, there is at least one $j \in \llbracket 1, k \rrbracket$ such that $i_{j}<n_{j}$. In the second case, they
only contain discs filled with $G$ of type $\left(i_{1}, \ldots, i_{j}\right) \in \mathcal{T}_{j}$ and $j<k$ since the total number of outputs is $k$. This allows us to define $s_{d+1} G^{n}=-\sum \mathcal{E}(\mathscr{D})$ where the sum is over all the filled diagrams $\mathscr{D}$ of type $\bar{n}$ and of the form

where the dotted arrows represent the map $g$. Note that we did not use the fact that $F$ is a $d$ -pre-Calabi-Yau morphism. Thus, there exists an element $s_{d+1} H \in \operatorname{Multi}_{d}(A, B)^{C \cdot} \cdot[d+1]$ such that $s_{d+1} H \circ s_{d+1} G=\mathrm{id}_{B}$. Using the associativity of the composition, we get that $H=F$ and thus $s_{d+1} G \circ s_{d+1} F=\mathrm{id}_{A}$ and $s_{d+1} F \circ s_{d+1} G=\mathrm{id}_{B}$.

It remains to check that $s_{d+1} G$ is a $d$-pre-Calabi-Yau morphism. By Lemma 3.9 the identities $\left(M I^{n}\right)$ are satisfied for $n \in \mathbb{N}^{*}$. We now consider $k>1$ and suppose that the identities $\left(M I^{\bar{i}}\right)$ are satisfied for every $\bar{i} \in \mathcal{T}_{j}$ for $j<k$ and consider $\bar{n} \in \mathcal{T}_{k}$. Since $s_{d+1} F$ is a $d$-pre-Calabi-Yau morphism, we have that $s_{d+1} F{ }_{\text {multinec }}^{\circ} s_{d+1} M_{A}=s_{d+1} M_{B}{ }^{\circ} s_{d+1} F$ which gives $\sum \mathcal{E}(\mathscr{D})=\sum \mathcal{E}\left(\mathscr{D}^{\prime}\right)$ where the sums are over all the diagrams $\mathscr{D}$ and $\mathscr{D}^{\prime}$ of type $\bar{n}$ and of the form

and

respectively. Since $s_{d+1} F \circ s_{d+1} G=\mathrm{id}$, we have that $\sum \mathcal{E}(\mathscr{D})=M_{B}^{\bar{n}}$. Therefore, we have that $\left(s_{d+1} G_{\text {multinec }} s_{d+1} M_{B}\right)^{\bar{n}}=\sum \mathcal{E}\left(\mathscr{D}_{1}^{\prime}\right)+\sum \mathcal{E}\left(\mathscr{D}_{2}^{\prime}\right)$ where the sums are over all the diagrams of type $\bar{n}$ and of the form

respectively. We now show that $\sum \mathcal{E}\left(\mathscr{D}_{2}^{\prime}\right)=0$. Suppose that the identity $\left(M I^{\bar{i}}\right)$ is also satisfied for every $\bar{i} \in \mathcal{T}_{j}$ with $j=k$ and $N(\bar{i})<N(\bar{n})$. We then have that $\sum \mathcal{E}\left(\mathscr{D}_{2}^{\prime}\right)=\sum \mathcal{E}\left(\mathscr{D}_{3}^{\prime}\right)$ where the second sum is over all the filled diagrams $\mathscr{D}_{3}^{\prime}$ of type $\bar{n}$ and of the form


Note that for the diagrams of type $(0, \ldots, 0) \in \mathcal{T}_{k}$ we only used the identities $\left(M I^{\bar{i}}\right)$ for $\bar{i} \in \mathcal{T}_{j}$ with $j<k$. Then, by induction and since $\left(s_{d+1} F \circ s_{d+1} G\right)^{i}=0$ for $\bar{i} \neq 1$, we have that $\sum \mathcal{E}\left(\mathscr{D}_{3}^{\prime}\right)=0$ so $s_{d+1} G$ is a $d$-pre-Calabi-Yau morphism.

### 4.2 Transferring pre-Calabi-Yau structures

In this subsection, we generalize the results of [5] to the case of $d$-pre-Calabi-Yau algebras. We first define two different ways of composing maps and then give useful identities for the proof of Theorem4.13 and Theorem4.14

Definition 4.10. Let $A$ and $B$ be two graded vector spaces and consider $s_{d+1} F \in \operatorname{Multi}_{d}(A, B)[d+1]$. Given $s_{d+1} M \in \operatorname{Multi}_{d}(B)[d+1]$ and $s_{d+1} H \in \operatorname{Multi}_{d}(A, B)[d+1]$ we define the lower composition of $s_{d+1} M$ and $s_{d+1} H$ with respect to $s_{d+1} F$ as the element $\left(s_{d+1} M \underset{s_{d+1} F}{\circ} s_{d+1} H\right) \in \operatorname{Multi}_{d}(A, B)[d+1]$
such that such that

$$

exists $E \in \operatorname{Multi}_{d}^{\bar{n}}(B)$ such that $\left(s_{d+1} M_{B} \circ \circ{ }_{\text {nec }} s_{d+1} M_{B}\right)^{\bar{n}}=\partial\left(s_{d+1} E\right)$. We thus define $\mu_{B}^{\bar{i}}=M_{B}^{\bar{i}}$ for $\bar{i} \in \mathcal{T}_{j}$ with $j<k$ or $j=k$ and $N(\bar{i})<N(\bar{n})$ and $\mu_{B}^{\bar{n}}=M_{B}^{\bar{n}}-E$. Then, $\left(s_{d+1} \mu_{B} \circ \circ{ }_{\text {nec }} s_{d+1} \mu_{B}\right)^{\bar{i}}=0$ for $\bar{i} \in \mathcal{T}_{j}$ with $j<k$ or $j=k$ and $N(\bar{i})<N(\bar{n})$.

Moreover, by (4.4) we have that $\left(s_{d+1} M_{B} \stackrel{\circ}{\circ} s_{d+1} F-s_{d+1} F_{\text {multinec }}^{\circ} s_{d+1} M_{A}\right)^{\bar{n}}$ is a cycle so it can be written as

$$
\left(s_{d+1} M_{B} \circ s_{\text {pre }} s_{d+1} F-s_{d+1} F \underset{\text { multinec }}{\circ} s_{d+1} M_{A}\right)^{\bar{n}}=s_{d+1} E^{\prime} \circ\left(F^{1}\right)^{\otimes N(\bar{n})}+\partial\left(s_{d+1} E^{\prime \prime}\right)
$$

where $E^{\prime}$ is a cycle of $\operatorname{Multi}_{d}(B)$ and $E^{\prime \prime} \in \operatorname{Multi}_{d}(A, B)$.
We set $\nu_{B}^{\bar{i}}=\mu_{B}^{\bar{i}}$ for $\bar{i} \in \mathcal{T}_{j}$ with $j<k$ or $j=k$ and $N(\bar{i})<N(\bar{n}), \nu_{B}^{\bar{n}}=\nu_{B}^{\bar{n}}-E^{\prime}$ and $G^{\bar{i}}=F^{\bar{i}}$ for $i<n, G^{\bar{n}}=F^{\bar{n}}-E^{\prime \prime}$. Therefore, since we have only modified $s_{d+1} \mu_{B}$ by adding a cycle, we have $\left(s_{d+1} \nu_{B}{ }_{\text {nec }}^{\circ} s_{d+1} \nu_{B}\right)^{\bar{i}}=0$ for $\bar{i} \in \mathcal{T}_{j}$ with $j<k$ or $j=k$ and $N(\bar{i})<N(\bar{n})$. It is straightforward to check that $\left(s_{d+1} \nu_{B} \text { pre }{ }_{\text {pre }} s_{d+1} G-s_{d+1} G \text { multinec }{ }^{\circ} s_{d+1} M_{A}\right)^{\bar{n}}=0$. This finishes the proof.

### 4.3 Minimal models and quasi-isomorphisms of pre-Calabi-Yau algebras

We now remark that the previous results leads to the existence of minimal models for pre-CalabiYau algebras and prove that any quasi-isomorphism of $d$-pre-Calabi-Yau algebras admits a quasiinverse.

Definition 4.15. A d-pre-Calabi-Yau algebra $\left(B, s_{d+1} M_{B}\right)$ is minimal if $M_{B}^{1}=0$. Given a $d$-pre-CalabiYau algebra $\left(A, s_{d+1} M_{A}\right)$, a minimal model of $A$ is a minimal $d$-pre-Calabi-Yau algebra $\left(B, s_{d+1} M_{B}\right)$ together with a quasi-isomorphism $P: A \rightarrow B$ of $d$-pre-Calabi-Yau algebras.

As for the case of $A_{\infty}$-algebras we deduce from the previous results that minimal models of pre-Calabi-Yau algebras always exist. Indeed, given a $d$-pre-Calabi-Yau algebra $\left(A, s_{d+1} M_{A}\right)$, let $p: A \rightarrow H(A)$ be any quasi-isomorphism of dg vector spaces. By Theorem 4.14, there exists an $d$-pre-Calabi-Yau structure on $H(A)$ and a morphism of $d$-pre-Calabi-Yau algebras $P: A \rightarrow H(A)$ such that $P^{1}=p[1]$ is a quasi-isomorphism.

Lemma 4.16. Let $\left(A, s_{d+1} M_{A}\right)$ be a $d$-pre-Calabi-Yau algebra. Given quasi-isomorphisms of dg vector spaces $p: A \rightarrow H(A)$ and $i: H(A) \rightarrow A$, the d-pre-Calabi-Yau structures $M_{i}$ and $M_{p}$ on $H(A)$ given in Theorem 4.13 and 4.14 are isomorphic. In particular, given quasi-isomorphisms $p, p^{\prime}: A \rightarrow H(A)$ (resp. $i, i^{\prime}: H(A) \rightarrow A$ ), the $d$-pre-Calabi-Yau structures $M_{p}$ and $M_{p^{\prime}}\left(r e s p . M_{i}\right.$ and $\left.M_{i^{\prime}}\right)$ on $H(A)$ given in Theorem 4.14 (resp. in Theorem 4.13) are isomorphic.

Proof. Consider quasi-isomorphisms $p: A \rightarrow H(A)$ and $i: H(A) \rightarrow A$. By Theorem 4.13 one can define a $d$-pre-Calabi-Yau structure $M_{p}$ on $H(A)$ as well as a $d$-pre-Calabi-Yau morphism $P_{A}$ : $A \rightarrow H(A)$ such that $P^{1}=p[1]$. Moreover, by Theorem 4.14, one can construct a $d$-pre-Calabi-Yau structure $M_{i}$ on $H(A)$ and a $d$-pre-Calabi-Yau morphism $I: H(A) \rightarrow A$ such that $I^{1}=i[1]$. Those two constructions give isomorphic structures. Indeed, the composition $P \circ I:\left(H(A), M_{i}\right) \rightarrow$ ( $H(A), M_{p}$ ) is a $d$-pre-Calabi-Yau morphism such that $(P \circ I)^{1}$ is an isomorphism since $H(A)$ is minimal so $P \circ I$ is an isomorphism of $d$-pre-Calabi-yau algebras by Lemma 4.9

Definition 4.17. Let $\left(A, s_{d+1} M_{A}\right)$ and $\left(B, s_{d+1} M_{B}\right)$ be d-pre-Calabi-Yau algebras. We consider quasiisomorphisms of complexes $i_{A}: H(A) \rightarrow A$ and $p_{B}: B \rightarrow H(B)$. Then, by Theorem $4.13 H(A)$ is endowed with a d-pre-Calabi-Yau structure $M_{i_{A}}$ and $i_{A}$ extends to a d-pre-Calabi-Yau morphism $I_{A}$ :
$H(A) \rightarrow$ A. Moreover, by Theorem $4.14 H(B)$ is endowed with a $d$-pre-Calabi-Yau structure $M_{p_{B}}$ and $p_{B}$ extends to a d-pre-Calabi-Yau morphism $P_{B}: B \rightarrow H(B)$. Given a d-pre-Calabi-Yau morphism $F: A \rightarrow B$ we define a d-pre-Calabi-Yau morphism $H(F): H(A) \rightarrow H(B)$ as $H(F)=P_{B} \circ F \circ I_{A}$.

Using the previous results, we deduce that any quasi-isomorphism of $d$-pre-Calabi-Yau algebras admits a quasi-inverse.

Theorem 4.18. Let $\left(A, s_{d+1} M_{A}\right)$ and $\left(B, s_{d+1} M_{B}\right)$ be $d$-pre-Calabi-Yau algebras and consider a $d$-pre-Calabi-Yau morphism $F:\left(A, s_{d+1} M_{A}\right) \rightarrow\left(B, s_{d+1} M_{B}\right)$. Consider quasi-isomorphisms $i_{A}: H(A) \rightarrow A$ and $p_{B}: B \rightarrow H(B)$ and $H(F):\left(H(A), M_{i_{A}}\right) \rightarrow\left(H(B), M_{p_{B}}\right)$ given in Definition 4.17 Then, if $F$ is a quasi-isomorphism, there exists a quasi-isomorphism $G:\left(B, s_{d+1} M_{B}\right) \rightarrow\left(A, s_{d+1} M_{A}\right)$ of d-pre-CalabiYau algebras as well as quasi-isomorphisms $i_{B}: H(B) \rightarrow B, p_{A}: A \rightarrow H(A)$ such that $p_{A} \circ i_{A}=\operatorname{id}_{H(A)}$, $p_{B} \circ i_{B}=\operatorname{id}_{H(B)}$ and whose associated $H(G)$ in the sense of Definition 4.17 is the inverse of $H(F)$.

Proof. Since $F$ is a quasi-isomorphism, it induces by Lemma 4.9 an isomorphism of $d$-pre-CalabiYau algebras $H(F):\left(H(A), M_{i_{A}}\right) \rightarrow\left(H(B), M_{p_{B}}\right)$ which has an inverse denoted here by $K$ : $\left(H(B), M_{p_{B}}\right) \rightarrow\left(H(A), M_{i_{A}}\right)$. Consider $i_{B}: H(B) \rightarrow B, p_{A}: A \rightarrow H(A)$ such that $p_{A} \circ i_{A}=\operatorname{id}_{H(A)}$ and $p_{B} \circ i_{B}=\operatorname{id}_{H(B)}$. By Theorem 4.13 and Theorem 4.14 those maps extend to $d$-pre-Calabi-Yau morphisms $I_{A}: H(A) \rightarrow A, P_{A}: A \rightarrow H(A), I_{B}: H(B) \rightarrow B$ and $P_{B}: B \rightarrow H(B)$ such that $\left(P_{A} \circ I_{A}\right)^{1}=\operatorname{id}_{H(A)[1]}$ and $\left(P_{B} \circ I_{B}\right)^{1}=\operatorname{id}_{H(B)[1]}$. Moreover, up to an automorphism of the $d$-pre-Calabi-Yau algebra $H(A)$ (resp. $H(B)$ ), it is possible to assume that $P_{A} \circ I_{A}=\mathrm{id}$ (resp. $P_{B} \circ I_{B}=\mathrm{id}$ ). Then $G=I_{A} \circ K \circ P_{B}$ gives a quasi-inverse for $F$ since by definition we have that $H(G)=P_{A} \circ G \circ I_{B}=P_{A} \circ I_{A} \circ K \circ P_{B} \circ I_{B}=K$.
