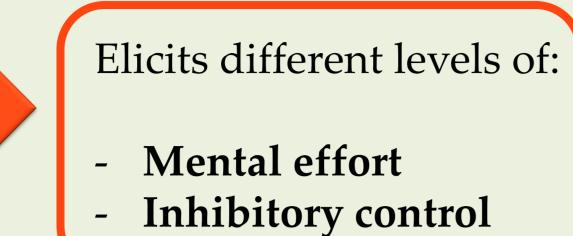


# INTRODUCTION

Cognitive aging leads to declines in inhibition. Inhibition deficits can lead to decision-making errors in complex work contexts. Cardiac reactivity may be a relevant marker of inhibition control, but little is known on its dynamics and age-related effects.

Performing a cognitive task with different levels of **Inhibition:** 

- Interference control
- Response inhibition



**Cardiac reactivity** as an autonomic marker of such mental activities, with: **Sympathetic nervous system activity**: cardiac pre-ejection period (PEP)

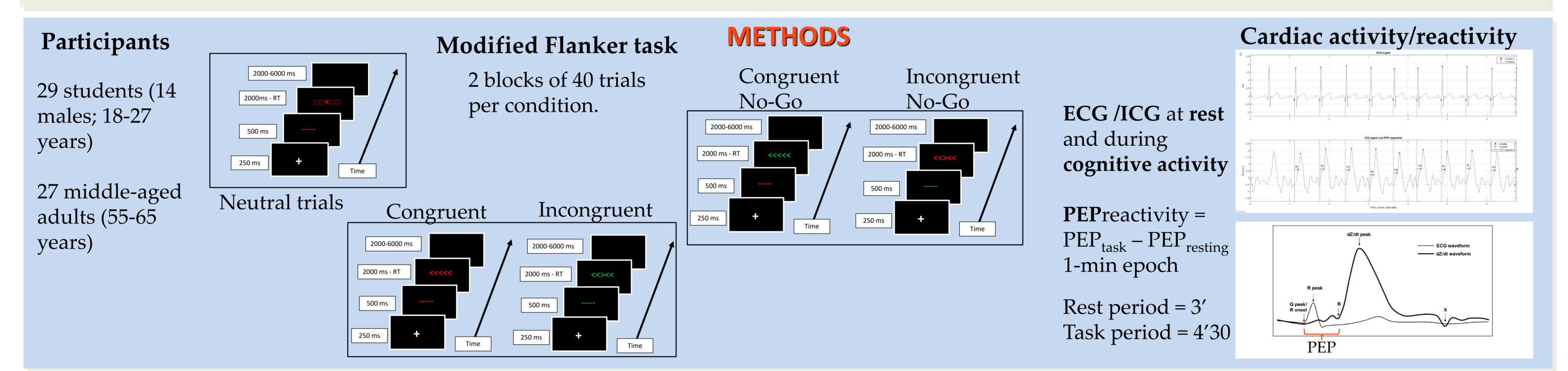

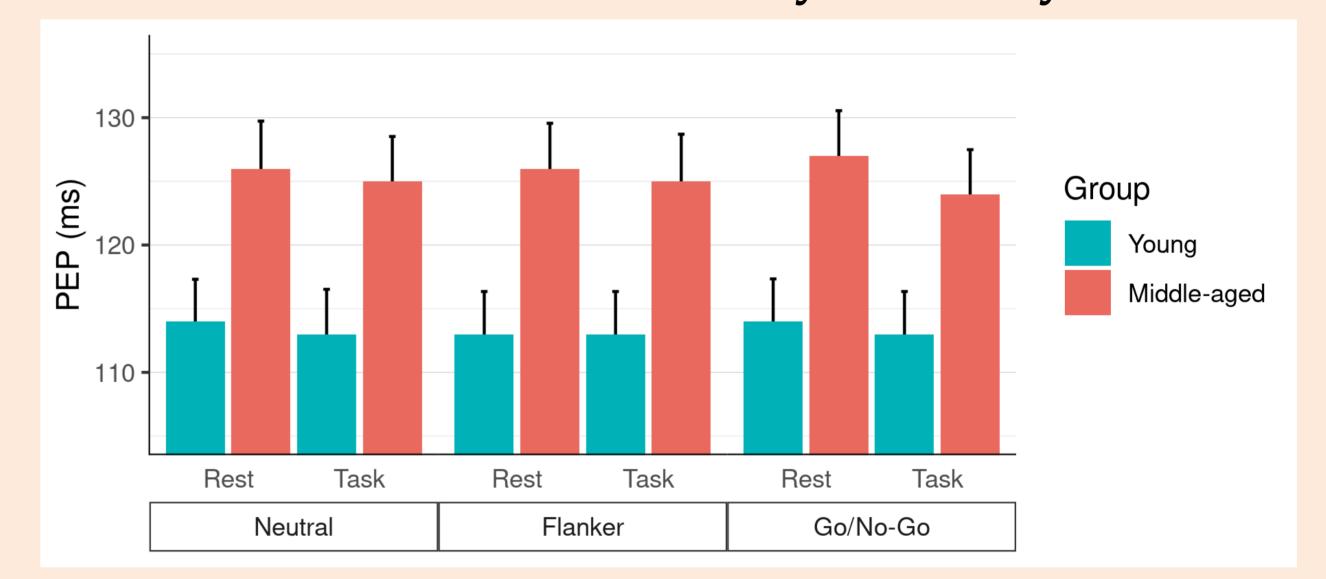

<u>Objectives</u>: To examine whether PEP reactivity dynamically adapts to different levels of inhibition control in young and middle-aged adults, using a mixed within-between-subjects experimental design.



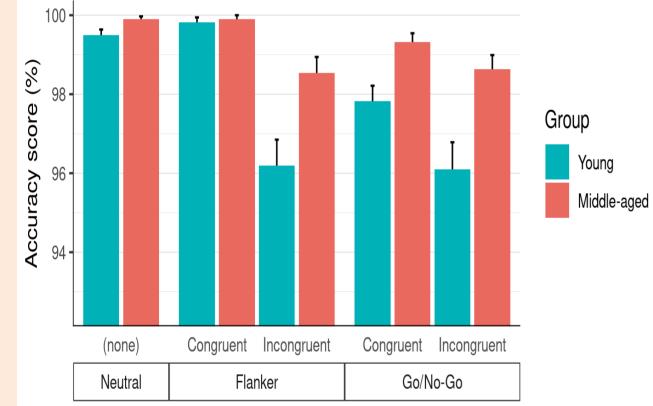
RESULTS

**Cardiac activity/reactivity** 



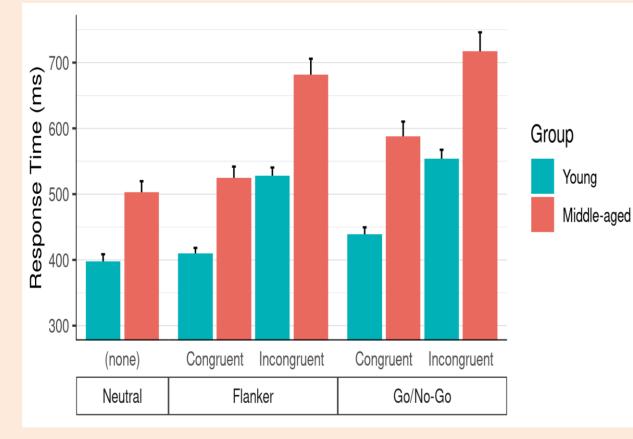
**Behavioral data** 

Accuracy



Accuracy was greater for Neutral block than Flanker block and Go/No-Go block ( $p < .001; \eta_p^2 = .33$ ). Greater for Congruent trials than for Incongruent trials ( $p < .001; \eta_p^2 = .34$ ). Greater for Middle-aged than Young ( $p < .001; \eta_p^2 = .35$ ).

### Reaction Time



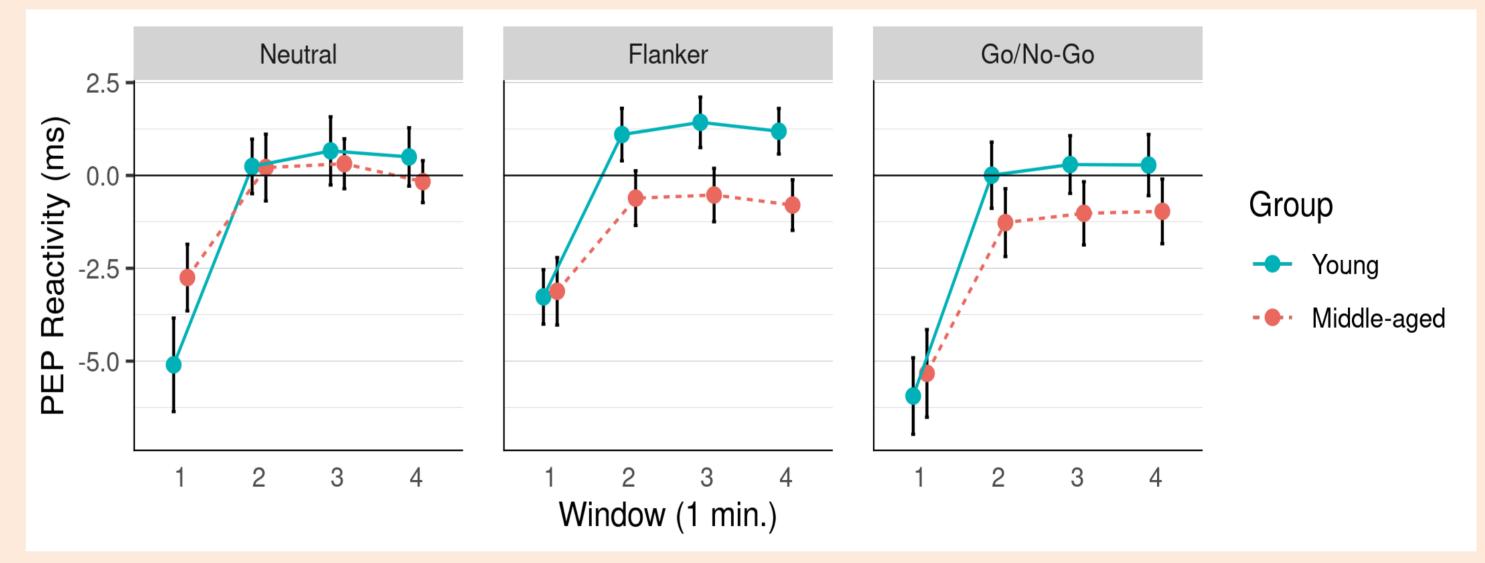
RT increased from Neutral to Flanker to Go/No-Go block (p < .001;  $\eta_p^2 = .72$ ). Shorter for Congruent trials than Incongruent trials (p < .001;  $\eta_p^2 = .72$ ). Longer for Middle-aged than Young

### Inhibition cost of Composite Score (Accuracy/RT\*100)

Block	Young	Middle-aged	Relative inhibition cost decreased
Inhibition cost Flanker	24.8 % (4.8)	23.7% (6.9)	from Flanker to Go/No-Go block $(p < .001; \eta_p^2 = .45).$
Inhibition cost Flanker Go/No-Go	21.9% (6.4)	17.9% (8.9)	No difference between the 2 groups.

Globally,  $PEP_{task}$  was slightly shorter than  $PEP_{rest}$  (p = .02;  $\eta^2_p$  = .09). PEP was longer for Middle-aged than Young (p = .01;  $\eta^2_p$  = .10). PEP was stable across rest periods.



PEP reactivity was significant only for the first 1-min window (w1). PEP reactivity was greater for Go/No-Go block than Neutral block and Flanker block (p = .002;  $\eta_p^2 = .11$ ). No difference between the 2 groups.

## DISCUSSION

Overall, participants were **less accurate and slower** during the **most challenging** task involving **interference control and response inhibition**. Middle-aged were more accurate but slower and their inhibition cost was comparable to the one of the younger participants. **Absolute PEP** values were **higher** for the **middle-aged** but **PEP reactivity** was **comparable** between the **2 groups**. These results add to the current very limited but contradictory literature on this topic (Cybulski, 1996; Gurel et al., 2019).

Importantly, for both groups, **PEP reactivity** was significantly **lower than 0 only during the first minute** of each experimental task, going back to baseline level afterward. Similar dynamics were recently reported but during a recovery period by Czarnek et al., (2021). **PEP reactivity** was also **more important** during the **flanker Go/No-Go** task comparatively to the flanker task and the neutral task.

**PEP reactivity** appears to be **sensitive to different levels of inhibitory control** requirement, but **does not increase linearly as a function of task demands**. It also appears to be a **short lasting phenomenon**, demonstrating a possible rapid dynamic adaptation of the cardiac activity to task constraints or a form of habituation. Additional within-subjects design studies are required to replicate these findings.
