8 Abstract

9 Extracellular alkaline phosphatase activity (APA) was measured in four tropical 10 (Stylophora pistillata, Pocillopora damicornis, Pavona cactus, Galaxea fascicularis) and two 11 Mediterranean (Oculina patagonica, Cladocora caespitosa) symbiotic coral species, both in 12 the coral host and associated symbionts, as well as in one tropical non-symbiotic coral 13 (Tubastraea sp.). The effects of light, feeding, and bleaching (loss of symbionts) were also 14 tested in Stylophora pistillata. Host APA increased both with long-term starvation, irradiance, 15 and bleaching suggesting that APA is linked to the metabolic activity of the host and symbionts, and to their phosphate limitation or repletion status. The comparison of APA 16 17 between coral species containing different symbiont clades suggests that clade C is less 18 efficient than clades A and B, but this result remains to be confirmed. At environmental 19 phosphate concentrations, if the total amount of phosphate generated by APA is taken up by the coral colony, it can supply 0.3 - 1.6 mmol P m⁻² d⁻¹. In comparison, dissolved inorganic 20 21 phosphorus (DIP) and particulate organic phosphorus (POP) have been shown supply 0.2 - 1.6 and 0.9 mmol P m⁻² d⁻¹, respectively, highlighting the importance of APA activity in 22 symbiotic corals. 23

33 Introduction

34 Phosphorus is essential to living organisms because it enters into the composition of many biological molecules as phosphate (e.g., deoxyribonucleic acids, ribonucleic acids, 35 36 phospholipids), and has a role in signaling pathways and metabolic reactions (mostly via the 37 role of adenosine triphosphate, ATP). Corals can fulfill their phosphate needs in several ways. 38 The first way is through the degradation of particulate organic phosphorus (POP), after the 39 capture of plankton caught by the coral host with its stinging tentacles (Johannes et al. 1970; 40 Wijgerde et al. 2011). POP in reef waters corresponds to a mean concentration of ca. 0.10 µmol P L⁻¹ (Furnas et al. 1988; Charpy 2001). Coral acquisition of phosphate from POP has 41 42 been seldom examined. A recent study estimated that extracoelenteric zooplankton feeding in the species *Galaxea fascicularis* may provide up to 0.9 ± 0.3 mmol P m⁻² d⁻¹ (Wijgerde et al. 43 2011), which was however obtained with a relatively high prey density (4100 nauplii L^{-1}). 44 45 Phosphate is also acquired from dissolved inorganic phosphorus (DIP), directly through an 46 active uptake mediated by the dinoflagellate symbionts (D'Elia 1977; Jackson and Yellowlees 47 1990; Godinot et al. 2009). This DIP presents concentrations between 0.05 and 0.50 µmol P L⁻¹ in reef waters (Atkinson 1987*a*; Charpy 2001), and contribute 0.2 to 1.1 mmol P m⁻² d⁻¹ to 48 reef benthos (Steven and Atkinson 2003; Cuet et al. 2011), and 1.6 mmol P m⁻² d⁻¹ to corals 49 50 (Godinot et al. 2009) at these concentrations. The last source of phosphate is represented by 51 dissolved organic phosphorus (DOP), which can be hydrolyzed into phosphate by 52 metalloenzymes called phosphatases. DOP concentrations in reef waters are in the same range as DIP concentrations, i.e., generally lower than 0.5 μ mol P L⁻¹ (Crossland and Barnes 1983; 53 54 Larned 1998). While the coral acquisition of phosphate from DIP has been frequently studied, 55 little research has been done on DOP degradation, and only isolated symbionts from 56 scleractinian corals were considered so far (Jackson et al. 1989; Annis and Cook 2002). However, DOP may provide a significant alternative source of phosphate for corals, in 57

replacement or in addition to DIP and POP, because it has been shown that phosphate uptake
from DOP hydrolysis by reef benthos phosphatases could be as fast as DIP uptake (Atkinson
1987*b*).

61 In reef waters, DOP is present as phosphomonoesters, phosphodiesters, and 62 phosphonates (molecules that contain a C-P bond). In this first study, we concentrated on the 63 use of phosphomonoesters. Phosphatases hydrolyzing phosphomonesters are classified as acid 64 and alkaline depending on their pH optimum; and each type has different substrate 65 specificities, catalytic mechanisms, and inhibition pathways (Hollander 1971). Phosphatase 66 activity has been shown to be a good indicator of phosphate deficiency and low 67 environmental DIP in a large number of marine organisms, such as cyanobacteria (Yentsch et 68 al. 1972), dinoflagellates (Dyhrman and Palenik 1999), and symbiotic dinoflagellates (Annis 69 and Cook 2002). Coral hosts and their symbionts (commonly called zooxanthellae), either 70 freshly isolated (FIZ) or cultured (CZ), exhibit phosphatase activity. Only two studies have 71 investigated phosphatases in FIZ and CZ, showing both acid and alkaline phosphatases 72 activities (AcPA and APA, respectively) with intracellular (Jackson et al. 1989) and 73 extracellular (Annis and Cook 2002) activities reported. Some other studies only mentioned 74 the presence of intracellular (Goreau 1956) and extracellular (Hayes and Goreau 1977) 75 phosphatase activity in coral hosts.

This study therefore first aimed at examining the alkaline phosphatase activity in the scleractinian coral *Stylophora pistillata* under different environmental conditions. We therefore tested the effect of light, feeding, and bleaching (loss of symbionts) of the coral host. The following hypotheses were tested: APA should increase with light as previously observed with DIP (D'Elia 1977; Godinot et al. 2009), and APA should vary with the availability of other phosphate sources. It should therefore increase with a loss of symbionts, which leads to a decreased DIP uptake and a release of DIP (D'Elia 1977; Muller-Parker et al. 83 1990); and it should decrease following feeding of the host, which corresponds to a POP 84 supply. It was indeed previously reported that zooxanthellae (zoox) APA significantly increased after 5 weeks of host starvation in FIZ or after cultivation in P-limited medium in 85 86 CZ (Jackson et al. 1989; Annis and Cook 2002). The second aim of this study was to compare 87 APA in coral species containing different symbiont clades. All these questions have never 88 been addressed in corals, but are essential and timely because phosphate uptake is related to 89 net carbon production (Atkinson 1992), and should therefore be one of the key factors 90 determining primary productivity of corals.

- 92 Methods

93 Organisms

94 APA was assessed in four tropical symbiotic species (*Stylophora pistillata*,

95 Pocillopora damicornis, Pavona cactus, and Galaxea fascicularis), two Mediterranean

96 symbiotic species (Oculina patagonica and Cladocora caespitosa), and one tropical non-

97 symbiotic species (*Tubastraea* sp.). APA was also assessed in bleached S. pistillata, prepared

98 by culturing nubbins for 6 weeks in the dark. Microscopy observations confirmed that

99 symbiont density was 3 orders of magnitude lower in bleached nubbins $(6.7 \times 10^3 \text{ zoox cm}^{-2})$

100 than in symbiotic ones $(2.5 \times 10^6 \text{ zoox cm}^{-2})$.

All colonies were maintained in aquaria supplied with natural seawater (exchange rate 2% h⁻¹) containing low nutrient concentrations (DOP < 0.1 μ mol P L⁻¹, DIP < 0.05 μ mol P L⁻¹ 103 ¹, nitrate < 0.4 μ mol N L⁻¹ and ammonium < 0.5 μ mol N L⁻¹). Seawater salinity was constant 104 at 38.2, pH was 8.1 ± 0.1, and temperature was maintained at 25.0 ± 0.5°C for tropical corals 105 and 18.0 ± 1.0°C for Mediterranean ones. Irradiance was 150 μ mol photons m⁻² s⁻¹ for 106 symbiotic corals, with a light:dark cycle of 12 h:12 h. Since corals were cultured at this light 107 intensity and adapted to it, it corresponded to a maximal rate of photosynthesis. The nonsymbiotic *Tubastraea* sp. and bleached *S. pistillata* were cultured in the dark. All corals were
fed twice a week with *Artemia salina* nauplii, but were used for the experiments three days
after the feeding (also for the experiments involving FIZ).

111 Isolatio

Isolation of symbionts

For each experiment with FIZ, symbionts were extracted from 5 coral nubbins using a commercial-type Water-Pick. They were further purified by three centrifugations (2000 rotations per minutes for 5 min at 25°C) followed by re-suspension in seawater (Johannes and Weibe 1970). Aliquots were frozen for subsequent cell counts, chlorophyll and protein determinations. Zooxanthellae phylogeny was determined to the clade level according to Santos et al. (2002), using chloroplastic ribosomal deoxyribonucleic acid sequences.

118APA assays

119 In this study, all experiments were conducted in seawater (pH = 8.1) and should 120 therefore be considered as assays for APA. APA was measured using a colorimetric assay, 121 which is based on the non-biological substrate p-nitrophenyl phosphate (pNPP) to yield a 122 colored product, p-nitrophenolate (pNP), upon hydrolysis under alkaline conditions. Most 123 measurements were performed with the symbiotic coral S. pistillata and its FIZ, but APA was 124 also compared between different coral species cited above (see description below). In each 125 case, 5 nubbins or 5 FIZ samples were considered. All APA experiments were performed 126 using six beakers filled with 200-mL of filtered seawater (0.2 μ m membrane filters, pH of 127 8.1), maintained in a water bath at 26°C or 18°C (for tropical and Mediterranean species, 128 respectively). Light was supplied by 400 W HQI lights and measured using a spherical 129 quantum sensor (LiCor LI-193).

In experiments involving coral nubbins, individual nubbins suspended to a nylon wire
were introduced in five beakers. A beaker without coral served as a control for APA activity
in the filtered seawater and for any non-enzymatic hydrolysis of the pNPP substrate. Thirty

133 minutes after nubbins were placed in the beakers (acclimatization period), the water was enriched with 250 μ mol P L⁻¹ of pNPP. Magnetic stirring bars ensured proper homogenization 134 135 inside the beakers. A 10-mL water sample was taken from each beaker immediately after 136 enrichment and then every 30 min for 120 min. Samples were immediately alkalinized with 137 2 mL of 1 mol L^{-1} NaOH to stop the enzymatic reaction and yield the yellow colored p-138 nitrophenolate (pNP). Absorbance was read at 400 nm after 30 minutes against a blank of 139 filtered seawater treated with NaOH. Concentrations of pNP were calculated from a standard 140 curve of pNP absorbance vs. concentration established during each experiment using known 141 concentrations of ACS reagent grade pNP in filtered seawater treated with NaOH. At the end 142 of the experiments, corals were frozen for subsequent normalization of the data. 143 For experiments involving FIZ, a concentrated zooxanthellae solution, obtained after 144 isolation of FIZ, was used to inoculate the five pNPP-enriched beakers, yielding concentrations comprised between 2×10^4 and 10^5 FIZ mL⁻¹. Sampling protocol and sample 145 146 measurements were the same as above, except that samples were filtered (0.45- μ m membrane 147 filters) prior to alkalinization to remove FIZ. 148 The working parameters for the APA assays were developed in preliminary tests. A 149 first preliminary test was performed to determine the optimal incubation length, using the 150 coral S. pistillata and its FIZ at various pNPP concentrations. During each assay, pNP 151 concentration increased linearly over time (independently of the pNPP concentration), during 152 ca. 180 min both for whole coral nubbins and FIZ. Thus, APA was considered linear over 153 these 180 min, and an incubation length of 120 min was chosen for the subsequent 154 experiments. We also examined the effect of pH on phosphatase activity in FIZ, since 155 previous studies suggested that pH optima is different for internal and external phosphatases, 156 and is likely related to the pH experienced by the zooxanthellae (Jackson et al. 1989; Annis 157 and Cook 2002). In the present study, external phosphatase activity of intact FIZ from S.

158 pistillata was predominantly alkaline, as phosphatase activity was 2.5 times higher at the pH 159 of seawater (8.1) than at an acidic pH (5.8; Fig. 1). We therefore worked at a pH of 8.1 (in 160 natural seawater, no buffer added) for the FIZ in the following experiments. We also 161 examined the effect of initial pNPP concentration on APA to determine the kinetics 162 characteristics of coral and zooxanthellae phosphatases. We measured host APA using pNPP concentrations of 0.05, 0.5, 1.0, 5.0, 25, 50, 250, 500, 1000, 2500, and 5000 µmol P L⁻¹, and 163 FIZ APA using pNPP concentrations of 0.05, 5.0, 25, 50, 250, 1000, and 2500 μ mol P L⁻¹. 164 165 APA in the coral host was detectable at pNPP concentrations as low as 0.05, 0.5, and 1.0 μ mol P L⁻¹ and was equal to 0.8 ± 0.1, 4.1 ± 0.4, and 5.5 ± 0.7 nmol P mg prot⁻¹ h⁻¹, 166 respectively, and was 1.2 ± 0.2 in FIZ at a pNPP concentration of 0.05 μ mol P L⁻¹. FIZ and 167 host extracellular APA were strongly dependent upon DOP concentration, as already reported 168 169 for the intracellular phosphatases of FIZ (Jackson et al. 1989), and curves fitted with the 170 Michaelis–Menten equation (Fig. 2; Eq. 1):

172 (1) where [pNPP] is the initial concentration of p-nitrophenyl phosphate introduced in the 173 beaker; K_m is the pNPP concentration at which activity is half-optimal, and corresponds to the 174 inverse of the affinity of the alkaline phosphatase towards the pNPP substrate; and APA_{max} is 175 the activity when the saturation concentration of pNPP has been reached. In both cases, APA saturated for pNPP concentrations between 250 and 500 μ mol P L⁻¹, and in subsequent 176 experiments, APA was measured at a pNPP concentration of 250 μ mol P L⁻¹ (i.e., near the 177 178 saturating concentration for both corals and FIZ). Other preliminary tests revealed that APA 179 was strongly affected by light level and coral nutrition. These parameters were therefore 180 tightly controlled in each of the subsequent experiments, to test their individual effect. 181 Therefore, unless otherwise specified, light level was maintained at $150 \pm 10 \,\mu$ mol photons m⁻ 2 s⁻¹, and corals were fed three days before the experiments. The set of experimental 182

183 conditions tested is summarized in Table 1. Moreover, for experiment 1 (Table 1), the dark
184 incubation was conducted at the end of the 12-hour dark period. For experiment 3 (Table 1),
185 APA measurements were also performed in the dark, at the end of the night, to prevent
186 metabolic changes associated with photosynthesis in the symbiotic nubbins.

Data normalization and statistical analyses

188 APA was expressed as units of pNPP hydrolyzed per hour, which corresponds to one 189 molecule of phosphate liberated by the enzyme per molecule of pNPP hydrolyzed. It was then 190 normalized for the coral host either to the chlorophyll (Chl) and zooxanthellae (zoox) content 191 (using the same methods as in Godinot et al. 2009), to the surface area of the nubbins (using 192 the wax-dipping method described in Stimson and Kinzie 1991), or to the protein (prot) content (after extraction in 1 mol L⁻¹ NaOH for 30 min at 90°C, measured using the 193 194 commercially available BC Assay Interchim kit). Protein content is a good estimator of the 195 biomass, since there is a linear relationship between protein content and dry weight in S. 196 *pistillata* (unpublished results). Data for the FIZ were normalized to protein content, and to 197 cell density and chlorophyll content. All data are expressed as the mean \pm standard error of 5 198 replicates. The software GraphPad Prism (version 5.0) was used to perform linear regressions 199 to examine the effect of light, and to study concentration-dependent APA using non-linear 200 regressions with Michaelis-Menten fittings. For the other experiments, StatView (version 5.0) 201 was used to perform *t*-tests, and one-way and two-ways analysis of variance (ANOVAs) on 202 the data, followed by Fisher's protected least significant difference (PLSD) tests.

204 **Results**

Since we used nubbins entirely covered with tissue and intact symbiont cells,
phosphatase activities should have been from external phosphatases only. In the following
results, we will refer to 'FIZ APA' for the activity related to the symbionts only, and to 'host

APA' for the activity related to the entire symbiotic association, but mainly coming from the host because only the host tissue was exposed to the medium. Moreover, normalization of APA per protein and skeletal surface area led to the same results, and only the normalization per protein is presented. It is considered as the most appropriate to compensate for the difference in biomass per skeletal surface area between the various coral species used, and between coral hosts and FIZ. In the clade experiment, results are also presented with the normalization to chlorophyll content.

Effect of light and feeding on the APA of S. pistillata

APA increased linearly with light in both host ($r^2 = 0.61$, $F_{1,18} = 29$, p < 0.0001) and 216 FIZ ($r^2 = 0.87$, $F_{1.18} = 120$, p < 0.0001; Fig. 3), being c.a. 3.0 times higher at 350 μ mol 217 photons m⁻² s⁻¹ than in the dark. APA also significantly increased over time in both host and 218 219 FIZ when corals were starved (1-way ANOVA, both p < 0.0001, $F_{3,16} = 16.9$ for host, and 220 $F_{3,16}$ = 57.4 for FIZ; Fig. 4). Host APA was the highest after 6 weeks of starvation (165.5 ± 20.3 nmol P mg prot⁻¹ h^{-1}). At this moment, activity was 4 times higher than in fed corals 221 $(40.0 \pm 2.4 \text{ nmol P mg prot}^{-1} \text{ h}^{-1})$, and remained 2.8 times higher until 9 weeks of starvation. 222 223 FIZ APA was the highest after 3 weeks of starvation ($154.6 \pm 4.3 \text{ nmol P mg prot}^{-1} \text{ h}^{-1}$), being 1.5 times higher than in FIZ from fed corals $(100.0 \pm 7.0 \text{ nmol P mg prot}^{-1} \text{ h}^{-1})$. After this 224 225 point, APA decreased back to the level of FIZ from fed corals.

Effect of the symbiotic status

In the non-symbiotic *Tubastraea* sp., light had no effect on APA, as APA was not significantly different in the dark (18.5 ± 2.9 nmol P mg prot⁻¹ h⁻¹) and in the light (19.3 ± 2.2 nmol P mg prot⁻¹ h⁻¹; *t*-test, t = 0.27, df = 9, p = 0.76,). Host APA in the dark was not significantly different between *Tubastraea* sp. and symbiotic *S. pistillata* (mean of 18.3 ± 1.6 nmol P mg prot⁻¹ h⁻¹; 1-way ANOVA, p = 0.89, $F_{2,12} = 0.21$; Fig. 5), but increased by 6.4 fold 232 in bleached *S. pistillata* (115.1 \pm 20.4 nmol P mg prot⁻¹ h⁻¹; 1-way ANOVA, *p* = 0.0001, *F*_{2,12} 233 = 21.85).

- 234 Comparison of APA in different coral hosts and zooxanthellae clades 235 When results obtained for the FIZ were normalized to the protein content, there was no 236 significant difference in APA between the clades (1-way ANOVA, p = 0.18, $F_{2,27} = 4.81$; data 237 not shown). Conversely, a significant difference in host APA was observed between species 238 (1-way ANOVA, p < 0.0001, $F_{5.24} = 21.7$; Fig. 6A). Differences were only related to 239 differences in the chlorophyll content normalized per protein content between coral species, 240 and were unrelated to the tropical or temperate status of the host, to the symbiont density, to 241 the chlorophyll content per surface area, or to the zooxanthellae clade (1-way ANOVAs, all p > 0.4). For FIZ, results were also normalized to the chlorophyll content. With this 242 243 normalization, there was a significant difference in APA between species (1-way ANOVA, 244 p < 0.0001, 192.6; Fig. 6B), which was related to the zooxanthellae clade (1-way ANOVA, 245 *p* < 0.0001, 232.7, respectively).

247 **Discussion**

This study reports on the alkaline phosphatase activity in coral hosts and their isolated symbionts under various environmental conditions. It is the first to examine APA in coral hosts, and to highlight the importance of host metabolism, and phosphate limitation or repletion, on this activity. It also emphasizes for the first time the effects of light and zooxanthellae clade on APA, and confirms that host feeding has a negative effect on this activity.

Effects of metabolic activity on APA

In symbiotic corals, APA was dependent upon symbiont activity, and likely upon
zooxanthellae photosynthetic activity, since APA was 3.0 times lower in the dark than at 350

 μ mol photons m⁻² s⁻¹ in a symbiotic coral (Fig. 3) while it did not increase with light in a non-257 258 symbiotic one. APA was also 6.4 times higher in bleached than in symbiotic colonies (Fig. 5), 259 suggesting a phosphate limitation in bleached corals, as previously demonstrated (Annis and 260 Cook 2002). In symbiotic corals, most of the phosphate requirements are supplied by the 261 activity of the symbionts, which continuously take up DIP from the surrounding seawater 262 (D'Elia 1977; Godinot et al. 2009). The loss of symbionts in bleached colonies corresponds to 263 a reduction of DIP uptake, and even to a release of it (Muller-Parker et al. 1990), which may 264 both lead to a deficit of phosphate in the symbiotic association. Therefore, the host has to rely 265 on organic phosphate (and increased APA) to fulfill its high phosphate metabolic demand 266 (Godinot et al. 2011). Conversely, in the non-symbiotic Tubastraea sp., APA was 6.2 times 267 lower than in bleached S. pistillata (Fig. 5), suggesting that despite the fact that Tubastraea 268 also looses DIP (D'Elia 1977), its total phosphate demand may be lower. Alternatively, 269 although non-symbiotic, bleached, and symbiotic corals, were supplied the same zooplankton 270 regime before the experiments, their feeding rates remain to be examined in order to 271 determine if their phosphate inputs from POP were different. 272 In symbiotic *S. pistillata*, host APA was also affected by heterotrophy and starvation. 273 The observed increase in APA with long-term starvation of the host (Fig. 4) can be related to 274 a lack of phosphate availability in the symbiosis. Indeed, feeding provides the host with a 275 source of POP (Johannes et al. 1970; Wijgerde et al. 2011), and this source disappears with 276 starvation, which therefore might trigger the increase of host APA. The same feeding effect 277 was observed in FIZ (Fig. 4) and was also reported previously in FIZ (Jackson et al. 1989; 278 Annis and Cook 2002). After a prolonged starvation (more than 3 weeks in FIZ and more than 279 6 weeks in the host), APA decreased again, probably due to a reorganization and/or reduction 280 of the coral metabolic activity, including a possible shut-down of metabolic machinery and

the recycling of macromolecules. It is in fact well established that starvation lowers protein

and chlorophyll concentrations, symbionts density (Titlyanov et al. 2001; Ferrier-Pagès et al.
2003; Houlbrèque et al. 2003), and rates of respiration and photosynthesis (Szmant-Froelich
and Pilson 1984; Davy et al. 2006). Such reduction of the metabolism may either be due to the
catabolism of alkaline phosphatases or may have led to a lower phosphate demand explaining
the APA decrease.

287 Results obtained finally showed that light increased host and FIZ APA (Fig. 3), maybe 288 due to the higher metabolic activity of corals in terms of respiration rates in the light (Porter et 289 al. 1984). Another explanation can be a faster depletion of phosphate stocks of the host by 290 symbiont photosynthesis, as phosphate is a component of ATP and enters into the 291 composition of other compounds of the Calvin cycle (Hall and Rao 1987), and as DIP demand 292 has been shown to increase with light (Jackson and Yellowlees 1990; Godinot et al. 2009). 293 Moreover, light levels used in this study are not as high as those encountered naturally in 294 reefs, and APA might therefore be even higher under natural conditions, with a much faster 295 hydrolysis of organic phosphate into inorganic phosphate.

Inter-species comparison and effect of zooxanthellae clade

297 Results obtained in this experiment suggest for the first time a possible dependency of 298 APA upon zooxanthellae clade, with the cosmopolitan clade C (Stat et al. 2008) being 299 apparently less efficient than clades A and B (Fig. 6). Specific metabolic characteristics of the 300 different clades may influence APA, possibly through differences in the phosphate demand 301 and/or uptake. This theory remains however to be further investigated, because only one study 302 has examined up to date the relationship between eutrophication and zooxanthellae clades 303 (Lampert-Karako et al. 2008), and has found no differences. Since only one clade B coral was 304 available for the present study, the preliminary results from this experiment need to be 305 completed by expanding the number of samples within the same clade, as well as the number 306 of clades investigated.

Contribution of DOP to the phosphate demand of corals

APA measured at DOP concentrations of 0.05 and 0.5 μ mol P L⁻¹, which corresponds 308 309 to the range of those occurring in situ (Crossland and Barnes 1983; Larned 1998), was equal to 0.8 ± 0.1 and 4.1 ± 0.4 nmol P mg prot⁻¹ h⁻¹ in the light, respectively, and 0.4 ± 0.1 and 1.9 310 \pm 0.3 nmol P mg prot⁻¹ h⁻¹ in the dark, respectively (2.2 times lower compared to the light 311 value). These values correspond to 0.3 to 1.6 mmol P m⁻² d⁻¹ (value \times 2.2 mg prot cm⁻² \times 12 h 312 313 of day and night ×10,000). If all phosphate provided by DOP hydrolysis through alkaline 314 phosphatase activity is entirely taken up by corals, DOP appears to be a significant source of 315 phosphate for corals, even at low environmental concentrations. Indeed, it has been shown that DIP contributes 0.2 to 1.6 mmol P m⁻² d⁻¹ (Steven and Atkinson 2003; Godinot et al. 316 2009; Cuet et al. 2011) and POP brings of 0.9 ± 0.3 mmol P m⁻² d⁻¹ (Wijgerde et al. 2011). 317 318 DOP may have an even more significant contribution if sources like phosphodiesters, 319 polyphosphates and phosphonates are taken into consideration. Coral species can benefit from 320 these sources using other phosphatases and phosphonatases. The question that remains to be 321 examined is how much of the phosphate recycled from DOP can effectively be absorbed by 322 coral colonies, since phosphate might be rapidly flushed out of the reef by water currents (Atkinson 1987b). Some additional studies, using a ³³P-labeled DOP source, may help answer 323 this question, by tracing ³³P inside coral tissues. 324

In conclusion, this study showed that host and symbionts alkaline phosphatase activities are dependent upon light and host feeding, and upon the metabolic activity of the host and the symbionts (with a possible clade effect). We showed that DOP may represent a significant source of phosphate for corals in oligotrophic reefs, since at similarly low environmental concentrations (less than $0.5 \,\mu$ mol P L⁻¹), this source may bring as much phosphate as DIP (1.6 mmol P m⁻² d⁻¹). The present study thus needs to be followed by attempts at determining the amount of phosphate effectively recycled from various sources of

- 332 DOP and POP by corals, in order to complete our first calculation of the balance of phosphate
- inputs from DIP, DOP, and POP in corals under oligotrophic conditions.
