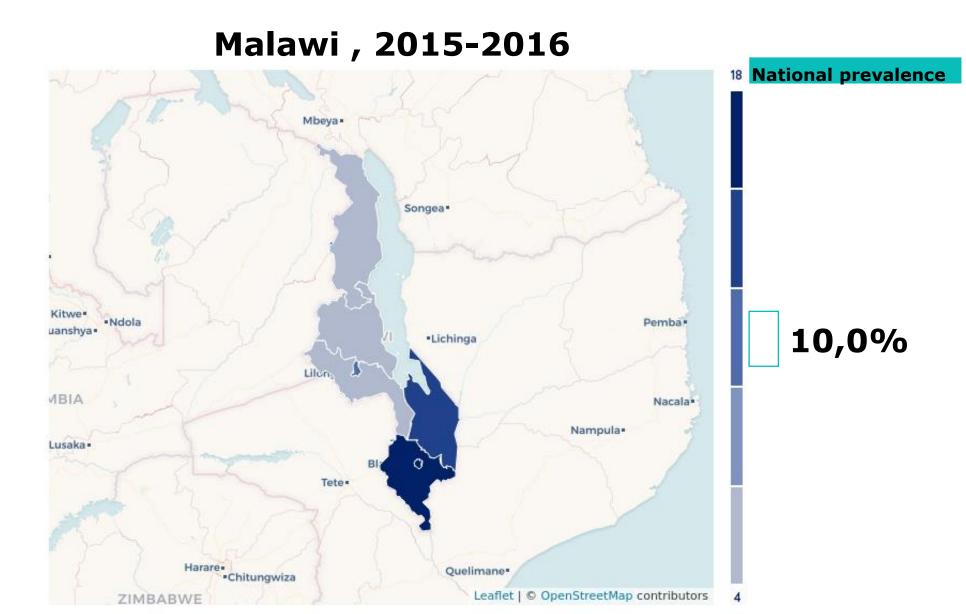




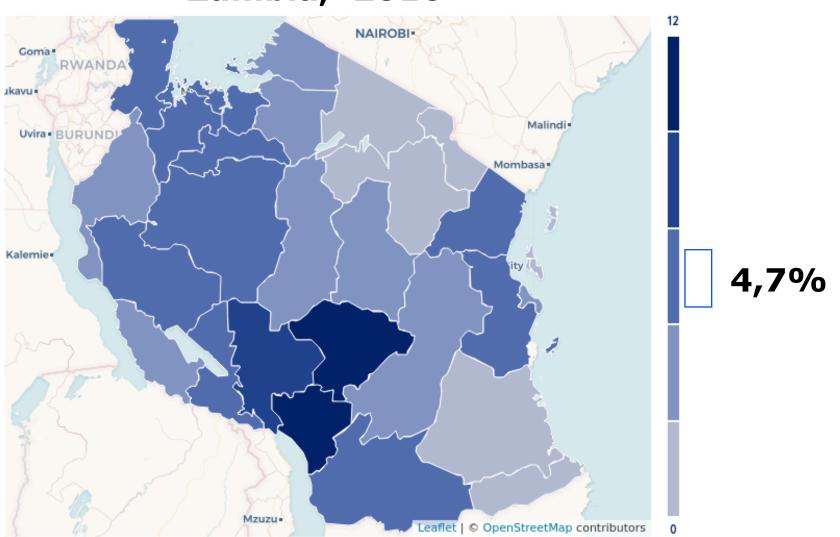
Background & Aim

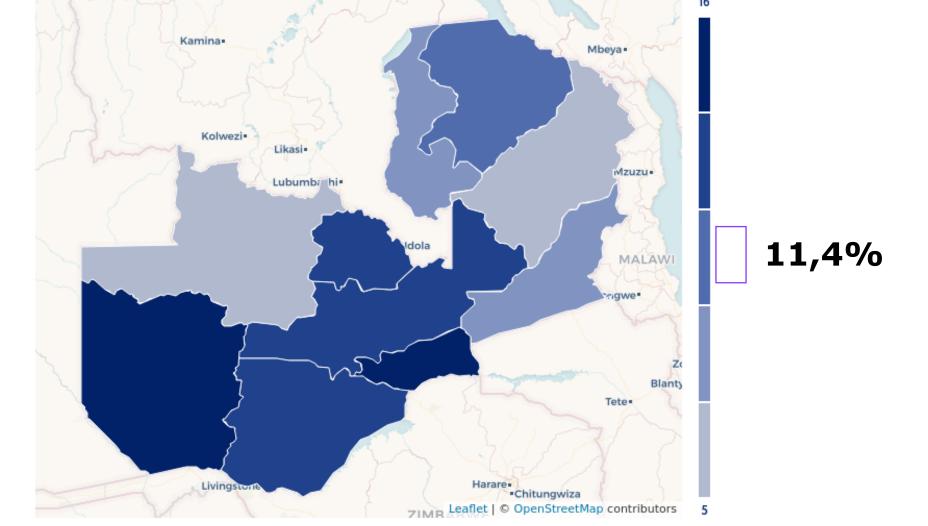
Figure 1: HIV sub-national prevalence among 15-49 years are heterogenous

- Population-level research evaluating HIV-related stigma across national contexts with varied national HIV prevalence is scarce and barely takes into account the heterogeneity of HIV burden within countries (Figure 1).
- This study aims to analyze how HIV-related stigma correlates with subnational HIV prevalence in three African countries with varied HIV epidemics.
- It distinguishes between the perspectives of selfreported HIV positive and negative individuals

Methods

- This paper used data from three nationally representative surveys, the Malawi, Zambia, and Tanzania Population-based HIV Impact Assessments (PHIA), collected from 2015 to 2017
- Logistic regression and multilevel models were performed to assess the associations between HIV prevalence level and each HIV-related stigma measures among self-reported HIV-negative people and PLWH
- The currents study focusses on the adult population aged 15 to 49 years
- Different aspects of HIV related stigma were assessed in this study following the guidelines provided by Earnshaw and Chaudoir (2009) (Figure 2)

Figure 2: Measurement of HIV-related stigma with PHIA surveys

Self-reported HIV positive persons

Internalized stigma

"Would you buy fresh vegetables from a shopkeeper or vendor if you knew that this person had HIV?" (no)

"Do you think that children living with HIV should be able to attend school with children who are HIV negative?" (no)

"I would be ashamed if someone in my family had HIV" (Agree)

Enacted stigma

In the last 12 months, have you been denied health services including dental care, because of your HIV status? (yes)

Anticipated stigma

In the last 12 months, when you sought health care in a facility where your HIV status is not known, did you feel you needed to hide your HIV status?

(yes)

Self-reported HIV negative persons

Discriminatory attitude

"Would you buy fresh vegetables from a shopkeeper or vendor if you knew that this person had HIV?" (no)

"Do you think that children living with HIV should be able to attend school with children who are HIV negative?" (no)

Prejudice

"I would be ashamed if someone in my family had HIV" (Agree)

Results

1) Results for HIV-negative individuals (Table 1)

- The results show that odds of expressing discriminatory attitude towards people living with HIV is significantly lower for HIV-negative individuals living in mid and high HIV prevalence regions compared to persons living in low HIV prevalence regions.
- Living in mid and high HIV prevalence regions was also associated with lower odds of expressing prejudice toward people living with HIV

2) Results for HIV-positive individuals (Table 2)

- People living with HIV living in high prevalence regions were more likely to express internalized stigma than those living in mid or low prevalence regions.
- No significant association was found between enacted and anticipated stigma and subnational HIV prevalence.

Conclusion

- The results indicate that among HIV-negative individuals subnational HIV prevalence is negatively associated with self-reported discriminatory attitudes and prejudice towards people living with HIV
- HIV prevalence was positively associated with self-reported internalized stigma among people living with HIV.
- These results provide insight on how resources could be invested to reduce HIV related stigma among both PLWH and HIV-negative people.
