Neutrino mass ordering determination through combined analysis with JUNO and KM3NeT/ORCA

Abstract

The determination of neutrino mass ordering (NMO) is one of the prime goals of several neutrino experiments. KM3NeT/ORCA and JUNO are two next-generation neutrino oscillation experiments both aiming at addressing this question. ORCA can determine the NMO by probing Earth matter effects on the oscillation of atmospheric neutrinos in the GeV energy range. JUNO, on the other hand, is sensitive to the NMO by investigating the interference effects of fast oscillations in the reactor electron antineutrino spectrum at medium baseline. This contribution presents the potential of determining the NMO through a combined analysis of JUNO and ORCA data. When measuring the Δ*m*²₃₁ with a wrong ordering assumption, the best-fit values are different between the two experiments. This tension, together with good constraints on the Δm_{31}^2 measurement by both experiments, enhances the combined NMO sensitivity beyond the simple sum of their sensitivities. The analysis shows that a 5 σ significance is reachable in less than 2 years of data taking with both experiments for true normal neutrino mass ordering, assuming current global best-fit values of the oscillation parameters, while 6 years will be needed for any other parameter set.

1. Introduction

The discovery of neutrino oscillations $[1, 2]$ at the turn of σ the last century unequivocally shows that neutrinos have mass. 32 Since this discovery, significant progress has been made [3] to ∞ determine several of the parameters needed to describe neu- 34 trino oscillations. There are nevertheless still some parameters 35 that are yet to be measured, such as the presence and size of 36 8 CP-violation in the lepton sector, the value and origin of the 37 9 neutrino masses, and their ordering. Indeed, while neutrino 38 10 oscillations imply that the neutrino flavor eigenstates (ν_e, ν_μ, ν_s)

12 with masses $(m_1, m_2, m_3,$ respectively) and that these masses 41 ¹² with masses $(m_1, m_2, m_3,$ respectively) and that these masses are different with $\Delta m_{jk}^2 = m_j^2 - m_k^2 \neq 0$, neutrino oscillations ¹⁴ do not provide any way to measure each mass directly. Like-¹⁵ wise, several experiments are mostly sensitive to the absolute ¹⁶ value of Δm_{jk}^2 , which creates some uncertainty regarding the 17 order of the neutrino masses. Currently, two different neutrino 46 18 mass orderings (NMO) remain possible: the normal ordering 47 19 (NO) with $m_1 < m_2 < m_3$ and the inverted ordering (IO) with 48
20 $m_3 < m_1 < m_2$. ²⁰ $m_3 < m_1 < m_2$.

The determination of the NMO is one of the main goals 50 22 of several experiments currently under construction, such as 51 23 JUNO and KM3NeT/ORCA, on which the present study is 52 ²⁴ based. An overview of these detectors, including how they ⁵³ ²⁵ perform the NMO determination, is provided in Secs. 2 and ⁵⁴ 26 3, respectively. Sec. 4 describes the procedure to combine the 55 27 results of these experiments to obtain the combined sensitivity 56 ²⁸ presented in Sec. 5. An extended description of this study and ²⁹ its results can be found in Ref. [4].

30 2. JUNO overview

The Jiangmen Underground Neutrino Observatory [5, 6] (JUNO) is a multipurpose experiment being build in the south east of China. The JUNO detector is located about 53 km from ³⁴ the Taishan and Yangjian Nuclear Power Plants (NPP), distance which was optimized to enhance the sensitivity to the NMO determination [5]. Electron antineutrinos from these NPPs will interact via the inverse beta decay interaction with liquid scintillator composing the JUNO neutrino target, with the outgoing positron carrying most of the initial neutrino's energy. In order to determine the NMO, JUNO needs to precisely reconstruct the energy spectrum of these antineutrinos by measuring the positron's visible energy with a resolution of about 3% at ⁴³ 1 MeV. The measured energy spectrum will be imprinted with the oscillation patterns from the oscillations induced by both Δm_{21}^2 and Δm_{31}^2 , and the interplay between these oscillation patterns makes it possible for JUNO to determine the NMO. Due to the requirement to observe precisely both oscillations, the energy resolution is a critical parameter for the success of JUNO.

The present study models JUNO based on the description of Ref. [5], with the exception that only the two already built reactor cores at the Taishan NPP are taken in consideration. as the construction of the two additional cores initially foreseen is currently uncertain [6]. The impact of this change is briefly discussed at the end of Sec. 5. It is worth noting that we do not consider any of the changes in detector performance that were presented recently in Ref. [7], where an improved performance ⁵⁷ of the detector compensates the reduction in sensitivity due to ⁵⁸ the loss of antineutrinos from two reactor cores at the Taishan NPP.

3. KM3NeT/ORCA overview

 The Oscillation Research with Cosmics in the Abyss₁₁₆ (ORCA) detector is part of the Cubic Kilometre Neutrino Tele- $_{117}$ 63 scope [8] (KM3NeT) being deployed in the Mediterranean Sea.₁₁₈ KM3NeT is a water Cherenkov detector comprising two tridi- mensional arrays of optical modules distributed to measure the light produced by charged particles originating from neutrino interactions in and around the detector, and traveling faster than light in the surrounding medium. The distance between neighbouring optical modules in the detector can be optimized₁₁₉ to search for astrophysical neutrinos in the TeV–PeV range or to study neutrino oscillations using atmospheric neutrinos with 121 energies above 1 GeV, which is the goal of ORCA. Using this array, the NMO is determined by probing the imprint of matter $_{123}$ effects on the neutrino oscillation pattern measured as a func- tion of the energy and direction of the neutrino. To perform this 125 measurement, the events detected in ORCA are distributed into two separate classes based on their topology, in order to sep- $_{127}$ ⁷⁸ arate $v_\mu + \bar{v}_\mu$ CC interactions (classified mainly as track-like)₁₂₈ from $v_a + \bar{v}_a$ CC interactions (classified mostly as shower-like). ⁷⁹ from $v_e + \bar{v}_e$ CC interactions (classified mostly as shower-like), given that the impact of matter effects will be different for each given that the impact of matter effects will be different for each 81 neutrino flavor being measured. An additional sample, contain-⁸² ing the events that cannot be clearly classified as either track- like or shower-like, is also created to maximise the purity of the 84 samples with a clear topological identification.

⁸⁵ In this study, two scenarios for the treatment of systematic ⁸⁶ errors for ORCA were considered. The baseline scenario uses ⁸⁷ the same assumptions as in other recent ORCA analyses [9] 88 and is expected to better correspond to the systematic errors on 89 the ORCA detector. The optimistic scenario is based on the ⁹⁰ treatment used in Ref. [10] that presents the expected sensitiv-91 ity to the NMO from a combined study using JUNO and the ⁹² IceCube Upgrade and PINGU (proposed ice Cherenkov detec-⁹³ tors located in the South Pole). Note also that, for this study, all ⁹⁴ sensitivity estimates are based on the performance of a fully-95 deployed ORCA detector (with 115 detection lines).

96 4. Combined analysis

97 As mentioned in Secs. 2 and 3, the sources and energies of ⁹⁸ the neutrinos used for the determination of the NMO in JUNO 99 and ORCA are very different. These two detectors also rely ¹⁰⁰ on different detector media and methods used for the detection ¹⁰¹ of these neutrinos. Thanks to these significant differences, only ¹⁰² the neutrino oscillation parameters are shared between these ex-103 periments while the other systematic errors are not correlated₁₂₉ ¹⁰⁴ between experiments. Furthermore, of the six parameters de-¹⁰⁵ scribing 3-flavor neutrino oscillations only two $(Δm₃₁² and θ₁₃)$
2022 impact both H_{JNO} and QRCA and need to be considered jointly ¹⁰⁶ impact both JUNO and ORCA and need to be considered jointly₁₃₂ 107 in the combined analysis. The other four parameters either have 108 no impact on JUNO (δ_{CP} and θ_{23}) or have only a negligible im-134
109 pact on ORCA (Δm^2 , and θ_{12}), and so can be treated indepen-135 ¹⁰⁹ pact on ORCA (Δm_{21}^2 and θ_{12}), and so can be treated indepen-
200 dently in the analysis of either detector ¹¹⁰ dently in the analysis of either detector.

In order to perform the combined analysis, an Asimov dataset 112 of each experiment is used to compute the χ^2 for a given

113 (Δm^2 , θ_{12}) pair for each experiment separately profiling for all $(\Delta m_{31}^2, \theta_{13})$ pair for each experiment separately, profiling for all
114 systematic errors and all other relevant oscillation parameters 114 systematic errors and all other relevant oscillation parameters. These computations are performed in a grid of $(\Delta m_{31}^2, \theta_{13})$ values to form a y^2 man. The obtained y^2 values are then added ¹¹⁶ ues to form a χ^2 map. The obtained χ^2 values are then added,
¹¹⁷ along with a prior term on θ_{12} to produce the combined χ^2 along with a prior term on θ_{13} , to produce the combined χ^2 value: value:

where the prior term on θ_{13} is added to account for the fact that current experiments have a better sensitivity to this oscillation parameter than either JUNO or ORCA will have. The global fit (GF) presented in Ref. [11] was used to obtain the θ_{13}^{GF} prior value and uncertainty.

This χ^2 is then used to evaluate the $\Delta \chi^2 = \chi^2_{\text{WO}} - \chi^2_{\text{TO}}$, where $\tilde{\}$ ¹²⁵ χ^{2}_{NO} (χ^{2}_{TO}) is the minimum value of the χ^{2} for the wrong (true) ¹²⁶ ordering in the χ^2 map. An example distribution of each independent experiment χ^2 profile along with the combined χ^2
profile is shown in Fig. 1 as a function of Λm^2 128 profile is shown in Fig. 1 as a function of Δm_{31}^2 .

When the ordering tested is the true ordering, one can see that ¹³⁰ both experiments obtain their minimum χ^2 value for the same Δm_{31}^2 . However, when the ordering tested is the wrong ordering, each experiment will obtain their minimum χ^2 at a different
 Λm^2 which creates a tension between these measurements and Δm_{31}^2 , which creates a tension between these measurements and boosts the sensitivity of the combined analysis beyond just the one obtained from adding the sensitivities to the NMO from ¹³⁶ each experiment separately.

5. Results and Conclusion

 Fig. 2 shows the NMO sensitivity as a function of time for each experiment independently, as well as for the combined analysis performed in this study. If the true ordering is nor-141 mal, and for the current best-fit θ_{23} value from Ref. [11], a 5 σ determination of the NMO is expected with 3 years of data from determination of the NMO is expected with 3 years of data from ORCA alone. In this case, the combined analysis would reduce the time required to reach such sensitivity by 1–2 years, de- pending on the systematic error scenario used. However, if the true ordering is inverted, it would take more than 10 years of 147 data to achieve a 5 σ determination of the NMO using ORCA value alone while the combined analysis of HINO and ORCA would alone, while the combined analysis of JUNO and ORCA would reach such a sensitivity after 6 years. It is also worth noting that the ORCA sensitivity to the NMO strongly depends on the true ¹⁵¹ value of θ_{23} , with the NO and IO scenarios presented above cor-
¹⁵² responding roughly to the best and worst sensitivities obtained responding roughly to the best and worst sensitivities obtained 153 for various values of θ_{23} and for either ordering. Further discus-¹⁶⁴ sion on the impact of θ_{23} is provided in Ref. [4]. sion on the impact of θ_{23} is provided in Ref. [4].

155 Fig. 3 shows the NMO sensitivity as a function of time for¹⁹⁷ the current (8 cores) and initially planned (10 cores) number $\frac{1}{199}$ 157 of cores running at the NPPs providing the \bar{v}_e for JUNO. This 200 figure shows that, while the number of cores available to JUNO²⁰¹ ¹⁵⁹ will strongly affect its individual sensitivity to the NMO, with $\frac{1002}{200}$ 160 a 3 σ determination varying from 10 years to 6 years, it has $\frac{1}{204}$ only a small impact on the sensitivity of the combined analysis. only a small impact on the sensitivity of the combined analysis.²⁰⁵ This happens because, in both scenarios, JUNO will be able ¹⁶³ to precisely measure Δm_{31}^2 , which will create a similar tension

to boost the combined NMO sensitivity. It is worth noting, in any case, that the JUNO-only NMO sensitivity is expected to be closer to the 10 cores scenario presented here, even though only 8 cores are expected to be available, thanks to several other improvements in the analysis and modeling of the detector [7].

¹⁶⁹ In summary, the NMO is expected to be determined at 5 σ in at most ~6 years when doing a combined JUNO and ORCA in at most ∼6 years when doing a combined JUNO and ORCA analysis. This is a significantly shorter time than required by either experiment separately. Even for favorable oscillation pa-173 rameters where the time required to determine the NMO would be shorter, a combined analysis will still reduce the time re-quired to make this determination by at least a year.
