## Introduction

This project aims to study the electronic effects of several  $\text{Fe}(\text{CO})_3\text{L}$ <sup>[1]</sup> complexes, because the ligands bound to the metal center are able to orientate the reactivity of the complex through their steric and electronic effects<sup>[2]</sup>. This was achieved using a gas phase approach based on photoelectron spectroscopy performed on the DESIRS<sup>[3]</sup> beamline of the SOLEIL synchrotron. The rationalization of the electronic effects of the ligand can then be obtained from the analysis of the ionization energies and the Fe-CO dissociation energies selected.

## Experiment

Ionisation of the gas-phase complexes using synchrotron radiation.




Figure 2a. Thermodesorption of aerosols.





Figure 2b. Home made oven installed in the jet chamber.




Figure 3. Experimental device showing the coupling of the DESIRS beamline to the i2PEPICO spectrometer DELICIOUS III.




Figure 1. Structure of the synthesised organometallic iron complexes

## Conclusion

Vaporisation of thermally stable or unstable real complexes with low quantities. SPES provide access to the electronic structure of the complexes which showed a great agreement with the theory. The tendency observed in the adiabatic ionisation energy is in correlation with the reaction yields of each catalyst complex. The first CO loss of the complexes did not show any selectivity and no trend effect was observed.

## Theory


Electronic structure calculations : PBE0/Def2-TZVP using the GAUSSIAN 09 software.  
Ionisation energy were computed with the IP-tuned LC- $\omega$ PBEh functional with the same basis set.<sup>[4]</sup>  
Fe-L bond description : decomposition (EDA) scheme coupled to Natural Orbital for Chemical Valence (NOCV) analysis at the BP86/TZ2P(ZORA)<sup>[5]</sup> level of theory using the ADF software.

## Kinetic Modeling

RRKM statistical model using MassKinetics software<sup>[6]</sup>

$$k(E) = \frac{\sigma N^{\#}(E - E_0)}{hp(E)}$$

$E$  = internal energy    $E_0$  = critical energy

### Slow PhotoElectron Spectra (SPES)




Figure 4. SPES of Fe4. Red sticks represent the calculated ionization energies of the molecular orbitals of the neutral complexes.




Figure 5. Breakdown diagram of Fe4 recorded in the 7.7 - 15.0 eV energy range and obtained with a 100 meV energy resolution.
