# Background

- Air pollution is a major health problem through exposure to ambient (outdoor) air pollution and airborne particles (PM).
- Airborne contaminants can have natural (wind-blown mineral dust) and anthropogenic (road traffic, industrial activities, domestic cooking and heating origins (Hoffmann et al., 1999; Petrovsky & Ellwood, 1999; Knab et al., 2001; Jordanova et al., 2010).
- Vegetation acts as a natural collector of these particles, called a biocollector (Verosub & Roberts, 1995).
- Leaves and tree bark are effective passive pollution collectors, as they provide a large surface area for trapping particles.
- Biomonitoring via the magnetic properties of tree leaves has been suggested by several authors as a good approach to measure pollution levels in cities
  with good spatial and temporal coverage (e.g. Matzka and Maher, 1999; Mitchell et al., 2010; Jordanova et al., 2010; Kardel et al., 2011).
- Magnetic methods have the advantage of being fast, easy to implement, inexpensive and non-destructive, allowing the processing of many samples, facilitating the spatialisation of contamination. This makes them a promising complementary technique to specialised monitoring stations.
- Magnetic properties include magnetic susceptibility and isothermal saturation magnetisation.
- The use of vegetation as a monitor of air pollution also has the advantage of proposing participatory science schemes (NanoEnvi-Toulouse project, AirGeo-Belmont Forum) based on the human-nature relationship, thus limiting possible "eco-anxiety" effects and enhancing the effect of vegetation (Great Green Wall type programme).

## The two main objectives of the project are:

- 1- to develop a methodology using plants as collectors to spatialise and monitor airborne particles
- 2- to characterise and identify geochemical and magnetic signatures of both anthropogenic and natural sources of particles.

This development of biomonitoring also aims to estimate the role of vegetation in the capture and retention of particles at the local (city) and regional scales. Our objective is to test different types of vegetation (leaves and bark) as recorders and sequesters of particles.

# Initial results:

- 40 bark samples (mainly *Eucalyptus*)
- The magnetic susceptibility varies between -6.4 10<sup>-9</sup> and 1.9 10<sup>-8</sup> m<sup>3</sup>.kg<sup>-1</sup>
   The highest values are measured in the bark of trees located near a

## Material et methods:

Magnetic data will be acquired on the plant samples in order to assess the concentrations of magnetic minerals (iron oxides). In particular, magnetic susceptibility and isothermal remanent magnetisation (IRM) will be measured. Magnetic susceptibility is a measure of the magnetic response of a material to an external magnetic field. The necessary equipment (kappabridges) is available in France (Toulouse) and Portugal. The GEt laboratory (Toulouse) has recently acquired an Agico KLY-5 kappabridge, which has increased sensitivity and allows the simultaneous acquisition of real and imaginary magnetic This offers the advantage of detecting susceptibility. superparamagnetic particles, allowing the tracing of nano-sized particles, known to have the greatest impact on health. Remanence (MRI) is acquired by exposing a sample to a magnetic field at room temperature. The resulting coercivity spectra allow the identification of magnetic grain populations (size and composition) that serve as a specific signature of a particle source. The equipment is available in laboratories in France and Portugal. Geochemical data will be measured on samples selected from the magnetic measurements. After digestion, the contents of major and trace elements (especially metals) will be acquired by ICP-MS.

# **Conclusion**:

The estimation of the capture of ambient air particles by plants will allow to:

- propose easy-to-implement biomonitoring methods,
- propose passive biosensors for areas without vegetation and set up participatory processes involving local stakeholders in the long term,
