# Analysis and prioritization of the causes of delays in the construction projects of Arvand Free Zone Organization

## Abstract

The projects of Arvand Free Zone have specific goals to upgrade the infrastructure of various recreational, commercial, cultural, health and tourism centers in this region, and actually the work mission of this organization is far beyond and different from a construction plan. Arvand Free Zone Organization is a series of different but related projects, which, according to the philosophy of creating Arvand Free Zone, needs to attract foreign and domestic investors for further prosperity and the life and survival of the region, which, of course, with planning Short-term and long-term plans can be defined with specific goals to achieve the upstream goals, and many projects will be created following the mentioned plans. This chain will be an ideal and standard set in accordance with other developed and advanced countries in the world, which will definitely reduce delays in projects will lead to early resumption of investment in the region, and delays in projects are the main factor in reducing the entire process. The mentioned matters will be mentioned, therefore, the reduction of delays is more and more important. For this reason, analyzing and prioritizing the causes of delays can be effective in solving and reducing this phenomenon.

#### 1. Introduction

Today, our country is progressing and taking great steps in the path of development, progress and construction [1-7]. In this direction, the implementation of various plans and projects, including the creation of large production factories, refineries, dams, power plants, universities, railways,

roads, residential towns, etc., play a significant role. D plans and projects, with components and There are many and complicated components that cannot be managed except by scientific management. In response to the question of the reasons for the failure of construction projects in Iran, various factors are considered. But one of the most important factors is the method of managing construction projects.

One of the characteristics of the industrial and economic growth and development of any country is the success of its construction projects [1, 2, 8, 9]. The main indicators in the success of projects are their high-quality execution without delay. Most of these policies pursue goals such as reducing cost, time, and improving quality. Delay, slowness and time increase in road construction projects indicate the existence of obstacles and root problems in the implementation of valuable projects. The implementation process of the government's plans and construction projects is always interrupted due to various reasons, which ultimately leads to the prolongation of the projects and delays in the time of their use. Increasing the life of construction plans and projects, while their implementation is accompanied by a lot of risk, also increases their finished cost. Increase in life The government's construction plans have progressed to the point where the failure to complete the plans within the specified time is considered normal and basically an established and unwritten procedure by the country's budgeting and executive system. Also, the major part of the capital of every country, especially in developing countries, is dedicated to construction projects and its infrastructure, which is one of the factors of economic growth and development of any society, success in implementing Its construction projects are considered. If the projects are delayed, some of them will lose their technical and economic justification, along with the waste of national funds.

Examining the project delays by the employer or the contractor in order to use the experience and knowledge gained during the implementation of the project can be used in the next similar projects, especially This is the reason that in projects that are implemented in different places Many executive agents of the project change, so the knowledge and experience gained during the project in different parts by executive agents at all levels should be documented and managed. In this case, it is possible to prevent similar cases from happening in the future by using past experiences.

Employers are looking for the cause of delays in order to be able to calculate the compensation of damages and penalties for contractors' delays, and also in exchange for appropriate estimates of the amount of additional costs to be imposed. It helps the contractor to file a claim for the delay in

the work and analyze the causes of the delays. do Also, the companies that provide guarantees and project credits should also have detailed information about the causes and responsibilities of delays in order to control the performance of the recipients of these facilities [10-13].

## 1.1 The status of construction projects in Iran

The Iranian Parliament Research Center announced in a report published in line with the review of the 2019 budget bill, that it shows the progress of the completion of construction projects during the years 1381 to 1390. During these years, an average of 473 construction projects that should be implemented annually The country was reached alone; in the percentage of the concession, the atmosphere was at the same time, and the percentage of the time was not ended and the cost of 1/8/16,000. Budget laws have been imposed on the country's economy.

This cost is about 75.95 thousand billion tomans, which is considered as the cost of delay in the completion of the projects, which is more than the annual average required to complete the projects, and it is 245% on average. Surplus credit according to the budget law should be allocated to each plan He works until the designs are completed. In simpler terms, any construction plan costs 2.5 times its actual price. which should be seen as the initial budget of the predicted error or the additional cost caused by the effects created during the implementation of the project.

Some reports tell about the existence of 9,800 national construction projects and 45,000 provincial projects that are half finished and are being implemented in the country. Lack of credit has contributed 36 percent to the delay of national and construction projects. Following the problems caused by financial and credit inadequacies, the weakness of executive devices in performing the assigned construction tasks, with 5.8 percent, has been one of the main reasons for project delays.

At the same time, 4.8 percent of the causes of delays in projects are due to contracting problems. This percentage in some ministries, including road and urban development with 3.14 percent, industry, mining and trade with 13.2 percent and the Ministry of Energy with 10 percent, is more than the national average (4.8 percent) [14-16].

#### 2. Analysis method

To analyze the data, after ensuring the normality of the population by Pearson's correlation coefficient, and to obtain the degree of relationship, we have used multiple regression analysis.

The reliability of the questionnaire prepared in this research was obtained by Cronbach's alpha and its significance level is 85.0

## 2.1 Analytical findings

This type of statistics is about the characteristics and parameters related to the research statistical community and the quality of the relationship between concepts and variables. The main difference between descriptive statistics and inferential statistics is that in descriptive statistics it is not possible to generalize the results obtained from the statistical sample to the entire statistical population of the research, the purpose of descriptive statistics is simply to provide a description of the characteristics of the statistical sample of the research along with the central indicators. and dispersion, while in inferential statistics, the results and findings obtained from the statistical sample can be generalized to the entire statistical population of the research. In other words, the central concept of inferential statistics is generalizability. In which, in order to check the hypotheses and test the research model, simple or bivariate regression, f-test of two independent groups, multiple regression analysis and Cronbach's alpha method were used to calculate reliability coefficients. In addition, a significance level of 0.05 has been considered for all hypotheses [17-20].

## 3. Results

By using the research, the reasons for the delays in the construction projects of Arvand Free Zone were divided into 6 general spectrums and more than 7 indicators were identified for these spectrums. Then, by asking the experts of the matter and competent specialists, 52 indicators were finally obtained to identify the reasons for the delay in the construction projects of Arvand Free Zone. The identified spectra are as described in the following tables (table no. 1 to 6).

Basically, by performing the Kolmogorov test, we are testing a neutral hypothesis, which is as follows:

Now, according to the above table, we look at the number corresponding to Sig. If this number is smaller than the desired P, usually P=0.05, then we ignore the above hypothesis in favor of the non-normal distribution of the studied variable. But if it is equal to or greater than the P number (as it is equal to 881.0 in the Kolmogorov test and 691.0 in the Shapiro test), then we cannot ignore the above neutral hypothesis (in favor of the normality of the distribution of the desired variable) therefore, the result of the above table means that the desired variable has a normal distribution.

In Table 14, in column B, beta is presented as a constant value and as an independent variable coefficient. The table of coefficients includes two categories of standardized beta and unstandardized beta coefficients. In non-standardized beta coefficients, the scale of the variables is not the same with each other, while in the standardized beta coefficients, the scale of the variables is the same and it is possible to compare the variables. Therefore, standardized coefficients are used to compare the effect of the independent variable on the dependent variable.

The influence of the coefficients in order are: related to human power (242.0), employer issues (201.0) and managerial issues (217.0), natural factors (150.0), financial (115.0) and war (075.0).

Friedman's test Friedman's test was used to rank the factors and their effect on project delay:
