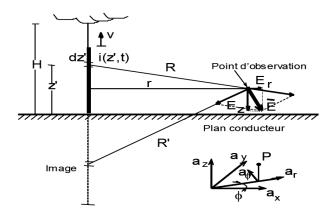


Fig.1 Lighting channel based current with the following parameter

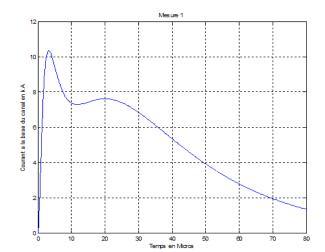

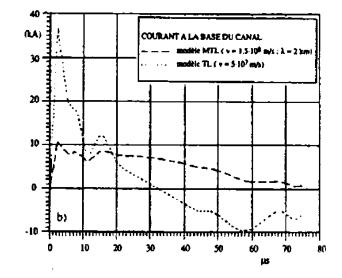

Comparing the both result shows a prefect agreement which, probate strongly the theorical approach adopted by the channel based current.

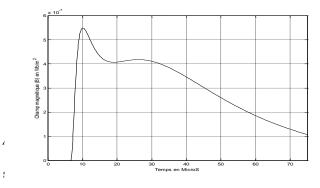


Fig. 4 the typical electric protections in a PV module

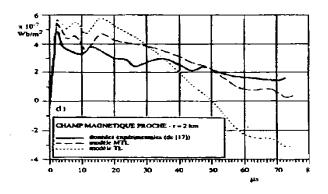
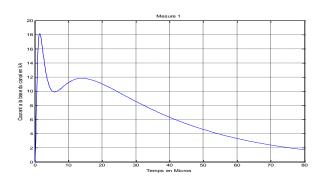
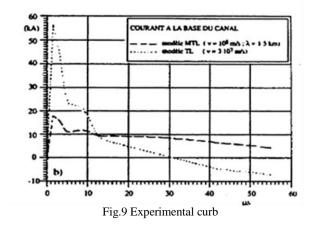


Fig.5 Expérimental curb

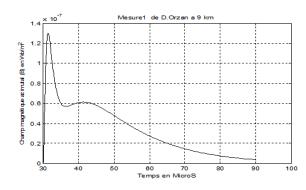


Fig.10 Curb got through a simulation

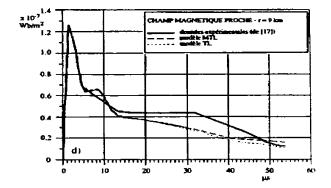


Fig.11 Experimental curb
