A B S T R A C T

In this paper, we introduce a Caputo-sense fractional derivative to an existing model for the Chikungunya transmission dynamics, replacing integer derivative. After reviewing previous work on the integer order model, we suggest a change whereby the integer derivative is replaced by the Caputo derivative operator, and then we obtain results about the asymptotic stability of equilibrium points in this new fractional model. We prove the existence and uniqueness of the solution as well as the global stability of the fractional system. We then construct a numerical scheme for the fractional model, and use parameter values from the Chikungunya epidemic in Chad to perform numerical simulations. This allows us to validate our theoretical results and compare the dynamics behaviour of both models. We find from numerical simulations, that for the fractional-order parameter η in the range (0.85; 1), daily detected cases are closer to those the model predict. Thus in the case of Chikungunya epidemic in Chad, the model with fractional derivative produces better results than which with integer derivative.

Introduction

Chikungunya, or ''man who bends up'' in the Makonde language (Tanzania), is an arboviral disease that appears epidemically in many countries around the world. It was spread by the bite of a female mosquito that looked like an aedes (Aedes albopictus and Aedes aegypti). After the initial outbreak in Tanzania in 1952, the chikungunya virus (CHV) was described by researchers Marion Robinson and Lumsden [1,2]. Since this date, several Chikungunya epidemic episodes were observed in Europe (Italy and France), Asia (Bangkok, Thailand, Vellore, Calcutta and Maharashtra, Yemen Pakistan), South America (brazil) and Africa (Comoros islands, Tanzania, Kenya, Democratic Republic of Congo, Chad), and in Reunion Islands in the Indian ocean [3–8]. In all these epidemic cases, the main control measures are vector control (use of insecticide, larvicide, sterile insect technique, etc.) and individual protection, since vaccination against Chikungunya, although in the development phase, is not yet available [9,10].

To understand the transmission dynamics of Chikungunya and also evaluate the existing control measures, several mathematical models were proposed and studied (see [9-16] and the references therein). All of the works mentioned above are extensions of the SEIR-SEI type model, in which the authors include some existing control measures to combat disease transmission in human populations. Indeed, Agusto et *al.* in [11] developed a model structured by age. Mathematical analysis of the model indicated that the DFE is GAS whenever R_0 < 1. However, if the disease-induced death rate is taking account, they found that the backward bifurcation phenomenon occurs, when the DFE co-exists with two others points (one is unstable and other is stable) when $R_0 < 1$. They also found that the inclusion of age structure does not altered qualitative behaviour of the model. Dumont et *al.* in [9] proposed a model which take into account only mosquito aquatic stage, vector control and individual protections. They performed local asymptotic stability of the Chikungunya-free equilibrium whenever the basic reproduction number (R_0) is less than one, while necessary condition to the GAS of Chikungunya-free equilibrium is obtained. They constructed numerical scheme based on the non-standard method, and estimated numerically R_0 . They finally obtained that the value of R_0 depend is place-dependent. In [13], Yakob and Clements formulated a transmission model of the Chikungunya virus between humans and mosquitoes. Using real data, they fitted the model and obtain that the type reproduction number is equal to 4.1. Through sensitivity analysis, they found that epidemics of Chikungunya occurred in Réunion Island were strongly influenced by latent period in humans and pre-patent period. The extension of these model were considered by other authors who included also control measures and applied optimal control [14,17]. In [17], Moulay and co-workers formulated a model including three control measures (vector control, individual protection and treatment) to fight the spread of Chikungunya in Réunion island. They use optimal control tools to analyse the optimal control model. Numerically, they obtained that there exist cost effective control efforts. The above models did not consider the density-dependent death rates of the populations involved (mosquitoes and humans). Recently, Abboubakar et *al.* in [18] proposed a SEIR-SEI-ELP model that includes density-dependent death rates, and four control measures. They performed an optimal control and efficiency analysis to figure out which combination of controls works best and permit a decrease in the total numbers of infected humans as well as the total numbers of mosquitoes in the adult and aquatic phases.

All the above cited models are principally formulated using classical derivatives (ordinary differential equations). Since more than two last decades, several works have shown that fractional derivatives are better than classical derivative when we want to model some Biological phenomenon like infectious diseases (see [19–30]). Compared to classical derivatives, FDs present a great advantage which is the memory effect [31,32]. One of disadvantage is that models with FDs do not have exact analytic solutions. Thus, numerous numerical methods are developed to approximate solutions [33,34].

To our knowledge, there are few works on mathematical modelling of Chikungunya transmission dynamics using fractional derivatives. We found, for the moment, the works of Helikumi and coworkers [35,36]. In [35], Helikumi et *al.* proposed and analysed a fractional Chikungunya model which include asymptotic individuals. Their main objective was investigated the memory effect on the disease dynamics. Then, in [36], they modified the previous model by including one compartment for aquatic stages of mosquitoes, as well as control measures. Model parameters were considered time-dependent. They calibrated the model using real data and thus performed sensitivity analysis. The fractional optimal control model was then formulated and analysed. They concluded through numerical simulations that memory effects affect the dynamics of Chikungunya. Contrary to [18], the Chikungunya fractional models cited above [35,36] does not distinguish all aquatic stages (eggs, larvae and pupae). In a control point of view, this can represent a problem since the eggs, larvae, and pupae do not respond in the same manner to larvicides or other chemical products whose principal role is to reduce these mosquito populations in their aquatic stage.

The goal of this work is to extend the model proposed by Abboubakar et *al.* in [18], which describes the transmission dynamics of the recent outbreak of Chikungunya in Chad, by changing the integer-derivative to a fractional derivative in the sense of Caputo. And thus, to compare both the qualitative and quantitative dynamics of both models, We begin by recalling the theoretical results of the integer model and then formulate the model with a fractional derivative. We compute the offspring reproduction number N and the basic reproduction number R_0 , both of which are proportional to the fractional order η . Using the Banach contraction theorem and the Ulam–Hyers stability criterion, we show the solutions existence and uniqueness of the fractional model, as well as the uniform stability of the fractional model in the Lyapunov sense. The numerical method is built using the Generalized Fractional Euler Method (GFEM). We finally perform several simulations to validate our theoretical results as well as compare the two dynamics qualitatively and quantitatively.

The following outline constitutes the paper's structure: In Section g , we will review a few of the fundamental definitions and ideas of fractional calculus. Model formulation is discussed in Section g. The fractional model for Chikungunya is analysed in Section g. The Existence and uniqueness of solution as well as the global stability of the fractional model is also proved in **Section** g. Numerical scheme as well as numerical results are performed in **Section** g. A conclusion accomplishes the work.

Preliminaries on fractional calculus

Fractional calculus extends ordinary calculus by examining integrals and derivatives of any real or complex order. It has been applied to real-world problems. In this section, we provide few notions and useful results needed to analyse fractional models.

Definition 1 (*Riemann–Liouville fractional integral [26]*). Assume that $\alpha > 0$ be a real number and $f : [a, b] \to \mathbb{R}$ an integrable function. The Riemann–Liouville fractional integral of f of order α is defined by :

where Γ denotes the Gamma function defined as follows: $\Gamma(t) := \int_0^\infty \tau^{t-1} \exp(-\tau) d\tau$ for $t > 0$. Γ has the following properties : $\Gamma(t + 1) = t\Gamma(t)$, for all $t > 0$, and $\Gamma(n + 1) = n!$ for *n* a positive integer.

Model formulation

The model we consider is the one formulated in $[18]$ and depicted in Fig. 1, which consists of a system of ten (10) ordinary differential equations. The populations involved are humans and vectors (mosquitoes). The human population is split into four compartments: susceptible humans denoted by *^ℎ* , exposed humans (infected but not infectious) denoted by *^ℎ* , infectious humans denoted by *^ℎ* , and recovered humans denoted by *^ℎ* . Due to the epidemiological knowledge of Chikungunya, the immunity conferred after being infectious is permanent. Since the aquatic phase plays a major role in the mosquito's life, the dynamics of mosquitoes are composed of aquatic mosquitoes, which are divided into three sub-populations (E for Eggs, L for larvae, and P for pupae), and adult mosquitoes, which include the susceptible mosquitoes denoted by S_v , the exposed mosquitoes denoted by E_v , and the infectious mosquitoes denoted by I_v . Infected mosquitoes remain infected throughout their lives. Thus, the model considered in [18] is given as follows:

In Eq. (14) , Λ_h denotes the recruitment rate of susceptible individuals, ρ is the per capita birth rate of humans, μ_i , $i = 1, 2$, represent the mortality rates μ_1 and μ_2 , $\lambda_h(t)$ is the force of infection (FOI) given by

where *a* and β_h are, respectively, the average numbers of mosquito bites and probability of infection transmission from an infectious vector to a susceptible human. The transition rate between compartments *^ℎ* and *^ℎ* is denoted by *^ℎ* (1∕*^ℎ* is the average duration of the latent stage in infected human). δ_h denotes the death rate induced by the disease, and σ_h is the recovered rate of infectious humans. For the adult mosquito dynamics, θ is the rate at which pupae become adult females (susceptible mosquitoes), μ_i , $i = 3, 4$, are the mortality rates of adult female mosquitoes, γ_v is the transition rate between compartments E_v and I_v (1/ γ_v is the average duration of the latent stage in infected mosquito). For the aquatic mosquito dynamics, ξ represents the average number of eggs laid by each adult female, at each deposit; K_E , K_L , K_P are respectively the carrying capacity of eggs, larvae and pupae; *s* is the transition rate between E and L while l is the transition rate between L and P; μ_E , μ_L and μ_P are the natural death rates of eggs, larvae and pupae, respectively; α and β are respectively the additional death rate of larvae and pupae, due to the density [43].

We denote the total population's sizes by $N_h(t) = S_h(t) + E_h(t) + I_h(t) + R_h(t)$ and $N_v(t) = S_v(t) + E_v(t) + I_v(t)$. The model (14) is defined in the following set $\Sigma = \Sigma_h \times \Sigma_v$, where $\Sigma_h := \{(S_h, E_h, I_h, R_h) \in \mathbb{R}_+^4 : N_h > 0\}$ and $\Sigma_v :=$ $\{(S_v, E_v, I_v, E, L, P) \in \mathbb{R}_+^6 : N_v \ge 0; E \ge 0; L \ge 0; P \ge 0\}.$

In the system, we substitute the Caputo fractional derivative of order η for the next ordinary derivative, where η is an arbitrary real in the interval (0*,* 1]. To resolve the irrelevancy of the dimensions between the left and right hand-sides of the equations of system (14), due to the substitution of ordinary derivatives with fractional derivatives in the model, we multiply the left-hand side of each equation by $\chi^{\eta-1}$, where χ is a time constant used to compensate the units [44], after replacing the differential operators. We thus claim the following result (we omit the proof which is similar to the one from $[18]$):

Theorem 5 (*[18]*)**.**

- 1. If $N \leq 1$ then Q_1 is globally asymptotically stable on \mathcal{L}_1 and unstable otherwise;
- 2. If $N > 1$ and $R_0 \le 1$ then Q_2 in locally asymptotically stable on Σ_1 and unstable otherwise;
- 3. The fractional model (16) admits at least one endemic equilibrium whenever $R_0 > 1$, and the backward bifurcation can occurs in the *case* (**N** > 1 *and* $R_0 \le 1$).

Biological implication of Theorem 4 is that the population of mosquitoes can be eradicated if one can apply control measures which able to decrease the offspring number. Although the complete eradication of mosquitoes in tropical areas is still an option for many countries in sub-Saharan Africa, the maintenance of vector control measures will permit to reduce the mosquito population, and thus reduce the likelihood of contact mosquito–Human. Similarly, it follows from Theorem 5 that the control measures aimed at protecting humans against mosquito bites, the prose in charge of the sick with the administration of an effective treatment, and

the preventive measures, will make it possible to decrease the basic reproduction number at its minimal value. Indeed, the epidemic period corresponds to $R_0 > 1$. So in most cases, if we manage to get $R_0 < 1$, then we can end the epidemic.

Existence, uniqueness and uniform stability of the solutions of the fractional model

This subsection provides the fractional model solution's existence and uniqueness (16).

Numerical scheme and simulation results

To solve fractional differential equations (FDEs), numerous analytical and numerical methods have been used, the majority of which do not have exact analytic solutions. For numerical solution of the system (16), we will apply the *Generalized Fractional Euler Method* (GFEM) [49].

Numerical scheme

Here, we construct a numerical scheme to simulate our fractional-order Chikungunya model (16). We use the new generalized fractional Euler method described in [42]. For the reader's convenience, we resume the description of this method before adapting it to our model.

Let us consider the following new generalized Caputo-type initial value problem :

Note that if $\varphi = 1$, then the above system represents an initial value problem with the classical Caputo-type derivative.

In (60), c_{φ} is a positive constant that only depends on φ (Lemma 4) and \aleph is supposed to be small enough. Lemma 5 gives $|\tilde{X}_{k+1}| \leq c\varsigma_0$, where c is an independent positive constant independent of k and \aleph . This ends the proof. \square

Theorem 9. *For the numerical method* (56)*, we have*

According to the above described method for some τ , the approximate solutions of $X = (S_h, E_h, I_h, R_h, S_v, E_v, I_v, E, L, P)$ denoted by

Numerical results

In this section, we perform several numerical simulations to firstly validate our analytical results and secondly to compare the dynamics of both models. The following parameter values are used: $\mu_3 = 0.033$, $\mu_4 = 0.00034$, $\xi = 12$, $\theta = 0.08$, $s = 0.7$, $l = 0.4$, $\mu_E = 0.4$; $\mu_L = 0.4$; $\mu_P = 0.4$, $\alpha = \beta = 2 \times 10^{-4}$, $\Lambda_h = 1$, $\rho = 2.7 \times 10^{-4}$, $\mu_1 = 1.00038 \times 10^{-10}$, $\mu_2 = 10^{-8}$, $\beta_h = 0.9999$; $a = 2.4676$; $\gamma_h = 0.3333$, $\sigma_h = 0.1499$, $\delta_h = 9.999 \times 10^{-4}$, $\beta_v = 0.600$, $\gamma_v = 0.4999$ [18].

In Fig. 2, we depict reported cases of the 2019 Chikungunya epidemic in Chad versus model predictions for different values of the fractional-order η . We see that for $\eta \in (0.85; 1)$, daily detected cases are closer to those the model predict.

We begin by representing the two thresholds N and R_0 which govern the dynamics of both models as function of the fractionalorder parameter η . The results are depicted on Figs. 3 & 4. We clearly see that the offspring reproduction number N is a increasing function of η (Fig. 3). However, the basic reproduction number R_0 increases for the fractional-order parameter $\eta \in (0, 0.67)$, and decrease for $\eta \in [0.67; 1]$ (Fig. 4).

We then plot the two important thresholds N and R_0 in term of some model parameters. The results are depicted in Fig. 5. The offspring number N increases with the increases of ξ and θ , while it decreases when the density-independent mortality rate of mosquitoes μ_3 increases. This suggests that control measures which result to the decrease of total number of female mosquitoes are the best way to fight the disease. Indeed, decrease N implies to the eradication of mosquito population. We see that \mathbf{R}_0 is a increasing function of β_h and β_v , while it decreases when the treatment rate σ_h increases.

Figs. 6 and 7 validate the results claimed in Theorems 3 and 4. We see that for $N < 1$ (Fig. 6), populations of aquatic vectors decrease until the trivial point (0,0,0,0), and thus proving its global asymptotic stability. However, when **N** > 1 (Fig. 7), all trajectories of state variables of the vector dynamics model (19), independently of the fractional-order parameter value, tend to the non-trivial equilibrium (E^*, L^*, P^*, N_v^*) , proving thus its global asymptotic stability.

The results depicted in Fig. 7 confirm that the non-trivial equilibrium is globally asymptotically stable whenever $N > 1$. On a quantitative viewpoint, Fig. 6 shows that the obtained numerical solutions which are Eggs (E) Larvae (L) , Purpae (P) and Adult vectors (N_p) decrease according to the increase of fractional order η . In Fig. 7, Eggs (E) Larvae (L), Purpae (P) and Adult vectors (N_v) decrease when η decreases. This means that vector control measures which result to the decrease of the offspring reproduction number N are appropriates to decrease the mosquito population. Thus, if one could applied all vector control measures which permits to decrease the proliferation of mosquitoes, then the probability that a infected mosquito bites a susceptible human will be reduce. Indeed, without mosquito, Chikungunya virus cannot spread in human population.

Setting the offspring reproduction number N greater than one $(N > 1)$, we then simulate the reduce model given by Eq. (30). The results are depicted in Figs. 8 and 9. Note that Fig. 8 corresponds to the case $R_0 < 1$ while Fig. 9 corresponds to the case $R_0 > 1$.

Figs. 8 shows that Susceptible humans (S_{*h*}) (resp. removed humans R_h , susceptible vectors S_v) increases when *η* increases. The Infected humans in the latent stage E_h (resp. infectious humans I_h , infected vectors E_v and I_v) decrease according to the increase of η . Fig. 8 shows that the Infectious and Symptomatic humans (I_h) and the Recovered humans(R_h) increase when η increases. The same reasoning is done in Fig. 9. In a control point of view, if the population of mosquito cannot be eradicated, it would better to apply anothers existing control measures as individual protection (Wearing suitable clothes), quarantined of infectious persons as well as their rapid management with administration of appropriate treatments, to reduce as much as possible the basic reproduction number R_0 below unity.

Also, numerical simulation results show that fractional model provides various flexibility in taking decision concerning disease controls.

(c) $\mathbf{R}_0 = f(\beta_h, \beta_v)$

Conclusion

In this work, a fractional mathematical model for Chikungunya transmission dynamics has been investigated. We began by recalling some preliminary material on fractional calculus, and we presented the fractional-order Chikungunya model in the Caputo sense. Then, we firstly analysed the mosquito model dynamics and computed the offspring reproductive number N as well as the trivial and non-trivial equilibrium points. We proved that these two equilibrium points are globally asymptotically stable depending of the value of N. Indeed, if N < 1, then the trivial equilibrium point is GAS, while if N > 1, then the non trivial equilibrium is GAS. After that, we analysed the full model by computing the basic reproduction number R_0 , the equilibrium points of the full model as well as the stability analysis of these equilibrium points. Indeed, we proved that the trivial equilibrium of the full model is globally asymptotically stable whenever $N < 1$, while for $N > 1$, the trivial equilibrium point becomes unstable and the biological meaningful disease-free equilibrium is stable locally whenever $R_0 < 1$. As in the case of the integer model, the fractional model admits at least one endemic equilibrium point whenever the basic reproduction number is greater than one.

We proved the existence and uniqueness of solutions using the Banach contraction theorem. The global stability of the fractional model is obtained by means of the Ulam–Hyers method. Indeed, we proved that under certain conditions, the fractional model is uniformly Lyapunov stable. The Generalized Fractional Euler Method is used to construct a numerical scheme. We performed several simulations to validate our theoretical results, as well as see the impact of the fractional-order in the model dynamics. Numerical

simulation results permit to conclude that mosquito control measures permit to reduce the population of mosquito. Although it is not possible to eradicate the mosquito population (indeed the case $N < 1$ is not biologically feasible in Sub-Saharan African countries), one can reduce as well as possible the basic reproduction number until obtained $R_0 < 1$. The biological implication of these observations is that it is necessary to combine mosquito control measures with other control measures like individual protection, efficient treatment, and possible vaccination if this last is available. Indeed, in [18], it has been proved that combination of all available control measures is the best ways to fight vector-borne disease like Chikungunya.

Even though both models (classical and fractional derivatives) have the same qualitative dynamics, we discovered through numerical simulations that the fractional model is a better approach from a quantitative standpoint because it better fits the Chikungunya reported cases, and thus provides more flexibility in making disease control decisions.

In this work, we did not determine the exact value of the fractional-order parameter η which better fits the data. Also, numerous fractional derivative exist and must be taking into account. The direct perspective of this work can be resumed to the determination of the fractional-order parameter η and the type of fractional derivative which better predict Chikungunya epidemic in Chad.
