## Proofs for Section 4

Proof of Corollary 1. We focus with no loss of generality on the case where (8) holds neither under $\overline{\mathbf{P}}$ nor under $\underline{\mathbf{P}}$. We need to show that $\underline{F}\left(\underline{t}^{c}\right) \geq \bar{F}\left(\bar{t}^{c}\right)$. For this we show that the unique $\hat{t}$ defined by $\underline{F}\left(\underline{t}^{c}\right)=\bar{F}(\hat{t})$ satisfies $\hat{t} \geq \bar{t}^{c}$. We have

$$
\begin{aligned}
\int_{\hat{t}}^{1}\left(\theta-t^{a}\right) \overline{\mathbf{P}}(\mathrm{d} \theta) & =\int_{\bar{F}^{-1}\left(\underline{F}\left(t^{c}\right)\right)}^{1}\left(\theta-t^{a}\right) \overline{\mathbf{P}}(\mathrm{d} \theta) \\
& =\int_{\underline{F}\left(t^{c}\right)}^{1}\left[\bar{F}^{-1}(p)-t^{a}\right] \mathrm{d} p \\
& \geq \int_{\underline{F}\left(t^{c}\right)}^{1}\left[\underline{F}^{-1}(p)-t^{a}\right] \mathrm{d} p \\
& =\int_{\underline{t}^{c}}^{1}\left(\theta-t^{a}\right) \underline{\mathbf{P}}(\mathrm{d} \theta) \\
& =0 \\
& =\int_{\bar{t}^{c}}^{1}\left(\theta-t^{a}\right) \overline{\mathbf{P}}(\mathrm{d} \theta)
\end{aligned}
$$

where the inequality follows from Shaked and Shanthikumar (2007, Section 4.A.1), and the last two equalities follow from (9). If $\hat{t} \geq t^{a}$, then a fortiori $\hat{t}>\bar{t}^{c}$. Otherwise, $\max \left\{\bar{t}^{c}, \hat{t}\right\}<t^{a}$ implies that $\theta-t^{a}<0$ for $\theta$ between $\bar{t}^{c}$ and $\hat{t}$, so that $\hat{t} \geq \bar{t}^{c}$ from the above inequality. Hence the result.

Proof of Corollary 2. For future reference, we more generally show the result for any right-truncation $\mathbf{P}_{b} \equiv \mathbf{P}[\cdot \mid \theta \leq b]$ of $\mathbf{P}$, with cdf $F_{b}$ and density $f_{b}$ over $[0, b]$, where $\frac{1}{\delta^{2} C}<b \leq 1$. Corollary 2 corresponds to the special case $b=1$. A first observation is that MHRP is preserved

[^0]by right-truncation.

Lemma A. 1 If $\mathbf{P}$ satisfies $M H R P$, then so does $\mathbf{P}_{b}$ for any $b \in(0,1)$.

Proof. For each $t \in[0, b)$, we have

$$
r_{b}(t) \equiv \frac{f_{b}(t)}{1-F_{b}(t)} \propto \frac{f(t)}{F(b)-F(t)}=r(t) \frac{1-F(t)}{F(b)-F(t)}
$$

so that $r_{b}(t)$ is the product of two strictly positive and strictly increasing functions of $t$. The result follows.

Now, fix some $b \in\left(\frac{1}{\delta^{2} C}, 1\right)$ and, for each $\beta \in\left(\frac{1}{b \delta^{2} C}, 1\right)$, define

$$
\begin{equation*}
\phi_{b}(\beta) \equiv \mathbf{E}_{b}\left[\theta \left\lvert\, \theta \geq \frac{1+\beta \delta}{(1+\delta) \beta \delta^{2} C}\right.\right]-\frac{1}{\beta \delta^{2} C} \tag{A.4}
\end{equation*}
$$

We show that there exists a unique solution $\beta_{b}^{u}$ to $\phi_{b}(\beta)=0$ and that $\phi_{b}(\beta) \geq 0$ if and only if $\beta \geq \beta_{b}^{u}$. This, in particular, implies Corollary 2 , with $\beta^{u} \equiv \beta_{1}^{u}$. Because $f$ is continuous, so is $\phi_{b}$. Hence, by the intermediate value theorem, we only need to check that $\phi_{b}\left(\frac{1}{b \delta^{2} C}\right)<0$, that $\phi_{b}(1)>0$, and that $\phi_{b}$ is strictly increasing. As for the first two statements, we have

$$
\phi_{b}\left(\frac{1}{b \delta^{2} C}\right)=\mathbf{E}_{b}\left[\theta \left\lvert\, \theta \geq \frac{1+b \delta C}{(1+\delta) \delta C}\right.\right]-b \quad \text { and } \quad \phi_{b}(1)=\mathbf{E}_{b}\left[\theta \left\lvert\, \theta \geq \frac{1}{\delta^{2} C}\right.\right]-\frac{1}{\delta^{2} C}
$$

and the result follows from $b \delta^{2} C>1$ and the fact that $\mathbf{P}_{b}$ has full support over $[0, b]$. As for the third statement, notice that, letting $\xi \equiv \frac{1}{\beta \delta^{2} C}$ and changing variables accordingly, it is equivalent to the claim that

$$
\mathbf{E}_{b}\left[\theta \left\lvert\, \theta \geq \frac{\xi+\frac{1}{\delta C}}{1+\delta}\right.\right]-\xi
$$

is strictly decreasing in $\xi \in\left(\frac{1}{\delta^{2} C}, b\right)$. A classical result from reliability theory (see, e.g., Bryson and Siddiqui 1969) states that, for a distribution that satisfies MHRP, the mean residual life is strictly decreasing in the age. By Lemma A.1, such is the case of $\mathbf{P}_{b}$, and thus

$$
\frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}_{b}[\theta \mid \theta \geq t]<1
$$

for all $b \in(0,1)$ and $t \in[0, b)$. It follows that

$$
\frac{\mathrm{d}}{\mathrm{~d} \xi} \mathbf{E}_{b}\left[\theta \left\lvert\, \theta \geq \frac{\xi+\frac{1}{\delta C}}{1+\delta}\right.\right]<\frac{1}{1+\delta}<1
$$

for all $\xi \in\left(\frac{1}{\delta^{2} C}, b\right)$. Hence the result.

Proof of Corollary 3. By (3)-(4) and (9), the probability of harmful consumption is

$$
F\left(t^{c}\right)-F\left(t^{h}\right)=F\left(t^{c}\right)-F\left(\frac{\mathbf{E}\left[\theta \mid \theta \geq t^{c}\right]+\frac{1}{\delta C}}{1+\delta}\right)
$$

As observed in the main text, $t^{c}$ is strictly decreasing in $\beta \in\left(\frac{1}{\delta^{2} C}, \beta^{u}\right)$. Hence it is sufficient to show that

$$
\begin{equation*}
H(t) \equiv F(t)-F\left(\frac{\mathbf{E}[\theta \mid \theta \geq t]+\frac{1}{\delta C}}{1+\delta}\right) \tag{A.5}
\end{equation*}
$$

is strictly increasing in $t \in\left(t^{u}, 1\right)$, where

$$
t^{u} \equiv \frac{1+\beta^{u} \delta}{(1+\delta) \beta^{u} \delta^{2} C}
$$

Notice for future reference that, for each $t \in\left(t^{u}, 1\right)$,

$$
\begin{equation*}
t>\frac{\mathbf{E}[\theta \mid \theta \geq t]+\frac{1}{\delta C}}{1+\delta} \tag{A.6}
\end{equation*}
$$

because, as $\beta^{u}$ is the unique value of $\beta \in\left(\frac{1}{\delta^{2} C}, 1\right)$ that achieves equality in (10), (A.6) becomes an equality at $t=t^{u}$ and because, as $\mathbf{P}$ satisfies MHRP, the mapping $t \mapsto(1+\delta) t-\mathbf{E}[\theta \mid \theta \geq t]$ is strictly increasing over $[0,1)$. Then, for each $t \in\left(t^{u}, 1\right)$,

$$
\begin{align*}
H^{\prime}(t) & =f(t)-\frac{1}{1+\delta} f\left(\frac{\mathbf{E}[\theta \mid \theta \geq t]+\frac{1}{\delta C}}{1+\delta}\right) \frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t] \\
& \geq f(t)-\frac{1}{1+\delta} f\left(\frac{\mathbf{E}[\theta \mid \theta \geq t]+\frac{1}{\delta C}}{1+\delta}\right) \\
& >0 \tag{A.7}
\end{align*}
$$

where the first inequality again follows from MHRP, and the second inequality follows from (11) and (A.6). Hence the result.

Corollary A. 1 If $\mathbf{P}$ satisfies $M H R P$ and $f$ is nonincreasing in a left-neighborhood of $t=1$ or strictly positive at $t=1$, and if

$$
\begin{equation*}
f(1)<\frac{1}{2(1+\delta)} f\left(\frac{1+\frac{1}{\delta C}}{1+\delta}\right) \tag{A.8}
\end{equation*}
$$

then the probability $F\left(t^{c}\right)-F\left(t^{h}\right)$ that harmful consumption takes place under the optimal IC mechanism is strictly increasing in $\beta$ in a right-neighborhood of $\beta=\frac{1}{\delta^{2} C}$.

Proof. Defining $H$ as in (A.5), we have

$$
\frac{\mathrm{d}}{\mathrm{~d} \beta}\left[F\left(t^{c}\right)-F\left(t^{h}\right)\right]>0
$$

in a strict right-neighborhood of $\beta=\frac{1}{\delta^{2} C}$ if and only if $H^{\prime}<0$ in a strict left-neighborhood of $t=1$ or, equivalently, by (A.7),

$$
\begin{equation*}
f(1)-\frac{1}{1+\delta} f\left(\frac{1+\frac{1}{\delta C}}{1+\delta}\right) \liminf _{t \rightarrow 1^{-}} \frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t]<0 \tag{A.9}
\end{equation*}
$$

We need to show that (A.8) implies (A.9) if $f(1)>0$ or, if $f(1)=0$, if $f$ is nonincreasing in a left-neighborhood of $t=1 .{ }^{1}$ That is, we need to show that, under these assumptions,

$$
\liminf _{t \rightarrow 1^{-}} \frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t] \geq \frac{1}{2}
$$

Suppose, by way of contradiction, that there exists a sequence $\left(t_{n}\right)_{n \in \mathbb{N}}$ in $(0,1)$ converging to 1 such that, for some $\varepsilon>0$,

$$
\left.\frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t]\right|_{t=t_{n}}<\frac{1-\varepsilon}{2}
$$

for all $n$. Then, because

$$
\frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t]=\frac{f(t)}{1-F(t)}\{\mathbf{E}[\theta \mid \theta \geq t]-t\}
$$

we have

$$
\begin{equation*}
f\left(t_{n}\right)\left\{\int_{t_{n}}^{1} \theta f(\theta) \mathrm{d} \theta-t_{n}\left[1-F\left(t_{n}\right)\right]\right\}-\frac{1-\varepsilon}{2}\left[1-F\left(t_{n}\right)\right]^{2}<0 \tag{A.10}
\end{equation*}
$$

for all $n$. Consider then the function

$$
I(t) \equiv f(t)\left\{\int_{t}^{1} \theta f(\theta) \mathrm{d} \theta-t[1-F(t)]\right\}-\frac{1-\varepsilon}{2}[1-F(t)]^{2}
$$

We clearly have $I(1)=0$. We now show that, under the stated assumptions on $f, I$ is strictly decreasing in a left-neighborhood of $t=1$, which, given (A.10), yields the desired contradiction as the sequence $\left(t_{n}\right)_{n \in \mathbb{N}}$ converges to 1 . As $I$ is continuous, it is sufficient to show that its right upper Dini derivative $\mathrm{D}^{+} I$ is strictly negative in a strict left-neighborhood of $t=1$ (Giorgi and Komlósi 1992, Theorem 1.14). By continuity of $f$, the mapping $t \mapsto \int_{t}^{1} \theta f(\theta) \mathrm{d} \theta-t[1-F(t)]$ is continuously differentiable. A simple calculation then shows that, for each $t \in(0,1)$,

$$
\mathrm{D}^{+} I(t)=[1-F(t)]\left(\mathrm{D}^{+} f(t)\{\mathbf{E}[\theta \mid \theta \geq t]-t\}-\varepsilon f(t)\right)
$$

Now, recall that, by assumption, $f$ is strictly positive over $(0,1)$. Thus, if $f(1)>0$, then $\mathrm{D}^{+} I$ is strictly negative in a strict left-neighborhood of $t=1$ because the mean residual life $\mathbf{E}[\theta \mid \theta \geq t]-t$ converges to zero as $t$ goes to 1 ; similarly, if $f(1)=0$, then, because the mean residual life $\mathbf{E}[\theta \mid \theta \geq t]-t$ is strictly positive for all $t \in[0,1)$, the same conclusion obtains if $f$ is nonincreasing, so that its right upper Dini derivative $\mathrm{D}^{+} f$ is nonpositive in a strict left-neighborhood of $t=1$. Hence the result.

The somewhat convoluted condition (A.8) can be interpreted as follows. If initially $\beta \approx \frac{1}{\delta^{2} C}$, then nearly all types consume under the optimal IC mechanism, that is, $t^{c} \approx 1$. If $\beta$ increases

[^1]by $\mathrm{d} \beta$, then $t^{c}$ decreases by some amount $\mathrm{d} t^{c}$, so that a mass of types approximately equal to $f(1) \mathrm{d} t^{c}$ can be neutralized. At the same time,
$$
t^{h}=\frac{\mathbf{E}\left[\theta \mid \theta \geq t^{c}\right]+\frac{1}{\delta C}}{1+\delta} \approx \frac{1+\frac{1}{\delta C}}{1+\delta}
$$
decreases by an amount
$$
\left.\mathrm{d} t^{h} \approx \frac{\mathrm{~d} t^{c}}{1+\delta} \frac{\mathrm{d}}{\mathrm{~d} t} \mathbf{E}[\theta \mid \theta \geq t]\right|_{t=1^{-}} \geq \frac{\mathrm{d} t^{c}}{2(1+\delta)}
$$
under the weak conditions we impose on $f .^{2}$ The mass of new types thus trapped in harmful consumption is bounded below by $\frac{1}{2(1+\delta)} f\left(t^{h}\right) \mathrm{d} t^{c}$, which exceeds the mass $f(1) \mathrm{d} t^{c}$ of neutralized types if condition (A.8) is satisfied. As a result, the probability of the harmful-consumption trap $\left(t^{h}, t^{c}\right)$ locally increases in $\beta$. Notice that, because $f$ is assumed to be strictly positive over $(0,1)$, condition (A.8) is satisfied as soon as $f(1)=0$.

## Proofs for Section 5

Proof of Proposition 2. For each $\beta_{H} \in\left(\beta_{L}, 1\right)$, we denote by $t^{a}\left(\beta_{H}\right), t^{h}\left(\beta_{H}\right), t^{c}\left(\beta_{H}\right)$, and $t^{*}\left(\beta_{H}\right) \equiv \max \left\{t^{h}\left(\beta_{H}\right), t^{c}\left(\beta_{H}\right)\right\}$ the relevant cutoffs defined in Sections $2-3$. It follows from (3)-(4) that $t^{a}$ and $t^{h}$ are continuous. As for $t^{c}$ and $t^{*}$, notice that, for each $\beta_{H} \in\left(\beta_{L}, 1\right)$, the assumption that $\mathbf{P}$ has a continuous density $f$ allows us to rewrite (9) as

$$
\begin{equation*}
\frac{\int_{t^{c}\left(\beta_{H}\right)}^{1} \theta f(\theta) \mathrm{d} \theta}{1-F\left(t^{c}\left(\beta_{H}\right)\right)}=\frac{1}{\beta_{H} \delta^{2} C} \tag{A.11}
\end{equation*}
$$

which implies, using again the assumption that $f$ is continuous, that $t^{c}$ and $t^{*}$ are continuous as well. Now, for each $\beta_{H} \in\left(\beta_{L}, 1\right)$, define

$$
\begin{equation*}
\varphi_{t_{L}^{*}}\left(\beta_{H}\right) \equiv \mathbf{E}\left[\theta \mid t^{*}\left(\beta_{H}\right) \leq \theta<t_{L}^{*}\right]-t^{a}\left(\beta_{H}\right)=\frac{\int_{t^{*}\left(\beta_{H}\right)}^{t_{*}^{*}} \theta f(\theta) \mathrm{d} \theta}{F\left(t_{L}^{*}\right)-F\left(t^{*}\left(\beta_{H}\right)\right)}-\frac{1}{\beta_{H} \delta^{2} C} \tag{A.12}
\end{equation*}
$$

Because $f$ and $t^{*}$ are continuous, so is $\varphi_{t_{L}^{*}}$. Hence, by the intermediate value theorem, we only need to check that $\varphi_{t_{L}^{*}}\left(\beta_{L}^{+}\right)<0$, that $\varphi_{t_{L}^{*}}(1)>0$, and that $\varphi_{t_{L}^{*}}$ crosses zero only once. As for the first two statements, we have

$$
\varphi_{t_{L}^{*}}\left(\beta_{L}^{+}\right)=t_{L}^{*}-t^{a}\left(\beta_{L}\right) \quad \text { and } \quad \varphi_{t_{L}^{*}}(1)=\mathbf{E}\left[\theta \mid t^{*}(1) \leq \theta<t_{L}^{*}\right]-t^{a}(1)
$$

and the result follows from $t_{L}^{*}<t_{L}^{a}=t^{a}\left(\beta_{L}\right), t^{*}(1)=t^{a}(1)=t^{h}(1)<t_{L}^{h} \leq t_{L}^{*}$, and the fact that $\mathbf{P}$ has full support over $[0,1]$. As for the third statement, we distinguish two cases.

Case 1 If $\beta_{L}<\beta_{H}<\beta^{u}$, with $\beta^{u}$ defined as in Corollary 2, then the unconstrained-optimal

[^2]mechanism for type $H$ is not IC and, therefore, $t^{*}\left(\beta_{H}\right)=t^{c}\left(\beta_{H}\right)>t^{h}\left(\beta_{H}\right)$. In this case, from (A.11)-(A.12), we have
$$
\varphi_{t_{L}^{*}}\left(\beta_{H}\right)=\frac{\int_{t^{c}\left(\beta_{H}\right)}^{t_{L}^{*}} \theta f(\theta) \mathrm{d} \theta}{F\left(t_{L}^{*}\right)-F\left(t^{c}\left(\beta_{H}\right)\right)}-\frac{\int_{t^{c}\left(\beta_{H}\right)}^{1} \theta f(\theta) \mathrm{d} \theta}{1-F\left(t^{c}\left(\beta_{H}\right)\right)}<0
$$
as $t_{L}^{*}<1$ and $\mathbf{P}$ has full support over $[0,1]$. It follows that $\varphi_{t_{L}^{*}}$ cannot cross zero over $\left(\beta_{L}, \beta^{u}\right)$, and thus that the desired threshold cannot belong to this interval.

Case 2 If $\beta_{H} \geq \max \left\{\beta_{L}, \beta^{u}\right\}$, then the unconstrained-optimal mechanism for type $H$ is IC and, therefore, $t^{*}\left(\beta_{H}\right)=t^{h}\left(\beta_{H}\right)$. In this case, we have

$$
\varphi_{t_{L}^{*}}\left(\beta_{H}\right)=\mathbf{E}\left[\theta \left\lvert\, \frac{1+\beta_{H} \delta}{(1+\delta) \beta_{H} \delta^{2} C} \leq \theta<t_{L}^{*}\right.\right]-\frac{1}{\beta_{H} \delta^{2} C}=\phi_{t_{L}^{*}}\left(\beta_{H}\right)
$$

where $\phi_{t_{L}^{*}}\left(\beta_{H}\right)$ is as defined in (A.4) with $b=t_{L}^{*}$. As shown in the proof of Corollary 2, because $\mathbf{P}$ satisfies MHRP, $\phi_{t_{L}^{*}}$ is strictly increasing and vanishes at a single point $\beta_{t_{L}^{*}}^{u}$, which defines the desired threshold $\beta_{H}^{n i}\left(\beta_{L}\right)$. That $\beta_{H}^{n i}\left(\beta_{L}\right)>\beta^{u}$ was shown in Case 1. That $\beta_{H}^{n i}\left(\beta_{L}\right)$ is strictly increasing in $\beta_{L}$ follows from the fact that $t_{L}^{*}=t^{*}\left(\beta_{L}\right)$ and, thus, $\phi_{t_{L}^{*}}$ are strictly decreasing in $\beta_{L}$. Hence the result.

Proof of Proposition 3. A useful preliminary observation is that, because the mechanism designer always prefers a higher abstinence rate than the DM, we can, in analogy with the proof of Proposition 1, neglect constraints (17) and (19) in our quest for an optimal IC joint mechanism. That is, the following result holds.

Lemma A. 2 Any solution to the relaxed problem

$$
\begin{equation*}
\max \left\{\sum_{i=L, H} p_{i} \beta_{i}\left\{t_{i}^{h} \mathbf{E}\left[\Pi_{i}(\theta)\right]-\mathbf{E}\left[\theta \Pi_{i}(\theta)\right]\right\}: \pi \text { satisfies (16) and (18) }\right\} \tag{A.13}
\end{equation*}
$$

is a solution to problem (20).

Proof. We show that any solution to (A.13) satisfies (17) and (19), and thus is a solution to (20). We accordingly distinguish two cases.

Case 1 Suppose, by way of contradiction, that a solution $\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$ to (A.13) violates (17). Then type $L$ would prefer to abstain whenever the recommendation is $L$. Because the utility from consumption is weakly lower for the mechanism designer than for type $L$, the former prefers that type $L$ abstain in this case, and a fortiori that type $H$ abstain as $t_{H}^{a}<t_{L}^{a}$. Therefore, the joint mechanism $\left(\pi_{L H}, 0, \pi_{\emptyset}+\pi_{L}\right)$ would satisfy (16) and (18) and improve upon the solution to (A.13), a contradiction.

Case 2 Suppose, by way of contradiction, that a solution $\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$ to (A.13) violates
(19). Then type $H$ would prefer to abstain whenever the recommendation is $L H$. Because the utility from consumption is weakly lower for the mechanism designer than for type $H$, the former prefers that type $H$ abstain in this case. Therefore, the joint mechanism $\left(0, \pi_{L}+\pi_{L H}, \pi_{\emptyset}\right)$ would satisfy (16) and (18) and improve upon the solution to (A.13), once again a contradiction. The result follows.

Among all joint mechanisms $\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$ that issue the recommendation $L H$ with some probability $\gamma_{L H}$, those such that

$$
\pi_{L H}(\theta)=1_{\left\{\theta<t \gamma_{L H}\right\}}
$$

for $t_{\gamma_{L H}} \equiv F^{-1}\left(\gamma_{L H}\right)$ are the best for efficiency purposes as they minimize the expected harm from consumption for a given probability of joint consumption. The following lemma shows that they are also best at satisfying the incentive constraints (16) and (18), as they issue recommendations to abstain to higher-risk types than any other joint mechanism that satisfies the same constraints and issues the same recommendations with the same probabilities.

Lemma A. 3 For any joint mechanism $\pi \equiv\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$ that satisfies (16) and (18), there exists a joint mechanism $\tilde{\pi} \equiv\left(\tilde{\pi}_{L H}, \tilde{\pi}_{L}, \tilde{\pi}_{\emptyset}\right)$ that also satisfies (16) and (18), and such that

$$
\begin{align*}
\mathbf{E}\left[\tilde{\pi}_{j}(\theta)\right] & =\mathbf{E}\left[\pi_{j}(\theta)\right], \quad j=L H, L, \emptyset  \tag{A.14}\\
\tilde{\pi}_{L H}(\theta) & =1_{\left\{\theta<t \gamma_{L H}\right\}} \tag{A.15}
\end{align*}
$$

for $\gamma_{L H} \equiv \mathbf{E}\left[\pi_{L H}(\theta)\right]$ and $t_{\gamma_{L H}} \equiv F^{-1}\left(\gamma_{L H}\right)$. Moreover, $\tilde{\pi}$ achieves a weakly higher value in (A.13) than $\pi$, and strictly so if $\pi$ does not satisfy (A.15) on a $\mathbf{P}$-nonnull set.

Proof. For the proof of this lemma, it is convenient to work with an equivalent formulation of a joint mechanism, due to Aumann (1964). Let $\Omega \equiv[0,1]$ be a sample space, endowed with Lebesgue measure $\boldsymbol{\lambda}$ over the Borel sets. It follows from Aumann (1964, Lemma F) that, for every joint mechanism $\pi \equiv\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$, there exists a measurable direct mechanism $x: \Theta \times$ $\Omega \rightarrow\{L H, L, \emptyset\}$ issuing, for every type $\theta \in \Theta$ and for every element $\omega \in \Omega$, a recommendation for both types to consume $(L H)$, for only type $L$ to consume $(L)$, or for both types to abstain (Ø), and such that

$$
\begin{equation*}
\pi_{j}(\theta) \equiv \boldsymbol{\lambda}[\{\omega \in \Omega: x(\theta, \omega)=j\}], \quad(\theta, j) \in \Theta \times\{L H, L, \emptyset\} . \tag{A.16}
\end{equation*}
$$

Conversely, for any measurable direct persuasion mechanism $x: \Theta \times \Omega \rightarrow\{L H, L, \emptyset\}$, (A.16) uniquely defines a joint mechanism $\pi \equiv\left(\pi_{L H}, \pi_{L}, \pi_{\emptyset}\right)$.

Now, let $x: \Theta \times \Omega \rightarrow\{L H, L, \emptyset\}$ be the direct mechanism associated to $\pi$, and, for each
$j \in\{L H, L, \emptyset\}$, let

$$

be the probability that $x$ issues recommendation $j$ and $\theta<t_{\gamma_{L H}}$. Define a new direct joint persuasion mechanism

\tilde{x}(\theta, \omega) \equiv \begin{cases}L H & \text { if } \quad \theta<t_{\gamma_{L H}}, \\ L & \text { if } \quad \theta \geq t_{\gamma_{L H}} \wedge\left(x(\theta, \omega)=L \vee\left(x(\theta, \omega)=L H \wedge \omega<\frac{\gamma_{L}\left(t_{\gamma_{L H}}\right)}{\gamma_{L L}\left(\gamma_{\gamma_{L H}}\right)+\gamma_{\emptyset}\left(t_{\left.\gamma_{L H}\right)}\right)}\right)\right), \\ \emptyset & \text { if } \quad \theta \geq t_{\gamma_{L H}} \wedge\left(x(\theta, \omega)=\emptyset \vee\left(x(\theta, \omega)=L H \wedge \omega \geq \frac{\gamma_{L}\left(\tau_{L H}\right)}{\gamma_{L}\left(t_{\gamma_{L H} H}+\gamma_{\emptyset}\left(\gamma_{\gamma_{L H}}\right)\right.}\right)\right),\end{cases}
$$

and let $\tilde{\pi} \equiv\left(\tilde{\pi}_{L H}, \tilde{\pi}_{L}, \tilde{\pi}_{\emptyset}\right)$ be the corresponding joint mechanism. The direct mechanism $\tilde{x}$ is constructed so that the recommendation probabilities are the same as under $x$, but consumption is recommended to both types if and only if $\theta<t_{\gamma_{L H}}$. Hence (A.14)-(A.15) hold by construction. Moreover, $\tilde{\pi}$ satisfies the incentive constraints (16) and (18), as it issues recommendations to abstain to higher-risk types than $\pi$. Finally, $\tilde{\pi}$ weakly improves efficiency upon $\pi$, as it induces the same expected consumption levels with a lower expected harm from consumption, and strictly so if $\pi$ does not satisfy (A.15) on a $\mathbf{P}$-nonnull set. The result follows.

Lemma A. 3 implies that any solution $\pi^{* *} \equiv\left(\pi_{L H}^{* *}, \pi_{L}^{* *}, \pi_{\emptyset}^{* *}\right)$ to (A.13) is such that, for some cutoff $t_{L H}^{* *}$, we have (up to a P-null set)

$$
\left.\pi_{L H}^{* *}(\theta)=1_{\left\{\theta<t_{L H}^{* *}\right\}}\right\}
$$

For any such joint mechanism, type $H$ consumes if and only if $\theta<t_{L H}^{* *}$. Thus his consumption behavior is already fully determined. Hence, given an optimal cutoff $t_{L H}^{* *}$, problem (A.13) reduces to finding a measurable function $\pi_{L}^{* *}:[0,1] \rightarrow[0,1]$ that vanishes over $\left[0, t_{L H}^{* *}\right)$ and that solves the following problem:

As in Section 3, the left-hand side of constraint (16) is not well-defined if $\pi_{\emptyset}=0 \mathbf{P}$-almost surely over $\left[t_{L H}^{* *}, 1\right.$ ), and similarly the left-hand side of constraint (18) is not well-defined if $\pi_{L}=0$ $\mathbf{P}$-almost surely over $\left[t_{L H}^{* *}, 1\right)$. To circumvent this problem, we again adopt the convention that the undefined constraint is emptily satisfied, which allows us to linearize the constraints (16) and (18). We start with an existence result.

Lemma A. 4 Problems (A.17), (A.13), and (20) have a solution.
Proof. Our convention on the constraints (16) and (18) allows us to rewrite (A.17) as

\text { and } \mathbf{E}\left[\theta \pi_{L}(\theta)\right] & \left.\geq t_{H}^{a} \mathbf{E}\left[\pi_{L}(\theta)\right]\right\}, \tag{A.18}
\end{align*}
$$

where the maximum is taken over the set

$$
\begin{equation*}
S \equiv\left\{\pi_{L} \in L_{\infty}(\mathbf{P}): \pi_{L}(\theta) \in[0,1] \text { for all } \theta \in[0,1] \text { and } \pi_{L}(\theta)=0 \text { for all } \theta \in\left[0, t_{L H}^{* *}\right)\right\} \tag{A.19}
\end{equation*}
$$

Notice that $S$ is a closed subset of the unit ball $B_{L_{\infty}(\mathbf{P})}$ of $L_{\infty}(\mathbf{P})$ when the latter set is endowed with the weak* topology $\sigma\left(L_{\infty}(\mathbf{P}), L_{1}(\mathbf{P})\right)$, which we henceforth assume without further mention. By the Banach-Alaoglu compactness theorem (Aliprantis and Border 2006, Theorem 6.21), $S$ is thus compact in that topology, and so is by duality the set $S^{\prime}$ of the functions in $S$ that satisfy the constraints in (A.18); notice furthermore that $S^{\prime}$ is nonempty as it contains the function

Because $S^{\prime}$ is a nonempty compact set and the objective function in (A.18) is continuous in $\pi_{L}$ by duality, (A.18) and, hence, (A.17) have a solution. To complete the proof, observe that, by Lemma A.2, we only need to show that (A.13) has a solution. Treating $t_{L H}^{* *}$ as a parameter, Berge's maximum theorem (Aliprantis and Border 2006, Theorem 17.31) implies that the solutions to (A.17) as $t_{L H}^{* *}$ varies are described by an upper hemicontinuous correspondence $\varpi_{L}^{* *}:[0,1] \rightarrow B_{L_{\infty}(\mathbf{P})}$ with nonempty compact values. Thus, by Lemma A.3, (A.13) reduces to maximizing a continuous function of $\left(t_{L H}^{* *}, \pi_{L}^{* *}\right)$ over $\left\{\left(t_{L H}^{* *}, \pi_{L}^{* *}\right): t_{L H}^{* *} \in[0,1]\right.$ and $\pi_{L}^{* *} \in$ $\left.\varpi_{L}^{* *}\left(t_{L H}^{* *}\right)\right\}$, which is a nonempty compact set by the closed graph theorem (Aliprantis and Border 2006, Theorem 17.11). The result follows.

We are now ready to characterize the solutions to (A.17).

Lemma A. 5 Under Assumption 2, problem (A.17) has a solution of the form (23).

Proof. We distinguish two cases.

Case 1 If constraint (18) is slack at the optimum, then (A.17) reduces to finding an optimal mechanism for type $L$ alone, as described in Section 3. Proposition 1 yields that this mechanism is given (up to a $\mathbf{P}$-null set) by

Case 2 If constraint (18) is binding at the optimum, that is, according to Case 1, if condition (15) does not hold, then

Our convention on the constraints (16) and (18) allows us to replace expectations in (A.21) by integrals, yielding the equivalent problem

\max \left\{\left(t_{L}^{h}-t_{H}^{a}\right) \int_{t_{L H}^{* *}}^{1} \pi_{L}(\theta) f(\theta) \mathrm{d} \theta:\right. & \int_{t_{L H}^{* *}}^{1} \theta\left[1-\pi_{L}(\theta)\right] f(\theta) \mathrm{d} \theta \geq t_{L}^{a} \int_{t_{L H}^{* *}}^{1}\left[1-\pi_{L}(\theta)\right] f(\theta) \mathrm{d} \theta \\
& \text { and } \left.\int_{t_{L H}^{* *}}^{1} \theta \pi_{L}(\theta) f(\theta) \mathrm{d} \theta=t_{H}^{a} \int_{t_{L H}^{* *}}^{1} \pi_{L}(\theta) f(\theta) \mathrm{d} \theta\right\}
\end{aligned}
$$

where the maximum is taken over the set $S$ defined by (A.19). Because $S$ is convex and the objective function as well as the constraints are affine in $\pi_{L}$, this equivalent problem is convex. Therefore, by the Kuhn-Tucker theorem (Clarke 2013, Theorem 9.4), for any solution $\pi_{L}^{* *}$ to this problem, which by construction is a solution to (A.21) and (A.17), there exists a vector of Lagrange multipliers $\left(\eta^{* *}, \lambda^{* *}, \mu^{* *}\right)$ such that the following properties are satisfied:

where $h^{*}$ is the affine function defined by

h^{* *}(\theta) \equiv \eta^{* *}\left(t_{L}^{h}-t_{H}^{a}\right)+\lambda^{* *} t_{L}^{a}+\mu^{* *} t_{H}^{a}-\left(\lambda^{* *}+\mu^{* *}\right) \theta

4. Complementary slackness:

\lambda^{* *}\left\{\int_{t_{L H}^{* *}}^{1} \theta\left[1-\pi_{L}^{* *}(\theta)\right] f(\theta) \mathrm{d} \theta-t_{L}^{a} \int_{t_{L H}^{* *}}^{1}\left[1-\pi_{L}^{* *}(\theta)\right] f(\theta) \mathrm{d} \theta\right\}=0 \tag{A.25}
\end{equation*}
$$

We distinguish four subcases.
Subcase 2.1 If $h^{* *}(\theta)>0$ for all $\theta \in\left(t_{L H}^{* *}, 1\right)$, then the objective function in (A.24) is uniquely (up to a $\mathbf{P}$-null set) maximized over $S$ by

We claim that $\lambda^{* *}+\mu^{* *}>0$. Indeed, if $\lambda^{* *}+\mu^{* *}<0$, then the objective function in (A.24) is uniquely (up to a $\mathbf{P}$-null set) maximized over $S$ by

so that

Now, given (A.28), (16) requires

However, we know from Lemma A. 2 that any solution to (A.13) and, hence, to (A.17) and (A.21), is also a solution to (20). In particular, given (A.27), (17) requires

Applying (A.23) yet again, we obtain $t_{H}^{a} \geq t_{L}^{h}$, with equality if and only if $\lambda^{* *}=0$. Hence this subcase cannot arise under Assumption 2. The result follows.

Proposition 3 is then an immediate consequence of Lemma A.5. Hence the result.
Proof of Lemma 3. We solve (A.13) for the optimal cutoffs $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ - the existence of which we established in Proposition 3-under the assumption that the individually optimal mechanisms with cutoffs $t_{H}^{*}$ and $t_{L}^{*}$ are not simultaneously implementable, that is, (15) does not hold. We first claim that we can restrict attention to cutoffs $\left(t_{L H}, t_{L}\right)$ such that $t_{L} \geq t_{L}^{*}$. To prove this claim, we distinguish two cases. If $t_{L}^{*}>t_{L}^{h}$, then (16) is satisfied if and only if $t_{L} \geq t_{L}^{*}$. If $t_{L}^{*}=t_{L}^{h}$, then, for any given $t_{L H}$, any cutoff $t_{L}<t_{L}^{h}$ would induce an inefficiently high rate of abstinence for type $L$ and would tighten (18) compared to $t_{L}=t_{L}^{h}$; hence an optimal cutoff $t_{L}$ must satisfy $t_{L} \geq t_{L}^{h}$, which is IC as $t_{L}^{h}=t_{L}^{*}$. The claim follows. Replacing expectations in (A.13) by integrals then yields the equivalent problem

\max \left\{p_{L} \beta_{L} \int_{0}^{t_{L}}\left(t_{L}^{h}-\theta\right) f(\theta) \mathrm{d} \theta+p_{H} \beta_{H} \int_{0}^{t_{L H}}\left(t_{H}^{h}-\theta\right) f(\theta) \mathrm{d} \theta\right\}, \tag{A.30}
\end{equation*}
$$

subject to the constraints

$$
\begin{align*}
\int_{t_{L H}}^{t_{L}}\left(\theta-t_{H}^{a}\right) f(\theta) \mathrm{d} \theta & \geq 0,  \tag{А.31}\\
t_{L}-t_{L}^{*} & \geq 0,  \tag{A.32}\\
1-t_{L} & \geq 0 . \tag{А.33}
\end{align*}
$$

The objective function in (A.30) is continuous in $\left(t_{L H}, t_{L}\right)$ and the feasible set defined by $\left(t_{L H}, t_{L}\right) \in[0,1]^{2}$ and (A.31)-(A.33) is nonempty and compact. Hence problem (A.30)-(A.33) has a solution $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$. The proof consists of four steps.

Step 1 We first show that $t_{L}^{* *}>t_{H}^{a}>t_{L H}^{* *} \geq t_{H}^{h}$ in any solution $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ to (A.30)-(A.33). That $t_{L}^{* *}>t_{H}^{a}$ follows from our preliminary observation that $t_{L} \geq t_{L}^{h}$ along with Assumption 2. As for $t_{L H}^{* *}$, suppose, by way of contradiction, that $t_{L H}^{* *} \geq t_{H}^{a}$. Because $t_{L}^{* *}>t_{H}^{a}$, we have

Hence lowering $t_{L H}^{* *}$ to a value $t_{H}^{a}-\varepsilon$ for some small $\varepsilon>0$ would preserve (A.31) and strictly increase the objective in (A.30), a contradiction. Thus $t_{H}^{a}>t_{L H}^{* *}$, as claimed. The proof that $t_{L H}^{* *} \geq t_{H}^{h}$ is similar, observing that the left-hand side of (A.31) is strictly increasing in $t_{L H} \in\left[0, t_{H}^{a}\right]$ and the objective function in (A.30) is strictly increasing in $t_{L H} \in\left[0, t_{H}^{h}\right]$.

Step 2 We next verify that the constraints (A.31)-(A.33) satisfy the Mangasarian-Fromovitz qualification conditions at $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ (Mangasarian 1969, 11.3.5). Letting $g$ be the mapping defined by the left-hand sides of the binding constraints at $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$, we must prove that

has a solution $z \in \mathbb{R}^{2}$, where $\nabla g\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ is the Jacobian matrix of $g$ at $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$. This is obvious if (A.31) is not binding. If (A.31) is binding, then the first line of $\nabla g\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ is

\mathrm{D} g_{1}\left(t_{L H}^{* *}, t_{L}^{* *}\right) \equiv\left(\left(t_{H}^{a}-t_{L H}^{* *}\right) f\left(t_{L H}^{* *}\right) \quad\left(t_{L}^{*}-t_{H}^{a}\right) f\left(t_{L}^{* *}\right)\right) .

We shall exploit the fact that $f$ is strictly positive over $(0,1)$. Notice first that, because $t_{H}^{a}>$ $t_{L H}^{* *} \geq t_{H}^{h}$ by Step 1, we always have $\left(t_{H}^{a}-t_{L H}^{* *}\right) f\left(t_{L H}^{* *}\right)>0$. If only (A.31) is binding, then $1>t_{L}^{* *}>t_{H}^{a}$ by Step 1 , so that $\left(t_{L}^{*}-t_{H}^{a}\right) f\left(t_{L}^{* *}\right)>0$ and

We can then take any $z \in \mathbb{R}_{++}^{2}$. Next, if (A.31) and (A.32) are binding, then $t_{L}^{* *}=t_{L}^{*}$, so that $\left(t_{L}^{*}-t_{H}^{a}\right) f\left(t_{L}^{* *}\right)>0$ and

We can then take any $z \in \mathbb{R}_{++}^{2}$. Finally, if (A.31) and (A.33) are binding, then it is optimal to have $t_{L H}^{* *}=t_{H}^{*}$ by Proposition 1, and

We can then take $z=(1, \varepsilon)$ for some small enough $\varepsilon<0$.

Step 3 According to Step 2, constraints (A.31)-(A.33) are qualified at any solution $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ to (A.30)-(A.33). Therefore, by the Kuhn-Tucker necessary optimality conditions for nonconvex optimization problems (Mangasarian 1969, 11.3.6), there exists a vector of Lagrange multipliers $\left(\zeta^{* *}, \nu^{* *}, \chi^{* *}\right)$ such that the following properties are satisfied:

1. Positivity:

3. Complementary slackness:

We distinguish three cases.

Case 1 Suppose first that (A.32) is binding, so that $t_{L}^{* *}=t_{L}^{*}$ and $\chi^{* *}=0$ by (A.39), and suppose further, by way of contradiction, that $\zeta^{* *}=0$. Then, by (A.36) along with the fact that $f\left(t_{L H}^{* *}\right)>0$ as $t_{H}^{a}>t_{L H}^{* *} \geq t_{H}^{h}$ by Step 1 and $f$ is strictly positive over $(0,1)$, we must have $t_{L H}^{* *}=t_{H}^{h} \leq t_{H}^{*}$. Therefore, using the assumption that the individually optimal mechanisms with cutoffs $t_{H}^{*}$ and $t_{L}^{*}$ are not simultaneously implementable, we obtain

Because $\zeta^{* *}>0$ and $t_{L}^{*} \geq t_{L}^{h}>t_{H}^{a}$, (A.41) implies $t_{L}^{*}>t_{L}^{h}$. Hence the bracketed terms in (A.41) are different from zero. Moreover, because the bracketed terms in (A.42) cannot simultaneously be zero, none of them can be zero. Because $t_{H}^{h} \leq t_{L H}^{* *}<t_{H}^{a}$ by Step 1, we can thus divide (A.42) by (A.41), which yields

We must have $\zeta^{* *}>0$ and, hence, by (A.37), (A.31) must be binding, for, otherwise, by (A.48)-(A.49), we would have $t_{L H}^{* *}=t_{H}^{h}$ and $t_{L}^{* *}=t_{L}^{h}$, so that the individually unconstrainedoptimal mechanisms for types $H$ and $L$ would be simultaneously implementable, a contradiction. That is, $\left(t_{L H}^{* *}, t_{L}^{* *}\right)$ must satisfy

Because $t_{L}^{*}>t_{H}^{a}$ and $\mathbf{E}\left[\theta \mid t_{H}^{*} \leq \theta<t_{L}^{*}\right]<t_{H}^{a}$ as the individually optimal mechanisms with cutoffs $t_{H}^{*}$ and $t_{L}^{*}$ are not simultaneously implementable, $t_{L}^{*} \in \mathcal{T}_{L}$. Because $\mathbf{E}\left[\theta \mid t_{H} \leq \theta<t_{L}\right]$ is strictly increasing in $t_{H}$ and $t_{L}, \mathcal{T}_{L}$ is thus an interval $\left[t_{L}^{*}, \sup \mathcal{T}_{L}\right]$, and there exists a unique strictly decreasing function $\hat{t}_{L H}: \mathcal{T}_{L} \rightarrow\left[0, t_{H}^{a}\right)$ implicitly defined by

we have $\kappa\left(t_{L}^{*}\right) \leq 0, \kappa(1) \geq 0$, and $\kappa\left(t_{L}^{* *}\right)=0$ in Cases 1,2 , and 3 , respectively. To conclude, we
only need to show that these cases are mutually exclusive. For this, we only need to show that $\kappa$ crosses zero only once, from above. Indeed, if $\kappa\left(t_{L}\right)=0$, then

& <-\frac{p_{H} \beta_{H}}{p_{L} \beta_{L}} \frac{\hat{t}_{L H}\left(t_{L}\right)-t_{H}^{h}}{\left(t_{L}-t_{L}^{h}\right)^{2}}+\frac{t_{H}^{a}-\hat{t}_{L H}\left(t_{L}\right)}{\left(t_{L}-t_{H}^{a}\right)^{2}} \\
& =\frac{\left[t_{H}^{a}-\hat{t}_{L H}\left(t_{L}\right)\right]\left(t_{H}^{a}-t_{L}^{h}\right)}{\left(t_{L}-t_{L}^{h}\right)\left(t_{L}-t_{H}^{a}\right)^{2}} \\
& <0, \tag{А.57}
\end{align*}

where the first inequality follows from (A.55), the second equality follows from (A.56) along with $\kappa\left(t_{L}\right)=0$, and the second inequality follows from Assumption 2. Thus Case 1 occurs if and only if $\kappa\left(t_{L}^{*}\right) \leq 0$, so that $\kappa\left(t_{L}\right)<0$ for all $t_{L}>t_{L}^{*}$, Case 2 occurs if and only if $\kappa(1) \geq 0$, so that $\kappa\left(t_{L}\right)>0$ for all $t_{L}<1$, and Case 3 occurs if and only if $\kappa\left(t_{L}^{*}\right)>0$ and $\kappa(1)<0$, so that $\kappa\left(t_{L}\right)$ changes sign from positive to negative only at $t_{L}=t_{L}^{* *}$. The result follows.

Proof of Corollary 4. The proof consists of three steps.

Step 1 Consider first the boundary $\underline{p}$, starting with the case $t_{L}^{*}>t_{L}^{h}$. Define the function $\hat{t}_{L H}$ as in (A.53). By Assumption 2, $t_{L}^{*}>t_{H}^{a}$, and, by construction, $\hat{t}_{L H}\left(t_{L}^{*}\right)<t_{H}^{a}$. Moreover, because the individually optimal mechanisms with cutoffs $t_{H}^{*}$ and $t_{L}^{*}$ are not simultaneously implementable, $\hat{t}_{L H}\left(t_{L}^{*}\right)>t_{H}^{*}$ and thus $\hat{t}_{L H}\left(t_{L}^{*}\right)>t_{H}^{h}$. if and only if $p_{H} \in[0, \underline{p}]$. Defining $\kappa$ as in (A.56), we thus have $\kappa\left(t_{L}^{*}\right) \leq 0$ for any such $p_{H}$. It then follows from Step 4 of the proof of Lemma 3 that $\left(t_{L H}^{* *}, t_{L}^{* *}\right)=\left(\hat{t}_{L H}\left(t_{L}^{*}\right), t_{L}^{*}\right)$. We have thus proven that, if $t_{L}^{*}>t_{L}^{h}$, there exists $\underline{p} \in(0,1)$ such that, for all $p_{H} \in(0, \underline{p}]$, type $L$ faces his individually optimal mechanism. To complete the proof, we only need to check that if $t_{L}^{*}=t_{L}^{h}$ and type $L$ faces his individually optimal mechanism, so that $t_{L}^{* *}=t_{L}^{*}=t_{L}^{h}$, then it must be that $p_{H}=0$, in which case we can set $\underline{p} \equiv 0$ by convention. Indeed, from (A.41) in Case 1 of the proof of Lemma 3, if we impose the constraint (A.31), which is relevant only if $p_{H}>0$, then $\zeta^{* *}>0$, and $t_{L}^{* *}=t_{L}^{*}$ implies $t_{L}^{*}>t_{L}^{h}$. Step 2 Consider next the boundary $\bar{p}$, starting with the case $t_{H}^{*}>t_{H}^{h}$. Then

We have thus proven that, if $t_{H}^{*}>t_{H}^{h}$, there exists $\bar{p} \in(0,1)$ such that, for all $p_{H} \in[\bar{p}, 1)$, type $H$ faces his individually optimal mechanism. To complete the proof, we only need to check that if $t_{H}^{*}=t_{H}^{h}$ and type $H$ faces his individually optimal mechanism, so that $t_{L H}^{* *}=t_{H}^{*}=t_{H}^{h}$, then it must be that $p_{H}=1$, in which case we can set $\bar{p} \equiv 1$ by convention. \frac{p_{H} \beta_{H}}{p_{L} \beta_{L}} \frac{\hat{t}_{L H}\left(t_{L}^{*}\right)-t_{H}^{h}}{t_{L}^{*}-t_{L}^{h}}>\frac{t_{H}^{a}-\hat{t}_{L H}\left(t_{L}^{*}\right)}{t_{L}^{*}-t_{H}^{a}} \text { and } \frac{p_{H} \beta_{H}}{p_{L} \beta_{L}} \frac{t_{H}^{*}-t_{H}^{h}}{1-t_{L}^{h}}<\frac{t_{H}^{a}-t_{H}^{*}}{1-t_{H}^{a}}
$$

if and only if $p_{H} \in(\underline{p}, \bar{p})$. Defining $\kappa$ as in (A.56), we thus have

Let us accordingly denote by $\hat{t}_{L}\left(p_{H}\right)$ the unique solution to (A.58). We clearly have $\mathrm{D}_{p_{H}} \kappa\left(p_{H}, t_{L}\right)>0$ and, from (A.57), $\mathrm{D}_{t_{L}} \kappa\left(p_{H}, t_{L}\right)<0$ if $\kappa\left(p_{H}, t_{L}\right)=0$. Hence the result.

Proof of Proposition 4. By Proposition 3, if Assumption 2 holds, then there exists an optimal IC joint mechanism of the form (27) with $\bar{t}_{L}^{* *}=1$. Suppose then that Assumption 2 does not hold. The result is immediate if we are in Case 1 or Subcases 2.1-2.3 of Lemma A.5; note, incidentally, that we can be in Subcase 2.2 , which, according to Lemma 3, cannot arise under Assumption 2. There remains to consider Subcase 2.4 of Lemma A.5, in which the affine function $h^{* *}$ is identically zero over $\left(t_{L H}^{* *}, 1\right)$.

Case 1 We first assume that $t_{H}^{a}>t_{L}^{h}$. Then, by arguments already invoked, $\lambda^{* *}>0$ and, by (A.25), any solution $\pi_{L}^{* *}$ to (A.17) must satisfy (A.26) and

Case 2 The proof for the limiting case $t_{H}^{a}=t_{L}^{h}$ or, equivalently, $\beta_{H}=\beta_{H}^{n o}\left(\beta_{L}\right)$, relies on a simple continuity argument. From the proof of Lemma A.4, for each $\beta_{H} \geq \beta_{H}^{n o}\left(\beta_{L}\right)$, any solution to (A.13) for $\beta_{H}$ can be represented by a pair $\left(t_{L H}^{* *}\left(\beta_{H}\right), \pi_{L}^{* *}\left(\beta_{H}\right)\right) \in[0,1] \times B_{L_{\infty}(\mathbf{P})}$. We can with no loss of generality assume that this sequence converges. For each $n \in \mathbb{N}$, we have $\beta_{H, n}>\beta_{H}^{n o}\left(\beta_{L}\right)$ and, hence,

\end{align*}

where the first equality follows from the fact that the sequence $\left(\pi_{L}^{* *}\left(\beta_{H, n}\right)\right)_{n \in \mathbb{N}}$ converges in $B_{L_{\infty}(\mathbf{P})}$ to $\pi_{L}^{* *}\left(\beta_{H}^{n o}\left(\beta_{L}\right)\right)$, using the definition of the weak* topology $\sigma\left(L_{\infty}(\mathbf{P}), L_{1}(\mathbf{P})\right)$, the second equality follows from (A.66), and the third inequality follows from the fact that the sequence $\left(t_{L H}^{* *}\left(\beta_{H, n}\right)\right)_{n \in \mathbb{N}}$ converges to $t_{L H}^{* *}\left(\beta_{H}^{n o}\left(\beta_{L}\right)\right)$ in $[0,1]$ and that $F$ is continuous as $\mathbf{P}$ is nonatomic. Because $F$ is strictly increasing as $\mathbf{P}$ has full support, (A.67) implies that the sequence $\left(t_{L}^{* *}\left(\beta_{H, n}\right)\right)_{n \in \mathbb{N}}$ converges to some limit $t_{\infty}$. To complete the proof, notice that, for any Borel subset $A$ of $[0,1]$,

Proof of Proposition 5. The proof consists in transforming our model into one to which the results of Kolotilin et al. (2017) can be adapted, and then to apply those results to characterize the optimal mechanism.

First, because the date-0 and date- 1 selves share the same $\beta$ and the same information about $\theta$, the optimal consumption decisions $x_{0}$ and $x_{1}$ must coincide in our model, $x_{0}=x_{1}=x$. Second, we may identify the receiver as each self of the DM, with decision utility

Similarly, the multiplicative factor $\frac{1}{t^{a}}$ does not affect the receiver's optimization problem, and can be omitted from its objective function $u$. However, as the sender does not know $t^{a}$, we cannot omit the multiplicative factor $\frac{1}{t^{a}}$ from her objective function $v$ without implicitly changing the weight she puts on each private type. ${ }^{4}$ We instead rescale $v$ with a multiplicative factor $1+\delta$. With a slight abuse of notation, we continue to denote the resulting transformed utilities by $u$ and $v$, and obtain

These final expressions depend on $\beta$ only through $t^{a}$. Now, the only differences with the persuasion problem studied in Kolotilin et al. (2017) are that $t^{a}$ is distributed on $\left[t_{0}, 1\right]$ rather than on $[0,1]$, and that there is an additional factor $\rho\left(t^{a}\right)$ in the first summand of $v\left(a, \theta, t^{a}\right)$. The following result is a modification of their Lemma 2, accounting for these changes.

The first term on the right-hand side of (A.71) is zero as $\rho$ and, hence, $\tilde{h}$ vanish at $t_{0}=\frac{1}{\delta^{2} C}$, while the second term can be rewritten using

To derive an optimal mechanism, it is key to understand the sign pattern of the function $J$ defined in Lemma A.6. The following result provides sufficient conditions for $J$ to be either always nonnegative or to cross zero at most once, from above.

Clearly, if $h^{\prime}\left(t_{0}\right)>0$, then $J>0$ in an open right-neighborhood of $t_{0}$. Similarly, if $h(1)=0$ and $h^{\prime}(1)<0$, then $J(1)<0$. In the latter case, the existence of a $t_{1} \in\left(t_{0}, 1\right)$ such that $J\left(t_{1}\right)=0$ follows from the intermediate value theorem. To conclude the proof, it thus remains to show that there can be at most one $t_{1} \in\left(t_{0}, 1\right)$ such that $J\left(t_{1}\right)=0$. We need to ensure that the term in square brackets in (A.72) crosses zero at most once, from above. Rearranging the condition that this term equal zero yields

$$
\begin{equation*}
-\frac{h^{\prime}\left(t^{a}\right)}{h\left(t^{a}\right)}=\frac{(1+\delta) t^{a}+\frac{1}{\delta C}}{\delta t^{a}\left(t^{a}-t_{0}\right)} . \tag{A.73}
\end{equation*}
$$

Because $h$ is log-concave, the left hand-side of (A.73) is nondecreasing. Thus, because the right-hand side of (A.73) is strictly decreasing, we obtain that (A.73) can have at most one solution over $\left(t_{0}, 1\right)$. The result follows.

By Kolotilin et al. (2017, Theorem 1), the receiver's utility profile $U^{x}$ is implementable by a mechanism $x$ if and only if $U^{x}$ is a convex function that lies between his utility profiles from full information and no information. With no information, the receiver abstains if and only if
$\mathbf{E}[\theta] \geq t^{a}$, in which case he obtains (abstention) utility $\mathbf{E}[\theta]-t^{a}$. His utility profile from no information is thus given by $\underline{U}\left(t^{a}\right) \equiv \max \left\{\mathbf{E}[\theta]-t^{a}, 0\right\}$. With full information, the receiver abstains if and only if $\theta \geq t^{a}$, in which case he obtains (abstention) utility $\theta-t^{a}$. His utility profile from full information is thus given by $\bar{U}\left(t^{a}\right) \equiv\left[1-F\left(t^{a}\right)\right] \mathbf{E}\left[\theta-t^{a} \mid \theta \geq t^{a}\right]$. Clearly, $\underline{U}$ and $\bar{U}$ are nonincreasing convex functions that satisfy $\underline{U} \leq \bar{U}, \underline{U}\left(t_{0}\right)=\bar{U}\left(t_{0}\right)$, and $\underline{U}(1)=\bar{U}(1)$. Designing the optimal mechanism boils down to finding a convex function $U^{x}$ that maximizes the right-hand side of (A.70) subject to the constraint $\underline{U} \leq U^{x} \leq \bar{U}$.

To complete the proof, we follow Kolotin et al. (2017, Section 4.2), in particular the discussion below their Theorem 2 and their Example 1, which treats the case where $J$ switches signs at most once, from positive to negative. They argue that the optimal utility profile $U^{x}$ must be piecewise linear wherever it does not coincide with the upper bound $\bar{U}$. If $J$ is everywhere nonnegative, the optimal $U^{x}$ satisfies $U^{x}=\bar{U}$, so that a full-information signal is optimal. If $J$ switches sign once, from positive to negative, they show that there exists $\tilde{t} \in\left(t_{0}, 1\right]$ such that the optimal $U^{x}$ satisfies $U^{x}\left(t^{a}\right)=\bar{U}\left(t^{a}\right)$ for $t^{a} \leq \tilde{t}$. For $t^{a}>\tilde{t}, U_{1}^{x}$ continues as a tangent, that is, it is piecewise linear with slope $\bar{U}^{\prime}(\tilde{t})$ until it hits $\underline{U}$, after which it coincides with $\underline{U}$. This choice of $U^{x}$ corresponds to a mechanism that fully discloses each $\theta<\tilde{t}$, whereas all $\theta \geq \tilde{t}$ are pooled into a red warning. As a result, DMs with high self-control, $t^{a} \leq \tilde{t}$, consume whenever it is optimal for them to do so. DMs with intermediate self-control, $t^{a} \in(\tilde{t}, \mathbf{E}[\theta \mid \theta \geq \tilde{t}]]$, abstain from consuming whenever they observe a red warning, which leaves them to abstain more often than under full information. Finally, DMs with $t^{a}>\mathbf{E}[\theta \mid \theta \geq \tilde{t}]$ have so little self-control that they always consume and obtain (abstention) utility 0 . Hence the result.

Indeed, in that case, the distribution of $\theta$ conditional on $\theta \geq t$ is approximately uniform when $t$ is close to 1 as $f$ is continuous, and, hence, a marginal increase $\mathrm{d} t$ in $t$ increases $\mathbf{E}[\theta \mid \theta \geq t]$ by approximately $\mathrm{d}\left[\frac{1}{2}(t+1)\right]=\frac{1}{2} \mathrm{~d} t$.

[^3]:    ${ }^{3}$ We keep the multiplicative constant $t_{L}^{h}-t_{H}^{a}$, which is strictly positive under Assumption 2, in order to make Lemma A. 5 relevant when this assumption does not hold, as in Proposition 4.
