IS THE COARSE-TO-FINE PROCESSING OF FEARFUL FACE IMPAIRED IN AUTISM? The dissociation between the neural and the behavioral response

INTRODUCTION

- Visual perception is thought to be coarse-to-fine, with early processing of global information from low spatial frequencies, followed by detailed information processing from high spatial frequencies (Figure 1)¹.
- Autistic individuals have a visual perception more oriented toward local information, which might partly explain their difficulties in face processing at the behavioral level².
- However, electrophysiological investigation of spatial frequency processing of faces in autistic children lead to



• Conditions : Coarse-to-Fine (CtF; from low to high spatial frequencies) and Fine-to-Coarse (FtC; from high to Low Spatial Frequencies)

mixed results ^{3,4} and no study investigated it in autistic adults.



Figure 1 : Coarse-to-fine model of visual perception. Fast extraction of LSF and their projection onto the orbitofrontal cortex, through the dorsal visual stream, enables predictions. Later integration of HSF through the ventral visual stream enables recognition. Predictions might be reduced in autism.

- Investigation of the **electrophysiological** response (P100, N170) and the **behavioral** response (d', response time)
- **Participants**: 51 typically developped participants (27 females) and 44 autistic participants (22 females) were recruited, matched on age (Mean Age = 30) and IQ (mean Full Scale IQ = 117).



- Local bias in the visual perception of autistic adults would disrupt the coarse-to-fine processing of emotional faces (electrophysiological level)
- This would lead to emotion recognition impairment (behavioral level)



Hypothese :

Figure 3 : Autistic individuals response time had longer TD .001) than (p < (particularly females) and lower d'. CtF sequences lead than FtC lower to ď sequences.

Figure 5 : FtC sequences elicited larger (p < .001) and faster (p < .001) N170 than CtF sequences. Females had faster N170 than males (p = .003).

- Electrophysiological data are consistent with coarse-to-fine processing of fearful faces: there is a faster P100 for CtF sequences, in line with early processing of LSF, whereas the N170, a slightly later component, is faster and larger for FtC sequences.
- Contrary to our hypothesis, CtF processing seems intact in autistic adults, despite impaired fearful detection (longer response time, lower d').

→ Findings suggest that difficulties for autistic adults to process emotionnal faces are related to higher order processing than primary visual processing.
