# Uniform Poincaré inequalities for the Discrete de Rham complex on general domains

#### Abstract

In this paper we prove Poincaré inequalities for the Discrete de Rham (DDR) sequence on a general connected polyhedral domain $\Omega$ of $\mathbb{R}^{3}$. We unify the ideas behind the inequalities for all three operators in the sequence, deriving new proofs for the Poincaré inequalities for the gradient and the divergence, and extending the available Poincaré inequality for the curl to domains with arbitrary second Betti numbers. A key preliminary step consists in deriving "mimetic" Poincaré inequalities giving the existence and stability of the solutions to topological balance problems useful in general discrete geometric settings. As an example of application, we study the stability of a novel DDR scheme for the magnetostatics problem on domains with general topology.

## 1 Introduction

Poincaré inequalities are a key tool to prove the well-posedness of many common partial differential equation problems. Mimicking them at the discrete level is typically required for the stability of numerical approximations. Poincaré inequalities for conforming Finite Element de Rham complexes can be derived through bounded cochain projections as described, e.g., in [2, Chapter 5]; see also [14] for a recent generalisation. In the context of Virtual Element de Rham complexes [4], similar results typically hinge on non-trivial norm comparison results, examples of which can be found in [5]. Discrete Poincaré-type inequalities in the context of the (non-compatible) Hybrid High-Order methods have been derived, e.g., in [18] (gradient), [10] (symmetric gradient) and [13, 21] (curl).

The focus of the present work is on the derivation of Poincaré inequalities for the Discrete de Rham (DDR) sequence of [16] on domains with general topology. Unlike Finite and Virtual Elements, DDR formulations are fully discrete, with spaces spanned by vectors of polynomials and continuous vector calculus operators replaced by discrete counterparts. Discrete Poincaré inequalities thus require to bound $L^{2}$-like norms of vectors of polynomials with $L^{2}$-like norms of suitable discrete operators applied to them. To establish such bounds, we take inspiration from [19], where it was noticed that the topological information is fully contained in the lowest-order DDR subsequence, and [17], where a Poincaré inequality for the curl on topologically trivial domains of $\mathbb{R}^{3}$ was derived. The lowest-order DDR sequence is strongly linked to Mimetic Finite Differences and related methods [6, 8, 9, 11, 12, 15]. The first step to prove discrete Poincaré inequalities in DDR spaces is thus precisely to establish the mimetic counterparts stated in Theorems 4, 6, and 7 below. Their proofs require to work at the global level, with conditions accounting for the topology of the domain appearing for the curl. The discrete Poincaré
inequalities for arbitrary-order DDR spaces collected in Section 2.7 below are then obtained combining the mimetic Poincaré inequalities with local estimates of the higher-order components.

We next briefly discuss the links between the present work and previous results for DDR methods. Fully general Poincaré inequalities for the gradient and the divergence had already been obtained, respectively, in [16. Theorem 3] and [17] using different techniques. The main novelty of the proofs provided here is that they are better suited to generalisations in the framework of the Polytopal Exterior Calculus recently introduced in [7]. A Poincaré inequality for the curl on topologically trivial domains had been obtained in [17, Theorem 20]. The main novelty with respect to this result consists in the extension to domains encapsulating voids. The interest of the material in this paper is additionally that it contains preliminary results to establish discrete Poincaré inequalities for advanced complexes, such as the three-dimensional discrete div-div complex recently introduced in [20].

The rest of the paper is organized as follows. The definitions of the relevant DDR spaces and operators are briefly recalled in Section 2 . Mimetic Poincarés inequalities are derived in Section 3, and then used to prove discrete Poincarés inequalities for the DDR complex in Section 4 The latter are used in Section 5 to carry out the stability analysis of a DDR scheme for the magnetostatics problem on domains with general topology. Some arguments in the proofs of mimetic Poincaré inequalities rely on specific shape functions for Finite Element spaces on a submesh, whose definitions and properties are summarised in Appendix A

## 2 Discrete de Rham construction

### 2.1 Domain and mesh

Let $\Omega \subset \mathbb{R}^{3}$ denote a connected polyhedral domain. We consider a polyhedral mesh $\mathcal{M}_{h}:=\mathcal{T}_{h} \cup \mathcal{F}_{h} \cup$ $\mathcal{E}_{h} \cup \mathcal{V}_{h}$, where $\mathcal{T}_{h}$ gathers the elements, $\mathcal{F}_{h}$ the faces, $\mathcal{E}_{h}$ the edges, and $\mathcal{V}_{h}$ the vertices. For all $Y \in \mathcal{M}_{h}$, we denote by $h_{Y}$ its diameter and set $h:=\max _{T \in \mathcal{T}_{h}} h_{T}$. For each face $F \in \mathcal{F}_{h}$, we fix a unit normal $\boldsymbol{n}_{F}$ to $F$ and, for each edge $E \in \mathcal{E}_{h}$, a unit tangent $\boldsymbol{t}_{E}$. For $T \in \mathcal{T}_{h}, \mathcal{F}_{T}$ gathers the faces on the boundary $\partial T$ of $T$ and $\mathcal{E}_{T}$ the edges in $\partial T$; if $F \in \mathcal{F}_{h}, \mathcal{E}_{F}$ is the set of edges contained in the boundary $\partial F$ of $F$. For $F \in \mathcal{F}_{T}, \omega_{T F} \in\{-1,+1\}$ is such that $\omega_{T F} \boldsymbol{n}_{F}$ is the outer normal on $F$ to $T$.

Each face $F \in \mathcal{F}_{h}$ is oriented counter-clockwise with respect to $\boldsymbol{n}_{F}$ and, for $E \in \mathcal{E}_{F}$, we let $\omega_{F E} \in$ $\{-1,+1\}$ be such that $\omega_{F E}=+1$ if $t_{E}$ points along the boundary $\partial F$ of $F$ in the clockwise sense, and $\omega_{F E}=-1$ otherwise; we also denote by $\boldsymbol{n}_{F E}$ the unit normal vector to $E$, in the plane spanned by $F$, such that $\omega_{F E} \boldsymbol{n}_{F E}$ points outside $F$. We denote by $\operatorname{grad}_{F}$ and $\operatorname{div}_{F}$ the tangent gradient and divergence operators acting on smooth enough functions. Moreover, for any $r: F \rightarrow \mathbb{R}$ and $z: F \rightarrow \mathbb{R}^{2}$ smooth enough, we let $\operatorname{rot}_{F} r:=\left(\operatorname{grad}_{F} r\right)^{\perp}$ and $\operatorname{rot}_{F} z=\operatorname{div}_{F}\left(z^{\perp}\right)$, with $\perp$ denoting the rotation of angle $-\frac{\pi}{2}$ in the oriented tangent space to $F$.

We further assume that $\left(\mathcal{T}_{h}, \mathcal{F}_{h}\right)$ belongs to a regular mesh sequence in the sense of [18, Definition 1.9], with mesh regularity parameter $\varrho>0$. This implies that, for each $Y \in \mathcal{T}_{h} \cup \mathcal{F}_{h} \cup \mathcal{E}_{h}$, there exists a point $\boldsymbol{x}_{Y} \in Y$ such that the ball centered at $\boldsymbol{x}_{Y}$ and of radius $\varrho h_{Y}$ is contained in $Y$.

Throughout the paper, $a \lesssim b$ (resp., $a \gtrsim b$ ) stands for $a \leq C b$ (resp., $a \geq C b$ ) with $C$ depending only on $\Omega$, the mesh regularity parameter and, when polynomial functions are involved, the corresponding polynomial degree. We also write $a \simeq b$ when both $a \lesssim b$ and $b \lesssim a$ hold.

### 2.2 Polynomial spaces and $L^{2}$-orthogonal projectors

For any $Y \in \mathcal{M}_{h}$ and an integer $\ell \geq 0$, we denote by $\mathcal{P}^{\ell}(Y)$ the space spanned by the restriction to $Y$ of polynomial functions of the space variables. Let, for $Y \in \mathcal{T}_{h} \cup \mathcal{F}_{h}, \mathcal{P}^{\ell}(Y):=\mathcal{P}^{\ell}(Y)^{n}$ with $n$ denoting the dimension of $Y$. We have the following direct decompositions: For all $F \in \mathcal{F}_{h}$,

We extend the above notations to negative exponents $\ell$ by setting all the spaces appearing in the decompositions equal to the trivial vector space $\{\mathbf{0}\}$. Given a polynomial (sub)space $\mathcal{X}^{\ell}(Y)$ on $Y \in \mathcal{M}_{h}$, the corresponding $L^{2}$-orthogonal projector is denoted by $\pi_{X, Y}^{\ell}$. Boldface font will be used when the elements of $\boldsymbol{X}^{\ell}(Y)$ are vector-valued, and $\boldsymbol{\pi}_{\boldsymbol{X}, Y}^{\mathrm{c}, \ell}$ will denote the $L^{2}$-orthogonal projector on $\boldsymbol{X}^{\mathrm{c}, \ell}(Y)$.

### 2.3 DDR spaces

The discrete counterparts of the spaces appearing in the continuous de Rham complex are defined as follows:

Proof. See Section 4.3.

## 3 Mimetic Poincaré inequalities

This section contains Poincaré inequalities in mimetic spaces that are instrumental in proving the main results stated in the previous section. Their proofs rely on the use of a tetrahedral submesh $\mathfrak{M}_{h}=$ $\mathfrak{I}_{h} \cup \mathfrak{F}_{h} \cup \mathfrak{F}_{h} \cup \mathfrak{B}_{h}$ in the sense of [18, Definition 1.8], with $\mathfrak{I}_{h}$ collecting the tetrahedral subelements and $\mathfrak{F}_{h}, \mathfrak{E}_{h}$, and $\mathfrak{B}_{h}$ their faces, edges, and vertices, respectively. We assume, for the sake of simplicity, that this submesh can be obtained adding as new vertices only centers of the faces and elements of $\mathcal{M}_{h}$. As a result of the assumptions in [18, Definition 1.8], the regularity parameter of the submesh only depends on that of $\mathcal{M}_{h}$ and, for a given element $T \in \mathcal{T}_{h}$, the diameters of the submesh entities contained in $\bar{T}$ are comparable to $h_{T}$ uniformly in $h$.

### 3.1 Mimetic Poincaré inequality for collections of vertex values

Theorem 4 (Mimetic Poincaré inequality for collections of vertex values). Let $\left(\alpha_{V}\right)_{V \in \mathcal{V}_{h}} \in \mathbb{R}^{\mathcal{V}_{h}}$ be $a$ collection of values at vertices. Then, there is $C \in \mathbb{R}$ such that

with hidden constant only depending on $\Omega$ and the mesh regularity parameter.
Proof. We extend the collection $\left(\alpha_{V}\right)_{V \in \mathcal{V}_{h}}$ to $\mathfrak{B}_{h}$ setting the values at face/element centers equal to the value taken at an arbitrary vertex of the face/element in question.

For any simplex $S \in \mathfrak{I}_{h}$ and any vertex $V \in \mathfrak{B}_{S}$ (with $\mathfrak{B}_{S}$ collecting the vertices of $S$ ), let $\phi_{S, V}$ denote the restriction to $S$ of the piecewise affine "hat" function associated with $V$ given by (77), and let $\phi_{h} \in H^{1}(\Omega)$ be the piecewise polynomial function defined by setting

where $C \in \mathbb{R}$ is chosen so that the zero-average condition $\int_{\Omega} \phi_{h}=0$ is satisfied. We next prove the following norm equivalences:

The conclusion follows from the above relations writing
where the second inequality follows from the continuous Poincaré-Wirtinger inequality, which holds since $\int_{\Omega} \phi_{h}=0$.
(i) Proof of (13). For any $T \in \mathcal{T}_{h}$, by regularity of the submesh, we have $h_{S} \simeq h_{T}$ for all $S \in \mathfrak{I}_{T}$ (with
$\mathfrak{I}_{T}$ collecting the subelements contained in $T$ ). It holds

& \stackrel{82}{=} \sum_{T \in \mathcal{T}_{h}} h_{T}^{3} \sum_{S \in \mathfrak{I}_{T}} \sum_{V \in \mathfrak{B}_{S}}\left(\alpha_{V}-C\right)^{2} \\

where the second equivalence follows from the fact that $\operatorname{card}\left(\mathfrak{B}_{S}\right) \lesssim 1$, in the third one we have additionally used $h_{S} \simeq h_{T}$ for all $T \in \mathcal{T}_{h}$ and all $S \in \mathfrak{I}_{T}$, and the last one is justified by the choice we made at the beginning for $\alpha_{V}, V \in \mathfrak{B}_{h} \backslash \mathcal{V}_{h}$. This readily gives (13).
(ii) Proof of (14). The key argument to obtain (14) lies in the de Rham theorem: Let $\left(\psi_{S, E}\right)_{E \in \mathfrak{F}_{S}}$ (with $\overline{\mathfrak{F}}_{S}$ collecting the edges of $S$ ) be the basis for the edge Nédélec space given by (78). Then, summing (86), we have

Now, for any edge $E \in \mathfrak{F}_{S}$ of any simplex $S \in \mathfrak{I}_{T}$, either $E \in \mathcal{E}_{T}$ or, by the choice made at the beginning of this proof for $\alpha_{V}$ with $V$ face or element center, $\llbracket \alpha_{V} \rrbracket_{E}$ can be computed as the sum of jumps along the boundary of $T$ (i.e. $\llbracket \alpha_{V} \rrbracket_{E}=$ $\sum_{E^{\prime} \in \mathcal{E}_{T}} \omega_{E^{\prime} E} \llbracket \alpha_{V} \rrbracket_{E^{\prime}}$ for $\left.\omega_{E^{\prime} E} \in\{-1,0,1\}\right)$. Therefore,

### 3.2 Mimetic Poincaré inequality for collections of edge values

If the topology of the domain is non-trivial, a suitable condition for each void must be satisfied in order to establish a mimetic Poincaré inequality for collections of edge values. Denote by $b_{2}$ the second Betti number, i.e., the number of voids encapsulated by $\Omega$. Let $\left(\mathcal{F}_{\gamma_{i}}\right)_{1 \leq i \leq b_{2}}$ denote collections of boundary faces such that $\gamma_{i}:=\bigcup_{F \in \mathcal{F}_{\gamma_{i}}} \bar{F}$ is the boundary if the $i$ th void. We start by proving a necessary and sufficient condition under which a function in the lowest-order Raviart-Thomas-Nédélec face space on the tetrahedral submesh is the curl of a function in the edge Nédélec space on the same mesh.

Lemma 5 (Condition on the cohomology). Denote by $\mathcal{R T}^{1}\left(\mathfrak{I}_{h}\right)$ and $\mathcal{N}^{1}\left(\mathfrak{I}_{h}\right)$ lowest-order face and edge finite element spaces on the submesh. Then, for all $\boldsymbol{\phi}_{h} \in \mathcal{R} \mathcal{T}^{1}\left(\mathfrak{I}_{h}\right)$, there exists $\chi_{h} \in \mathcal{N}^{1}\left(\mathfrak{I}_{h}\right)$ such that $\boldsymbol{\phi}_{h}=\mathbf{c u r l} \chi_{h}$ if and only if

\end{equation*}
$$

with $\boldsymbol{n}_{\Omega}$ denoting the unit normal vector to the boundary of $\Omega$ pointing out of $\Omega$.

Proof. To check that 18 is necessary, notice that the first condition comes from the identity div curl = 0 , while the second one follows from Green's theorem along with the fact that the flux of the curl of any function across a closed boundary is zero.

We next prove that condition (18) is sufficient using a counting argument. From the de Rham Theorem, we know that that the dimension of the space of harmonic forms is precisely the number of voids $b_{2}$. For all integer $i$ such that $1 \leq i \leq b_{2}$, we define the linear form $L_{i}$ such that, for any vector-valued function $\phi$ smooth enough,

For any $1 \leq i \leq b_{2}$, let $\boldsymbol{x}_{i} \in \mathbb{R}^{3}$ be any point inside the $i$ th void and consider the function $\boldsymbol{\phi}_{i}: \mathbb{R}^{3} \ni \boldsymbol{x} \mapsto$ $\frac{\boldsymbol{x}-\boldsymbol{x}_{i}}{\left\|\boldsymbol{x}-\boldsymbol{x}_{i}\right\|^{3}} \in \mathbb{R}^{3}$. Noticing that div $\boldsymbol{\phi}_{i}=0$ and applying the divergence theorem inside the $j$ th void, we infer that $L_{j}\left(\boldsymbol{\phi}_{i}\right)=0$ if $j \neq i$. Let us now show that $L_{i}\left(\boldsymbol{\phi}_{i}\right)>0$. Let $r>0$ be the distance between $\boldsymbol{x}_{i}$ and $\Omega$. Denoting by $\mathcal{S}_{i}$ the sphere of radius $\frac{r}{2}$ centred in $x_{i}$, we have that $\int_{\mathcal{S}_{i}} \phi_{i} \cdot \frac{\left(x-x_{i}\right)}{\left\|x-x_{i}\right\|}=\int_{\mathcal{S}_{i}} 4 r^{-2}=4 \pi>0$. Applying once again the divergence theorem to $\phi_{i}$ on the volume $\mathcal{V}_{i}$ enclosed between $\mathcal{S}_{i}$ and $\gamma_{i}$, we have that $0=\int_{\mathcal{V}_{i}} \operatorname{div} \phi_{i}=L_{i}\left(\phi_{i}\right)-\int_{\mathcal{S}_{i}} \phi_{i} \cdot \frac{\left(x-x_{i}\right)}{\left\|x-x_{i}\right\|}$. Therefore,

Denoting by $\boldsymbol{\pi}_{\mathcal{R} \mathcal{T}, h}^{1}$ the canonical interpolator onto $\mathcal{R} \mathcal{T}^{1}\left(\mathfrak{I}_{h}\right)$, we know that, for any function $\boldsymbol{\phi}, \operatorname{div}\left(\boldsymbol{\pi}_{\mathcal{R} \mathcal{T}, h}^{1} \boldsymbol{\phi}\right)=$ $\pi_{\mathcal{P}, 0}^{h}(\operatorname{div} \boldsymbol{\phi})$ and $L_{i}\left(\boldsymbol{\pi}_{\mathcal{R} \mathcal{T}, h}^{1} \boldsymbol{\phi}\right)=L_{i}(\boldsymbol{\phi})$ by definition of the interpolator. Therefore, for any integer $i$ such that $1 \leq i \leq b_{2}, \boldsymbol{\pi}_{\mathcal{R T}, h}^{1} \boldsymbol{\phi}_{i}$ is a discrete harmonic form and, by a counting argument, the linearly independent family $\left(\boldsymbol{\pi}_{\mathcal{R T}, h}^{1} \boldsymbol{\phi}_{i}\right)_{1 \leq i \leq b_{2}}$ spans the space of discrete harmonic forms.

Let now $\boldsymbol{\phi}_{h}$ be such that $\operatorname{div} \boldsymbol{\phi}_{h}=0$. Then, $\boldsymbol{\phi}_{h}=\operatorname{curl} \chi_{h}+\sum_{i=1}^{b_{2}} \lambda_{i} \boldsymbol{\pi}_{\mathcal{R} \mathcal{T}, h}^{1} \boldsymbol{\phi}_{i}$ for some $\chi_{h} \in \mathcal{N}^{1}\left(\mathfrak{I}_{h}\right)$ and $\left(\lambda_{i}\right)_{1 \leq i \leq b_{2}} \in \mathbb{R}^{b_{2}}$. We prove that the condition $L_{i}(\phi)=0$ for all $1 \leq i \leq b_{2}$ is sufficient to ensure that $\phi_{h}$ is in the range of curl by contradiction. As a matter of fact, if this were not the case, then there would be $i_{0}$ such that $\lambda_{i_{0}} \neq 0$. However, by (19), this would also imply $L_{i_{0}}\left(\boldsymbol{\phi}_{h}\right)=\lambda_{i_{0}} L_{i_{0}}\left(\boldsymbol{\pi}_{\mathcal{R T}, h}^{1} \boldsymbol{\phi}_{i 0}\right) \neq 0$, which is the sought contradiction.

Theorem 6 (Mimetic Poincaré inequality for collections of edge values). Let $\left(\alpha_{F}\right)_{F \in \mathcal{F}_{h}} \in \mathbb{R}^{\mathcal{F}_{h}}$ be $a$ collection of values at faces satisfying

where $\omega_{\Omega F} \in\{-1,1\}$ is such that $\omega_{\Omega F} \boldsymbol{n}_{F}$ points outside the domain $\Omega$. Then, there is a collection $\left(\alpha_{E}\right)_{E \in \mathcal{E}_{h}} \in \mathbb{R}^{\mathcal{E}_{h}}$ of values at edges such that, for all $F \in \mathcal{F}_{h}$,

\sum_{E \in \mathcal{E}_{F}} \omega_{F E} \alpha_{E}=\alpha_{F} \text { and } \sum_{T \in \mathcal{T}_{h}} h_{T} \sum_{E \in \mathcal{E}_{T}} \alpha_{E}^{2} \lesssim \sum_{T \in \mathcal{T}_{h}} h_{T}^{-1} \sum_{F \in \mathcal{F}_{T}} \alpha_{F}^{2} \tag{21}
\end{equation*}
$$

with hidden constant only depending on $\Omega$ and the mesh regularity parameter.
Proof. Let $\left(\phi_{E, S}\right)_{S \in \mathfrak{I}_{h}, E \in \mathfrak{F}_{S}}$ and $\left(\psi_{F, S}\right)_{S \in \mathfrak{I}_{h}, F \in \mathfrak{F}_{S}}$ (with $\mathscr{F}_{S}$ denoting the set of triangular faces of $S$ ) be the families of basis functions respectively given by 78 and 79 below. The main difficulty is to extend the family $\left(\alpha_{F}\right)_{F \in \mathcal{F}_{h}}$ to a family $\left(\alpha_{F}\right)_{F \in \mathscr{F}_{h}}$ satisfying, for all $S \in \mathfrak{I}_{h}$,

\sum_{F \in \mathscr{F} S} \omega_{S F} \alpha_{F}=0
$$

We perform the construction locally on each element $T \in \mathcal{T}_{h}$. Let $g \in L^{2}(T)$ be the piecewise constant function on $\mathfrak{I}_{T}$ such that

Recalling (20), by definition we have $\int_{T} g=0$. Hence, using Lion's Lemma [1. Theorem 3.1.e], we infer the existence of $\boldsymbol{u} \in \boldsymbol{H}_{0}^{1}\left(T ; \mathbb{R}^{3}\right)$ such that

where the last inequality follows from the definition of $g$ after observing that $|S| \simeq h_{T}^{3}$ for all $S \in \mathfrak{I}_{T}$ by mesh regularity. Setting $\alpha_{F}:=\int_{F} \boldsymbol{u} \cdot \boldsymbol{n}_{F}$ (with $\boldsymbol{n}_{F}$ denoting the unit normal vector to $F$, with orientation consistent with that of $F$ ), for all $S \in \mathfrak{I}_{T}$ and all $F \in \mathscr{F}_{S} \backslash \mathcal{F}_{T}$. We infer that, for all $S \subset \mathfrak{I}_{h}$, $\sum_{F \in \mathscr{F}_{S}} \omega_{S F} \alpha_{F}=0$, noticing that

& \sum_{F \in \tilde{\mathscr{F}}_{S}} \omega_{S F} \alpha_{F}=\sum_{F \in \mathscr{\mathscr { F } S} \backslash \mathcal{F}_{T}} \omega_{S F} \alpha_{F}+\sum_{F \in \mathscr{\mathscr { F }} \cap \mathcal{F}_{T}} \omega_{S F} \alpha_{F} \\
& =\sum_{F \in \mathfrak{F}_{S}} \omega_{S F} \int_{F} \boldsymbol{u} \cdot \boldsymbol{n}_{F}+\sum_{F \in \mathfrak{F} S \cap \mathcal{F}_{T}} \omega_{S F} \alpha_{F} \\
& =\int_{S} \operatorname{div} \boldsymbol{u}+\sum_{F \in \tilde{\mathfrak{F} S} \cap_{T}} \omega_{S F} \alpha_{F} \\
& \text { [23), [22 }-\sum_{F \in \mathscr{\mathscr { F }} \cap \cap \mathcal{F}_{T}} \omega_{S F} \alpha_{F}+\sum_{F \in \mathscr{\mathscr { F }} \wedge^{\prime} \cap \mathcal{F}_{T}} \omega_{S F} \alpha_{F}=0,
\end{aligned}
$$

where we have used the fact that $\boldsymbol{u} \cdot \boldsymbol{n}_{F}=0$ on every face $F \in \mathcal{F}_{T}$ lying on the boundary of $T$ to obtain the second equality. Let $\overline{\boldsymbol{u}}_{T}:=\frac{1}{|T|} \int_{T} \boldsymbol{u}$ and, for all integer $i$ such that $1 \leq i \leq 3$, denote by $u_{i}$ and $\bar{u}_{i}$ the $i$ th components of $\boldsymbol{u}$ and $\overline{\boldsymbol{u}}_{T}$, respectively. It holds

|T| \bar{u}_{i}=\int_{T} u_{i}=\int_{T} \boldsymbol{u} \cdot \boldsymbol{e}_{i} & =\int_{T} \boldsymbol{u} \cdot \boldsymbol{\operatorname { g r a d }}\left(x_{i}-\boldsymbol{x}_{T} \cdot \boldsymbol{e}_{i}\right) \\
& =-\int_{T} \operatorname{div} \boldsymbol{u}\left(x_{i}-\boldsymbol{x}_{T} \cdot \boldsymbol{e}_{i}\right)=-\int_{T} g\left(x_{i}-\boldsymbol{x}_{T} \cdot \boldsymbol{e}_{i}\right) \lesssim h_{T} \sum_{F \in \mathcal{F}_{T}}\left|\alpha_{F}\right|,
\end{aligned}
$$

so that, recalling that $|T| \simeq h_{T}^{3}$,

$$
\begin{equation*}
\left\|\overline{\boldsymbol{u}}_{T}\right\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)} \lesssim h_{T}^{-\frac{1}{2}} \sum_{F \in \mathcal{F}_{T}}\left|\alpha_{F}\right| . \tag{24}
\end{equation*}
$$

Therefore, we can use the Poincaré inequality on the domain $T$ to write

\|\boldsymbol{u}\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)} & \leq\left\|\boldsymbol{u}-\overline{\boldsymbol{u}}_{T}\right\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)}+\left\|\overline{\boldsymbol{u}}_{T}\right\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)} \\
& \lesssim h_{T}|\boldsymbol{u}|_{\boldsymbol{H}^{1}\left(T ; \mathbb{R}^{3}\right)}+\left\|\overline{\boldsymbol{u}}_{T}\right\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)} \stackrel{[23),[24}{\lesssim} h_{T}^{-\frac{1}{2}} \sum_{F \in \mathcal{F}_{T}}\left|\alpha_{F}\right| .
\end{aligned}
$$

Combining this result with the continuous trace inequality we have, for all $S \in \mathfrak{I}_{T}$ and all $F \in \mathfrak{F}_{S} \backslash \mathcal{F}_{T}$,

\left|\alpha_{F}\right| \lesssim h_{F}\|\boldsymbol{u}\|_{\boldsymbol{L}^{2}\left(F ; \mathbb{R}^{3}\right)} \lesssim h_{T}^{\frac{1}{2}}\|\boldsymbol{u}\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)}+h_{T}^{\frac{3}{2}}|\boldsymbol{u}|_{\boldsymbol{H}^{1}\left(T ; \mathbb{R}^{3}\right)} \lesssim \sum_{F \in \mathcal{F}_{T}}\left|\alpha_{F}\right|
$$

Therefore, summing over all tetrahedra inside $T$ and all tetrahedral faces, we obtain

We next define the following piecewise polynomial function:

Since $\operatorname{div} \psi_{h}=0$ and, for all $1 \leq i \leq b_{2}, \sum_{F \in \mathcal{F}_{\gamma_{i}}} \omega_{\Omega F} \int_{F} \psi_{h} \cdot \boldsymbol{n}_{F}=0$, we can use Lemma 5 to infer from the uniform Poincaré inequality on the simplicial de Rham complex [2] the existence of

$$

such that

\operatorname{curl} \boldsymbol{\phi}_{h}=\psi_{h} \text { and }\left\|\boldsymbol{\phi}_{h}\right\|_{L^{2}\left(\Omega ; \mathbb{R}^{3}\right)} \lesssim\left\|\boldsymbol{\psi}_{h}\right\|_{L^{2}\left(\Omega ; \mathbb{R}^{3}\right)} \tag{27}
\end{equation*}
$$

Summing (87), we have

\end{equation*}
$$

Hence, equating (26) and (28), we infer that, for all $F \in \mathcal{F}_{h} \subset \mathfrak{F}_{h}, \sum_{E \in \mathcal{E}_{F}} \omega_{F E} \alpha_{E}=\alpha_{F}$. Moreover, noticing that both $\boldsymbol{\phi}_{E, S}$ and $\psi_{F, S}$ are only supported in $S$, we have

& \simeq \sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} \sum_{E \in \mathfrak{E}_{S}} \alpha_{E}^{2}\left\|\boldsymbol{\phi}_{E, S}\right\|_{\boldsymbol{L}^{2}\left(S ; \mathbb{R}^{3}\right)}^{2}  \tag{29}\\
& \frac{[83]}{=} \sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} h_{S} \sum_{E \in \mathfrak{F}_{S}} \alpha_{E}^{2} \\
& \gtrsim \sum_{T \in \mathcal{T}_{h}} h_{T} \sum_{E \in \mathcal{E}_{T}} \alpha_{E}^{2}
\end{align*}
$$

and

$$
\begin{align*}
\left\|\boldsymbol{\psi}_{h}\right\|_{\boldsymbol{L}^{2}\left(\Omega ; \mathbb{R}^{3}\right)}^{2} & =\sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} \int_{S}\left(\sum_{F \in \tilde{\mathscr{F}}_{S}} \alpha_{F} \boldsymbol{\psi}_{F, S}\right)^{2} \\
& \simeq \sum_{T \in \mathcal{F}_{h}} \sum_{S \in \mathfrak{I}_{T}} \sum_{F \in \tilde{\mho}_{S}} \alpha_{F}^{2}\left\|\boldsymbol{\psi}_{F, S}\right\|_{\boldsymbol{L}^{2}\left(S ; \mathbb{R}^{3}\right)}^{2}  \tag{30}\\
& \stackrel{[84]}{\sim} \sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} h_{S}^{-1} \sum_{F \in \tilde{\Psi} S} \alpha_{F}^{2} \\
& \stackrel{[25]}{\sim} \sum_{T \in \mathcal{T}_{h}} h_{T}^{-1} \sum_{F \in \mathcal{F}_{T}} \alpha_{F}^{2},
\end{align*}
$$

where, in the last passage, we have additionally used the fact that $h_{S}^{-1} \lesssim h_{T}^{-1}$ for all $S \in \mathfrak{I}_{T}$ by mesh regularity. Finally, to prove (21), it suffices to write

### 3.3 Mimetic Poincaré inequality for collections of face values

Theorem 7 (Mimetic Poincaré inequality for collections of face values). Let $\left(\alpha_{T}\right)_{T \in \mathcal{T}_{h}} \in \mathbb{R}^{\mathcal{T}_{h}}$ be a collection of values at elements. Then, there is a collection $\left(\alpha_{F}\right)_{F \in \mathscr{F}_{h}} \in \mathbb{R}^{\mathcal{F}_{h}}$ of values at faces such that, for all $T \in \mathcal{T}_{h}$,

\sum_{F \in \mathcal{F}_{T}} \omega_{T F} \alpha_{F}=\alpha_{T} \text { and } \sum_{T \in \mathcal{T}_{h}} h_{T}^{-1} \sum_{F \in \mathcal{F}_{T}} \alpha_{F}^{2} \lesssim \sum_{T \in \mathcal{T}_{h}} h_{T}^{-3} \alpha_{T}^{2} \tag{31}
\end{equation*}
$$

with hidden constant only depending on $\Omega$ and the mesh regularity parameter.
Proof. Let $\left(\boldsymbol{\phi}_{F}\right)_{F \in \widetilde{\Im}_{h}}$ and $\left(\psi_{S}\right)_{S \in \mathfrak{I}_{h}}$ be the basis functions of the face Raviart-Thomas-Nédélec and of the fully discontinuous piecewise affine spaces on the tetrahedral submesh, respectively given by (79) and (80) below. Define the following piecewise polynomial function:

\psi_{h}:=\sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} \alpha_{T} \frac{|S|}{|T|} \psi_{S} . \tag{32}
\end{equation*}
$$

We infer from the uniform Poincaré inequality on the simplicial de Rham complex [2] the existence of $\phi_{h}:=\sum_{F \in \widetilde{\mathscr{F}}_{h}} \alpha_{F} \boldsymbol{\phi}_{F} \in \mathcal{R} \mathcal{T}^{1}\left(\mathfrak{I}_{h}\right) \subset \boldsymbol{H}(\operatorname{div} ; \Omega)$ such that

$$
\begin{equation*}
\operatorname{div} \boldsymbol{\phi}_{h}=\psi_{h} \text { and }\left\|\boldsymbol{\phi}_{h}\right\|_{L^{2}\left(\Omega ; \mathbb{R}^{3}\right)} \lesssim\left\|\psi_{h}\right\|_{L^{2}(\Omega)} . \tag{33}
\end{equation*}
$$

Summing (88), on the other hand, we obtain

\end{equation*}

where $\omega_{S F}$ is the orientation of $F$ relative to $S$. Since each $\psi_{S}$ is supported in $S$, we infer equating (32) and (34) that, for all $T \in \mathcal{T}_{h}$ and all $S \in \mathfrak{I}_{T}$,

\alpha_{T} \frac{|S|}{|T|}=\sum_{F \in \mathscr{Y} S} \omega_{S F} \alpha_{F} .
$$

For all $T \in \mathcal{T}_{h}$, summing this relation over $S \in \mathfrak{I}_{T}$, we have

\sum_{S \in \mathfrak{I}_{T}} \alpha_{T} \frac{|S|}{|T|}=\sum_{S \in \mathfrak{I}_{T}} \sum_{F \in \mathfrak{F}_{S}} \omega_{S F} \alpha_{F} \Longrightarrow \alpha_{T} \frac{\sum_{S \in \mathfrak{I}_{T}}|S|^{«}}{|T|}=\sum_{F \in \mathscr{F}_{T}} \omega_{T F} \alpha_{F},
$$

where we have used the fact that the contributions from the simplicial faces internal to $T$ cancel out in the right-hand side.

It remains to check that (31) holds. Noticing that the only $\boldsymbol{\phi}_{F}$ supported in $S$ are those associated with its faces $F$ collected in the set $\mathscr{F}_{s}$, we have

& \simeq \sum_{T \in \mathcal{T}_{h}} \sum_{S \in \mathfrak{I}_{T}} \sum_{F \in \mathfrak{F}_{S}} \alpha_{F}^{2}\left\|\boldsymbol{\phi}_{F}\right\|_{\boldsymbol{L}^{2}\left(S ; \mathbb{R}^{3}\right)}^{2} \\
& \stackrel{[84]}{=} \sum_{T \in \mathcal{T}_{h}} h_{T}^{-1} \sum_{S \in \mathfrak{I}_{T}} \sum_{F \in \mathscr{F} S} \alpha_{F}^{2}  \tag{35}\\
& \approx \sum_{T \in \mathcal{T}_{h}} h_{T}^{-1} \sum_{F \in \mathcal{F}_{T}} \alpha_{F}^{2},
\end{align*}
$$

where we have used $h_{S}^{-1} \simeq h_{T}^{-1}$ (consequence of mesh regularity) in the third line. Likewise, we have

\end{equation*}

where we have used $h_{S} \simeq h_{T}$ and $|S| \simeq|T|$. Finally, to prove (31), we write

## 4 Proofs of Poincaré inequalities in DDR spaces

### 4.1 Poincaré inequality for the gradient

We start with the following preliminary lemma.
Lemma 8 (Continuous inverse of the discrete gradient). For all $\underline{p}_{h} \in \underline{X}_{\mathrm{grad}, h}^{k}$, there is $\underline{q}_{h} \in \underline{X}_{\mathrm{grad}, h}^{k}$ such that

Proof. We provide an explicit definition of $\underline{q}_{h}$ and check that (37) holds. Specifically, we let $\underline{q}_{h} \in$ $\underline{X}_{\mathrm{grad}, h}^{k}$ be such that, for all $E \in \mathcal{E}_{h}$,

for all $F \in \mathcal{F}_{h}$,

$$
\begin{equation*}
\int_{F} q_{F} \operatorname{div}_{F} \boldsymbol{v}=-\int_{F} \boldsymbol{G}_{F}^{k} \underline{p}_{F} \cdot \boldsymbol{v}+\sum_{E \in \mathcal{E}_{F}} \omega_{F E} \int_{E} q_{E}\left(\boldsymbol{v} \cdot \boldsymbol{n}_{F E}\right) \quad \forall \boldsymbol{v} \in \mathcal{R}^{\mathrm{c}, k}(F) \tag{40}
\end{equation*}
$$

and, for all $T \in \mathcal{T}_{h}$,

$$
\begin{equation*}
\int_{T} q_{T} \operatorname{div} v+\sum_{F \in \mathcal{F}_{T}} \omega_{T F} \int_{F} q_{F}\left(\boldsymbol{v} \cdot \boldsymbol{n}_{F}\right) \quad \forall v \in \mathcal{R}^{\mathrm{c}, k}(T) \tag{41}
\end{equation*}
$$

Notice that the vertex values $\left(q_{V}\right)_{V \in \mathcal{V}_{h}}$ are only defined up to a global constant and that $q_{F}$ (resp., $\left.q_{T}\right)$ is well-defined by condition (40) (resp., 41) since $\operatorname{div}_{F}: \mathcal{R}^{\mathrm{c}, k}(F) \rightarrow \mathcal{P}^{k-1}(F)$ (resp., div $: \mathcal{R}^{\mathrm{c}, k}(T) \rightarrow$ $\mathcal{P}^{k-1}(T)$ ) is an isomorphism.

1. Equality of the discrete gradient. Let us first briefly show that

Let now $F \in \mathcal{F}_{h}$. By [7] Lemma 14] for $(k, d)=(0,2), \int_{F} G_{F}^{k} \underline{p}_{F} \cdot \operatorname{rot}_{F} r=-\sum_{E \in \mathcal{E}_{F}} \omega_{F E} \int_{E} G_{E}^{k} \underline{p}_{E} r$ for all $r \in \mathcal{P}_{0}^{k+1}(F)$, so that, by (43), $\boldsymbol{\pi}_{\mathcal{R}, F}^{k} \boldsymbol{G}_{F}^{k} \underline{q}_{F}=\boldsymbol{\pi}_{\mathcal{R}, F}^{k} \boldsymbol{G}_{F}^{k} \underline{p}_{F}$. On the other hand, plugging the
definition (40) of $q_{F}$ into (2), we readily infer that $\boldsymbol{\pi}_{\mathcal{R}, F}^{\mathrm{c}, k} \boldsymbol{G}_{F}^{k} \underline{q}_{F}=\boldsymbol{\pi}_{\mathcal{R}, F}^{\mathrm{c}, k} \boldsymbol{G}_{F}^{k} \underline{p}_{F}$. The above relations imply

Then, plugging the definition (41) of $q_{T}$ into (3), we get $\boldsymbol{\pi}_{\mathcal{R}, T}^{\mathrm{c}, k} \boldsymbol{G}_{T}^{k} \underline{q}_{T}=\boldsymbol{\pi}_{\mathcal{R}, T}^{\mathrm{c}, k} \boldsymbol{G}_{T}^{k} \underline{p}_{T}$. To estimate the face components, we first take in (40) v such that $\operatorname{div}_{F} \boldsymbol{v}=q_{F}$ (this is possible since $\operatorname{div}_{F}: \mathcal{R}^{\mathrm{c}, k}(F) \rightarrow \mathcal{P}^{k-1}(F)$ is an isomorphism by [2, Corollary 7.3]) use Cauchy-Schwarz and trace inequalities in the right-hand side to obtain

The estimate of the element components is entirely similar: taking in 41) $v \in \mathcal{R}^{\mathrm{c}, k}(T)$ such that $\operatorname{div} \boldsymbol{v}=q_{T}$ (which is possible since $\operatorname{div}: \mathcal{R}^{\mathrm{c}, k}(T) \rightarrow \mathcal{P}^{k-1}(T)$ is an isomorphism again by [2, Corollary 7.3]), we obtain $\left\|q_{T}\right\|_{L^{2}(T)}^{2} \lesssim h_{T}^{2}\left\|\boldsymbol{G}_{T}^{k} \underline{p}_{T}\right\|_{\boldsymbol{L}^{2}\left(T ; \mathbb{R}^{3}\right)}^{2}+h_{T} \sum_{F \in \mathcal{F}_{T}}\left\|q_{F}\right\|_{L^{2}(F)}^{2}$. Summing over $T \in \mathcal{T}_{h}$, using the fact that $h_{T} \leq h \lesssim 1$ for all $T \in \mathcal{T}_{h}$ for the first term and (48) for the second, and recalling the definition (9) of $\left||\cdot| \|_{\text {curl }, h}\right.$, we arrive at

1. Equality of the discrete curl. By definition of $z_{E}$, it holds $\pi_{\mathcal{P}, F}^{0} C_{F}^{k} \underline{z}_{F}=\pi_{\mathcal{P}, F}^{0} C_{F}^{k} \underline{v}_{F}$ for all $F \in \mathcal{F}_{h}$. The equality of the higher-order components is obtained plugging (53) into the definition (4) of $C_{F}^{k} \underline{z}_{F}$, which leads to $\int_{F} C_{F}^{k} \underline{z}_{F} r=\int_{F} C_{F}^{k} \underline{v}_{F} r$ for all $r \in \mathcal{P}_{0}^{k}(F)$. By [16, Proposition 4] (which corresponds to [7. Lemma 14] with $(d, k)=(3,1))$, the equality of the face curls implies $\boldsymbol{\pi}_{\mathcal{G}, T}^{k}\left(\boldsymbol{C}_{T}^{k} \boldsymbol{z}_{T}\right)=\boldsymbol{\pi}_{\mathcal{G}, T}^{k}\left(\boldsymbol{C}_{T}^{k} \underline{\boldsymbol{v}}_{T}\right)$. The equality of the projections on $\mathcal{R}^{\mathrm{c}, k}(T)$ results plugging (55) into the definition (5) of $\boldsymbol{C}_{T}^{k} \underline{z}_{T}$ with test function $\boldsymbol{w} \in \mathcal{G}^{\mathrm{c}, k}(T)$. Gathering the above results, we obtain $\boldsymbol{C}_{T}^{k} \underline{z}_{T}=\boldsymbol{C}_{T}^{k} \underline{\boldsymbol{v}}_{T}$ for all $T \in \mathcal{T}_{h}$, from which $\underline{\boldsymbol{C}}_{h}^{k} \underline{z}_{h}=\underline{\boldsymbol{C}}_{h}^{k} \underline{\boldsymbol{v}}_{h}$ follows recalling the definition (8) of the discrete curl.
2. Continuity. Let us now show the bound in (50). Concerning edge components, we write

To estimate the face component, we let $r$ in (53) be such that $\boldsymbol{r o t}_{F} r=z_{\mathcal{R}, F}$ and use Cauchy-Schwarz, inverse, and trace inequalities in the right-hand side to infer $\left\|z_{\mathcal{R}, F}\right\|_{L^{2}\left(F ; \mathbb{R}^{2}\right)} \lesssim h_{F}\left\|C_{F}^{k} \underline{v}_{F}\right\|_{L^{2}(F)}+$ $h_{F}^{\frac{1}{2}} \sum_{E \in \mathcal{E}_{F}}\left\|z_{E}\right\|_{L^{2}(E)}$. Squaring the above relation and using standard inequalities for the square of a finite sum of terms, we obtain, after noticing that $h_{F} \leq h$ for all $F \in \mathcal{F}_{h}$,

where the conclusion follows noticing that $h \leq \operatorname{diam}(\Omega) \lesssim 1$, recalling the definition (10) of $\||\cdot|\|_{\text {div, } h}$ for the first term, and invoking (57) for the second one.

The estimate of the element component is obtained in a similar way, starting from (55) with $\boldsymbol{w}$ such that $\operatorname{curl} \boldsymbol{w}=\boldsymbol{z}_{\mathcal{R}, T}$, leading to

Theorem 3 is established in the same way as Theorem 1 (see the end of Section 4.1) starting from the following result.

trace, and inverse inequalities in the right-hand side, pass to the square and use standard inequalities for the square of a finite sum of terms to obtain

## 5 Stability analysis of a DDR scheme for the magnetostatics problem

We apply the Poincaré inequalities stated in Section 2.7 to the stability analysis of a DDR scheme for the magnetostatics problem which generalises the one presented in [17] to domains with non-trivial topology. We introduce the space of discrete harmonic forms

## A Results on the trimmed finite element sequence on tetrahedral meshes

In this section we provide the explicit expression of the polynomial basis functions used in Section 3 These bases can be easily described on a reference element (see [3]). However, in order the compute their norms, we need to know their expression on the physical element. The transformation from the reference to the physical element is given by the pullback of the mapping between the two.

We consider a simplex $S$ with vertices $V_{0}, V_{1}, V_{2}$, and $V_{3}$ ordered so that, denoting by $\boldsymbol{x}_{V_{i}}$ the coordinate vector of $V_{i},\left\{\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right\}$ forms a direct basis of $\mathbb{R}^{3}$. The basis for the local affine Lagrange space $\mathcal{P}_{1}^{-} \Lambda^{0}(S) \cong \mathcal{P}^{1}(S)$ spanned by "hat" functions is

\phi_{3}(\boldsymbol{\psi})=\lambda_{3} \frac{\left[\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}\right) \times\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}\right)\right] \cdot\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right)}{\operatorname{det}\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right)}=\lambda_{3} .
$$

Hence, we have

$$
\int_{S} \phi_{3}^{2}=\int_{\lambda_{1}=0}^{1} \int_{\lambda_{2}=0}^{1-\lambda_{1}} \int_{\lambda_{3}=0}^{1-\lambda_{1}-\lambda_{2}}\left(\lambda_{3}\right)^{2} 6|S|=\frac{|S|}{10}
$$

Then, we proceed with the family (78). We have

$$
\begin{aligned}
\boldsymbol{\phi}_{23}(\psi) & =\frac{\lambda_{2}\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}\right) \times\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}\right)+\lambda_{3}\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}\right) \times\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right)}{\operatorname{det}\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{2}}\right)} \\
& =\frac{1}{6|S|}\left(\lambda_{2} 2\left|F_{012}\right| \boldsymbol{n}_{012}+\lambda_{3} 2\left|F_{013}\right| \boldsymbol{n}_{013}\right) .
\end{aligned}
$$

Expanding the product, we obtain

$$
\begin{aligned}
\int_{S} \boldsymbol{\phi}_{23} \cdot \boldsymbol{\phi}_{23} & =\int_{\lambda_{1}=0}^{1} \int_{\lambda_{2}=0}^{1-\lambda_{1}} \int_{\lambda_{3}=0}^{1-\lambda_{1}-\lambda_{2}}\left(\frac{1}{3|S|}\right)^{2}\left(\lambda_{2}^{2}\left|F_{012}\right|^{2}+\lambda_{3}^{2}\left|F_{013}\right|^{2}+2 \lambda_{2} \lambda_{3} c_{01}\left|F_{012}\right|\left|F_{013}\right|\right) 6|S| \\
& =\frac{2}{3|S|} \frac{\left|F_{012}\right|^{2}+\left|F_{013}\right|^{2}+c_{01}\left|F_{012}\right|\left|F_{013}\right|}{60}
\end{aligned}
$$

Finally, we prove that (84) holds for $\phi_{123}$ given by $\sqrt{79)}$. We have

$$
\boldsymbol{\phi}_{123}(\boldsymbol{\psi})=2 \frac{\lambda_{1}\left(\boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}\right)+\lambda_{2}\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{0}}\right)+\lambda_{3}\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right)}{\operatorname{det}\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{1}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{1}}, \boldsymbol{x}_{V_{1}}-\boldsymbol{x}_{V_{0}}\right)}
$$

Noticing that $\left(\boldsymbol{x}_{V_{i}}-\boldsymbol{x}_{V_{0}}\right) \cdot\left(\boldsymbol{x}_{V_{j}}-\boldsymbol{x}_{V_{0}}\right)=2\left|F_{0 i j}\right|$, we have

$$
\begin{aligned}
\int_{S} \boldsymbol{\phi}_{123} \cdot \boldsymbol{\phi}_{123}= & \int_{\lambda_{1}=0}^{1} \int_{\lambda_{2}=0}^{1-\lambda_{1}} \int_{\lambda_{3}=0}^{1-\lambda_{1}-\lambda_{2}}\left(\frac{2}{6|S|}\right)^{2}\left(\lambda_{1}^{2}\left|E_{01}\right|^{2}+\lambda_{2}^{2}\left|E_{02}\right|^{2}+\lambda_{3}^{2}\left|E_{03}\right|^{2}\right. \\
& \left.+4 \lambda_{1} \lambda_{2}\left|F_{012}\right|+4 \lambda_{1} \lambda_{3}\left|F_{013}\right|+4 \lambda_{2} \lambda_{3}\left|F_{023}\right|\right) 6|S| \\
= & \frac{1}{3|S|} \frac{\left|E_{01}\right|^{2}+\left|E_{02}\right|^{2}+\left|E_{03}\right|^{2}+2\left|F_{012}\right|+2\left|F_{013}\right|+2\left|F_{023}\right|}{60}
\end{aligned}
$$

Lemma 14 (Link with the differential operators). For all face $F$ of $S$, we define $\omega_{S F} \in\{-1,1\}$ such that $\omega_{S F} \boldsymbol{n}_{F}$ is outward pointing. Then, the followings identities hold;

$$
\begin{align*}
\operatorname{grad} \phi_{i} & =\sum_{j<i} \boldsymbol{\phi}_{j i}-\sum_{j>i} \boldsymbol{\phi}_{i j} & & \forall i \in\{0,1,2,3\},  \tag{86}\\
\operatorname{curl} \phi_{i j} & =\omega_{S F_{\hat{i}}} \omega_{F_{\hat{i}} E_{i j}} \phi_{\hat{i}}+\omega_{S F_{\hat{j}}} \omega_{F_{\hat{j}} E_{i j}} \boldsymbol{\phi}_{\hat{j}} & & \forall(i j) \in\{23,13,12,03,02,01\},  \tag{87}\\
\operatorname{div} \boldsymbol{\phi}_{i j k} & =\omega_{S F_{i j k}} \phi_{0123}, & & \forall(i j k) \in\{123,023,013,012\}, \tag{88}
\end{align*}
$$

where $\hat{i}$ denotes the complementary of $i$ in $\{0,1,2,3\}$.

Proof. First, let us prove (88). Noticing that $\operatorname{div} \boldsymbol{x}=3$, it only remain to check that

$$
\begin{equation*}
\operatorname{sgn} \operatorname{det}\left(\boldsymbol{x}_{V_{j}}-\boldsymbol{x}_{V_{i}}, \boldsymbol{x}_{V_{k}}-\boldsymbol{x}_{V_{i}}, \boldsymbol{x}_{V_{i}}-\boldsymbol{x}_{V_{l}}\right)=\omega_{S F_{i j k}} . \tag{89}
\end{equation*}
$$

This holds, since $\left(\boldsymbol{x}_{V_{j}}-\boldsymbol{x}_{V_{i}}\right) \times\left(\boldsymbol{x}_{V_{k}}-\boldsymbol{x}_{V_{i}}\right)=\left\|\boldsymbol{x}_{V_{j}}-\boldsymbol{x}_{V_{i}}\right\|\left\|\boldsymbol{x}_{V_{k}}-\boldsymbol{x}_{V_{i}}\right\| \boldsymbol{n}_{F}$, and $\boldsymbol{x}_{V_{i}}-\boldsymbol{x}_{V_{l}}$ is always outward pointing.

Then, to prove (87), we use the identity $\operatorname{curl}(\boldsymbol{A} \times \boldsymbol{B})=\operatorname{div}\left(\boldsymbol{B} \otimes \boldsymbol{A}^{\top}-\boldsymbol{A} \otimes \boldsymbol{B}^{\top}\right)$ in (78) to write

$$
\begin{equation*}
\operatorname{curl} \phi_{i j}=\frac{3\left(x_{V_{l}}-x_{V_{k}}\right)-\left(x_{V_{l}}-x_{V_{k}}\right)}{\operatorname{det}\left(x_{V_{l}}-x_{V_{k}}, x_{V_{i}}-x_{V_{k}}, x_{V_{j}}-x_{V_{i}}\right)}, \tag{90}
\end{equation*}
$$

where $(k l)$ is such that $\{i, j, k, l\}=\{0,1,2,3\}$ and $k<l$. Noticing that $\boldsymbol{x}_{V_{l}}-\boldsymbol{x}_{V_{k}}$ is an inward pointing to the face $\hat{k}$, and $\boldsymbol{x}_{V_{i}}-\boldsymbol{x}_{V_{k}}$ lies outward pointing in the plane of $F_{\hat{k}}$, we have

$$
\begin{equation*}
\operatorname{det}\left(x_{V_{l}}-x_{V_{k}}, x_{V_{i}}-x_{V_{k}}, x_{V_{j}}-x_{V_{i}}\right)=\frac{1}{6|S|} \omega_{F_{\hat{k}} E_{i j}}=-\frac{1}{6|S|} \omega_{F_{\hat{l}} E_{i j}} \tag{91}
\end{equation*}
$$

where we inserted $\boldsymbol{x}_{V_{k}}-\boldsymbol{x}_{V_{i}}$ in the second argument of the determinant to get the second inequality. Inserting $\boldsymbol{x}-\boldsymbol{x}$ in (90) and replacing the denominator according to (91), we obtain curl $\boldsymbol{\phi}_{i j}=$ $6|S|\left(\omega_{F_{\hat{k}} E_{i j}} 2\left(\boldsymbol{x}-\boldsymbol{x}_{V_{k}}\right)+\omega_{F_{\hat{l}} E_{i j}} 2\left(\boldsymbol{x}-\boldsymbol{x}_{V_{l}}\right)\right)$ We infer (87) recalling (89).

Finally, let us prove 86). We only prove the equality for $\phi_{0}$, the other three being similar. By the assumption on the basis, we have $\operatorname{det}\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{1}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{1}}, \boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{0}}\right)=6|S|$. Then, a direct computation shows that

$$
\begin{aligned}
\operatorname{grad} \phi_{0} & =-\frac{\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{1}}\right) \times\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{1}}\right)}{6|S|} \\
& =-\frac{\left(x_{V_{2}}-\boldsymbol{x}\right) \times\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{2}}\right)+\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}\right) \times\left(\boldsymbol{x}_{V_{2}}-\boldsymbol{x}_{V_{1}}\right)+\left(\boldsymbol{x}-\boldsymbol{x}_{V_{1}}\right) \times\left(\boldsymbol{x}_{V_{3}}-\boldsymbol{x}_{V_{1}}\right)}{6|S|}
\end{aligned}
$$

Noticing that

$$
\begin{gathered}
\phi_{03}(x)=\frac{\left(x_{V_{2}}-x_{V_{1}}\right) \times\left(x-x_{V_{1}}\right)}{6|S|}, \quad \phi_{02}(x)=-\frac{\left(x_{V_{3}}-x_{V_{1}}\right) \times\left(x-x_{V_{1}}\right)}{6|S|}, \\
\phi_{01}(x)=\frac{\left(x_{V_{3}}-x_{V_{2}}\right) \times\left(x-x_{V_{2}}\right)}{6|S|}
\end{gathered}
$$

we infer that grad $\phi_{0}=-\boldsymbol{\phi}_{01}-\boldsymbol{\phi}_{03}-\boldsymbol{\phi}_{02}$.
