#### 1 Photocatalytic hydrogen production and carbon dioxide reduction catalyzed by an artificial cobalt hemoprotein 3 Guillermo A. This new 14 artificial metalloenzyme has been purified and characterized by Maldi-TOF MS, circular dichroism 15 and UV-visible spectroscopy. Using theoretical experiments, the structure of this biohybrid and the 16

positioning of the residues near the metal complex were examined, which made it possible to 17 complete the coordination of the cobalt ion by an axial glutamine Gln283 ligand. While the Co(III)-18 porphyrin catalyst alone showed a weak catalytic activity for both reactions, 10 times more H<sub>2</sub> and 19 4 times more CO<sub>2</sub> were produced when the Co( III)-porphyrin complex was buried in the 20 hydrophobic cavity of the protein. This study thus provides a solid basis for further improvement 21 of these biohybrids, using well-designed modifications of the second and outer coordination sphere, 22 by site-directed mutagenesis of the host protein. 23

1. Introduction

One of the greatest challenges facing our society is to replace current fuels with new, 27 abundant and renewable sources of energy. Hydrogen (H<sub>2</sub>) seems to be the ideal energy 28 carrier because, in addition to its highly energetic H-H bond, it's environmentally 29 friendly combustion releases only water as product. H<sub>2</sub> production processes are numer-30 ous (thermal, photochemical, biological, electrolytic, etc.) and the resources used in these 31 processes are equally as abundant (water, solid waste, cellulose, biomass, etc.). To meet 32 the fast-growing global demand for H<sub>2</sub>, the development of catalysts for the production 33 of hydrogen is highly sought after. Specifically, new original molecular complexes, most 34 often bioinspired, based on non-noble metals such as nickel, cobalt or molybdenum, have 35 been synthesized and studied to replace platinum, a catalyst that is certainly effective but 36 scarce and expensive [1-4] Molecular catalysts have been shown to be proficient in the 37 hydrogen evolution reaction (HER) showing increased efficiency and stability. In partic-38 ular, a variety of molecular cobalt catalysts have been developed for the production of 39 hydrogen, such as: glyoxime and the vitamin B12, which have the disadvantage of being 40 poorly soluble and unstable in water [5]; Mononuclear and dinuclear cobalt polypyridines 41 [6,7]; macrocyclic ligands like cobalt corroles [8]; cationic cobalt porphyrins [9]; anionic 42 cobalt porphyrins [10]; cobalt heme-peptides [11]; and more recently a synthetic mini-43 enzyme known as mimochrome VI\*a [12]. These cobalt complexes underwent light-in-44 duced proton reduction in water when combined with a photosensitizer and a sacrificial 45 electron donor. However, many of these complexes are sparingly soluble in water and 46 their chemical stability is not optimal. To improve the catalytic performance of these sys-47 tems, their outer coordination sphere can be designed to promote the efficient transfer of 48 electrons, H<sup>+</sup>, or H<sub>2</sub>. To overcome this limitation, efforts have been made to develop arti-49 ficial metalloenzymes with an unnatural active site integrated into a protein. This strategy 50 has been shown to improve the production of H<sub>2</sub> [13] and different artificial Co-artificial 51 metalloenzymes have been obtained by non-covalent insertion of cobaloxime derivatives 52 into apo-hemoproteins, such as sperm whale myoglobin or heme oxygenase [14,15] or in 53 a protein carrying out electron transfers such as ferredoxin [16]. In order to improve the 54 catalytic efficiency of those artificial metalloenzymes, another cofactor like the cobalt pro-55 toporphyrin IX was incorporated into a sperm whale myoglobin scaffold by the group of 56 Ghirlanda [17]. In a recent publication, the same group successfully reported the light-57 driven reduction of CO2 and the generation of H2 using an artificial hemoprotein made 58 from the Cytochrome b562 apoprotein that included Co-Protoporphyrin IX as a cofactor 59 [18]. Inspired by these results, we decided to assemble new artificial metalloenzymes by 60 a covalent-grafting strategy, involving the synthesis of various cobalt cofactors, bearing a 61 moiety that would be able to react with the SH group of a cysteinyl residue that could 62 permanently graft them to the protein. Recently, our group has shown that a new class of 63 thermostable artificial proteins named  $\alpha$ Reps have the potential to be transformed into 64 artificial metalloenzymes by covalent grafting of a synthetic metal complex [19]. These 65  $\alpha$ Rep proteins are easily produced in *E. coli*, are very stable within a large pH range, and 66 exhibit a large hydrophobic core. We have thus previously reported a proof of concept by 67 creating artificial Diels-Alderases by covalent attachment of phenanthroline- or 68 terpyridine-Cu(II) complexes in a specific  $\alpha$ Rep single-chain asymmetric bidomain 69 variant named (A3A3')Y26C [20]. This protein has been shown to adopt a closed bivalve 70 shell-like conformation and molecular modeling identified that this cavity was large 71 enough for the anchoring of even larger metal complexes such as meso-72 tetraphenylporphyrin [21]. Thus, from an enzyme designer's point of view, the artificial 73  $\alpha$ Rep proteins bring together the properties required for the development of artificial 74 metalloenzymes dedicated to H<sub>2</sub> production. Accordingly, we here report the production 75 and characterization of a new artificial metalloenzyme obtained by covalent attachment 76 of a cobalt porphyrin derivative into the  $\alpha$ Rep (A3A3')Y26C variant and further show its 77 remarkable activity to catalyze the photoinduced production of H<sub>2</sub> and CO<sub>2</sub> reduction. 78

# 2. Results and discussion

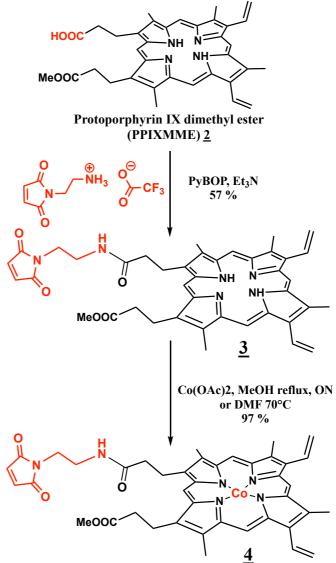
## 2.1. Synthesis of Co(III)Mal-PPIXMME 4

The Co(III)Mal-PPIXMME cofactor <u>4</u> was prepared in 3 steps. In a first step, the hydrolysis of protoporphyrin IX dimethyl ester (PPIXDME) by 6N HCl during 15 min. at room temperature (RT) following the reaction conditions described by Ellsworth R.K. [22] (see Materials and Methods). Protoporphyrin IX monomethyl ester (PPIXMME) <u>2</u> was then obtained in a 28 % yield, and was characterized by NMR and UV-visible spectroscopies as well as by ESI MS (see Materials and Methods). 86

The two following steps of the synthesis are shown in figure 1. Reaction of 2 with a 87 slight excess of N-(2-aminoethyl)-maleimide trifluoroacetate salt (1.1 equiv.), in the pres-88 ence of triethylamine and PyBOP as a coupling agent, in dimethylformamide (DMF) for 89 30 min. at RT afforded the maleimido-ethylamido-protoporphyrin IX monomethyl ester 90 Mal-PPIXMME **3** as a brown solid in a 45 % yield. **3** was characterized by NMR and UV-91 visible spectroscopies and ESI MS (see Materials and Methods). These characteristics were 92 in good agreement with those of a very similar product maleimido-ethylamido-protopor-93 phyrin IX monoethyl ester Mal-PPIXMEE already reported by the group of Y. Watanabe 94 [23]. 95

Finally, the addition of 10 equiv. of Co(OAC)2.4 H2O to the obtained compounds <u>3</u> in96anhydrous DMF at 70 °C led, after removal of the excess of cobalt salt by extraction in a97dichloromethane (DCM)/water mixture and removal of the solvent under reduced pressure, to Co(III)-Mal-PPIXMME as a dark green solid in a 97 % yield. <u>4</u> was characterized98by UV-visible spectroscopy and ESI MS spectrometry.100

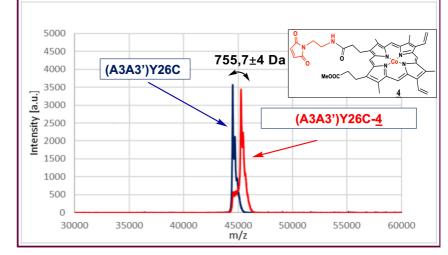

# 2.2. Biohybrid preparation

The (A3A3')Y26C-Co(III)Mal-PPIXMME (A3A3')Y26C-4) biohybrid was prepared in 105 three steps. The single-chain bidomain protein in which a cysteine-free domain was linked 106 with a domain bearing the Y26C mutation ((A3A3')Y26C) was first produced and purified 107 as recently described [24]. Compound 4 was then synthesized from protoporphyrin IX in 108 three steps as described above. The biohybrid was finally assembled by incubation of the 109 (A3A3')Y26C protein with 10 eq. of compound 4 for 3 days at 4 °C, in a 50 mM Na-phos-110 phate pH 7.75 coupling buffer containing 150 mM NaCl and 25% dimethyl sulfoxide 111 (DMSO). After removal of the excess of compound  $\underline{4}$  by extraction with butan-2-one, the 112 (A3A3')Y26-4 biohybrid was recovered in the aqueous phase. 113

The (A3A3')Y26C- $\underline{4}$  biohybrid was then characterized by MALDI-ToF mass spectrometry analysis (Fig. 2). Whereas (A3A3')Y26C showed a major peak at M = 44502 Da, a 115



peak at 45262 Da was observed for the  $(A3A3')Y26C-\underline{4}$  biohybrid, which was in agreement with the covalent attachment of compound  $\underline{4}$  (M = 755.7 Da) on (A3A3')Y26C. 117

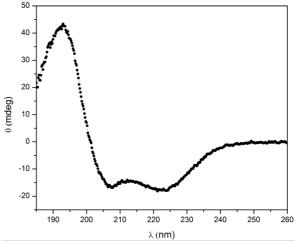


Figure 3. Far-UV CD spectrum of a 2.2 mM solution of the (A3A3')Y26C-4biohybrid in 20 mM so-131dium phosphate buffer pH 7.5.132

To analyze the effect of the binding of  $\underline{4}$  into the cavity of (A3A3')Y26C on the folding 121 of the protein circular dichroism (CD) measurements were carried out. The far UV circular 122 dichroism spectrum of the (A3A3')Y26C-4 biohybrid (Fig. 3) showed a signal with two 123 negative bands at 222 and 208 nm and a positive band around 190 nm that was 124 characteristic of proteins containing mainly  $\alpha$  helices as secondary structure. This signal 125 was very similar to that of the non-modified (A3A3')Y26C protein [19, 21] indicating that 126 its 3D structure was not altered after covalent attachment of the porphyrin cofactor in its 127 hydrophobic pocket, even in the presence of 25% DMSO, and further treatment with 128 butan-2-one. 129

# 2.3. UV-visible characteristics of the $(A3A3')Y26C-\underline{4}$ biohybrid

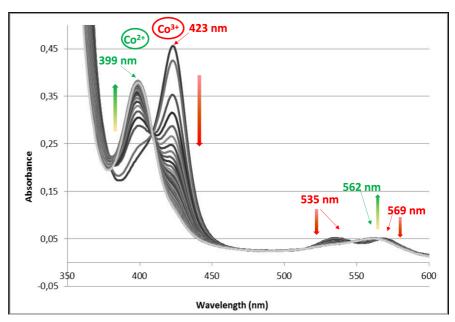


Figure 4. Evolution of the UV-Vis spectrum of (A3A3')Y26C-4 7.5µM in 10 mM HEPES, NaCl 150141mM buffer, pH 8.0 after the addition of a 1.5 mM anaerobic solution of sodium dithionite. Spectra142were recorded every 5 min during 2h.143

The addition, under anaerobic conditions, of 1.5 mM sodium dithionite to a 7.5  $\mu$ M 134 solution of (A3A3')Y26C-<u>4</u> in 10 mM HEPES, NaCl 150 mM buffer, pH 8.0 led to the gradual replacement, with an isosbestic point at 408 nm, of the spectrum characteristic of 136 Co(III)-Mal-PPIXMME <u>4</u> with peaks at 423, 535 and 569 nm by a new one with peaks at 137 399 and 562 nm that was characteristic of the reduced form of the biohybrid Co(II)-Mal-PPIXMME <u>4</u> (Fig. 4).

The characteristics of these spectra were compared in Table 1 with those obtained after incorporation of Co(III)- and Co(II)-protoporphyrin IX into the apoprotein of various hemoproteins including myoglobin (Mb) [24] and its H64V-V68A double mutant [25], 2 cytochromes P450; P450<sub>Cam</sub> [26] and CYP119 [27] two peroxidases; Horseradish peroxidase (HRP) [24] and dye decolorizing peroxidase (DYP) [28], Aldoxime deshydrogenase (Oxd) [28], and Catalase (Cat) [28].

As shown in Table 1, the electronic absorption spectrum of the oxidized Co(III)-(A3A3')Y26C-4 biohybrid is similar to those obtained by incorporation of Co(III)PPIX not only into apoproteins which bind the cobalt cation through an axial thiolate ligand such as P450 cam [26] and CYP 119 [27] but also to those of some apoproteins which bind the cobalt cation through an axial histidine ligand such as Mb, HRP [24] and DYP [28]. Such a comparison does thus not allow the identification the of cobalt axial ligand of cobalt in (A3A3')Y26C-4. However, when comparing the electronic absorption spectra of the 160

various reduced complexes, it appears that the spectral characteristics of the Co(II)-161 (A3A3')Y26C-4 biohybrid are very different from those observed with P450 cam [26] and 162 CYP 119 [27] whereas they are closer from those observed in the case of proteins bearing 163 an axial histidine ligand with, in particular, a very strong similarity with those of the Co(II) 164 dye decolorizing peroxidase (DYP) [28]. This latter comparison tends to suggest axial 165 coordination of the cobalt ion by a histidine ligand in the Co(II)-(A3A3')Y26C-4 biohybrid. 166 However, in order to clarify the environment of the cobalt in the distal pocket of this 167 artificial metalloenzyme, and in particular the nature of its axial ligand, computational 168 modeling studies were engaged. 169

### 2.4. Computational modeling studies

In the absence of X-ray structure of the (A3A3')Y26C-<u>4</u> biohybrid, we embarked on a molecular modeling study. It aimed primarily at elucidating the most stable orientation of the non-natural porphyrin into (A3A3')Y26C and assessing relevant interactions between both subsystems including possible coordination bonds between nearby laying amino acids and the metal.

First, protein-ligand dockings were carried out. As protein structure, we use the rep-176resentative geometry of the most populated cluster of conformations of a 300 ns molecular177dynamics (MD) performed with AMBER [29] of the wild type A3A3' for which Tyr26 was178mutated to cysteine using the UCSF Chimera plug-in for amino acid substitution [30]. The179artificial cofactor was followingly docked using the covalent protocol available in Gold180and the GoldScore scoring function that we updated for metalloligand recently [31].181

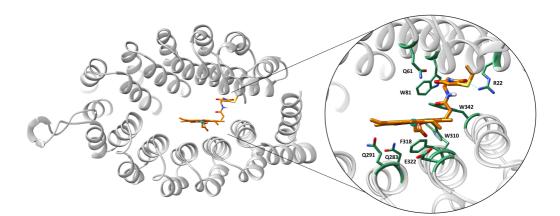
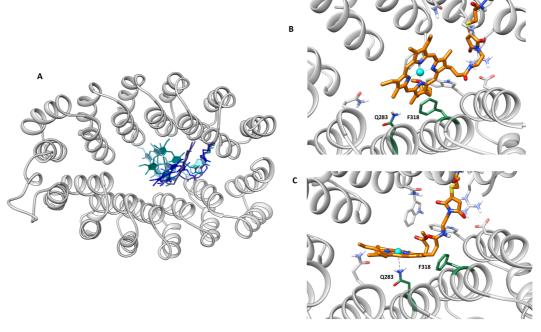


Figure 5. Representation of the lowest energy geometry of the (A3A3')Y26C-4 biohybrid obtained192with Gold and the Goldscore scoring function.193

A first docking run was performed with a rigid protein scaffold. From the 50 solu-182 tions obtained, the lowest energy solution reached 55.1 GoldScore units and can be con-183 sidered a good interaction between both molecular partners. The porphyrin stands very 184 well into the inter-dominial pocket and displays good interactions with amino acids of the 185 cavity like Phe318 with the macrocycle, the methyl group of the methyl propionate ester 186 side chain interacts with a hydrophobic patch constituted by Trp81, Trp310 and Trp342 187 and the cyclic moiety of the linker interacting polarity with Arg22 (Fig. 5). Close-lying 188 residues that could coordinate are Gln 61,283 and 291 or Asp322. 189

Based on this structure, further dockings were carried out to see if nearby laying residues could eventually interact with the metal. This has been performed by giving rotational flexibility to the side chain of amino-acid Glu322 and Phe318 as well as Gln283. 196 From those calculations, it appears that Glu322 and Gln291 may both reach convenient distances for coordination though the former needs Phe318 to be out of the way to the iron. Additionally, these docking solutions show different degrees of rotation of the porphyrin around the linker. This highlights a certain amount of flexibility of the porphyrin 200

that could be related to transient interactions between the metal and the protein. To further analyze this hypothesis, classical molecular dynamics (MD) were performed. 201

Classical MDs were carried out with the AMBER suite of programs using the AM-203 BER20 force field [29]. The porphyrin linker was set up by defining a non-standard amino 204 acid and using of the MCPB.py algorithm for the parameterization of the metallic center 205 and its first coordination sphere (see ESI for further details on the computational section) 206 [32, 33]. Calculations started from the best solution for the initial series of dockings and 207 run for 400 ns. The trajectory shows the stability and convergence of the system after this 208 time (Fig. S1). The calculations agree with the flexible docking and show a flexible cofactor 209 in the binding site (Fig. 6A). However, some orientations clearly dominate. The most pop-210 ulated one is similar to the best-docked structure described at the beginning of this section 211 (Fig. 6B). One can observe a very stable  $\pi$ -stacking between Phe318 and the porphyrin. 212 Interestingly, the Phe318 side chain lays most of the simulation just below the metal with 213 a position that would be occupied by an axial ligand of the metal in natural hemoenzymes. 214 This shows that only one face of the porphyrin is accessible for catalysis and has a well-215 defined and asymmetric distal environment. Alternative orientations correspond to ge-216 ometries in which the interaction Phe318-4 is lost. When such interaction is lost, com-217 pound 4 behaves very freely in the interface between A3 and A3'subdomains. Im-218 portantly, one of the most populated geometries of these alternative orientations shows 219 short distances between Gln283 and the cobalt (Fig. 6C), some consistent with direct Co-220 Gln283 coordination and others with a bridged water molecule between the amino acid 221 and the metal. Such interaction is only possible because the absence of the interaction 222 Phe318-4 is associated with an increase in the accessibility of the metal. 223

In conclusion, the molecular modeling study shows that: 1). The linkage of compound **4** to (A3A3')Y26C leads to a macrocycle located at the interface between both subdomains and excluded from the solvent, 2) the main orientation of **4** in A3A3' presents a strong contact between Phe318 and the macrocycle that aids the packing of the porphyrin hydrophobically to one domain and leads to an asymmetric environment on the distal side, and 3) that possible coordination of the metal would only appear on transient structures with Gln283.

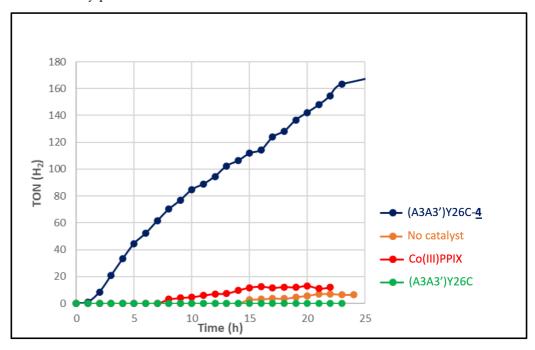

# 2.5. Photocatalytic activity of the (A3A3')Y26C-4 biohybrid

The ability of the (A3A3')Y26C- $\underline{4}$  biohybrid to catalyze not only the production of H<sub>2</sub>, 236 but also to reduce CO<sub>2</sub> under photoinduced conditions. [Ru(bpy)<sub>3</sub>]<sup>2+</sup> (bpy = 2,2'- 237 bipyridine) was chosen as the photosensitizer and ascorbic acid as the sacrificial electron 238 donor agent, since it was shown previously that under irradiation at 405 nm the excited 239 state of [Ru(bpy)<sub>3</sub>]<sup>2+</sup> is reduced by ascorbic acid to [Ru(bpy)<sub>3</sub>]<sup>+</sup>, which in turn transfers 240 electrons to the catalyst generating its active form capable of reducing substrates such as 241 protons [34] or CO<sub>2</sub> [35]. 242

# 2.5.1. Light-driven H<sup>+</sup> reduction

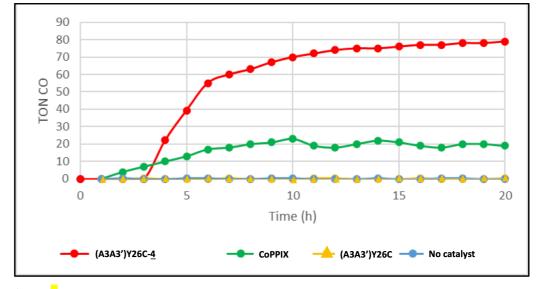
To assay the production of H2 upon photoinduced reduction of protons, experiments 244 were carried out in argon degassed 100 mM ascorbic acid in the presence of 1 mM 245 [Ru(bpy)<sub>3</sub>]<sup>2+</sup> as a photosensitizer and of either 7 µM (A3A3')Y26C-<u>4</u> or 7 µM Co(III)PPIX 246 as catalyst, in 100 mM potassium phosphate buffer at pH 7.0, under irradiation with a 247 white LED light at  $\lambda > 405$  nm. Figure 7 shows the evolution of the turnover number (TON) 248 related to  $H_2$  production over time for 25 h. It appears that in the presence of the 249 A3A3'Y26C-4 biohybrid the production of H2 increases over time to reach a value of 163 250 TON after 25 hours. On the contrary, when the metalloporphyrin CoPPIX was used as a 251 catalyst, only a low production of H<sub>2</sub> not exceeding 13 TON was observed after 25 h 252 whereas a negligible H<sub>2</sub> production was observed in the presence of the non-modified 253 (A3A3')Y26C protein or in the absence of a catalyst. These results clearly show that the 254production of H<sub>2</sub> catalyzed by the cobalt (III)-porphyrin was greatly enhanced, by a factor 255 of at least 10, when the latter was buried in the hydrophobic cavity of the (A3A3')Y26C 256 protein. In addition, it is noteworthy that the TON value obtained with the biohybrid 257 (A3A3')Y26C-4 as catalyst was similar to that described by the Ghirlanda's group using 258 Co-cytochrome b 562 as the catalyst [30]. It is also important to note that, even after 25h of 259 irradiation time, the A3A3'Y26C-4 did not show any sign of degradation and continued 260 to show steady production of H<sub>2</sub>. 261

The experiments were carried out in 100 mM ascorbic acid, 100 264 mM potassium phosphate buffer in the presence of 1 mM [Ru(bpy)<sub>3</sub>]<sup>2+</sup> as photosensitizer and of 7 265  $\mu$ M (A3A3')Y26C-<u>4</u> ( $\bullet$ ), Co(III)PPIX ( $\bullet$ ), (A3A3')Y26C ( $\bullet$ ) as catalyst or without catalyst ( $\bullet$ ) 266 under white LED light,  $\lambda > 405$  nm irradiation. All experiments were carried out at least two times. 267

# 2.5.2. Light-driven CO<sub>2</sub> Reduction

The photoinduced reduction of CO2 catalyzed by (A3A3')Y26C-4 (7 µM) was also 269 studied at pH 7.0 and 20 °C in a CO<sub>2</sub> saturated potassium phosphate buffer containing 100 270 mM ascorbic acid as a sacrificial electron donor and 1 mM  $[Ru(bpy)_3]^{2+}$  as a 271 photosensitizer. Figure 8 shows that, under irradiation with a white LED light at  $\lambda > 405$ 272 nm, a significant amount of CO can be produced reaching a plateau with a TON of 80 in 273 about 12 hours. The appearance of this plateau is probably due to the deactivation of the 274 cobalt porphyrin through a carbonyl transfer to one of the meso positions of the porphyrin 275 rim as it was reported by Jiang *et al.* [37]. The time lag of 3h observed before CO 276 production was detected by gas chromatography (GC) can probably be rationalized by an 277 initial accumulation of the CO inside the hydrophobic pocket of the protein before being 278 released when its concentration increases. This CO characteristic was reported to be 279 essential for its transport from CO dehydrogenase where it is produced to the acetyl CoA 280 synthase via direct hydrophobic gas channels before being used in a carbonylation reac-281 tion [37]. When (A3A3')Y26C-4 is replaced by the CoPPIX metalloporphyrin, a plateau at 282 TON = 20 is reached after 7 h. In control experiments, no CO production was observed in 283 the presence of the non-modified (A3A3')Y26C protein as a catalyst or in the absence of a 284 catalyst. Here also, our results clearly show that the production of CO catalyzed by the 285 cobalt porphyrin was greatly enhanced by a factor of 4 when the latter was inserted in the 286 hydrophobic cavity of the (A3A3')Y26C protein. Interestingly, the TON value obtained 287 with the biohybrid (A3A3')Y26C-4 as catalyst was twice higher than that described by the 288 Ghirlanda's group using Co-cytochrome b 562 as the catalyst (42 TON) under similar 289 reaction conditions [18]. 290

# 3. Materials and methods

# 3.1. Synthesis of Co(III)Mal-PPIX <u>4</u> The Co(III)Mal-PPIX cofactor <u>4</u> was prepared in 3 steps. 3.1.1. Protoporphyrin IX dimethyl ester (PPIX DME) hydrolysis [23]. 66.8 mg of Protoporphyrin IX dimethyl ester PPIX DME <u>1</u> were dissolved in 6 N HCl 302

66.8 mg of Protoporphyrin IX dimethyl ester PPIX DME <u>1</u> were dissolved in 6 N HCl 302 and the solution was allowed to stand for 15 minutes at room temperature. This solution 303 was then added to 200 ml chloroform overlayed with 200 ml of 10% (w/v) aqueous sodium 304 acetate. The resulting mixture was then completely neutralized with solid NaHCO<sub>3</sub> to 305 transfer all of the porphyrin into the chloroform organic layer. This layer was then evap-306 orated to dryness and the obtained solid was redissolved in 2 ml of 2,6 lutidine for purifi-307 cation via silica gel column chromatography with dichloromethane/methanol 99/1 as elu-308 ent. PPIX monomethyl ester (PPIX MME) 2 was obtained as a purple solid (18.4 mg, 28 % 309 yield). 310

3.1.2. Synthesis of maleimido-ethylamido-protoporphyrin IX monomethyl ester Mal-PPIX 316 MME 3. 317

PPIX MME 2 (28.5 mg, 49.42 µmol) was dissolved in 1 mL of anhydrous DMF and 15 318 µL of triethylamine were added. PyBOB (36 mg, 69.18 µmol) dissolved in 1mL anhydrous 319 DMF was added to this solution and the reaction medium was left under stirring for 30 320 minutes at room temperature (RT). To this solution a solution of N-(2-ami-321 noethyl)malemide trifluoroacetate salt (13.8 mg, 54.36 µmol) in anhydrous DMF (1mL) 322 was added quickly. The resulting mixture was stirred at room temperature overnight and 323 protected from light. The solvent was removed and the crude product was purified by 324 silica gel chromatography (eluted with 1% MeOH in CHCl3) to give maleimido-ethyl-325 amido-protoporphyrin IX monomethyl ester Mal-PPIX MME 3 as a brown solid (15.7 mg, 326 45 %). 327

3.1.3. Insertion of cobalt into maleimido-ethylamido-protoporphyrin IX monomethyl ester 334 Mal-PPIX MME. 335

In a 10 mL round bottom flask, 15.7 mg (22.5 µmol) of compounds 3 was dissolved 336 in 3 mL anhydrous DMF and a solution of Co(OAc)2.4 H2O (55.96 mg, 225 µmol) in 3 mL 337 anhydrous DMF was added dropwise. The solution was heated at 70 °C until the meta-338 lation was completed as proven by UV-visible spectroscopy. After the solvent was re-339 moved under reduced pressure, the residue was dissolved in 3 mL DCM. The organic 340 layer was then washed 3 times with 100 mL of water, dried over Na<sub>2</sub>SO<sub>4</sub>, filtered and the 341 solvent was removed under reduced pressure, to obtain Co(III)-Mal-PPIX MME 4 as a 342 dark green solid (16.5 mg, 97 %). 343

# 3.2. Production and purification of $\alpha$ Rep proteins

The production and the purification of the  $\alpha$ Rep proteins were carried out essentially 347 as reported in a previous paper [24]. 348

# 3.2.1. Protein production

TheBL21-Gold(DE3)pLys bacteria strain was transformed with the plasmid encoding 350 for the  $\alpha$ Rep protein and grown on 2YT-agar plates supplemented with ampicillin (100 351 µg/mL) and 1% glucose. One clone was picked and grown overnight at 37 °C in 2YT media 352 supplemented with ampicillin (100 µg/mL) and 1% glucose. The overnight preculture was 353 used to inoculate 1 L of fresh 2YT medium containing 100 µg/mL ampicillin and 354

distributed into two 2 L flasks. Cells were grown at 37 °C until the optical density at 600 355 nm reached 0.8 Protein expression was then induced by the addition of 500  $\mu$ M IPTG and 356 cultures were further incubated at 37 °C for 4 h. Cells were harvested by centrifugation 357 for 20 min at 5000 g at 4 °C and resuspended into 40 mL of washing buffer (50 mM sodium 358 phosphate, 300 mM NaCl, 20 mM imidazole pH 8) supplemented with a tablet of EDTA-359 free anti-protease cocktail (Roche). Suspended cells were stored at - 80°C. 360

### 3.2.1. Protein purification

Frozen cells from 1 L of bacterial culture were defrosted and a tablet of EDTA-free 362 anti-protease cocktail (Roche) and 2 µL of DNase I were added. After 30 minutes of incu-363 bation at 4°C, cells were lysed by five 30 s cycles of sonication on ice and centrifuged 1 364 hour at 10000 g at 4 °C. His-tagged proteins were purified from the crude supernatant 365 using nickel-affinity chromatography on a 5 mL Ni-NTA column. The column was 366 washed with 150 mL of washing buffer (50 mM sodium phosphate, 300 mM NaCl, 20 mM 367 imidazole pH 8) and proteins were eluted in six 1 mL fractions in the elution buffer (50 368 mM sodium phosphate, 300 mM NaCl, 300 mM imidazole pH 8). A typical yield of about 369 100 mg of protein per liter of culture was obtained. Eluted fractions were analyzed by 370 SDS-PAGE and pure fractions of proteins were pooled.  $\alpha$ Rep protein was recovered and 371 concentrated resulting in a 5 mL solution that was loaded on a gel filtration column (Hi-372 Load 16/600 Superdex 75, GE Healthcare) equilibrated with coupling buffer (10 mM 373 HEPES 150 mM NaCl pH 7.75). Elution fractions after gel filtration were pooled and 374 stored at 4 °C until chemical coupling. Purity was checked by SDS-PAGE and concentra-375 tions were obtained from the absorbance at 280 nm measured on a Nanodrop spectropho-376 tometer (Thermo Scientific) using an extinction coefficient at 280 nm of 58900 M<sup>-1</sup>.cm<sup>-1</sup> cal-377 culated from the protein sequence (https://web.expasy.org/protparam/). 378

# 3.3. Covalent anchoring of compound 3 into (A3A3')Y26C

In a 50 mL conical tube, 6.25 mL of a 200  $\mu$ M Co(III)-mal cofactor solution in DMSO 380 were added (final concentration 50 µM) to a solution of (A3A3')Y26C in 10 mM HEPES 381 150 mM NaCl pH 7.75 at a final concentration of 5  $\mu$ M, in the presence of DMSO (25 % in 382 the final coupling solution) for a final volume of 25 mL. The solution was stirred for 3 days 383 at 4 °C. The mixture was then extracted with 25 mL of 2-butanone at 0 °C, to remove the 384 excess unreacted Co(III) -mal cofactor, and the remaining solution was cooled in an ice 385 bath. It was then centrifuged at 5000 g for 5 min. The pellet containing the (A3A3')Y26C-386 Co(III)Mal-PPIXMME biohybrid, (A3A3')Y26C-4, was resuspended in 10 mM HEPES, 387 150 mM NaCl pH 8. The obtained protein solution was then loaded on a gel filtration 388 column (HiLoad 16/600 Superdex 75, GE Healthcare), which was equilibrated with 10 mM 389 HEPES 150 mM NaCl pH 8 and (A3A3')Y26C-<u>4</u> cofactor was eluted in a single peak. The 390 purified biohybrid was quantified from its absorbance at 280 nm measured on a 391 Nanodrop spectrophotometer. 392

# 3.4. Photocatalysis Experiments

To a degassed solution of 1 mM [Ru<sup>II</sup>(bpy)<sub>3</sub>]Cl<sub>2</sub> and 100 mM NaAsc, the biohybrid 394 protein was added to lead to a final concentration of 7 µM in a total volume of 3 mL of 0.1 395 M phosphate buffer pH 7. The solution was further degassed with Ar and then irradiated 396 with a SugarCube white LED (200 Wm<sup>-2</sup>; filtered at  $\lambda$ >420 nm) for 25 h. During irradiation, 397 the solution was stirred and thermostated at 20 °C with the RM6 Lauda cooling system. 398 Gas samples from the overhead space were automatically injected into MicroGC Fusion 399 Gas Analyser (Inficon) every hour. For CO<sub>2</sub> reduction, the cell was saturated with CO<sub>2</sub> 400 gas. All experiments were made at least in duplicate.

# 3.5. Spectroscopic characterization of the (A3A3')Y26C-4 biohybrid

Electronic absorption spectra of the oxidized and reduced (A3A3')Y26C-4 biohybrid 403 were recorded and compared to the spectra of other Co-PPIX-protein complexes 404

previously reported in the literature. 1 mL samples of a 7.5  $\mu$ M solution of purified 405 (A3A3')Y26C-4 were prepared in argon-sparged 10 mM HEPES, NaCl 150 mM buffer, pH 4068.0 and placed in a septum-sealed cuvette to ensure anaerobic conditions. The reduction 407 was initiated via addition of 1.5 mM sodium dithionite. Spectra were recorded every five 408 minutes at RT until absorbance changes were no longer observed. 409

# 3.6. Spectroscopic characterization of the (A3A3')Y26C-4 biohybrid

Circular dichroism (CD) spectra were recorded from 185 nm to 260 nm with a data 411 pitch of 0.2 nm, a scan speed of 50 nm min<sup>-1</sup>, a response time of 0.5 s and a bandwidth of 412 2 nm using quartz cells with a 1 mm path length, on a Jasco J810 dichrograph. Each spec-413 trum was recorded five times and averaged. The CD signal was corrected with buffer 414 subtraction resulting in the ellipticity ( $\theta$ ) in mdeg. Data were acquired from a 2.2  $\mu$ M sam-415 ple of biohybrid previously desalted on a Zeba spin desalting column (Thermo) equili-416 brated with 20 mM sodium phosphate buffer, pH 7.5. 417

# 3.7. Computational methods

The coordinates from modelled A3A3'-Y26C-MnTPP were obtained from a previous 419 study [21]. Covalent MnTPP cofactor was removed and MD simulation was performed to 420 obtain the most representative structure of the native form of A3A3'. Cys26 was mutated using the Dunbrack library available at UCSF Chimera [30]. Cofactor 4 structure was op-422 timized with Gaussian16 [38] via QM calculations in water solvent (SMD) [39] using 423 B3LYP functional and Grimme's dispersion D3 with 6-31G(d,p) for CHONS atoms and 424 SDD + F for Co [40]. The oxidation state of Co was set to III and spin state was singlet. 425

Covalent dockings were performed using GOLD5.8.0 [31] using as score function 426 Goldscore with paramaters adapted from for metals [41]. Covalent linkage was performed 427 with CA-Cys26 Radius search was set to 15 Å and 50 runs were performed. Flexibility to 428 certain residues was given by allowing free rotation of side chains. 429

MD simulations were prepared using xleap [42], using as the force field FF19SB for 430 proteins, TIP3P for water and GAFF for non-standard residues. MCPB.py was used to 431 parametrize cofactor 4 using the Seminario method [43] for force constants and parame-432 ters and RESP for charge and RESP method for charges [44]. Optimization, frequency and 433 RESP calculations were performed at the same level of theory specified before. The system 434 was solvated using a cubic water box and Na<sup>+</sup> as counter ions were added to neutralize. 435 MD simulations were performed using AMBER20 software [32]. Three different energy 436 minimizations were performed to relax the system followed by a heating step in which 437 the system equilibrated from 0 K to 300 K. Finally, NVT and NPT equilibrations were 438 performed, followed by a 400 ns production run. Detailed computational can be found in 439 SI. 440

# 4. Conclusion

In summary, an artificial metalloenzyme was obtained by covalent coupling of 442 Co(III)Mal-PPIXMME 4 to the mutant (A3A3')Y26C of an artificial bidomain protein 443 named alpha Rep ( $\alpha$ Rep). This new artificial metalloenzyme (A3A3')Y26C-<u>4</u> was 444 characterized by Maldi-TOF MS, circular dichroism and UV-visible spectrophotometry. 445 The Comparison of the maxima of absorption of (A3A3')Y26C-4 with those of various 446 Co(II)- and Co(III)-PPIX-substituted hemoproteins (Table 1) suggested the possible 447 coordination of the cobalt ion by an axial histidine. However, investigation of the structure 448 of this biohybrid and the positioning of the residues near the metal complex using 449 theoretical experiments suggested the possible coordination of the metal by an axial glu-450 tamine Gln283 although it would be transient in nature and mutagenic efforts may be 451 needed to improve axial coordination. 452

The (A3A3')Y26C-4 biohybrid was then shown to be able to catalyze, not only the 453 photoinduced production of  $H_2$ , but also the reduction of  $CO_2$  into CO. While the 454 Co(III)porphyrin catalyst alone showed a low activity with respect to these two reactions, 455 more than 10 times more  $H_2$  and 4 times more  $CO_2$  were produced in the reaction whereby 456 the Co(III)porphyrin was buried within the hydrophobic cavity of the protein. Based on 457 these results, we will thus be able in the future to optimize our biohybrid by carrying out 458 different mutants for axial coordination and also to introduce positive charges on the 459 proximal face of the biohybrid, which should increase the local concentration of CO<sub>2</sub> in 460 the enzymatic cavity to enhance its conversion into CO. 461
