# Divsets, numerical semigroups and Wilf's conjecture

#### Abstract

Let $S \subseteq \mathbb{N}$ be a numerical semigroup with multiplicity $m=\min (S \backslash\{0\})$ and conductor $c=\max (\mathbb{N} \backslash S)+1$. Let $P$ be the set of primitive elements of $S$, and let $L$ be the set of elements of $S$ which are smaller than $c$. Wilf's conjecture (1978) states that the inequality $|P||L| \geq c$ always hold. The conjecture has been shown to hold in case $|P| \geq m / 2$ by Sammartano in 2012, and subsequently in case $|P| \geq m / 3$ by the author in 2020. The main result in this paper is that Wilf's conjecture holds in case $|P| \geq m / 4$ with $c \in m \mathbb{N}$.


## 0 Caution

This document is the starting point of a full paper to be gradually completed in successive versions within the next few weeks of Fall 2023.

## 1 Introduction

A numerical semigroup is a cofinite submonoid $S$ of $\mathbb{N}$, i.e. a subset containing 0 , stable under addition and with finite complement $\mathbb{N} \backslash S$. Equivalently, it is a set of the form $S=$ $\left\langle a_{1}, \ldots, a_{n}\right\rangle=\mathbb{N} a_{1}+\cdots+\mathbb{N} a_{n}$ where $a_{1}, \ldots, a_{n}$ are positive integers with $\operatorname{gcd}\left(a_{1}, \ldots, a_{n}\right)=1$, called generators of $S$. The least such $n$ is usually denoted $e$ and called the embedding dimension of $S$, see below.

Let $S$ be a numerical semigroup and $S^{*}=S \backslash\{0\}^{*}$. A primitive element of $S$ is an element $a \in S^{*} \backslash\left(S^{*}+S^{*}\right)$, i.e. an element of $S^{*}$ which is not the sum of two elements of $S^{*}$. We denote by $P=P(S)$ the set of primitive elements of $S$, and by $D(S)=S^{*} \backslash P(S)=S^{*}+S^{*}$ the set of decomposable elements of $S$. It is easy to see that $P$ is finite and is the unique minimal generating set of $S$. The embedding dimension of $S$ is $e=e(S)=|P|$, the multiplicity of $S$ is $m=m(S)=\min S^{*}$, the Frobenius number of $S$ is $F=F(S)=\max (\mathbb{Z} \backslash S)$ and the conductor of $S$ is $c=c(S)=F+1$, satisfying $c+\mathbb{N} \subseteq S$ and minimal with respect to that property. The genus of $S$ is $g=g(S)=|\mathbb{N} \backslash S|$, its number of gaps. We partition $S$ as $S=L \sqcup R$, where $L=L(S)=\{a \in S \mid a<F(S)\}$ and $R=R(S)=\{a \in S \mid a>F(S)\}$, the left part and right part of $S$, respectively.

Currently, one of the main open problems on numerical semigroups is the following conjecture, first stated as a question by Wilf [21].

Conjecture 1.1 (Wilf, 1978). Let $S$ be a numerical semigroup. Then $|P||L| \geq c$.
See [5] for a survey on the conjecture up to 2018. Among many partial results, the conjecture has been shown to hold in case $|P| \geq m / 2$ by Sammartano in 2012 [19], and subsequently in case $|P| \geq m / 3$ by the author in 2020 [9]. The main result in this paper is as follows.

Theorem 1.2. Let $S$ be a numerical semigroup such that $c \in m \mathbb{N}$ and $|P| \geq m / 4$. Then $S$ satisfies Wilf's conjecture.

The motivation to focus on the case $c \in m \mathbb{N}$ is justified in Section 2.

## 2 Special numerical semigroups

Given a numerical semigroup $S$, consider the Euclidean division of its conductor $c$ by its multiplicity $m$ with nonpositive remainder:

$$
\begin{equation*}
c=q m-\rho, \quad 0 \leq \rho \leq m-1 . \tag{1}
\end{equation*}
$$

As in [11], we call the integer $q=\lceil c / m\rceil$ the depth of $S$. The particular case $c=q m$, i.e. with $\rho=0$, might well be the heart of Wilf's conjecture. Indeed, the proofs of Wilf's conjecture in either case $c \leq 3 m$ [8] or $|P| \geq m / 3$ [9] can be significantly shortened when $\rho=0$. Moreover, the first five instances of the very rare "near-misses in Wilf's conjecture" all belong to this case [10].

These facts lead us to believe that if Wilf's conjecture fails for some exotic numerical semigroups, then it already fails in cases where $\rho=0$. This justifies introducing the following terminology.

Definition 2.1. A numerical semigroup $S$ is special if $c \in m \mathbb{N}$, where $m$ is its multiplicity and c is its conductor.

For instance, the ordinary numerical semigroup $O_{m}=\{0\} \cup(m+\mathbb{N})$ is special since it satisfies $c=m$. The above discussion leads us to consider the special case as a priority in research on Wilf's conjecture.

In this context, we extend here the validity of Wilf's conjecture to the case $|P| \geq m / 4$ for special numerical semigroups. More generally, using the notation in (1), our main result in this paper reads as follows.

Theorem 2.2. Let $S$ be a numerical semigroup satisfying $|P| \geq m / 4$. Then $|P||L| \geq c-m+\rho$. Morever, if S is special, then $|P||L| \geq c$, i.e. $S$ satisfies Wilf's conjecture.

## 3 The Apéry set

Notation 3.1. Let $S$ be a numerical semigroup of multiplicity $m$. We denote by $A=A P(S, m)$ the Apéry set of $S$ with respect to $m$, defined as

$$
A=S \backslash(m+S)
$$

We set $A^{*}=A \backslash\{0\}$.
Definition 3.2. Let $S$ be a numerical semigroup of multiplicity $m \geq 2$ and conductor $c$. The level function of $S$ is $\lambda: S \rightarrow \mathbb{N}$ defined by $\lambda(s)=\lceil s / m\rceil$ for all $s \in S$. Thus $\lambda(s)=l$ if and only if $s \in S \cap[[l m-\rho,(l+1) m-\rho-1]]$.

Proposition 3.3. Let $S$ be a numerical semigroup with level function $\lambda: S \rightarrow \mathbb{N}$. Then $\lambda\left(s_{1}+\right.$ $\left.s_{2}\right) \in\left\{\lambda\left(s_{1}\right)+\lambda\left(s_{2}\right)-1, \lambda\left(s_{1}\right)+\lambda\left(s_{2}\right), \lambda\left(s_{1}\right)+\lambda\left(s_{2}\right)+1\right\}$ for all $s_{1}, s_{2} \in S$.

Proof. Let $l_{i}=\lambda\left(s_{i}\right)$ for $i=1,2$. Then $s_{i} \in S \cap\left[\left[l_{i} m-\rho,\left(l_{i}+1\right) m-1-\rho\right]\right]$ for $i=1,2$. Hence $s_{1}+s_{2} \in S \cap\left[\left[\left(l_{1}+l_{2}\right) m-2 \rho,\left(l_{1}+l_{2}+2\right) m-2-2 \rho\right]\right]$. Etc.

Definition 3.4. Let $S$ be a numerical semigroup of depth $q \geq 1$. The depth function of $S$ is the function $\delta: S \rightarrow \mathbb{Z}$ defined by $\delta(s)=q-\lambda(s)$ for all $s \in S$.

Notation 3.5. Given a finite subset $X \subset S$, we denote by $\tau(X)$ its total depth, i.e. $\tau(X)=$ $\sum_{x \in X} \delta(x)$.

Proposition 3.6. Assume $S$ is special of depth $q$. Then $W(S)=|P| \tau\left(A^{*}\right)-|A \cap D| q$.

## 4 Divsets

Notation 4.1. Let $x_{1}, \ldots, x_{n}$ be commuting variables. We denote by $M=\left\{x_{1}^{a_{1}} \cdots x_{n}^{a_{n}} \mid\left(a_{1}, \ldots, a_{n}\right) \in\right.$ $\left.\mathbb{N}^{n}\right\}$ the set of all monomials in $x_{1}, \ldots, x_{n}$. For $d \in \mathbb{N}$, we denote by $M_{d} \subset M$ the subset of monomials $u \in M$ of degree $d$.

Definition 4.2. $A$ divset is a finite set $X$ of monomials in $n$ variables $x_{1}, \ldots, x_{n}$ which is stable under taking divisors. That is, for all $u \in X$, if $v \in M$ and $v \mid u$ then $v \in X$.
Example 4.3. $X=\left\{x_{1}^{3}, x_{1}^{2} x_{2}, x_{1}^{2}, x_{1} x_{2}, x_{1}, x_{2}, 1\right\}$ is a divset in the variables $x_{1}, x_{2}$.
Notation 4.4. Given a set of $U$ of monomials in $\left\{x_{1}, \ldots, x_{n}\right\}$, we denote by $[U]$ the set of divisors of the elements of $U$. That is, $[U]=\{v \in M|\exists u \in X, v| u\}$.

In the above example $X=\left\{x_{1}^{3}, x_{1}^{2} x_{2}, x_{1}^{2}, x_{1} x_{2}, x_{1}, x_{2}, 1\right\}$, we have $X=\left[x_{1}^{3}, x_{1}^{2} x_{2}\right]$.
Definition 4.5. Let $X$ be a divset. We define the degree of $X$ as

$$
\operatorname{deg}(X)=\max \{\operatorname{deg}(u) \mid u \in X\}
$$

Notation 4.6. Let $X$ be a divset. We denote by $\max (X)$ the maximal elements of $X$ under divisibility, i.e. the set of those $u \in X$ which do not divide any $v \in X \backslash\{u\}$.

Clearly, a divset $X$ is completely determined by $\max (X)$, as $X=[\max (X)]$.
Notation 4.7. Let $X$ be a divset on the variables $\left\{x_{1}, \ldots, x_{n}\right\}$. For all $d \geq 0$, we denote $X_{d}=X \cap M_{d}=\{u \in X \mid \operatorname{deg}(u)=d\}$.

For instance, we have $X_{0}=\{1\}$ and $X_{1}=\left\{x_{1}, \ldots, x_{n}\right\}$.
Notation 4.8. Let $X$ be a divset. We denote by $D(X)=\{u \in X \mid \operatorname{deg}(u) \geq 2\}$, i.e. the set of decomposable monomials in $X$. Thus $X=\{1\} \sqcup X_{1} \sqcup D(X)$. We denote $X^{*}=X \backslash\{1\}$.

### 4.1 The graph of a divset

Let $X$ be a divset. We canonically associate to $X$ a graph $G=G(X)$ defined as follows. An edge in $G$ is a pair $\left\{u_{1}, u_{2}\right\}$ with $u_{1}, u_{2} \in X^{*}$ such that $u_{1} u_{2} \in X$. This defines the edge set $E(G)$. The set $V(G)$ of vertices of $G$ is defined as the set of the extremities of the edges. Said otherwise, we have $V(G)=\left\{u \in X^{*} \mid \exists v \in X^{*}, u v \in X\right\}$.

An important measure of $X$ in the sequel is the vertex-maximal matching number of the graph $G(X)$, defined below.

Notation 4.9. We set $\operatorname{vm}(X)=$ the largest cardinality of a subset $Y \subseteq X^{*}$ obtained as the set of vertices of a matching in $G(X)$, i.e. a union of pairwise disjoint pairs $\{u, v\} \subseteq Y$ such that $u v \in X$.

Definition 4.10. Let $X$ be a divset on $n$ variables. We say that $X$ is tame if

$$
(n+1) \operatorname{vm}(X) \geq 2|D(X)|
$$

We say that $X$ wild if it is not tame.
The link with Wilf's conjecture will become clear in the next section.

### 4.2 Divsets and numerical semigroups

In a numerical semigroup $S$ of multiplicity $m$, its Apéry set with respect to $m$ carries key information on the structure of $S$.

Notation 4.11. Let $S$ be a numerical semigroup of multiplicity $m$. We denote by $A=A P(S, m)$ the Apéry set of $S$ with respect to $m$, defined as

$$
A=S \backslash(m+S)
$$

We set $A^{*}=A \backslash\{0\}$.

It is well known that $A P(S, m)$ has exactly $m$ elements, one for each class mod $m$. More precisely, we have

$$
A P(S, m)=\left\{w_{0}, \ldots, w_{m-1} \mid w_{i}=\min (S \cap(i+m \mathbb{N}))\right\}
$$

It turns out that divsets can be considered as a sort of abstract model for Apéry sets. This will be made more precise below.

Definition 4.12. Let $S$ be a numerical semigroup and $X$ a divset. A morphic map from $X$ to $S$ is a map $f: X \rightarrow S$ such that $f(1)=0$ and $f(u v)=f(u)+f(v)$ for all $u, v \in X$.

Definition 4.13. Let $S$ be a numerical semigroup of multiplicity m. Let $A=A P(S, m)$. A divset representation of $S$ is a injective morphic map $f: X \rightarrow S$, where $X$ is a divset of cardinality $|X|=m$ and such that $f(X)=A$.

Proposition 4.14. Let $S$ be a numerical semigroup of multiplicity $m$. Then $S$ admits at least one divset representation.

Proof. The key point is the well known fact that, for any Apéry element $a \in A^{*}$, if there is a decomposition $a=s_{1}+s_{2}$ with $s_{1}, s_{2} \in S^{*}$, then necessarily $s_{1}, s_{2} \in A^{*}$.

Proposition 4.15. Let $S$ be a numerical semigroup such that $c \in m \mathbb{N}$ and which is represented by a tame divset $X$. Then $S$ satisfies Wilf's conjecture.

Proof. We have $\tau\left(X^{*}\right) \geq \operatorname{vm}(X) q / 2$. Hence

$$
\begin{aligned}
W_{0}(S) & =|P \cap L| \tau\left(X^{*}\right)-|X \cap D| q \\
& \geq(n+1) \operatorname{vm}(X) q / 2-|X \cap D| q \\
& =((n+1) \operatorname{vm}(X)-2|X \cap D|)) q / 2 .
\end{aligned}
$$

Since $X$ is tame by hypothesis, we have $(n+1) \operatorname{vm}(X)-2|X \cap D| \geq 0$. Hence $W_{0}(S) \geq 0$.

## 5 The case $\operatorname{deg}(X)=2$

We prove here that divsets of degree 2 are tame. This establishes Wilf's conjecture for all special numerical semigroups $S$ such that $D(S) \subseteq P+P$. In order to do so, we need the following lemma about the classical matching number in graphs, namely the maximum number of independent edges.

Lemma 5.1. Let $H=\left(H_{1}, H_{2}\right)$ be a simple bipartite graph without isolated vertices, with matching number $k$. Then

$$
|E(H)| \leq k \cdot \max \left(\left|H_{1}\right|,\left|H_{2}\right|\right) .
$$

Proof. We may assume $\left|H_{1}\right| \leq\left|H_{2}\right|$. Then $k \leq\left|H_{1}\right|$. Let $M$ be a maximal matching with $k$ edges, say

$$
M=\left\{\left(x_{i}, y_{i}\right) \mid x_{i} \in H_{1}, y_{i} \in H_{2}, 1 \leq i \leq k\right\} .
$$

Claim. $\left|H_{1}\right|=k$. Assume not. Let then $x_{k+1} \in H_{1} \backslash\left\{x_{1}, \ldots, x_{k}\right\}$. Since $H$ does not have isolated vertices, it follows that $x_{k+1}$ has a neighbour $z \in H_{2}$. Now necessarily $z \in\left\{y_{1}, \ldots y_{k}\right\}$, for otherwise there would be a new edge $\left(x_{k+1}, z\right)$ independent of $M$, which would then yield a matching of cardinality $k+1$, a contradiction. Up to renumbering, we may assume $z=y_{k}$, i.e.

$$
\left(x_{k+1}, y_{k}\right) \in E
$$

As $\left|H_{2}\right| \geq\left|H_{1}\right| \geq k+1$, there is a vertex $y_{k+1} \in H_{2} \backslash\left\{y_{1}, \ldots, y_{k}\right\}$. Since $y_{k+1}$ is not isolated, it has a neighbour $z \in H_{1}$. But as in the preceding reasoning, we have $z \in\left\{x_{1}, \ldots, x_{k}\right\}$, for otherwise the edge $\left(z, y_{k+1}\right)$ would be independent of $M$, a contradiction. Up to renumbering, we may assume $z=x_{k}$. Thus

$$
\left(x_{k}, y_{k+1}\right) \in E
$$

But then, by suppressing the edge ( $x_{k}, y_{k}$ ) of $M$ and replacing it by the two independent edges $\left(x_{k+1}, y_{k}\right),\left(x_{k}, y_{k+1}\right)$, we obtain a matching

$$
M^{\prime}=M \sqcup\left\{\left(x_{k+1}, y_{k}\right),\left(x_{k}, y_{k+1}\right)\right\} \backslash\left\{\left(x_{k}, y_{k}\right)\right\}
$$

of cardinality $k+1$, a contradiction. This finishes the proof of the claim, whence

$$
\left|H_{1}\right|=k
$$

Since $H=\left(H_{1}, H_{2}\right)$ is bipartite, we have $|E| \leq\left|H_{1}\right|\left|H_{2}\right|=k\left|H_{2}\right|$, as claimed.
Proposition 5.2. Let $X$ be a divset of degree 2, i.e. such that $D(X)=X_{2}$. Then $X$ is tame, i.e. $(n+1) \vee \mathrm{vm}(X) \geq 2|D(X)|$, where $n=\left|X_{1}\right|$.

Proof. Let $V=\left\{x_{1}, \ldots, x_{n}\right\}$, the set of variables dividing the monomials of $X \cap D$. Then $|X \cap D| \leq n(n+1) / 2$. Let $M \subseteq X \cap D$ be a maximal set of monomials of degré 2 and pairwise coprime. Denote $V_{1} \subseteq V$ the set of variables involved in $M$. Let $V_{2}=V \backslash V_{1}, n_{1}=\left|V_{1}\right|$ and $n_{2}=\left|V_{2}\right|=n-n_{1}$. By construction, we have

$$
\tau\left(V_{1}\right) \geq n_{1} q / 2
$$

Case 1. $V_{1}=V$. In this case we are done. Indeed, we then have $\tau(V)=\tau\left(V_{1}\right) \geq n q / 2$, and since $|X \cap D| \leq n(n+1) / 2$, it follows that

$$
\begin{aligned}
W(S) & =|P| \tau(V)-|X \cap D| q \\
& \geq(n+1) n q / 2-n(n+1) / 2 \cdot q \\
& \geq 0
\end{aligned}
$$

Case 2. Assume $V_{1} \neq V$, i.e. $V_{2} \neq \emptyset$. By maximality of $M$, it follows that every monomial $u=x_{i} x_{j} \in X \cap D$ with $i \leq j$ satisfies $x_{i} \in V_{1}$. Let $k$ be the maximum number of monomials $u=x_{i} x_{j}$ with $x_{i} \in V_{1}, x_{j} \in V_{2}$ and pairwise coprime. We have $k \leq \min \left(n_{1}, n_{2}\right)$, but also $k \geq 1$ since $V_{2} \neq \emptyset$. For each such pair $\left(v_{1}, v_{2}\right) \in V_{1} \times V_{2}$, i.e. with $v_{1} v_{2} \in X \cap D$, we have $\delta\left(v_{1}\right)+\delta\left(v_{2}\right) \geq q$. This already contributes $k q$ to $\tau(X)$. Thus

$$
\begin{equation*}
\tau(X) \geq\left(n_{1}-k\right) q / 2+k q . \tag{2}
\end{equation*}
$$

Next, we claim that

$$
\begin{equation*}
|X \cap D| \leq n_{1}\left(n_{1}+1\right) / 2+k \max \left(n_{1}, n_{2}\right) \tag{3}
\end{equation*}
$$

Indeed, as $V_{2}$ is the empty graph, every monomial in $X \cap D$ has its support in $\left[V_{1}, V_{1}\right]$ or $\left[V_{1}, V_{2}\right]$. But the preceding lemma implies that the number of monomials with support in [ $V_{1}, V_{2}$ ] is less than or equal to $k \max \left(n_{1}, n_{2}\right)$. This proves (3).

Now, $W(S) \geq(n+1) \tau(V)-|X \cap D| q$. Hence, by (2) and (3), we have

$$
\begin{aligned}
W(S) & \left.\geq(n+1)\left(\left(n_{1}-k\right) / 2+k\right) q-n_{1}\left(n_{1}+1\right) / 2-k \max \left(n_{1}, n_{2}\right)\right) q \\
& =\left((n+1)\left(n_{1}+k\right)-n_{1}\left(n_{1}+1\right)-2 k \max \left(n_{1}, n_{2}\right)\right) q / 2 .
\end{aligned}
$$

It remains to show that $(n+1)\left(n_{1}+k\right)-n_{1}\left(n_{1}+1\right)-2 k \max \left(n_{1}, n_{2}\right) \geq 0$. We have

$$
\begin{aligned}
(n+1)\left(n_{1}+k\right)-n_{1}\left(n_{1}+1\right)-2 k \max \left(n_{1}, n_{2}\right) & =n_{1}(n+1)-n_{1}\left(n_{1}+1\right)+k\left(n+1-2 \max \left(n_{1}, n_{2}\right)\right) \\
& =n_{1} n_{2}+k\left(n_{1}+n_{2}+1-2 \max \left(n_{1}, n_{2}\right)\right) \\
& =n_{1} n_{2}+k\left(\min \left(n_{1}, n_{2}\right)-\max \left(n_{1}, n_{2}\right)+1\right)
\end{aligned}
$$

since $n_{1}+n_{2}=\min \left(n_{1}, n_{2}\right)+\max \left(n_{1}, n_{2}\right)$. But if $k \leq a \leq b$, we have

$$
\begin{aligned}
a b+k(a-b+1) & =k(a+1)+b(a-k) \\
& \geq k(a+1) .
\end{aligned}
$$

It follows that $(n+1)\left(n_{1}+k\right)-n_{1}\left(n_{1}+1\right)-2 k \max \left(n_{1}, n_{2}\right) \geq k\left(\min \left(n_{1}, n_{2}\right)+1\right)$.
