#### Standard narrative

- Ireland pre-1960 marked by traditional nationalism
- Change of policy adopted in 1958
  - Involving an embrace of internationalism
  - And particularly European integration
  - And a move away from nationalism



# Three possible flaws in this argument



- That the government was the sole driver of change
- That the direction of change was uncontested
- That the change would marginalise Irish nationalism

#### An alternative version

- Multiple drivers of change
- Different directions of movement
- A redefinition of Irish nationalism



## Three drivers of change three destinations?

- Political leadership
  - European integration
- Economic development
  - US-led internationalism
- Socio-cultural adaptation
  - Diffuse transnationalism



## Nationalism in internationalism



- Adaptation of nationalism to fit an internationalised world
  - From absolute, exclusive nationalism based on identity legitimacy
  - To pooled, inclusive nationalism focused on output legitimacy
- Adaptation of internationalism to accommodate nationalism
  - A contested concept with (at least) three versions

#### Traditional and revised nationalism

	Traditional nationalism	Revised nationalism
Ethnic identity	Single and distinctive	Overlapping and diverse
Concept of sovereignty	Hard – own state, borders	Shared – nested, porous
Economic & social outlook	Autonomous development	Emphasis on progress
National identity	Unique and separate	Multiple and shared

## Ireland & Europe pre-1960

- Strong focus on traditional nationalism
  - Sovereignty of state (IFS, border)
  - Party system built on nationalist split
  - Catholic social values written into constitution
  - Autarkic approach to economic development
  - Very few international links




## Path to membership

- Switch to open, export-oriented economy
- EEC was not an inevitable corollary
  - Still a very high degree of dependence on UK
  - Still a very limited economy
- But it was an obvious consideration




### At this stage...

- Very much government-led
- Most economic sectors supportive
  - Though note some of the "protected" sectors
- Most of the public supportive
  - Apart from traditional nationalists



## Adaptation to membership

- Learning the norms of cooperative behaviour
- Adapting to economics of Common Market
- Somewhat mercenary mentality

- Membership of the EMS
- Diversification of Irish trade
- Role of EC in Northern Ireland



#### The Irish miracle

- Celtic Tiger boom
  - 1995-2000 average annual growth rate of 9.5%
    - Largely fuelled by multinational investment
  - 2001-2008 average annual growth rate of 5.9%
    - Largely fuelled by property speculation



## The trouble with tigers

- Corporation tax
- False image of Irish prosperity
- Different explanations of the boom
- Limits to growth



#### Crisis after crisis

- Financial crash & bailouts
- Migration challenge
- Brexit crisis
- Covid crisis
- Russian crisis



## The impact of the crises



- From a more EU-sceptic stance (financial crisis)
- To not much impact at all (migration, Russia)
- To reinforcing solidarity with the EU (Covid)
  - Or EU and US (Brexit)

## N-in-I: political changes

- Focus on European integration
- High degree of commitment
- Benefits of cooperation



## N-in-I: economic factors and actors

- Growth of a thriving Irish economy
- Two competing visions:
  - The European one
  - The American one
- Boston or Berlin debate



#### N-in-I: social dimensions

- Inward migration to Ireland
- Secularisation of society
- Exposure to a much wider world
  - Travel and telecoms



### Impact on nationalism

- Weakening of traditional perceptions
- Greater focus on economic progress
- Greater focus on social transformation



## Impact on international dimensions



- Some of this draws Ireland closer to (western) European norms
- Some of it moves Ireland towards a much more global identity
- But overall, a strong sense that EU is good for Ireland

## Directions of change

- Integration
  - Both economic and political
- Internationalism
  - Predominantly economic
- Transnationalism
  - Strong social and cultural elements
