#### 32 Abstract

33 Atmospheric particulate matter (APM) produced by the steel industry is a complex 34 mixture of particles that includes a wide variety of metals and metallic nanoparticles. 35 These particles settle out onto areas surrounding the industries. There is evidence that this 36 'settleable' APM (SePM) may cause air-to-water cross-contamination with significant 37 effects on aquatic biota. Recent investigations have reported sublethal impacts on gill 38 structure and blood oxygen-carrying capacity of fishes, which raises the hypothesis that 39 there will be consequences for gas exchange capacity and ability to support aerobic 40 activities. Therefore, we investigated the effects of an environmentally relevant level of 41 SePM contamination on swimming performance and associated aerobic metabolic rates 42 in Nile tilapia, Oreochromis niloticus. Short-term exposure (96h) to SePM reduced 43 critical swimming speed, energetic efficiency of aerobic swimming, standard metabolic 44 rate, maximum metabolic rate, and aerobic scope. The compromised swimming 45 performance could have adverse ecological effects by limiting foraging ability, predator evasion, territorial protection, and migration. The impairments to aerobic capacity could 46 also affect overall fish performance by influencing long-term energy balance and 47 48 allocation to growth and reproduction. Thus, despite being sublethal, SePM 49 contamination is considerably debilitating and, if its limiting effects are not compensated 50 in the longer term, it could reduce the survival and fitness of fish populations.

#### 1. Introduction

Small amounts of metals/metalloids occur naturally in the aquatic environment 56 57 through biogeochemical cycles. However, industrial activity causes a continuous and 58 persistent production of atmospheric particulate matter (APM), affecting land and water 59 bodies in diverse ecosystems (Callén et al., 2009; Park and Kim, 2005; Salgado, 2003; 60 Tsai and Cheng, 2004). APM is usually composed of a complex mixture of particles that 61 vary in shape and size. Its final composition can be variable and contains emerging metal 62 compounds with unpredictable new combinations of metals and metal nanoparticles 63 (Nordberg et al., 2007; Salgado, 2003; Soriano et al., 2012).

64 Although, recent publication has revealed potential risk to fish biota (e.g., Soares 65 et al., 2022 De Angelis et al., 2022), the presence of metallic particles from APM 66 deposition (sedimentable APM - SePM) in water bodies has not been properly monitored. 67 Several environmental regulatory agencies still do not consider air-water cross-68 contamination in their environmental monitoring programs (e.g., CONAMA, 2018, Environmental Protection Agency - EPA, and European Union and Canada). For 69 70 example, estuarine waters close to the steel industrial complex in Vitoria Bay in the state 71 of Espírito Santo, Brazil, receive constant deposition, of varying intensity, of metallic particles from SePM such as Al, Cr, Mn, Fe, Ni, Cu, Zn, As, Se, Ag, Cd, Hg, and Pb (µg 72 73  $\cdot$  L<sup>-1</sup>, Souza et al., 2021b, 2021a).

Previous studies in the environs of Vitoria city have found that SePM can affect the aquatic environment and cause bioaccumulation (Souza et al., 2013) and biomagnification processes through the food web (Santos et al., 2017; Souza et al., 2018). Environmentally relevant levels of SePM contamination have adverse effects on fishes, such as deleterious impacts on hematological status and innate immunity, and stress responses (*O. niloticus*, Soares et al., 2022). In particular, SePM had effects that would

compromise blood oxygen-carrying capacity, causing a reduction in hematocrit, erythrocyte numbers, and mean corpuscular hemoglobin concentration (Soares et al., 2022). Moreover, exposure to SePM also caused gill damage and ventilatory alterations in the same species (De Angelis et al., 2022). These findings indicate that SePM may cause limitations to physiological performance when aerobic metabolic demand increases, with consequences for activities such as swimming, feeding, reproducing, and diverse other components of population functioning.

87 This hypothesis can be investigated with measurements of swimming capacity and 88 associated aerobic metabolism (McKenzie et al., 2007; Plaut, 2001; Priede, 1985). 89 Swimming capacity is a key physiological variables; that have direct ecological relevance 90 because they define fish capacity to forage, evade predators, protect territory, and migrate, 91 among many other activities that can influence survival and fitness (McKenzie et al., 92 2007; Plaut, 2001; Priede, 1985). At the same time, the associated aerobic metabolism 93 indicates the resting metabolic rate, the minimum and maximum aerobic capacity, and 94 the respective aerobic scope. Fish activities are energetically located inside its aerobic 95 scope. A scope alteration just changes the overall animal capacity to perform. Therefore, 96 that is directly correlated to its ecology; since aerobic scope is considered a parameter of 97 animal performance in relation to environmental conditions, especially related to 98 instantaneous energy-demanding activities (Domenici et al., 2013; Lucas et al., 2021; 99 Milinkovitch et al., 2012).

100 Swimming performance and elements of aerobic metabolism have long been 101 known to be sensitive to environmental factors and stressors and have been used 102 extensively as biomarkers of the toxicological effects of pollutants (Beamish, 1978; Brett, 103 1967; Sprague, 1971).

104 We assessed the result of short-term (96h) exposure to an environmentally 105 relevant level of SePM contamination on the swimming performance and aerobic 106 metabolism of Nile tilapia. This tropical freshwater species provides a good model for 107 ecotoxicology because its physiology is well-studied (Solis et al., 2007). It has been 108 introduced into many tropical and sub-tropical countries across the globe, where it 109 provides important fisheries (De Silva et al., 2004; Schofield et al., 2011), and it inhabits 110 the SePM-contaminated sites in the Vitória Bay area (Gallão et al., 2019). Our approach 111 allowed us to identify and assess sublethal effects of SePM on functional biomarkers that 112 are relevant to animal performance. This allows projection of consequences for 113 individuals and populations of an important food fish, with implications that are relevant 114 both to environmental quality and human health.

- 116 **2. Materials and Methods**

## 117 Settleable Atmospheric Particulate Matter - SePM

118 SePM collection and analysis methods have been described previously (Soares et 119 al., 2022). It is composed of a complex mixture of particles, especially emerging metal 120 compounds with unpredictable new combinations of metals and metal nanoparticles; its 121 composition varies in shape and size. (Nordberg et al., 2007; Salgado, 2003; Soriano et 122 al., 2012). The SePM used in this experiment was collected at Ilha do Boi (20°18'32"S, 40°16'33"O), near the industrial complex of Tubarão in Vitória City (5-8 g/m<sup>2</sup> of SePM 123 124 each month over an area of 5,000 m<sup>2</sup>, Souza et al., 2021a). This location has an intensive 125 influence of SePM emitted by this industrial complex, which is integrated by an iron 126 pelleting industry and an iron and steel exportation harbor (Santos et al., 2017). The SePM 127 presence in the water environment may be related to input from air and water run-off from 128 hard-standing areas (McLusky and Elliott, 2004). Recently, isotopic analyses

demonstrated that the metals present in that SePM (emitted from the nearby industrial
complex) were in fact the main source of aquatic contamination in those water bodies.
(Souza et al., 2018). Industrial activity may vary seasonally, influencing SePM deposition
(Santos et al., 2017; Souza et al., 2019). Therefore, we sampled the contaminant from a
pool of raw SePM collected over a year in order to assure experimental repeatability (De
Angelis et al., 2022; Soares et al., 2022).

Similar to previous experiments, we used 1  $g \cdot L^{-1}$  of raw SePM mass to produce 135 environmentally realistic contamination in the exposed group (De Angelis et al., 2022; 136 137 Soares et al., 2022), this level of contamination is similar to that observed in estuarine 138 waters close to Vitória Bay observed in environmental records (aquatic environment) and 139 reported by the Institute of the Environment and Water Resources for the estuarine area 140 near the city of Vitória, ES - Brazil (IEMA, 2021; Santos et al., 2017; Souza et al., 2013). 141 Arrivabene et al. (2015) reported SePM in the estuarine waters of Santa Cruz and Vitória 142 Bay, which is related to air-water cross-contamination from metallurgical activity. Souza 143 et al. (2013) established chemical characterization of metallic contaminants in these 144 estuarine waters and observed significant amounts of metals and metalloids from SePM 145 in surface waters, interstitial water, and sediments (Al, Cr, Mn, Fe, Ni, Cu, Zn, As, Se, Ag, Cd, Hg, and Pb -  $\mu g \cdot L^{-1}$ ). The raw SePM was diluted in the experimental water (see 146 147 below). A sample of the SePM used for contamination was stored for any further analyses 148 and evaluations. The Control group was not exposed to SePM.

We collected water samples from the experimental aquaria for quantitative and qualitative metal analyses. We used mass spectrometry with inductively coupled plasma (Q-ICPMS, Agilent 7500 Series CX technology) equipped with an Awe SX-100 autosampler (CETAC-technologies, Omaha, NE, USA) at the Food Science and 153 Technology Institute of Córdoba (YCITAC - Universidad Nacional de Cordoba,154 Argentina).

## 156 Fish supply and acclimation

157 Juveniles of O. niloticus were provided by the Polettini fish farm (Mogi-Mirim -158 SP. Brazil) and transported to the Department of Physiological Sciences at UFSCar (São 159 Carlos – SP), where they were acclimated in 1,000 L holding tanks during 30 d. Each 160 tank had a continuous supply of dechlorinated, well-aerated water ( $25 \pm 1^{\circ}$ C; DO 6.0–7.3 mg.L<sup>-1</sup>; hardness 48–53 mg.L<sup>-1</sup>; pH 6.7–7.3, (as CaCO<sub>3</sub>); alkalinity 40–43 mg.L<sup>-1</sup> as 161 CaCO<sub>3</sub>; chloride 42 mg.L<sup>-1</sup>; ammonium 0.1 mg.L<sup>-1</sup>; and conductivity 110  $\mu$ S.cm<sup>-1</sup>). Fish 162 163 remained under natural photoperiod (~12 h:12 h) and were fed ad libitum with specific 164 commercial pellets: Ø 5-8 mm, 6 % fat, 32 % protein and 12 % moisture (Supra<sup>®</sup> Acqua 165 line) during acclimation period. Food supply was withdrawn 24h before contamination 166 protocol and experiments. The UFSCar Committee of Ethics in Animal Experimentation 167 (CEUA-UFSCar) analyzed and approved all procedures.

## 169 Experimental Design

170 After acclimation, 20 fish (body mass,  $M_B = 180 \pm 98g$ , length = 17.9  $\pm$  0.17 cm, 171 width =  $1.9 \pm 0.02$  cm, and height =  $6.7 \pm 0.09$  cm) were divided into two groups of 172 similar mass, which underwent the exposure protocol. For 96h, each fish was put in an 173 individual aquarium (200 L) with clean water (Control, n = 10) or water with SePM 174 (SePM, n = 10). Each aquarium was shielded with a black plastic sheet to avoid visual 175 disturbance and respected the recommended OECD fish:water volume ratio (1g:1L, 176 (OECD 203, 2019). After 48h, 50% of aquarium water was replaced with the relevant 177 water. After 96 h, each fish underwent an incremental critical swimming speed (Ucrit)

protocol with concomitant respirometry (Brett 1964), in a Steffensen-type acrylic swimtunnel respirometer as described by McKenzie et al. (2017), see details below.

180 In the present protocol, fish swam in clean, biofiltered, and aerated water, having 181 acclimated to the tunnel for 24h. Therefore, this would allow the SePM group to partially 182 recover from exposure effects, if that were possible. To further investigate the potential 183 for fish to recover from the effects of SePM, a second swimming trial was performed at 184 96 h after the first, with all animals held in uncontaminated water with the same individual 185 aquarium exposure protocol (Rec group). This Rec test was only applied to the SePM 186 group. It has previously been demonstrated that the swimming performance of Nile tilapia 187 is constant over two sequential 96h periods in clean water (McKenzie et al., 2017).

### 189 Swimming Performance

190 After exposure protocol, each fish was put into a bucket which was flushed with 191 clean biofiltered water for 5 min. After that, the fish was transferred to the respirometry 192 chamber of the swim tunnel (volume 13.4 L) and left to recover for 24h in aerated clean water at  $25 \pm 1^{\circ}$ C. During recovery, they were kept swimming at 1 body length  $\cdot s^{-1}$  (BL $\cdot s^{-1}$ 193 194 <sup>1</sup>). In that gentle speed, fish could maintain body position using some pectoral sculling 195 and gentle tail beats (see McKenzie et al., 2003). The anterior portion of the swim 196 chamber was covered with opaque black plastic sheeting to avoid visual disturbance of 197 the fish, which spontaneously occupied the covered area.

The swimming trial was based on the protocol of McKenzie et al. (2017). Each fish underwent increasing levels of swimming speed. Each level increased 1  $BL \cdot s^{-1}$  in swimming speed and had 30 min duration. After reaching 4  $BL \cdot s^{-1}$ , increments were reduced to 0.5  $BL \cdot s^{-1}$  until exhaustion (collapsing against the back of the swim chamber, McKenzie et al., 2017). Swimming speeds were corrected for the blocking effect of each fish (Bell and Terhune, 1970). The second swimming trial (Rec group) was held with the same characteristics as the first. The Ucrit ( $BL \cdot s^{-1}$ ) was calculated by adding the velocity of the most recently completed swimming step to the product of the velocity incremental increase and the time proportion of swimming until fatigue at the last current velocity, as described by Brett (1964):

where Us is the last completed velocity of the swimming step, Uss is the incremental increase in velocity, and Tss is the time proportion of swimming until fatigue at the last current velocity.

#### 214 Swimming respirometry

215 During swimming, oxygen uptake was measured by intermittent closed 216 respirometry in two cycles of 15 min at each speed (measuring time -9 minutes, waiting 217 time -1 minute, and flushing time -5 minutes). An optical oxygen probe and the 218 associated software (Fibox, GmbH and Oxyview, Pre-sens) allowed for continuous 219 recordings of the oxygen tension in the respirometry chamber. The oxygen uptake rate 220 was calculated at each swimming speed based on the gradient of decline in O<sub>2</sub> during the closure period, at a sampling rate of once each 15 s. The rate of oxygen uptake ( $\dot{M}O_2$  -221  $mMolO_2 \cdot kg^{-1} \cdot h^{-1}$ ) was then calculated as 222

where  $\beta O_2$  denotes the coefficient for O<sub>2</sub> solubility in water (mg of O<sub>2</sub> · L<sup>-1</sup>); V<sub>RE</sub>, the chamber volume (L); Wo<sup>-1</sup>, fish body mass (Kg); and  $(\frac{\delta p O 2}{\delta t})$  indicates the O<sub>2</sub> reduction over time (% of O<sub>2</sub> · h<sup>-1</sup>). After each swimming protocol, blank tests were performed to measure rates of background microbial oxygen uptake, then the respirometer wasthoroughly washed with clean water.

229 For each swim test, a least-squares exponential regression was applied to the 230 relationship between swimming speed and the MO2 measurements. Extrapolation back 231 to the y-intercept, a notional swimming speed of zero, was employed to estimate standard metabolic rate (SMR), the minimum rate of ATP use required to sustain life, in the 232 233 absence of voluntary muscular movements and digestion/absorption of nutrients (Chabot 234 et al., 2016). Maximum metabolic rate (MMR) was measured as the highest  $\dot{M}O_2$  achieved during the swimming trail, which is assumed to represent the maximum 235 236 rate of oxygen uptake that an animal can achieve to create ATP aerobically (Norin and 237 Clark, 2016). Aerobic metabolic scope (AS) was measured as:

which estimates the maximum capacity to supply oxygen to sustain metabolic activities beyond SMR, activities such as digestion, locomotion, growth, reproduction, and so on (Fry, 1971). We also assessed the net metabolic cost of swimming (COS - mMolO<sub>2</sub> · kg<sup>-1</sup> · h<sup>-1</sup> at a sustained speed of 2 BL·s<sup>-1</sup> as:

an estimate of the metabolic cost of activity at low velocity (Allen et al., 2021).

245 The swimming efficiency (Eswim -  $\mu$ molO<sub>2</sub> · Kg<sup>-1</sup> · BL<sup>-1</sup>) was evaluated as 246 described by McKenzie et al. (2017):

Finally, we analyzed the maximum energetic efficiency of swimming performance (Emax -  $\mu$ molO<sub>2</sub> · Kg<sup>-1</sup> · BL<sup>-1</sup>), a variable of significant ecological relevance (Ohlberger et al., 2006), was calculated based on Kunz et al. (2018):

### 253 *Statistical analyses*

All data were analyzed for normality and homogeneity (Shapiro-Wilk and Levene). Differences between experimental groups (Control and SePM) were analyzed by Student's T-test. Recovery was tested by comparing the mean values of SePM (first swimming test) and Rec (second swimming test) with paired Student's T-test. All data were analyzed with R v.4.1.1 (R Core Team 2021). We assumed the significance level of 95% (P<0.05). The relevant data are presented as means  $\pm$  SE.

#### 261 **3. Results**

## 262 Settleable Atmospheric Particulate Matter

263 SePM contamination introduced several metal elements into the water. The main 264 bioavailable components were iron and aluminum, followed by titanium and cerium 265 (Table 1). Fe and Al represented composed approximately 97% of the total metals 266 available in the contaminated water. However, despite their high concentration, both metals were below the reference LC50 for fishes (Fe - 1.46-1.71 mg  $\cdot$  L<sup>-1</sup> and Al - 0.095-267 235 mg  $\cdot$  L<sup>-1</sup> -Kennedy, 2011). Additionally, these metals were below the upper limit (Fe, 268 269 0.3-5.0; Al, 0.1-0.2 mg. L<sup>-1</sup>) indicated for protected freshwater bodies (for drinking 270 supply, aquatic communities, aquaculture, and fishing, CONAMA, 2005).

## 272 SePM affected swimming performance and aerobic metabolic rates

The Control group had a mean Ucrit of  $5.68 \pm 0.21$  BL  $\cdot$  s<sup>-1</sup> at 25°C. This swimming performance was associated with maintenance of significant respiratory support for activity (Figure 1). SMR was  $4.49 \pm 0.32$  mMolO<sub>2</sub>  $\cdot$  kg<sup>-1</sup>  $\cdot$  h<sup>-1</sup> in the Control group. Activity increased metabolic rate so that MMR was 3.2 times higher at 14.58  $\pm$  277 0.82 mMolO<sub>2</sub> · kg<sup>-1</sup> · h<sup>-1</sup>, such that Control AS was  $10.09 \pm 0.61 \text{ mMolO}_2 \cdot \text{kg}^{-1} \cdot \text{h}^{-1}$ 278 (Figure 2). The Control group had COS at  $3.21 \pm 0.51 \text{ mMolO}_2 \cdot \text{kg}^{-1} \cdot \text{h}^{-1}$ , Eswim of 1.58 279  $\pm 0.25 \text{ }\mu\text{molO}_2 \cdot \text{Kg}^{-1} \cdot \text{BL}^{-1}$ , while Emax was  $2.75 \pm 0.12 \text{ }\mu\text{molO}_2 \cdot \text{Kg}^{-1} \cdot \text{BL}^{-1}$  (Figure 280 3).

The SePM group showed impaired performance with a Ucrit of  $4.15 \pm 0.26$  BL · s<sup>-1</sup>, 27% lower than the Control fish (p < 0.001 - Figure 1). This reduction in performance was associated with effects of SePM on respiratory metabolism. SePM contamination reduced SMR by 26% ( $3.32 \pm 0.17$  mMolO<sub>2</sub> · kg<sup>-1</sup> · h<sup>-1</sup>, p = 0.001 - Figure 2A) and MMR by 27% ( $10.51 \pm 0.78$  mMolO<sub>2</sub> · kg<sup>-1</sup> · h<sup>-1</sup>, p = 0.002 - Figure 2B) when compared to the Control group. Additionally, SePM contamination decreased AS by 29% compared to the control group ( $7.19 \pm 0.77$  mMolO<sub>2</sub> · kg<sup>-1</sup> · h<sup>-1</sup>, p = 0.003 - Figure 2C).

SePM did not change the energetics of sustained swimming at low velocity, with values of COS of  $3.72 \pm 0.31 \text{ mMolO}_2 \cdot \text{kg}^{-1} \cdot \text{h}^{-1}$  (p = 0.333 - Figure 3A) and Eswim of 2.09 ± 0.23 µmolO<sub>2</sub> · Kg<sup>-1</sup> · BL<sup>-1</sup> (p = 0.102 - Figure 3B) that were similar to the Control group. However, SePM contamination did alter Emax, which was 11% lower in the SePM group compared to the Control, at  $2.46 \pm 0.07 \text{ µmolO}_2 \cdot \text{Kg}^{-1} \cdot \text{BL}^{-1}$  (p = 0.011 - Figure 3C).

## 295 Second swimming trial

The second swimming trial provided no evidence of recovery in swimming performance or metabolic rates (Table 2). Swimming performance was 18% further reduced in the Rec group, with a Ucrit of  $3.41 \pm 0.17$  (Table 2). All other variables remained stable when compared to the first swimming trial. Although all 10 fish in the SePM group survived the 96h contamination and the first swim test, 3 of these fish did 301 not survive the additional 96h recovery period before the second swim test. All fish that

302 underwent the second swim test survived to the end of the experimental protocol.

303

#### 304 Discussion

Our experimental approach used a functional test to address the effects of sublethal levels of contamination on a widely-studied fish species. An environmentally relevant concentration of SePM limited the swimming performance of *O. niloticus*, an effect that was associated with substantial alterations in respiratory metabolism. This is clear evidence of effects on functional integrity, an impairment that indicates significant limitations on respiratory metabolism that may reduce fish fitness due to direct and indirect impacts on mobility and energy supply.

#### 313 SePM and general metal toxicology

Our exposure protocol used an environmentally relevant level of SePM 314 315 contamination and was able to replicate the presence and concentration of bioavailable 316 metals as reported in Santa Cruz and Vitoria Bay (IEMA, 2021; Souza et al., 2021a; Souza 317 et al., 2021; Soares et al., 2022; De Angelis et al., 2022). The analysis of SePM confirmed 318 that the contamination is highly complex in metal composition. The observed range of 319 metals corroborates the results of previous studies (Galvão et al., 2022; Soares et al., 320 2022; Souza et al., 2021a; Souza et al., 2021). Metals have a broad range of impacts on 321 fish physiology, including oxidative stress, genotoxicity, hematological alterations, 322 histopathological alterations in many organs, and problems in diverse physiological 323 systems (Lushchak, 2011; Pyle et al., 2002; Taylor et al., 1996; Giles, 1984). Moreover, 324 previous analyses also described the presence of different-sized particles, which may vary

in shape and composition. Furthermore, part of these are in nanometric scale (Salgado,
2003; Santos et al., 2017; Souza et al., 2021b).

327 Therefore, the bioavailable metals in experimental water comprise a complex and 328 unpredictable contaminant due to the range of different elements, possible combinations 329 of metallic/metalloid components, and the presence of metallic nanoparticles (Salgado, 330 2003; Souza et al., 2018; 2021a; 2021b; Soares et al., 2022). This makes it difficult to 331 identify the main components responsible for functional alterations observed in tilapia. 332 Presently, using raw SePM in experimental protocols is the only way to replicate such 333 environmental contamination and study its impacts (Soares et al., 2022; De Angelis et al., 334 2022). Although the precise mechanisms underlying the SePM effect have yet to be 335 revealed, the observed limits to performance are of obvious interest since the level of 336 individual metals was below their lethal concentration (Kennedy, 2011) and under the 337 maximum limits set by the Brazilian regulatory agency (CONAMA, 2005). It seems that we are dealing with an emerging problem that might be highly ecologically relevant. 338

339

#### 340 SePM exposure limits swimming performance

Short-term swimming performance tests have generated valuable data to evaluate
fish health after physiological challenges, such as infections (Tierney and Farrell, 2004)
and sublethal toxicant exposures (Beaumont et al., 1995; McKenzie et al., 2007).
Swimming performance has been used to identify physiological damage caused by
diverse dissolved metals in salmonids, such as copper (Waiwood and Beamish, 1978),
zinc (Alsop et al., 1999), and nickel (Pane et al., 2004). This was the first investigation
that used fish swimming performance to evaluate the effect of SePM.

348 Previous experiments using a similar swimming protocol at the same temperature
349 in Nile tilapia reported Ucrit values similar to our Control group (McKenzie et al., 2017),

350 confirming the consistent quality of the fish population used and the utility of the 351 swimming trials. Consequently, the reduced values of Ucrit and Emax in SePM-352 contaminated fish identify clear impairment of swimming performance and metabolic 353 effectiveness.

It is parsimonious to attribute the Ucrit reduction to the associated changes in aerobic metabolism. Functional cardiorespiratory integrity is necessary to support a high level of aerobic swimming (McKenzie, 2011). Therefore, a break in the integrity of mechanisms for oxygen uptake and delivery may account for the reduction in swimming capacity. The observed decrease in Emax supports such an argument.

Our experimental approach allowed us to reveal that SePM limited the ability to swim, which has obvious ecological relevance. Swimming relates to the capacity to perform essential behavioral tasks for interactions with the environment, such as maintaining a position against currents, foraging, migrating, reproducing, and many others. The evidence that swimming capacity was limited by impaired metabolic support is also relevant because it indicates that other aerobically demanding activities would be similarly impacted.

## 367 SePM exposure affected aerobic metabolism

Metabolic measures provide a significant description of energy mobilization in individual animals (Rosewarne et al., 2016), which is considered a direct reflection of the functional integrity of an individual and its potential to operate in nature (Rice, 1990). The assessment of aerobic profile has been reported as ecologically relevant as a potential bioindicator of metabolic performance, growth rate, and survival (Killen et al., 2010) as they bring a unifying currency of animal performance (Wikelski and Ricklefs, 2001). The swimming performance protocol allowed for calculating robust metabolic indexes 375 regarding the fish metabolic profile and revealed aspects of the energy used for basal
376 maintenance (SMR) and the relative cost of the activity under low (COS, Eswim) and
377 high demand reaching up its limit and the related increase scope (MMR, AS, and Emax).

378 Control tilapia had a metabolic profile very similar to previous reports for the 379 species. For instance, using a similar swimming technique at the same temperature, 380 McKenzie et al. (2017) reported similar mean values for SMR, MMR, and AS 381 (respectively,  $4.1 \pm 0.5$ ,  $16.8 \pm 1.3$ ,  $12.6 \pm 0.1 \text{ mMolO}_2 \cdot \text{Kg}^{-1} \cdot \text{h}^{-1}$ ) in the same strain of 382 Nile tilapia.

383 The 96h exposure to SePM clearly limited both the total energy used and the 384 efficiency of the use of this energy. The exposed fish had reduced standard metabolic 385 rates. Although they were capable of matching the aerobic demands of low levels of 386 sustained swimming (COS and Eswim), SePM-contaminated fish could not achieve the 387 same metabolic rate to support high swimming speeds. Therefore, the overall aerobic 388 metabolic phenotype was affected, with a reduction in basal metabolic processes and an 389 impaired ability to meet the increased metabolic rate required to support intense activity 390 such as swimming at high speeds.

391 Xenobiotics are reported to cause apparently conflicting metabolic effects, such 392 as: metabolic limitations and metabolic masking (Hammer, 1995). The first condition 393 would impair both metabolite supply and removal. Therefore, it would limit the SMR and 394 would have an additional contribution to the reduction in the energetic efficiency of 395 swimming and the critical speed. Additionally, it would reduce the maximal energy 396 production capacity and aerobic scope. Even at sublethal level, metals have been reported 397 to induce alterations with an ultimate metabolic consequence and long-term effects such 398 as reduction in development, growth, and reproduction (Lucas et al., 2021). For instance, 399 a low level of Cu and Cd was observed to reduce the metabolic rate in the freshwater fish

400 species *Pimephales promelas* (Pistole et al., 2008). Zn also reduced the metabolic activity
401 in *Rhamdia quelen* (Leitemperger et al., 2019).

402 Previous experiments reported that SePM contamination has a deleterious effect 403 on both capacities for oxygen uptake and delivery in the tilapia (De Angelis et al., 2022; 404 Soares et al., 2022). That was also associated with a compensatory ventilatory increase 405 and ended up reducing the tolerance to hypoxia (De Angelis et al., 2022). Such effects 406 are coherent with the current findings of reduced swimming performance and alterations 407 in aerobic metabolism. The same authors reported that tilapia could sustain its routine 408 metabolic rate (RMR) after a similar SePM contamination (De Angelis et al., 2022). We 409 suggest that the combination of these factors (maintenance of RMR while reducing SMR 410 with high ventilation cost) indicates problems with energy allocation. A larger part of the 411 total energy would be used for ventilation, while other processes potentially have limited 412 energy support. That interpretation corroborates the observed energetic limitation of 413 swimming. A higher ventilatory effort is expected to increase the energy used for active 414 ventilation at each swimming level (Freadman, 1981). Therefore, such an energy 415 reallocation was revealed as inefficient energy use (i.e., low Emax), lower MMR and AS 416 when the fish were forced to increase their metabolism for swimming.

Additionally, AS has been proposed as an index of animal performance in relation to environmental conditions, since it is related to instantaneous energy-demanding activities and may demonstrate the physiological consequences of several environmental constraints such as temperature increase, hypoxia, and pollutants (Domenici et al., 2013; Lucas et al., 2021; Milinkovitch et al., 2012). Therefore, the observed reduction in AS on exposure to SePM may restrain a range of relevant energetically demanding activities such as growth, reproduction, and offspring size (Claireaux and Lefrançois, 2007).

424 Furthermore, the capacity to support increased energy demand levels is also 425 supposed to impact recovery after exhausting activity. Part of the SePM group (30%) died 426 during the additional recovery period after the first swimming trial. This may be related 427 to SePM negative effects previously reported; SePM caused significant damage to the gill 428 structure, aerobic capacity, oxygen-carrying capacity of the blood, and energy allocation 429 in Nile tilapia (De Angelis et al., 2022; Soares et al., 2022), impairing O<sub>2</sub> uptake from the 430 water, the metabolism and swimming performance as observed in the present experiment. 431 MMR can be associated with intrinsic and extrinsic factors (Norin and Clark, 2016). Thus, 432 the maximum swimming activity may cause a transitory debilitation in every vertebrate 433 since it depletes cellular energy reserves and pH alteration due to lactic acid produced, 434 and others. It also causes ionic unbalance in fish associated with the increased ventilatory 435 effort. Post-activity recovery might cause long-term demands for an aerobic effort to 436 sustain the biochemical effort to recover osmolarity, pH, and energetic balance. 437 Apparently, SePM-contaminated fish was unable to recover as fast as control fish. 438 Therefore, these casualties reinforce the apparent severity of this type of pollution and 439 suggest that if such limitations are not compensated in the long term, SePM will impact 440 a fish's overall use of energy. Consequently, it may have effects on development, growth, 441 reproduction, post-prandial metabolic increment, and any other metabolically demanding 442 activities (McKenzie et al., 2007; Killen et al., 2010; Plaut, 2001; Priede, 1985; Rice, 443 1990) with potential consequent reductions in the overall fitness of the fish population 444 and ecological impact.

446 Final Conclusions

An environmentally relevant concentration level of SePM significantly limited the
 swimming performance of *O. niloticus* and caused significant reductions in metabolic

449 indexes, SMR, MMR, Emax, and AS. Although exposure to environmentally relevant 450 levels of SePM did not lead to immediate death, it did induce significant limitations on 451 physiological performance. Such a combination between swimming and metabolic 452 limitations may affect activities that support fish population dynamics. SePM has the 453 potential to affect multiple levels of fish performance, and therefore, it is still a rather 454 unexplored toxic component that may lead to a growing and silent threat to aquatic biota. 455 It does require further study to understand toxicity thresholds, the mechanisms of toxicity 456 to several organisms, and forms of risk assessment. Future work should also address the 457 effect of long-term contamination by SePM over a range of natural physicochemical 458 variations such as salinity and temperature.
