Mary E. Wilkins Freeman (1852–1930) is best known, read and taught today as the author of short regionalist fiction, and true enough, her literary production is largely set in rural New England, a region she depicts in its period of economic decline or marginalization after the US Civil War. A New England nun, however, she was not.¹ Reading Freeman with and against the grain implies unlearning what we think we know about her and her oeuvre. Freeman's work frustrates our attempts to situate her in clearly delineated categories because her prolific production spanned over nearly fifty years, from the early 1880s and well into the modernist era; because she experimented with a diverse array of forms and genres, writing poems and novels and sketches, children's tales, sentimental stories, and protest novels; because her biography tells us that she straddled social classes; because, and most importantly perhaps, her work ultimately resists many of the very frames that have brought her back to visibility (transcendentalism, sentimentalism, realism, naturalism). Her literary production is robust and varied enough to bear the weight of a profound critical rethinking which questions the paradigms that have obscured her work-and that of other (women) writers-from view.

An increasingly vibrant literary scholarship has already opened new critical expectations and has unsettled the conditions of normative legibility that guided the relatively cloistered readings of her work in the decades following her last publications. Some fifty years after her death, and thanks to the recovery work that brought her back from the margins of American letters in the

1980s, Mary E. Wilkins Freeman gained recognition in the US and abroad at 1 2 the intersection of diverse and sometimes overlapping literary critical rubrics, 3 including New England "local color," rebellious regionalism and female natu-4 ralism. More recently, however, Freeman studies have taken a different set of 5 turns including Gothic, ecocritical, queer, and transnational approaches. New 6 research on Freeman, invigorated by the foundation of the Mary E. Wilkins 7 Freeman Society at the 2017 meeting of the ALA in Boston, has disclosed unex-8 pected aspects of her work. This essay collection, co-edited by the three found-9 ers of the society and featuring a concluding piece by one of the most important scholars to lead the first wave of Freeman's recovery, Sandra Zagarell, aims at 10 11 pushing further in this direction. It does not intend so much to recover Freeman 12 as to *uncover* alternative modes of reading her work.

13 While the volume focuses explicitly on Freeman, it nonetheless self-14 consciously seeks to avoid the pitfalls that have on occasion affected projects of 15 authorial recovery, especially the dangers of imposing self-coherence and artis-16 tic consistency. Hence, reopening the case of Freeman does not mean revert-17 ing to the trope of the writer as an exceptional figure or the myth of unified authorial intention, let alone a biographical approach that often dismisses the 18 author's late production-in the case of Freeman, the texts that she wrote once 19 married and "delocalized" to New Jersey. To the contrary, instead of imposing 20 a single interpretive grid on Freeman's work, we offer a variety of authorial and 21 2.2 critical practices, which we hope will allow future scholars to find in Freeman's 23 texts the means to challenge previous readings, including the very categories we 24 have chosen for analysis here. The road to at once diversifying and recovering a 25 new set of critical readings of Freeman's oeuvre may then best begin by explor-26 ing the lesser-known history of Freeman's reception from the last decades of 27 the nineteenth century—when she first gained fame—to today's post-recovery 28 critical modes of approaching her oeuvre.

A New England Writer, For Better or For Worse

31 Mary Ella Wilkins² was born in 1852 in Randolph, Massachusetts, to Warren 32 Wilkins, a carpenter and housebuilder, and his wife Eleanor (Mary changed 33 her middle name to Eleanor to commemorate her mother, who died in 1880). 34 Randolph's economic base of agriculture and shoe manufacturing was eroding 35 by the time Mary was a teenager. In 1867 the family moved to the resort town 36 of Brattleboro, Vermont, where her father set up a dry goods business, one 37 that eventually failed. Mary was well educated, but the family was increasingly 38 impecunious, and she taught school and gave music lessons in her youth. By 39 the late 1870s she sent poetry and children's stories to magazines and news-40 papers around the country, and in 1883, she published her first story for adults, 41 "Two Old Lovers." Soon after the publication of that story, Mary's father died, 42 leaving her without immediate family. She, then, moved back to Randolph,

where she lived for nearly twenty years with a childhood friend, Mary Wales and Wales's parents. In 1902, after a prolonged engagement, she married Dr Charles Manning Freeman and moved to his home town of Metuchen, New Jersey. The marriage seemed happy for a time, but by 1909 Charles had entered sanitariums due to excessive drinking, and the couple broke after 1919 in a formal separation. Her writing, most especially in her first two short story collections for adults, A Humble Romance and Other Stories (1887) and A New England Nun and Other Stories (1891), as well as in her novel Pembroke (1894), propelled her into a world of literary celebrity; she was friendly with several prominent Northeastern editors including Mary Louise Booth, Joseph 10 Edgar Chamberlin, and Henry Alden, as well as authors like Sarah Orne Jewett, 11 William Dean Howells, Hamlin Garland, and Rudyard Kipling. Although she 12 earned the most royalties from her short stories, she also wrote poetry, thirteen 13 novels, a play, work in collaboration with other writers, eight children's books, 14 and a handful of articles.³ 15

While New England made Mary E. Wilkins Freeman famous, New England 16 also was the reason of her dismissal. Freeman, and other (female) writers of 17 her generation, were hastily labeled "local color writers" and, as such, were 18 excluded from the process of canon formation in the 1920s. Yet a local flavor, 19 or a sense of rootedness, had not always rhymed with obsoleteness, or queer-20 ness. One needs only to go back to the last decades of the nineteenth century 21 to grasp how place was the major paradigm in the literary reconstruction of 2.2 the nation. In the 1880s, when Mary E. Wilkins entered the market of region-23 alist literary production, New England was no longer the "seed-bed of this 24 great American republic, and of all that is likely to come of it," as Harriet 25 Beecher Stowe had once claimed, and illustrated (Stowe, n.p.). New England 26 had become a region almost like any other, a "place" with its singularity and its 27 situatedness. William Dean Howells, a champion of "local color" in the pages 28 of the Atlantic Monthly and Harper's Magazine, did support the New Eng-29 lander Sarah Orne Jewett and Mary E. Wilkins Freeman, but he also praised 30 Mary Noailles Murfree of Tennessee, Hart Crane of California, and Hamlin 31 Garland of Wisconsin, with the rationale that truth, the truth of the nation 32 most importantly, is plural, local, and always circumscribed-not indexed, that 33 is, on the principle of generality, but contingent on the place where it was first 34 articulated. For the dean of American letters, US literature, then, was to be as 35 decentralized as the nation itself had become.⁴ Mary E. Wilkins Freeman, as 36 one of the particular voices of the nation, was part of this regional destiny of 37 American literature.⁵ Local as her work was, or rather because of its rootedness 38 somewhere, it was representative of a commons that was built on differences, 39 rather than similarities. This equivalence of local differences that Howells's 40 influential "Editor's Studies" championed again and again was what made the 41 nation (and national literature) again possible after the Civil War. 42

The cult of the local, however, did not last. When an overseas US imperialism 1 2 developed at the turn of the century under the aegis of Theodore Roosevelt, 3 the Howellsian local pluralism that had made the heyday of regionalism in 4 American letters no longer reigned supreme. The peculiar became instead the 5 label of an anti-Americanism. In that scheme, local color New England, being 6 the furthest away perhaps from a mythical West where manhood could con-7 quer and reign, featured as the true antithesis of the national mythography, and 8 Freeman, among others, became the representative of morbid femininity and 9 treacherous parochialism. Indeed, Roosevelt's definition of "true patriotism" left very little doubt as to who the enemies of the nation were: 10

In the first place we wish to be broadly American and national, as opposed to being local or sectional. We do not wish, in politics, in literature, or in art, to develop that unwholesome parochial spirit, that overexaltation of the little community at the expense of the great nation, which produces what has been described as the patriotism of the village, the patriotism of the belfry. (166)

19 The likes of the Shattuck sisters in "A Mistaken Charity" (1883), one half-deaf, 20 the other half-blind, who braved old age and the poor house's laws, to get back "home," or the stubborn Marm Lawson in "Brakes and White Vi'lets" (1884), 21 2.2 who kills her sickly granddaughter by keeping her in her moldy old house lest 23 she should lose her to the city, became dissonant notes in an American clamor-24 ous symphony. Strenuous as they were, the task of being the representative, if 25 peculiar, voices of the nation was no longer theirs—even if New England, as the 26 former center of a national literary imaginary, kept something of its grandeur 27 in the midst of its demise.

28 No wonder, then, that in his History of American Literature since 1870 29 (1915), Fred Lewis Pattee, in spite of his New England origins, or rather 30 because of them, had "the New England period" in American letters precede "the National period," as if New England literature could only testify to "[t]he 31 32 passing of an old regime" (233). Freeman, accordingly, was classified among 33 the "recorders of the New England decline" (Chapter XI), a declension narrative that Pattee, however, did not initiate. As Fetterley and Pryse (2003) remind 34 35 us, from the turn of the century onwards, the surveys of US literature sys-36 tematically categorized New England literature as passé and, as such, unfit to 37 represent US literature. The works of Freeman, but also of Sarah Orne Jewett, 38 Rose Terry Cooke, or Alice Brown, were spurned as delicate, or genteel at best, 39 unless they were anathematized as deleterious reading.

Interestingly, however, at the turn of the century, Freeman did not suffer
from the charge of "un-Americanness" as much as, say, Jewett, who was lastingly plagued by her genteel origins. Like her predecessor Rose Terry Cooke,

Freeman was redeemed of her New Englandness, as it were, by her social 1 2 class-the modest background she grew up in. And because she wrote on what she knew-poor country people's lives, "the narrow environment of New 3 England villages," that was hers (Pattee 236)-and did so, allegedly, by tapping 4 in the "austere and limited" (236) schooling that she had received as a child, 5 she was spared of the sin of bookishness or artistry. Pattee characteristically 6 insisted that she was born a realist. "She seems to have followed no one," he 7 wrote, "realism was a thing native to her" (236). And as a realist, she could not 8 9 find the door of the pantheon of American letters entirely closed to her. In April 1926, Freeman became the first recipient of the William Dean Howells Medal 10 for Distinction in Fiction from the American Academy of Arts and Letters-a 11 distinction that should have sealed her fate and her fame. Not so, however, 12

•

Freeman's realism was either not enough, or too much to be true. Not grim enough for Edith Wharton, who famously reproached her for considering New England "through [...] rose-coloured spectacles," and overlooking the "outcropping granite" in favor of the "sweet-fern" and "mountain-laurel"; Freeman's stories, for Pattee, were to the contrary too stern and somber—the outcome of a Puritanism gone awry, the sickly flowering of a degenerating country.⁶ "When she approached literature," he diagnosed, articulating an origin narrative that would stick to Freeman for decades,

it was as a daughter of the Puritans, as one who had been nurtured in repression. Love in its tropical intensity, the fierce play of the passions, color, profusion, outspoken toleration, freedom—romance in its broadest connotation—of these she knew nothing. She had lived her whole life in the warping atmosphere of inherited Puritanism, of a Puritanism that had lost its earlier vitality and had become a convention and a superstition, in a social group inbred for generations and narrowly restricted to neighborhood limits. (236)

This belated, if critical, Puritanism, was to be Freeman's birthmark, both a 31 blemish and a blessing, as well as her costly entrance fee to American letters. 32 Three decades after Pattee, Perry D. Westbrook's influential sum, Acres of 33 Flint: Writers of Rural New England (1951), made the exact same diagnosis. 34 Intent on salvaging from oblivion those writers of rural New England that had 35 been buried as unworthy of praise, Westbrook did so paradoxically by identi-36 fying their works as the perverted avatars of an ambivalent past. He observed 37 in "a group of New England rural writers, most of them village-bred women," 38 "a conscience that had been exaggerated to the point of becoming hysteria." 39 Singling out Freeman among them as having "a morbidly sensitive conscience" 40 (88), Westbrook read her texts as "the workings of a lopsided will," "crooked" 41 (91) for lack of adequate objects. For Westbrook, then, one thing was certain: 42

the New England of cantankerous old maids and stubborn farmers could only be conjugated in the past; this literature was a morbid relic of a history that no longer holds true, and, as such, it could not be America's authoritative writing.

4 Myths die hard; and Freeman, labeled and advertised as "a recluse from 5 New England," as soon as 1893, continued to feature as one vestigium of 6 another era in the heart of Progressive America (Doyle 287). At the turn of 7 the century, critics could wonder, without the slightest irony, at her using a 8 typewriter (Moss). Was she supposed to wield a quill? And rare were those 9 who tried to extricate Freeman from the enclosure of the past. When, in 1898, Joseph Edgar Chamberlin of the Critic tried to return her to the present, his 10 11 words must have sounded like a provocation: Randolph is a suburb of Bos-12 ton, he insisted, and Freeman knows and appreciates the cosmopolitan city as 13 much as you readers. Her window overlooks electrical tracks, and her house 14 is heated by radiators! But Chamberlin wrote against the grain; for most crit-15 ics, and the readers after them. Freeman was an authentic New Englander, her prose was rooted in the granite soils of her native New England, and her gaze 16 17 warped by centuries of Puritanism. New England, yet again. It may not come as a surprise, then, that New England served as the pivot of the second-wave 18 19 recovery of Freeman, but this time it was as the foil against which her work 20 was read.

In 2003, Fetterley and Pryse's Writing Out of Place deterritorialized Freeman's 21 2.2 work the better to enroll her texts as regionalist critique.⁷ By de-emphasizing the 23 New England dimension of her oeuvre, they meant to counter her (and other writ-24 ers') stigmatization as mere providers of quaint picturesqueness and anecdotal, if 25 not dangerous, pre-modern peculiarity. Regionalist Freeman, they explained, has 26 not much in common with her local color avatar, who should be regarded as an 27 ideological fabrication serving the interests of a masculinist national hegemony. Because rootedness essentializes place and transforms it into one of the commodi-28 29 ties produced by the nation state, it also reifies the oeuvre which, as a relic of the 30 past, becomes yet another artefact of national production. Denaturalizing regionalism, understanding regionalism as a "discourse," instead of a "geographical 31 32 manifestation," as a point of resistance in the power network that cannot be eas-33 ily or exactly located, has a clear political pay-off: regionalism is thereby turned 34 into a social or political strategy of defiance—a situated knowledge, not an essen-35 tial emanation of a particular, and often marginal, place (Fetterley and Pryse 7). 36 Accordingly, reading Freeman as partaking in regionalist critique is important: it means aligning her stories with "elements of disruption, resistance, and revolu-37 tion" (125); it uncovers a "politics of resistance to the imperialism of gender, age, 38 39 and class" (249); reading Freeman "out of place" allows one to read her "from inside the perspective of the queer" (332). But equally important is to understand 40 41 that such radical dismissal of New England as a hermeneutic category in Free-42 man's work was preceded by other attempts to push beyond a reading of her work

as systematically harnessed to place. Such history that unfolded from the 1970s to the 1990s is the history of Freeman's recovery.

Twists and Turns in Freeman Scholarship

Most readers who come to Freeman have been influenced by the feminist critics who prompted renewed attention to her oeuvre from the 1970s to the 1990s, a work of recovery that itself bifurcated into two main branches. On the one hand, there were those who chose to depict the predominately female world of late nineteenth-century New England that she belonged to as a nurturing, mother-centered realm (Donovan, New England Local Color Literature), and on the other, as early as the 1974 Feminist Press edition of Freeman's short stories by Michelle Clark, and up to the 1983 Norton edition by Marjorie Pryse, there were critics who focused their commentary and story selection on tales of defiance featuring characters (mostly female) who rebelled against the gender and class conventions of their time. Writes Pryse, "For the first time in American peacetime history, the women of an entire region were left in a world transformed into a quasimatriarchal one both by the casualties of the Civil War and by the departure of a substantial proportion of the region's remaining young healthy male population." And she adds, more specifically about Freeman: "Throughout her career, whenever she addressed the themes of rebellion and revolt, in the village fiction that focuses primarily on women, she wrote her most successful work" (viii, xii). The boundaries between the two readings were not as clear-cut as it may seem. But suffice it to say that, coming out of the works of philosophers, psychologists, or historians as diverse as Hélène Cixous, Lillian Faderman, Nancy Chodorow, Carol Gilligan, or Carroll Smith-Rosenberg, some feminist critics insisted on women's ethic of care, and their willingness to cultivate and maintain mutual bonds, particularly with other women, while others emphasized instead women's resistance and direct confrontation to patriarchy. Because there was in both cases a potential for essentialist application, much of this scholarship has been contested over the years, sometimes by the very critics that had initiated it. Yet its central premise, more carefully historicized and somehow nuanced, has remained a pivot of later criticism-that women of a certain class and ethnicity have drawn sustenance from each other rather than from the men around them.

35 Between the two. Freeman's fiction has largely fallen on the side of rebellion and resistance, as chafing against the directive of the female ethic of care. 36 Michelle Clark (1974) wrote that Freeman characters' dependence on each 37 other economically and socially leads them to "fight, envy, disagree, com-38 pete, bicker, and manipulate" even though they are often usually intensely 39 loyal in the end (195). Josephine Donovan details a shift in the 1870s and 40 1880s toward female education and work outside the home, causing a rift 41 between mothers and daughters in fiction by Jewett and Freeman. Whereas 42

Jewett chooses the mother's matriarchal realm, Donovan proposes, Freeman 1 2 chooses the daughter's longing to escape ("Silence or Capitulation"). Similarly, 3 Pryse associates lewett with a "reunion with mother" and Freeman with a 4 "revolt of the mother" (ix). Most notably, Mary R. Reichardt's work recover-5 ing Freeman's short fiction across her long career argues that Freeman's fiction 6 only partially corroborates the findings of feminist researchers into women's 7 lives: "Rather, the emotional and mutually dependent bonds women form with 8 other women in Freeman's New England more often than not take on a dis-9 turbingly threatening or ominous tone" (104). Indeed, for every early Freeman story that celebrates a women's special brand of strength-"The Revolt 10 of 'Mother'" (1890), "Louisa" (1890), "A Church Mouse" (1889), and "A 11 12 Poetess" (1890)—there are later stories in which caring and nurturing resemble smothering or disciplining—"Old Woman Magoun" (1905), "The Reign of the 13 Doll" (1904), "The Lost Ghost" (1903), or "The Selfishness of Amelia Lam-14 15 kin" (1908). More than other female writers of her generation, then, Freeman has gained prominence as "dark Freeman," away from the matriarchal utopias 16 17 of Jewett's stories or the "rose-and lavender" palette that Wharton had tried to attach to her name (A Backward Glance 294). Freeman thus complicates an 18 abstract sense of quasimatriarchal realms and the female ethic of care by show-19 20 ing that women's power involves the same contradictions, difficult choices, and abuse of boundaries that any kind of power inherently entails. Rather than 21 2.2 romanticizing an idealized view of women's nurturing lives, Freeman adopts 23 a decidedly more modern stance that anticipates the expansion of power that 24 women have gradually, albeit not unconditionally, enjoyed. With sobriety and 25 compassion, she looks into particular instances where women's power takes 26 the edge of abuse. From our vantage point of the twenty-first century, we are 27 more prepared to discuss these aspects of her work.

28 Freeman scholars are indebted to Leah Blatt Glasser's critical biography 29 of Freeman In a Closet Hidden (1996), which was among the first works to 30 unlock Freeman's complex identity as a woman and an author. Glasser meticulously analyzed Freeman's "psychology of self-division" (xviii) that would find 31 32 expression in thematic and narrative motifs, such as character doubles and mir-33 ror scenes, which convey Freeman's own ambiguity about rebellion. Glasser's 34 research into Freeman's letters and manuscripts was paved by Brent Kendrick's 35 collection of Freeman's letters The Infant Sphinx (1985), another seminal book that was based on archival research. Considering Freeman's long life, the scarcity 36 of her archives bears further question. The Mary Wilkins Freeman Collection 37 #7407 at the Clifton Waller Barrett Library, Special Collections Department, 38 39 University of Virginia, houses her books, a few of her story manuscripts, and several letters which have already been published in Infant Sphinx. New let-40 41 ters will appear in Brent Kendrick's forthcoming edited collection of her letters. 42 Additionally, Glasser cites a collection of three letters at the Alfred Williams

Anthony Collection, Rare Books and Manuscripts Division, New York Public Library, and reminiscences of Freeman's time at Holyoke in the Mary E. Wilkins Freeman folder at Mount Holyoke College Archives. As we are uncovering new directions in Freeman studies, her correspondence may contain formerly ignored evidence that would buttress the hypotheses put forward in this collection. Going back to the archives may indeed flesh out what we perceive makes Freeman interesting today: the vibrant productivity of her later years; the move towards the non-human and non-normative forms of kinship with trees or nonhuman animals; the ongoing tensions of her oeuvre between writing to formula and experimentation with genres, between a complicity with certain forms of 10 capitalism and a courageous resistance to the exploitation of labor, between her 11 queer leanings and the necessity of female solidarity malgré tout. 12

Readers and scholars will likely continue to be drawn to Freeman for her depictions of female rebellion and defiance, yet recent work carries this line of inquiry into new directions: the fetish, the Gothic, and what Donna M. Campbell in this volume calls "the criminal."8 Taking up Westbrook's argument, yet reinscribing Freeman in her time and age, that of turn-of-the century consumerism, Monika Elbert argues forcefully that her characters' sense of frustration with their narrow lives "leads to an excess of senseless and compulsive behavior reflected in frenzied and repeated activities, such as spending money, sewing incessantly, or collecting useless knick-knacks" (192). Such characters are fetishists rather than benign objects of cosmopolitan readers' sympathy. Jennifer Fleissner similarly argues that Louisa Ellis and other famous Freeman characters suffer from what is now called obsessive compulsive disorder (111-22), while Linda M. Grasso, reading Freeman's "Old Woman Magoun" alongside Sui Sin Far's "The Wisdom of the New," understands these desperate matricides as "symbolically encapsulat [ing] the writers' frustration, rage, and despair about their status as artists in a 'young' America that refuses to allow them to nurture their talent" (19). Rather than frightening and unproductive violence, these stories, Grasso concludes, produce "righteous anger" that "demands social justice" and "has the potential to create community" (19).

The political and social work of Freeman's communities of angry women 32 and downtrodden men is probably most visible in her Gothic short fiction. 33 Beth Wynne Fisken argues that ghosts in Freeman's stories record anxiety and 34 ambivalence about childrearing. Roxanne Harde treats Freeman's child ghost 35 in "The Little Maid at the Door" (1891) as one of several Victorian British or 36 American child ghosts that indict society's practice of allowing children to suf-37 fer, particularly if they are involuntarily associated with erring and disgraced 38 parents. Gothic short fiction has become a popular topic among Freeman crit-39 ics in recent years, with new analyses by Dara Downey, Nicole Diederich, Dan-40 iel Mrozowski, Melissa Pennell, and Jennifer Bann among others, which mostly 41 corroborate Fisken's sense that there is something disturbing about Freeman's 42

reading of mothers and children. In that sense, Freeman's Gothic was not only 1 2 a belated reworking of the genre, but it also partook of a larger denunciation of 3 the world in which she lived. A new edition of The Wind in the Rose-Bush and 4 Other Stories of the Supernatural edited by Myrto Drizou, points to the impor-5 tance of this later collection in which "Freeman's Gothic challenges not only 6 traditional gender stereotypes but also conventional representations of home" 7 (xiv) and mother-daughter relationships in a changing world. Indeed, what 8 remains thought-provoking about Freeman's work is how much she rebelled 9 against the social wrongs of the turn-of-the-century US while simultaneously embracing some of the premises of a cosmopolitan, urban, and consumerist 10 11 society (Elbert); how she was both fascinated by modernity and wary of a 12 "progress" that brought its lots of social and economic problems to the US 13 countryside.

14 As Sandra Zagarell reminds us in her introduction to the Penguin Classics 15 edition of Freeman's stories, Freeman's first published short story, "Two Old Lovers" (1883), as well as "A Wayfaring Couple" (1885) are set in factory 16 17 towns, as is The Portion of Labor (1901). Mostly because of the predominating sense that regionalism was a form of the pastoral, or because it was associated 18 with the tradition of female benevolence literature, labor-capital relations have 19 20 never been a major strand in Freeman criticism. But here again we may well have been blinded by persisting critical a-prioris concerning female "regional-21 2.2 ists." Debra Bernardi, for one, has read Freeman out of the tradition of female 23 benevolence, and shown how Freeman's characters in her short stories rebel 24 against scientific charity as bungled by ministers and middle-class female neigh-25 bors. Focusing on The Portion of Labor (1901), a novel about a shoe factory 26 strike, Mary Marchand and Dorothy Berkson, on the other hand, have read 27 it as a failed attempt to update a nineteenth-century tradition of benevolence literature, in which middle-class white women-drawing on their uniquely 28 29 feminine powers of sympathy-descend upon a multi-ethnic working class. 30 However, focusing on the childlike, unreasoning qualities of Freeman's heroine, Ellen Brewster, they disregard Ellen's acumen at public speaking, or Freeman's 31 32 talent at reproducing the sordid self-respect of the working-class families that 33 surround her main character. The novel does not sit neatly in a feminist tradition of middle-class heroines who enter the public sphere through their reform 34 35 work, because it focalizes factory conditions through the workers. Two essays in this volume revisit The Portion of Labor, a novel not reprinted since 1967, 36 37 so as to draw attention to one neglected facet of Freeman's work, her social awareness and stubborn reformism. 38

Freeman's social reformism should not however be too quickly dissociated
 from her vision of racial relations. Freeman critics have begun to investigate
 the presence of racial anxiety in her work. In the introduction to the 1991
 Critical Essays on Mary Wilkins Freeman, Shirley Marchalonis makes it clear

that Freeman partook of the race theories of her day, using the language of bloodlines in her fiction and nonfiction, highlighting the Puritan ancestry of her characters, and contrasting that lineage to the more exotic, passionate, or violent French, Native American, and African American characters. Stephanie Palmer's work (2020) further addresses how Freeman's fictions were championed by contemporary critics as fine products of an Anglo-Saxon bloodline, but the wayward, nonconforming nature of Freeman's eccentrics, Palmer argues, ultimately troubled critics intent on upholding an image of the United States as a modern nation.

Many of the essays in this volume investigate the racial significations of 10 Freeman's fiction and resist a "Freeman so white" reading of her oeuvre. 11 Fogels's chapter, for instance, complicates what may first appear as the mono-12 lithic whiteness of Freeman's texts. Whiteness, as Hannah Lauren Murray has 13 recently shown in her study of early US fiction, was less an essence than a 14 status bestowed on those who exhibited certain traits, including respectabil-15 ity, industry, and sociality (4). The Shattuck sisters of "A Mistaken Charity," 16 Fogels's chapter shows, fail to exhibit these typical traits by sliding into poverty 17 and not caring that their roof is full of chinks or their chins full of hairs. Their 18 refusal to accept charity raises questions about the instability of whiteness for 19 poor women, the way that whiteness can be bestowed or lost in a liminal pro-20 cess involving "precarity and demotion" (Murray 6). Whereas many writers 21 viewed the loss of white privilege as anxiety provoking, for Freeman, it could 2.2 be humorous or even joyful. Monolithic whiteness is also unsettled by Free-23 man's complex handling of ethnicity. In The Portion of Labor, as shown in 24 Rogers-Cooper's chapter, the intersection of gender, class, and ethnic identity 25 questions working-class forms of resistance as found in naturalist novels of the 26 time. While Ellen, Freeman's main character, is exceptionally beautiful, intel-27 ligent, and charismatic, she is also ableist and racialized as belonging to an Irish 28 American culture-which turns the text into an exemplar of what Zagarell 29 might call Freeman's, and the era's, ideological "cross-currents" (Zagarell, 30 "Cross-Currents"). We tend to forget that power, and the power of women 31 especially, can be racialized in Freeman. Campbell offers a rare reading of Free-32 man's disturbing novel Madelon (1896) which features a mixed-race heroine. 33 The eponymous character, with French and Native bloodlines that are impli-34 cated in her stubborn self-reliance, is one of Freeman's strongest women, and 35 her capacity for violence is rarely dealt with in feminist readings. 36

Acknowledging the series of interlinked turns that criticism on Freeman has undergone since the 1970s, and more specifically in the three decades since *Critical Essays on Mary Wilkins Freeman* appeared (Marchalonis 1991), this volume, then, intends to push beyond critical regionalism (Zagarell, "Introduction" xviii), or rather, push critical regionalism into new directions. Cutting across the emphasis on both a Foucauldian discourse of heterotopia and a Deleuzian

deterritorializing impulse that tended to erase the material and historical pres-1 2 ence of New England (Fetterley and Pryse 2003), we believe that it is possi-3 ble to evade the pitfalls of essentialism without throwing away place with the 4 bathwater of antiquarianism or the logic of regional commodification. In the 5 2000s and 2010s, critics did recover New England vet not the New England of 6 Pattee, Westbrook, or, for that matter, Richard Brodhead.9 Cécile Roudeau's La 7 Nouvelle-Angleterre: Politique d'une écriture (2012) argues that erasing New 8 England amounts to disallowing the tension between center and periphery that 9 haunts Freeman's regionalism. If New England shapes Freeman's critical region-10 alism, she argues, it is because Freeman's New England, as both (ex-)center and 11 periphery, is always critical of itself. For J. Samaine Lockwood, this self-criticism 12 is related to a queer historicism practiced by Freeman and other women archi-13 vists, who returned to history with a difference, by placing the unmarried New 14 England daughter at the heart of their endeavor.

15 On the other hand, if differently, ecocriticism also reiterates that Freeman really is writing about New England, with its flowers, trees, animals, moun-16 17 tains, rivers, bridges, gardens, and crops, as well as, but not predominantly, the 18 humans that dwell within it. Terrell F. Dixon shows how Freeman's Understudies (1901) and Six Trees (1903), later collections that have not yet received the 19 attention they deserve, "present an expansive, evolving ecofeminist vision-20 21 one that avoids essentialism and that creates green women and green men who 2.2 love and defend nature while engaged in ordinary life" (173). While it is useful 23 to draw links between Freeman and the earlier New England transcendental-24 ists-and Dixon, Alaimo, and Stone have done so-these critics also identify 25 differences, in that Freeman critiques traditional gender relations (Alaimo 60) 26 to the point of proposing her own kind of queer regionalism or queer ecology. Freeman's intimate relationships between women and women,¹⁰ humans and 27 trees, or women and objects, are not just sisterly, empathetic, or fetishistic. 28 29 "(B)ecause of the non-normative formulation of kinship and domesticity that 30 emerged out of them but also because of the ways in which they embody experiences of alienation from forms of biological, social, and economic reproduc-31 32 tion involved in heterosexual domesticity" (Ansley 434-5), these alliances offer 33 a queer form of resistance to hegemonic discourses and categories, something 34 that has been increasingly brought to the fore as critics read more of Freeman's 35 oeuvre, moving beyond her two canonical collections.

With the emergence of digitized newspaper databases, more and more Freeman stories are being discovered that were not reprinted in her story collections or listed in Freeman bibliographies. One of these newly discovered stories is the fascinating "An Idyl of a Berry Pasture," which was published in *Once a Week* (Aydelott and Wilkins). It is becoming evident, then, that Freeman has not said her last word. These discoveries significantly undermine lingering suspicions that she was just a cog in the wheel of the Harper's publishing house, and that

her regionalism was but a fashionable way for readers of the national literary monthlies to consume rural otherness. Freeman was a writer of her time, and her tales were tales of New England; she did write some of her stories to formula-the result, perhaps, of the precariousness of her family finances-and resolved plots with marriages or lovers' reunions. But if she catered to the late nineteenth-century metropolitan tastes for tales of life in the backward but virtuous countryside, she also wrote-against them-texts that still unsettle our appreciation of her today. Against the Freeman that we know, this volume wants to go one dig into the Freeman that we don't quite know yet. Doing so requires that we do not stop at her two early collections, but that we read her 10 against the periodization that has relegated late (married) Freeman to oblivion 11 and beyond the local and national scale that has traditionally been hers. In 12 brief, and most importantly, it demands that we leave aside our assumptions 13 about how a middle-class white female writer of turn-of-the-century New Eng-14 land should write and accept, instead, a rare, if unexpected, complexity that 15 requests patient unravelling once again. 16

•

COLLECTION OVERVIEW

The chapters in the volume are organized into four sections that conclude with an afterword by Sandra Zagarell. The sections collectively explore how Freeman pushes against dominant critical perspectives and question our own assumptions about major epistemological rubrics, including genre and periodization, as well as normative structures such as local and national belonging, class, age, and gender affiliation. Reading Freeman with and against the grain, the following chapters engage with her diverse literary production-not her canonical stories only, but also her lesser-known novels-so as to let her texts speak back to us in new and unpredictable voices.

The first section, "Kinship Outside of Normative Structures," uncovers 28 alternative modes of communality in Freeman's fiction. In the chapter "Mary E. 29 Wilkins Freeman's Neighborly Encounters and the Project of Neighborliness," 30 Iana Tigchelaar introduces the concept of "neighborliness" to describe Free-31 man's complex representation of kinship bonds beyond normative constructs. 32 Looking at a wide range of Freeman's short stories-from staples, such as 33 "Christmas Jenny" and "A Village Singer," to less widely discussed stories 34 in the volume Understudies-Tigchelaar argues that Freeman's neighborly 35 encounters occur at liminal spaces that imagine new forms of belonging within 36 (and across) regional hierarchies of class, age, gender, and ability. In the next 37 chapter, "'Her Own Creed of Bloom': The Transcendental Ecofeminism of 38 Mary E. Wilkins Freeman," Susan M. Stone reads some of the stories discussed 39 by Tigchelaar-including "Christmas Jenny" and "The Great Pine"-yet from 40 a different perspective. Stone argues that Freeman's fiction acts as a bridge 41 between first-wave transcendentalism and ecofeminism insofar as it centers on 42

ecological stewardship to rethink boundaries between nature and the human, 1 2 "providing readers with option-filled alternatives to socially prescriptive and 3 restrictive domesticity and gender conventions." As a sustained expression of 4 ecofeminist views, Freeman's work inflects key transcendental concepts to envi-5 sion new forms of companionship, responsibility, and belonging. Freeman's 6 search for new modes of belonging is also the focus of the following chapter, 7 "'Preposterous Fancies' or a 'Plain, Common World'? Queer World-Making in 8 Mary E. Wilkins Freeman's 'The Prism' (1901)," in which H. J. E. Champion explores Freeman's representation of queer children. Through a close reading 9 10 of "The Prism," a rarely anthologized story, Champion analyzes the protag-11 onist's eccentric sense of autonomy that borders on autosexuality, resisting 12 normative projections of linearity in terms of age, domesticity, and marriage. Although the plot concludes with marriage. Champion contends, it suggests the 13 14 possibility of imagined queer futures.

15 The second section, "Violent, Criminal, and Infanticidal Womanhood," continues the examination of deviant female characters throughout Free-16 17 man's fiction. In "The Reign of the Dolls: Violence and the Nonhuman in Mary E. Wilkins Freeman," Donna M. Campbell addresses criminal acts 18 of violence, in which women are not just victims but also perpetrators and 19 aggressors. Freeman's representations of child kidnapping, fatal neglect, and 20 murder rely on nonhuman surrogates such as dolls and animals. Through 21 2.2 their power to signify suffering, desire, and trauma, Campbell argues, these 23 surrogates not only embody but also catalyze the disruption of power struc-24 tures, including the market economy, racial discrimination, gender inequality, 25 and colonial history. The next two chapters explore Freeman's eccentric and 26 violent heroines from a transatlantic scope, placing Freeman in new crosscultural contexts. In her chapter, "Transatlantic Lloronas: Infanticide and 27 Gender in Mary E. Wilkins Freeman and Alexandros Papadiamantis," Myrto 28 29 Drizou argues that the depiction of child murder, which she interprets as 30 infanticide, in "Old Woman Magoun" evokes a transatlantic mythology of deviant maternal figures epitomized by La Llorona, the Wailing or Weep-31 32 ing Woman in Meso-American mythology that is also central to Alexan-33 dros Papadiamantis's 1903 Greek novella, The Murderess. In the following 34 chapter, Aušra Paulauskienė argues that Freeman's deviant women—both in well-read stories, such "A New England Nun" and "Louisa," and lesser stud-35 36 ied novels-evoke Catholic tropes to criticize old-dogma Puritanism. These 37 tropes, including religious ritual, cloister motifs, and the representation of motherhood, as the stronghold of outdated religion, bring Freeman closer to 38 39 Irish American fiction, a new context for reading her work. As Paulauskiene 40 concludes, such connections to Irish American texts draw out the powerful 41 entanglement of social, religious, and political systems of belief in the increas-42 ingly multi-ethnic nation.

The third section, entitled "Women's Work: Capital, Business, Labor," situ-1 2 ates Freeman within a range of turn-of-the-century economic discourses, such as the literary market, social class, and labor reform. The first two chapters place 3 Freeman's neglected novel The Portion of Labor in the vexed terrain between 4 a sentimental tradition of protest novels à la Stowe and the early twentieth-5 century realist and naturalist reform fiction with which Freeman has rarely been 6 associated. Justin Rogers-Cooper argues that it is the novel's "feminist labor 7 8 solidarities" that engender the conditions for working-class forms of resistance 9 such as strikes. In Freeman's text, the performance of queer intimacy and desire are recast as a political tool for social reform. Laura Dawkins, on the other hand, 10 analyzes the thorny issue of child labor, as represented in the novel. Freeman, 11 Dawkins argues, turns the "cult of childhood" into the "theft of childhood" in 12 the context of a family wage economy that forces tough decisions on both par-13 ents and children. Freeman's conflicted adherence to reform should not, how-14 ever, be dissociated from her own multifaceted relation to labor and capital as a 15 writer. Brent L. Kendrick sheds light on one of the lesser-known aspects of Free-16 man's literary career, namely, her financial competence and business acumen. 17 Taking Freeman as a prime example of a highly successful "literary business-18 woman," Kendrick examines her business decisions, publishing strategies, and 19 various dealings with cash, property, and investment. Given her successful navi-20 gation of the literary market, Kendrick suggests, Freeman deserves to be noted 21 not only for her prolific output but also for her economic skill. This section con-2.2 cludes with Audrey Fogels's chapter "Deconstructing Upper Middle-Class Rites 23 and Rituals: Reading Mary E. Wilkins Freeman's Stories Alongside Mary Louise 24 Booth's Harper's Bazar." Fogels argues that Freeman's archaic New England 25 settings and quaint lower-middle-class characters function as ironic mirrors to 26 the world of Harper's Bazar and the privileges of upper-middle-class member-27 ship. Fogels's analysis of well-known stories, such as "A Mistaken Charity" and 28 "Sister Liddy," and rarely discussed ones, such as "A Modern Dragon," draws 29 on textual and visual evidence to suggest that Freeman's portrayal of consumer 30 culture, financial hardship, and women's competition underwrites the Bazar's 31 covert vet complex commitment to feminist concerns. 32

•

The final section, "Periodization Reconsidered," addresses how Freeman's 33 work extends beyond conventional period markers and established literary 34 histories. Daniel Mrozowski examines Freeman's late collection of stories 35 that has received scant scholarly attention. Mrozowski points out that Free-36 man's portraval of war mobilization in the home front challenges traditional 37 modes of representing the war, as it combines mundane choices and rever-38 sals of fate with larger questions of pacifism and internationalism. What is 39 more, Freeman's response to the Great War questions our own response to 40 "realist" writers at the close of their career, especially when they continue to 41 write well into the period we tend to define as "modernism." Monika Elbert's 42

essay, "A Cacophony of Voices: Freeman's Modernism," further elaborates on 1 2 Freeman's engagement with modernist anxieties and concerns in the context 3 of an increasingly industrialized New England. Elbert suggests that Freeman 4 represents her home not as a pastoral rural space but as a site of alienation, 5 consumerism, and capitalism, connected to global problems such as World 6 Wars. Freeman's early twentieth-century stories, in particular, feature false 7 relationships, disenchantment with objects of prestige, and struggles of self-8 actualization in a disintegrating world, all of which bring Freeman closer 9 to themes of modernist fragmentation and disenchantment than regionalist wistfulness and nostalgia. The following chapter, "Underground Influence: 10 11 Sylvia Townsend Warner's Pastiche of Mary E. Wilkins Freeman," argues that 12 Freeman's work lived on into the 1920s through the 60s, even after Freeman 13 lost her main audience. Stephanie Palmer explores Freeman's transatlantic 14 influence on the twentieth-century British writer Sylvia Townsend Warner. 15 Palmer identifies a "progressive female-to-female influence" that is structured differently than the Bloomian model of influence, featuring a broader array of 16 17 emotions including but not only about anxiety. The final chapter of the volume, entitled "Untimely Freeman," sheds new light on Freeman's "understudies" 18 from the deliberately anachronistic perspective of a twenty-first-century reader. 19 Part of the "late Freeman" corpus, Understudies has been recently recovered 20 21 as her "first volume of ecofiction," yet has remained, perhaps in accordance 2.2 with its title, somewhat obscure. Reading Understudies from the perspective of 23 recent scientific hypotheses and philosophical developments about the animal 24 and the vegetal world as a world of relations in which the human no longer 25 abides as center, does not imply de-historicizing her, Roudeau argues; it rather 26 requires historicizing both her writing and our reception in order to engage 27 with the non-coincidence between the two as an opportunity to be seized, not 28 a discontinuity to be lamented.

29 Sandra Zagarell, in her "Afterword," brings these voices together and 30 offers an incisive assessment of Freeman's resonance with the twenty-first-century reader and critic. As each contributor to this volume shows. Freeman's 31 32 texts continue to yield fresh insight, especially in the context of new critical 33 approaches to gender, race, age, and class. This insight is never unidirectional, 34 however. Freeman's work speaks back to contemporary critics insofar as it illu-35 minates the fault lines of current social and political debates and, in doing so, 36 opens the space for further conversations that help us navigate the complexi-37 ties of our own time and age. In a world where modes of connection have been largely restructured by the global pandemic, in which the climate crisis, the 38 39 fear of massive deforestation and species extinction demand both a planetary response and practical changes within our most quotidian practices, Freeman's 40 41 fiction seems all too familiar, as her plots place the minute, the domestic, and 42 the monotonously mundane at the core of narratives that echo forward to our

carefully sheltered lives. This deep-rooted desire for connection is both soothing and unsettling. Some may choose to spend their lives "in a closet hidden," after all, a phrase that perhaps echoes differently in pandemic times, when unable or unwilling to confront the world, we remain wary of contact, and contagion, ready to invent or reactivate new forms of (remote) sociability. The spectral, the ghostly, are forms of correspondence that we have reconfigured to experience and learned to newly appreciate.

But Freeman's way of releasing the unsettling power of connectiveness is also instructive insofar as it embraces and reaches beyond the orbit of individual existence, combining examples of subtle, everyday revolt and largerscale examinations of organized movements, as in *The Portion of Labor*. The global crises we have experienced in the 2020s, pandemic- or climate-related, and evidenced in the migrant crises and a global political and social unrest, have revealed that class, race, and gender inequalities persist amidst radical change; indeed, they necessitate new modes of struggle beyond conventional paradigms of connection and outside conventional alliances. Freeman's shifts between forbearance and defiance continue to comfort and inspire new readers, who may be more ready than they were in the 1990s, during the heyday of Freeman's recovery, to commit themselves, individually or collectively, at the level of their local community or more broadly, to activist action and a new language of hope.



MARY E. WILKINS FREEMAN'S NEIGHBORLY ENCOUNTERS AND THE PROJECT OF NEIGHBORLINESS

20 21 Against a familiar backdrop of economic recession, industrial innovation, and a shifting social landscape, Mary E. Wilkins Freeman wrote the short fiction 2.2 23 she is best known for—scenes of New England village life that depict with clarity, insight, and humor the daily dramas of courtship and marriage, family life, 24 religious faith, and domestic spaces. Freeman also wrote poetry and novels, as 25 well as short fiction in innumerable other veins, including dozens of stories for 26 children, supernatural tales, and series of fiction focused on animals, flowers, 27 28 and trees. And yet Freeman's fame rested on her depictions of villages and their 29 seemingly anachronistic inhabitants. This fame was a double-edged sword-Freeman's skill in depicting regional locales and residents cemented her status 30 as a regionalist writer during a time when even regionalism's most vocal sup-31 porters voiced their defense of the movement in limiting terms. In an 1891 32 "The Editor's Study," for example, William Dean Howells describes Freeman's 33 stories as "miniatures" that record "narrowly" lived lives (20). Freeman and 34 35 other local colorist or regionalist authors were frequently seen by their contemporaries as merely chronicling a fast-disappearing rural reality. Even when 36 acknowledging the artistry of regionalist authors, critics emphasized their work 37 38 as secondary or marginal; for example, in an 1895 article examining Boston's literary history since the Civil War, Howells writes that while he does not "for-39 get the exquisitely realistic art of Miss Jewett or Miss Freeman," their stories 40 "[have] hardly the novelist's scope" (868). 41

However, as the work of recovery over the past few decades has turned 1 2 critical attention to literary regionalism, this narrow conception of the genre's 3 scope has been scrutinized. The first work of feminist critics, including Judith 4 Fetterley, Marjorie Pryse, and Sandra Zagarell, was to read the female-centered 5 imaginaries of much regionalist fiction in the context of the patriarchal systems 6 and structures of the late nineteenth century. Their oppositional reading has 7 often situated appraisals of Freeman alongside other recovered regional writ-8 ers, arguing that Freeman's regional stories oppose national narratives, her 9 female characters resist patriarchal control, and her domestic spaces counter the public sphere. Further work in reading regionalism's complex relationship 10 11 with the larger social, cultural, political, and commercial forces shaping not 12 just local but national and global power relations during the late nineteenth 13 and early twentieth centuries has emerged from critics including Stephanie 14 Foote, June Howard, Hsuan L. Hsu, Tom Lutz, Mark Storey, and Edward Watts.¹ Hsu contextualizes even the most nostalgic portrayals of seemingly 15 pre-industrial regionals as subject to the global or national forces their regions 16 17 imagine to escape, and that their regional productions "[occur] in relation to large-scale phenomena such as migrant flows, transportation networks, and 18 international commerce" (Hsu 164). Like Hsu, other critics see regionalist 19 20 writers as deeply entangled (whether deliberately or inadvertently) in issues of national and global significance. Howard, for example, notes the recent trend 21 2.2 in "relational" studies of concepts including regionalism, pointing toward 23 the way social sciences and policy studies position region in terms of the 24 "interdependence of neighboring states" and often focus "on how economic, 25 political, and cultural connections mesh" (Center 3). Storey states that the 26 literature characterized as regional reveals "the hidden and encoded traces of 27 social and cultural change on a level that is shared and transregional," a depic-28 tion that is always in dialogue with "the geographically indiscrete experience 29 of modernity" (205).

30 Following Howard's advice as she encourages reading regionalism "in relation to a form or practice that illuminates" both individual texts and cultural 31 32 and historical context ("Circuits" 123), this essay suggests another form for reading Freeman's regionalist stories that clearly indicates the genre's imbrica-33 34 tion in the intricate web of power relations that structured the late nineteenth 35 and early twentieth centuries: what I am calling Freeman's project of neighborliness. By neighborliness, I mean the recurrent formations of kinship bonds 36 outside of normative structures that appear with regularity in her short fic-37 tion.² These bonds do not merely oppose these structures, but actively work to 38 39 enact structural transformation, reimagining the closed space of the domestic family, the restricted Calvinist environment of the village church, or the hier-40 41 archical social structure of the regional community. Central to the project of 42 neighborliness is the neighborly encounter, a liminal, transformative meeting

that instigates the reimagining of a community's power and structure along neighborly lines. Freeman's neighborly encounters promote neighborliness by proposing a modified network of meaning and belonging in her regional communities.

 (\blacklozenge)

Reading Freeman's regional fiction in light of neighborly encounters illuminates another purpose behind the project of neighborliness: it also serves as the means by which Freeman attempts to make legible to her largely urban readership the proper mode for consuming these stories and the regional inhabitants they represent. In this, the neighborly encounter serves as an alternative mode of reading regionalist texts, in contrast to the hierarchical mode suggested by the figure of the urban observer/narrator apparent in much regional literature. The success of the neighborly encounter in transforming culture and community rests on collaborative efforts that cross boundaries of class, age, gender, and ability. The community transformation that results from these neighborly encounters serves by extension as a model for the reconciliation of the regional "other" in configurations of national identity. Freeman's empathetic portrayal of socially sidelined individuals whose marginalization is compounded by the perception of their communities as peripheral reveals the potential for social transformation via neighborly encounters. Neighborliness as dramatized by Freeman in these stories also suggests a privileging of communitarian values over individualism—a revaluation that resonates today. By staging neighborly encounters in liminal spaces and states, Freeman's regional texts work to transform relationships both within the text and within the nation, reframing the modes by which her readers would recognize themselves and others.

"Christmas Jenny" and the Neighborly Encounter

In order to define what I mean by neighborliness and what I am describing as 27 the neighborly encounter, I turn to Freeman's story "Christmas Jenny," origi-28 nally published in Harper's Bazar in December 1888 and collected in A New 29 England Nun and Other Stories in 1891. "Christmas Jenny" tells the story of 30 an elderly couple, Jonas and Betsey Carey, and their neighbor, Jenny Wrayne, 31 who is known as "Christmas Jenny" for the handmade wreaths and seasonal 32 greenery she sells in the village around Christmastime. Jonas is prone to "tan-33 trums" when things don't go his way, and Jenny rescues Betsey during two of 34 these tantrums (offering the advice that parents of toddlers have known for 35 decades: ignore him and he'll get over it on his own). These acts of neighborly 36 kindness bookend the story, and in-between plays out the other central drama: 37 the village's judgment of Jenny, whom they perceive to be unusual, perhaps a 38 witch, and in need of the intervention of the community. When the minister 39 and church deacon pay Jenny an unannounced visit to confirm for themselves 40 the charges that she is abusing the sick and injured animals she has rescued and 41 the young disabled child she has adopted, Betsey intervenes to speak on behalf 42

of the absent Jenny. The men are convinced by Betsey and moved to generosity,
sending Jenny a Christmas turkey, gifts for Willy, her ward, and a new calico
dress. The story ends with a feast Jenny shares with the Careys and the light
from Jenny's Christmas candle shining down on the village, an emblem for the
general blessing of neighborly kindness.

6 "Christmas Jenny" illustrates a number of key characteristics of the neigh-7 borly encounter, specifically in the meeting between Betsey Carey and the 8 visiting minister and deacon. Neighborly encounters often occur in liminal or 9 interstitial spaces, settings which facilitate the transformative nature of the 10 encounters. Liminality, a term I am reading in light of Victor Turner's notion 11 of the liminal state as the middle stage of the ritual process by which social 12 order may be transformed, appears as a setting or as a condition in many of Freeman's stories.³ In "Christmas Jenny," Betsey encounters the minister and 13 14 deacon in the liminal space of Jenny's home, which is described as being neither fully domestic nor out of doors, but mingling the two. The liminality of neigh-15 borly encounters enables the inversion or questioning of hierarchical power 16 17 arrangements, as is the case in the meeting between Betsey, who is an elderly female parishioner, and the minister and Deacon Little, who hold positions of 18 power in their New England village. Challenging social structures, the liminal 19 figure in the neighborly encounter often experiences a transcendent, empow-20 ered state which temporarily inverts power structures and has the potential 21 2.2 to enact long-term community change. In "Christmas Jenny," Betsey's liminal 23 empowerment persuades the two men of the importance of neighborly values, 24 which in turn blesses the entire community.

25 The neighborly encounter, then, is a transformative meeting, often in a 26 liminal space or setting, between "neighbors," people who are united by geo-27 graphic proximity but often separated within their communities by reasons of social station, age, ability, behavior, or gender. The encounter serves the pur-28 29 pose of promoting neighborly values such as radical generosity and hospitality 30 and moves the participants to prioritize their neighborly relationships. While neighborliness is in a sense a tenet of Christianity and village life (recount the 31 32 New Testament story of the Good Samaritan, where Jesus answers the question "who is my neighbor," intended by the "expert in the law" who asked the ques-33 34 tion to narrow his range of obligation to others, with a parable about radical hospitality), Freeman's neighborliness reveals the ways in which patriarchal 35 theology and civic structures have restricted the range of care and responsibility 36 37 toward others. Frequently the neighborly encounter illuminates the failures of traditional Christian benevolence and civic charity to truly address the needs of 38 39 all neighbors. Freeman's neighborliness therefore works to address internally a social wrong in the community, and as such functions as a community cor-40 41 rective that brings with it the additional benefit of the general promotion of 42 community-kinship bonds that extend beyond normative structures like the

domestic family unit and the village church. In promoting the project of neighborliness, these stories reveal the ways in which Freeman is speaking to larger questions of identity and belonging beyond her regional communities.

•

In focusing on belonging and on individual and collective identity, Foote argues that "neighborliness gives us a way to imagine the social work of regional fiction outside the conventional models of family or nation" ("Neighborliness").⁴ In this, neighborliness bears similarities to a few other approaches to reading regionalist literature. Jennifer Ansley's "Geographies of Intimacy in Mary Wilkins Freeman's Short Fiction" proposes reading "female-centered communal imaginaries," which she describes as queer due to their "non-normative formu-10 lations of kinship and domesticity," as one of Freeman's narrative strategies for 11 navigating the economic impact of industrialization and the concurrent changes 12 to normative domesticity in New England communities (434). Ansley's queer 13 imaginaries can be read alongside Zagarell's narratives of community as describ-14 ing the social work of regionalist texts in relationship to formations of commu-15 nity. Zagarell's concluding essay to Narratives of Community: Women's Short 16 Story Sequences complicates her initial discussion of community-based narra-17 tives by examining Freeman's The Jamesons, a text she sees as in direct com-18 munication with (and critique of) the foundational regional text, Jewett's The 19 Country of the Pointed Firs.⁵ While Zagarell states that her 1988 definition of the 20 genre of narratives of community "idealized it as a fully positive form of social 21 organization," her 2007 essay recognizes that representations of community can 2.2 be "limiting" and "destructive," and that all readings of narratives of community 23 should be contingent upon the social and historical contexts of their production 24 and reception (434). Zagarell's particular project here, reading The Jamesons in 25 the context of Jewett's Country (and particularly Country's urban narrator, who 26 sees Dunnet Landing through a nostalgic lens) as well as in light of The Ladies' 27 Home Journal's narrow notion of commercialized domesticity, offers one such 28 contingent reading. 29

Similarly, in *Regional Fictions*, Foote takes up the idea of community for-30 mation, identity, and citizenship in Jewett's Country, and like Zagarell notes 31 that Country promotes a sense of regional unity on the foundation of "sup-32 pressed relationships between natives and strangers," relationships which "are 33 themselves modulated interventions in a more general concern over origins and 34 nativity" (18). Much of Jewett's Country is concerned with the urban narrator's 35 anxiety over her own belonging to the idealized community of Dunnet Land-36 ing, and this anxiety, Foote argues, is embedded in the eventual revelation that 37 regional identity is not homogenous but is in fact paradoxically reliant upon 38 the shifting notions of "foreign" and "strange" which are used to define who 39 is a native insider. Although Foote's focus is Jewett's Country, which she uses 40 "to show that the foreign constitutes what seems most comfortably homelike in 41 the region," she also notes that "the problems of citizenship in the supposedly 42

homogeneous region" extends to other New England women's regionalism as
well, including Freeman, whose short stories "[reveal] her belief in the necessity
of community and also the variation in many characters' local or individual
relations with a normative community" (37). Withdrawal from community,
as seen with Louisa Ellis of "A New England Nun," is one such variation,
Foote notes.

7 In their discussions of community formations in regional texts, Foote and 8 Zagarell both identify the meeting between the urban observer narrator and 9 the regional resident as essential to the mediation of community identity and 10 membership in regional fiction. Zagarell reveals that The Jamesons' narrative 11 of community differs from Country's in that what threatens the village of Lin-12 nville's integrity is not modernization, but nostalgic, urban interlopers-the Jameson family of New York City, who summer in Linnville, to be specific.⁶ 13 14 Foote, too, focuses on the unnamed narrator of Jewett's Country whose own 15 subject position as insider or outsider (and simultaneously as a privileged authority figure) in Dunnet Landing is in constant flux. In this, Zagarell and 16 17 Foote join many other critics of regionalist fiction, including Judith Fetterley and Marjorie Pryse, in identifying the significant narrative role played by the 18 urban visitor in regionalist fiction. However, in my discussion of neighborliness 19 20 in Freeman's fiction, I identify another stage on which the negotiations of community identity and belonging take place. Neighborly encounters resemble the 21 2.2 meetings between metropolitan visitor and rural resident that animate much 23 regional fiction; however, in Freeman's neighborly encounters, participants are 24 members of the same community who are working within their communities 25 to take up similar questions about community belonging and regional identity. 26 By dramatizing meetings that encourage seeing liminal regional inhabitants as 27 "neighbors," the neighborly encounter serves as an alternative way of reconciling outsiders within the social fabric of the regional community, one which 28 29 attempts to avoid the fetishization of regionalist literature and its regional resi-30 dents that the outsider narrator often enables.

31 32

INTERSTITIAL SPACES, LIMINAL ENCOUNTERS

The neighborly encounter is characterized by a "betweenness," which implies 33 34 both literal and figurative notions of thresholds, doorways, and margins and 35 instigates the blurring of arbitrary boundaries between identity categories. As 36 Turner discusses in The Forest of Symbols, while this liminal stage suggests 37 alienation, it also carries with it the possibility of transformation (236). Key 38 to the neighborly encounter is the collective outcome of neighborliness; the 39 liminal figure does not experience transformation alone, but instead in her rein-40 tegration into society brings new knowledge to her place in a typically hierar-41 chal structure. The liminal process is, therefore, central to social change, given 42 its capacity to generate new, communitarian social arrangements.⁷ In many of

Freeman's stories, the liminality of the neighborly encounter manifests spatially in interstitial zones such as front steps, doorways, or thresholds, spaces whose "betweenness" mediates public and private, inside and outside. These border spaces symbolically stand for the liminal person's status as both temporarily outside of social boundaries and working to promote neighborliness within the freedom from social constraints that outsider status offers. These liminal spaces, already located in-between categories of identification and setting, are particularly apt stages for neighborly encounters. Examples of these interstitial spaces abound in Freeman's regional fiction. In stories like "A Conflict Ended," in which a man spends every Sunday for years sitting on the church 10 steps in protest of a minister's doctrinal interpretation, or in "The Outside of 11 the House," in which an elderly couple take up residence on the porch of a 12 seaside mansion when their wealthy neighbors who own the house are away. 13 Freeman explores the way interstitial spaces like front porches, doorways, and 14 yards can be used to negotiate not just individual but collective identity. 15

For example, Freeman's "Peony," one of her stories in Understudies that 16 draw on flowers and animals for their central metaphors, offers a clear depic-17 tion of threshold liminality in the service of neighborliness. As Mary Reichardt 18 has observed, the central metaphors in Understudies explore the Emersonian 19 idea that "all elements of the natural world bear correspondence to each other" 20 (Study 76). For Arabella Lambert, her corresponding natural element is the 21 peony, described as coarser than the more refined rose—an ironic description, 2.2 since Freeman offsets Arabella's supposed coarseness with an excessive empa-23 thy and abundant generosity toward her neighbors. Arabella's niece, Sarah, 24 condemns her generosity, telling her aunt that "The door of your heart is 25 always open, and [neighbors] walk in and take advantage of it" (199). The 26 story's neighborly encounter occurs after Arabella has given away much of 27 the home's furnishings to a couple who lost their savings in a bank collapse. 28 She blocks the doorway to her house, refusing her niece entry until she accepts 29 the latest in her aunt's series of acts of radical generosity. The central metaphor 30 is underlined during this scene: as Arabella stands in the doorway, unmoving 31 and unspeaking, she fixes her gaze on her peonies, vowing to continue to "yield 32 unstintingly all her largess of life to whomsoever crossed her path with a heart 33 or hand of need for it" (213). 34

Arabella's immovable doorway meeting with her niece is one of Freeman's 35 more obvious instances of a threshold encounter in service of neighborliness, but 36 the liminal threshold space appears in many other stories, as well. In addition 37 to these literal thresholds, Freeman grapples with the hierarchies of power in 38 regional communities in her depictions of encounters in public gathering places 39 like meeting houses, churches, schools, and village squares. These more tradi-40 tional public spaces intended for social interaction are ostensibly held in common 41 but are in practice often male-controlled and dominated by normative narratives 42

and ideals. These spaces become liminal stages for neighborly encounters when
they are "misused" according to social norms. One type of misuse has to do with
a liminal blurring of boundaries in these public spaces—boundaries between
domestic and public, between inside and outside, as in the case of Betsey's neighborly encounter in the liminal space of Jenny's house.

6 This is true of the liminality in a number of well-known stories, like "A 7 Church Mouse," in which Hetty Fifield sets the stage for the neighborly encoun-8 ter that marks the story's climax through her transformation of the village 9 church into a domestic space. Hetty decorates the meeting house with "treasures of worsted-work," hangs a "gay sunflower quilt" to curtain off a living area 10 11 for herself, and cooks strong-smelling food for herself in the building (98–100). 12 Similarly, in "The Revolt of 'Mother'," the appropriated space is Adoniram Penn's new barn, which he has built instead of the new home he has been prom-13 14 ising his wife, Sarah, for decades. Sarah's interstitial misuse of the barn, a space 15 meant to mark her husband's commercial success, brings about a personal and familial transformation. The liminal settings of neighborly encounters demon-16 17 strated in these two stories are echoed throughout other of Freeman's stories that feature interstitial spaces. For example, in "A Village Singer," Candace 18 Whitcomb, the former leading soprano in the church choir, has been forced out 19 due to her "cracked and uncertain" aging voice and replaced by the younger 20 Alma Way (80). To protest her removal, Candace, whose house is next door 21 2.2 to the church, plays her own parlor organ and sings loudly over Alma's vocal 23 performances. Like Hetty's experience in "A Church Mouse," this interstitial 24 encounter emphasizes the blurred boundaries between the domestic space of 25 Candace's home and the public, patriarchal space of the church.

26 Whether taking place in misused, appropriated public spaces or in intersti-27 tial zones, neighborly encounters work to disrupt the narrative and structure of 28 authority. At times in these stories, marginalized characters' mere existence is 29 enough to illuminate arbitrary and oppressive hierarchical structures. This is the 30 case in "A Church Mouse," where Hetty's plight comes about because the village's twin structural pillars of the church and the domestic family unit neglect 31 32 the neighborly values of charity, hospitality, and generosity toward those who 33 don't fit into either of those normative structures. Hetty's village is filled with families who keep to their own "company," a network of relatives and in-laws. 34 Within this private, domestic framework and without the benefit of charitable 35 36 organizations, the village has no place for someone in Hetty's position. In addi-37 tion, the resistance of church authorities to Hetty serving as the church sexton, 38 a job typically done by a younger male villager, reveals the gendered, ageist, 39 and ableist hierarchy of the church that defines the social fabric of the village. By challenging the village's social order, Hetty draws attention to the need for 40 41 neighborliness and the negative repercussions that patriarchal social structures 42 and gaps in social services have caused in regional settings. Candace's situation

in "A Village Singer" is similarly gendered; Candace points out to the visiting minister that the leading tenor, who is three years her senior, was not given the same treatment as she was. Candace's interstitial actions initiate an encounter that challenges the hypocrisy of the congregation and the patriarchal authority of the church. While she has not succeeded in transforming her village, she has stepped outside of the bounds of propriety, demonstrating how marginalized people can harness the implicit power of liminality to resist absorption into dominant ideology.8

"Strange" Deviance and Community Transformation

In the interstitial spaces and liminal situations of the neighborly encounter, Freeman's marginalized characters use their position from outside of the social order to both reimagine their communities and to revise their own subject positions within their communities. Part of this reimagining comes from a deviation from conforming to social norms, a deviation that can be temporary (as in Candace's protest singing) or enduring (such as Hetty's move into the church). A number of stories focus on characters whose promotion of the values of neighborliness comes at the price of their role within the social order. Esther Gay of "An Independent Thinker," who is hard of hearing, is ostracized for not attending church services she cannot hear; however, she occupies the hours 20 she would spend at church meetings knitting to earn income which she gives 21 anonymously to help her impoverished neighbors. In "Life-Everlastin'," Luella 2.2 Norcross offers sustenance and care to many of the community's marginalized, 23 poor, and transient figures, but refuses to attend church due to unbelief. Here 24 as elsewhere, Freeman aligns blind adherence to church doctrine or other social 25 norms with unthinking conformity-Luella's sister's frustration that Luella will 26 not attend church meetings does not come out of any concern for her mortal 27 soul, but because she wants her to behave (and dress) "like other folks" (67). 28 In "A Church Mouse," Hetty's "reputation of always taking her own way, and 29 never heeding the voice of authority" has given her an "unfortunate name" in 30 her village (99). Consequently, Hetty is imagined by the villagers as a "brier among the beanpoles, or a fierce little animal with claws and teeth bared" (99); 32 described as a weed or an animal, Hetty's strong will and eccentricity lead to her dehumanization. Similarly, Jenny is considered "somewhat fantastic" as a result of a failed love affair that has rendered her "love-cracked," according 35 to the villagers (54); her "eccentricity," which the church authorities believe is a "possibly uncanny deviation from the ordinary ways of life," leads to the 37 "witch-hunt" that Betsey thwarts (59). Jenny's outsider status has "tinctured 38 her whole life with an alien element" (54); Freeman's use of the term alien here suggests both foreign and nonhuman.⁹ 40

Beyond these strange characters who are othered due to their eccentric natures, Freeman also aligns othering with the experience of otherwise normative

characters who are situationally marginalized during neighborly encounters. 1 2 While Sarah, Candace, and Betsey are not initially considered odd in the way 3 Jenny and Hetty are, each of them comes to be seen as strange by the authority 4 figure with whom she clashes in their encounter. The minister in "The Revolt 5 of 'Mother'" finds Sarah to be "beyond him," noting that "[he] could deal 6 with primal cases, but parallel ones worsted him" (133). Following one of 7 her interstitial performances in "A Village Singer," Candace is accused by her 8 nephew of being "crazy," and the visiting minister too "could not account for 9 such violence, such extremes, except in a loss of reason" (88, 87). The deacon and minister who encounter Betsey in "Christmas Jenny" describe her as 10 11 transformed and frightening: "They were thankful to leave that small, vocifer-12 ous old woman, who seemed to be pulling herself up by her enthusiasm until 13 she reached the air over their heads, and became so abnormal she was fright-14 ful" (59). In their deviation from the restrictive, normative behavior in their 15 regional communities, Sarah, Candace, and Betsey, too, become strange.¹⁰

But strangeness alone is insufficient to enact social change in the service of 16 17 neighborliness in Freeman's stories; it is in the interaction between the marginalized, liminal figures and those in positions of authority that the transformative 18 potential of the neighborly encounter is realized. The encounters themselves are 19 20 characterized by the temporary inversion of power Turner describes as central to the liminal phase. In "The Revolt of 'Mother'," for example, Sarah speaks 21 2.2 in language and is described in terms that highlight her power and authority 23 in her confrontation with the minister. Sarah "returned [the minister's] saluta-24 tion with dignity" before defending herself with a spirit previously hidden by a 25 "meek front" (132). Sarah asserts that she has "[her] own mind an' [her] own 26 feet" and needs only consult with God about her decisions, arguing for her full 27 humanity as a Christian with direct access to God, rather than a wife who is subservient to her husband's control and divine intervention (133). Similarly, in 28 29 "Life-Everlastin" Luella is described as having an almost extrasensory percep-30 tion during her conversation with the visiting minister: "Luella ... looked at the minister. Her deep-set blue eves seemed to see every atom of him; her noble 31 32 forehead . . . seemed to front him with a kind of visual power of its own" (71).

33 This combination of unexpected physical and verbal power can be seen 34 throughout Freeman's neighborly encounters. In "A Village Singer," when 35 Reverend Pollard calls on Candace with the aim of gently reprimanding her, 36 Candace speaks forcibly and effectively, highlighting the hypocrisy of the church and the social fabric of the village. Rather than acceding to the cler-37 gyman's admonishments, Candace defiantly defends her disruptive singing, 38 39 strategically pointing out the congregation's un-Christian duplicity: when Pollard suggests they "kneel and ask the guidance of the Lord in the matter," 40 41 Candace refuses, noting that it wasn't the Lord who created this situation, 42 but rather status-conscious people "'gettin' as high-steppin' an' fussy in a

meetin'-house as they are in a tavern, nowadays'" (86, 85). Candace's strategies here resemble Betsey's emotional defense of her neighbor in "Christmas Jenny," as both women point out the Christian hypocrisy at work in their subjugation. Betsey argues, in fact, that Jenny's care for wounded or sick animals and a young disabled child ""mounts to jest about as much as sendin' money to missionaries'," elevating her strange neighbor's behavior from eccentric to Christ-like (58). Candace, too, uses native logic and the assertion of her own authority to engage in discursive cultural criticism; her dving words, a negative commentary on Alma's singing, reassert herself as the authority on quality singing from outside of the bounds of both the church building and patriar-10 chal authority. 11

The inversion of social hierarchies during the neighborly encounter does not just empower the marginalized; during these encounters, characters who hold positions of power within the normative structures of the community are described in terms that highlight their loss of mastery as they meet these marginalized figures. In "The Revolt of 'Mother'," the minister "stood awkwardly," spoke "helplessly," and uttered "perplexed apologetic remarks" during his encounter with Sarah, while Adoniram similarly loses the power of speech (132-3, 134). In "A Church Mouse," Deacon Gale and two other church authorities stand before Hetty "stiff and irresponsive," speaking hesitantly and "feebly" to the stubborn woman (101-2). In "Life-Everlastin'," Reverend Sand is "filled . . . with amazement and terror" as he confronts the agnostic Luella (72). So, too, does Reverend Pollard encounter Candace's defense of her singing protest in "The Village Singer"-never imagining that a quiet New England woman could engage in "such violence, such extremes," which he likens to "the elements of revolution" (87) and does not feel competent to address.

In these encounters that promote neighborly values, Freeman repeatedly rec-27 reates alternative strategies of representation that resist normative structures. 28 While these neighborly encounters most obviously promote neighborliness 29 within the regional communities Freeman depicts in her stories, they also serve 30 a larger purpose: as a culturally resonant image of the proper mode by which 31 regionalism's urban audience should approach a region's "strange" inhabitants. 32 As many critics have noted, in dramatizing the encounter between "native" 33 and "stranger," regional literature frequently functioned as a seemingly fixed 34 point of reference against which to define normative national identity. In my 35 examination of neighborliness, the dramatized encounter is intraregional, fur-36 ther unsettling the supposed fixed categories of identification. While these char-37 acters are indeed strange, the function of their strangeness isn't to reinforce 38 others' normalcy, but to call into question these fixed categories of identity 39 on multiple scales. While Freeman's ministers, husbands, socially conscious 40 housewives, and other characters who have embraced their positions within the 41 normative structures of their communities do initially define themselves against 42

deviant characters' strangeness, the project of neighborliness refuses to allow
 these figures to reaffirm their own normalcy by these means.

•

3 This is because the recognition of common humanity that is key to the proj-4 ect of neighborliness demonstrates that transformation is communal, not just 5 individual. The power liminal figures gain during neighborly encounters trans-6 lates into social restructuring on multiple scales. For example, "The Revolt of 7 'Mother'" transforms Sarah's social standing, both within her family and in 8 the eves of the community: Sarah's rebellion inspires an "inborn confidence" in 9 her children for their mother, who anticipate the encounter between their parents in the new house with "pleasant excitement" (133), and the townspeople 10 11 who learn of Sarah's revolt are similarly captivated, "[pausing] to look at the 12 staid, independent figure on the side track" (132). Similarly, in "Christmas Jenny," the minister and Deacon Little begin their patriarchal survey of Jenny's 13 14 house "remorselessly," but following their encounter with Betsey, they speak 15 "apologetically," and vow to support Jenny rather than condemn her (56, 59). The collective nature of neighborly transformations is even more apparent in 16 17 "A Church Mouse," in which it is the support of other women, who com-18 bine efforts with Hetty and against the male church officials, that enables a 19 communitarian compromise. In addition, following the dramatic encounter 20 between Hetty, the male church authorities, and the women who come to her aid, Hetty takes further steps toward promoting neighborliness: Hetty's act of 21 2.2 bell-ringing to "awaken" the town on Christmas Day solidifies her authority 23 as sexton while also supporting a relatively new tradition (keeping Christmas, 24 which, when Hetty was young, was not common in the village), one that unites 25 the townspeople and breaks from strict Congregationalism. Freeman's use of 26 the word "awakened" in this context is intriguing, considering the religious 27 overtones the word carries-Hetty is the instigator of the awakening, and it 28 is an act that unifies the community along neighborly rather than traditional 29 domestic or civic lines. In this, "A Church Mouse" resembles the conclusion of 30 "Christmas Jenny," where Jenny's Christmas candle serves as a symbol for the 31 community's privileging of neighborly values.

32 The collective efforts of Hetty and the women of her village, Jenny's com-33 munally enjoyed candle, Arabella and Luella's excessive generosity toward their neighbors, and the many other encounters between liminal and normative 34 35 figures in Freeman's stories reveal a thematic pattern of disruption and trans-36 formation in the service of neighborliness, or the elevation of non-domestic 37 bonds of neighborly kinship within a community. The project of neighborly 38 reconciliation in Freeman's fiction, which illuminates the oppressive nature of 39 normative structures, pivots on acts of generosity and hospitality for outsiders. This radical hospitality is illustrated in stories like "The Great Pine," in which a 40 man named Dick, having returned home from a lengthy sojourn at sea, discov-41 42 ers that during his absence his wife married a neighbor man, had a child with

him, and died. The baby and the new husband, who is bedridden by illness, are being cared for by Dick's daughter. In this unusual domestic setting, Dick both gives and receives hospitality as he is welcomed by his replacement and as he chooses to become caretaker to the motley assortment. As in the other stories collected in Six Trees, "The Great Pine" builds on a central metaphor-in this case, the pine tree of the story's title represents the paradoxical binary of solitude and fellowship, polarities with which Dick wars. Freeman's narrator muses about the "intimate connection and reciprocal influence" among "all forms of visible creation"-initially illustrated with the care Dick eventually shows to the tree, but ultimately embodied in the radical neighborliness Dick 10 extends to his wife's second husband and family (241). Dick's conversion to 11 neighborliness by the story's end is echoed when the great pine falls: "He was 12 no more to be seen dominating the other trees, standing out in solitary majesty 13 among his kind" (247). Dick's transformation, like that of the forest, illustrates 14 the collective purpose of neighborliness, opposing the "solitary majesty" and 15 individual domination typical of normative, hierarchical structures. 16

"AMONG NEW ENGLAND NEIGHBORS"

In a letter to her friend and editor Mary Louise Booth on 15 March 1887, Freeman expresses distress with the proposed title for her first story collection for adults and wonders "if Among New England Neighbors would have been any better" (Kendrick 79).¹¹ Freeman's use of the word "neighbors" here is intriguing, but even more telling in the context of the project of neighborliness is her use of the preposition "among," a term which suggests not only being surrounded by something, but being a member of that something. In contrast to local color and regionalist fiction that dramatizes the encounter between native and stranger in order to both reaffirm the superiority of the urban perspective and infuse regional settings and people with a nostalgic authenticity against which and in the context of which to define modern advancement, the stories in Freeman's A Humble Romance and Other Stories and the many stories that followed dramatize a different encounter, one that places the reader "among" their regional "neighbors."

The neighborly encounter's empowerment of the marginalized within the 33 community alongside the transformation of their communities into places that 34 value even the strangest among them is a strategy of representation intended to 35 reimagine the encounters between the urban readers who consume the stories and 36 the regional residents represented by the stories. In this way, Freeman's stories 37 don't just depict encounters between the socially unequal residents of regional 38 communities but work through these literary encounters to display to the con-39 sumers of regional literature the proper attitude they should adopt toward both 40 the genre of regionalism and regional residents. As such, Freeman simultaneously 41 employs and exploits the reader's expectations for regional literature's settings 42

and characters, producing scenes of community reconciliation in which catego-1 2 ries of normalcy and deviation are unsettled. While Zagarell notes that in some 3 cases, a community's coherence "may be grounded in categorizing certain people 4 as outliers, outcasts, deviants" ("Reflections" 434), the neighborly encounter 5 empowers those who are categorized as outsiders within their own communities 6 to communicate a transformed vision of coherence and unity. By encouraging 7 readers to recognize these outsiders as "neighbors," Freeman's fiction proposes 8 an alternative mode by which outsiders can be assimilated-both into the social 9 fabric of the village and into the broader narrative of national identity.

10 This assimilation is not without its limitations or its areas of concern, how-11 ever. If, following Zagarell, we recognize that narratives of community reflect 12 not a purely positive or even benign mode of belonging to communities, then 13 the emphasis in Freeman's neighborly encounters on the collective benefit of 14 neighborliness should be read with caution. Neighborliness is the means by 15 which one's obligation to others—especially to others who exist outside of the closed systems that structure the community-is defined and reinforced. For 16 17 Freeman, neighborliness bridges the gaps that outsiders-those marginalized 18 within their communities due to reasons of age, solitude, ability, poverty, nonconformity, and gender-have fallen through. But here it is important to note 19 the significance of the community blessing at the end of "Christmas Jenny" and 20 other stories featuring neighborly encounters. As an outcome of the neighborly 21 2.2 encounter, the broader benefit to the collective makes the excesses of neighbor-23 liness more palatable, particularly when neighborliness is seen as a culturally 24 resonant metaphor for the reception of regional texts and people. In emphasiz-25 ing the collective benefit resulting from the neighborly encounter, Freeman para-26 doxically demonstrates that individual empowerment alone is an insufficient 27 cause for the extravagance of neighborliness.

28 While Freeman's project of neighborly reconciliation offers tantalizing 29 possibilities for reimagining the modes of belonging to regional and national 30 imagined communities, the limitations of neighborliness leave many questions unanswered. Is the transformative insight gained and communicated by mar-31 32 ginalized figures during their liminal encounters lost in their reintegration into 33 their communities, or are their communities truly transformed? Freeman's ten-34 dency at the end of her stories featuring neighborly encounters to broaden her focus, shifting from scenes centering her "strange" outsiders to a more 35 wide-angle perspective on the entire village, offers an intriguing entry point at 36 37 which to probe this question. Is Freeman limiting the transformative power of 38 neighborliness by encouraging her readers to focus ultimately on the benefit of 39 collective transformation that reintegrates deviant characters into the fabric of 40 the community?

Freeman's neighborly project is also limited in a more apparent way: her vision of neighborliness asks readers to imagine kinship with marginalized

figures who fall outside of normative domestic and civic structures for reasons of age, class, ability, and gender. Absent from this list are those marginalized due to race or ethnicity. Whiteness is presumed in all of these encounters, spotlighting the structural inequalities that are intrinsic to regionalism's vision of community. The inherent whiteness of Freeman's neighbors is perhaps the most obvious limitation of the project of neighborliness, but the role neighborliness plays in service to community reintegration suggests that Freeman's larger message to her urban readers is perhaps not so revolutionary as one might hope. While the metric of neighborliness enables a vision of community formation that exceeds the boundaries of the domestic family and normative religious and civic structures, the regional "other" who is reintegrated into her commu-nity is ultimately a relatively safe and familiar outsider, particularly at a time when questions of racial and ethnic difference and nativist notions of national identity were rife. Ultimately, the neighborly encounter is the means by which Freeman's communities move toward a transformed coherence-one that in opposing normative structures and working to redistribute power among the marginalized of the community paradoxically demonstrates that such trans-formation requires the participation of those in power to truly effect change.

- 3. During the liminal phase, participants are necessarily outside of ordinary grouping systems; they are, as Turner says, "betwixt and between the positions assigned and arrayed by law, custom, conventions, and ceremonial" (*Ritual Process* 95).
- 4. Foote takes up the topic of neighborliness in a forthcoming essay that comes to some similar conclusions as I do here, although Foote's overall project has a different aim from mine. For example, she defines neighborliness as a "social interaction generated by the accident of physical proximity" that "provides a more nuanced way than community to look at the dialectics between strangers and natives, and at the unspoken but customary obligations people owe to one another." However, Foote's essay differs from mine in some key ways. One of these is that she describes Freeman's neighborliness as "almost always [having] an expressly legislative function," chief among which is "help[ing] to draw boundaries between different social actors" (5). While I also read Freeman's neighborliness as exploring the limitations of traditional conceptions of community within normative structures (Foote specifically discusses the structural forces of the domestic sphere and US imperialism), my examination ties neighborliness to liminal encounters that work to erase boundaries rather than further reinscribe them. I am grateful to Stephanie Foote for generously sharing this essay with me in draft form, and I look forward to engaging with her ideas more when the essay is published in the forthcoming Cambridge Companion to Race and American Literature.
- 5. In the case of *The Jamesons*, Zagarell argues, Freeman offers a "canny critique" of the regionalist narrative of community, turning "the genre into a satire of *Country* and other regionalist works for their unquestioned metropolitanism and proffers a community that differs" from other regionalist communities (such as Jewett's Dunnet Landing) which are steeped in tradition (440).
- 6. Zagarell notes that Freeman's *The Jamesons* "might be called a narrative of community preservation, for its six sketches focus on Mrs Jameson's assaults on community life and the community's deepening skill in withstanding her" (441).
- 7. Turner calls the more direct and egalitarian exchanges that grow out of the ambiguity in social relations created by liminality "communitas." While Turner describes these exchanges as "essentially opposed to structure," he also notes that communitas is simultaneously invested in remaking social structures from within (*Dramas*, *Fields, and Metaphors* 243).
- 8. This is similar to the conclusion of another of Freeman's stories of frustrated women artists, "A Poetess" (1890). What seems like a spiteful act at the story's end (Betsey Dole's request that the minister who unknowingly destroyed her dreams of writing poetry bury her with the ashes of her burned poems) is in a sense a criticism of the confining structure of the church, which, rather than offering true Christ-like welcome to someone like Betsey, instead replicates social hierarchies.
- 9. The "strangeness" I discuss here has been read by Ansley as "queer" ways of identifying. Ansley also argues that disability, poverty, and non-reproductivity are seen as deviant because they don't contribute to (or produce workers for) the capitalist system. In many of Freeman's stories, Ansley notes, "characters' orientation to space is 'queer' insofar as their perceived relationship to their environment is shaped by their disaffection from the demands of capitalism as it pulls them toward normative spaces of capital, biological, and social reproduction" (452–3).

1	10. Foote notes that regionalism "both displaces cultural anxiety about strangers, as
2	well as paradoxically registering the fact that anyone may become an alien, an
3	exotic fetish," a phenomenon she reads as a result of "the smooth function of
