Quantification of Asian monsoon variability from 68 ka BP through pollen-based climate reconstruction

ABSTRACT

 The glacial-interglacial variability of precipitation and its driving mechanism in monsoonal regions has long been a subject of debate. However, there are few records of quantitative climate reconstruction dating to the last glacial cycle in areas dominated by the Asian summer monsoon. Here, using a pollen-based quantitative climate reconstruction based on three sites in areas exposed to the Asian summer monsoon, we demonstrate that climate has undergone great variability over the past 68 ka. The differences between the last glacial and the Holocene 27 optimum could have been as much as 35%–51% for precipitation, and 5-7 °C for mean annual temperature. Our findings also reveal regional heterogeneity during the abrupt climate events of Heinrich Event 1 and Younger Dryas, that drove drier conditions in southwestern China dominated by the Indian summer monsoon, and a wetter climate in central eastern China. The pattern of variation in reconstructed precipitation, exhibiting strong glacial-interglacial variability, is broadly consistent with the stalagmite d18O records from Southwest China and South Asia. Our results of reconstruction quantify the sensitivity of the MIS3 precipitation to orbital insolation changes, and highlight the prominent influence of interhemispheric temperature gradients on Asian monsoon variability.

 Comparison with transient simulations and major climate forcings has shown that the mode of precipitation variability during the transition from the last glacial maximum to the Holocene has been significantly modulated by weak or collapsed Atlantic meridional overturning circulation events in addition to insolation forcing.

INTRODUCTION

 The Asian summer monsoon, comprising the Indian Summer Monsoon (ISM) and the East Asian Summer Monsoon (EASM), is a critical climate system in the understanding of orbital- scale climate variability driven by changes in the land-sea thermal contrast and atmospheric pressure [1]. Among the climate variables, precipitation reconstruction is a key process in revealing the summer monsoon's evolution and variability, while stalagmite d18O records have been considered to be a significant proxy indicator [2,3]. In the Asian monsoon region, a great number of stalagmite d18O records have revealed the close relationship between monsoon variations and solar insolation on orbital-millennial scales, showing a significant precession cycle [4]. The synthesized Chinese stalagmite data show that d18O records are a valid indicator of EASM intensity or integrated moisture transport, and the d18O variations of Chinese stalagmites cannot be simply interpreted as local precipitation, but rather as a mean state of summer monsoon intensity [5,6]. However, the temporal and spatial consistency of the d18O records with strong precession cycles are notably different from the significant 100 ka cycles derived from the marine and loess records [7]. Such contradiction leads to the driving mechanism for glacial-interglacial cycles and the role of internal forcings such as ice sheet size, CO2 concentration, and millennial scale perturbations remains unclear [8,9]. Moreover, the high consistency of Chinese stalagmite d18O records as a mean state of summer monsoon variability cannot directly reflect the regional heterogeneity of rainfall

 in the Asian Monsoon Domain (AMD) [10]. In this respect, the application of quantitative climate reconstructions based on pollen data can reflect regional heterogeneity and validate the difference between monsoon intensity and rainfall amount. Although quantitative precipitation reconstruction studies at a global or continental scale exist [11], few have focused on quantitative data from the last glacial period and the Holocene in monsoonal China. In recent decades, efforts have been made towards quantitative climate reconstruction in eastern Asia, but most studies have been confined to the Holocene and located in marginal areas influenced by the summer monsoon, such as northern China and the Tibetan Plateau [12,13]. One study based on the Dajiuhu pollen record from east-central China covering the last 16 ka shows that the annual precipitation has varied from about 900 mm during the last deglaciation (16–10 ka BP) to 1256 mm during the Holocene optimum (10-7 ka BP) [14]. On the Tibetan Plateau, where the summer monsoon influence is relatively weak, the pollen-based precipitation reconstruction revealed extremely dry conditions at the Last Glacial Minimum (LGM), being only 32% of the present-day rainfall [13]. However, high-resolution climate reconstruction within the humid monsoonal area is still lacking. This greatly hinders our understanding of the driving mechanisms responsible for orbital and abrupt climate changes, and our ability to identify the possible existence of phase-relationships in the monsoon climate system.

 Here, we present quantitative reconstructions of precipitation and temperature for the past 68 ka using representative pollen records from three locations along the summer monsoon pathway in southern China. Two records are located directly in the moisture pathway of the ISM in southwestern (SW) China, while one is located in central eastern China where climate is influenced not only by the ISM, but also by the EASM (Fig. 1). Using a novel statistical approach to pollen-based climate reconstruction, we obtained very consistent results that allowed us to quantify precipitation variability, decipher regional heterogeneity, and evaluate the speleothem proxy records. Our high-resolution climate reconstruction, associated with simulation using a transient model, provides robust evidence for a better understanding of the spatiotemporal hydroclimate changes in the Asian monsoon system.

MATERIAL AND METHODS

Regional setting and core sites

 The quantitative climate reconstruction strategy we followed was based on three pollen records. The longest one, covering the last 68 ka, is Tengchong-Qinghai (TCQH) [20] from a volcanically dammed lake (25.1312°N; 98.5731°E; 1885 m) situated to the west of the

 Gaoligong Mountains in Yunnan Province of SW China. The local climate is dominated by Indian monsoon circulation, with humid conditions from May to October, and a dry season from November to April. The mean annual temperature (MAT) of the core locality is approximately 15.4 °C, and the mean annual precipitation (MAP) is approximately 1532 mm, with a peak in July (>300 mm). The second core was obtained from the protected Caohai (CH) lake of western Guizhou Province (26.8140°N; 104.3405°E; 2165 m). This site, also in the southeastern margin of the Tibetan Plateau of SW China, experiences weaker monsoon rainfall intensities. However, together with the TCQH record, this site provides information on summer rainfall levels along the ISM moisture trajectory. The MAT in the study locality is approximately 10.9 °C, and MAP is approximately 974 mm, with a peak in June and July (>160 mm).

 The Dajiuhu (DJH) record [21] originates from a karst lake in the Shennongjia mountains near the Middle Yangtze River of central China (31.4833°N; 110.0666°E; 1751 m), close to the northern boundary of the subtropical zone. The DJH wetland is 1770–1800 m above sea level and surrounded by mountains with heights in the range 2200–2600 m. The regional climate is characterized by a transition between subtropical and warm temperate regimes. Under the strong influence of the EASM, the area has short, warm and wet summers, and long, cold, dry winters. Presently, the MAT is 7.4 °C and the annual precipitation is 1379 mm, 40%–50% of which falls in summer. Annual evaporation varies from 500 to 800 mm, indicating relatively high humidity.

Age models and pollen records

 The TCQH core was drilled using a gravity piston corer under water 2.13 m deep. The core was 13.2 m long and the sediments were relatively uniform, except for a possible volcanic ash layer at 6.1–6.6 m. In total, 261 samples at 4–5 cm intervals were collected for pollen analysis. The chronology of the core was determined using accelerator mass spectrometry radiocarbon (AMS14C) dating of 14 samples of plant fragments and bulk organic sediments by Beta Analytic Inc., Miami, USA (Fig. S1a and Table S1 online). However, there were few dating samples for the glacial period, particularly for the interval older than 30 ka BP. In order to make up for this deficit, the paleomagnetic datapoints were used to provide additional age control points for the lower section of the core [20]. The relative paleomagnetic intensity (RPI)

 curve of the TCQH core was compared with curves obtained from analyses of South China Sea sediments [22] and the global RPI stacks [23]. Four recognized RPI lows correlated with those

from Sint-200, at 16, 30, 40, and 62 ka, respectively corresponding to four geomagnetic

excursions. The first two were in good agreement with the 14C dating results. Therefore, the

two deeper age controls (#40 and 62 ka BP) were used for our chronological framework [20].

 The resulting age-depth model suggested that the core covered the last 68 ka BP, corresponding to marine isotope stages MIS4 to MIS1. The average temporal sampling resolution was about 250 years.

In 2013, a 4.05 m continuous sediment core was taken from the CH wetland. All sediment was

 sampled at 1–2 cm intervals, with a total of 226 samples prepared for pollen analysis. Nine samples were taken for AMS 14C dating. Based on the calibrated ages, the time span covered by the CH record was approximately 22 ka BP, with a sampling resolution of about 94 years.

 A continuous and undisturbed 6.0 m core was collected from a peat bog at the DJH site using a Russian-type peat corer [21]. A total of 153 sediment samples were taken at 2–5 cm intervals from this core. To obtain a chronology for the sequence, seven bulk peat and wood samples were taken for AMS 14C dating. The dating results showed that the core covered the last 42 ka BP, with a sampling resolution of about 270 years. The two ages (10.03 and 13.37 ka BP) at depths of 163 and 193 cm basically defined the range of Younger Dryas (YD) event. In addition, a published pollen-based quantified precipitation of the same lake based on more dating results [14] was used to compared with our data. At the three study sites described above, all 14C dates were calibrated to calendar ages using the Bacon software package and IntCal20 calibration curves [24]. The three records include a total of 639 pollen samples, corresponding

to a centennial resolution.

 For all pollen samples from the three cores mentioned above, 1–2 g of sediment was weighed and processed by heavy liquid separation [25]. Briefly, after adding 15% HCl to remove carbonates, followed by 10% KOH to remove humic substances, each sample was subjected to heavy liquid flotation, then mounted in glycerin jelly and examined under a light microscope. On average, 521 terrestrial pollen grains (with proportionally corresponding numbers of fern and algal spores) per sample were counted. All percentages of pollen grains and spores (of trees, shrubs, terrestrial herbs, wetland herbs (Cyperaceae), ferns, and algae) quoted here are based on the total sum of pollen from terrestrial taxa. The data were graphed

using Tilia (Figs. S2–S4 online) [26].

Pollen-based quantitative climate reconstruction

 To identify the climate variables that most strongly influence the regional vegetation, six climate variables, including MAT, mean temperatures of warmest month (MTwa) and coldest month (Mtco), MAP, mean precipitations of warmest month (MPwa) and coldest month (MPco), were initially selected to characterize the climate at each modern pollen sampling site. A correlation analysis of these six climate variables was carried out for the three study cores using the modern pollen datasets (Fig. S5 online). Result showed that the best variables of the three cores were MAT and MAP (Table S2 online), and the seasonal climate parameters had a high correlation with them. Therefore, MAT and MAP were considered appropriate variables for the development of calibration models.

 The continuous improvement of modern pollen databases in East Asia provides a good foundation for this quantitative paleoclimate study [27]. The selection of the distribution range of modernpollen samples is a key step in the pollen-based quantitative climate reconstruction. Based on the chosen climate variables and the zonal vegetation types in the regions, the modern pollen sites with 9 different radiuses (from 700 to 1500 km at 100 km spacing) were compared. This comparison showed that the results of quantitative reconstruction did not improve linearly with the spatial increase of selected distribution area. Along with the stepwise increase of the spatial extent of the calibration subset when the radius is increased from 700 to 1500 km, values of R2 peaks and the values of RMSEP are relatively low when the radii are 1000, 1100, and 1200 km, especially for the 1100 km radius subset, suggesting that the dataset (r = 1100 km) exhibits the best model performance for all the three sites (Table S2 online).

 Therefore, in this study, we used the reference datasets within a radius of 1100 km around the focal sites to provide high-quality information on pollen-climate relationships to enable quantitative paleoclimate reconstruction (Fig. S6 and Table S2 online). In addition, we tested the suitability of several calibration models for the selected modern pollen database. The Locally Weighted-Weighted Average Partial Least Squares (LW-WAPLS) calibration model was ultimately chosen because it yielded a significantly lower root mean square error (RMSE) than the other tested transfer function methods (Table S3 online). The results of leave-one-out cross validation of the LW-WAPLS model are summarized in Table S4 (online). It was found that the model's RMSE values were lowest and its R2 values were highest when the reconstruction was based on #30 analogs (k = 32, 30 and 28). The ''Rioja" package in ''R" was used to establish and check the pollen-climate models, and the ''analog" package was used for the Locally Weighted-Weighted Average (LW-WA) and LW-WAPLS models [28].

Model simulations

 The National Center for Atmospheric Research Community Climate System Model (NCAR- CCSM) is a global, coupled ocean/atmosphere/sea-ice/land-surface climate model [29]. For the present study, we used the result of a transient simulation in a fully coupled climate model, version 3 (NCAR-CCSM3) at low resolution [30], which can simulate the climate evolution of the last 300 ka. The atmospheric model, Community Atmospheric Model 3 (CAM3), and the land model have a #3.75° latitude-longitude resolution (T31). The ocean model is the NCAR implementation of the Parallel Ocean Program (POP), with a #3.6° longitudinal resolution.

 The sea-ice model is the NCAR Community Sea-Ice Model (CSIM), a dynamic-thermodynamic model that includes a subgrid-scale ice thickness distribution. Several 3000-year-long transient simulations were carried out, in which the orbital forcing (ORB), green-house gases concentration (GHG), and ice-sheet volume (ICE), differently combined (ORB, ORB + GHG, ORB + GHG + ICE), were ascribed to the last 300,000 years (300 ka BP to present day, 0 ka BP), but with an acceleration factor of 100. The low resolution NCAR-CCSM3 generates glacial-interglacial variability comparable to modern observed records [30] as well as to some key

proxy records since the LGM [31]. In this study, we used the simulated

 results of the monsoon region in eastern Asia (between 20°–55°N and 90°–120°E) over the last 70 ka for comparison with the pollen-based quantitative climate reconstruction.

RESULTS

 The three records studied were from the Tengchong–Qinghai volcanic lake (TCQH), the Caohai mountain wetland (CH), and the Dajiuhu mountain wetland (DJH), covering the last 68, 22, and 42 ka respectively (Fig. 1 and Fig. S1 online). At the two ISM sites (TCQH and CH), the vegetation changes from the glacial to Holocene were characterized by the transformation from a sclerophyllous forest dominated by Tibetan evergreen oak, named Quercus (T/E), to a broadleaved forest dominated by Castanopsis/Lithocarpus (Figs. S2 and S3 online) [20]. In contrast, the DJH record reflected a change from a mixed alpine coniferous/sedge meadow to temperate deciduous forest due to its more northerly latitudinal position and the climatic dominance of the EASM (Fig. S4 online) [21].

 Two climate variables—MAP and MAT—were quantitatively reconstructed (Fig. 2). The predicted quantitative results of these climate variables, using LW-WAPLS calibration models, gave high correlation coefficients between observed and predicted values (R2 > 0.8). The reconstructed precipitation records for TCQH show a relatively low level of precipitation (average 1026 mm) in the earliest interval (68–57 ka BP) corresponding to MIS4, with significantly more precipitation (average 1258 mm) during MIS3 between 57 and 43 ka BP. All three records consistently indicate that precipitation fell to a minimum (average 927 mm in TCQH, 542 mm in CH, and 903 mm in DJH) at 28–16 ka BP, which coincides perfectly with

 the timing of the global LGM [33]. The variability in precipitation between the LGM and the Holocene in the three cores ranged by as much as 500–940 mm, the largest being in the case 242 of CH. It is worth noting that the precipitation reconstructed with the DJH core clearly increased during the period around 18–16 ka BP (H1), which is highly consistent with the Humification result (Fig. S7 online) and previous high-resolution reconstruction results

of the same site [14].

 In order to understand better the relationship between reconstructed MAP and simulated annual and seasonal climate changes in each study site, we compared the simulated precipitation (in summer, winter and annual) using the TraCE21 model for the locations of TCQH, CH, and DJH (Fig. S8 online). The result shows that the pollen-based MAP matches the simulated precipitation in summer and the whole year better than that in winter, indicating a strong summer monsoon rainfall signal in pollen assemblages. This implies that the pollen proxy is also a good summer monsoon indicator and comparable with stalagmite records. However, there is a clear decoupled variation between the pollen proxy and the model's result during the LGM in all three sites. Such inconsistent changes may imply, on the one hand, that the simulated local precipitation for the LGM was largely overestimated (particularly in TCQH and DJH) or, on the other hand, decreased temperature at LGM might interfere, to some extent, with the result of pollen-based precipitation reconstruction because thermal condition is one of the main factors of vegetation transformation. We also quantitatively reconstructed MAT, which yielded compelling results because the modern pollen dataset covers a large area with high spatial resolution. Its overall variation trends were found to be in good agreement with the results derived from biomarkers (brGDGTs) [18] for the same lake (TCQH), although there were some differences in amplitude due to seasonal biases [34] (Fig. S9 online). The two southwest 263 records show much lower temperatures than at present at the LGM i.e., 5.7 °C (TCQH) and 7.2 °C (CH). In central China (DJH), where the climate is dominated by the EASM, it was 265 #4.7 °C lower than at present, which is close to the model's results [11,35]. The greater lowering of temperature at the LGM observed at the TCQH and CH sites in SW China than at DJH in central China are likely due to the extent of mountain glaciers along longitudinal valleys in the Hengduan mountain ranges on the southeastern edge of the Tibetan Plateau. We note that the elevations of our study sites are all above 1700 m, and suggest that these results probably reflect a steeper lapse rate in low-latitude mountains during the LGM [36] due to elevation- dependent temperature amplification by surface albedo caused by changes in mountain glaciers [37]. Temperature and rainfall quantified in the Holocene Thermal Maximum (HTM), concentrated between 9 and 5 ka BP, were basically in phase and approximately contemporaneous at the three different sites.

DISCUSSION AND CONCLUSION

Hydroclimate changes and regional heterogeneity of the Asian monsoon system

278 In areas where the current annual precipitation exceeds 1300 mm (e.g., TCQH and DJH), the

 absolute reductions in precipitation during the LGM were quite similar (about 35% lower). The larger decrease in precipitation (51%) at the CH site, being spatially consistent with the present- day low rainfall, suggests that the winter monsoon had a stronger influence during the LGM in this location. The orbital-scale variation of precipitation derived from thethree study records from SW and central eastern China are basically coupled, although their absolute amounts differ (Fig. 2 and Table S5 online). This is broadly in agreement with the hypothesis derived from orbital-scale d18O data from stalagmites, which suggests that variations in monsoon strength are driven by large-scale atmospheric dynamics associated with changes in solar radiation, rather than precipitation at the regional scale [38]. However, some reconstructed and modeled monsoon rainfall in southeastern (SE) China suggests the strongest EASM intensity occurred in the middle or late Holocene [39,40], which differs from speleothem d18O data. Our data, with relatively low resolution for the Holocene interval, suggest that precipitation was generally high in the middle Holocene over the study areas, while the late Holocene saw amore pronounced drop in DJH rainfall in central China than in SW China. This indicates that there was interregional diversity in the Holocene rainfall patterns of southern China. This may be attributed to the position of the westerly jet stream [40], and/or a stronger Western Pacific Subtropical High (WPSH) and southerly monsoon wind and moisture divergence during mid-to-late Holocene producing less moisture divergence and reduced rainfall in SE China [10].

 In addition, we observed clear indications of the abrupt climate changes associated with the Heinrich event 1 (H1) and YD. However, these millennial-scale abrupt climate perturbations in the DJH records of central eastern China were characterized by increased rainfall rather than the reduced rainfall observed in SW China, indicating precipitation in antiphase. In particular, DJH records show that precipitation increased from #860 mm during the LGM to #1020 mm at the H1 event, exhibiting a clear antiphase with the lowest stand of rainfall amount over the ISM region (i.e., in the TCQH and CH records). Such hydroclimatic heterogeneity over the East Asian region is consistent with the modern-day spatial pattern of summer rainfall variability over East Asia. This is represented by a meridional ''tripole" pattern of precipitation, with increased rainfall over northeastern and southwestern China, and decreased rainfall over central eastern China [32,41]. Our age-depth model of the DJH record compared with another record with more 14C dating data [34] produces an accurate framework for capturing the YD event, which shows a coincidence between an abrupt colder climate and higher precipitation at the YD. However, it should be pointed out that both records from DJH wetland lack direct dating results close to the H1 event, so there may be age uncertainties due to relatively low time-resolution. This needs to be confirmed in the future.

 Our findings agree with the results from the multiproxy speleothem records for the middle Yangtze region that indicate a wetter central eastern China during North Atlantic cooling events, despite the oxygen isotopic records suggesting a weaker monsoon [32]. Our quantitative result is compelling because it demonstrates that a weakened Asian summer monsoon led to drier conditions in SW China, while central China was relatively wetter during these abrupt events. The jet transition hypothesis concerning shifts in the meridional temperature gradient and seasonal displacement of the westerlies has been proposed as an explanation for the observed antiphase of rainfall and for the East Asian hydroclimate simulation that predicts a slowdown of the Atlantic Meridional Overturning Circulation (AMOC) that is representative of the H1 event and YD [32,42].

Pollen-based climate reconstruction in comparison with speleothem d18O records

 The highly coupled orbital-scale variation of precipitation evident from the three pollen records in southern China shows a significant variability from the last glacial period to the Holocene. In general, its pattern agrees well with d18O records from most stalagmites in eastern Asia which have been considered as the index of monsoon intensity. The overlap between the speleothem records and the reconstructed MAP is broadly coherent in most records from regions both ISM and EASM dominances, despite some biases during the glacial period (Fig. 3). Taking into account the significant difference between the d18O records from southwest and southeast of Chinese mainland [10,17], we compared the speleothem d18O records separately from regions of ISM and EASM domains (Fig. 3). On glacial-interglacial timescales, the records from the Xiaobailong (XBL) [17] and southeastern Yunnan (SEY) (unnamed cave) [16] in SW China and the CBoB caves (Hin Thun No.2 cave, Padamya cave, Phabaung Gu cave, and Ya Thea Phyan Gu cave) near the Bay of Bengal [16] displayed distinct differences in d18O values between the last glacial period (MISs 4–2) and the Holocene, indicating relatively weak ISM during the glacial period.

 This is in good agreement with our quantified precipitation and previously observed evidence from the Chinese loess [43]. In particular, the integrated d18O data from the CBoB records located near the Bay of Bengal [16] are highly coherent with our reconstructed precipitation (Fig. 3e), indicating that the CBoB caves are located at a key location in the main moisture transport path from the Indian Ocean to the study areas. It has been found that the records close to the monsoon moisture source demonstrate larger glacial-interglacial variability, which then decreases landward because of the moisture pathway effect in the stalagmite d18O data [16]. It is presumably correct that the massive shelf exposure influence (such as Sunderland) on tropical Indo-Pacific hydroclimate was large at LGM, affecting both regional ocean and atmosphere circulations, and amplifying the glacial-interglacial cyclicity [44].

 In SE China, the speleothem d18O records from Dongge (DG) and Hulu (HL) caves [2,3] show greater differences from our data than in SW China. A climate model with an embedded oxygen- isotope model shows that the moisture advection path from Indian Ocean to eastern China moved equatorward and strengthened over the southern Bay of Bengal during the LGM, contributing only #30% and 15% of the LGM precipitation at DG and HL, respectively [45]. A recent simulation using an isotope-enabled general circulation model has revealed that LGM summer precipitation decreased substantially over the Indian Ocean and South Asia, but increased in East Asia (around east of 105°E) [17]. These modeling results have shed light on how glacial-interglacial changes in monsoon rainfall are manifested in isotopically different ways between SW and East China. According to the Rayleigh distillation model, temperature is one of the factors responsible for the differences in d18O between the LGM and the present on land in Southeast Asia [16].

 Our estimate of MAT between the last glacial period and the Holocene is about 5–7 °C at the ISM-dominated mountain sites on the southeastern margin of the Tibetan Plateau, which is consistent with previously reported temperature estimates for the Tibetan Plateau [46] and the modeled temperature for SW China [47]. Pronounced glacial climate changes may have resulted in greater isotopic distillation than today and thus progressively lower d18O values for precipitation as one moves downstream along the trajectory of the ISM [6].

For orbital and millennial timescales, a comparison of our quantified precipitation with

 speleothem d18O records suggests that the variations in d18O records may reflect strong (weak) summer monsoon events as a whole, rather than amount of local rainfall at an individual site [8,17]. Despite the variation in d18O of precipitation indicating a mean state of summer monsoon intensity, the records from the locations near the moisture source area (e.g., CBoB) may exhibit a closer variability with local amount of precipitation as shown by our pollen-based precipitation reconstruction. The coupled relationship with stalagmite d18O data from SW China and the coastal area near the Bay of Bengal demonstrates the high reliability of pollen-based precipitation reconstruction, which can be used as a standard precipitation mode in monsoonal region dominated by ISM.

Model-proxy comparison and climate forcings

 A standardized approach was used to integrate quantitative precipitation data in eastern Asia, including our three sites and Gonghai lake (GH), the latter on the edge of the Chinese Loess Plateau near the EASM boundary [12]. In the two sub-systems (i.e., ISM and EASM) of Asian summer monsoon, we found that the general trends of precipitation variation are broadly coupled. The only difference between the two monsoon domains is that the absolute rainfall amount was much higher in SW China (ISM) than in central-east (DJH) and northern China (GH) dominated by EASM (Fig. 3). In addition, the variation pattern of MIS3 rainfall is better matched with the summer insolation at 60°N than at 30°N, likely indicating that high-latitude forcing was more important in driving the hydroclimate changes in the Asian monsoon domain (Fig. 4A, b). Several proxy data from loess and stalagmite records also suggest that solar radiation at high latitudes may dominate the precipitation variability of the Asian summer monsoon [54]. The tradi tional theory postulates that changes in the high-latitude summer insolation drove variations in glacial-interglacial ice sheet extents which, in turn, triggered changes in other parts of the global climate system [55]. Over recent decades, however, another hypothesis has highlighted that monsoon variation is largely driven by inter-tropical insolation differences [56]. It was found that the summer insolation at 60°N high-latitude and the July 21 insolation differential between tropics 30°N and 30°S were virtually identical in terms of their phases [8], both of which are in good agreement with our reconstructed precipitation variations (Fig. 4). In general, June insolation at high-latitude of the Northern Hemisphere is considered as the critical forcing driving changes in the ice sheet extent, while insolation differential between interhemispheric tropics triggers monsoon variations on the orbital-scale, such as the Asian summer monsoon [57]. The consistency of our data with the ''Summer Inter- Tropical Insolation Gradient" (SITIG) first proposed by Reichart [56] likely supports the hypothesis that the insolation differential between interhemispheric tropics drives Asian monsoon variations on the orbital-scale [8]. Compared with the traditional theory, ''SITIG" appears to be a more integrated forcing of monsoons, because the insolation difference involves both ''pull" and ''push" forcings from two hemispheres that drive monsoon changes.

 Our evidence, tightly coupled with the SITIG, highlights the influence of interhemispheric temperature gradients on monsoon variability. The consistency with the marine proxy records from the Indian Ocean, the main source area of Asian summer monsoon rainfall, also agrees with the mechanism triggered by the inter-tropical insolation gradient [49,50].

 In matching our data and the insolation cycles, we found some obvious time lags in the reconstructed precipitation. For instance, during the last glacial termination, there was a distinct time lag (4–5 ka) between the lowest amount of precipitation (corresponding to H1 event) and 422 the lowest boreal summer insolation. The drier conditions that prevailed during H1 have been found in many records in eastern Asia and across the world [58]. To understand further the forcings of precipitation changes in AMD, we used the transient simulation in a fully coupled climate model of low resolution [59], which can simulate the climate evolution of the last 300 ka. The National Center for Atmospheric Research Community Climate System Model 3 (NCAR-CCSM3) forcing experiments under orbital (ORB), greenhouse gases (GHGs), and ice sheet (ICE) were created individually. The orbital modulation of glacial-interglacial precipitation 429 variability shown in the models may be useful for a correct interpretation of monsoonal changes in high-resolution pollen records. As expected, the solo-forcing experiments clearly show the dominance of orbital effect on AMD precipitation changes over the last glacial-interglacial cycle, which are basically consistent with our quantitatively reconstructed MAP pattern over the last 68 ka (Fig. 5). Although the NCAR-CCSM3 produces precipitation variability that is generally comparable to our combined proxy records, it still has a 4–5 ka difference between them at the lowest values during the LGM.

 The time lag of pollen-based precipitation behind the transient model and/or solar radiation during the last glacial termination (H1), together with the YD event, can be explained by the high and low latitude climate teleconnections, where the abrupt input of fresh water to the North Atlantic led to reductions in the AMOC and resultant lowering of sea surface temperatures (SSTs) [49,60].

 The AMOC dynamics and ice volume forcing are the key processes which link changes in high-latitude temperature to low-latitude monsoon intensity [8,61]. The 231Pa/230Th records from a highly resolved marine sedimentary record in the deep western North Atlantic show that only those Heinrich events that occurred close to glacial maxima coinciding with massive expansions of marine-based and land-based ice sheets (H1 and H2) were able to trigger the off mode of AMOC [51,62], and deeply affect the Asian monsoon intensity.

 Investigations of marine d18O records derived from planktonic foraminifera and (SST) estimates in the tropical Indian Ocean [49] also suggest a close relationship between the warm basins of the Indo-Pacific region and high-latitude ice sheet changes linked by the global thermohaline circulation (Fig. 4). A simulated Northern Hemisphere terrestrial climate dataset for the past 60 ka produced a result similar to our data, that the inclusion of abrupt events represents millennial-scale monsoon variability driven by fluctuations in the strength of the AMOC (Fig. 5) [11]. North Atlantic water-hosing experiments suggest a dynamic response of the monsoonal wind and precipitation in East Asia to a reduction of the AMOC, and the northern westerlies may play a role in transmitting the signal from the North Atlantic to the Asian monsoon regions [63].

 In the Holocene, the heterogeneous spatiotemporal patterns of rainfall as inferred from previous proxy-based reconstructions and modeling for China indicate that the mechanisms behind the EASM remain poorly understood [40]. Our quantification data suggest that the maximum rainfall amount occurred at slightly different periods of the Holocene in the three locations, but no earlier than 8–9 ka ago, which was behind the peak of summer insolation and the result derived from the transient model. Such a result is broadly consistent with the synthesized Chinese Holocene stalagmite d18O records showing that the maximum strength and stability of the EASM occurred during the middle Holocene at 6–8 ka BP [3], in accordance with the classical view of a middle Holocene Optimum in China [10]. During the late Holocene, the quantified precipitations from around 3 ka BP on a centennial-millennial scale show some sharp fluctuations and a slight declining trend. Analysis of dominant pollen taxa in the late Holocene shows that the key pollen taxa (e.g., Poaceae, Pinus, Alnus, etc.) differ from those in the LGM (dominated by deciduous trees or Tibetan Sclerophyllous Quercus and alpine conifers). The increase in grassland and Alnus or Pinus forest may be related to the expansion of secondary forest due to more frequent fires [64]. It implies that pollen-based precipitation reconstruction of the late Holocene may be influenced by anthropogenic disturbance, leading to significant errors within reconstruction and bias against simulation results.

CONCLUSION

 The pollen-based quantitative climate reconstruction of the last 68 ka highlights a significant climate variability in southern China, which is characterized by a 35%–51% reduction in MAP, and 5–7 °C lowering in MAT during the last glacial period. Quantification of temperature changes suggests a steeper altitudinal lapse rate in the low-latitude alpine regions during the LGM, which is consistent with climate simulation in the marginal mountains of the Tibetan Plateau. The quantitative precipitation reconstruction broadly agrees with the d18O records from most stalagmites in East Asia.

 On glacial-interglacial timescales, the records from the caves in SW China and near the Bay of Bengal are more consistent with our data than those from East China. This is in accordance with the studies on synthetic Chinese d18O records and modeling results, showing that glacial- interglacial changes in monsoon rainfall are manifested in isotopically different ways between SW and East China. In particular, the best matching of our data with the CBoB records may indicate that the location of the caves closer to the monsoon moisture source demonstrate larger glacial-interglacial variability. In addition, shelf exposure influence on tropical Indo-Pacific hydroclimate can largely affect regional ocean and atmosphere circulations, and thus amplify the glacial-interglacial cyclicity. By comparing with climate forcings and transient climate simulations, we found that the Asian monsoon precipitation was mainly driven by the insolation

 transition from the LGM to the mid-Holocene was largely modulated by the abrupt changes caused by the input of fresh water to the Atlantic and Southern Oceans during events such as H1 and YD. We suggest that composite interactions between external (solar radiation) and internal forcings (e.g., shelf exposure, SST and so on) significantly affected the variability of the Asian summer monsoon. Our evidence also supports the hypothesis that there was a spatial

507 differential between interhemispheric tropics on the orbital-scale, but its variation during the

- 513 antiphase of precipitation between the records from SW and central China during the H1 and
- 514 YD events, indicating regional heterogeneity in the Asian monsoon systems. The present study
- 515 provides a robust standard pattern for precipitation variations in the humid regions of the Asian
- 516 summer monsoon, which can be used to validate the unquantified paleoclimate data. This study
- 517 provides a useful analog for the behavior of the Asian summer monsoon in the coming centuries.
