# A CONSTRUCTION OF THE SHEPHARD-TODD GROUP $G_{32}$ THROUGH THE WEYL GROUP OF TYPE $E_{6}$

#### Abstract

It is well-known that the quotient of the derived subgroup of the Shephard-Todd complex reflection group $G_{32}$ (which has rank 4) by its center is isomorphic to the derived subgroup of the Weyl group of type $E_{6}$. We show that this isomorphism can be realized through the second exterior power, and take the opportunity to propose an alternative construction of the group $G_{32}$.


Let $G_{32}$ denote the complex reflection group constructed by Shephard-Todd [ShTo] and let $E_{6}$ be a Weyl group of type $\mathrm{E}_{6}$ (which is denoted by $G_{35}$ in the Shephard-Todd classification). Let $\mathbf{S p}_{4}\left(\mathbb{F}_{3}\right)$ (resp. $\mathbf{S O}_{5}\left(\mathbb{F}_{3}\right)$ ) denote the symplectic (resp. orthogonal) group of dimension 4 (resp. 5) over the finite field with three éléments $\mathbb{F}_{3}$. Let $\Omega_{5}\left(\mathbb{F}_{3}\right)$ be the image of $\mathbf{S p}_{4}\left(\mathbb{F}_{3}\right)$ in $\mathrm{SO}_{5}\left(\mathbb{F}_{3}\right)$ through the natural morphism $\mathbf{S p}_{4}\left(\mathbb{F}_{3}\right) \rightarrow \mathbf{S O}_{5}\left(\mathbb{F}_{3}\right)$ : this is the normal subgroup of index 2 of $\mathrm{SO}_{5}\left(\mathbb{F}_{3}\right)$. Finally, if $G$ is a group, let $\mathrm{D}(G)$ and $\mathrm{Z}(G)$ denote respectively its derived subgroup and its center and, if $d$ is a non-zero natural number, let $\mu_{d}$ be the group of $d$-th roots of unity in $\mathbb{C}$.

It is shown in [LeTa, théo. 8.43 et 8.54 ] that $G_{32} \simeq \boldsymbol{\mu}_{3} \times \mathbf{S p}_{4}\left(\mathbb{F}_{3}\right)$ and that $E_{6} \simeq \mathbf{S O}_{5}\left(\mathbb{F}_{3}\right)$. In particular,

$$
\begin{equation*}
\mathrm{D}\left(G_{32}\right) / \boldsymbol{\mu}_{2} \simeq \Omega_{5}\left(\mathbb{F}_{3}\right) \simeq \mathrm{D}\left(E_{6}\right) . \tag{*}
\end{equation*}
$$

The purpose of this note is to present a direct elementary explanation of the isomorphism $\mathrm{D}\left(G_{32}\right) / \boldsymbol{\mu}_{2} \simeq \mathrm{D}\left(E_{6}\right)$, which in fact allows us to construct the the complex reflection group $G_{32}$ from the rational reflection group $E_{6}$. This construction uses the classical morphism $\mathbf{S L}_{4}(\mathbb{C}) \longrightarrow \mathbf{S O}_{6}(\mathbb{C})$, and follows the same lines as our previous paper [Bon] (in which we constructed the complex reflection group $G_{31}$ from the Weyl group of type $B_{6}$ ).

This note does not pretend to prove a deep result: it is just a a nice example of the application of the classical theory of reflection groups (invariants, Springer theory,...).

Remark. It is shown in [LeTa, Theo. 8.53] that $G_{33} \simeq \boldsymbol{\mu}_{2} \times \Omega_{5}\left(\mathbb{F}_{3}\right)$. In particular, this gives an indirect isomorphism $\mathrm{D}\left(G_{33}\right) \simeq \mathrm{D}\left(E_{6}\right)$. However, we do not know of any construction of this isomorphism which would be in the same spirit as above.

## 1. The morphism $\mathrm{SL}_{4}(\mathbb{C}) \rightarrow \mathrm{SO}_{6}(\mathbb{C})$

We recall here the construction of this morphism, using some notation from [Bon]. Let us fix a complex vector space $V$ of dimension 4 and let

\begin{aligned}
\Lambda: \mathbf{G} \mathbf{L}(V) & \longrightarrow \mathbf{G} \mathbf{L}\left(\wedge^{2} V\right) \\
g & \longmapsto \wedge^{2} g
\end{aligned}
$$

be the natural morphism of algebraic groups. Note that $\wedge^{2} V$ has dimension 6 and that

$$
\begin{equation*}
\operatorname{Ker} \Lambda \simeq \boldsymbol{\mu}_{2}=\left\{ \pm \mathrm{Id}_{V}\right\} \tag{1.1}
\end{equation*}
$$

The lists of eigenvalues of elements of $\mathbf{G} \mathbf{L}(V)$ or $\mathbf{G L}\left(\wedge^{2} V\right)$ will always be given with multiplicities. If $g \in \mathbf{G L}(V)$ admits $a, b, c$ and $d$ as eigenvalues, then

$$
\begin{equation*}
\Lambda(g) \text { admits } a b, a c, a d, b c, b d \text { and } c d \text { as eigenvalues. } \tag{1.2}
\end{equation*}
$$

In particular,

$$
\begin{equation*}
\operatorname{det} \Lambda(g)=(\operatorname{det} g)^{3} \tag{1.3}
\end{equation*}
$$

Let us fix now a generator $\varepsilon$ of the one-dimensional vector space $\wedge^{4} V$. The choice of this generator allows to identify $\mathbb{C}$ and $\wedge^{4} V$ and to define a bilinear form

$$
\begin{array}{ccc}
\beta_{\wedge}: \wedge^{2} V \times \wedge^{2} V & \longrightarrow \mathbb{C} \\
(x, y) & \longmapsto x \wedge y
\end{array}
$$

This bilinear form is symmetric and non-degenerate. By definition of the determinant,

$$
\begin{equation*}
\beta_{\wedge}(\Lambda(g)(x), \Lambda(g)(y))=(\operatorname{det} g) \beta_{\wedge}(x, y) \tag{1.4}
\end{equation*}
$$

for all $g \in \mathbf{G} \mathbf{L}(V)$ and $x, y \in \wedge^{2} V$. For dimension and connectedness reasons, the image of $\mathbf{G L}(V)$ through $\Lambda$ is the neutral component $\mathbf{C O}\left(\wedge^{2} V\right)^{\circ}$ of the conformal orthogonal group $\mathbf{C O}\left(\wedge^{2} V\right)=\mathbf{C O}\left(\wedge^{2} V, \beta_{\wedge}\right)$ and $\Lambda$ induces an isomorphism of algebraic groups

$$
\begin{equation*}
\mathbf{S L}(V) / \boldsymbol{\mu}_{2} \simeq \mathbf{S O}\left(\wedge^{2} V\right) \tag{1.5}
\end{equation*}
$$

The next elementary lemma will be useful (in this paper, we denote by $j$ a primitive third root of unity).

Lemma 1.6. - Let $g \in \mathbf{S O}\left(\wedge^{2} V\right)$ having $j, j, j, j^{2}, j^{2}$ and $j^{2}$ as eigenvalues. Then there exists a unique element $\tilde{g} \in \mathbf{S L}(V)$, having $1, j, j$ and $j$ as eigenvalues, and such that

$$
\Lambda^{-1}\left(\left\{g, g^{-1}\right\}\right)=\left\{ \pm \tilde{g}, \pm \tilde{g}^{-1}\right\}
$$

Proof. - Let $h \in \mathbf{S L}(V)$ be such that $\Lambda(h)=g$. Then $\Lambda^{-1}\left(\left\{g, g^{-1}\right\}\right)=\left\{ \pm h, \pm h^{-1}\right\}$. Let $a, b, c$ and $d$ be the eigenvalues of $h$. By (1.2), by reordering if necessary the eigenvalues of $h$, we may assume that $a b=a c=j$. In particular, $b=c$. So $b d=c d$, which implies that $b d=c d=j^{2}$ (for otherwise $j$ would be an eigenvalue of $g$ with multiplicity $\geqslant 4$ ). Still by (1.2), $(a d, b c)=\left(j, j^{2}\right)$ or $(a d, b c)=\left(j^{2}, j\right)$.

If $(a d, b c)=\left(j, j^{2}\right)$, then $b=c=d$ and $b^{2}=j^{2}$, so $b=c=d=\eta j$ and $a=\eta$, for some $\eta \in\{ \pm 1\}$. By replacing $h$ by $-h$ if necessary, the eigenvalues of $h$ are then $1, j, j, j$ and so $h$ is indeed the unique element of $\Lambda^{-1}\left(\left\{g, g^{-1}\right\}\right)$ admitting this list of eigenvalues.

If $(a d, b c)=\left(j^{2}, j\right)$, then $d=j b=j c$ and $b^{2}=j$, which implies that $a=b=c=\eta j^{2}$ and $d=\eta$, for some $\eta \in\{ \pm 1\}$. By replacing $h$ by $-h$ if necessary, the eigenvalues of $h$ are then 1 , $j^{2}, j^{2}, j^{2}$ and so $h^{-1}$ is indeed the unique element of $\Lambda^{-1}\left(\left\{g, g^{-1}\right\}\right)$ admitting $1, j, j, j$ as list of eigenvalues.

Corollary 1.7. - Let $g \in \mathbf{S O}\left(\wedge^{2} V\right)$ having $j, j, j, j^{2}, j^{2}$ and $j^{2}$ as eigenvalues. Then $g$ and $g^{-1}$ are not conjugate in $\mathbf{S O}\left(\wedge^{2} V\right)$.

Proof. - Assume that we have found $w \in \mathbf{S O}\left(\wedge^{2} V\right)$ such that $w g w^{-1}=g^{-1}$. Let $\omega$ and $\gamma$ be respective preimages of $w$ and $g$ in $\mathbf{S L}(V)$. Then $\Lambda\left(\omega \gamma \omega^{-1}\right)=g^{-1}=\Lambda\left(\gamma^{-1}\right)$. This shows that $\gamma^{-1}$ is conjugate to $\gamma$ or to $-\gamma$, which is impossible by examining the possible lists of eigenvalues of $\gamma$ obtained in the proof of Lemma 1.6.

## 2. Construction of $G_{32}$

Let us see $E_{6}$ as a finite subgroup of $\mathbf{O}\left(\wedge^{2} V\right)$ generated by reflections. Set

$$
\mathbf{j S O}\left(\wedge^{2} V\right)=\left\langle\mathbf{S O}\left(\wedge^{2} V\right), j \operatorname{Id}_{\wedge^{2} V}\right\rangle
$$

and

$$
\sqrt[3]{\mathbf{S L}}(V)=\left\{g \in \mathbf{G} \mathbf{L}(V) \mid \operatorname{det}(g)^{3}=1\right\}=\left\langle\mathbf{S L}(V), j \operatorname{Id}_{V}\right\rangle
$$

Then

$$
\begin{equation*}
\Lambda^{-1}\left(\mathbf{j S O}\left(\wedge^{2} V\right)\right)=\sqrt[3]{\mathbf{S L}}(V) \tag{2.1}
\end{equation*}
$$

We then define

$$
W=\Lambda^{-1}\left(\left\langle\mathrm{D}\left(E_{6}\right), j \operatorname{Id}_{\wedge^{2} V}\right\rangle\right)
$$

It is a subgroup of $\sqrt[3]{\mathbf{S L}}(V)$. The aim of this note is to show that $W$ is isomorphic to the complex reflection group $G_{32}$ of Shephard-Todd. Note first that

$$
\begin{equation*}
\boldsymbol{\mu}_{6} \subset W \tag{2.2}
\end{equation*}
$$

2.A. Reflections in $\boldsymbol{W}$. - The list of degrees $E_{6}$ is $2,5,6,8,9,12$ while its list of codegrees is $0,3,4,6,7,10$ (see [Bro, Table A.3]). In particular, exactly 3 of the degrees are divisible by 3 , which shows [Spr, Theo. 3.4] that $E_{6}$ contains an element $w_{3}$ admitting the eigenvalue $j$ with multiplicity 3 . We will denote by $C_{3}$ the conjugacy class of $w_{3}$ in $W$. Since also exactly 3 of the codegrees are divisible by 3 , this implies, for instance by [LeMi, Theo. 1.2], that $w_{3}$ is regular in the sense of Springer [Spr, §4] (that is, admits an eigenvector for the eigenvalue $j$ whose stabilizer in $E_{6}$ is trivial). Since $E_{6}$ is a rational group, $w_{3}$ also admits $j^{2}$ as an eigenvalue with multiplicity 3 . Hence, the eigenvalues of $w_{3}$ are $j, j, j, j^{2}, j^{2}$ and $j^{2}$. In particular, $\operatorname{det} w_{3}=1$ and so

$$
w_{3} \in \mathrm{D}\left(E_{6}\right)=E_{6} \cap \mathbf{S O}\left(\wedge^{2} V\right)
$$

By [Spr, Theo. 4.2(iii)], the centralizer of $w_{3}$ in $E_{6}$ has order $6 \cdot 9 \cdot 12$, which shows that

$$
\begin{equation*}
\left|C_{3}\right|=2 \cdot 5 \cdot 8=80 \tag{2.3}
\end{equation*}
$$

Moreover [Spr, Theo. 4.2(iii)], if $w \in E_{6}$, then

$$
\begin{equation*}
w \in C_{3} \text { if and only if } \operatorname{dim} \operatorname{Ker}\left(w-j \operatorname{Id}_{V}\right)=3 . \tag{2.4}
\end{equation*}
$$

Hence, if $w \in C_{3}$, then $w^{-1} \in C_{3}$ but $w^{-1}$ is not conjugate to $w$ in $\mathrm{D}\left(E_{6}\right)$ (by Corollary 1.7).

Now, let $\operatorname{Ref}(W)$ denote the set of reflections of $W$. If $s \in \operatorname{Ref}(W)$, the eigenvalues $\Lambda(s)$ are $1,1,1, \operatorname{det}(s), \operatorname{det}(s), \operatorname{det}(s)$. Since $\operatorname{det}(s) \in\left\{j, j^{2}\right\}$, the eigenvalues of $\operatorname{det}(s) \Lambda(s)$ are then $j, j, j, j^{2}, j^{2}, j^{2}$. It follows from (2.4) that $\operatorname{det}(s) \Lambda(s) \in C_{3}$. This defines a map

$$
\begin{array}{ccc}
\lambda: \quad \operatorname{Ref}(W) & \longrightarrow & C_{3} \\
s & \longmapsto & \operatorname{det}(s) \Lambda(s)
\end{array}
$$

The next result will be very useful:
Lemma 2.5. - The map $\lambda$ is bijective.

Proof. - First, if $\lambda(s)=\lambda\left(s^{\prime}\right)$, then there exists $\xi \in \mathbb{C}^{\times}$such that $s^{\prime}=\xi s$. Since $s$ and $s^{\prime}$ are reflections, this is possible only if $\xi=1$, and so $s=s^{\prime}$. This shows that $\lambda$ is injective.

Let us now show the surjectivity. Let $w \in C_{3}$. By Corollary 1.7, there exists a unique $\tilde{w} \in \Lambda^{-1}\left(\left\{w, w^{-1}\right\}\right)$ admitting $1, j, j, j$ as eigenvalues. Then $j^{2} \tilde{w}$ and $j \tilde{w}^{-1}$ are reflections satisfying

$$
\lambda\left(j^{2} \tilde{w}\right)=\operatorname{det}\left(j^{2} \tilde{w}\right) \Lambda\left(j^{2} \tilde{w}\right)=j^{8} \cdot j^{4} \Lambda(\tilde{w})=\Lambda(\tilde{w})
$$

and

$$
\lambda\left(j \tilde{w}^{-1}\right)=\operatorname{det}\left(j \tilde{w}^{-1}\right) \Lambda\left(j \tilde{w}^{-1}\right)=j^{4} \cdot j^{2} \Lambda\left(\tilde{w}^{-1}\right)=\Lambda(\tilde{w})^{-1} .
$$

So $w \in\left\{\lambda\left(j^{2} \tilde{w}\right), \lambda\left(j \tilde{w}^{-1}\right)\right\}$, which shows that $\lambda$ is surjective.

We then deduce from (2.3) and Lemma 2.5 that

$$
\begin{equation*}
|\operatorname{Ref}(W)|=80 . \tag{2.6}
\end{equation*}
$$

2.B. Structure of $W$. - Our main result is Theorem 2.7 below: the proof we propose here uses neither known properties of the group $G_{32}$ nor the classification of complex reflection groups and so might be viewed as an alternative construction of $G_{32}$ starting from $E_{6}$ (however, note that we use properties of $E_{6}$ ).

Theorem 2.7. - The group $W$ :
(a) has order 155520 ;
(b) is generated by reflections of order 3;
(c) is irreducible and primitive;
(d) admits 12, 18, 24, 30 as list of degrees.

Proof. - Set $E_{6}^{\#}=\left\langle\mathrm{D}\left(E_{6}\right), j \operatorname{Id}_{\wedge^{2} V}\right\rangle$ and $W^{+}=W \cap \mathbf{S L}(V)$. Recall that $\left|E_{6}\right|=51840$. So
(2.8) $\left|\mathrm{D}\left(E_{6}\right)\right|=25920, \quad\left|E_{6}^{\#}\right|=77760, \quad|W|=155520 \quad$ and $\quad\left|W^{+}\right|=51840$.

This shows (a). Moreover,

$$
\begin{equation*}
\mathrm{Z}(W)=\boldsymbol{\mu}_{6} \quad \text { and } \quad W / \boldsymbol{\mu}_{6} \simeq \mathrm{D}\left(E_{6}\right) . \tag{2.9}
\end{equation*}
$$

Let $\mathscr{R}=\left\{\operatorname{det}(s)^{-1} s \mid s \in \operatorname{Ref}(W)\right\}$. Set

$$
G=\langle\operatorname{Ref}(W)\rangle \quad \text { and } \quad H=\langle\mathscr{R}\rangle .
$$

The statement (b) is equivalent to the following one

$$
W=G .
$$

First, $\Lambda(\mathscr{R})=C_{3}$ and so $\Lambda(H)=\mathrm{D}\left(E_{6}\right)$ (as this last group is simple and $C_{3}$ is a conjugacy class). In particular, $W=H \cdot \boldsymbol{\mu}_{6}$ and so, since $H \subset G \cdot \boldsymbol{\mu}_{3}$, we obtain

$$
W=G \cdot \boldsymbol{\mu}_{6}
$$

which is almost the expected result (\#). Before showing (\#), note that, since $\Lambda(H)=\mathrm{D}\left(E_{6}\right)$, we have that $H$ (and so $G$ ) acts irreducibly on $V$. Moreover, if $G$ is not primitive, then $G$ (and so $H$ ) would be monomial [LeTa, Lem. 2.12], which would imply that $\Lambda(H)=\mathrm{D}\left(E_{6}\right)$ is monomial, which is false. So

## (\%) $G$ is irreducible and primitive.

Statement (c) follows.
Let us conclude this proof by showing simultaneously (b) et (d). Let $d_{1}, d_{2}, d_{3}, d_{4}$ be the degrees of $G$. It follows from (2.6) and for instance from [Bro, Theo. 4.1] that

$$
\left\{\begin{array}{l}
d_{1} d_{2} d_{3} d_{4}=|G| \\
d_{1}+d_{2}+d_{3}+d_{4}=84
\end{array}\right.
$$

The morphism det : $G \rightarrow \boldsymbol{\mu}_{3}$ is surjective (since $\operatorname{det}(s) \in\left\{j, j^{2}\right\}$ for any $s \in \operatorname{Ref}(W)$ ), and this implies that $\boldsymbol{\mu}_{3} \subset G$ (because $G /\left(G \cap \boldsymbol{\mu}_{6}\right) \simeq \mathrm{D}\left(E_{6}\right)$ is simple). It remains to show that $|G| \neq|W| / 2=77760$.

So assume that $|G|=77760$. Since $\boldsymbol{\mu}_{3} \subset G$, all the $d_{i}$ 's are divisible by 3 and, since $\boldsymbol{\mu}_{6} \not \subset G$, at least one of them $\left(\right.$ say $\left.d_{4}\right)$ is not divisible by 6 . Write $e_{i}=d_{i} / 3$. Then

$$
\left\{\begin{array}{l}
e_{1} e_{2} e_{3} e_{4}=960=2^{6} \cdot 3 \cdot 5 \\
e_{1}+e_{2}+e_{3}+e_{4}=28 \\
e_{4} \text { is odd }
\end{array}\right.
$$

From the second equality, we deduce that at least one of the $e_{i}$ 's (say $e_{3}$ ) is odd. From the first equality, we deduce that at least one of the $e_{i}{ }^{\prime} s\left(\right.$ say $e_{2}$ ) is even and so $e_{1}$ is also even. The first equality shows that $e_{1}$ or $e_{2}$ (say $e_{2}$ ) is divisible by 8 . So $e_{2} \in\{8,16,24\}$. A quick inspection of the possibilities shows that $e_{1}=4, e_{2}=16$ and $\left\{e_{3}, e_{4}\right\}=\{3,5\}$. The degrees of $G$ are then $9,12,15$ and 48 . Since 16 divides one of the degrees, it then follows from [Spr, théo. 3.4(i)] that $G=H \times \boldsymbol{\mu}_{3}$ contains an element of order 16 and so $H$ contains an element of order 16. Therefore, $\mathrm{D}\left(E_{6}\right)=\Lambda(H)$ contains an element of order 8 , which is impossible (see Remark 2.11 below for a proof of this fact based only on Springer theory). This contradicts the fact that $|G|=77760$. So we have shown (\#), that is,

$$
W=\langle\operatorname{Ref}(W)\rangle=G
$$

This is statement (b). In particular, $\mu_{6} \subset W$ and so all the $d_{i}$ 's are divisibles by 6 . Set $a_{i}=d_{i} / 6$. Then $(\diamond)$ implies that

$$
\left\{\begin{array}{l}
a_{1} a_{2} a_{3} a_{4}=120=2^{3} \cdot 3 \cdot 5 \\
a_{1}+a_{2}+a_{3}+a_{4}=14
\end{array}\right.
$$

By the same argument as before, since $\mu_{12} \not \subset W$, we may assume that $a_{3}$ and $a_{4}$ are odd and that $a_{1}$ and $a_{2}$ are even. A quick inspection of the possibilities shows that $\left\{a_{1}, a_{2}\right\}=\{2,4\}$ and $\left\{e_{3}, e_{4}\right\}=\{3,5\}$. This concludes the proof of (d).

Corollary 2.10. - The group $W$ is isomorphic to the reflection group $G_{32}$ of Shephard-Todd.

Proof. - This follows from Theorem 2.7 and from the classification of complex reflection groups [ShTo].

Hence, Corollary 2.10 gives an explanation for the fact, mentioned in the introduction, that $\mathrm{D}\left(G_{32}\right) / \boldsymbol{\mu}_{2} \simeq \mathrm{D}\left(E_{6}\right)$ : the isomorphism is realized by $\Lambda$.

Remarque 2.11. - In the proof of Theorem 2.7, we have used the fact that $\mathrm{D}\left(E_{6}\right)$ does not contain any element of order 8 . This fact can be easily obtained by a computer calculation for instance, but we propose here a proof using only Springer theory. Let $w \in E_{6}$ be an element of order 8 . Then $w$ necessarily admits an eigenvalue which is a primitive 8 -th root of unity $\zeta$. As only one of the degrees of $E_{6}$ and only one of the codegrees of $E_{6}$ is divisible by 8 , this implies that $w$ is a regular element in the sense of Springer [LeMi, Theo. 1.2]. Then [Spr, Theo. 4.2(v)] the list of eigenvalues of $w$ is $\zeta^{-1}, \zeta^{-4}, \zeta^{-5}, \zeta^{-7}, \zeta^{-8}, \zeta^{-11}$, and so $\operatorname{det}(w)=\zeta^{-36}=-1$. So $w \notin \mathrm{D}\left(E_{6}\right)$.
