





IDENTITY SEARCH : IMPORTANT THEME IN THE DUTY OF REMEMBRANCE

CORPSES WITH PARTICULAR STATUS : NEITHER ARCHAEOLOGICAL NOR FORENSIC BUT SPECIFIC TO THE MINISTRY OF THE **ARMED FORCES**

SINCE 1915, SOLDIERS WHO DIED ON THE FIELDS ARE MENTIONED AS « DEATH FOR FRANCE »

IT ALLOWS THEIR BODIES TO REST IN NATIONAL CEMETERY (NÉCROPOLE NATIONALE, PERPETUAL), OR FAMILY'S GRAVE
