24	Abstract

25	Population characteristics of <i>Holothuria leucospilota</i> were evaluated by sampling at nine sites
26	in the northern Oman Sea (Iran) from March 2017 to March 2018. Mean of growth and
27	mortality indices were calculated including infinite length ($L\infty = 50.5$ cm), growth coefficient
28	$(K = 0.51 \text{ (yr}^{-1}))$, growth performance index ($\Phi = 3.11$), natural mortality ($M = 0.94 \text{ yr}^{-1}$),
29	fishing mortality ($F = 0.56 \text{ yr}^{-1}$), total mortality ($Z = 1.50 \pm 0.12 \text{ yr}^{-1}$) and exploitation
30	coefficient ($E = 0.36 \text{ yr}^{-1}$). Mean of relative production and relative biomass per recruitment,
31	and exploitation rate of this species were Y'/ $R_p = 0.02$, B'/ $R_p = 0.30$ and $U = 0.28$,
32	respectively. Mean gonado-somatic index indicated that spawning time occurred during June
33	and December. The mean size at first sexual maturity (LM_{50}) was 246 mm for males, 220 mm
34	for females and 225 mm for both sexes. The lifespan was estimated at 6 years. The present
35	study has demonstrated that the white threads fish stock in the northern Oman Sea has not
36	reached yet the 'overfished' status but as illegal fishing occurs within the studied area, this
37	does not exclude a specific management or restriction of the fishing of this species for its
38	conservation.

1. Introduction

Sea cucumbers conservation and management are necessary because these marine benthic 53 54 species have an important ecological role in the marine ecosystems such as the recycling of nutrients (Shiell & Knott, 2010) but in the meantime are a significant source of income for 55 56 many coastal communities worldwide (Purcell, 2010). From both an ecological and socioeconomic perspectives, the long-term sustainability of sea cucumber fisheries is of great 57 importance to coastal communities. The current status of sea cucumber stocks in numerous 58 59 countries has poor fishery management due to prevalent exploitation and ever-increasing market demand. However, there is an international effort on aquaculture in different countries 60 61 to minimize the depletion of natural population. The unique life-history traits of holothurians 62 (e.g. low or infrequent recruitment and density-dependent reproductive success) also make 63 these species especially vulnerable to overfishing (Purcell, 2010). Population dynamics are driven by changes in abundance or biomass of a population through time by a series of life-64 65 history traits such as fecundity, successful recruitment, growth rates and mortality rates. Estimation of population dynamics can provide greater insight into a harvested marine 66 67 population species. It can indicate how a population arrives at its current state and how it may change in the future (Brown & Guy, 2007). Recruitment, growth, and mortality rates are the 68 69 primary population dynamics parameters that explain the harvestable part of a fish population 70 (Brown & Guy, 2007).

71 Holothuria leucospilota (Brandt, 1835) belongs to the phylum of Echinodermata and is fished 72 commercially. Sea cucumbers belong to the class Holothuroidea and are referred to as holothurians ('bêche-de-mer', 'trepang' or 'hai-som'). The dominant species harvested 73 74 commercially belong to the order Aspidochirotida, with the two families Holothuriidae and Stichopodidae that are dominantly found in tropical zones (Purcell, Samyn & Conand, 2012). 75 H. leucospilota lives in shallow habitats up to 10 m depth, mostly on outer and inner reef flats, 76 back reefs, seagrass beds, microatoll detrital fringe, shallow coastal lagoons but with higher 77 78 densities on the inner reef slopes. This species is very common, with its distribution extending 79 into warm-temperate zones. It is a deposit-feeder and therefore has an important ecological 80 role (Purcell, Samyn & Conand, 2012).

The Oman Sea is a region of the northern Indian Ocean that connects the Arabian Sea with the Strait of Hormuz, which then runs to the Persian Gulf. It borders Iran and Pakistan on the north, Oman on the south, and the United Arab Emirates on the west (Taghavimotlagh & Shojaei, 2017). The Oman Sea, with its unique ecological conditions, hosts a wide variety of marine species that provide livelihood, employment and vast economic activities for the

settlers. Iran has more than 120,000 fishermen. Therefore fishing has played a major role in 86 creating employment in coastal areas, as well as in economic activities for post-harvested 87 operations (Taghavimotlagh & Shojaei, 2017). A numerous studies on biological and 88 ecological characteristics (reproduction, growth, population dynamics, fishing pressure, etc.) 89 90 of several harvested sea cucumber species were carried out in different parts of the world (Herrero-Perezrul et al., 1999; Skewes et al., 2002; Uthicke, Welch & Benzie, 2004; Conand, 91 92 2008; Choo, 2008; Purcell, Gossuin & Agudo, 2009; Dissanayake & Stefansson, 2010; Chávez, De Lourdes-Salgado & Palleiro, 2011; De Jesús-Navarrete, Poot & Medina-Quej, 93

94 2018).

95 Recently, the illegal fishing of *H. leucospilota* in the northern waters of the Oman Sea has increased significantly. It is not used for local consumption in the region but it is caught for 96 97 exportation. There is currently no specific management or restriction for this species in this area. Despite the ecological and economical importance of this species, little is known about 98 99 the stock of *H. leucospilota* population. This study investigates several life-history traits and stock assessment measures of *H. leucospilota* from Oman Sea in order to provide fundamental 100 101 information for identifying and managing properly this species. First, structure of population, lifespan, spawning period, gonado-somatic index, size at first maturity and growth rate of H. 102 103 leucospilota from the Oman Sea will be presented. Then, a series of fisheries assessment data will be estimated such as biomass, recruitment and mortality in order to evaluate the 104 105 sustainability of the *H. leucospilota* population in the Oman Sea.

107 **2. Methods**

108 **2.1 Sample sites and specimen collection**

Based on the location in the northern Oman sea (Iran), nine sites were selected for sampling *Holothuria leucospilota* in the ports of Ramin (60° 45′E, 25° 15′N), Kachoo (60° 55′E, 25°
16′N), Aliabady (61° 05′E, 25° 10′N), Beris (61° 10′E, 25° 82′N), Beris plane (61° 15′E, 25°
72′N), Pasabandar (61° 25′E, 25° 70′N) Tis (60° 35′E, 25° 24′N), Pozm (60° 16′E, 25° 23′N)
and Gurdim (59° 61′E, 25° 22′N) (Fig. 1). Samplings were carried out monthly in the nine
sites from March 2017 to March 2018. Sea cucumbers were collected with the help of divers

in subtidal areas (sandy and Pebbles shore) at depths of less than 10 meters. Additionally, in

the fishing area, organisms were captured using a linear transect 50 meters long and 2 meters

- 117 wide, using scuba diving. A total of 802 specimens of *H. leucospilota* species were collected.
- 118 The weight and length of all specimens were measured. The collected organisms were placed
- 119 in a potassium chloride solution (10%) for half an hour prior to biometric measurements.
- 120

121 **2.2 Biometry**

122 Biometric measurements (length and weight) were performed on anesthetized sea cucumbers.

- 123 Total length (TL) was determined by a biometric ruler with 1 mm precision (Fig. 2) and wet
- 124 weight with a scale to the nearest 1 gr.
- 125 The Equation (1) was used to calculate the relationship between the total length and wet
- 126 weight, with, Wi the sea cucumber weight (g), Li, the sea cucumber length (mm), a, a constant
- 127 coefficient, and *b*, an equation power

- 130 The Equation (2) was used to decipher significant differences between the calculated b from
- 131 Equation (1) and b = 3 for a sea cucumber of similar growth with *s.dx*, the logarithm of the
- 132 standard deviation of total length to the standard deviation of total weight (*s.dy*), *b* (the slope),
- 133 r^2 (coefficient of determination) and *n* (sample sizes) (Zar, 1996).

136 2.3 Life-history traits and population dynamic parameters of Holothuria leucospilota

137 2.3.1 Structure of population and growth rates

138 All biometric measurements from the nine different stations were pooled monthly, and

139 subsequently grouped into classes of three centimetres interval. Two methods were used to

- 140 analyse the data for growth rates (Method 1: Shepherd method and Method 2: ELEFAN
- 141 (Electronic Length Frequency Analysis) method).
- 142 Method 1: the data were analysed using FiSAT II (FAO-ICLARM Stock Assessment Tools,
- 143 www.fao.org/fi) using the Shepherd method (Gayanilo, Pauly & Parre, 2003).

144 Method 2: the estimation of the infinite length $(L\infty)$ was obtained using Equation (3) and the 145 Maximum length of the sea cucumber (*Lmax*) (Froese & Binohlan, 2000).

- 147 Growth rate was obtained by applying the ELEFAN method (optimization model), by using
- 148 the RStudio software with the TropFishR package (Mildenberger, Taylor & Wolff, 2017).
- 149 The optimum value of t_0 (time that length is zero) was calculated by the experimental formula
- 150 of Pauly equation (Equation (4)) with *K*, the growth factor (Froese & Binohlan, 2000).

- 152 Comparisons of growth indices such as the infinite length $(L\infty)$ and the growth factor (K)
- 153 were performed using the Equation (5).

The maximum lifespan of this species was based on the following formula (Froese & Pauly,
2017; and Equation (6)).

- 159 2.3.2 Mortality
- 160 Natural mortality (*M*) was calculated based on the Pauly Equation (7) (Sparre & Venema,
- 161 1998) with, *M* the annual natural mortality coefficient, $L\infty$ the infinite length of the sea
- 162 cucumber (cm), K the growth curve parameter of the von Bertalanffy growth equation and T
- 163 (Celsius) is the mean environmental temperature (Sparre & Venema, 1998). The mean annual
- temperature of the sea surface of north Oman Sea was estimated at 26 °C (Keymaram et al.,
 2009).

167 Total mortality (Z) was calculated based on the length-converted catch curves data. The 168 fishing mortality was estimated using the Equation (8), with Z, the total mortality, F, the 169 fishing mortality and M the natural mortality.

171 The exploitation rate (*E*), which is the ratio of fishing mortality to total mortality, was

172 calculated with the Equation (9) from Sparre & Venema (1998).

175 2.3.3 Recruitment and biomass

The relative yield per recruitment (*Y/R*) was estimated against the fishing mortality coefficient or exploitation rate. In this Equation (10), *E*, is the exploitation coefficient, *U*, the exploitation rate, *M*, the natural mortality coefficient, *F*, the fishing mortality coefficient and L_c (Length at first capture) is the same as L_{c50} (Gayanilo, Pauly & Parre, 2003).

- In addition, the relative biomass per recruitment (B'/R) was calculated using the followingEquation (11).

- 186 2.3.4 The gonado-somatic index (GSI)
- 187 The maturity stages for male and female *Holothuria leucospilota* were determined

188 macroscopically using a 5-stage maturity key (Gaudron, Kohler & Conand, 2008). These

189 stages included: 'resting stage' (I), 'immature stage' (II), 'growing stage' (III), 'maturation

190 stage' (IV), 'post-spawning stage' (V). The gonado-somatic index (GSI) is expressing the

191 mean gonad weight as a proportion of a total body weight and was calculated using the

- 192 Equation (12), where GW, is the gonad weight and EW, is eviscerated body weight (Gaudron,
- 193 Kohler & Conand, 2008).

195 Monthly data of sea temperature (in °C) were recorded in different stations (by multi-

196 parameter device, Hach ltd.) and used as a predicted environmental factor of the seasonal GSI.

197

198 2.3.5 Mean size at first sexual maturity (LM_{50})

The mean size at first sexual maturity (LM_{50}) was estimated for females by fitting the logistic function to the proportion of mature sea cucumbers in 4-cm (TL) size categories (Equation 13) in which *Y* is the proportion of the number of all mature males and females to all immature males and females in the same length class, *X* is the total length in cm and *a* and *b* are correlation constants (King, 2007). The mean size at first maturity was taken when 50% of individuals were mature.

207 2.4 Statistical analyses

208 Comparison of population dynamic values with two methods (Method 1: Shepherd method

and Method 2: ELEFAN method) and between male and female lengths, and weights were

210 tested by Student Test (*t*-test) with paired *t*-test and independent *t*- test, respectively.

211 Correlation between temperature and GSI was tested by a Pearson correlation test. A Chi-

square test was used to assess sex ratio differences between males and females. Normality of

this data was assessed by using the Kolmogorov-Smirnov test. Data analyses were performed

using, FiSAT II and R Studio softwares (1.1.46) with the TropFishR package.

216 **3. Results**

217 **3.1 Length frequency distribution of** *Holothuria leucospilota*

218 The mean \pm (min – max) deviation of total length and total weight for male (624 specimens)

and female (178 specimens) white threads fish were $31 \pm 6 (18 - 45)$ cm, $31 \pm 5 (19 - 43)$ cm

220 respectively, and, $770 \pm 164 (370 - 1220)$ g, $762 \pm 155 (375 - 1125)$ g respectively. The

differences between total length and total weight in both sexes were not significant (p > 0.05;

222 Student test). The length (TL) data were categorised into 3-cm groups which the highest

frequency (195 sea cucumbers) was belonging to individuals with 27 to 30 cm length (Fig.

224 3A).

225

226 **3.2 Length-weight relationship of** *Holothuria leucospilota*

- 227 The relationship between length and weight for *H. leucospilota* was calculated following the
- Equation (1) and gave a = 25.76 and b = 0.97 ($\mathbb{R}^2 = 0.61$) for females, and for males, a =
- 229 30.79 and b = 0.92 (R² = 0.93) and for both sexes a = 24.93 and b = 0.98 (R² = 0.59). The
- 230 Student test has shown significant differences between estimated b and b = 3 at the level of
- 231 0.05 (Fig. 3B), which means an allometric growth pattern (for both sexes) of *H. leucospilota*
- in the northern waters of the Oman Sea.
- 233

234 **3.3 Growth studies**

- The population dynamic parameters using the two methods (Shepherd and ELEFAN methods)
 for males, females and both sexes of *Holothuria leucospilota* are detailed in Table 1. There
- 237 were no significant differences between the results of the two methods used (p > 0.05; *t*-test).
- 238 Growth parameters for both sexes together were estimated at $L\infty = 50.5$ cm (with weight at
- 239 infinite: $W\infty = a^* (L\infty) \wedge b = 1.211 \text{ kg}$, $K = 0.51 (\text{yr}^{-1})$, and $t_0 = -0.27$. The growth curve (Fig.
- 240 4A) highlighted six cohorts and age groups and the growth performance index was estimated
- 241 at $\Phi = 3.11$. There was recruitment throughout the year and the highest rate of recruitment
- 242 was observed in winter and summer periods (Fig. 4B). Based on the results, the maximum
- 243 lifespan of this species was around 6 years (Fig. 5).

245 **3.4 Mortality estimate**

The natural mortality (*M*), fishing mortality (*F*) and total mortality (*Z*) were estimated at 0.94 (yr⁻¹), 0.56 (yr⁻¹), and 1.5 (yr⁻¹) respectively (Table 2). The exploitation coefficient (*E*) was estimated at 0.36 (yr⁻¹) (Fig. 6). Based on the calculated parameters, the von Bertalanffy equations for this species (length and weight) in the Northern Oman Sea (Iran) were as follow:

- 254 **3.5 Yield and Biomass per Recruit**

- Based on length at first capture ($L_c = 27$ cm), which is 50% the probability of catching sea
- 256 cucumber, relative production per recruitment and relative biomass per recruitment were
- estimated at Y'/Rp = 0.02 and B'/Rp = 0.3, respectively. Overall, the result demonstrated an
- 258 exploitation rate (U) of 0.28 and a fishing mortality at maximum sustainable yield (*Fmsy*)
- equalled to 0.6 for this sea cucumber stock (Fig. 6).
- 260

261 **3.6** Sex ratio, gonad-somatic index (GSI) and size at first sexual maturity (LM50)

- From all sea cucumber sampled, 639 were males (75%) and only 223 were females
- 263 (25%). The sex ratio was significantly biased towards males (1 female/ 3 males) ($Chi^2 =$
- 100.38, p < 0.05). The mean value of GSI for both sexes was 5.59 ± 1.75. The highest GSI

values were observed in June (21% \pm 6) and December (8% \pm 2) and the lowest GSI value

was observed in August ($1\% \pm 0.5$) (Fig. 7). Moreover, there was no significant correlation

between the GSI and the monthly temperature (Pearson correlation, p > 0.05). Mean GSI and

maturity stage indicated that spawning time was during June and December. The mean size at first sexual maturity (LM_{50}) was 246 mm for males, 220 mm for females and 225 mm for both sexes (Fig. 8).

272 **4. Discussion**

A series of life-history traits and population dynamics values of the species *Holothuria leucospilota* was evaluated with success and this is the first time in the study area despite an economic and ecological importance. *H. leucospilota* is one of the economically valuable species in the southern and northern Oman Sea (Iran). The Echinoderm phylum (including sea cucumbers) plays a 'key role' in structuring marine ecosystems mainly in the organic matter processing. The over-fishing of these sea cucumbers is likely to disturb the sustainability of the targeted ecosystems (Uthicke, Schaffelke & Byrne, 2009).

281 **4.1 Life-history traits of** *Holothuria leucospilota*

The length-weight (L-W) relationship has shown allometric growth with females heavier than
males for the same length group. It seems, growth curve (length and weight) of *H*.

- 284 *leucospilota* slows down after two years and allometric growth is common in sea cucumbers
- 285 (Herrero-Perezrul et al., 1999; Al-Rashdi, Claereboudt & Al-Busaidi, 2007; Chávez, de
- Lourdes-Salgado & Palleiro, 2011; Dereli et al., 2016). The relationship between length and
- weight for *H. tubulosa* species was calculated as, $W = 7.66 L^{1.06} (R^2 = 0.52)$ (Dereli et al.,
- 288 2016), for *Parastichopus parvimensis* species $W = 0.4 L^{1.83}$ (Chávez, De Lourdes-Salgado &
- Palleiro, 2011), for *H. scabra* species $W = 0.0033 L^{2.17} (R^2 = 0.80)$ (Al-Rashdi, Claereboudt &
- Al-Busaidi, 2007), for *Isostichopus fuscus* species $W = 1.14 L^{1.83}$ (Herrero-Perezrul et al.,
- 1999). In this study for *H. leucospilota*, the relationship between L-W is $W = 24.93 L^{0.98}$.
- 292 The L-W relationship is of great importance in fishery assessments (Haimovic & Velasco,

2000). Interestingly, it is well known that the functional regression 'b' value gives insights on

the body form, and it is directly related to the weight affected by ecological factors such as

temperature, food supply, spawning conditions and also other factors, such as sex, age, fishing

- time, and area and fishing vessels (Ricker, 1973).
- 297 In the present study, *H. leucospilota* was shown to spawn twice a year with a major peak in June and a weaker peak in December. Spawning events were not correlated with an increase 298 299 or a decrease of temperature. Greater percentages of new recruits also support spawning events in winter and in summer periods. Spawning period of H. leucospilota was reported 300 301 from November to April in Australia (Franklin, 1980), from November to March in Cook Islands (Drumm & Loneragan, 2005), from June to September in Taiwan (Choo, 2008), in 302 303 February and in May in Indian Ocean (Conand, 2008), in February and in May in the Western Indian (Gaudron, Kohler & Conand, 2008), and, from June to October in Daya Bay in China 304 305 (Huang et al., 2018). The differences in spawning periods of any species are affected by environmental conditions. In tropical regions, almost shallow-water holothurians have an 306 307 annual of 2- to 3-months spawning period during the warmer months of the year. The holothurians have different reproductive patterns and need to be studied in each region (Chao, 308 309 Chen & Alexander, 1995). The sea cucumber reproduction cycle differs among species and 310 even within a species distributed in different regions (Huang et al., 2018).
- 311 The size at first sexual maturity (LM_{50}) for white threads fish was estimated at 246 mm for
- 312 males and 220 mm for females. Females seem to get mature earlier; therefore their growth
- 313 might be slower than that of males, as a result of a higher energy involved earlier into
- 314 reproduction instead of growth. Therefore, females *H. leucospilota* have a length at infinite
- $(L\infty)$ smaller than that of males. The LM_{50} of *H. sanctori* was 201 to 210 mm in the eastern
- Atlantic in Spain (cited in Conand, 1993). For *H*. atra, *LM*₅₀ was 165 mm for males and 155

317 mm for females in Egypt (Abdel_Razek et al., 2005). The size at first maturity is an important

- 318 parameter for managing a stock of a commercial species, as it helps to limit capture sizes
- 319 (Conand, 2008) and it is used as a tools for enhancing sustainable management in fisheries

320 (Kohler, Gaudron & Conand, 2009). This parameter is needed for fisheries management,

- 321 conservation of exploited sea cucumbers and small immature individuals' collection decreases
- 322 for sustainability of the population.
- 323

324 **4.2 Population dynamic of** *Holothuria leucospilota*

325 Comparison of the population parameters of *H. leucospilota* from the present study with those of other studies in different parts of the world (Table 2) has shown that infinite length and 326 327 growth coefficient of females from different species are generally smaller than those of males from respective species. Moreover, the infinite length and growth coefficient of different 328 329 species change from region to region (Table 2). Differences in the range of the infinite length and growth rate are influenced by the ecological differences of each region (King, 2007). The 330 331 growth rate (K) is expected to be higher in the tropical regions. Higher K values for species 332 are common in tropical waters. Holothurians are ectotherms and their metabolic rate increase with higher temperature until a threshold (Hashemi et al., 2015). In general, the difference in 333 334 the infinite length and growth rate from one region to another region might be due to the 335 quantity and quality of food and climatic conditions (Bartulovic et al., 2004). Various factors can also affect holothurians growth including age, sex, season, year, type of feeding 336 behaviour, physiological conditions, differences in food availability and reproductive period 337 (Lalèyè, 2006). Mean of growth performance index (Φ) was found to be equalled to 3.11 338 (Table 2). The comparison of Φ' values of growth curves is necessary to understand the 339 340 correlation between the infinite length and the growth rate. A growth curve has a growth rate 341 that holds constant changes at different times and for different sizes. Differences in ecological 342 conditions and latitude changes can affect the values of infinite length and growth rate (King, 343 2007).

344 The natural mortality rate of *H. Leucospilota* in this study was higher than that of fishing

- 345 mortality. The ratio of fishing mortality to maximum sustainable yield named as the
- exploitation coefficient (F/FMSY) was less than one. If this value is more than 1, it indicates
- 347 that there is over-fishing (Arrizabalaga, Murua & Majkowski, 2012). In this present study, the
- 348 exploitation coefficient was less than 0.5, indicating that the amount of capture from fisheries

349 was not more than the optimum level. Both exploitation coefficient and exploitation rate

- 350 should not be greater than 0.5 or, the fishing mortality should not exceed natural mortality
- 351 otherwise it indicates over-fishing (Sparre & Venema, 1998; King, 2007). The most important

352 factors affecting the pressure on stocks are, first, the amount of catch and harvesting of a

- 353 stock, and second, the environmental factors that affect survival and access to the fishery
- resources (Mateus & Estupinan, 2002).
- 355

4.3 Management and conservation of the species in the Oman Sea

357 It is recommended that appropriate instructions need to be established for the harvesting and management of Holothuria leucospilota species in the Oman Sea. Harvesting of the white 358 359 threads fish should not occur in winter and in summer during spawning periods. The size of capture should be greater than 250 mm as it is known that size at first maturity is an important 360 361 parameter for managing stock (Conand, 2008). This parameter is needed for fisheries management, conservation of exploited sea cucumbers and small immature individuals' 362 collection decreases for sustainability of population. The present study has demonstrated that 363 the stock of *H. leucospilota* has not yet reached an 'overfished' status. The results of the 364 present study could help in the management of the exploitation of H. leucospilota population 365 and its sustainability with the establishment of a harvesting period and a size limit capture. 366
