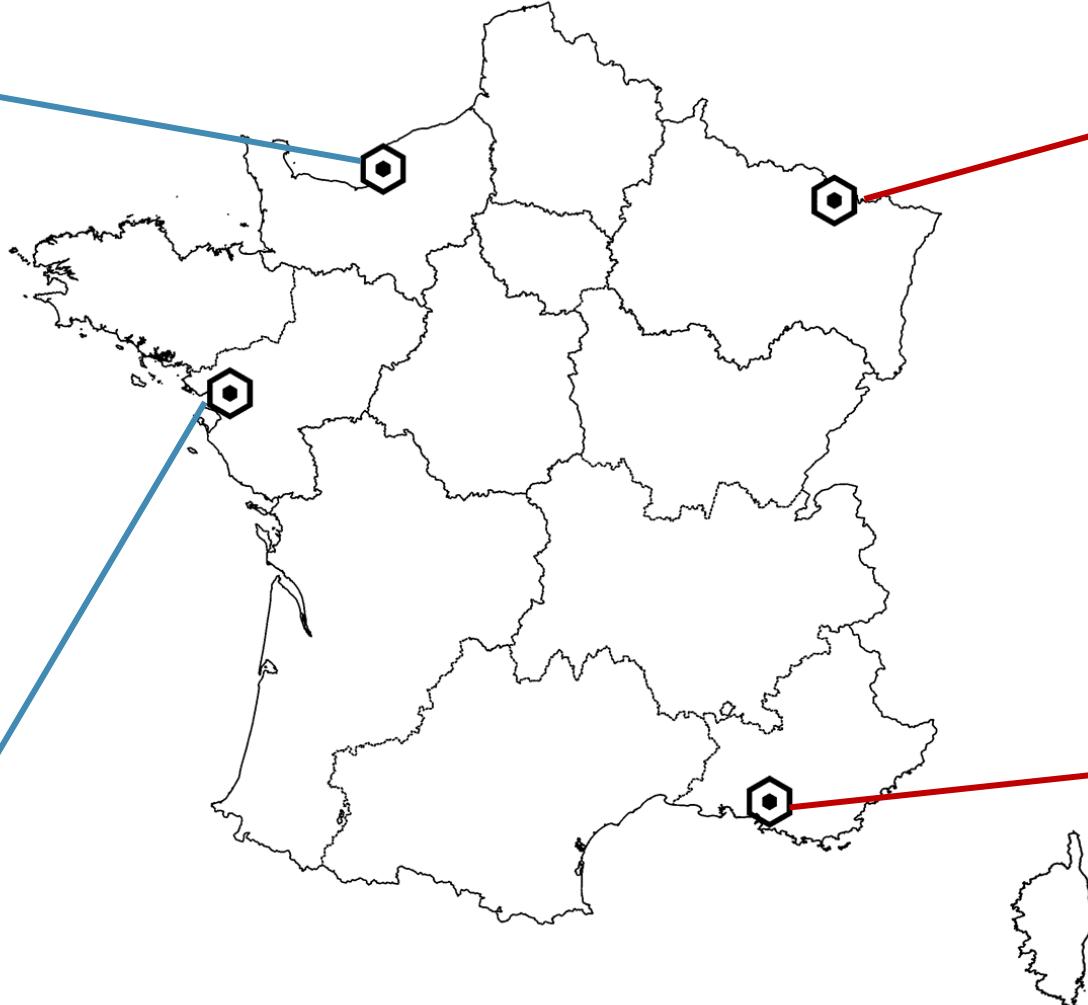

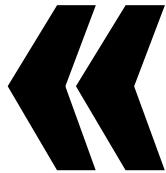

The impacts on the electricity grid of the political decision to shut down coal-fired power stations were insufficiently anticipated and have led to a disruption in the energy transition of these four territories towards a "post-carbon regime".

Two theoretical approaches

Timeframe of the energy transition

- Widely varying temporal dynamics (Fouquet, Pearson 2012)
- Non-linearity of transition processes (Labussière, Nadaï, 2020), which follow chaotic rythmes (Grubler, 2012)
- Currently, a transition wanted and coordinated by the public authorities (Sovacool, 2016): What does it entail ?

Pathways and branching points

- The result of a multitude of decisions (Foxon, 2010, 2013; Rosenbloom, 2017)
- The role of organisational structures (Durand et al., 2022; Lapostolle, 2021)
- “Branching points” as decisive moments in the construction of new trajectories (Foxon et al., 2013) through the realignment of stakeholders' visions (Fotopoulos et al., 2019)

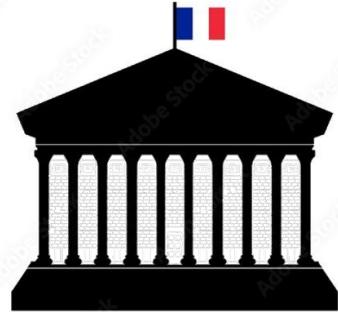

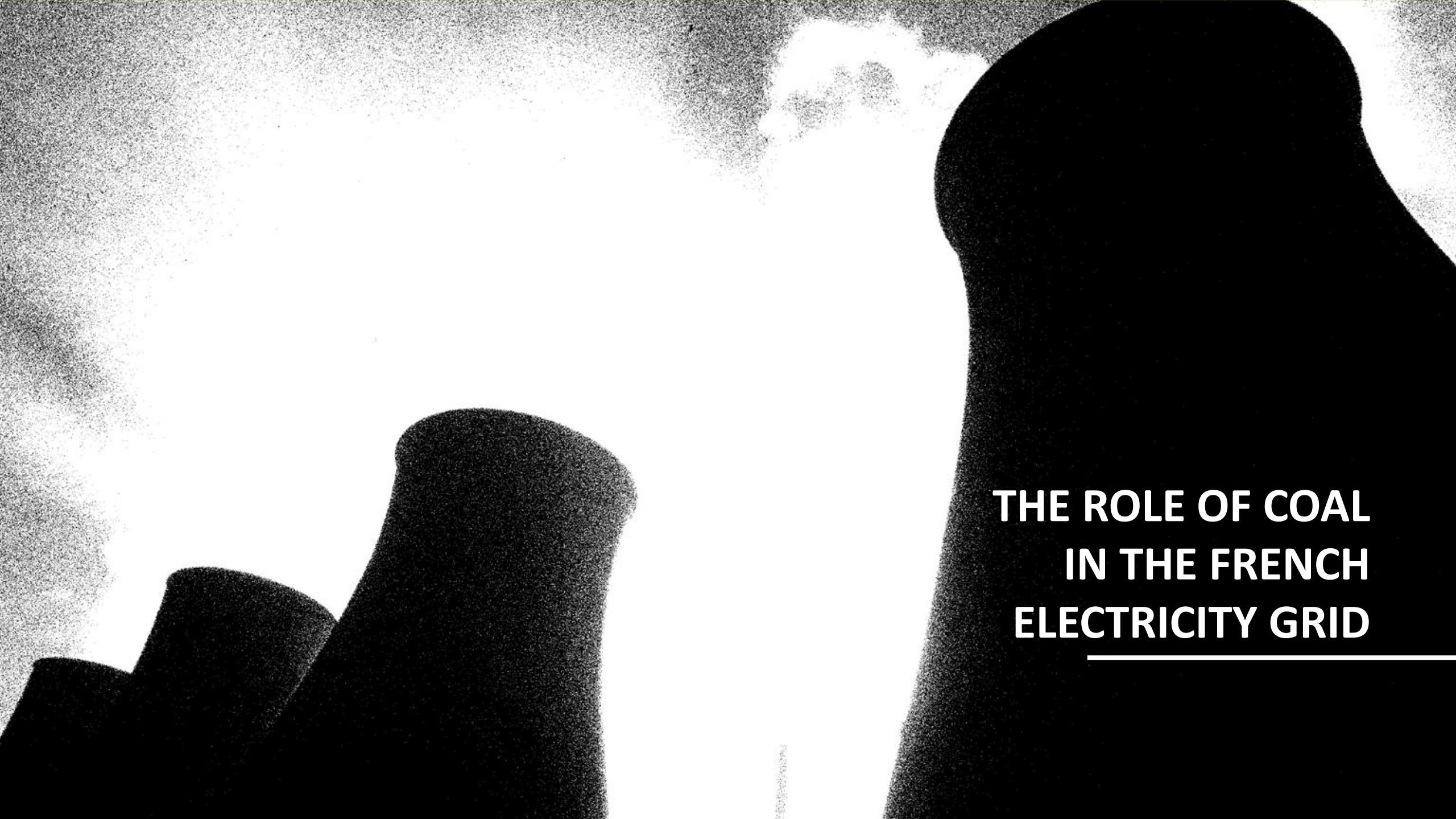

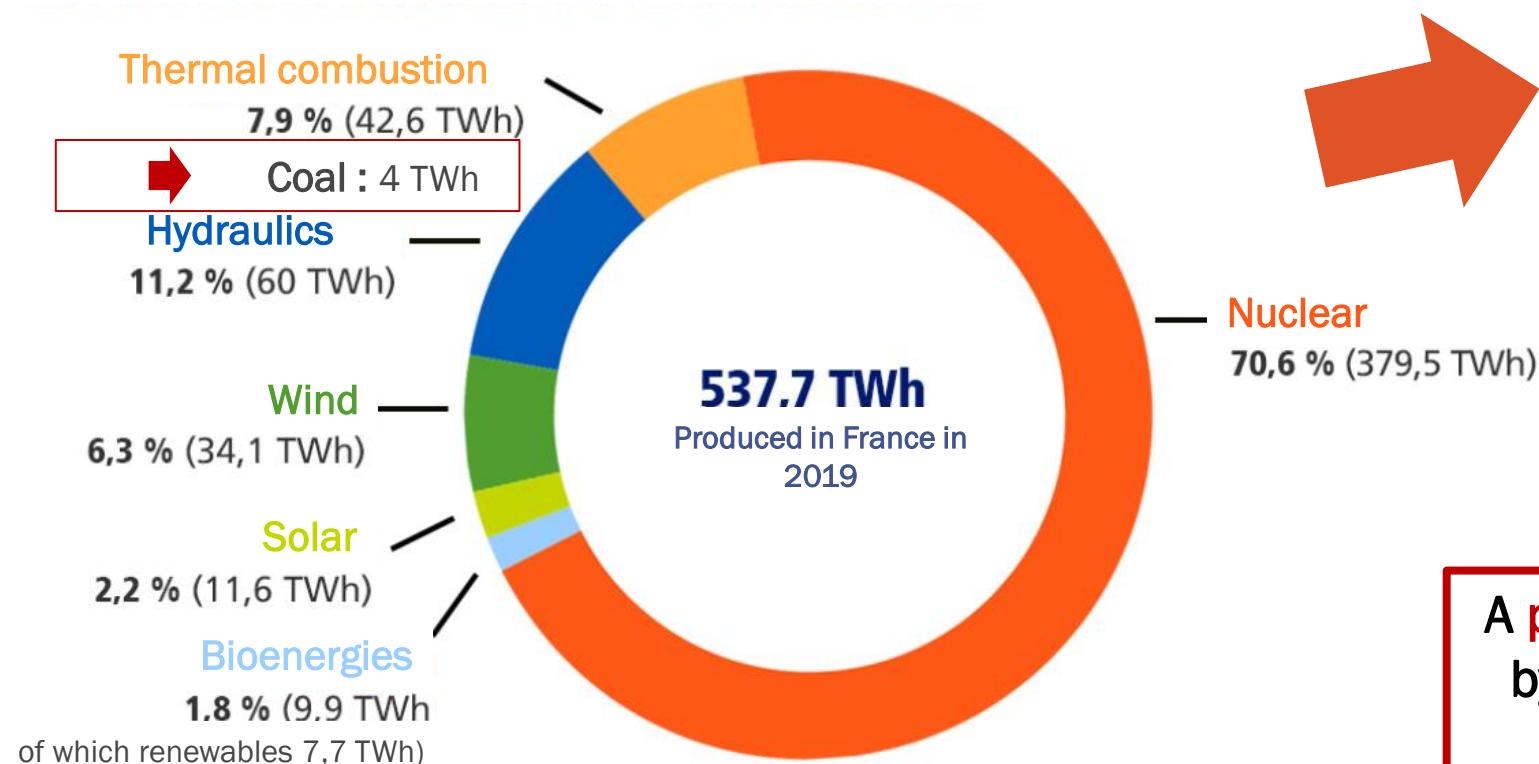

FRENCH ELECTRICITY GENERATION IN 2019



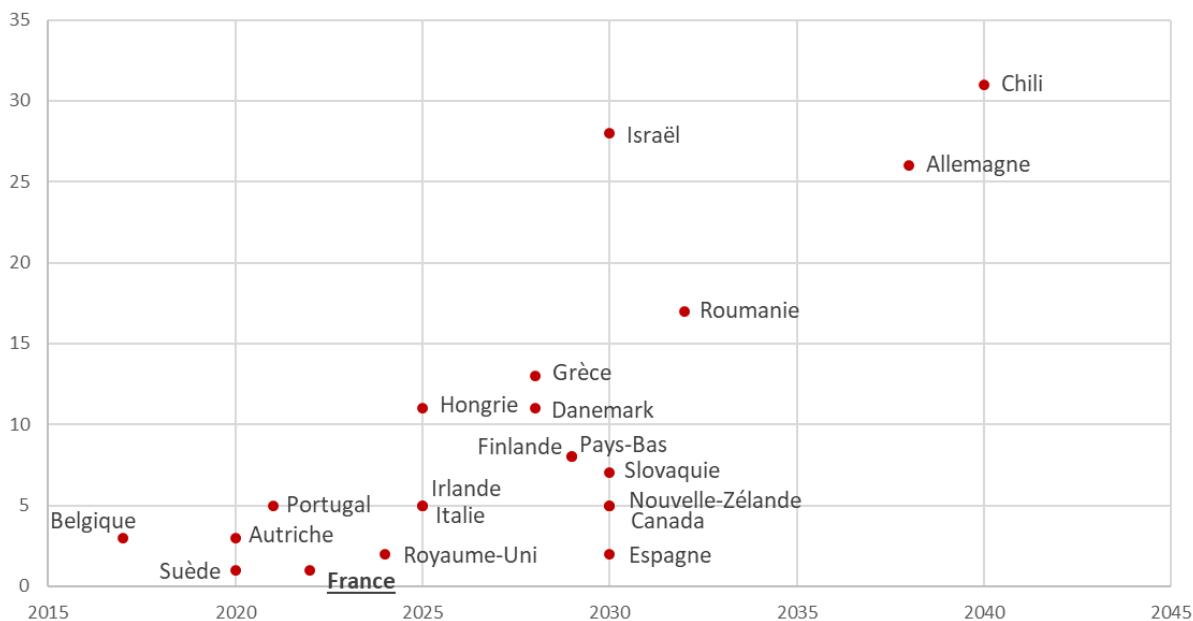
Breakdown of French electricity generation in 2019 by type of energy.

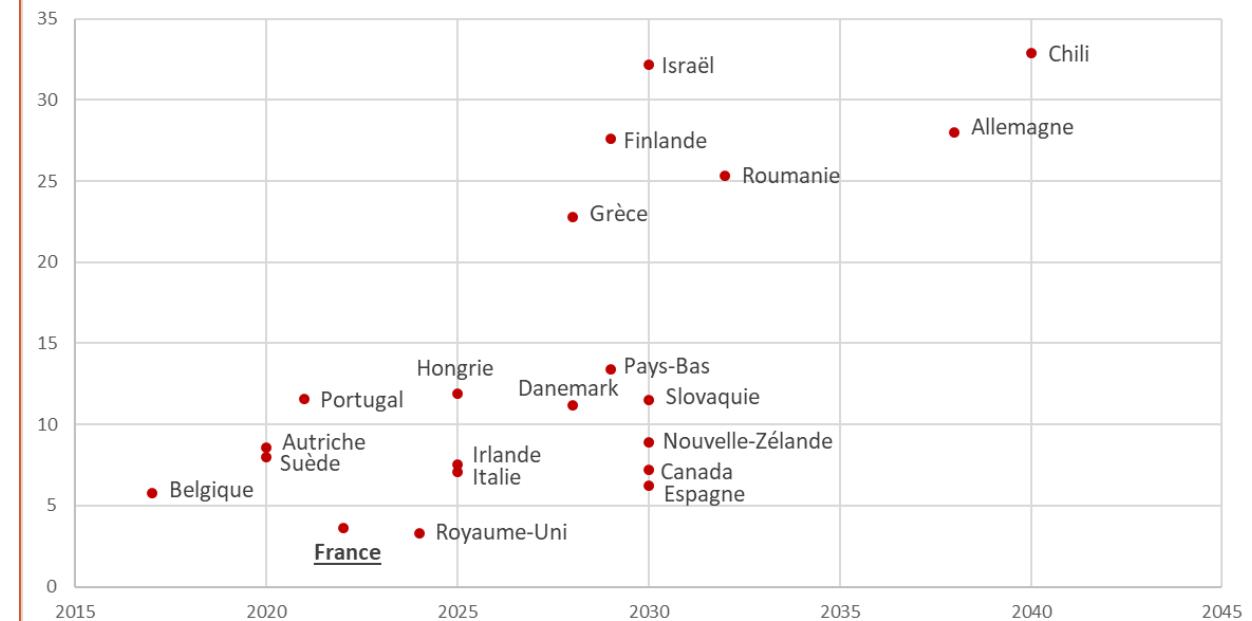

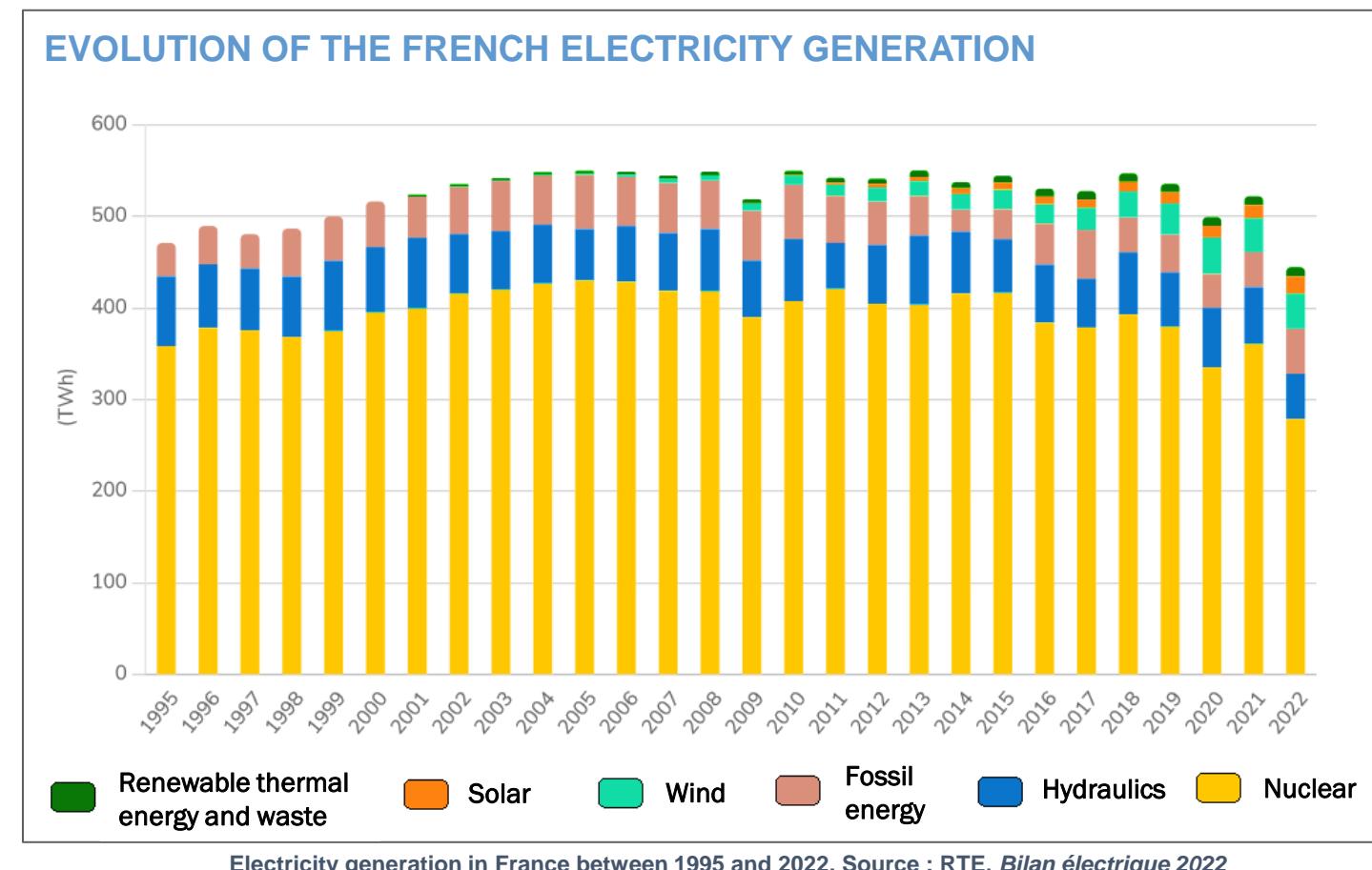
+ 2022 : end of the five-year term of President E. Macron = a symbolic act

What technical realities?

Significant reduction in drivable electricity generation capacity.

Major role in balancing supply and demand at times of peak demand.

Increased vulnerability of the electricity network in the event of major disruptive events.

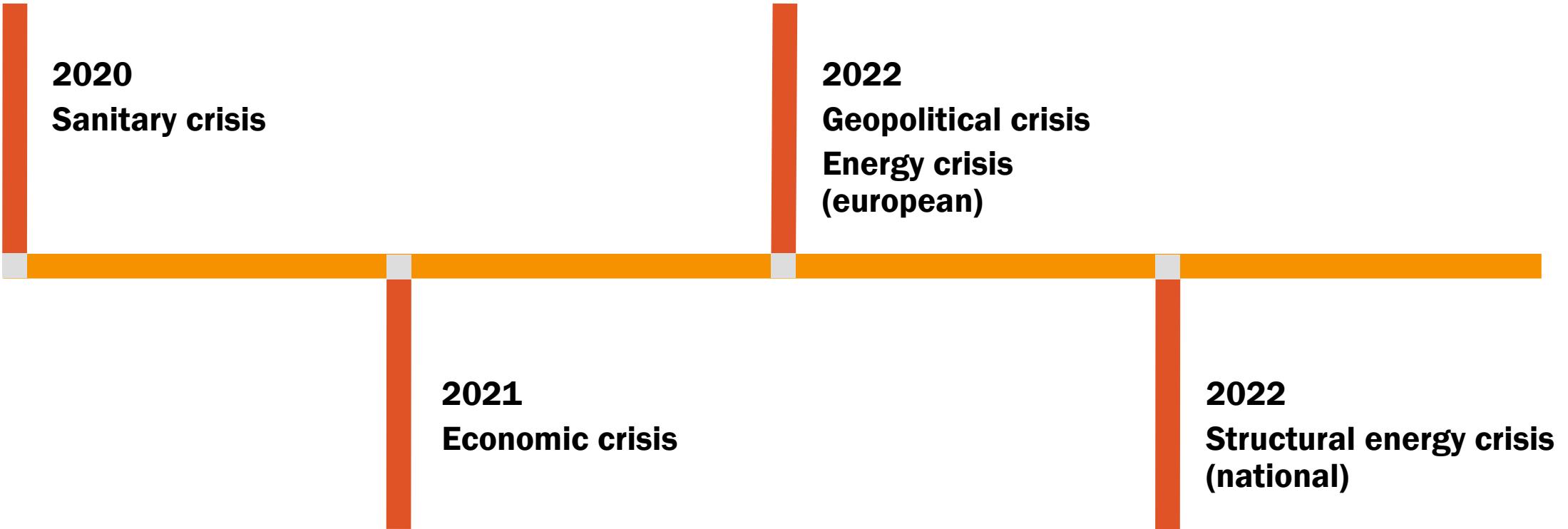


Total electricity production 2010-2021 : - 5,1 %

→ with drivable production capacity : - 11 %

2022 : Electricity imports exceed exports for the first time since 1980

Official closure on March, 31st 2022

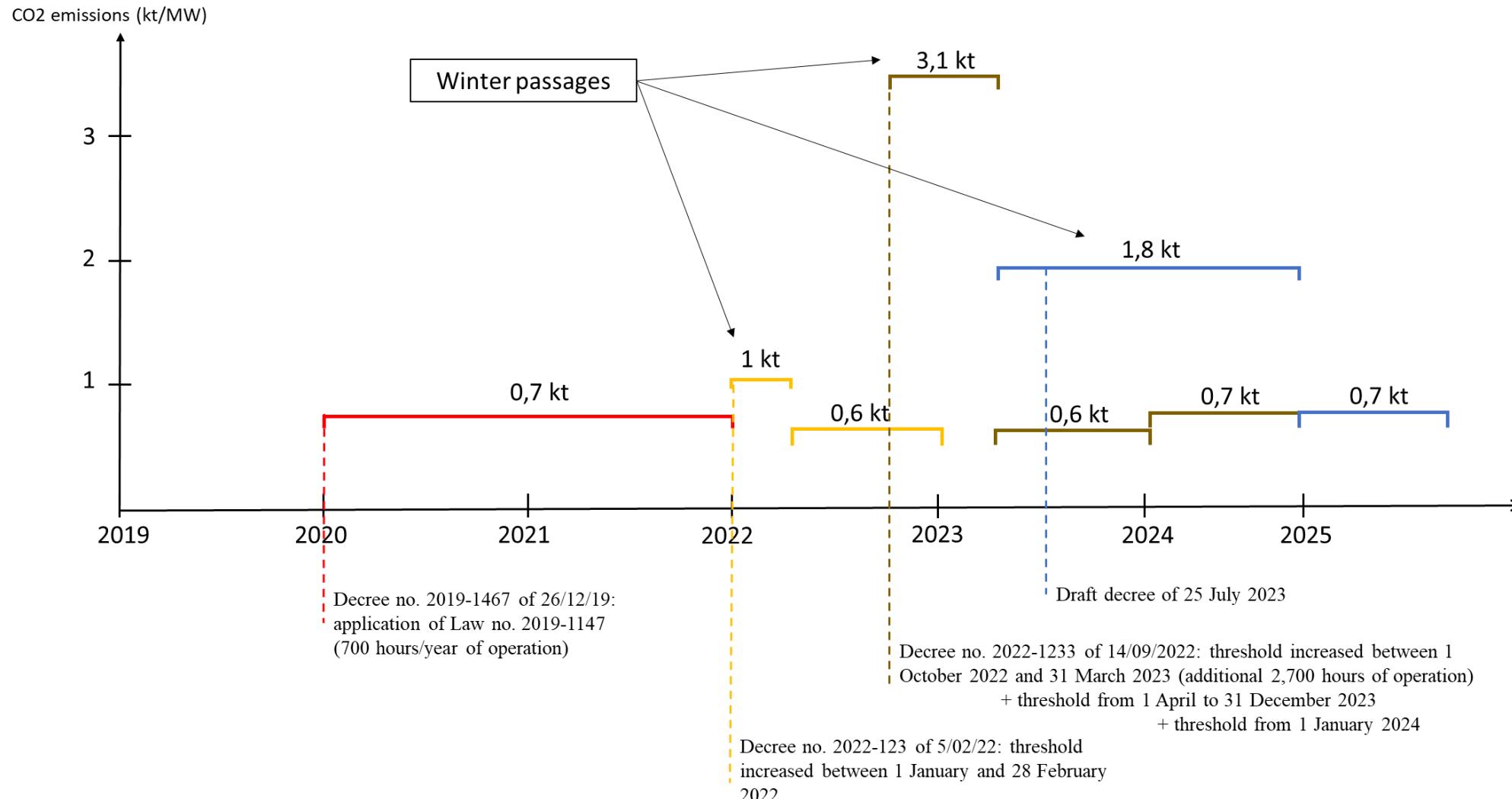

Changes in CO2 emission thresholds in the French legislation

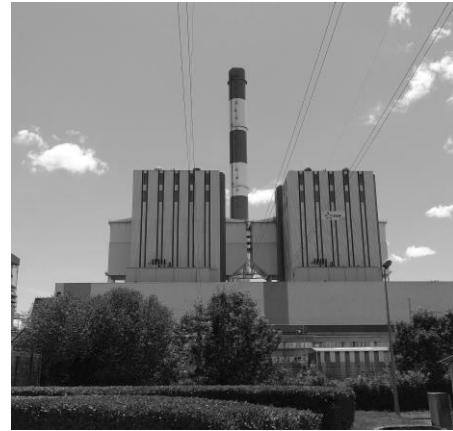

Signed in 2020 between the State, local authorities,
the sites owners...

To prepare for the post-coal phase through the
conversion of sites, territories and employees

- What are the transition trajectories at these industrial sites? How are they constructed?
- Temporality of the energy transition: is the energy relay guaranteed to ensure the security of supply of the electricity network?

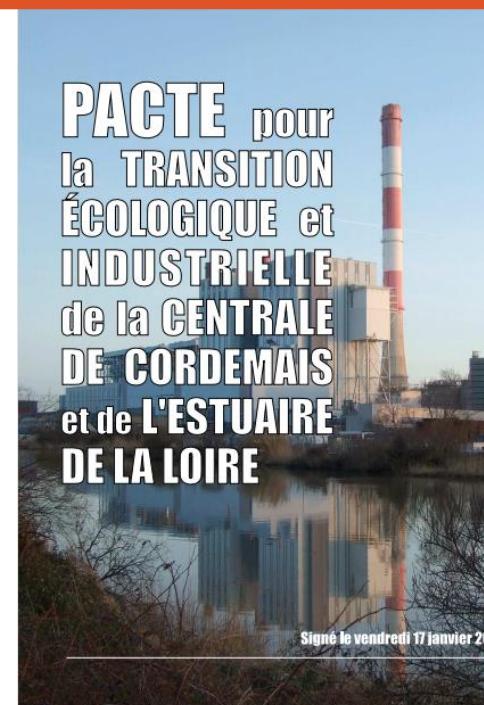

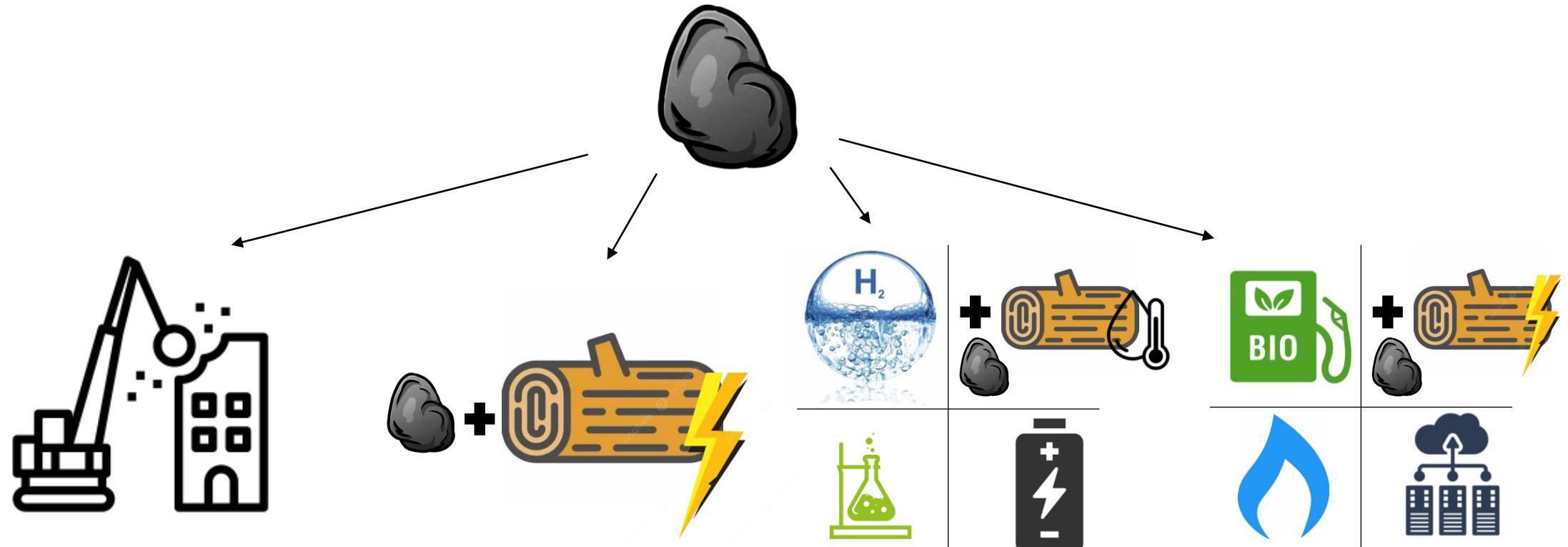

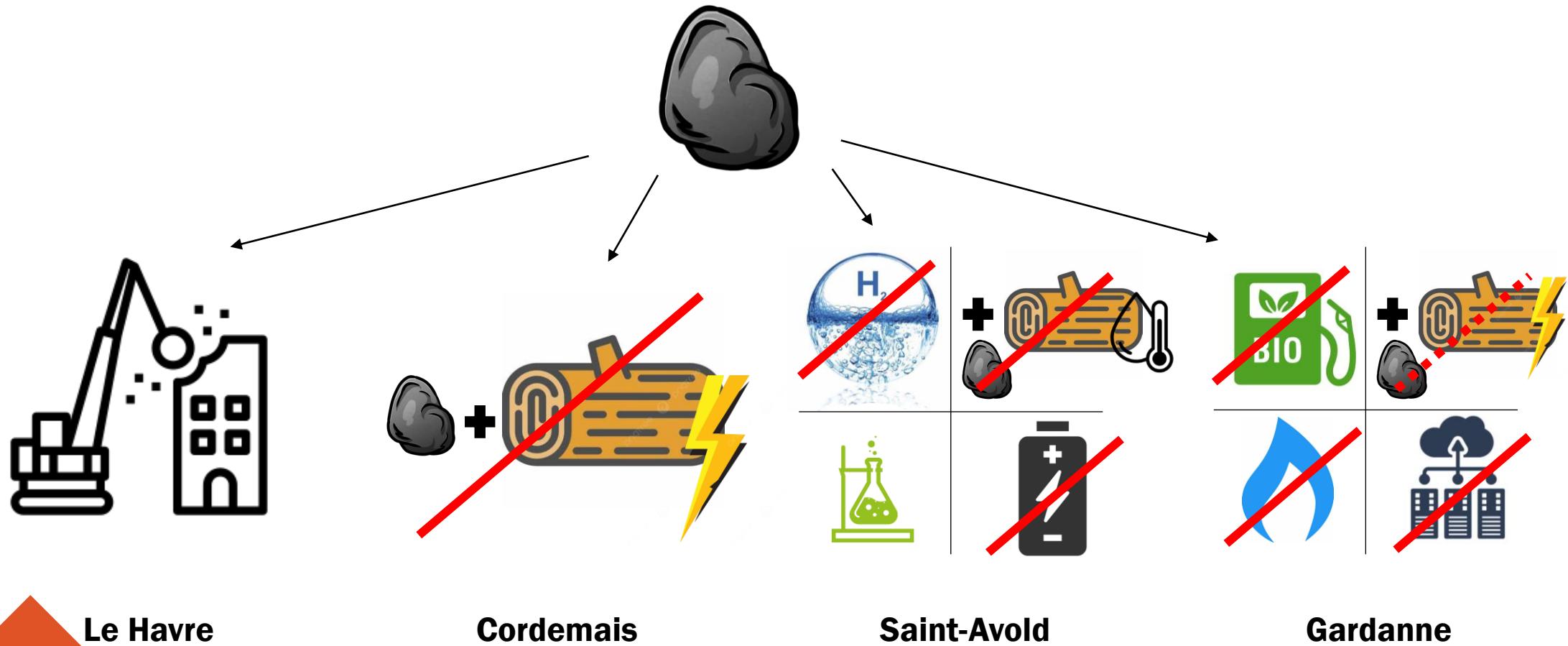

→ When politics meets the territory : administrative delays, social conflicts, local oppositions, economic opportunities

Conclusion

1

No electrical relay for the closure of coal-fired power stations

Need to prioritise the issues of decarbonisation and securing the energy supply.

2

Limited peak operating capacity

None of the conversion projects is an equivalent substitute for coal-fired power stations in terms of contribution to the electricity grid.

3

Far too short a conversion period

The time for spatial planning is not the time for political planning : the energy transition is constantly disrupted by territorial realities.

A lack of strategic planning
