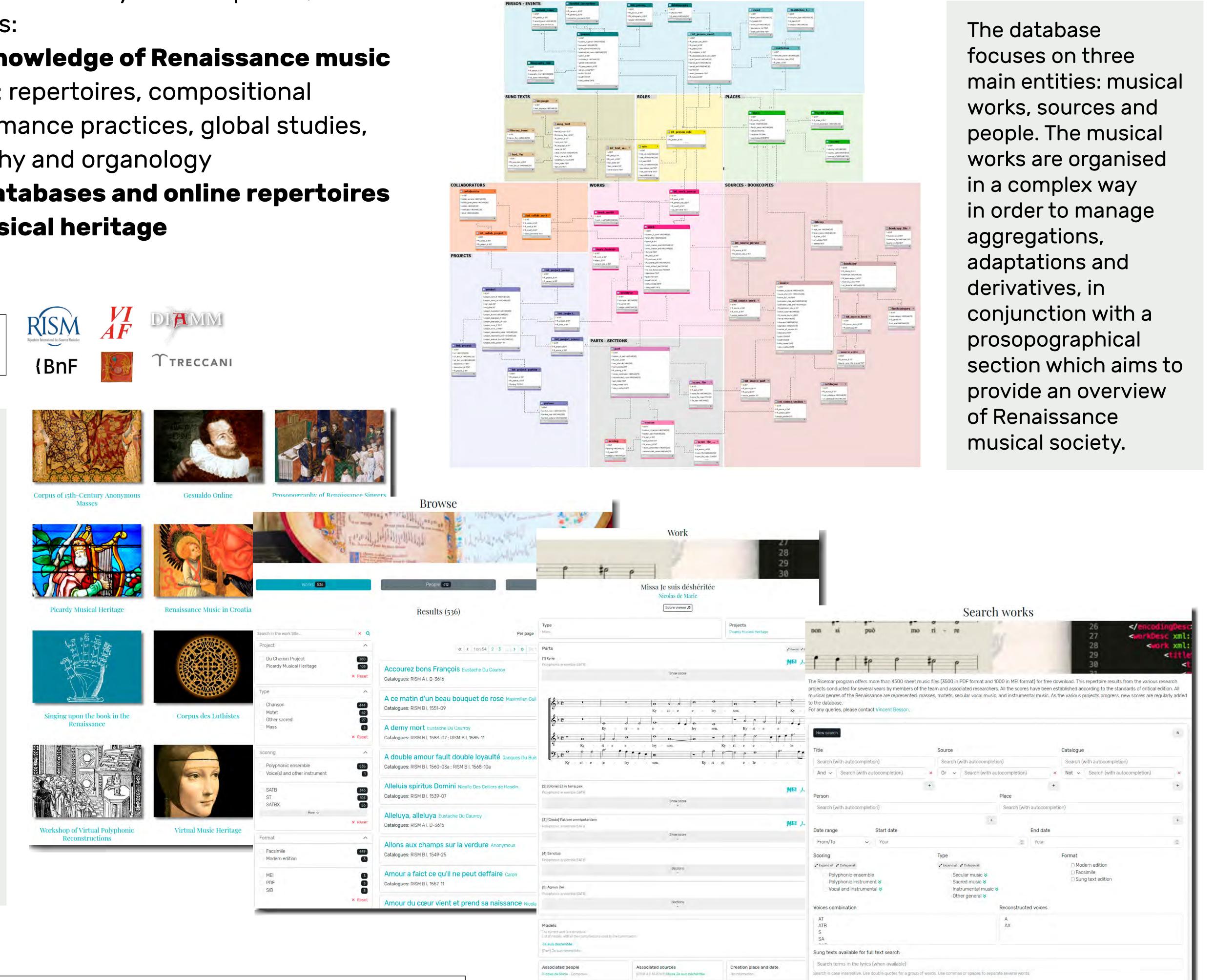

in all its aspects: repertoires, compositional processes, performance practices, global studies, theory, iconography and organology

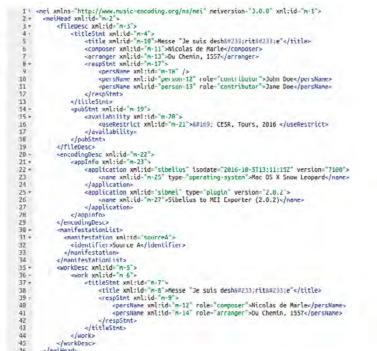
- to construct databases and online repertoires

Users can browse projects, works, sources and people and perform multicriteria search queries. The data is enriched with links to external resources, such as digitisations of the sources, and aligned with authority files. The available scores can be downloaded in different file formats.

Each score can be seen and played according to several options relating to score display (orientation, zoom, etc.) or audio (instrument, tempo, etc.). A side section allows users to view either the MEI code or the critical apparatus encoded in the MEI file. Users can suggest annotations.
