# Invisible floating objects

#### Abstract

We consider a time-harmonic water waves problem in a 2 D waveguide. The geometry is symmetric with respect to an axis orthogonal to the direction of propagation of waves. Moreover, the waveguide contains two floating obstacles separated by a distance $L$. We study the behaviours of $R$ (the reflection coefficient) and $T$ (the transmission coefficient) as $L$ tends to $+\infty$. From this analysis, we exhibit situations of non reflectivity $(R=0,|T|=1)$ or perfect invisibility $(R=0, T=1)$.


Keywords: water waves, waveguides, invisibility, asymptotic analysis

## Introduction



Figure 1: The waveguide $\Omega_{L}$.
We consider the propagation of water waves in a 2 D waveguide $\Omega_{L}$ witch coincides with $\mathbb{R} \times$ $(-1 ; 0)$ outside of a bounded domain. We assume that $\Omega_{L}$ is symmetric with respect to the vertical line $x=L / 2$ and contains two floating objects separated by a distance $L$ (see Figure 1). This leads us to study the problem

\partial_{n} u & =\lambda u & & \text { on } \Gamma_{0}:=\mathbb{R} \times\{0\} \\
\partial_{n} u & =0 & & \text { on } \partial \Omega_{L} \backslash \Gamma_{0}
\end{align*}\right.
$$

where $\lambda>0$ is proportional to the square of the frequency and $\partial_{n}$ stands for the outward normal derivative. Define $\beta>0$ such that $\beta \tan (\beta)=$ $\lambda$. Only two waves $w^{ \pm}(x, y)=\mathrm{e}^{ \pm i \beta x} \cosh (\beta(y+$ $1)$ ) can propagate in $\Omega_{L}$. And (1) admits the scattering solution

$$
u=\left\lvert\, \begin{array}{rr}
w^{+}+R w^{-}+\ldots & \text { for } x<0 \\
T w^{+}+\ldots & \text { for } x>0
\end{array}\right.
$$

where $R, T \in \mathbb{C}$ and where the dots are terms which are exponentially decaying at $\pm \infty$. Due
to conservation of energy, the reflection and transmission coefficients satisfy $|R|^{2}+|T|^{2}=1$. Thus, perfect invisibility implies non reflectivity but the converse is not true in general. Working as in [1], we compute an explicit asymptotic expansion of $R$ and $T$ as $L \rightarrow+\infty$. This allows us to exhibit non reflecting geometries. Then playing with an additional parameter, we explain how to get not only $|T|=1$ but also $T=1$ (perfect invisibility).

## Half waveguide problems

In this section, we use the symmetry of the problem to decompose it into two half waveguide problems. Set $\omega_{L}:=\left\{(x, y) \in \Omega_{L}, x<\right.$ $L / 2\}$ and $\Sigma:=\{0\} \times(-1 ; 0)$ (see Figure 2).


Figure 2: The half waveguide $\omega_{L}$.
Consider the two problems

$$
\begin{array}{|l|l}
\Delta u_{D}=0 \text { in } \omega_{L} & \Delta u_{N}=0 \text { in } \omega_{L} \\
\partial_{n} u_{D}=\lambda u_{D} \text { in } \Gamma_{0} & \partial_{n} u_{N}=\lambda u_{N} \text { in } \Gamma_{0} \\
\partial_{n} u_{D}=0 \text { in } \partial \omega_{L} \backslash \Gamma_{0} & \partial_{n} u_{N}=0 \text { in } \partial \omega_{L} \backslash \Gamma_{0} \\
u_{D}=0 \text { in } \Sigma & \partial_{n} u_{N}=0 \text { in } \Sigma .
\end{array}
$$

They admits solutions such that $u_{D}=w^{+}+$ $R_{D} w^{-}+\ldots$ and $u_{N}=w^{+}+R_{N} w^{-}+\ldots$. Here $R_{D}, R_{N} \in \mathbb{C}$ and the dots are terms which are exponentially decaying at $-\infty$. Due to conservation of energy, we have $\left|R_{D}\right|=\left|R_{N}\right|=1$. We can show that

$$
\begin{equation*}
R=\frac{R_{N}+R_{D}}{2} ; \quad T=\frac{\left(R_{N}-R_{D}\right)}{2} e^{-i \beta L} \tag{2}
\end{equation*}
$$

Therefore, to obtain an asymptotic expansion of $R, T$ as $L \rightarrow+\infty$, it is enough to work on $R_{D}, R_{N}$.
When $L \rightarrow+\infty$, the limit geometry of $\omega_{L}$ is the domain $\omega_{\infty}$ with just one floating object pictured in Figure 3. We denote by

$$
s=\left(\begin{array}{cc}
r & t \\
t & \tilde{r}
\end{array}\right) \in \mathbb{C}^{2 \times 2}
$$

the unitary scattering matrix of the propagation problem set in $\omega_{\infty}$. When $r t \neq 0$, as $L \rightarrow+\infty$, we can prove the expansions $R_{D}=R_{D}^{a s y}+\ldots$ and $R_{N}=R_{N}^{a s y}+\ldots$ with
$R_{D}^{a s y}=r-\frac{t^{2}}{e^{-i \beta L}+\tilde{r}} ; \quad R_{N}^{a s y}=r-\frac{t^{2}}{-e^{-i \beta L}+\tilde{r}}$.
One can check that $\left|R_{D}^{a s y}\right|=\left|R_{N}^{a s y}\right|=1$. Introduce $\theta_{D}, \theta_{N}, \theta_{D}^{a s y}, \theta_{N}^{a s y} \in \mathbb{R} /(2 \pi \mathbb{Z})$ the phases of $R_{D}, R_{N}, R_{D}^{a s y}, R_{N}^{a s y}$. Finally, define
$e:=\theta_{D}-\theta_{N}-\pi ; \quad e^{a s y}:=\theta_{D}^{a s y}-\theta_{N}^{a s y}-\pi$.

## Non reflectivity

From (2), we see that we have $R(L)=0$ if and only if $e(L)=0$. To prove that this occurs for certain $L$, first we show that there is $L^{\star}$ such that $e^{a s y}\left(L^{\star}\right)=0$ and $\partial_{L} e^{a s y}\left(L^{\star}\right) \neq 0$. Then using the exponential convergence of $e(L)$ to $e^{a s y}(L)$ when $L \rightarrow+\infty$, as well as the continuous dependence of $e(L)$ with respect to $L$, we can obtain the desired result.

Theorem 1 Assume that $r \boldsymbol{f} \neq 0$. Then there is a sequence $\left(L_{n}\right)$ of values of $L$ such that $R\left(L_{n}\right)=$ 0. And we have $L_{n+1}-L_{n} \underset{n \rightarrow+\infty}{\sim} \pi / \beta$.


Figure 4: $\quad R(L), T(L)$ for $L \in(0.5 ; 7)$ (top). Real part of the scattered field $u_{s}=u-w^{+}$for $L=3.15$ (bottom). In this case, $R(L) \approx 0$ and $u_{s}$ is exponentially decaying in the left branch.

We illustrate this theorem in Figure 4. The floating objects are half disks of radius 0.5 . We approximate numerically (FEM) the scattering coefficients $R(L), T(L)$ for $L \in(0.5 ; 7)$. And we
observe that the curve $L \mapsto R(L)$ indeed passes through zero. An example of non reflecting geometry is given in Figure 4.

## Perfect transmission

Now we study the problem of imposing $T=1$. Using (2) and the expansions of $R_{D}, R_{N}$, we get

$$
T=T^{a s y}+\ldots \quad \text { with } \quad T^{a s y}=\frac{t^{2} e^{-2 i \beta L}}{e^{-2 i \beta L}-\tilde{r}^{2}}
$$

Then a direct calculus shows that the curve $L \mapsto T^{\text {asy }}(L)$ passes through 1 if and only if $t \in \mathbb{R}$. This occurs for example when the floating object is a demi ellipse of semi minor axe 0.3 and semi major axe $l$ for $l=l^{\star} \approx 3.6$ (see Figure 5). With this notation, with the inverse function theorem, we can prove the following result.

Theorem 2 Assume that $r\left(l^{\star}\right) t\left(l^{\star}\right) \neq 0$. Then there is a sequence $\left(l_{n}, L_{n}\right)$ converging to $\left(l^{\star},+\infty\right)$ such that $T\left(l_{n}, L_{n}\right)=1$. And we have $L_{n+1}-$ $L_{n} \underset{n \rightarrow+\infty}{\sim} \pi / \beta$.


Figure 5: Coefficients $r(l), t(l)$ for $l \in(0.5 ; 3.9)$ (top left). Coefficients $R\left(l^{\star}, L\right), T\left(l^{\star}, L\right)$ for $L \in$ $(0.5 ; 10)$ (top right). Real part of the scattered field $u_{s}=u-w^{+}$for $L=2.9$ and $l=3.6$. In this case, $T(l, L) \approx 0$ and $u_{s}$ is almost exponentially decaying in the two branches.
