# Lagrangian intersections and glancing points: typical transitions of phase in semiclassical approximations

#### Abstract

Given a semiclassical distribution $f_{h}$ microlocalized on a Lagrangian manifold $\Lambda_{0}, H \in C^{\infty}\left(T^{*} \mathbf{R}^{n}\right)$, and $H=E$ a regular energy surface, we find asymptotic solutions of the $\operatorname{PDE}(H(x, \widehat{p})-E) u_{h}(x, E)=f_{h}(x)$ in terms of the Maslov canonical operator, when the Hamilton vector field $v_{H}$ fails to be transverse to $\Lambda_{0}$ at some points.


## 1 Introduction

Given $H \in C^{\infty}\left(T^{*} \mathbf{R}^{n}\right)$, we discuss the semiclassical approximation to the solution of the equation

$$
(\widehat{H}-E) u_{h}(x, y, E)=f_{h}(x), \quad \widehat{H}=H(x, \widehat{p}), \quad \widehat{p}=-i h \partial_{x}
$$

with a right hand side $f_{h}$ microlocalized on a smooth Lagrangian submanifold $\Lambda_{0}$ :

$$
f_{h}(x)=\left[\mathcal{K}_{\Lambda_{0}} a\right](x), \quad a: \Lambda_{0} \rightarrow \mathbf{R}
$$

where $a$ is an amplitude on $\Lambda_{0}$, and $\mathcal{K}_{\Lambda_{0}}$ denotes the Maslov canonical operator. The solution of this problem is formally given by:

$$
u_{h}(x, E)=\frac{i}{h} \int_{0}^{+\infty} v_{h}(x, t) \exp (i E t / h) d t
$$

via the solution of the Cauchy problem for the Schrödinger equation

$$
\begin{equation*}
i h \partial_{t} v_{h}=\widehat{H} v_{h}, \quad v_{h}(x, 0)=f_{h}(x) . \tag{1.1}
\end{equation*}
$$

We formulate first a set of standard hypotheses, which are sufficient in the framework of formal asymptotics we are considering here.

1. $E$ is non critical for $H$, i.e. $d H \neq 0$ on $\Sigma_{E}=\{H=E\}$.
2. $E$ is non trapping energy level for $H$, in the sense of scattering theory. This allows to cut-off the integral defining $u_{h}(x, E)$ near $t=+\infty$ as in (2.1);
3. "non-return condition" [16] which is not necessary if we content ourselves to evaluate microlocally $u_{h}(x, E)$ outside $\Lambda_{0}$. Otherwise this is a difficult problem involving Sommerfeld radiation condition, see e.g. [5]
4. $\Lambda_{0} \cap \Sigma_{E}$ is compact (isotropic) submanifold, which is fulfilled if $H$ is of elliptic type.

Let $\mathbf{R}_{x, t}^{n+1}=\{(x, t)\}$ be the space-time and $T^{*} \mathbf{R}_{x, t}^{n+1}$ be its cotangent bundle with the coordinates $(x, t, p, E)$ such that $p d x-E d t$ is the canonical 1 -form. To define the semiclassical approximation for $v_{h}$ one needs:

- the Lagrangian submanifold of $T^{*} \mathbf{R}^{n+1}$

$$
\Lambda=\left\{(x, p)=g^{t}(z), t>0, E=H(z): z \in \Lambda_{0}\right\}
$$

where $g^{t}=\exp t v_{H}$ is the phase flow of the Hamiltonian vector field $v_{H}$ generated by $H$

$$
\dot{x}=\partial_{p} H(x, p), \quad \dot{p}=-\partial_{x} H(x, p) .
$$

- the amplitude $b: \Lambda \rightarrow \mathbf{R}$ being the solution to the transport equation with an initial condition $\left.b\right|_{\Lambda_{0}}=a$. Then $v_{h}(x)$ is given by

$$
v_{h}(x, t)=\left[\mathcal{K}_{\Lambda} b\right](x, t)+\mathcal{O}(h), \quad b: \Lambda \rightarrow \mathbf{R} .
$$

So we can expect the following semiclassical approximation

$$
\begin{equation*}
u_{h}(x, E)=\frac{i}{h} \int_{0}^{+\infty}\left[\mathcal{K}_{\Lambda} b\right](x, t) \exp (i E t / h) d t+\mathcal{O}(h) . \tag{1.2}
\end{equation*}
$$

The relevant contributions to this integral come from $t=0, t=+\infty$ and the critical points $t \in(0,+\infty)$. See also [14] for higher order approximation.

The Lagrangian submanifold of $T^{*} \mathbf{R}^{n}$

$$
\Lambda_{+}^{E}=\left\{z \in T^{*} \mathbf{R}^{n}: \exists t \geq 0, z \in \exp t v_{H}\left(\Lambda_{0} \cap \Sigma_{E}\right)\right\}
$$

gives the contribution of the critical points $t \in(0,+\infty)$. The following two cases are possible.

1) The Lagrangian submanifold $\Lambda_{0}$ is transversal to $\Sigma_{E}$ - it means that $E$ is not a critical value for the restriction $H_{\Lambda_{0}}$. Then $v_{H}$ is not tangent to $\Lambda_{0}$ and consequently to the submanifold $\Lambda_{0} \cap \Sigma_{E}$. Therefore $\Lambda_{+}^{E}$ is an immersed Lagrangian submanifold with boundary and we say that $\left(\Lambda_{0}, \Lambda_{+}^{E}\right)$ is a (Lagrangian) intersecting pair.
2) The Lagrangian submanifold $\Lambda_{0}$ is tangent to $\Sigma_{E}$ at a point $z$ called glancing - it means that $z$ is a critical point of the restriction $H_{\Lambda_{0}}$ with the critical value $E$. Then $v_{H}$ is tangent to $\Lambda_{0}$ and $\Lambda_{+}^{E}$ may have singularities, see e.g. [6] for applications to the semiclassical context.

Remark: A model problem with the point $t=+\infty$ giving a relevant contribution into the integral (1.2) is investigated in (4).

## 2 Basic example of intersecting pair

A simple example of a Lagrangian intersecting pair is given by $\widetilde{\Lambda}_{0}=\{x=0\}$ (vertical fiber at 0 ) and
$\widetilde{\Lambda}_{+}^{0}=\left\{(x, p) \in T^{*} \mathbf{R}^{n}: x^{\prime}=0, p_{n}=0, x_{n} \geq 0\right\}, x^{\prime}=\left(x_{1}, \ldots, x_{n-1}\right), p^{\prime}=\left(p_{1}, \ldots, p_{n-1}\right)$,
the flow-out of $\widetilde{\Lambda}_{0}$ by the Hamilton vector field with Hamiltonian $p_{n}$. In this case $\widehat{H}=-i h \partial_{x_{n}}$,

$$
f_{h}(x)=\left[\mathcal{K}_{\widetilde{\Lambda}_{0}} a\right](x)=\int_{\widetilde{\Lambda}_{0}} e^{i x p / h} a(p) d p=f_{1}\left(\frac{x}{h}\right)
$$

where $f_{1}$ decreases rapidly at infinity,

$$
v_{h}(x, t)=f_{h}\left(x^{\prime}, x_{n}-t\right)
$$

and

$$
\begin{align*}
& u_{h}(x, 0)=\frac{i}{h} \int_{0}^{+\infty} f_{h}\left(x^{\prime}, x_{n}-t\right) d t=  \tag{2.1}\\
& \frac{i}{h} \int_{0}^{+\infty} \Theta_{t_{0}}(t) f_{1}\left(\frac{x^{\prime}}{h}, \frac{x_{n}-t}{h}\right) d t+\mathcal{O}\left(h^{\infty}\right)
\end{align*}
$$

for all $x_{n} \leq t_{0} / 2$, here $\Theta_{t_{0}}$ is a cut-off function equal to 1 on $\left[0, t_{0}\right]$ and 0 near $+\infty$.

This pair of Lagrangian manifolds is actually the paradigm of intersecting pairs, i. e. in some local canonical charts $\Lambda_{0}=\widetilde{\Lambda}_{0}$ and $H(x, p)=E+p_{n}$. In particular $\left(\Lambda_{0}, \Lambda_{+}^{E}\right)$ are mapped onto $\left(\widetilde{\Lambda}_{0}, \widetilde{\Lambda}_{+}^{0}\right)$ by a canonical transformation sending $\partial \Lambda_{+}^{E}=\Lambda_{0} \cap \Lambda_{+}^{E}$ onto $\partial \widetilde{\Lambda}_{+}^{0}=\widetilde{\Lambda}_{0} \cap \widetilde{\Lambda}_{+}^{0}$.

## 3 Main motivation: Helmholtz equation and Bessel cylinder

Most intrinsic formulae are available in the case of the physically relevant case of a Hamiltonian positively homogeneous with respect to $p$, e.g. the Helmholtz operator. This provides global eikonal coordinates and avoids the microlocal reduction to $H=E+\widehat{p}_{n}$.

Taking into account glancing intersection amounts to "correct" locally the formulae giving the phase function and the half-density in new local coordinates, which are obtained using a normal form.

Let us consider the Bessel cylinder $\Lambda_{0} \subset T^{*} \mathbf{R}^{n}$

$$
\begin{equation*}
\Lambda_{0}=\{x=\varphi \omega(\psi), p=\omega(\psi): \varphi \in \mathbf{R}\} \tag{3.1}
\end{equation*}
$$

where $\omega(\psi)$ is a vector on the unit sphere in $\mathbf{R}^{n}$.
Our main motivation is the study of Bessel beams, i.e. a wave whose amplitude is described by a Bessel function of the first kind. Assume for instance we are given a non-linear Helmholtz equation on $\mathbf{R}^{2}$ of the type

$$
-h^{2} \Delta u-u=F(\varepsilon u), \quad F(0)=0, \quad F^{\prime}(0)=1
$$

where $F$ is a smooth function and $\varepsilon$ is a small parameter. We expand $u=$ $u_{0}+\varepsilon u_{1}+\cdots$, and find at zero order in $\varepsilon$ the equation $\left(-h^{2} \Delta-1\right) u_{0}=0$. Its radially symmetric solution is given by $u_{0}=f_{h}(x)$ where

$$
f_{h}(x)=(2 \pi / h)^{1 / 2} J_{0}(|x| / h),
$$

and is microlocalized on the Bessel cylinder $\Lambda_{0} \subset T^{*} \mathbf{R}^{2}$ defined by (3.1) for $n=2$.

At first order in $\varepsilon$ we get the Helmholtz equation

$$
\left(-h^{2} \Delta-1\right) u_{1}=f_{h}, \quad H=p^{2}
$$

where $u_{1}=u(x, 1)$ in our previous notation, and

$$
u_{h}(x, 1)=-J_{1}(|x| / h)(|x| / 2 h)
$$

is its radially symmetric solution. We observe that all points of $\Lambda_{0}$ turn to be glancing because $\Lambda_{0} \subset \Sigma_{1}$ and $H_{\Lambda_{0}} \equiv 1$.

For the Helmholtz equation with variable coefficients, we have the following:

Proposition 3.1 Let $\Lambda_{0}$ be the $n$-dimensional Bessel cylinder (3.1) and $H \in$ $C^{\infty}\left(T^{*} \mathbf{R}^{n}\right)$ be homogeneous of degree $m$ with respect to $p$. Then $z=(x, p) \in$ $\Lambda_{0}$ is a glancing point at energy $E$ iff

$$
\begin{align*}
& \partial_{p} H(z)+\varphi \partial_{x} H(z)=m H \omega(\psi), \\
& \left\langle-\partial_{x} H(z), \omega(\psi)\right\rangle=0, \quad H(z)=E \tag{3.2}
\end{align*}
$$

Proof: We complete $\omega(\psi)$ in $\mathbf{S}^{n-1}$ into a (direct) orthonormal basis $\omega^{\perp}(\psi)=$ $\left(\omega_{1}(\psi), \cdots, \omega_{n-1}(\psi)\right)$ of $\mathbf{R}^{n}$, and denote by $\omega^{\perp}(\psi) \delta \psi=\omega_{1}(\psi) \delta \psi_{1}+\cdots+$ $\omega_{n-1}(\psi) \delta \psi_{n-1}$ a section of $T \mathbf{S}^{n-1}, \delta \psi_{j} \in \mathbf{R}$. The tangent space $T_{z} \Lambda_{0}$ has the parametric equations

$$
\delta X=\omega(\psi) \delta \varphi+\varphi \omega^{\perp}(\psi) \delta \psi, \delta P=\omega^{\perp}(\psi) \delta \psi,(\delta \varphi, \delta \psi) \in \mathbf{R}^{n}
$$

so $v_{H} \in T_{z} \Lambda_{0}$ iff there exist $(\delta \varphi, \delta \psi)$ such that

$$
\partial_{p} H=\omega(\psi) \delta \varphi+\varphi \omega^{\perp}(\psi) \delta \psi-\partial_{x} H=\omega^{\perp}(\psi) \delta \psi
$$

Taking scalar products with $\omega(\psi), \omega^{\perp}(\psi)$, and using that $\left(\omega(\psi), \omega^{\perp}(\psi)\right)$ form a basis of $\mathbf{R}^{n}$, readily shows that relations

$$
\begin{equation*}
\partial_{p} H+\varphi \partial_{x} H=\left\langle\partial_{p} H, P(\psi)\right\rangle \omega(\psi),\left\langle-\partial_{x} H, \omega(\psi)\right\rangle=0 \tag{3.3}
\end{equation*}
$$

are necessary and sufficient for $v_{H} \in T_{z} \Lambda_{0}$.
We set $\mathcal{H}(\varphi, \psi)=\left.H\right|_{\Lambda_{0}}$. Then

$$
\nabla \mathcal{H}(\varphi, \psi)=\left(\left\langle\partial_{x} H, \omega^{\perp}(\psi)\right\rangle, \varphi\left\langle\partial_{x} H, \omega^{\perp}(\psi)\right\rangle+\left\langle\partial_{p} H, \omega^{\perp}(\psi)\right\rangle\right)
$$

so (3.3) readily gives $\nabla \mathcal{H}(\varphi, \psi)=0$. Therefore $z=(x, p) \in \Lambda_{0}$ is a glancing point.

Now, if $H$ is positively homogeneous of degree $m$ with respect to $p$, using Euler identity, we get $\delta \varphi=\left\langle\partial_{p} H, P(\psi)\right\rangle=m H$, and (3.2) holds iff for $v_{H} \in T_{z} \Lambda_{+}^{E} \cap T_{z} \Lambda_{0}$ when $H=E$.

In particular when $H(z)=\frac{|p|^{m}}{\rho(x)}$ is a conformal metric, with $\rho$ a smooth positive function on $\mathbf{R}^{n}, z$ is a glancing point iff

$$
\begin{aligned}
& \text { either : } \varphi \neq 0 \text { and } \nabla \rho=0 \text {, } \\
& \text { or : } \varphi=0 \text { and }\langle\nabla \rho(0), \omega(\psi)\rangle=0 \text {. }
\end{aligned}
$$

Example: Let $n=2, m=1, H(z)=\frac{|p|}{\rho(x)}$, with $\rho(x)=\frac{1}{2}\left(1+\left(x-x_{0}\right)^{2}\right)$. If $x_{0}=\varphi \omega(\psi) \neq 0$, we have $\rho^{4}\left(x_{0}\right) \operatorname{det} \nabla^{2}\left(\left.H\right|_{\Lambda_{0}}\right)=\varphi^{2}, \rho^{2}\left(x_{0}\right) \operatorname{Tr} \nabla^{2}\left(\left.H\right|_{\Lambda_{0}}\right)=$ $-\left(1+\varphi^{2}\right)$. Critical energy is given by $E=H(z)=\frac{|p|}{\rho(x)}$, i. e. $E_{0}=1 / \rho\left(x_{0}\right)$.

Remark: Let $n=2, H(z)$ positively homogeneous of degree $m=1$. Away from glancing points, $\Lambda_{+}^{E}$ is parametrized near $t=0$ by $\left(\psi, \theta^{E}\right)$, where $\theta^{E}=$ $\theta^{E}(t, \varphi)$ and $\theta^{E}: \mathbf{R}^{2} \rightarrow \mathbf{R}$ is a submersion, such that

$$
H(X(t, \varphi, \psi), P(t, \varphi, \psi))=E
$$

When $\rho(x)=\rho(|x|)$, we have $\varphi=\varphi(E)$ on $\Lambda_{+}^{E}$, so that we can take $\theta^{E}(t, \varphi)=E t$ (or equivalently $\theta^{E}(t, \varphi)=\varphi(E)+E t$, which is the eikonal on $\Lambda_{+}^{E}$ ), and $\Lambda_{+}^{E}$ is parametrized by $(t, \psi)$. Conversely, if $\Lambda_{+}^{E}$ is parametrized by $(t, \psi)$, the fact that $\Lambda_{+}^{E}$ is Lagrangian implies the symmetry relation $\left\langle\dot{X}, P_{\psi}\right\rangle=\left\langle\dot{P}, X_{\psi}\right\rangle$. For $H=\frac{|p|}{\rho(x)}$, taking the limit $t \rightarrow 0$ in Hamilton equations gives $\varphi\left\langle\nabla \rho, \omega^{\perp}(\psi)\right\rangle=0$, which shows that $\rho$ is radially symmetric.

## 4 Eikonal coordinates and generating families in the case $m=1$

Let $\iota: L \rightarrow T^{*} \mathbf{R}_{x}^{d}$ be a smooth immersed Lagrangian manifold, the 1-form $p d x$ is closed on $L$, and so locally $p d x=d S$. If $p d x \neq 0$ then $S$ can be chosen as a (local) coordinate on $L$. Following [7, [10] we say that $S$ is the eikonal or the action on $L$ which can be completed to a system of eikonal coordinates on $L$.

Let $L=\Lambda_{0} \subset T^{*} \mathbf{R}_{x}^{n}$ the Bessel cylinder (3.1). Since $p d x=d \varphi$ on $\Lambda_{0}$ we get that $(\varphi, \psi)$ are eikonal coordinates.

Let $L=\Lambda \subset T^{*} \mathbf{R}_{x, t}^{n+1}$ be the integral manifold in the extended phase space. If $m=1$ then according to Euler identity

$$
\dot{S}=p \dot{x}-H=p \partial_{p} H-H=0
$$

along the trajectories and $(\varphi, \psi, t)$ are eikonal coordinates on $\Lambda$. Let

$$
\Phi: \mathbf{R}^{N} \times \mathbf{R}_{x}^{d} \rightarrow \mathbf{R}, \quad \theta \in \mathbf{R}^{N}
$$

be a smooth function such that the $N \times(d+N)$ matrix $\left(\partial_{\theta \theta}^{2} \Phi, \partial_{\theta x}^{2} \Phi\right)$ has rank $N$ on the critical set

$$
\begin{equation*}
C_{\Phi}=\left\{(\theta, x) \in \mathbf{R}^{d} \times \mathbf{R}^{N}: \partial_{\theta} \Phi(\theta, x)=0\right\} . \tag{4.1}
\end{equation*}
$$

In other words, $C_{\Phi}$ defined by the equations (4.1) is a smooth submanifold in the sense of the implicit function theorem. Then

$$
\begin{equation*}
\iota_{\Phi}: C_{\Phi} \rightarrow T^{*} \mathbf{R}_{x}^{d}, \quad(\theta, x) \mapsto\left(x, \partial_{x} \Phi(\theta, x)\right) \tag{4.2}
\end{equation*}
$$

is a Lagrangian (i. e. $\iota_{\Phi}^{*} d p \wedge d x=0$ ) immersion, $L=\iota_{\Phi}\left(C_{\Phi}\right)$ is an immersed Lagrangian submanifold, and $\Phi$ is called a generating family or phase function of $L$ - see e.g. [3], [13].

It is standard to show that the number $N$ of $\theta$-variables can be reduced to $N \leq d$, and the minimal possible $N$ is equal to the co-rank of the projection $L \rightarrow \mathbf{R}_{x}^{d}$.

If the system (4.1) is degenerate in the sense of the implicit function theorem then $L=\iota_{\Phi}\left(C_{\Phi}\right)$ is a singular (isotropic) submanifold. In particular its dimension can be less than $d$. See e.g. [6] for a general discussion.

Let $d=n$ and $L=\Lambda_{0} \subset T^{*} \mathbf{R}_{x}^{n}$ be Bessel cylinder (3.1). Following [8], it is convenient to use among the $\theta$-parameters a Lagrange multiplier $\lambda$ and get for $\Lambda_{0}$ the generating family

$$
\begin{aligned}
& \Phi_{0}(x, \theta)=\varphi+\lambda\langle\omega(\psi), x-\varphi \omega(\psi)\rangle=(1-\lambda) \varphi+\lambda\langle\omega(\psi), x\rangle, \\
& \theta=(\lambda, \varphi, \psi) \in \mathbf{R}^{n+1} .
\end{aligned}
$$

Let now

$$
p=P(\varphi, \psi, t), \quad x=X(\varphi, \psi, t)
$$

be the Hamiltonian trajectory with an initial condition on the Bessel cylinder (3.1):

$$
P(\varphi, \psi, 0)=\omega(\psi), \quad X(\varphi, \psi, 0)=\varphi \omega(\psi)
$$

We apply then (4.2) to $d=n+1$ and $L=\Lambda$ being the flow out of $\Lambda_{0}$ by $v_{H}$ in $T^{*} \mathbf{R}^{n+1}$.

Proposition 4.1 Let $H(x, p)$ be positively homogeneous of degree 1 with respect to $p$. Then

$$
\Phi(\theta, x, t)=\varphi+\lambda\langle P(\varphi, \psi, t), x-X(\varphi, \psi, t)\rangle, \theta=(\lambda, \varphi, \psi) \in \mathbf{R}^{n+1}
$$

is a generating family for $\Lambda \subset T^{*} \mathbf{R}_{x, t}^{n+1}$ at the points satisfying the inequality $\operatorname{det}\left(P, P_{\psi}\right) \neq 0$, which holds at least for small $t$ (because $\operatorname{det}\left(P, \partial_{\psi} P\right)=1$ for $t=0)$. In particular, $\Phi$ satisfies the initial condition $\Phi(\theta, 0, x)=\Phi_{0}(\theta, x)$.

Note that $\Phi$ is the 1 -jet on $\Lambda$ of the solution of the Hamilton-Jacobi equation

$$
\partial_{t} \Psi+H\left(x, \partial_{x} \Psi\right)=0,\left.\quad \Psi\right|_{t=0}=\langle x, \omega(\psi)\rangle
$$

defining $v_{h}$ in (1.1), namely $\partial_{t} \Phi+H\left(x, \partial_{x} \Phi\right)=0$ after the substitution $\lambda=1$, $x=X(\varphi, \psi, t)$.

Let $z_{0} \in \Lambda_{0}$ be a non-glancing point. It means that $z_{0}$ is not a critical point of the restriction $\left.H\right|_{\Lambda_{0}}$.

Proposition 4.2 If $H(x, p)$ is positively homogeneous of degree 1 with respect to $p$ and $E=H\left(z_{0}\right)$ then

$$
\Phi_{+}^{E}\left(\theta_{+}, x\right)=\Phi(\lambda, \varphi, \psi, x, t)+E t, \theta_{+}=(\lambda, \varphi, \psi, t) \in \mathbf{R}^{n+2}
$$

is a generating family for $\Lambda_{+}^{E} \subset T^{*} \mathbf{R}_{x}^{n}$ at the points that are close to the Hamiltonian trajectory starting at $z_{0}$ and satisfy the inequality $\operatorname{det}\left(P, P_{\psi}\right) \neq$ 0 , which holds at least for small $t$.

## 5 Invariant density using the eikonal coordinates

Let $y=\left(y_{1}, \cdots, y_{d}\right)$ be some local coordinates on $C_{\Phi}$ extended locally to smooth functions on $\mathbf{R}^{d} \times \mathbf{R}^{N}$. Then the non vanishing real function

$$
\begin{align*}
& F[\Phi, d y]=\frac{d y \wedge d\left(\partial_{\theta} \Phi\right)}{d x \wedge d \theta}= \\
& \frac{d y_{1} \wedge \cdots \wedge d y_{d} \wedge d\left(\partial_{\theta_{1}} \Phi\right) \wedge \cdots \wedge d\left(\partial_{\theta_{N}} \Phi\right)}{d x_{1} \wedge \cdots \wedge d x_{d} \wedge d \theta_{1} \wedge \cdots \wedge d \theta_{N}} \tag{5.1}
\end{align*}
$$

is well-defined near $C_{\Phi}$ as the quotient of two volume forms.
The restriction of this function to $C_{\Phi}$ is important for computations of the Maslov canonical operator on a Lagrangian submanifold $L=\iota\left(C_{\Phi}\right)$ via its generating family $\Phi$ - see e.g. [7], [10].

Proposition 5.1 Let $H(x, p)$ be positively homogeneous of degree 1 with respect to $p, \Phi$ be the generating family for $\Lambda \subset T^{*} \mathbf{R}_{x, t}^{n+1}$ from Proposition 4.1, $\theta=(\lambda, \varphi, \psi)$, and $y=(\varphi, \psi, t)$. Then

$$
\left.F[\Phi, d y]\right|_{C_{\Phi}}= \pm \operatorname{det}\left(P, \partial_{\psi} P\right)
$$

## 6 Specific results near a glancing point

If $\Lambda_{+}^{E}$ is an immersed Lagrangian submanifold we can compute the contribution of the critical points $t \in(0,+\infty)$ in the integral (1.2) using the Maslov
canonical operator on $\Lambda_{+}^{E}$ (see [2]). At glancing points $\Lambda_{+}^{E}$ can become singular and this procedure does not work.

Here we consider glancing points which are non-degenerate critical points of $\left.H\right|_{\Lambda_{0}}$ in the case $n=2$. We use ( $x, y, p_{x}, p_{y}$ ) instead of $\left(x_{1}, x_{2}, p_{1}, p_{2}\right)$, let

$$
\begin{aligned}
\pi_{t}:\left(p_{x}, p_{y}, E, x, y, t\right) & \mapsto(x, y, t), \\
\pi_{E}:\left(p_{x}, p_{y}, E, x, y, t\right) & \mapsto(x, y, E)
\end{aligned}
$$

be the natural projections.
Theorem 6.1 Let $z_{0} \in \Lambda_{0}$ be a glancing point being a non-degenerate minimum or maximum of $\left.H\right|_{\Lambda_{0}}, z \in \Lambda$ be a point of the trajectory starting at $z_{0} \in \Lambda_{0}$ and the point $\pi_{t}(z)$ does not belong to the caustic of $\Lambda$. Then in a neighbourhood of the point $z$ there exists a canonical map

$$
\left(p_{x}, p_{y}, E, x, y, t\right) \mapsto\left(p_{\xi}, p_{\eta}, \varepsilon, \xi, \eta, \tau\right)
$$

i. e.

$$
d p_{\xi} \wedge d \xi+d p_{\eta} \wedge d \eta-d \varepsilon \wedge d \tau=d p_{x} \wedge d x+d p_{y} \wedge d y-d E \wedge d t
$$

such that

- $\pi_{E}\left(p_{\xi}, p_{\eta}, \varepsilon, \xi, \eta, \tau\right)=(\xi, \eta, \varepsilon)$;
- $\varepsilon$ depends only on $E$ and does not depend on the other coordinates ( $p_{x}, p_{y}, x, y, t$ );
- the Lagrangian submanifold $\Lambda$ is defined by the following formulas

$$
\begin{gathered}
S(\xi, \eta, \tau)=-\left(\tau^{3} / 3+\xi^{2} \tau\right), \quad p_{\xi}=\partial_{\xi} S=-2 \xi \tau \\
p_{\eta}=\partial_{\eta} S=0, \quad \varepsilon=-\partial_{\tau} S=\tau^{2}+\xi^{2}
\end{gathered}
$$

A proof of this theorem with the help of standard methods of Singularity Theory is going to be published later.

Let us consider the following simplest example. If

$$
\begin{gathered}
H=p_{y}, \quad S_{0}(x, y)=x^{2} y+y^{3} / 3, \quad z_{0}=0 \\
\Lambda_{0}=\left\{p_{x}=\partial_{x} S_{0}=2 x y, p_{y}=\partial_{y} S_{0}=x^{2}+y^{2}\right\} .
\end{gathered}
$$

Then

$$
\begin{gathered}
S(x, y, t)=x^{2}(y-t)+(y-t)^{3} / 3 \\
\Lambda=\left\{p_{x}=\partial_{x} S, p_{y}=\partial_{y} S, E=-\partial_{t} S\right\} .
\end{gathered}
$$

The trajectory starting at $z_{0}$ is $p_{x}=p_{y}=x=0, y=t$, let $z$ be its point for $t=T$. Then the canonical transformation

$$
\begin{aligned}
p_{\xi} & =p_{x}, \quad p_{\eta}=p_{y}-E, \quad \varepsilon=E, \\
\xi & =x, \quad \eta=y-T, \quad \tau=t-y
\end{aligned}
$$

gives $S=-x^{2} \tau-\tau^{3} / 3$ according to Theorem 6.1.
Theorem 6.1 implies the following: for $z \in \Lambda$ as above, if $U_{z} \subset \Lambda$ is a sufficiently small neighbourhood of $z$, then for any smooth function $b: \Lambda \rightarrow \mathbf{R}$ vanishing outside of $U_{z}$, there exists smooth function $S, B: \mathbf{R}_{x, y, t}^{3} \rightarrow \mathbf{R}$ vanishing outside of $\pi_{t}\left(U_{z}\right)$ such that

$$
\begin{gathered}
\Lambda \cap U_{z}=\left\{p_{x}=\partial_{x} S, p_{y}=\partial_{y} S, E=-\partial_{t} S\right\} \cap U_{z}, \\
{\left[\mathcal{K}_{\Lambda} b\right](x, y, t)=B(x, y, t) \exp \left\{\frac{i S(x, y, t)}{h}\right\} .}
\end{gathered}
$$

Therefore the integral (1.2) is rewritten in terms of the Maslov canonical operator on the same $\Lambda$ but in the space $T^{*} \mathbf{R}_{x, y, E}^{3}$ :

$$
\int_{0}^{+\infty}\left[\mathcal{K}_{\Lambda} b\right](x, y, t) \exp \left\{\frac{i E t}{h}\right\} d t=\int_{-\infty}^{+\infty} B(x, y, t) \exp \left\{\frac{i(S(x, y, t)+E t)}{h}\right\} d t
$$

and we can express this value in the coordinates of Theorem 6.1]like in [9], [15].

## 7 The transition of $\Lambda_{+}^{E}$ and its phase

Now we describe what happens with the singular Lagrangian submanifold $\Lambda_{+}^{E}$ as $\sigma=E-E_{0}$ changes its sign. More precisely, let us consider a submanifold

$$
\operatorname{loc} \Lambda_{+}^{E}=\left\{z \in T^{*} \mathbf{R}^{n}: \exists t \geq 0, z \in \exp t v_{H}\left(\Lambda_{0} \cap U_{z_{0}} \cap \Sigma_{E}\right)\right\} \subset \Lambda_{+}^{E}
$$

where $U_{z_{0}}$ is a sufficiently small neighbourhood of the initial point $z_{0} \in \Lambda_{0}$ from Theorem 6.1.

Corollary 7.1 In a neighbourhood of the point $\pi_{E}(z)$ there exist new local coordinates

$$
(\xi(x, y, E), \eta(x, y, E), \varepsilon(E)), \quad \varepsilon\left(E_{0}\right)=0
$$

such that the singular Lagrangian submanifold $\operatorname{loc} \Lambda_{+}^{E}$ is defined by the following formulas

$$
\begin{gathered}
S(\xi, \eta, \tau)=-\left(\tau^{3} / 3+\xi^{2} \tau\right), \quad p_{\xi}=\partial_{\xi} S=-2 \xi \tau \\
p_{\eta}=\partial_{\eta} S=0, \quad \varepsilon=-\partial_{\tau} S=\tau^{2}+\xi^{2} .
\end{gathered}
$$

The Lagrangian submanifold $\operatorname{loc} \Lambda_{+}^{E}$ is empty if $\varepsilon(E)<0$. If $\varepsilon(E)>0$ then $\operatorname{loc} \Lambda_{+}^{E}$ becomes the cylinder over the Lagrangian curve " $\infty$ " shown in Fig. 1]. The graph of the phase in this case is the cylinder over the curve with two cusps shown in Fig. 2. If $\varepsilon(E)=0$ then $\operatorname{loc} \Lambda_{+}^{E}$ degenerates into an interval of the Hamiltonian phase trajectory starting at $z_{0}$.

The above transition is realized, for example, if $H=\left(p_{x}^{2}+p_{y}^{2}\right) / \rho(x, y)$, $\rho$ has a non-degenerate maximum or minimum at the origin, and $f_{h}=$ $J_{0}\left(\sqrt{(x-a)^{2}+y^{2}} / h\right), \quad a \neq 0$. In this case $\Lambda_{0}$ is the cylinder $p_{x}=\cos \phi$, $p_{y}=\sin \phi, x=a+\tau \cos \phi, y=\tau \sin \phi$. As the "source" $(a, 0)$ goes to $-\infty f_{h}$ becomes the simple wave $\exp \frac{i x}{h}$ and $\Lambda_{0}$ is the plane $p_{x}=1, p_{y}=0$. Here is the simplest example $f_{h}=\exp \frac{i x}{h}, \quad \varrho=1+x^{2}+y^{2}$ where one can get all explicit formulas. Our first figure is the dependence between $y$ (the horizontal axe) and $p_{y}$ (the vertical axe) if $x=0$. The second figure is the dependence between $y$ (the horizontal axe) and the phase (the vertical axe). The first curve is the derivative of the second one.

## 8 Glancing hypersurfaces and Lagrangian intersections

We discuss here a possible application of non transverse Lagrangian intersections to problems of diffraction by an obstacle. Let $M$ be a smooth manifold, since we are working locally, we will assume $M=\mathbf{R}^{n}$. Let $F, G$ be two smooth hypersurfaces of $T^{*} M$, intersecting transversally at $z$. Recall [12, Definition 21.4.6] that $F$ and $G$ are said to be glancing at $z$ iff the Hamilton foliation of $F=\{f=0\}$ and $G=\{g=0\}$ (locally near $z$ ) are simply tangent at $z$.

Stated otherwise, we have $f(z)=g(z)=\{f, g\}(z)=0$ (Poisson bracket), but the second Poisson brackets $\{f,\{f, g\}\}(z),\{g,\{g, f\}\}(z)$ are non zero.

By the theorem of equivalence of glancing hypersurfaces of Melrose [12, Theorem 21.4.8] there are local symplectic coordinates $(x, \xi)$ vanishing at $z$ such that $F, G$ are defined resp. by $x_{1}=0$ and $\xi_{1}^{2}-x_{1}-\xi_{2}=0$. Then $g=\xi_{1}^{2}-x_{1}-\xi_{2}=0$ will be the "normal form" of $H$ in these coordinates. (We use the notation $g$ for the normal form of $H$, or $H-E$ ).

We apply this theorem to $G$ being the energy surface $H=E$ (i. e. $g=0$ ) and $F$ an auxiliary hypersurface intersecting $G$ transversally at a glancing point $z$. We want to find some germs of Lagrangian manifolds $\Lambda$ such that $\Lambda$ is transverse to $F$ at $z$ but $(\Lambda, G)$ has glancing intersection at $z$. This means that $T_{z} \Lambda \cap\left(T_{z} F\right)^{\sigma}=\{0\}$ and $\mathbf{R} v_{H}(z)=\left(T_{z} G\right)^{\sigma} \subset T_{z} \Lambda$, where superscript $\sigma$ denotes symplectic orthogonal. Assume $n=2$ for simplicity.

Define $\Lambda$ locally near $z$ by $f_{1}=f_{2}=0$, with $\left\{f_{i}, f_{j}\right\}=0$. Consider the symmetric matrix

$$
A_{z}=A_{z}(\Lambda, G)=\left(\begin{array}{cc}
\left\{f_{2},\left\{f_{2}, g\right\}\right\} & -\left\{f_{1},\left\{f_{2}, g\right\}\right\} \\
-\left\{f_{2},\left\{f_{1}, g\right\}\right\} & \left\{f_{1},\left\{f_{1}, g\right\}\right\}
\end{array}\right)(z)
$$

and the vector

$$
B_{z}=B_{z}(\Lambda, G)=\binom{\left\{g,\left\{g, f_{1}\right\}\right\}}{\left\{g,\left\{g, f_{2}\right\}\right\}}(z) .
$$

Let $z$ be a glancing point for the pair $(\Lambda, G)$ i. e.

$$
g(z)=f_{1}(z)=f_{2}(z)=0,\left\{g, f_{1}\right\}(z)=\left\{g, f_{2}\right\}(z)=0 .
$$

We distinguish the following 10 possibilities for the 2-jets of $(\Lambda, G)_{z}$ (not covering the entire classification of [18]):

1. $\operatorname{det} A_{z}>0, B_{z} \neq 0$;
2. $\operatorname{det} A_{z}>0, B_{z}=0$;
3. $\operatorname{det} A_{z}<0,{ }^{t} B_{z} A_{z} B_{z} \neq 0$;
4. $\operatorname{det} A_{z}<0,{ }^{t} B_{z} A_{z} B_{z}=0, B_{z} \neq 0$;
5. $\operatorname{det} A_{z}<0, B_{z}=0$;
6. $\operatorname{det} A_{z}=0,{ }^{t} B_{z} A_{z} B_{z} \neq 0$;
7. $\operatorname{det} A_{z}={ }^{t} B_{z} A_{z} B_{z}=0, A_{z} \neq 0, B_{z} \neq 0$;
8. $\operatorname{det} A_{z}=B_{z}=0, A_{z} \neq 0$;
9. $A_{z}=0, B_{z} \neq 0$;
10. $A_{z}=B_{z}=0$.

We know that a general Lagrangian manifold can be parametrized in the mixed representation, so when $n=2$ by one of the following cases

$$
\begin{aligned}
(I) \Lambda & =\left\{p=\partial_{x} \phi\right\}, \\
(I I) \Lambda & =\left\{x=-\partial_{p} \phi\right\}, \\
(I I I) \Lambda & =\left\{x_{1}=-\partial_{p_{1}} \phi, p_{2}=\partial_{x_{2}} \phi\right\}, \\
(I V) \Lambda & =\left\{p_{1}=\partial_{x_{1}} \phi, x_{2}=-\partial_{p_{2}} \phi\right\} .
\end{aligned}
$$

We have
Proposition 8.1 Assume $\Lambda$ as above to be parametrized by a quadratic phase $\phi=\phi_{0}$. In Cases (I), (II), (III) $\phi_{0}$ are one-parameter families taking values:
(I) $\phi_{0}(x)=\frac{1}{2}\left(a x_{1}^{2}-2 x_{1} x_{2}\right)$;
(II) $\phi_{0}(\xi)=\frac{1}{2}\left(2 \xi_{1} \xi_{2}+c \xi_{2}^{2}\right)$;
(III) $\phi_{0}\left(x_{2}, \xi_{1}\right)=\frac{1}{2} b\left(\xi_{1}+x_{2}\right)^{2}$
respectively, where $a, b, c \neq 0$. The manifold $\Lambda$ is transverse to $F$ at $z=0$, and the corresponding matrices $A_{z}(\Lambda, G), B_{z}(\Lambda, G)$ above are then given by:

$$
\begin{aligned}
& \text { (I) } A_{z}=2\left(\begin{array}{cc}
1 & a \\
a & a^{2}
\end{array}\right), B_{z}=2\binom{-a}{1} \\
& \text { (II) } A_{z}=2\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right), B_{z}=2\binom{1}{0} \\
& \text { (III) } A_{z}=2\left(\begin{array}{ll}
0 & 0 \\
0 & 1
\end{array}\right), B_{z}=2\binom{1}{0}
\end{aligned}
$$

At last, Case (IV) does not occur.
