### Isothiourea-Catalyzed Enantioselective Synthesis of *trans*-3,4-Dihydrothiopyranones: Harnessing Thiochalcones as Original Michael Acceptors

**ABSTRACT:** Highly enantioselective formal (4 + 2)-cycloaddition between carboxylic acids and thiochalcones promoted by (+)-HBTM-2.1 isothiourea organocatalyst has been reported. The methodology relied on the generation of C1-ammonium enolate intermediates and proceeded through a nucleophilic 1,4-addition-thiolactonization cascade. It enabled the stereocontrolled preparation of sulfur-containing  $\delta$ -thiolactones in good yields, moderate diastereoselectivity and excellent enantiomeric excess (up to 99%). This annulation benefited from the peculiar reactivity of uncommon electron-rich thiochalcones used as Michael acceptors.

Chiral dihydropyranones constitute a class of heterocycles that have attracted particular interest due to their occurrence in pharmaceuticals as well as in precursors of natural products.<sup>1</sup> Because of their importance, many efforts have been devoted to their efficient catalytic enantioselective synthesis.<sup>2</sup> Surprisingly, the asymmetric access to dihydrothiopyranones - their sulfur-containing analogues – has been scarcely investigated. despite their promising biological activities.<sup>3</sup> To date, only one enantioselective methodology has been proposed by Biju et al. in which N-heterocyclic carbene promoted (3 + 3)-annulation between 2-bromoenals and β-oxodithioesters providing dihydrothiopyranones in high enantioselectivities (Scheme 1a).<sup>4</sup> Therefore, the development of a novel stereocontrolled synthetic route for the construction of dihydrothiopyranones is still highly desirable and meet our longtime interest in the asymmetric synthesis of heterocyclic scaffolds.<sup>5</sup>

To achieve this goal, we turned our attention to a class of Lewis base, chiral isothioureas (ITUs), popularized by Birman,<sup>6a</sup> Romo,<sup>6b</sup> Porco<sup>6c</sup> and Smith,<sup>6d</sup> which have recently emerged as privileged organocatalysts for the enantioselective activation of carboxylic acids.<sup>7</sup> Catalytic event typically starts with the condensation of chiral ITU with carboxylic acid derivative, resulting in the formation of various reactive intermediates such as acylisothiouronium salt or acylisothiouronium enolate (Scheme 1b) that have a wide range of synthetic applications.<sup>8</sup> In particular, the latter zwitterionic species, displaying a nucleophilic site and a latent electrophilic site, has found broad utility in a variety of enantioselective transformations including formal cycloadditions.<sup>7,8</sup> Recently, the group of Smith and others have disclosed elegant enantioselective Michael additionlactonization/lactamization cascades with  $\alpha,\beta$ -unsaturated enones and imines providing efficient access to dihydropyranones and dihydropyridinones with excellent dia- and enantioselectivities (Scheme 1b).<sup>9</sup> Inspired by these seminal works, we wondered whether thiochalcones could react as suitable partners in a similar cascade reaction in the presence of an ITU catalyst. This would offer a direct and convenient approach for the enantioselective synthesis of targeted dihydrothiopyranones.

However, developing such transformations with this thionated substrates is challenging. First, they are relatively more electron-rich and thus significantly less reactive compared to Michael acceptors commonly used in that kind of methodologies including trihalogenomethylenones<sup>9c,e</sup> or  $\alpha$ -keto- $\beta$ , $\gamma$ -unsaturated phosphonates.9d In addition, although the use of thiochalcones as heterodienes in Diels-Alder reactions has been extensively studied by the groups of Motoki, Saito, Mlostoń and others,<sup>10</sup> their involvement in other cycloadditions – notably as dipolarophiles<sup>11</sup> or dienophiles<sup>12</sup> – is relatively new and remains elusive. Eventually, thiochalcones 1 cannot be isolated as monomers because they spontaneously dimerize to generate complex mixtures of thia-Diels-Alder adducts in which 3,4-dihydro-2*H*-thiopyrans 2 and 3,4-dihydro-1,2-dithiines 3 are the major isomers (Scheme 1c).<sup>12</sup> Hence, concentration of active monomeric thiochalcone is low rendering the overall cascade process ambitious when combined with the reversibility of the ammonium enolate formation.8b

Herein we report an isothiourea-catalyzed formal (4 + 2)-cycloaddition of carboxylic acids with thiochalcones, affording a variety of dihydrothiopyranones in good yields with high enantioselectivities and moderate to high diastereoselectivities (Scheme 1d). Encouragingly, reacting thiochalcone 1a with an anhydride, generated in situ from 2-phenylacetic acid (4a) and pivaloyl chloride, in the presence of (+)-HBTM-2.1 (5a, 10 mol%), *i*Pr<sub>2</sub>NEt and Na<sub>2</sub>CO<sub>3</sub> in dichloromethane at room temperature provided desired dihydrothiopyranone 6a in 21% yield and 89% ee (Table 1, entry 1).<sup>13</sup> Diastereoselectivity of the reaction was difficult to determine due to <sup>1</sup>H NMR signals overlapping. However, a 5.5:1 dr was roughly estimated in favor of the transisomer. The cascade remained sluggish even when an excess of carboxylic acid was used (entry 2). In order to increase the concentration of monomeric thiochalcone form, 5 equiv of 1a was employed and it resulted in dramatically enhanced yield (74%, entry 3). It is noteworthy that 77% of the excess of 1a could be cleanly recovered through silicagel column chromatography. After screening other solvents such as acetonitrile, THF or toluene (entries 4-6), CH<sub>2</sub>Cl<sub>2</sub> proved to be the best one in term of yield and enantioselectivity. Then, we speculated that increasing reaction temperature might favor the overall process by shifting the equilibrium toward the formation of the active monomeric thiochalcone species. However, conducting the reaction at 50 °C in 1,2-dichlorethane (entry 7) markedly decreased the yield of 6a presumably due to its degradation. Reducing the catalyst loading to 5 mol% could also give a reasonable yield (entry 9). Changing the catalyst to (-)-BTM (5b) delivered the desired product in lower yield and enantioselectivity (entry 8). Further optimization revealed that Na<sub>2</sub>CO<sub>3</sub> had no visible impact on the transformation (entry 10). Contrary to other ITUcatalyzed reactions, the use of a catalytic amount of HOBt had no positive influence on the stereocontrol.14

With the best conditions in hand, we next explored the scope of the isothiourea-promoted Michael addition-thiolactonization cascade by using diverse carboxylic acids (Scheme 2). Levels of enantioselectivity were generally satisfactory but diastereoselectivity was variable (4:1-9:1 dr).

Electron-depleted substrates were tolerated, delivering the dihydrothiopyranones in decent yields. Pleasingly, phenylacetic acids with meta-halogenoaryl groups afforded the desired adducts **6b** and **6c** in respectable yields and enantioselectivities. A slight increase in the enantioselectivity was observed with 3bromo-substituted thiochalcone (6d, 91% ee). 4-(Trifluoromethyl)phenylacetic acid (4e) reacted also well leading to 6e in slightly reduced yield and ee in line with what had been depicted in previous publications.<sup>9b,c</sup> Carboxylic acids substituted by electron-rich arenes such as 4-methylphenyl and 4-methoxyphenyl were smoothly converted into the corresponding dihydrothiopyranones (6f and 6g) in good yields, enantio- and diastereoselectivities. Acid 4h bearing more sterically demanding benzo[d][1,3]dioxole provided the desired product **6h** in 82% vield with 91% ee and 5:1 dr. Finally, the reaction with a carboxylic acid substituted by an alkene group,<sup>9e</sup> gave **6i** in excellent yield and enantioselectivity albeit with a moderate dr.

The scope of Michael addition-thiolactonization sequence between 2-phenylacetic acid (1a) with various thiochalcone derivatives was also surveyed (Scheme 3). The electronic properties of the C1-aryl ring did not greatly affect the stereoselectivity and had a little effect on the yield. For instance, thiochalcone 1b with para-trifluoromethyl moiety on the aromatic substituents led to dihydrothiopyranone 6j in 71% yield and 87% ee. Electro-enriched thiochalcones, which preferentially adopt the most stable dimeric form (3,4-dihydro-2H-thiopyran, 2), and are consequently less prone to retro-cyclization,<sup>12</sup> underwent cycloaddition to give 6k-m in satisfactory yields (40-88%) with high enantio- (89-99% ee) and diastereoselectivities (up to 8:1 dr). Similarly, heterocycle-containing 3-phenyl-1-(thiophen-2-yl)prop-2-ene-1-thione  $(1f)^{10d}$  – a substrate that had been proven challenging in some earlier cycloadditions -12 provided product 6n in 57% yield and 68% enantiomeric excess. Thiochalcone 1g, with 4-bromophenyl ring as the C3-substituent, was also a suitable partner, giving dihydrothiopyranone 60 in 65% yield and 82% ee. The absolute configuration of 6e (3S,4R) was established by X-ray crystal-structure analysis. That of the other compounds reported herein were assigned by analogy.

To demonstrate the robustness of the protocol, a scale-up reaction was performed with a reduced amount of thiochalcone. As shown in Scheme 2, cycloadduct 6g was obtained in a slightly lower yield with a maintained 96% enantioselectivity. The synthetic utility of dihydrothiopyranones 6 was demonstrated by several modifications (Scheme 4). Base-mediated methanolysis of 6g provided unstable thioenol intermediate 7. Subsequent acetylation with acetyl chloride furnished isolable product **8** in good yield without any erosion of enantioselectivity (Scheme 4a). However, decrease of the diastereoselectivity was noted. In addition, subjecting allylic product **6i** to an excess of base led to the thermodynamically-favored isomer **9** (Scheme 4b) in moderate yield but retained enantiomeric excess.

To gain further information about the mechanism of the reaction, some control experiments were carried out. First, the evolution of the equilibrium between 3,4-dihydro-2*H*-thiopyran **2** and 3,4-dihydro-1,2-dithiin **3** thiochalcone major isomers was monitored for a period of 4 hours via <sup>1</sup>H NMR analysis. The fraction of most stable dimer **2** slightly increased over the time at the expense of adduct **3**. Moreover, **2**\**3** ratio was not affected by the addition of 1 equiv of *i*Pr<sub>2</sub>NEt or 10 mol% of catalyst **5a** suggesting they had no influence on this equilibration (see the Supporting Information).

Noteworthy, no cycloaddition occurred when *trans*-1,3-diphenylprop-2-en-1-one (chalcone, **10**) was used as the Michael acceptor under optimized conditions, highlighting the peculiar properties of our sulfur-containing conjugated substrates (see the Supporting Information). Ultimately, the diastereomeric stability of dihydrothiopyranones was examined by treating **6g** with an excess of *i*Pr<sub>2</sub>NEt. Its dr remained unchanged, which indicates that no epimerization occurs during the cascade reaction (for further details see the Supporting Information).

Based on earlier studies disclosed by Smith *et al.* and results obtained above, a plausible mechanism is proposed in Scheme 5.<sup>9c</sup> Addition of nucleophilic ITU catalyst to mixed anhydride **A** generated *in situ*, leads to acylisothiouronium cation **B**. Its subsequent deprotonation/enolization affords the chiral zwitterionic (*Z*)-acylisothiouronium enolate  $C.^8$  The latter undergoes a stereoselective Michael addition on monomeric thiochalcone **1** released, at low concentration, in the reaction mixture from its 3,4-dihydro-2*H*-thiopyran **2** and 3,4-dihydro-1,2-dithiin **3** dimeric forms by a retro-Diels-Alder reaction. Afterward, the obtained Michael adducts **D** cyclizes to furnish desired thiolactone derivative **6** with concomitant regeneration of catalyst **5a**.

The asymmetric induction can be explained using the classical rationale developed for chiral ITUs and supported by DFT calculations. Stabilizing non-covalent O–S interaction ( $n_0$  to  $\sigma_{\rm C}$ s<sup>\*</sup> overlap) locks the conformation of acylisothiouronium enolate **C** orienting the phenyl group of the ITU in a pseudoaxial position which shields its *Si*-face.<sup>15</sup> The stereoselectivity of the reaction can be then predicted using a Heathcock's model<sup>16</sup> with staggered conformation minimizing non-bonding interactions.<sup>17</sup>

To conclude, a mild enantioselective synthesis of *trans*-dihydrothiopyranones promoted by isothiourea organocatalyst has been developed. It provided optically active  $\delta$ -thiolactones in decent to good yields, moderate diastereoselectivity and high enantiomeric excess using carboxylic acid and thiochalcone building blocks. The latter Michael acceptors are singularly electron-rich which is unprecedented in such *C*1-ammonium enolate 1,4-addition-lactonization cascade, underlining the unique properties of thiocarbonyl derivatives. The cycloaddition could be easily scaled-up and the obtained adducts was opened thanks to a transesterification reaction.
