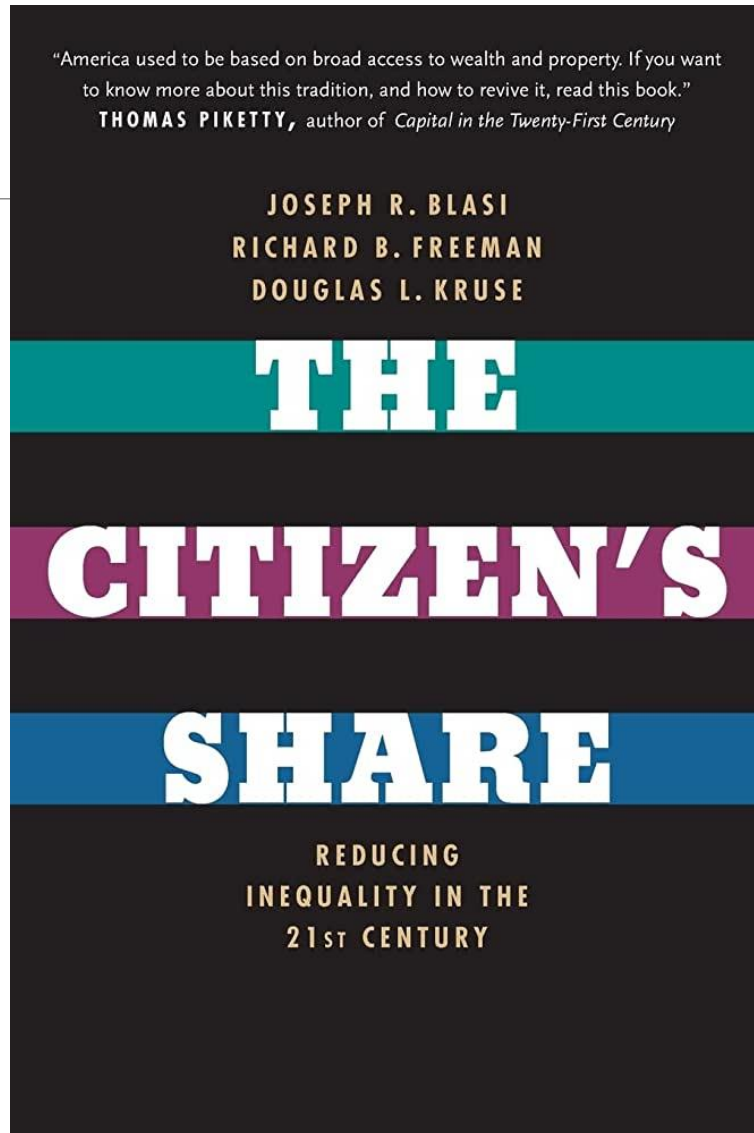

# SDGs affected by employee ownership



- Increased corporate performance
- Better workplace outcomes



- 30% ownership of US companies => 10% decreased Gini coefficient (Dudley & Rouen, 2021)



- ESO can address race, gender income and wealth gaps
- ESO contributes to asset building of households

# The case

---

## ➤ **The company**

- A manufacturing company (construction, renovation/infrastructure and mobility) founded in the 1665 with presence in 75 countries.
- The company employs more than 166,000 people
- €44.2 billion in sales
- 3 out of 4 employees work outside France.
- 2 employee directors and 1 employee representing the employee shareholders (21% of the board)

## ➤ **Employee ownership**

- Employees hold 8% of the company's stocks and they are the first shareholder
- 60.000 employees have shares
- First ESPP in 1988 and one offered every year since then
- The % of shares held by employees, % of employees and the number of countries participating are indicators related to SDG 8 and to the the global reporting initiative 401-2
