### Highlights

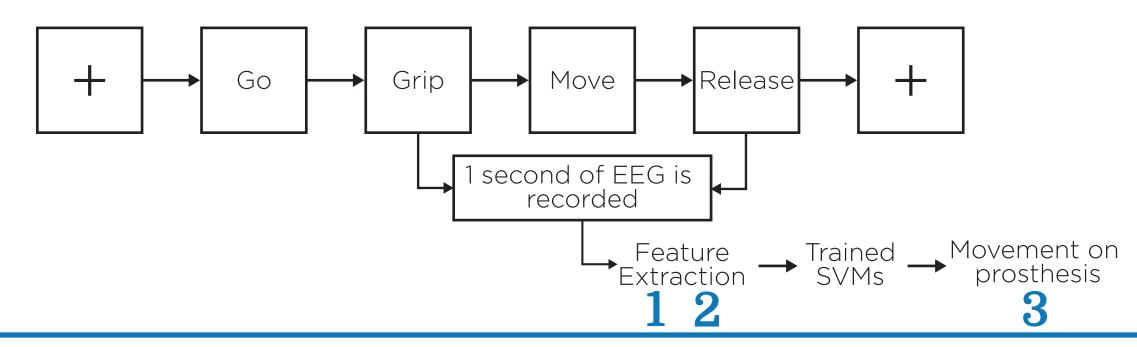
- The implementation of a finite-state machine design on the control of the prosthesis led to an increase in the classification performance on both the able-bodied and the amputee while simplifying the decision-making process after the classification.
- In real-time control, able-bodied subjects obtained higher performance compared to the one amputee, it could be due to the difference in EEG systems used with the groups (64 ActiCHamp vs. 16 electrodes OpenBCI).
- The sensory feedback system did not improve the classification performance in able-bodied and for the amputee.

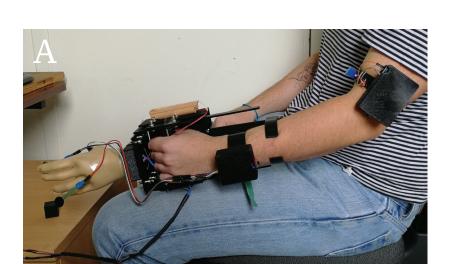
#### Background

- The goal of developing a Brain-Machine Interface (BMI) control system for medical prosthetics is to provide robust, comfortable and easy-to-use devices for the concerned user. They need to be fast and have high performance in estimating the user's intention in real-time.
- Yet, the transition from offline to online settings often proves to be challenging (Deo et al., 2023), with a drop in performance when testing the BMI system in the latter.
- In the literature, there are numerous examples of methods and techniques aimed at targeting this issue, here applied to the control of a prosthetic hand.

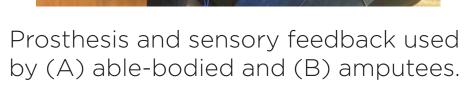
#### Methods

- Real-time control has been performed with amputees and able-bodied subjects during two sessions without and with the use of a sensory feedback device provided by a vibrating bracelet.
- The experiments consisted in doing a sequence of Grasping-Moving-Releasing three objects, using a modified Myobock® prosthesis controlled by EEG data.
- The effect of three different methods of feature extraction and decision-making process was tested on the online control performance and compared to the offline. B

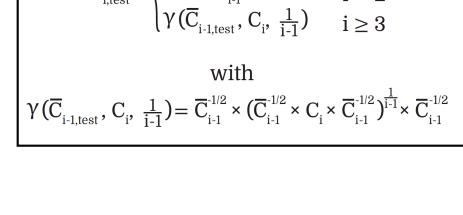


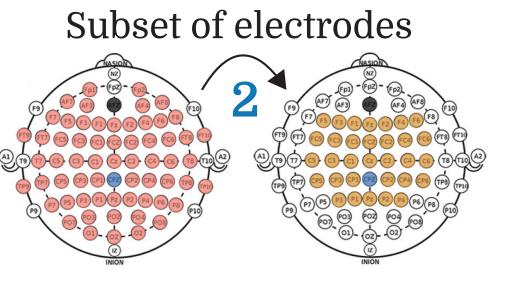




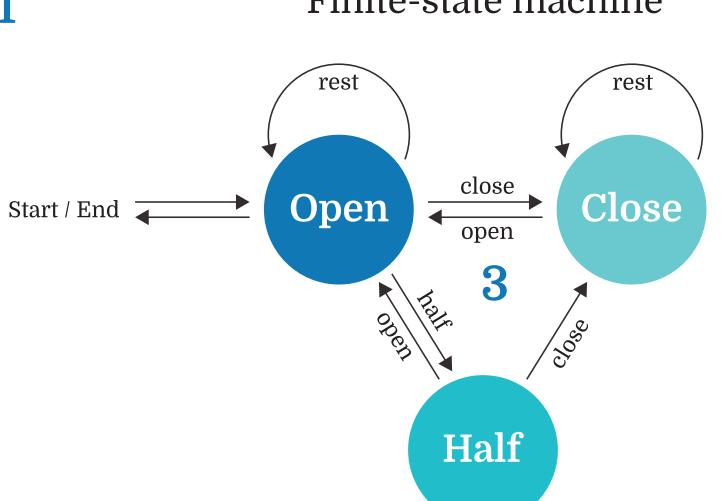

### The use of the finite-state machine design can improve the performances during the grip and release phases for the two groups

While the best performances were obtained with finite-state machine for the BB (Box&Blocks) & CS (Clothespin) objects, results are more nuanced with the CUP.

### Participants were performing better during the release phase compared to the grip phase

The Riemannian feature extraction pipeline, the alignment method and the selection of a subset of electrodes all increased this difference for able-bodied while only the Riemannian pipeline did for the amputee.

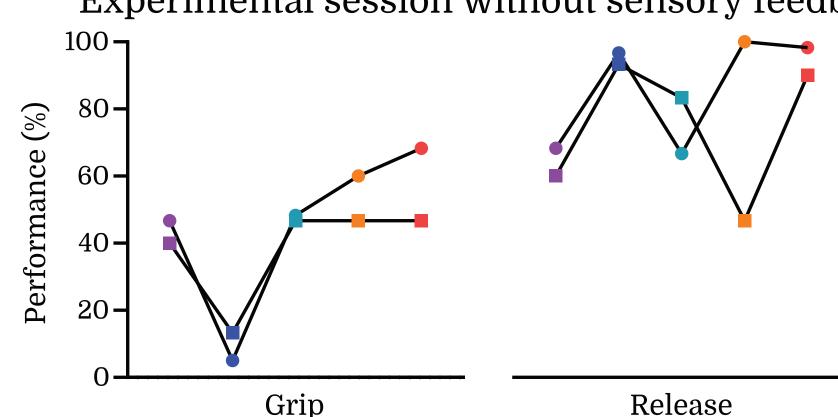

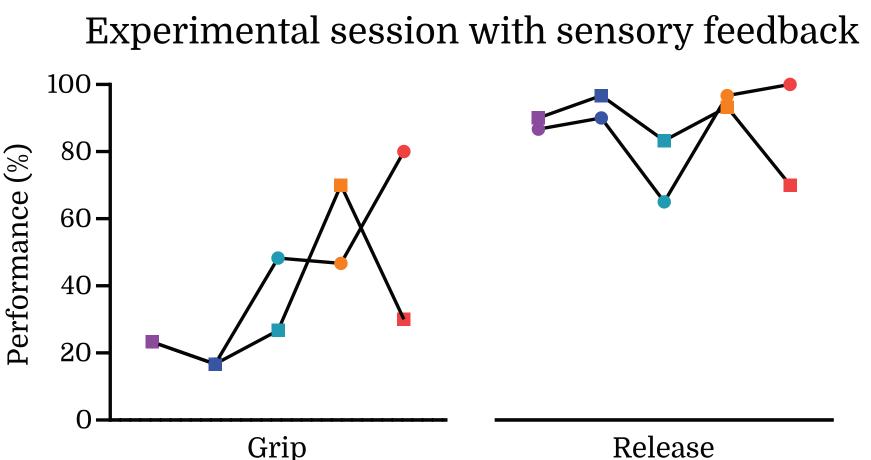

#### Conclusion

- Online classification performances were obtained with 19 able bodied and 1 amputee subject who controlled the modified Myobock prosthesis by using the EEG data recorded in real-time and compared to the performances obtained offline.
- The effect of two different feature extraction methods and of a new decision-making process on the classification performances were studied for the same classification algorithm (SVM RBF and TS-SVM).
- The decoding of object release is always better than the object grip with both able-bodied and amputee subjects for all different combinations.
- Using a Feature Extraction method based on Riemannian Geometry and alignment of covariance matrices, and a Finite-State Machine design as decision-making process in online allows to reach classification performances obtained in offline except for the CUP object.
