Interdisciplinary approaches to water in the Roman world

Abstract

Water resource management refers to the process of planning, developing, and managing water resources across uses. Understanding how the Romans approached the management of water resources is crucial to our understanding of the functioning of Roman society, not least from the point of view of the agricultural economy, urban development, trade, industry, and leisure. Just as modern societies, the Romans faced numerous challenges concerning the effective and continuous distribution of water, the management of waterways for transport purposes, and, when disputes arose, how best to balance competing interests. Though much has already been written individually on these topics, there remains considerable scope for research into the Roman approach to these issues from a holistic perspective. This volume therefore introduces a series of studies from a cross-disciplinary point of view, that includes contributions by archaeologists, geomorphologists, historians, and jurists, with a view to understanding how Roman technical, social, and legal solutions worked together to produce systemic results.

The contributions to this special issue of *Water History* were first presented at a workshop held at the University of Edinburgh in late summer 2019¹. The idea for the workshop was conceived in Budapest in 2018, at the Ottoman Rudas Baths. In those historic surroundings, perhaps not unlike the Roman baths in many respects, the editors discussed the potential and pitfalls of approaching the management of water resources in the ancient world from a cross-disciplinary perspective. The potential for such an approach is evident: the strong imprint of waterways and water management systems in the historical record provides a solid foundation for research in this direction, with a variety of archaeological, epigraphic, literary and legal sources each contributing to a rich and diverse evidential base. At the same time, the opportunities presented by a relative abundance of evidence give rise to methodological challenges, particularly concerning the integration of the interpretation of these sources into a coherent whole. Born out of a conviction that by interdisciplinary collaboration, greater and more penetrating insights can be achieved, this issue brings together contributions that aim to make progress toward producing a holistic account of water and waterway management in the Roman world.

In addition to a fertile evidential base, the choice of water and waterways as a topic for research is informed by the centrality of water and its distribution infrastructure to ancient life in all its aspects. This much is, of course, a trite observation: what is more important is to analyse the particular ways in which water was supplied to where it was needed and, in cases of shortage or conflict, how the interests of those affected were balanced against one another. In this connection, just as much as the technical solutions that enabled both travel on water and its supply in great quantities in support of agriculture (by means of irrigation), urban

development, trade, industry, and leisure, provide us with an insight into the physical infrastructure that promoted mobility and communal life, so too the human context – the social, political, legal, and economic framework – within which persons interacted in relation to water resources deepens our understanding of all these processes. Only by bringing together specialists in different fields, from jurists to archaeologists, geomorphologists to historians, can the full range of issues be properly and thoroughly explored.

Evidence requires to be interpreted in its proper context. Literary texts and inscriptions, for example, tend to focus mostly upon water resource management in a public context. Due to the nature of the texts that have survived, we have a greater insight into large projects led by public authorities than the day-to-day management of water on estates or in workshops². The most significant exception is, of course, the treatises of the Roman agronomists, who provide practical advice concerning the irrigation and drainage of agricultural land cultivated in the context of the villa economy (Willi 2021, pp. 113–178). Administrative documents, such as the texts produced in the context of the *cura riparum et* alvei Tiberis, the cura aquarum at Rome, and in municipal charters³, all contribute to our understanding, in both an Italian and provincial context. Archaeological findings, too, are essential in demonstrating the implementation of technical solutions. In recent years, complementing the traditional approach of studying built infrastructures, the application of scientific techniques to the analysis of archaeological materials has allowed substantial improvement in our understanding of wet areas and river environments. Our knowledge of the highly strategic network of rivers, man-made canals and port installations, of the functioning of ancient deltas, and of the influence of ancient environmental conditions on the development of water technologies, has also greatly benefited from the development of paleoenvironmental studies (for example Goiran et al. 2014; Sürmelihindi 2018; Pleuger et al. $2019)^4$.

Finally, Roman legal texts provide a rich source of insights into the legal, social and economic framework that structured the relationships between individuals in their exploitation of the natural environment. Given the importance of water and waterways to ancient life, particularly in the context of an agricultural economy, it is little surprise that these were the subject of legal innovation from the earliest stages of the city's development. In addition to the remedies referred to in the XII Tables (fifth century BCE), that protected the rights of landowners to water emanating from or running across their neighbour's property, the intervention of magistrates during the late Republic and the writings of the classical jurists through to the Severan age together comprise a substantial body of legal material concerned

among other things with the management of water resources⁵. Handling these texts, however, requires sensitivity, not only to the particular intellectual context in which juristic discussions took place, but also when considering the complexity of law in practice in the ancient world, which was characterised by a form of legal pluralism (especially in the Roman provinces)

As one of the foundations of the city's civil law, the writings of the classical Roman jurists have been studied intensely by Romanists for many centuries, though principally from a legal perspective. In a review article published in 1986, F. MILLAR observed that:

"...legal writers, so central both to the character of Roman culture and (obviously enough) to the 'legacy of Rome', have attracted extraordinarily little attention from Classicists, from students of Roman historiography or even from ancient historians, for whom this gigantic body of material represents, or ought to represent, an almost inexhaustible treasure-house of economic and social history, and of ideologies, conceptions and attitudes. What proportion of the total of surviving Classical Latin prose is represented by the million-odd words of the Digest, the earlier rescripts of the Codex Justinianus, the other remains of pre-Justinianic legal writing, and by the key text of them all, Gaius' Institutes?" (Millar 1986, p. 272).

The approximate answer to this question, posed before the advent of digitisation, is that juristic writings comprise about 11–12 percent of the extant corpus of classical Latin literature through to the end of the Severan period, and an even greater proportion if the search is limited to Latin prose.⁶ In addition to this, Ulpian (early third century CE), of whose writings about 300,000 words have been preserved, is only outstripped by Cicero (c. 1 million words) and Livy (c. 500,000 words) in terms of the volume of material that has survived of their works⁷. Though it is certainly the case that, since the 1980s, classical juristic texts have attracted greater attention outside of law schools, not least from those interested in the relationship between law, society, and economy in the Roman world, the 'treasure-house' remains far from exhausted (Du Plessis et al. 2016; Dari-Mattiacci and Kehoe 2020)⁸. One of the central aims in organising this conference was therefore to promote the interpretation of this evidence alongside more familiar sources, as a way of approaching the activities central to ancient life from a multiplicity of different perspectives⁹.

In this regard, the topic of water and waterways offers promising avenues of research. Water continuously moves above and beneath ground. The benefits it provides and the problems it can pose are experienced in a wide range of human activities. In addition, different uses and needs generate different perceptions of the resource itself. A fisherman's perception will differ from a boatman's, a peasant's from a craftsperson's, because they make different, and sometimes competing, uses of it. They do not necessarily need it at the same moment or in the same season. Some use it as a resource (e.g., for irrigation, leisure and industry), others as an environment for navigation and fishing. At the same time, one person's activities could interfere with those of the others, generating competing interests and potentially conflict between them. In each case, solutions had to be developed at a technical, social, and legal level.

The first contribution to this journal issue focuses upon the Roman *suburbium*, which well epitomises the crossroad of economic and social interests in the context of water use. However loosely delimited the area is for us, it is noted for its very dense human occupation by both living and dead, and for being an environment where the pressure on the natural resources was high (Goodman 2007). Land and water make no exception in this regard, due to the needs for housing and proximity of the urban market, on the one hand, and to the recreational uses of water and intensification of agriculture, on the other. In this specific context, CYNTHIA J. BANNON argues that a series of 1st and 2nd c. AD epitaphs show that legal rights to conduct water to tomb gardens could be economically valued, whether it came from a private plot (servitude) or from the public hydraulic network (concession). If funerary rituals required a certain amount of water, as well as the display of fountains and basins in the most luxurious resting places, the mention of water rights in language familiar to Roman private law shows that sizeable plots could also be commercially farmed.

Bannon's contribution also raises important questions concerning the interpretation of legal language in different evidential contexts. While juridical language in epitaphs is relatively common, it does not always correspond to the position set out in the legal sources. In some cases, the use of legal terminology probably aimed at impressing passers-by as well as potential litigants. The understanding of private law among Romans was likely as diverse and uneven as it is among citizens today, making the interpretation of legal terms in private inscriptions a delicate matter. In cases like those presented by Bannon, the use of legal language must be understood in the context of a discourse between the author of the text and its readers.

Turning inward toward the city centre, the model of the "consumer city" has long held an important place in the conception of ancient urban development¹⁰. This view is discussed and challenged by ELENA SÁNCHEZ LÓPEZ who examines the profusion and large range of productive activities in Roman towns. The current re-evaluation of cities as centres of production also provides scope for a reappraisal of the use of natural resources in this context¹¹. In this regard, questions remain concerning the large number of urban workshops

that needed water, sometimes in significant quantities. Indeed, both the construction sector and the manufacturing of everyday items, such as pots, clothes, leather or metal artefacts, required significant amounts of water. Insights into the way in which workshops met this challenge are provided not only by the archaeological evidence, but also by rental contracts preserved in the Graeco-Egyptian papyri.

Though it has been rightly pointed out that such workshops could use private and selfsufficient supply systems, like wells or rainwater reservoirs, archaeologists also suspect that connection to urban aqueducts was a solution favoured by many workshops, as appears to have been the case in Pompeii. Concessions from the public distribution network have long been associated with the *luxuria* of private homes, where gardens were adorned by refreshing fountains and brooks (Dessales 2013). Texts from the *Digest*, however, along with later imperial constitutions and Frontinus' treatise on the administration of Rome's public aqueducts all refer to such concessions being granted for *privati usus*, an expression that includes workshops and business premises. Such cross-reading of the legal and archaeological documentation clearly demonstrates that the water derived from the public network was used in workspaces and that both the role of public aqueducts and the amount of water required by productive businesses must be re-evaluated from this perspective.

It is perhaps because aqueducts were prominently associated with the supposed luxuria of urban life, in the reconstructed model of a consumer city, that the usefulness of public distribution networks has frequently been questioned. CARLOTTA FRANCESCHELLI argues that archaeology can help nourish this debate, by considering every element of the water supply system in the urban space. The argument is made out by carefully weighing the archaeological remains, in the Italian city of Ostra in the Marches, against the legal documentation. In this municipium of the Ager Gallicus, different sources of water were used in complementarity. While the city could advantageously tap into the shallow water table, it is also assumed that a public aqueduct (not yet uncovered) was fed by the aquifers of the Apennine ridge, and by springs on the nearby valley slopes, admittedly with seasonal variations. A specific feature of the hydraulic network of Ostra, however, is the large circular reservoir thought to have collected the wastewater from the nearby baths. Wastewater could in turn be utilised by artisanal activities that did not require clean water. Franceschelli suggests that this form of recycling could be correlated with the "aqua caduca" mentioned by municipal laws in Rome and in Spain, and whose legal status is not yet established. Such a system of water recovery must be replaced within the general observation, made elsewhere in the Roman world, that the construction of urban aqueducts was less related to a demographic surge than to a change of lifestyle, illustrated by sanitation infrastructures, the comfort and pleasures associated with large baths complexes and running water available in the public fountains.

The exploitation of water as a natural resource has both a geographical dimension, that can be the city as a whole, or a portion of it, like the peri-urban necropolises, and a temporal dimension, firstly because water is continually running, but also because it is very likely that its availability was in many cases seasonal. Though an important factor in the context of a resource in constant motion, the temporal dimension leaves little trace in the archaeological remains. As COSIMA MÖLLER shows, however, legal texts are very informative on this particular aspect of water management.

As we know from inscriptions related to so-called "irrigation communities", but also from the *Digest*, time was used as a unit to share a same source of water between different

users, and generally to solve distribution problems in case of pressure on resources¹². Time also matters from the point of view of legal rights to draw water, since continuity is a necessary condition for exercising such a right and non-use leads to the loss of it. On the other hand, despite a long-lasting controversy between Roman jurists, the use of water from a neighbouring plot could be legally protected after a certain period of time, even though it had not been rightfully granted. In both cases, juridical texts show how continuity, from a legal perspective, refers to a right to continuously use the water, more than as an actual use of it. Roman law therefore protected the opportunity to exercise a right, as much as it protected the right itself, something that cannot be detected through archaeological investigation but that can help us to better understand the functioning of hydraulic structures¹³.

If the exploitation of water resources could generate conflicts, waterways also generated opportunities for competition. Firstly, they could be used as reservoirs, from which water would be drawn by water-lifting machines or conducted by artificial canals. Then, they could also be used not only as a source of waterfowl or fish but probably more crucially for the ancient economy, as an essential channel of communication and trade. All these aspects had to be managed with a delicate balance between opportunities and risks, whether it be prolonged low-water periods or rising floods. Fluvial dynamics also proved to be a challenge wherever estuary areas were the place of intense trading activities. Silting could hamper navigation, and in some cases slow down trade. For economic, but also social and even political reasons, like in the case of Rome itself, which relied greatly upon imports to feed its population, solutions had to be developed both at the technological and legal level.

Due to their strategic and economic importance, rivers were also the object of much attention. As M. J. CASTILLO PASCUAL argues, their navigability, in particular, was a determining factor of the trade relations between newly-conquered regions and Rome, and therefore of the organisation of such territories, their network of roads, the location of their urban centres and even their administrative divisions. The river Baetis (modern-day Guadalquivir) proves, however, to be a complicated case study. Not only did its watercourse change a lot through time, particularly at its estuary due to silting, but its alluvial plain also experienced heavy anthropisation over a long and continuous period of time, leading to major transformations in the landscape. Today's river course offers therefore only very limited help in reconstructing the ancient route. To address this shortcoming, Castillo Pascual argues that the layout of the Via Augusta, fairly well-documented for parts of its route, provides valuable information with which to reconstruct the course of the ancient river. Based on examples in other parts of the peninsula, the author suggests that the road was complementary to the river. Using literary texts in combination with the results of geoarchaeological studies and the location of settlements and pottery workshops thought to have been situated along the waterway, Castillo Pascual proposes a reconstruction of the most controversial stretches of the river and the conditions of its navigability. Castillo Pascual's conclusion is that the estuary area of Roman Baetica was organised so as to overcome the natural obstacles thrown up by the fluvial dynamics of the region, by creating a road and river communication axis, principally for economic reasons.

Agricultural and mining products were indeed fundamental assets of the province. The foundation of colonies arguably had a similar geostrategic dimension, whereas it has traditionally been regarded as a demonstration of strength. It is thus argued that the *Colonia Iulia Romula Hispalis*, founded by Julius Caesar, was conceived as a hub of road and river communications. The example of the Baetis therefore appropriately illustrates the solutions deployed to mitigate the effects of a fast-changing fluvial landscape, at the level of a province. It interestingly complements our knowledge of such risk management measures at the individual level, where private riparian property owners could resort to the legal solution of alluvion to remedy the threat posed by fluvial instability, which doctrine was developed by jurists and applied by land surveyors (Masi Doria 2004; Chouquer 2008).

Geoarchaeology enables us to better understand the influence of sedimentological and geomorphological river dynamics on harbour infrastructures and on the urban fabric of harbour cities. However, geoarchaeological studies on fluvial risk have so far been mostly focused on floods and adjustments to water levels, and much less on lateral mobility (i.e. width changes and lateral migrations of the river bed), whereas ancient texts show that this issue was well-known in the Roman world¹⁴. On this theme, SALOMON ET AL. demonstrate that the orientation of archaeological structures in the port cities of Ostia and Portus was dependent on the river channels and the man-made canals serving the estuary area, although in different ways. While Ostia's history dates back at least to mid-republican Rome, the colony always had to adapt and adjust to the high sedimentation rate in the estuary area. At the beginning of the 2nd c. AD, the expansion of Portus was planned in anticipation of fluvial sedimentation. Study of the core deposits and analysis of the orientation of the archaeological features show how town-planning and building in Ostia were affected by sediment deposition and lateral mobility of the river channel. The evolution of the city of Ostia can only be understood against the backdrop of its fluvial context, and the same can be said about the relationship between the two city-harbours: the design of the waterways system at Portus drew upon the experience of silting, flooding, and riverbed mobility at Ostia.

This study, and others conducted by the same team, is crucial to understanding literary texts dealing with the silting of the Tiber mouth, the difficulties posed by the construction of a harbour in Ostia and of the network of canals, roads, and towpaths¹⁵. More strikingly, the results presented here plainly show the engineering efforts, as well as the investment in work and capital, made by Roman authorities in the Portus-Ostia area, to address the risk and to continue operating ports that were key to importing goods to the capital city at the lowest transportation costs possible.

Because fluvial transport was the most cost-effective means of transport for goods, navigability was a defining aspect of rivers. It could however often clash with other compelling needs, like the access to the banks and towpaths, or the possibility to get water for the irrigation of riverside cultivation areas, which were many around large urban centres. Roman jurists fully took into account this plurality of interests, and the texts from the *Digest* show that water was not only considered as a natural resource, but as an environment too. LAURETTA MAGANZANI therefore reminds us that river management carefully addressed the

fact that waterways could simultaneously constitute a valued resource and a major risk to human activity. Focusing on the *actio aquae pluviae arcendae* (action to ward off rainwater) Manganzani argues that this action could be used to prevent possible damage caused by overflooding rivers.

The economic importance of rivers, together with the variety of issues at stake, explains the number and diversity of legal rules applicable to their management. Whether it was necessary to develop solutions to address shortage and periods of low water, or floods, waterlogging, and fluvial mobility, legal remedies also went some way to addressing the risk. Risk results from the combination of a natural hazard, like a river overflowing, with the vulnerability of human assets, *i.e.* activities developed on the banks (Burton et al. 1978; Beck 1986; more specifically on flood and fluvial risks, see Vinet 2017a, b; Reghezza-Zitt 2019). The hazard becomes a disaster when the risk is being realised. Although there is nothing certain in the magnitude and frequency of a natural disaster, the exposed population is nevertheless able to evaluate the possibility that it might occur at some point. Similarly, legal solutions are developed to settle conflicts no one can know for sure with what frequency and magnitude they will break out. However, those concerned know from experience it is most likely that they will. Legal solutions, like risk management measures, are based not on the prediction of a damage (when, where and how it will happen), but on its anticipation. In this context, legal solutions can be understood as elements of the set of solutions available to communities and individuals to manage and mitigate the risk, alongside technological or social responses. That the Roman jurisprudence was developed in some ways to address natural risks is confirmed by the number of dispositions that could be applied, not only as a remedy or as a compensation for a harm done, but in anticipation of this damage, like the actio aquae pluviae arcendae.

The approach of past societies to water resource management, particularly in the archaeologically rich Roman context, has become a focal point for historical research. In many respects, the challenges facing the ancients were similar to those facing modern societies today. The solutions that the Romans developed, ranging from technical interventions into the natural environment, to social accommodations and the development of a legal framework, combined to produce a working system capable of meeting these challenges and to accommodate different uses of water, Roman and indigenous (Wilson 2012; Leone 2012). As the contributions collected in this volume show, a full appreciation of the Roman's approach to water resource management is only possible through a dedicated interdisciplinary approach, capable of explaining how interventions of different kinds reached a high degree of sophistication in their systemic interrelation.
