TRAJECTOIRES ET ORIGINES

BACKGROUND

- Demographic behavior is influenced by the surrounding context
- Information about the context in which people live is increasingly important in understanding demographic phenomena (Caporali et al., 2016)
- National -sometimes regional- macro indicators are commonly used in demography
- ► Eg: Fertility: Campisi et al. 2020, Nisén et al. 2020
- Studies integrating a finer contextual perspective are rarer
- ► Eg: Alcohol-related mortality and suicide: Winkleby et al. 2006, Martikainen et al. 2004, Agerbo et al. 2006. Migration: Beauchemin & Bouquier 2005. Fertility: Campisi et al. 2022
- Neighborhood and municipality level indicators are difficult to obtain and to access
- There is a need for contextual data encompassing different geographic levels
- Family, health and education policies are often decided at the regional level
- Policies regarding childcare facilities are often left to municipalities

OBJECTIVES

- A contextual database for the "*Trajectories and Origines 2*" (TeO2) survey, INED & INSEE (French Statistical Office) 2019-2020
- Build a set of indicators characterizing the place of residence of respondents at the time of the survey
- Develop a method to build a **database of geocoded contextual indicators** derived from the French population census and other French administrative sources

DATA SOURCES

- 2018 French Population Census
 - ► Access to census micro data is needed to compute contextual indicators
- In France, access to individual-level census data is provided through a secure data hub after an individual application has been approved

Permanent Base of Facilities

- Covers 188 different types of services and facilities at the district level
- Indicator of "Localized Potential Accessibility to Medical Facilities"
- Measure of spatial adequacy between supply and demand for primary health care at the municipal level
- French Deprivation Index
- Indicator of material and social disadvantage
- Income, living standards and poverty indicators
- Population density
- Housing supply/demand imbalance

The same computation method is applied for each indicator Example: <u>% of immigrants</u> in a given district

Census-based indices are percentages and rates obtained by aggregating individual-level

- Sum of the weighted number of immigrants residing in a given district /
- Weighted number of people residing in that district

information over the selected geographical levels

i = 1, ..., N (population of the district) k = 1, ..., J (districts) iw : survey weight $immi = \begin{cases} 1 & \text{if immigrant} \\ 0 & \text{otherwise} \end{cases}$

POP: Population size of the district

$$pop_k = \sum_{i=1}^{n_k} \mathbb{I}_i$$

POP_w: Weighted population size of the district

$$\operatorname{oop}_{-}w_k = \sum_{i=1}^{n_k} iw_i$$

PCT_IMMI: % of immigrants

$$pct_immi_k = \frac{\sum_{i=1}^{n_k} immi_i * iw_i}{\sum_{i=1}^{n_k} iw_i} \times 100$$

Aggregated index

$$\operatorname{pct_immi}_{L} = \frac{\sum_{k=1}^{n_{L}} \operatorname{pct_immi}_{k} * \operatorname{pop_w}_{k}}{\sum_{k=1}^{n_{L}} \operatorname{pop_w}_{k}}$$

DATABASE CONTENT

359x6 indicators at the district, municipal and broader geographical levels

Their choice relies primarily on the survey's main topic (i.e. migration) and on the availability of administrative data at a subnational level


 Indicator of disadvantage considered as a combination of material and social disadvantages at the municipal level


CDB LINKAGE TO SURVEY DATA

- The contextual database contains indicators for the entire French territory
- It has been **linked to survey information**, by means of the geographical code of respondent's place of residence
- The linked database will soon become available to scientists willing to contextualize individual-level analyses




Immigrant population in France, 2008 and 2018 (quintiles)

VISUALIZATION

We are developing a Shiny App for dynamic data visualization (with Arno Muller, INED)

DATA AVAILABILITY

Make it available for record linkage to other geocoded surveys

RETROSPECTIVE & PROSPECTIVE CDB

- The current version of the CDB describes the French context in 2018
- It characterizes the survey respondents' current place of residence
- "Which context is it that matter? At which point at individual life stage?" (Goldscheider, 2000)
- Rosa Weber (INED) is currently expanding the temporal coverage of the CBD, using this
 method and harmonized French population census microdata since 1968
- Computation of the same indicators across a longer time span
- Linked TeO2 survey respondents' place of residence at age 15, first independent, and previous residence
- We aim at updating the CDB in the future, at each yearly census release

A BROADER RANGE OF POSSIBLE APPLICATIONS OF THIS METHOD

• Computation of **new indicators**: extension to other domains, for fertility and mortality research
